Figure 1.10 is an enlarged view of Figure 1.7 shown for ease of illustration.

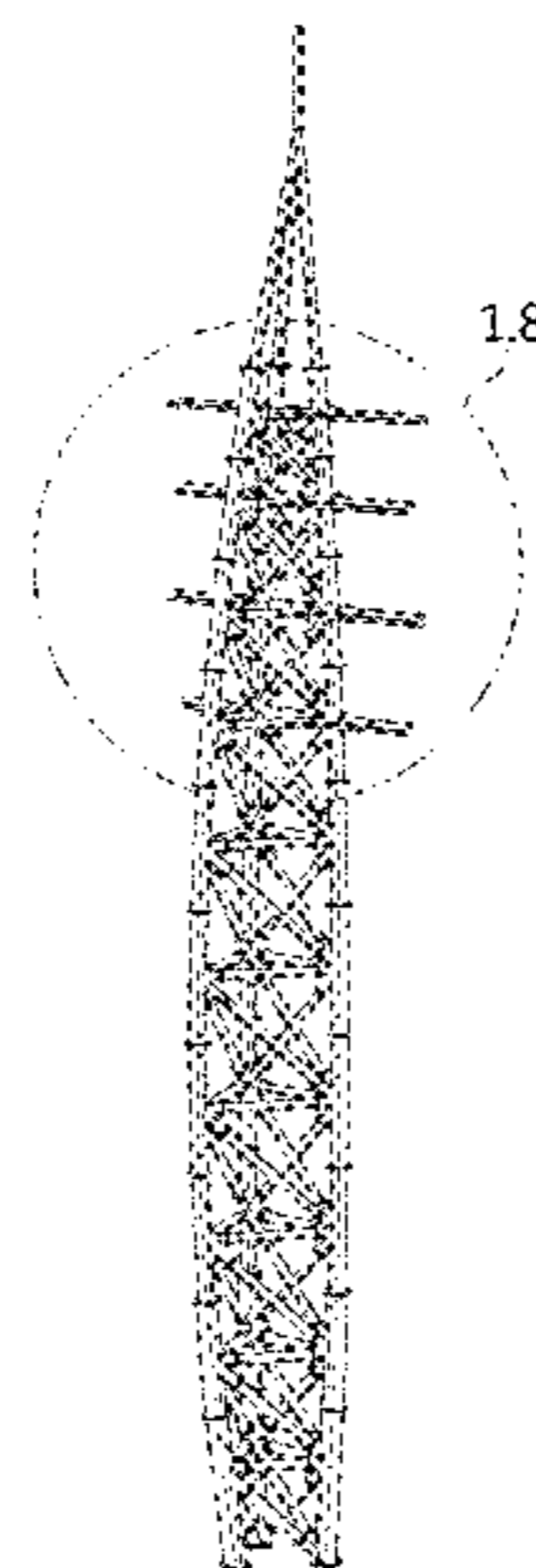

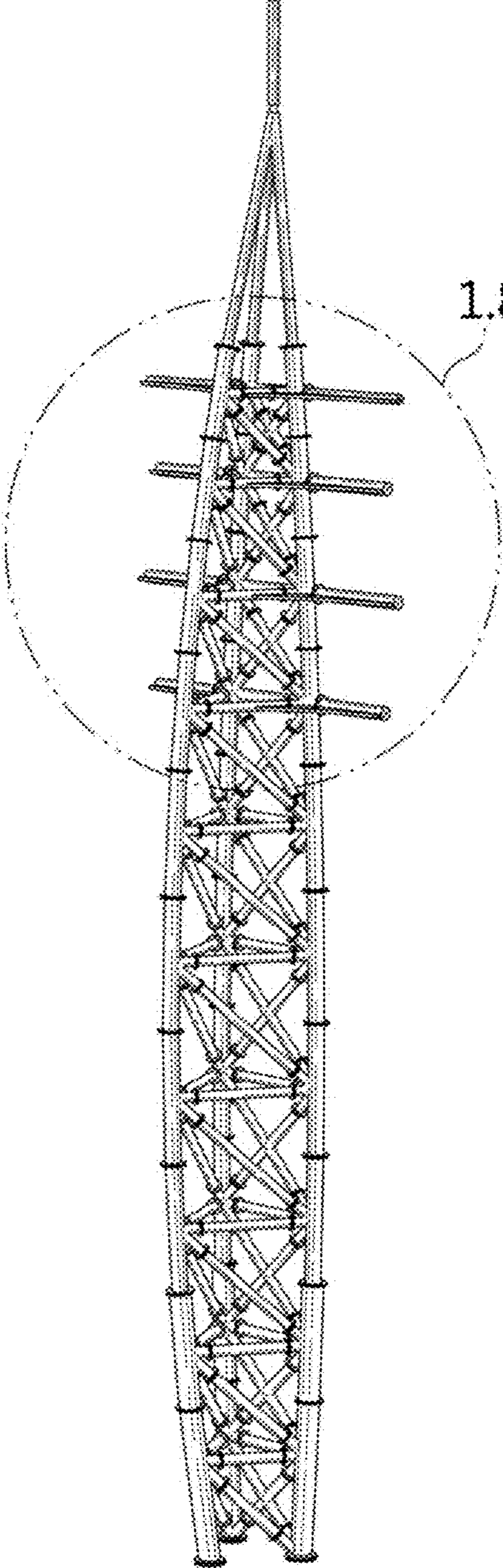

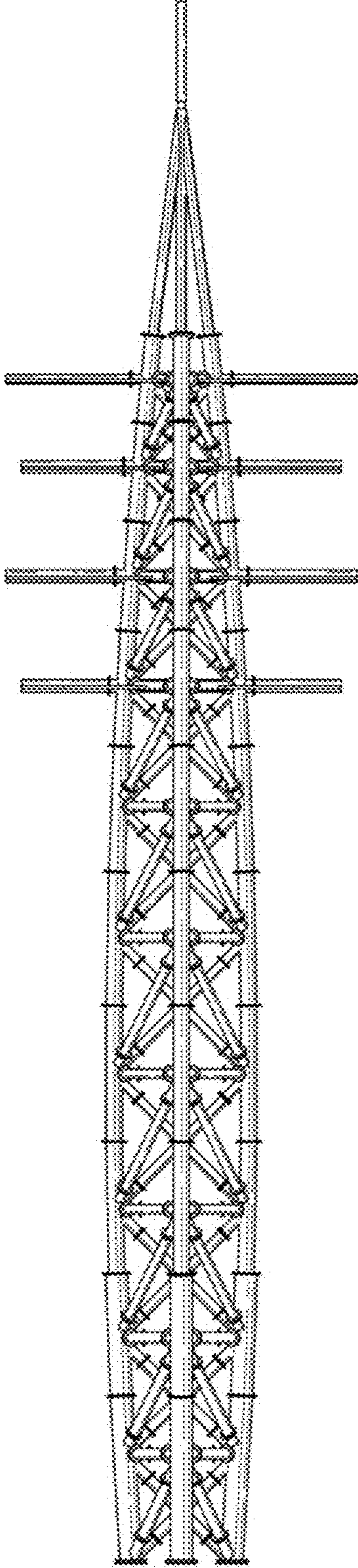

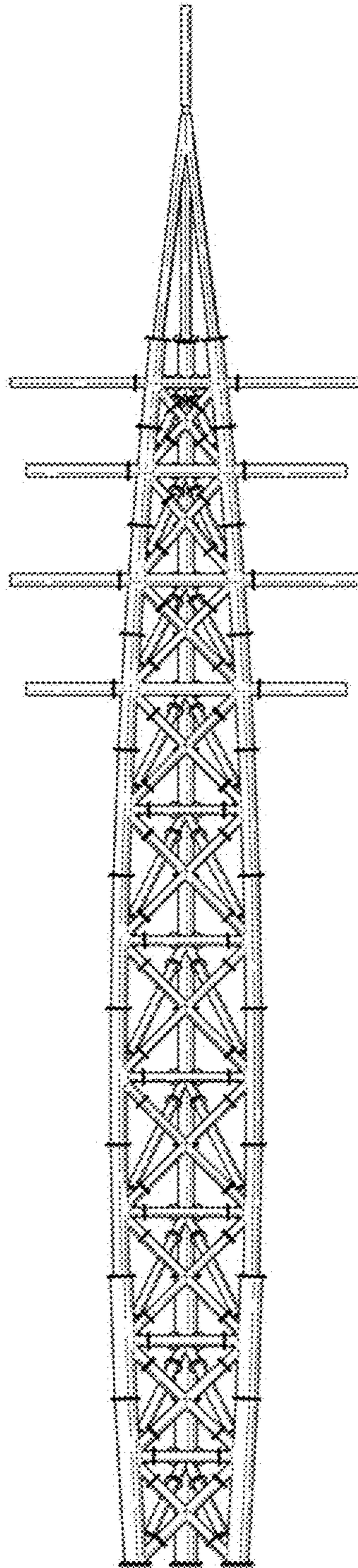

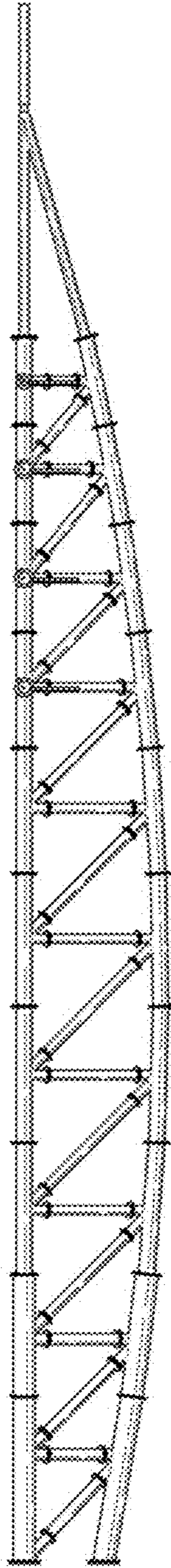

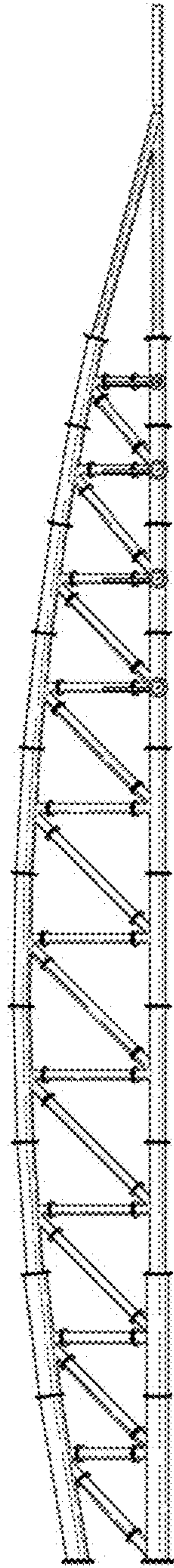

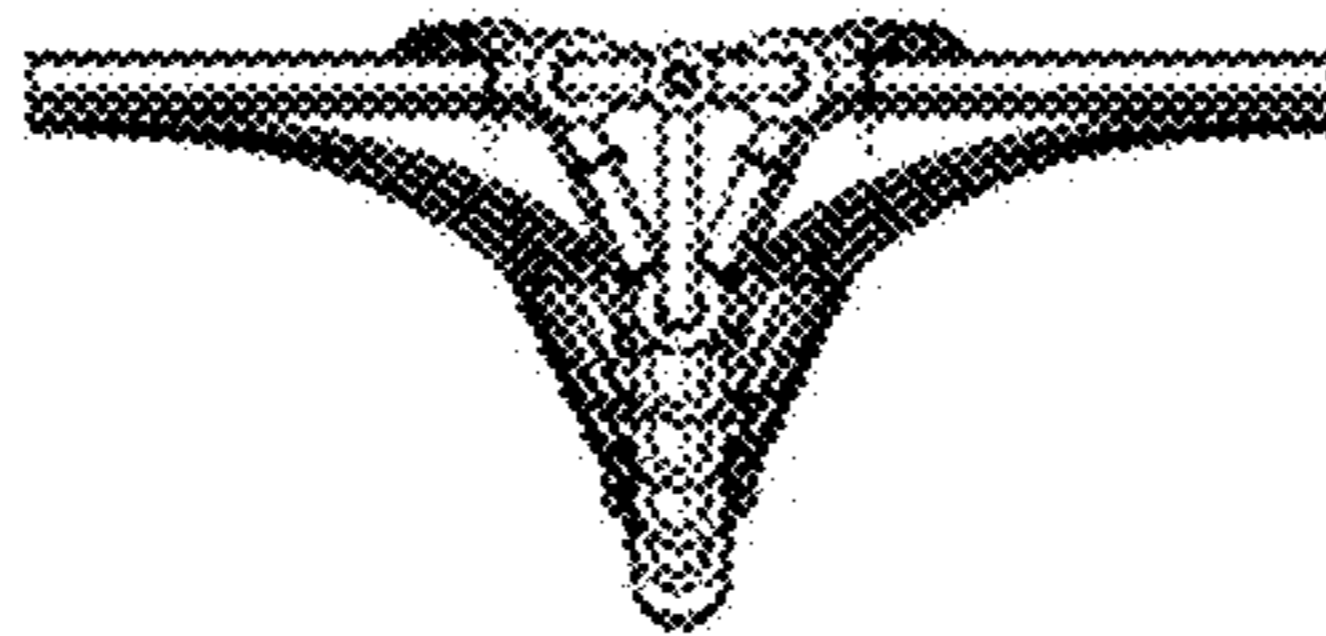

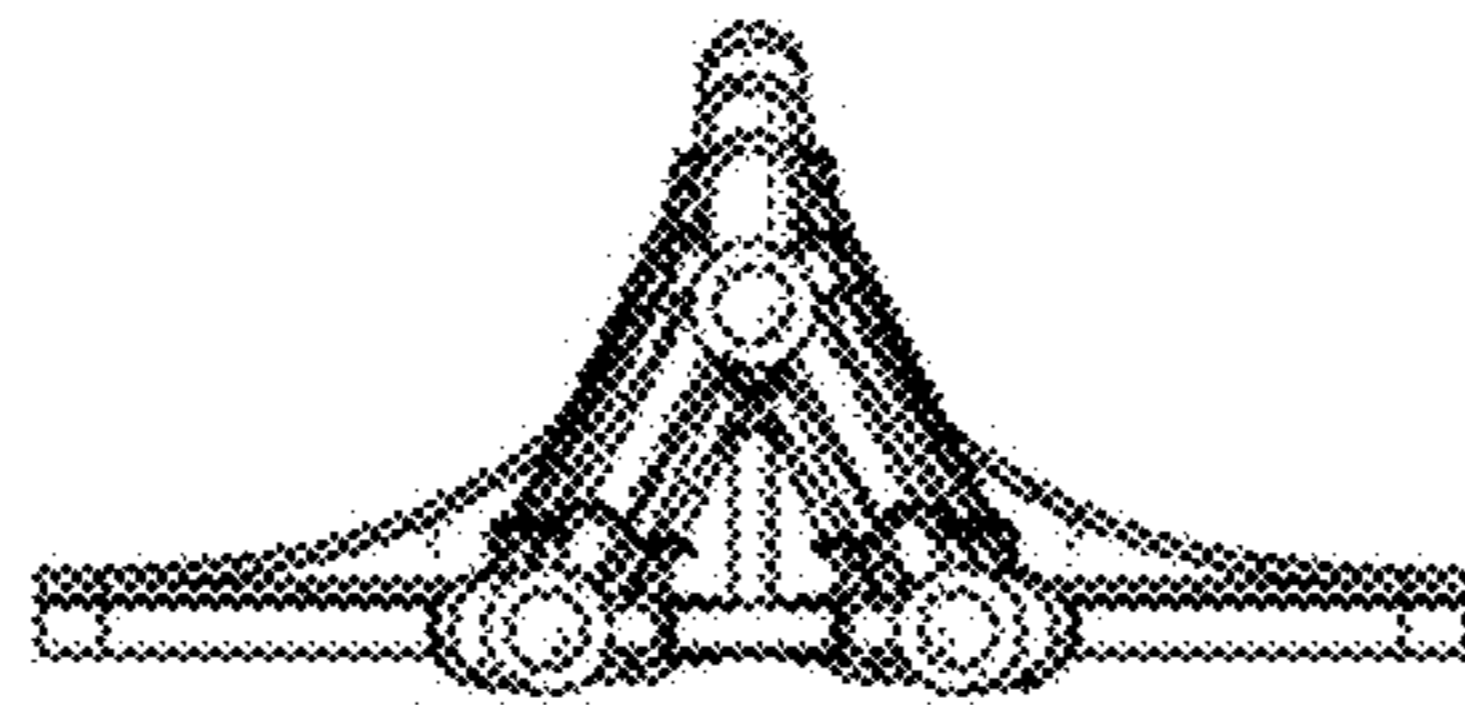

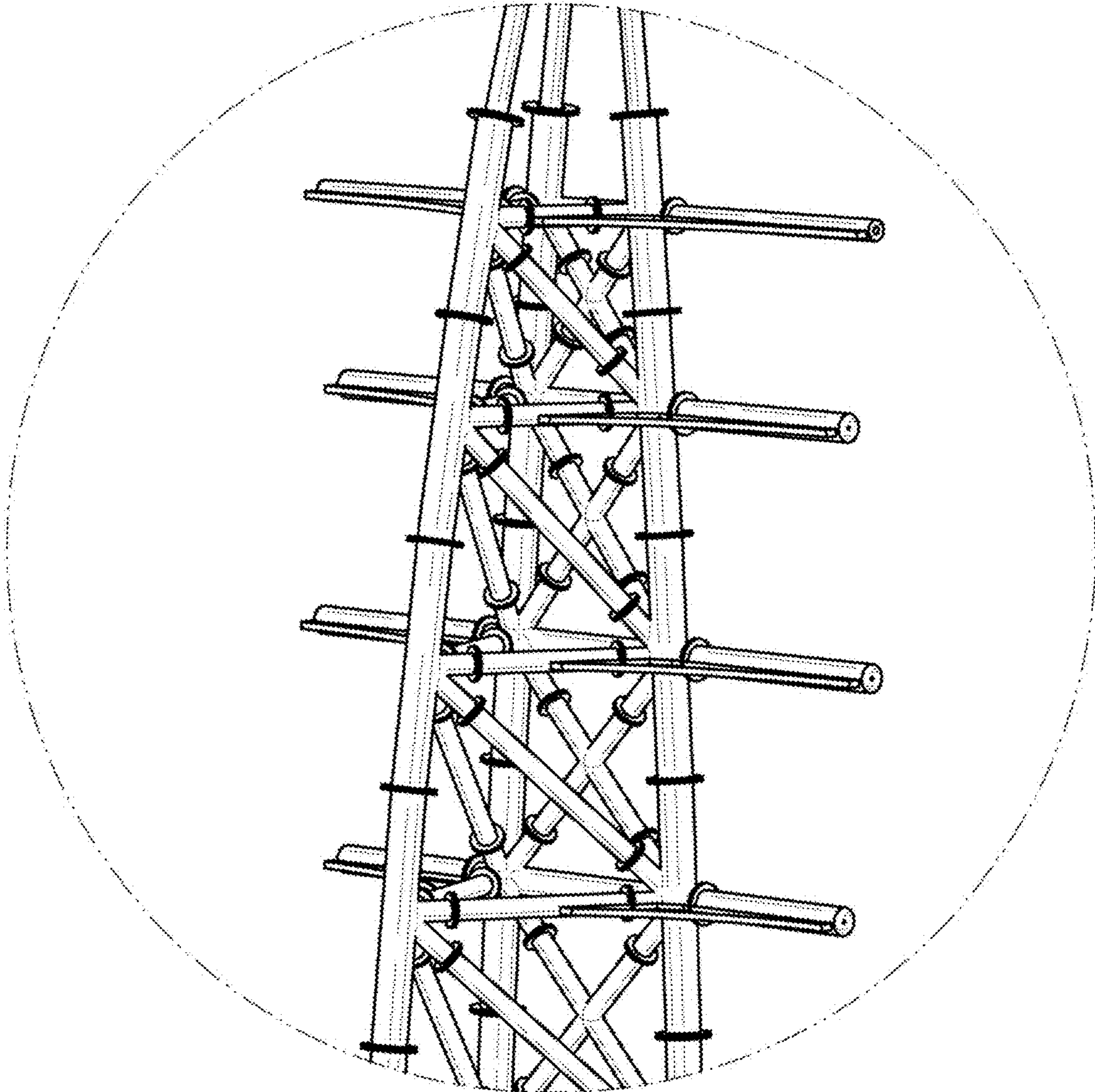

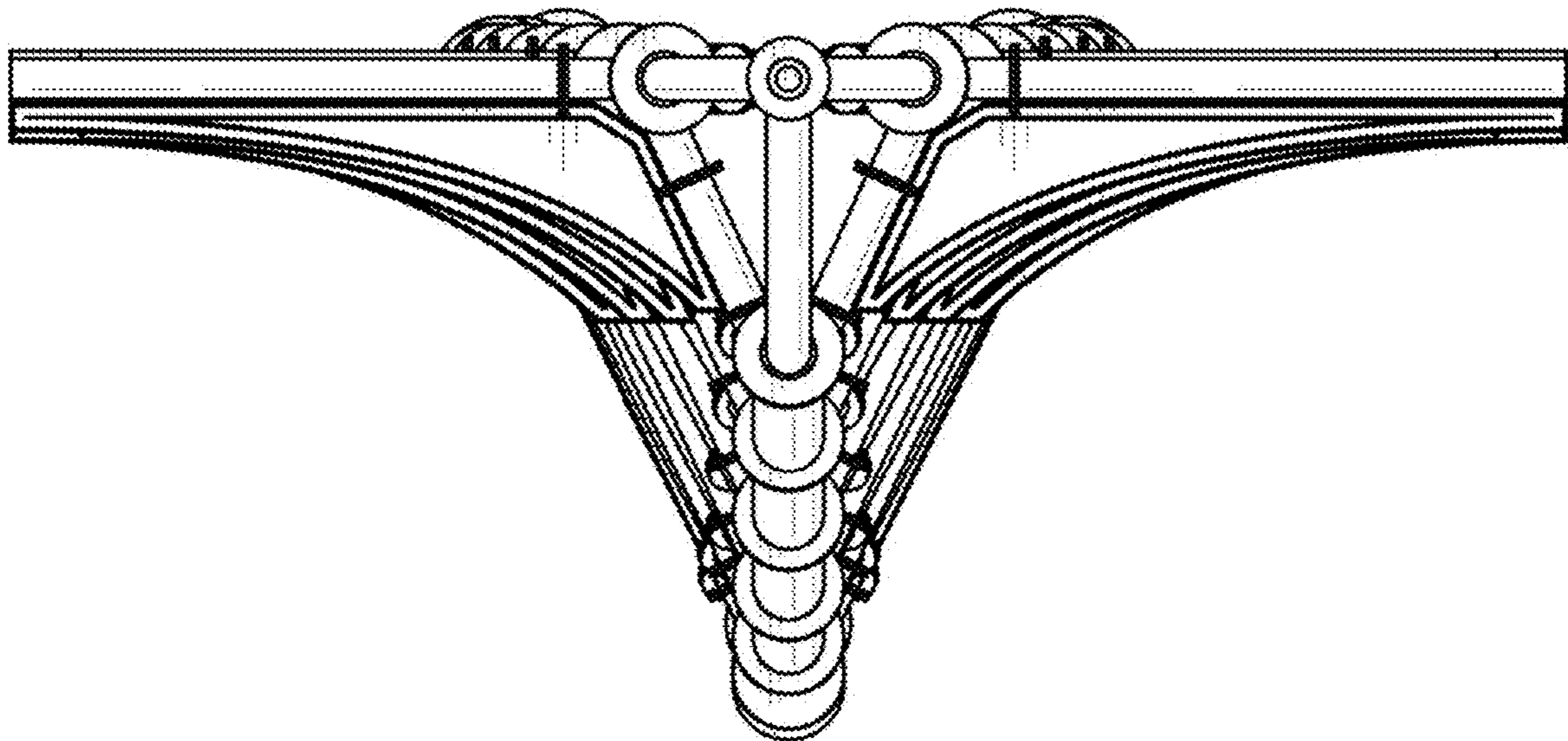
