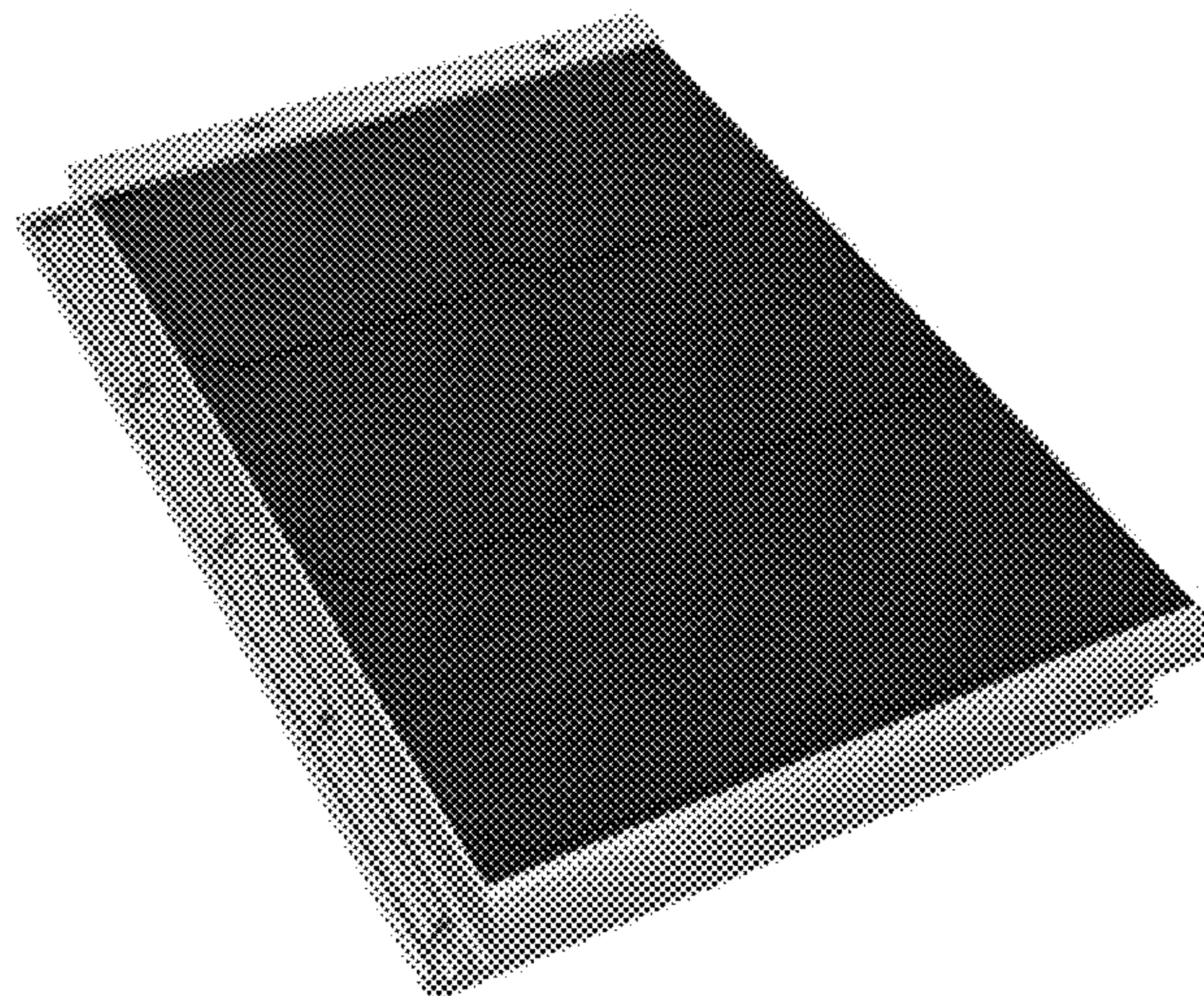
(57) **CLAIM**

**DESCRIPTION**

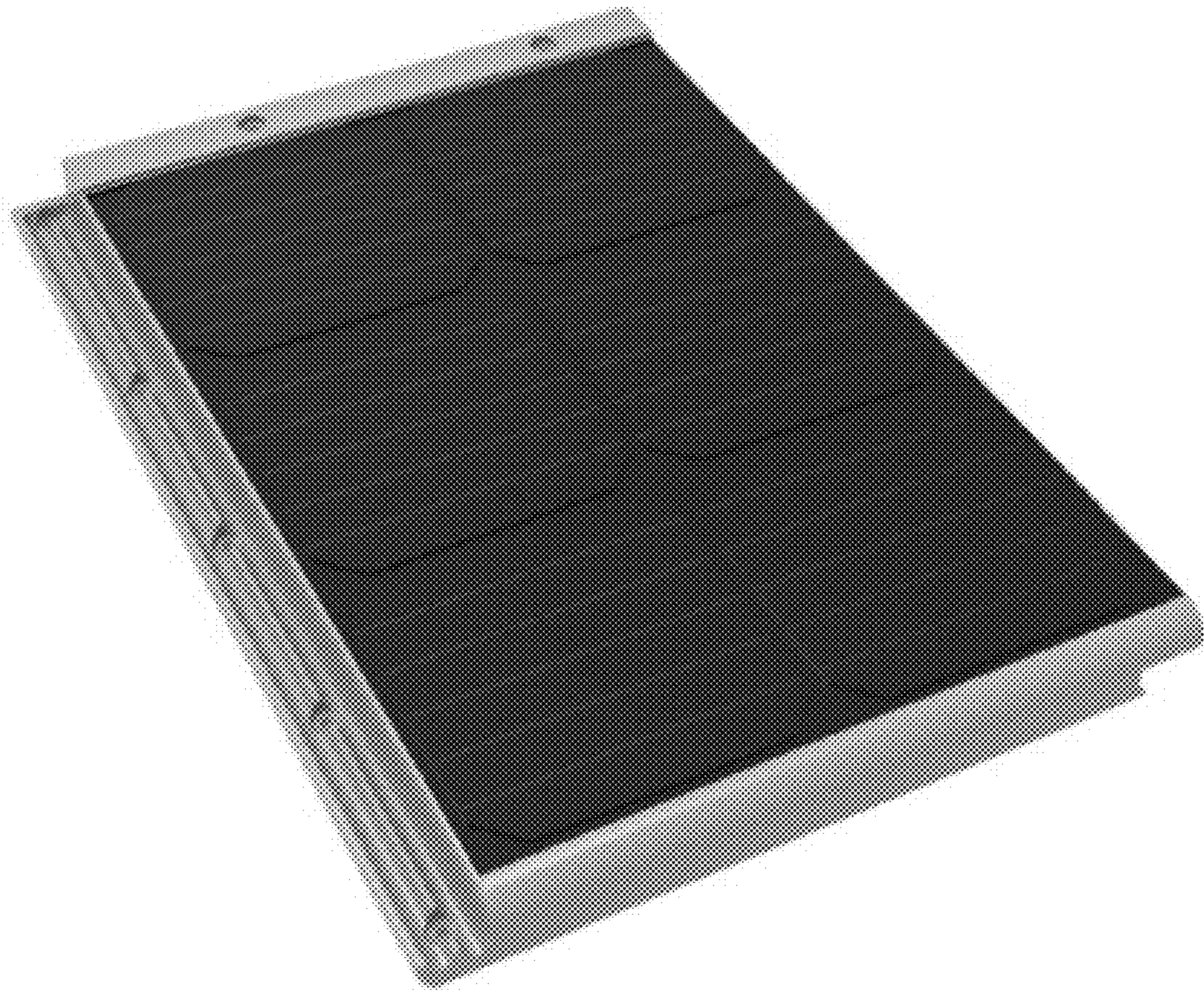
1. Roof tile

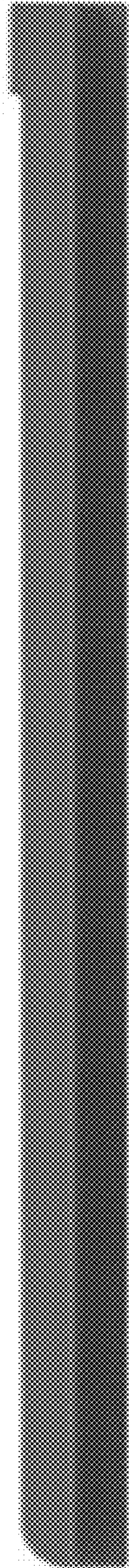

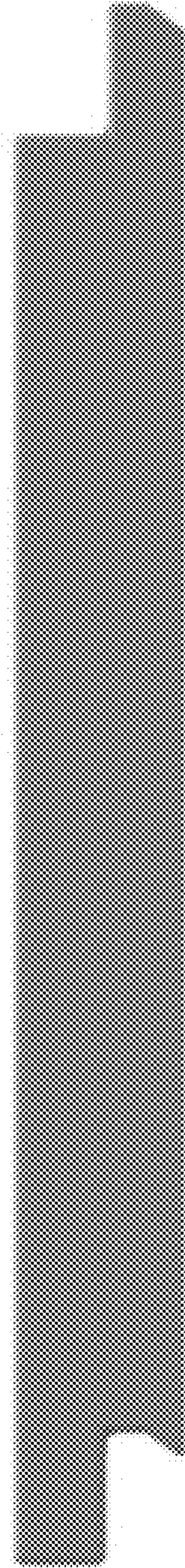

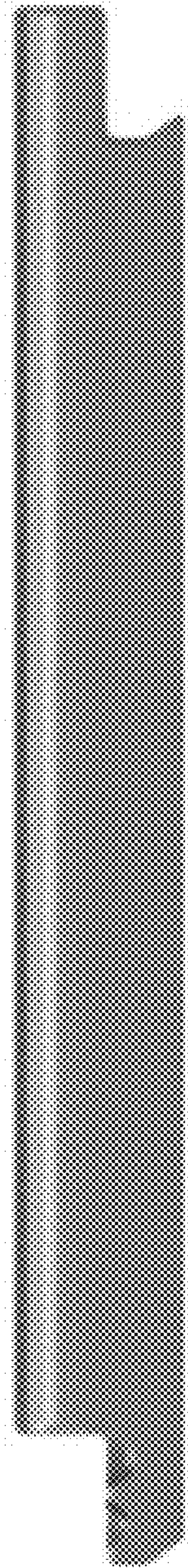

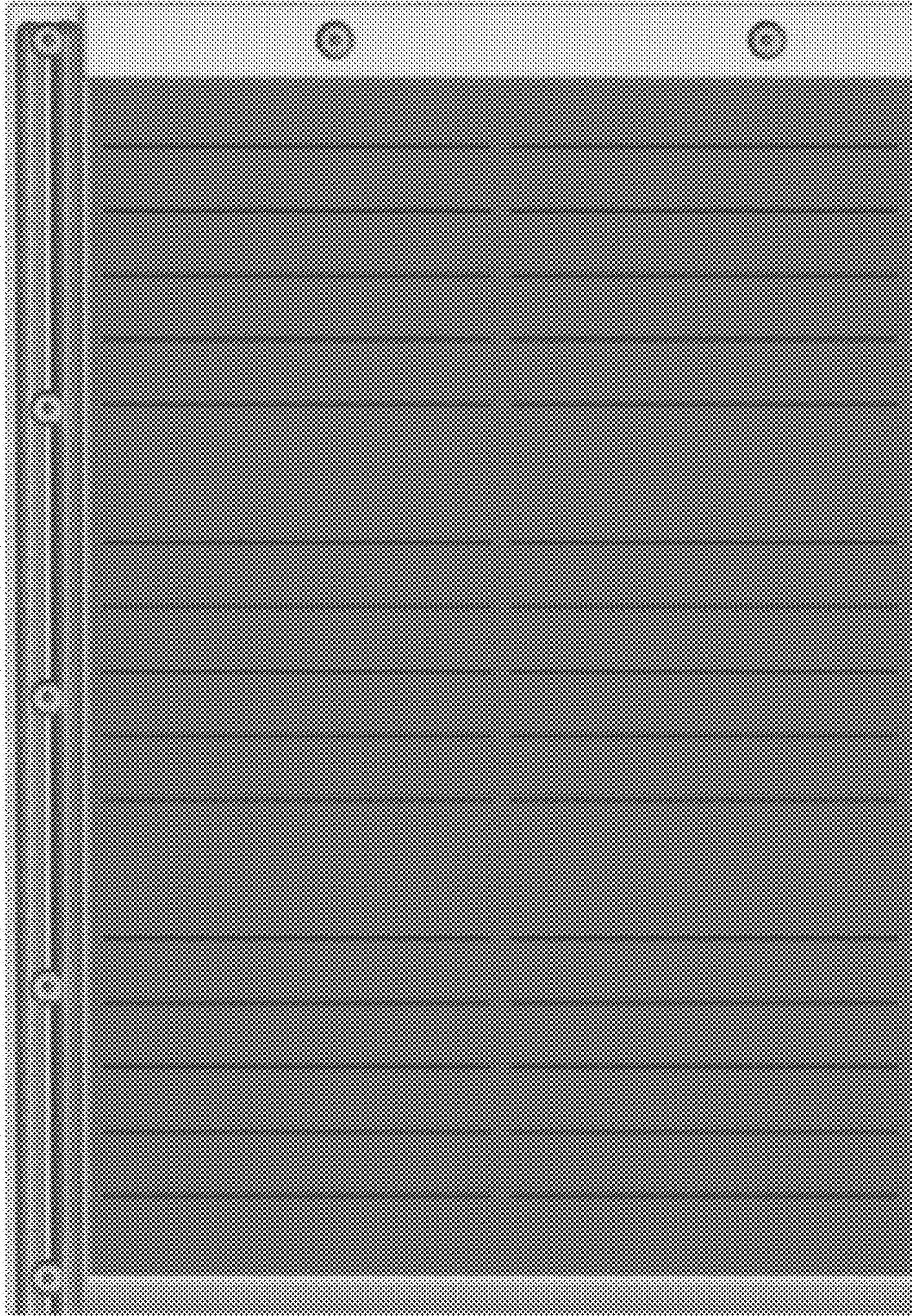

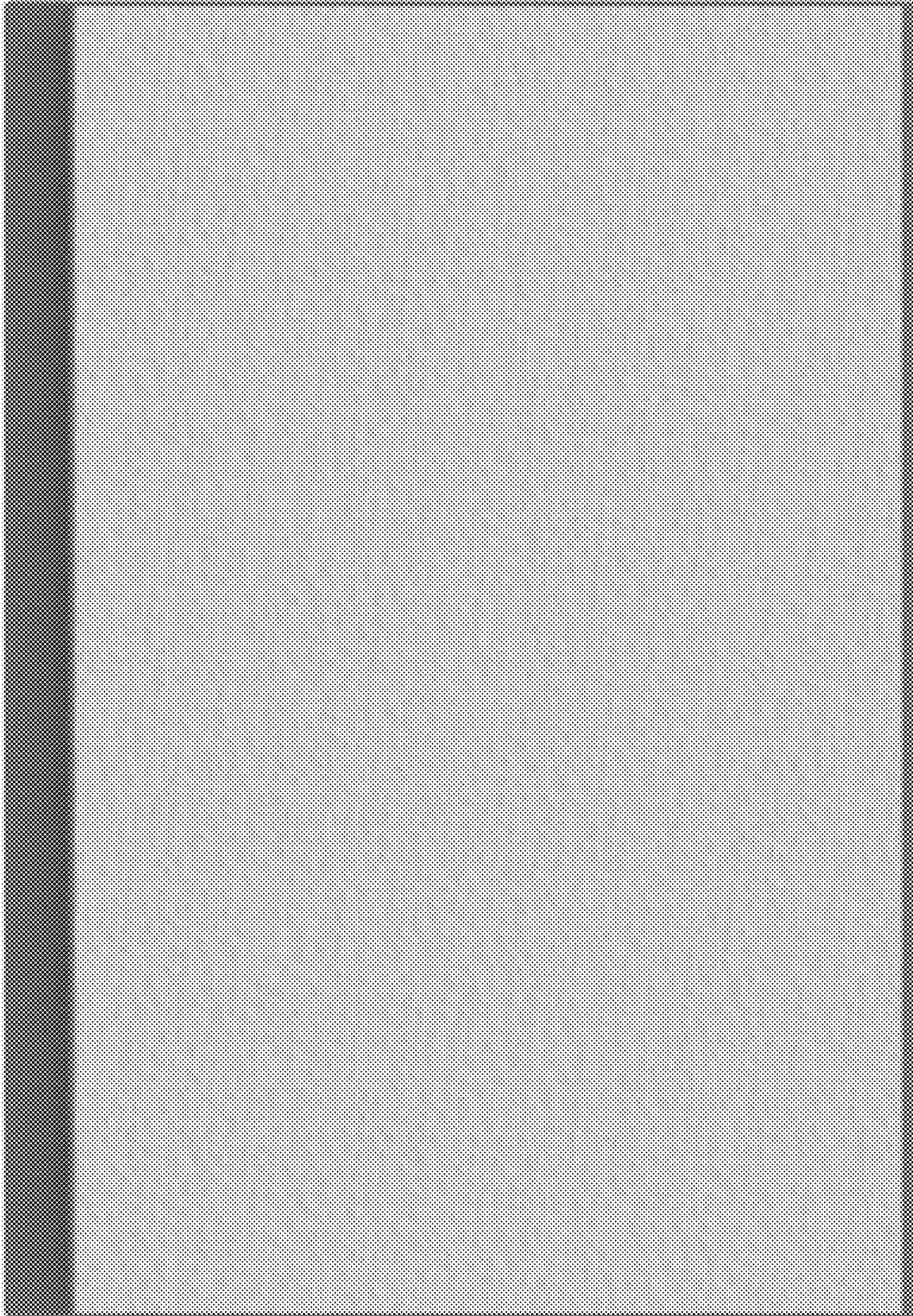
