DESCRIPTION

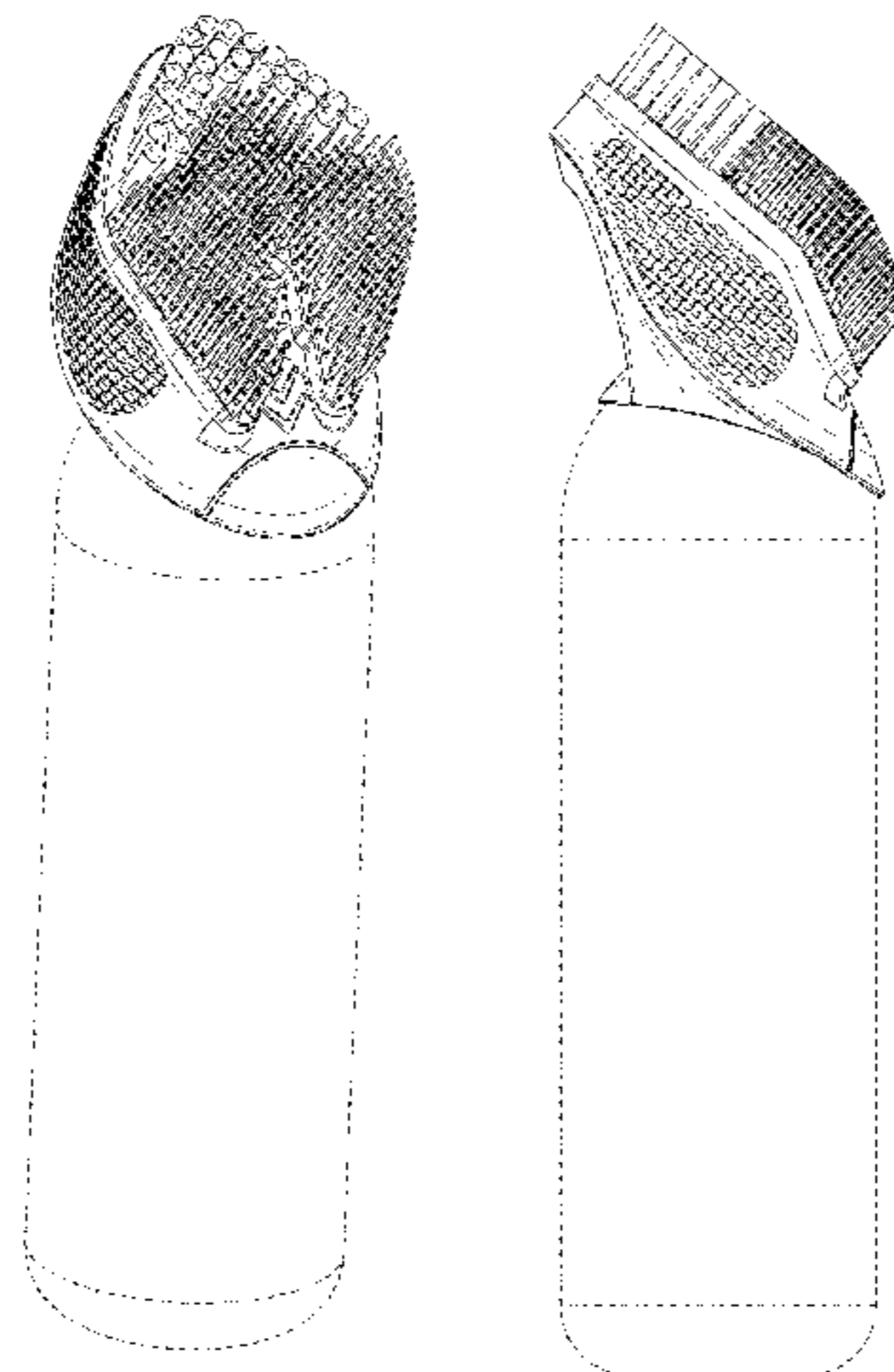
FIG. 1 is a perspective view of my new and original design for a carpet cleaning head cap;

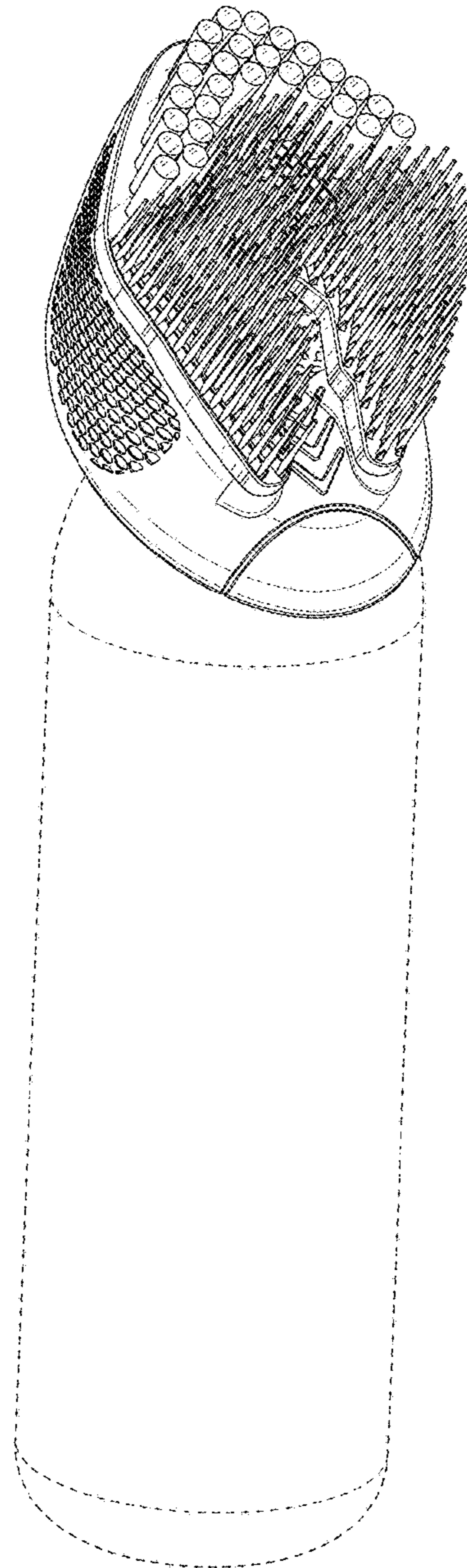

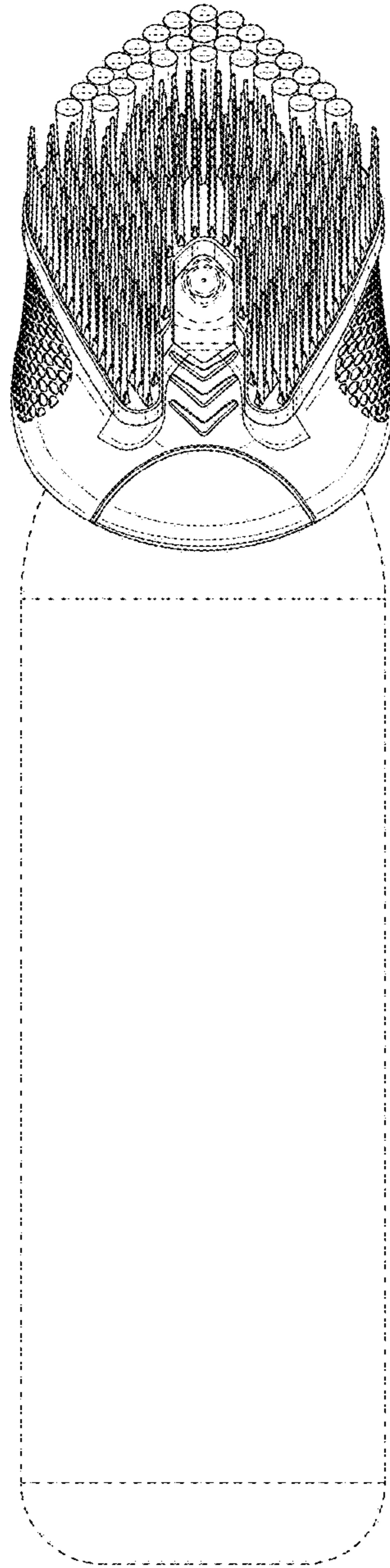

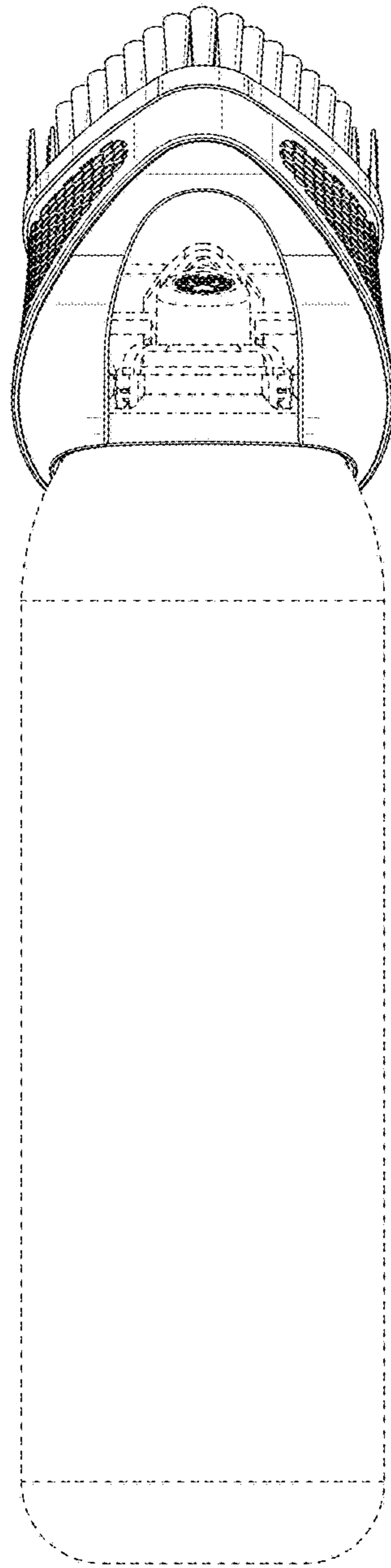

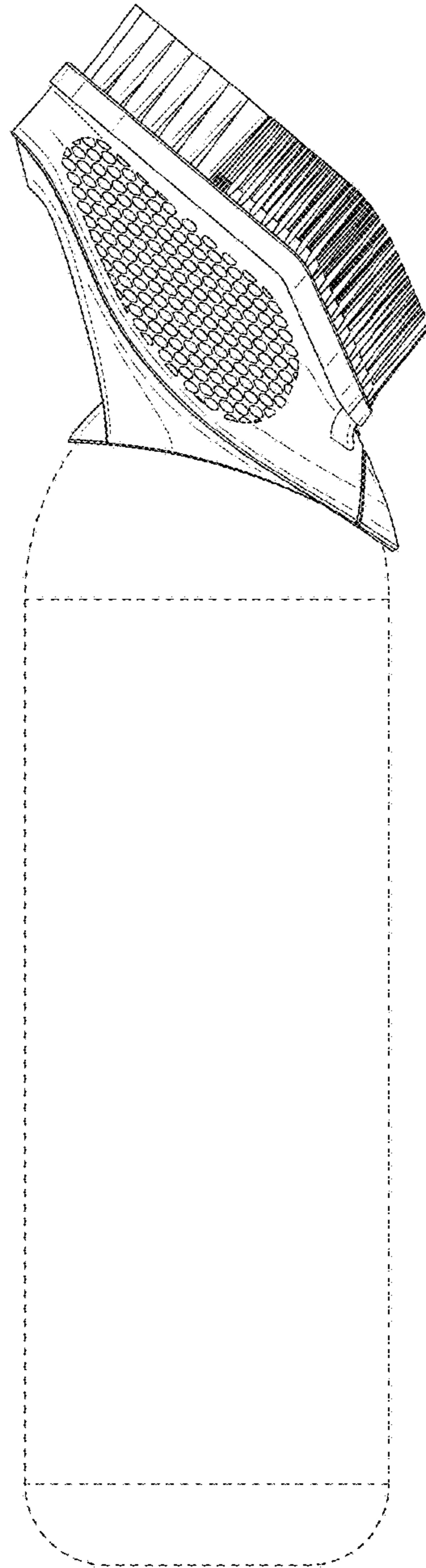

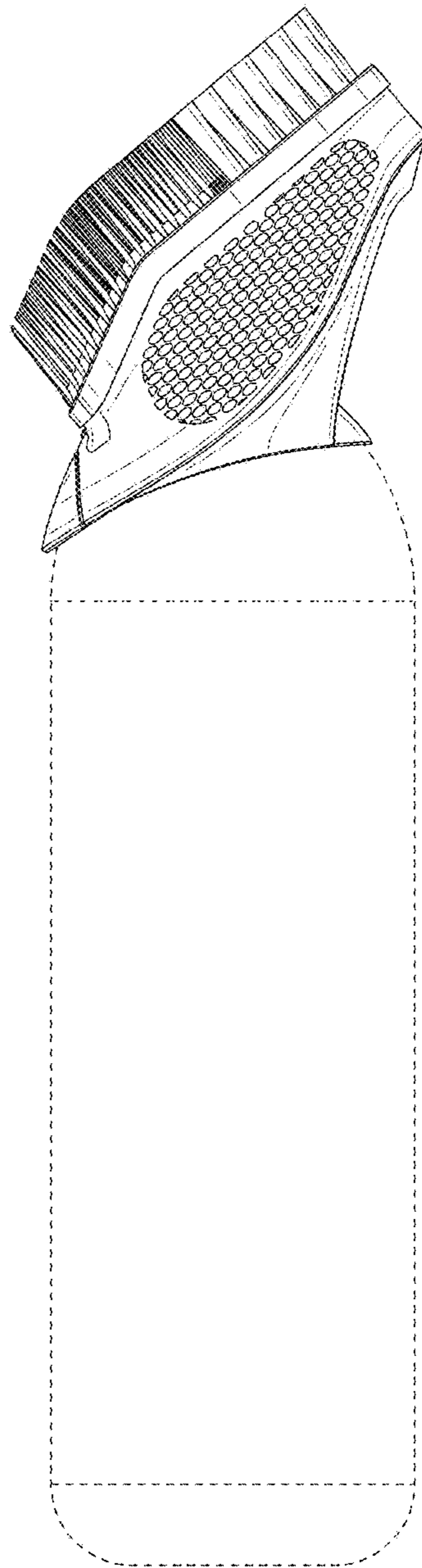

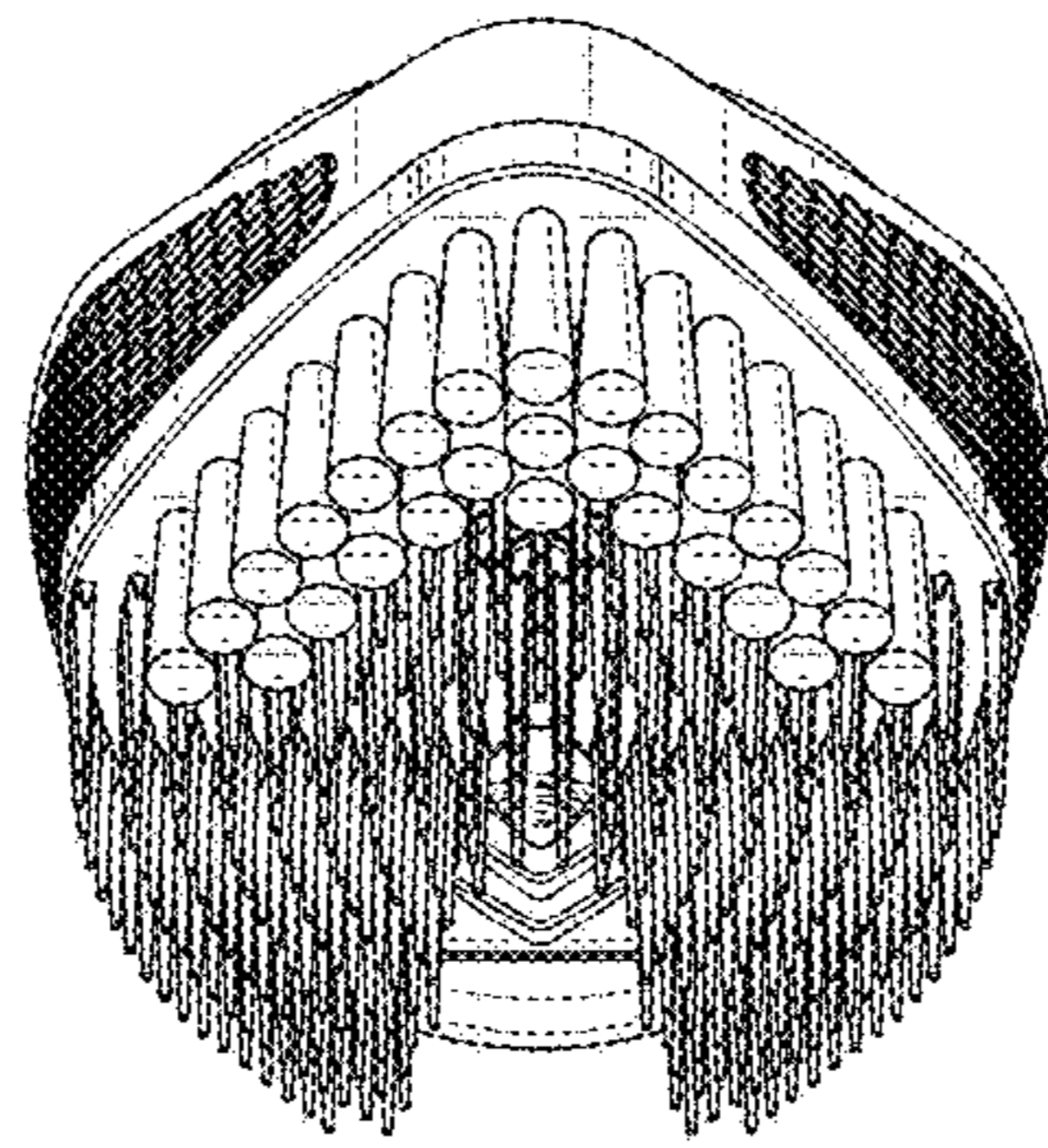

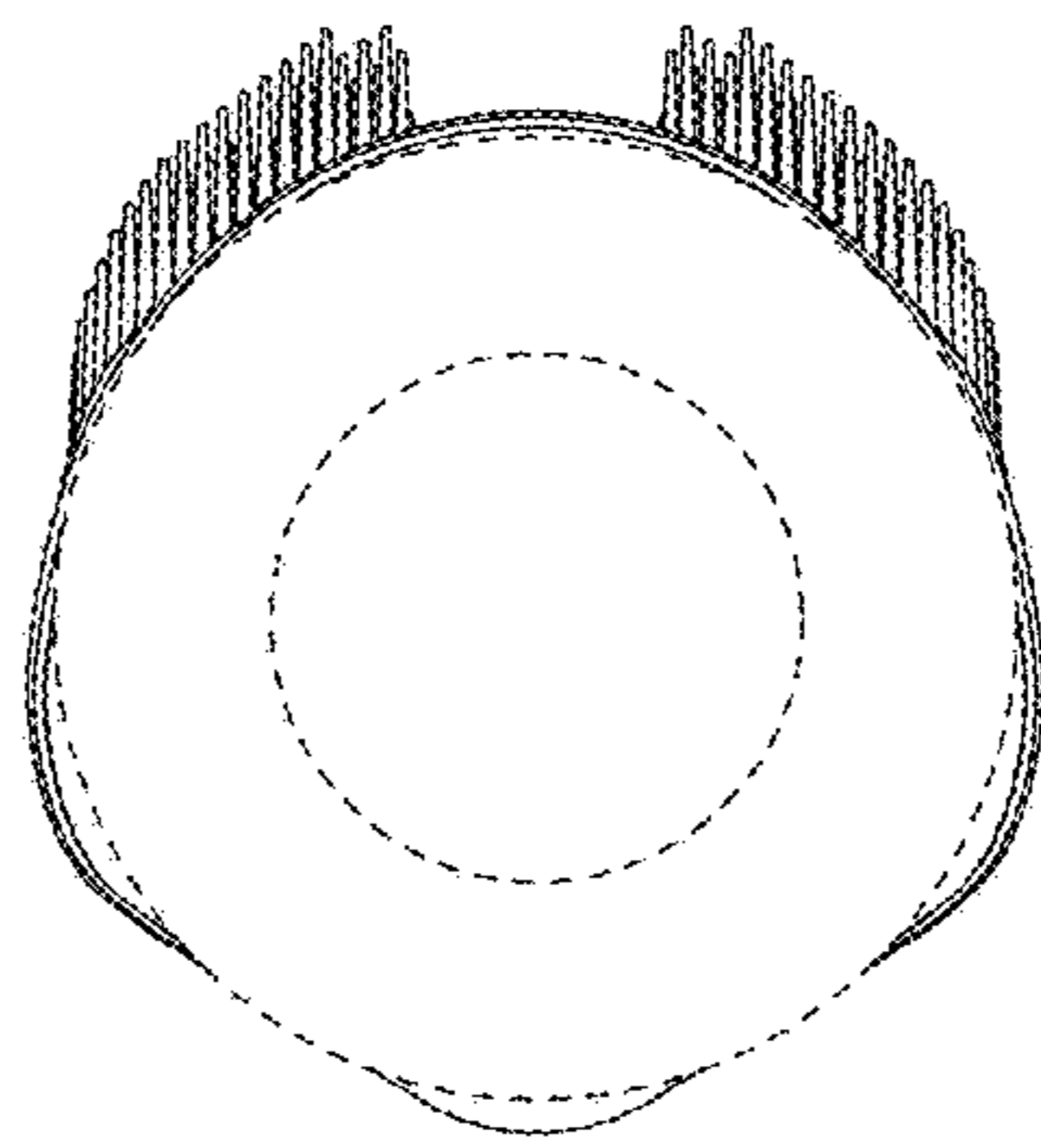
