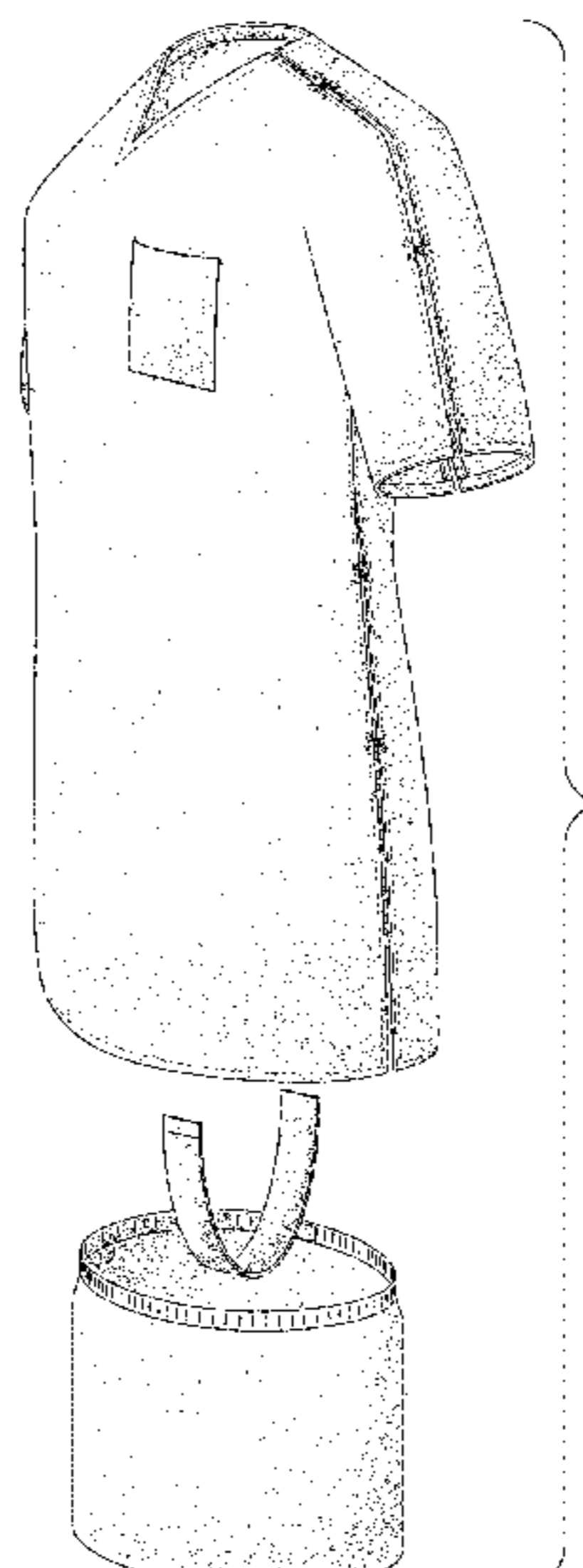
FIG. 6 is a top view thereof; showing a diamond shaped V-neck opening between a front portion and a rear portion of the privacy gown; and,

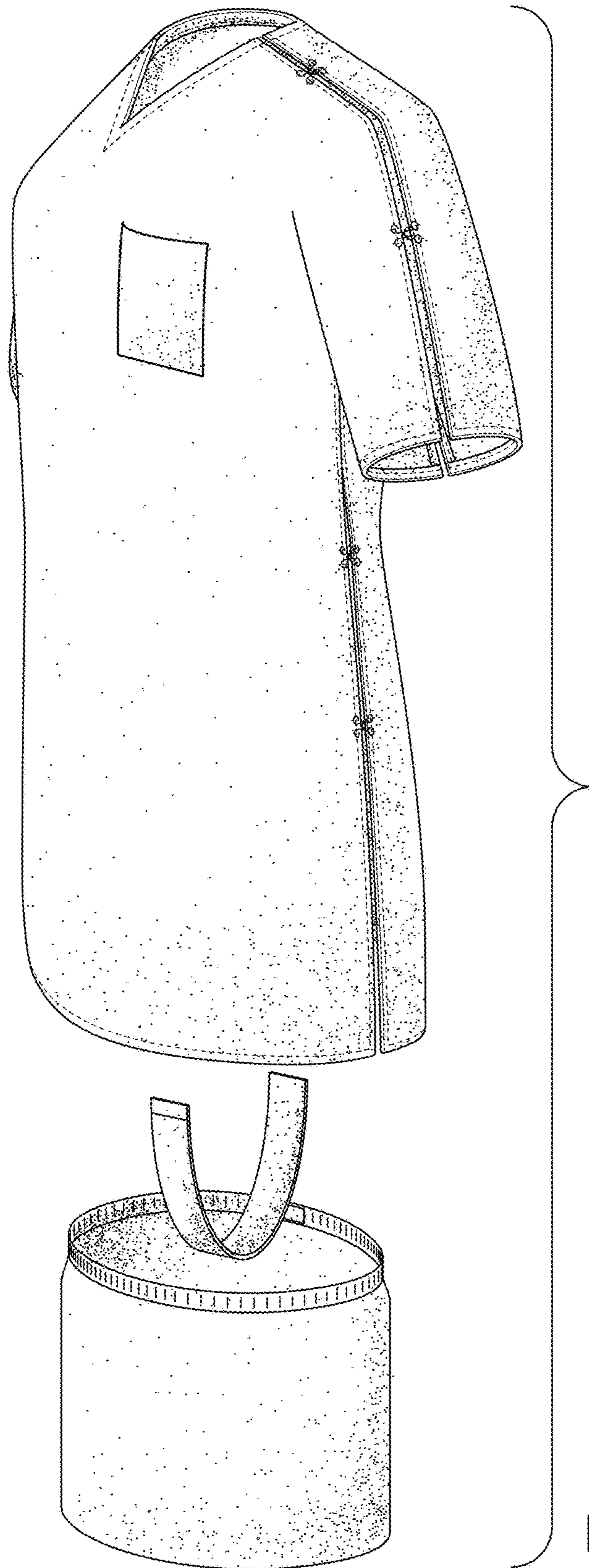

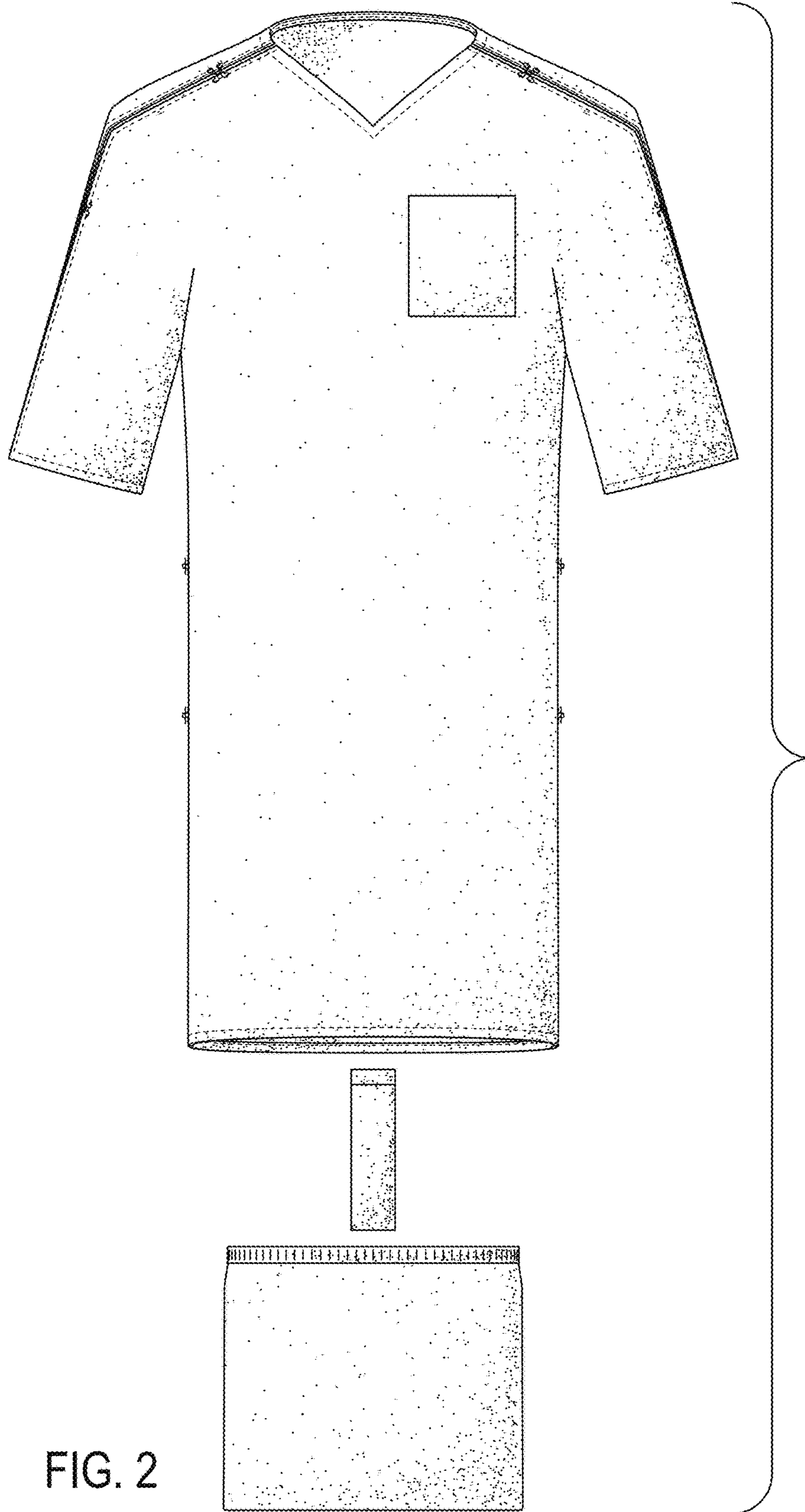

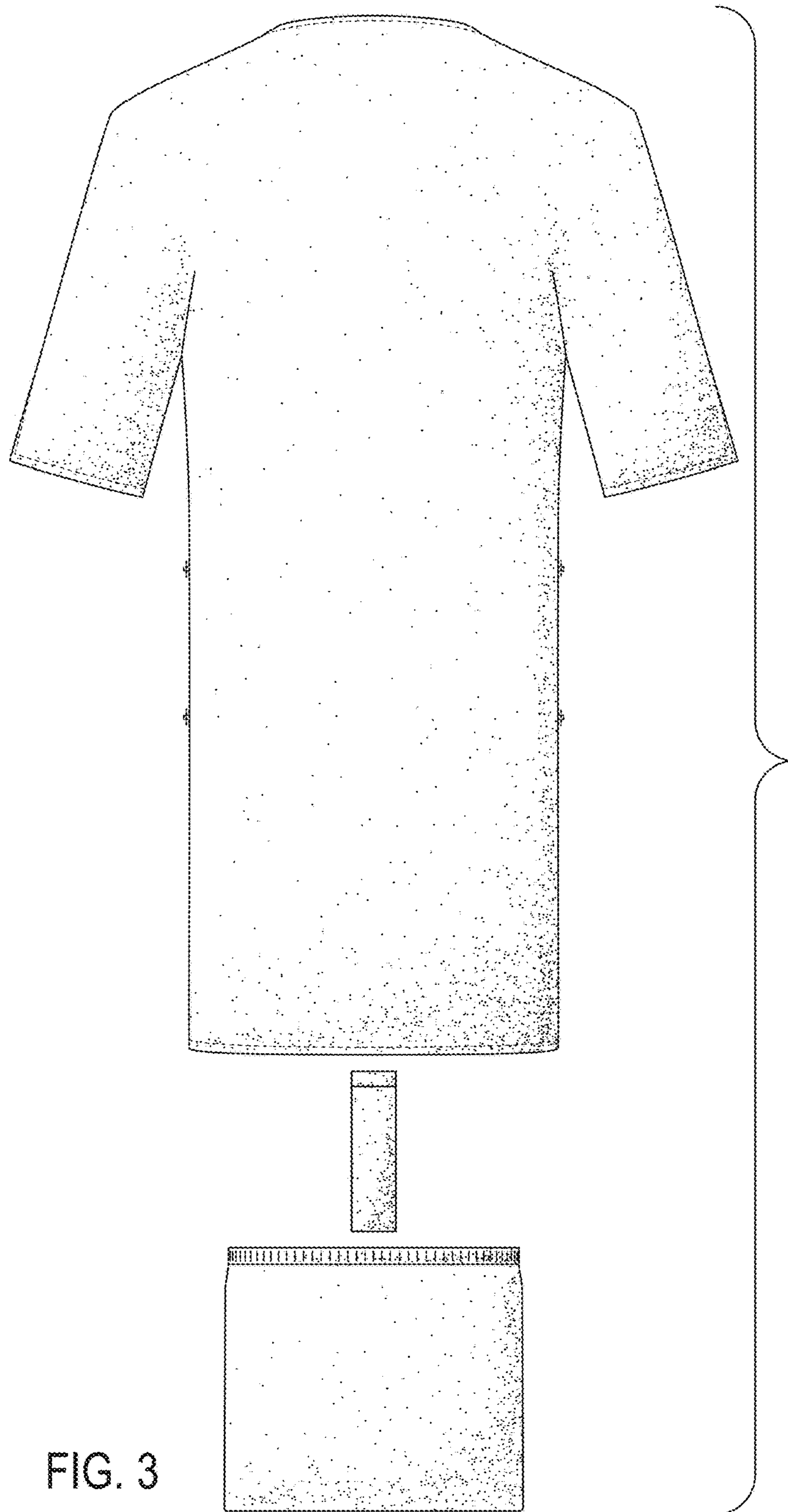

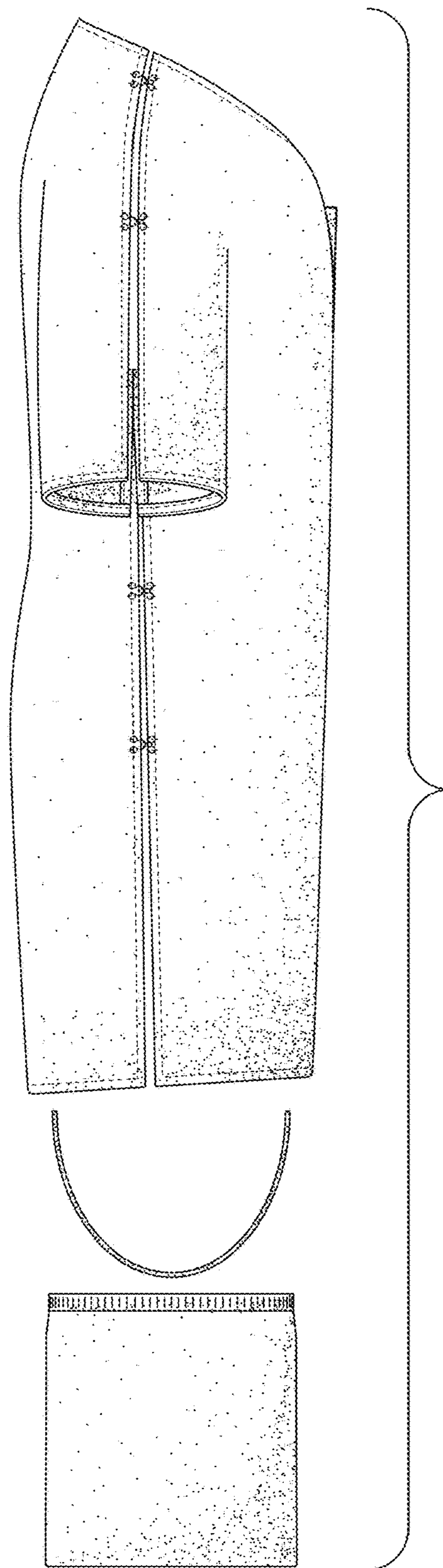

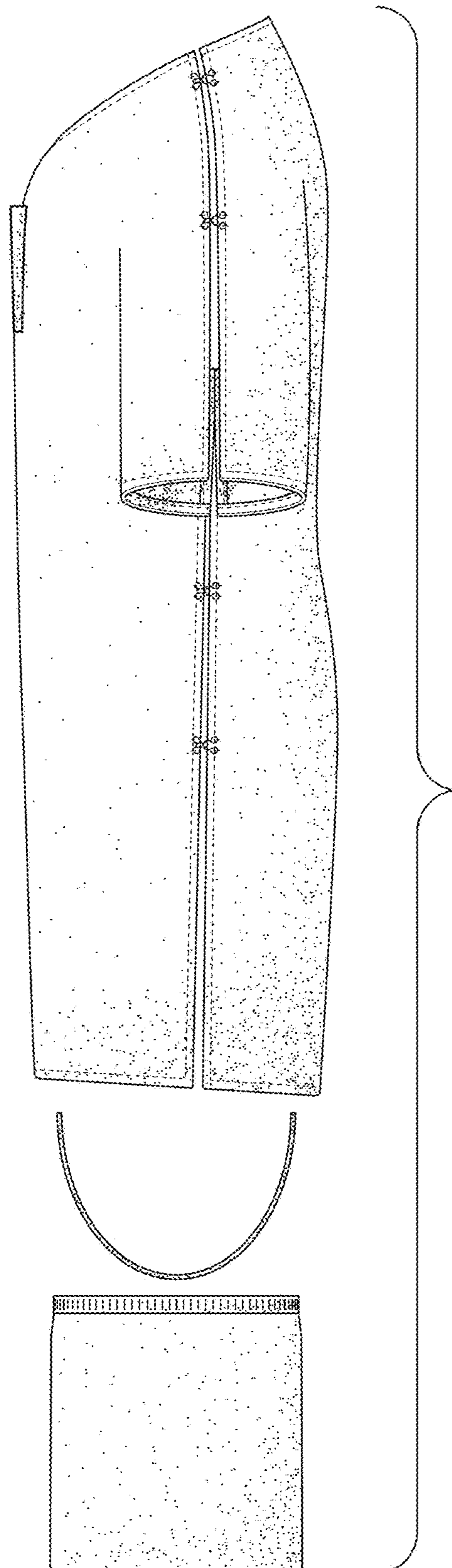

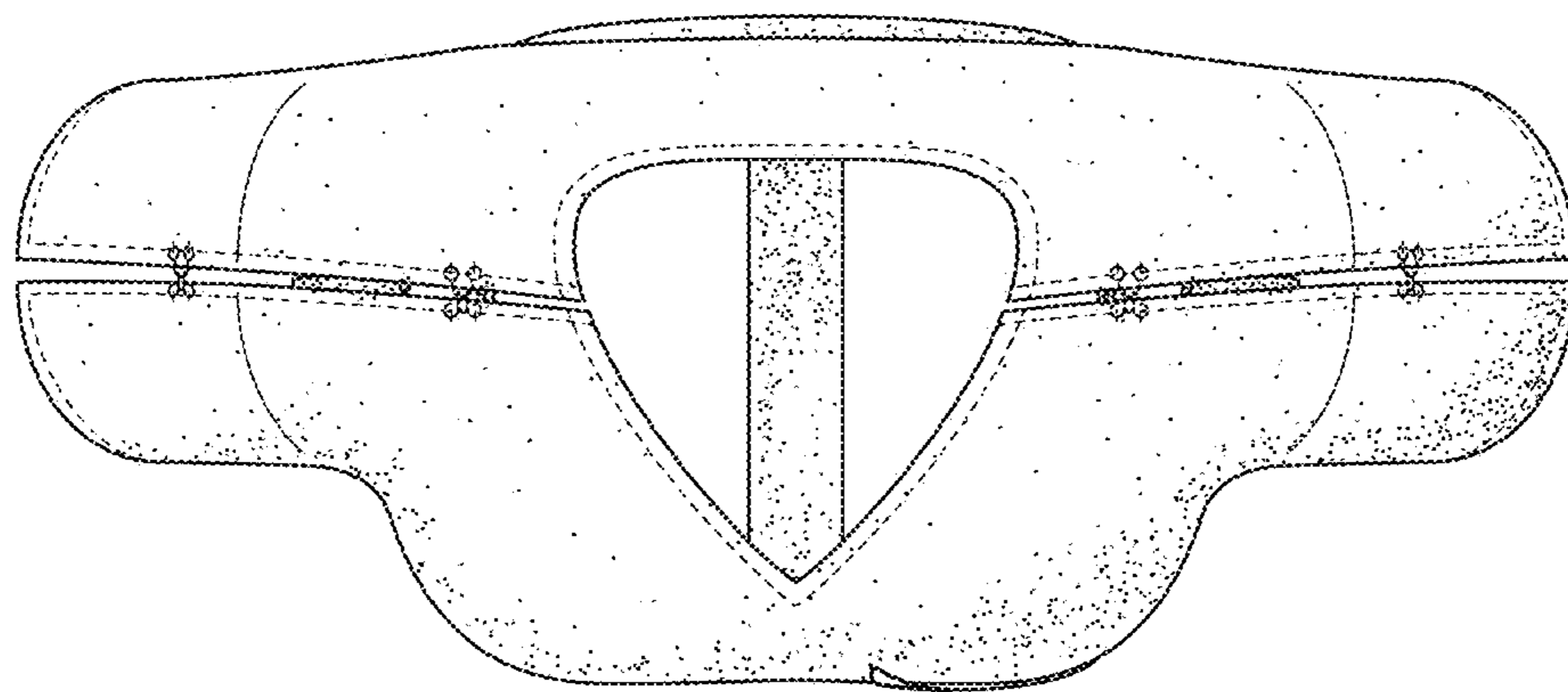

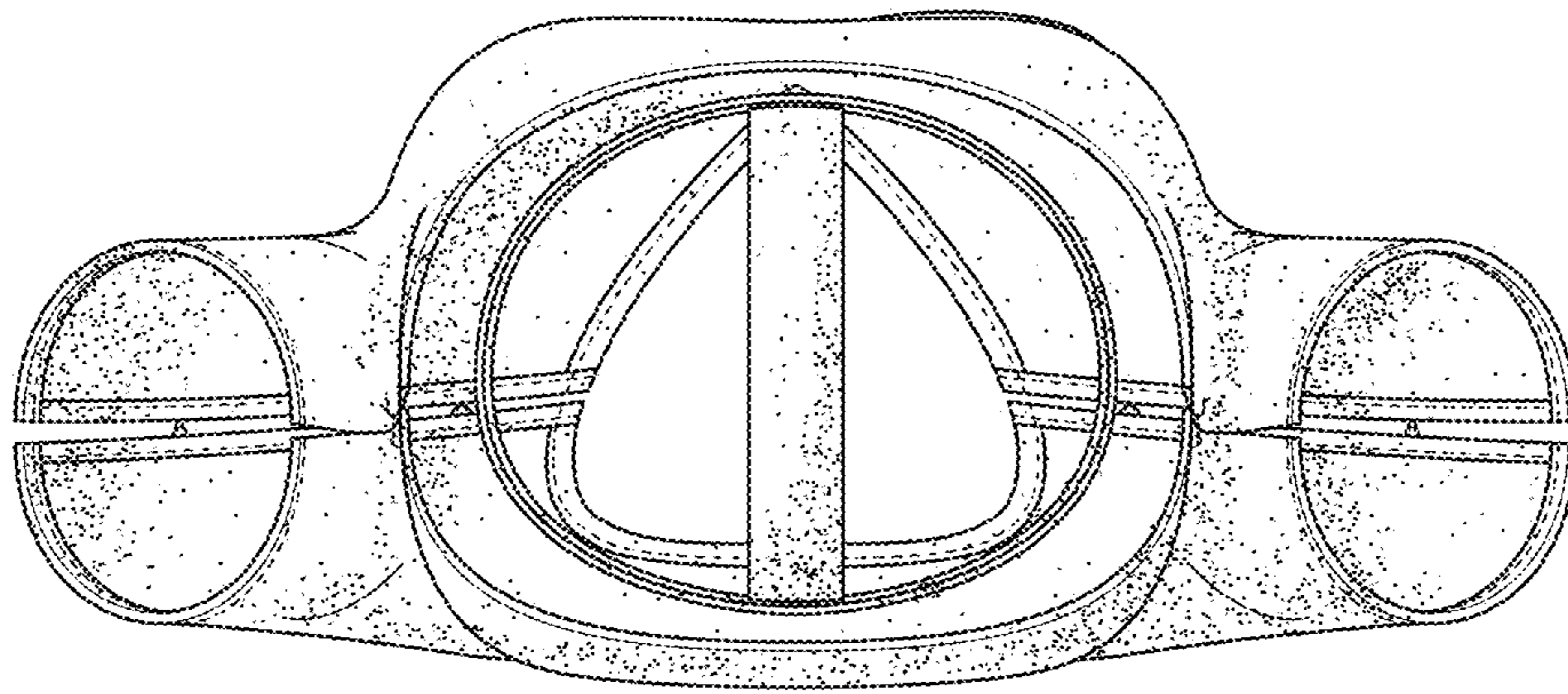
