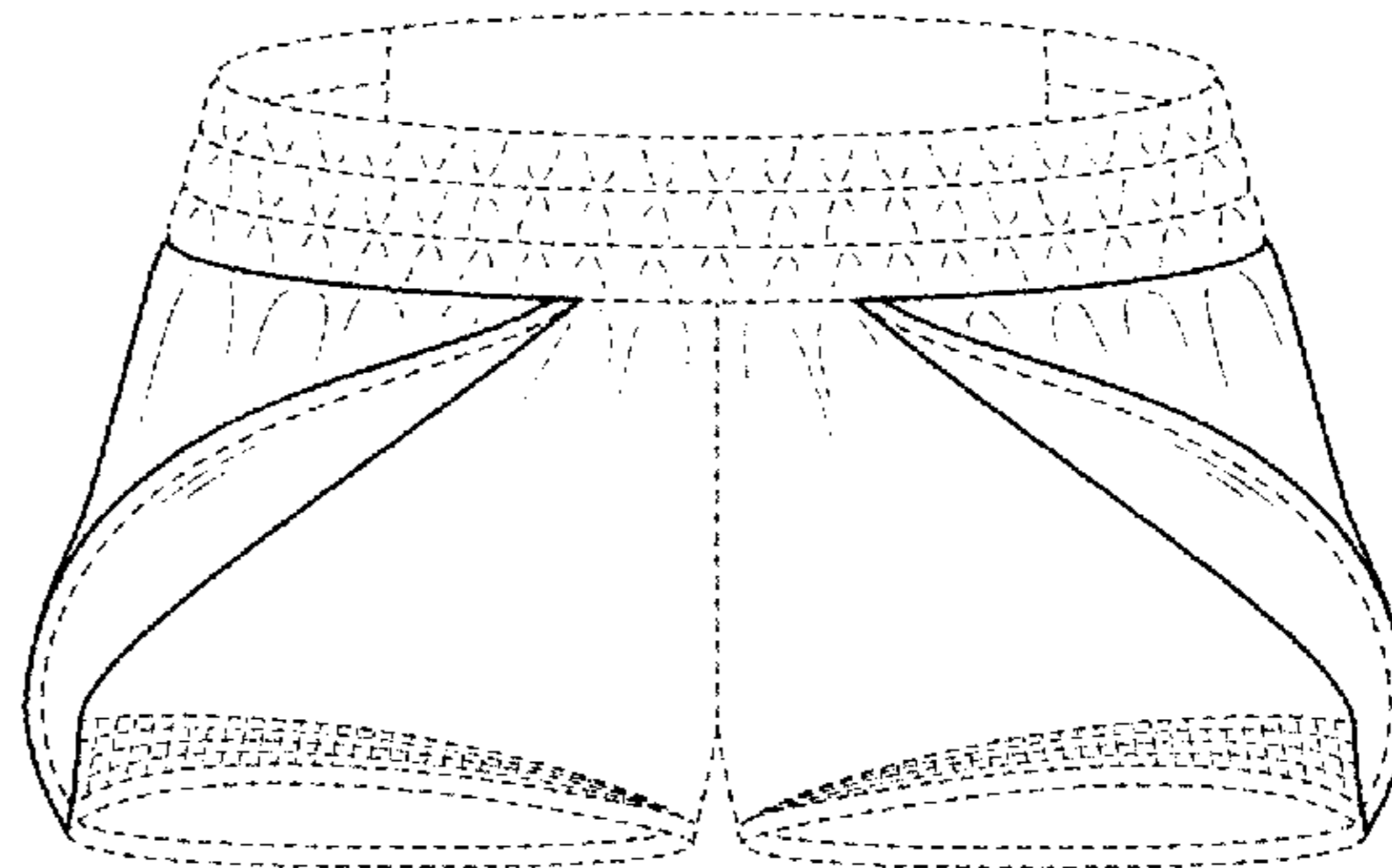
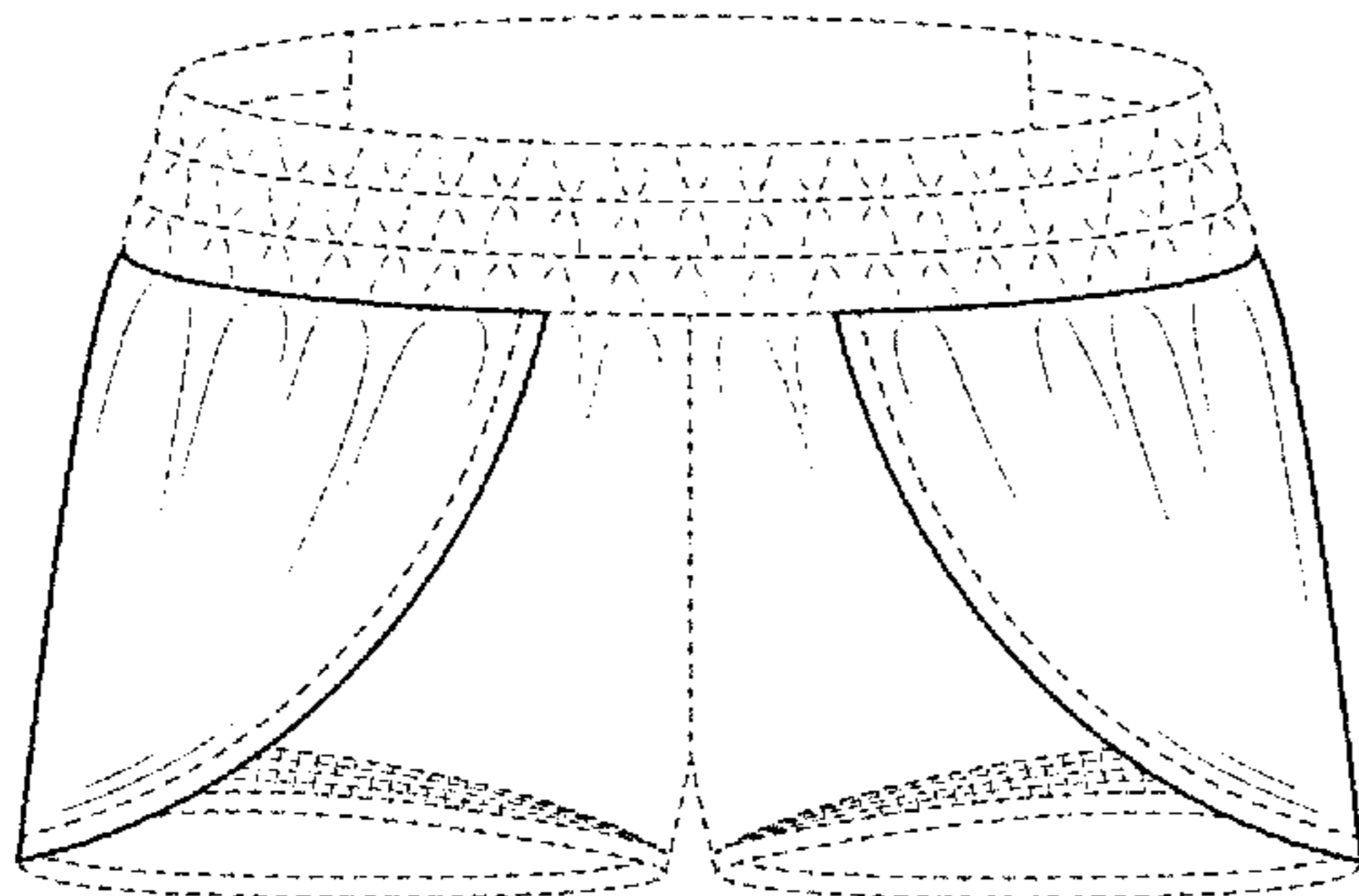
(57) **CLAIM**

The ornamental design for shorts, as shown and described.

DESCRIPTION

FIG. 1 is a front view of shorts showing my new design;
 FIG. 2 is a rear view thereof;
 FIG. 3 is a right side view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a front perspective view thereof;
 FIG. 6 is a rear perspective view thereof;
 FIG. 7 is a front view thereof shown in an environment of use; and,
 FIG. 8 is a front view thereof with side panels thereof shown in an opened position.
 The portions of the shorts shown in broken lines in FIGS. 1-8 do not form part of the claimed design. The broken line showing of the hands, arms, legs, and torso in FIG. 7 is for the purpose of illustrating portions of the environmental structure and forms no part of the claimed design. As shown in FIG. 8, the side panels of the shorts are not bonded to the front panels of the shorts along the outer edges of the side panels.

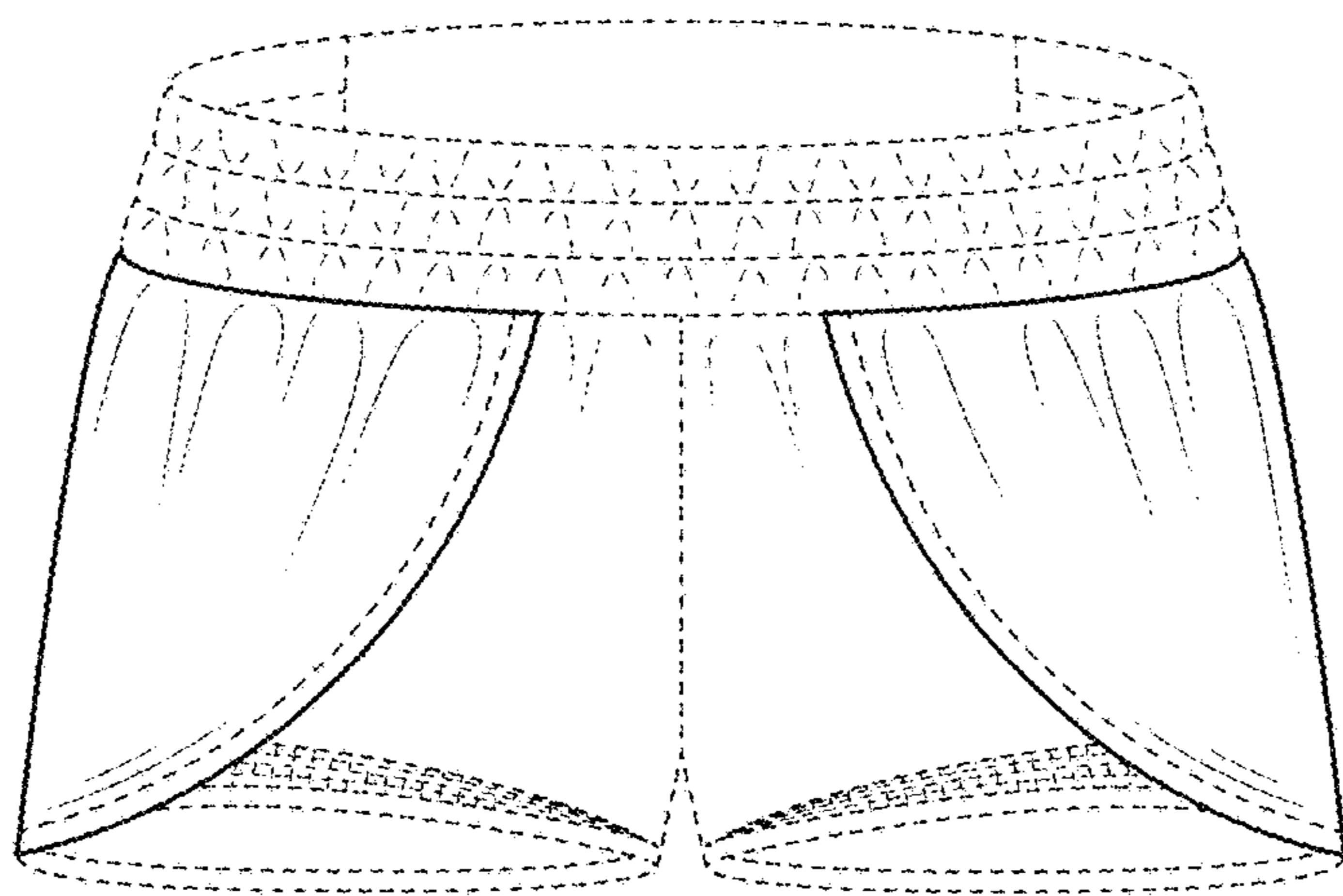

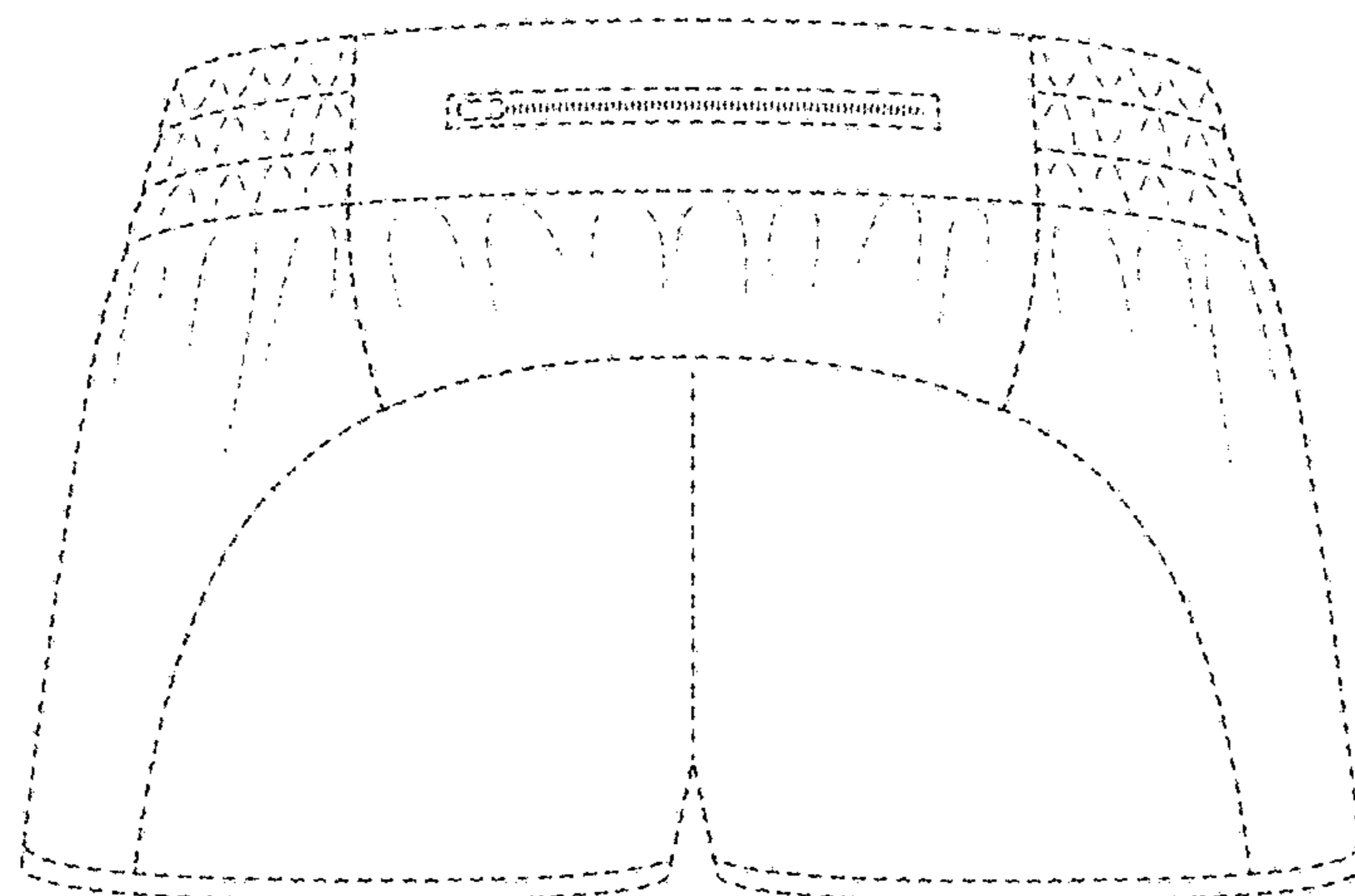

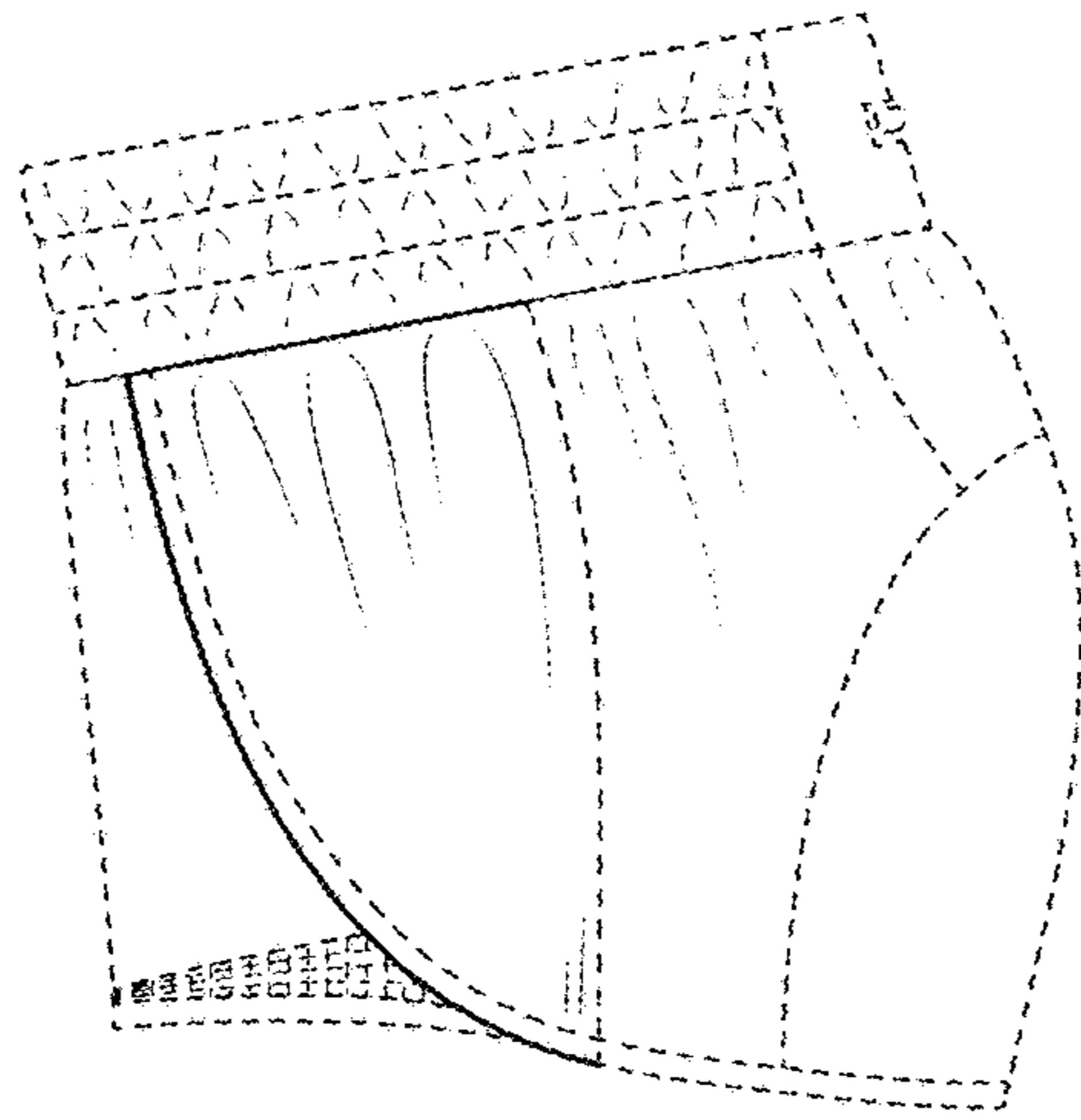

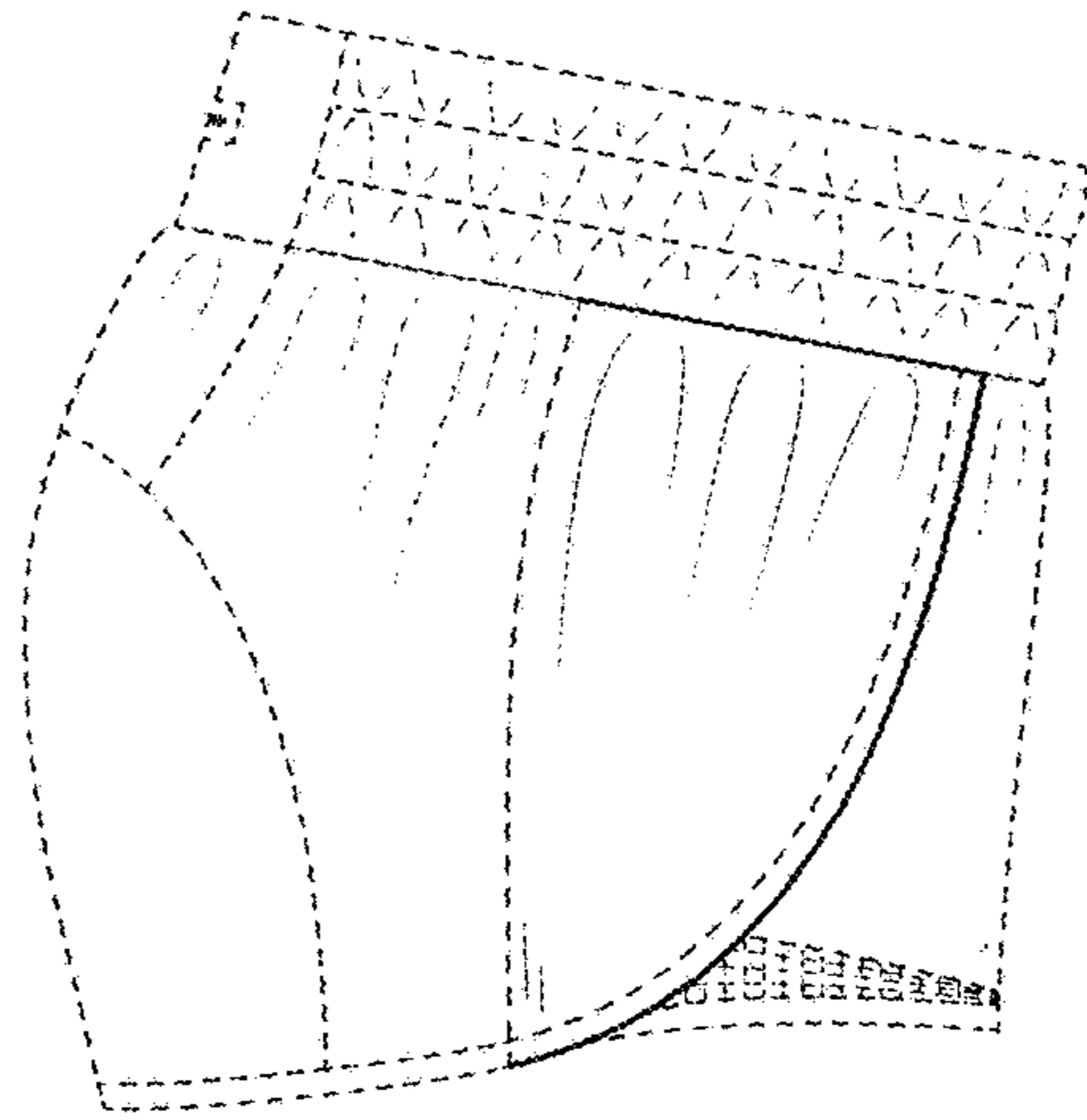

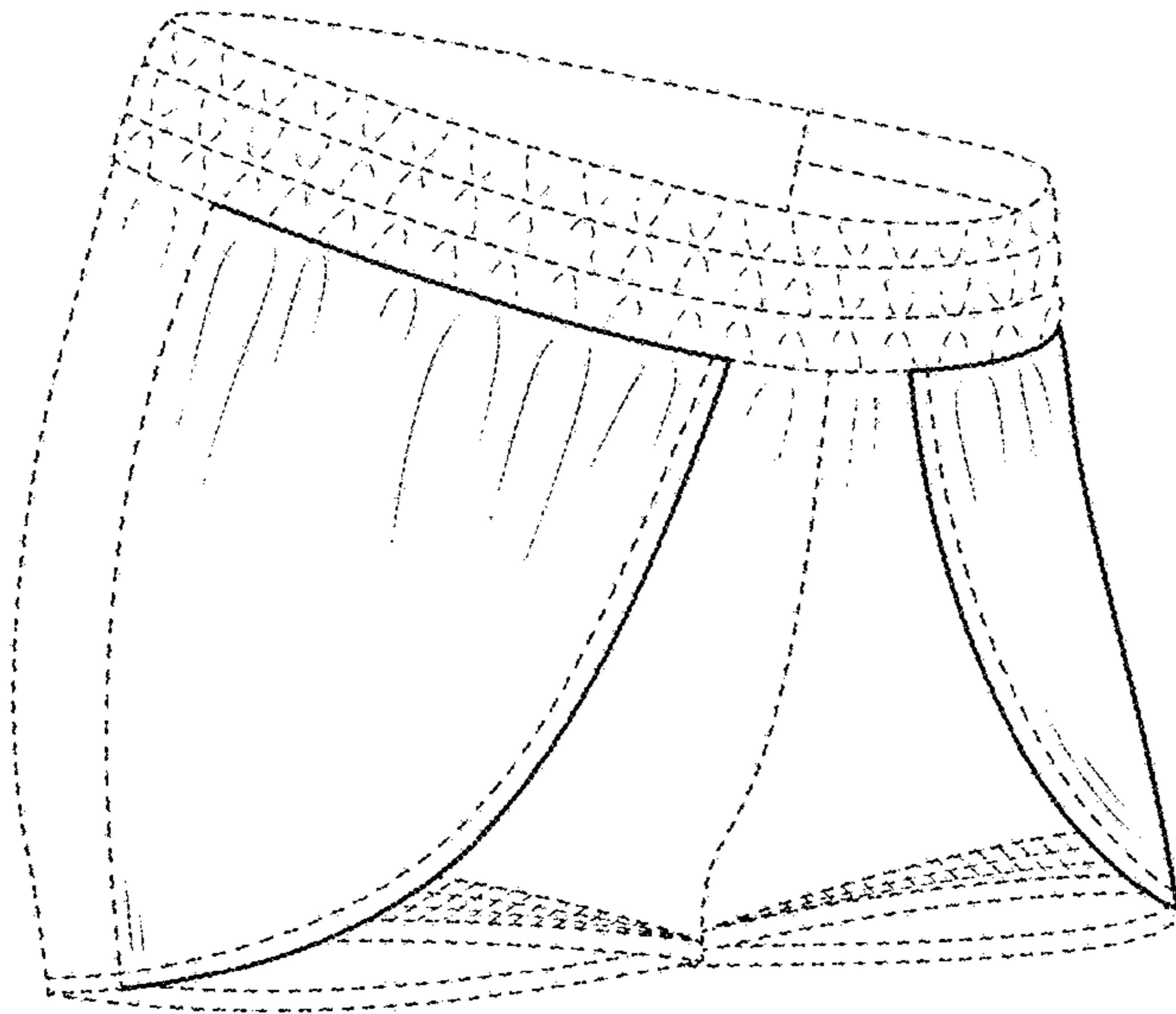

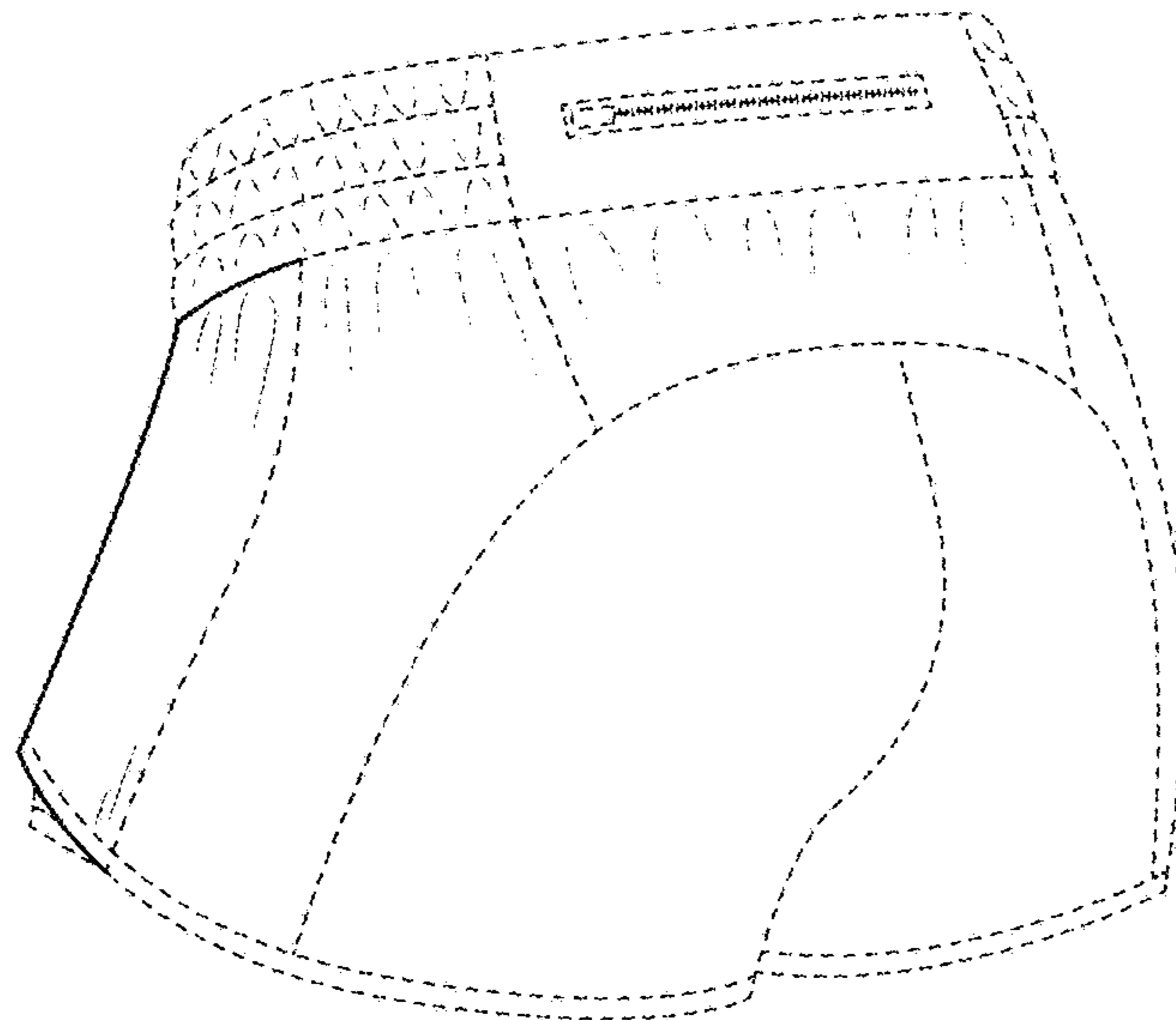

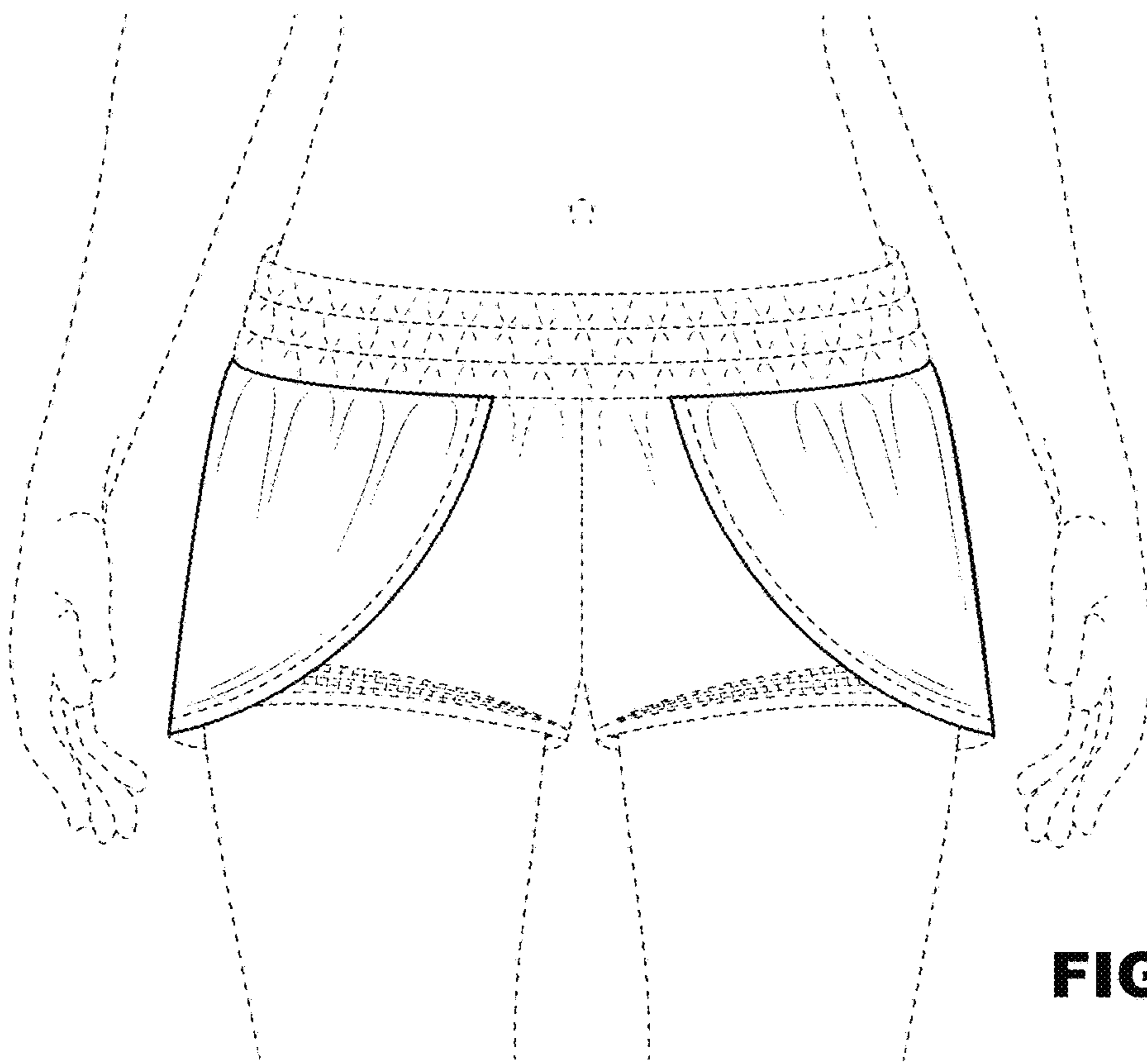

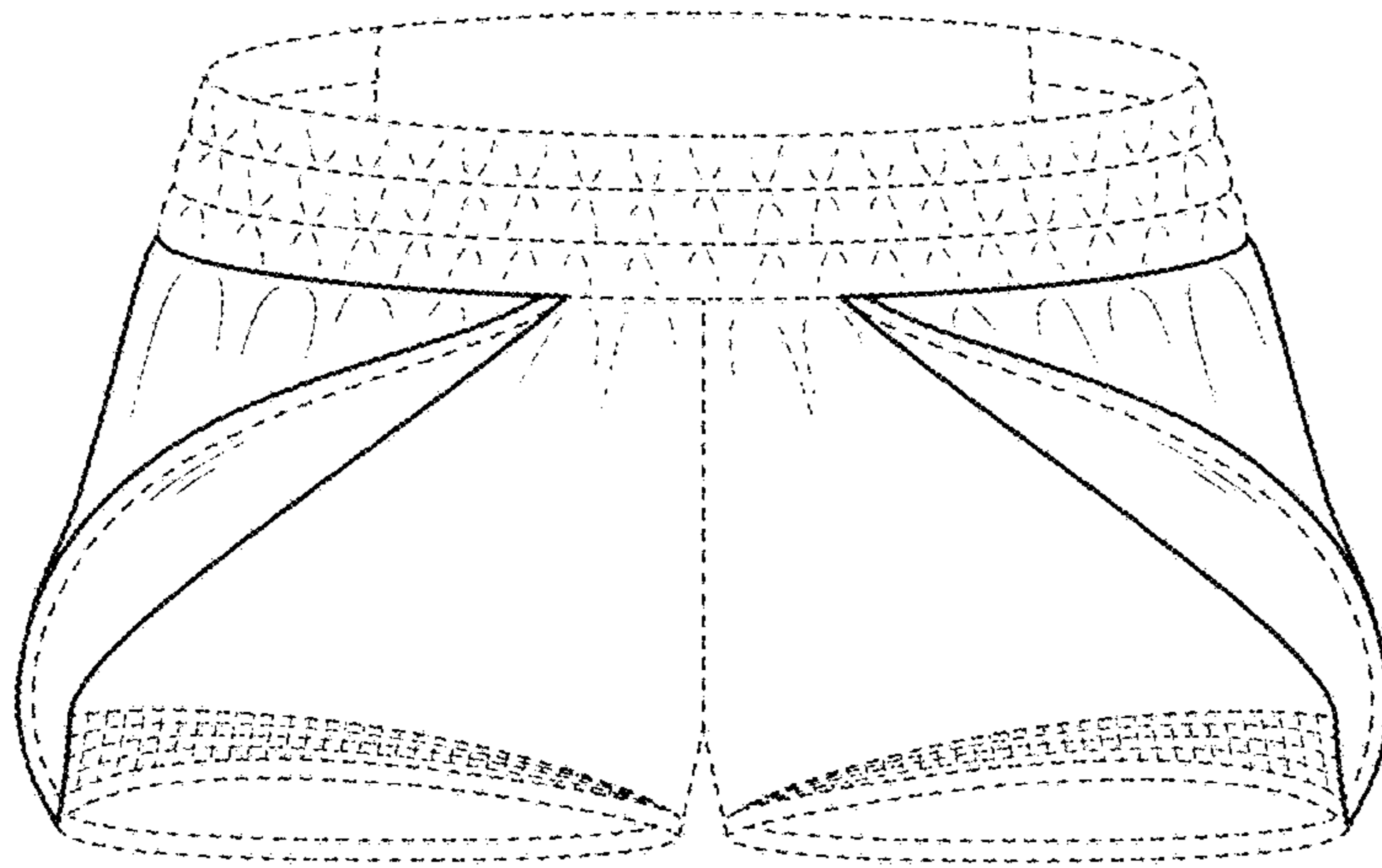
