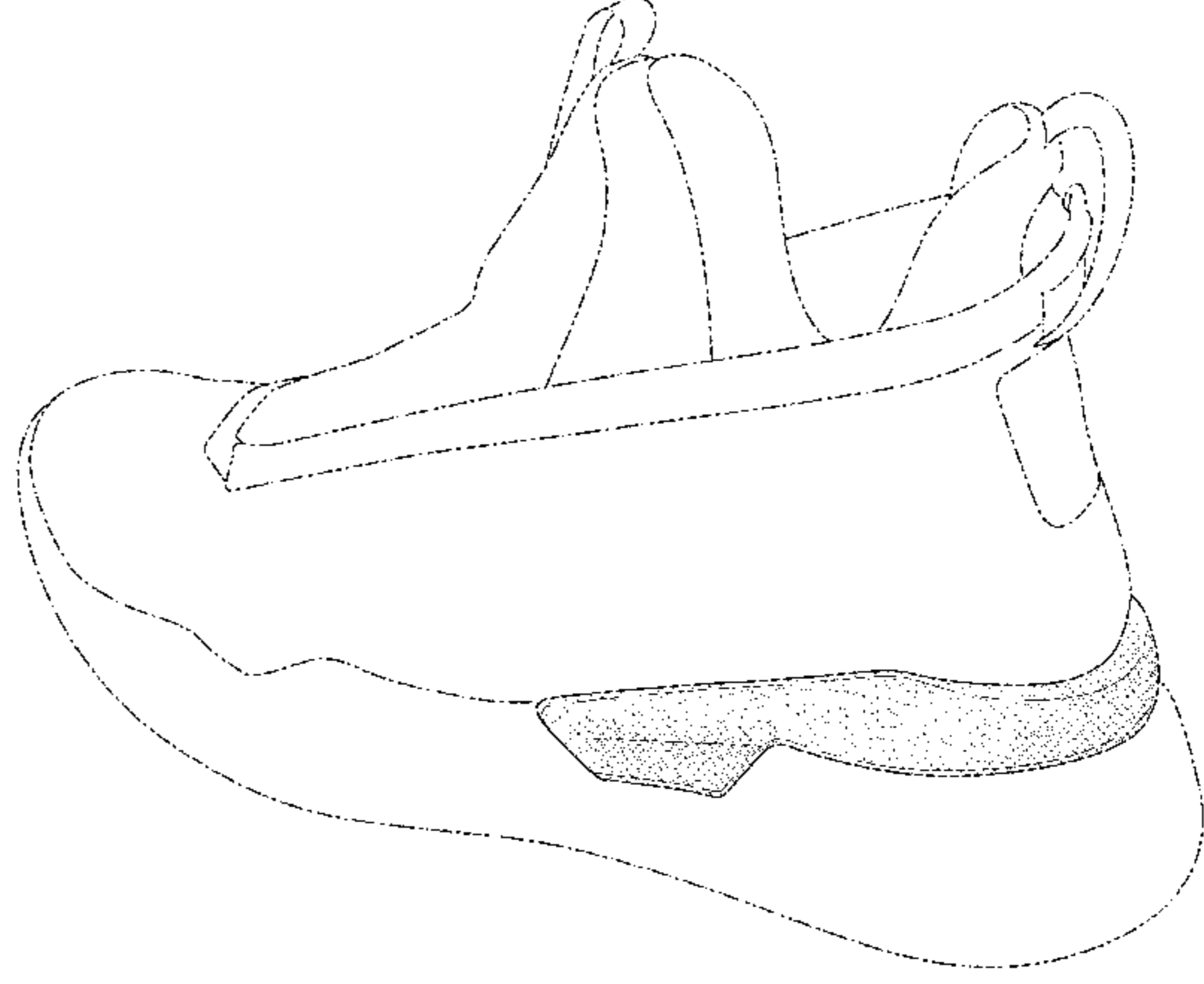
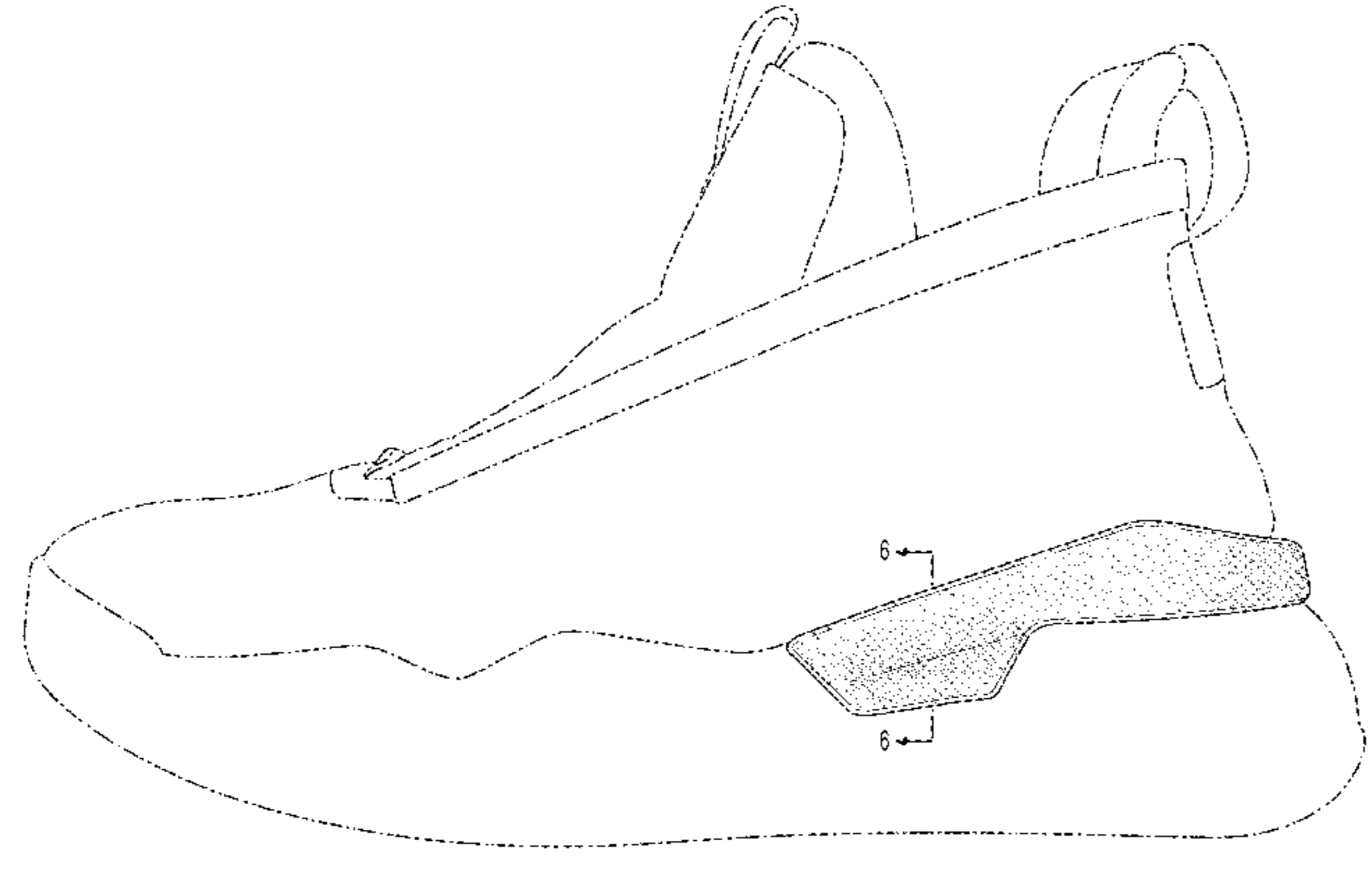

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a side view of a shoe showing my new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a rear view thereof; FIG. 4 is an opposite rear perspective view thereof; FIG. 5 is an opposite side view thereof; and, FIG. 6 is a cross section taken through line 6-6 of FIG. 1. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

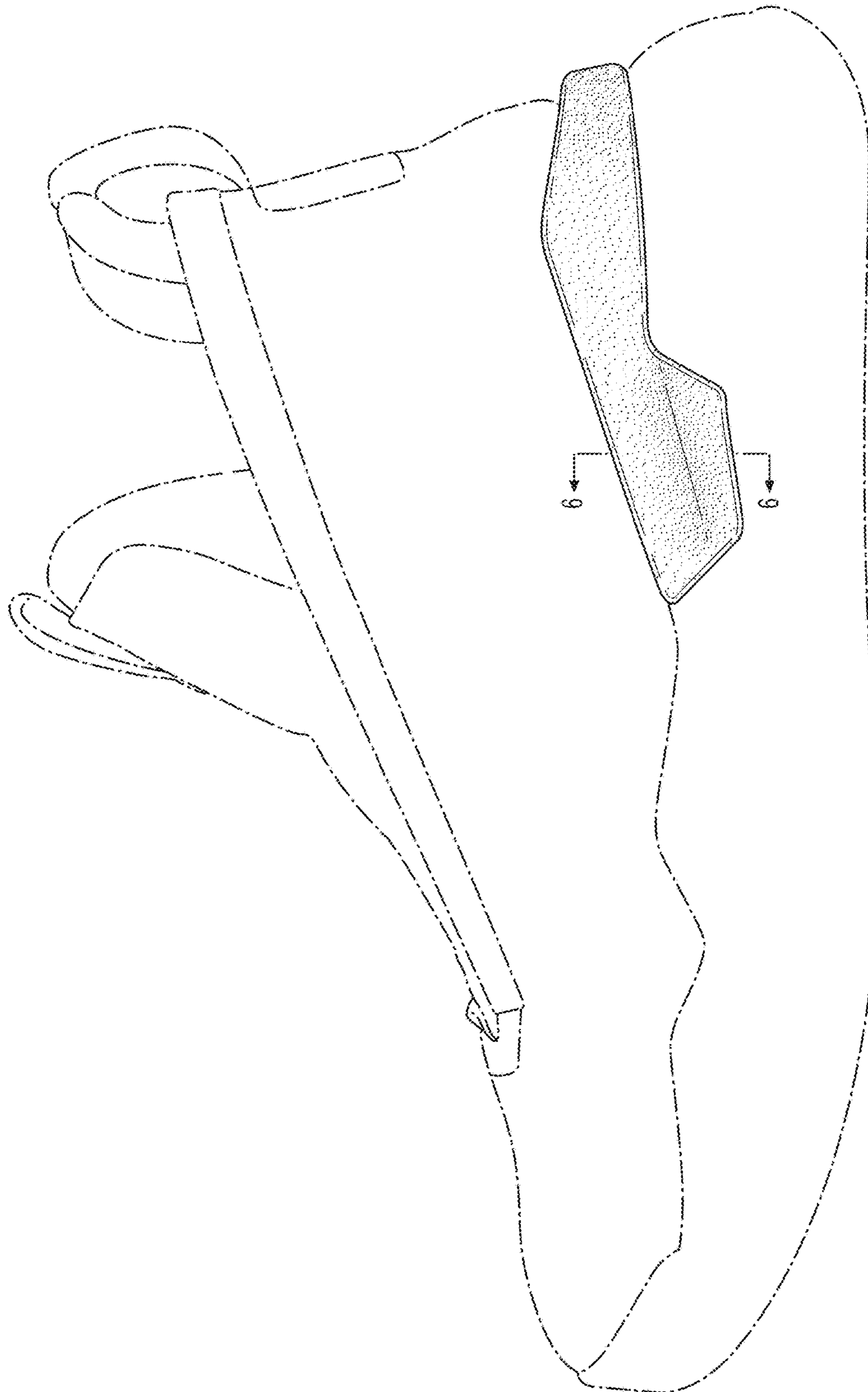

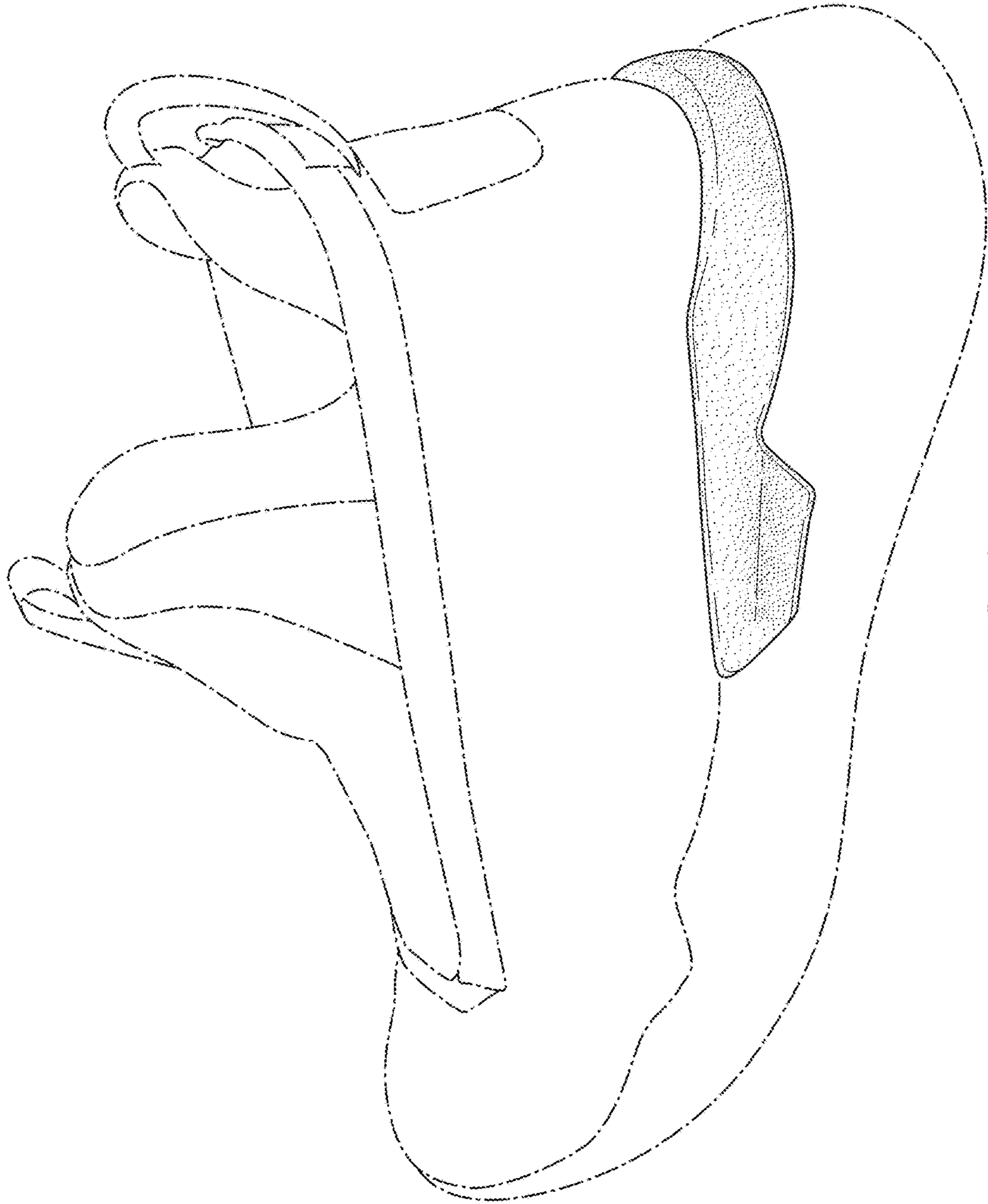

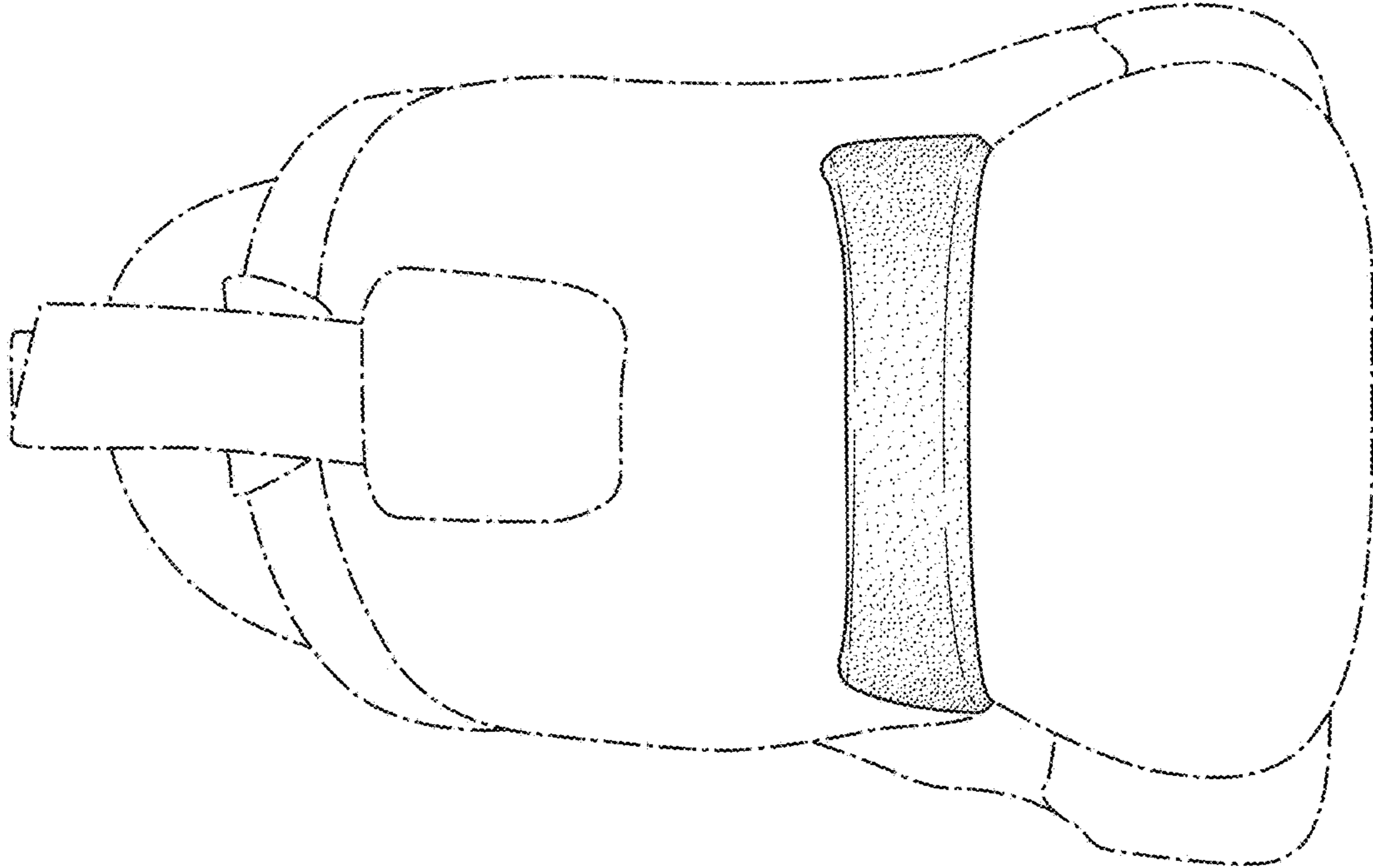

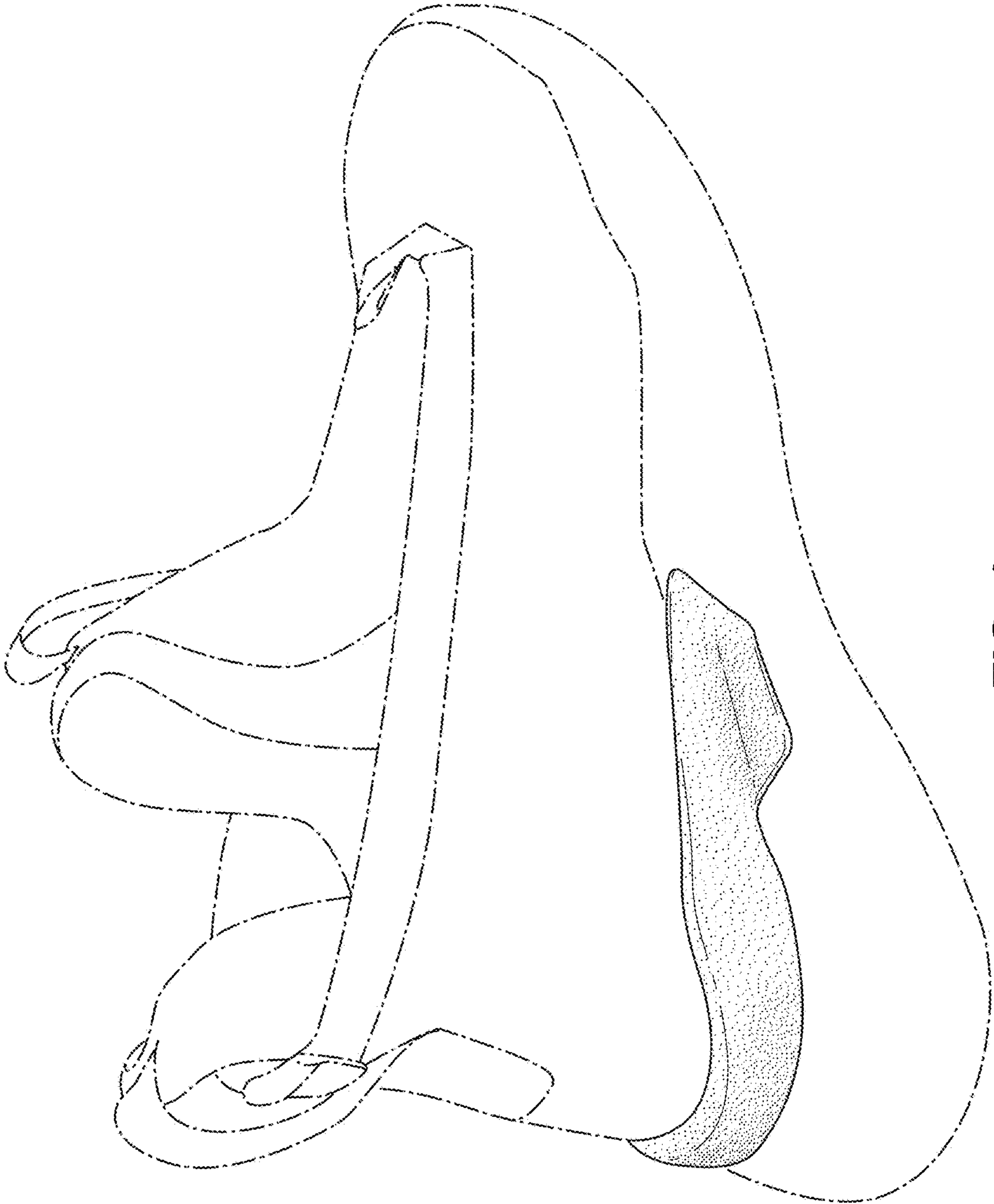

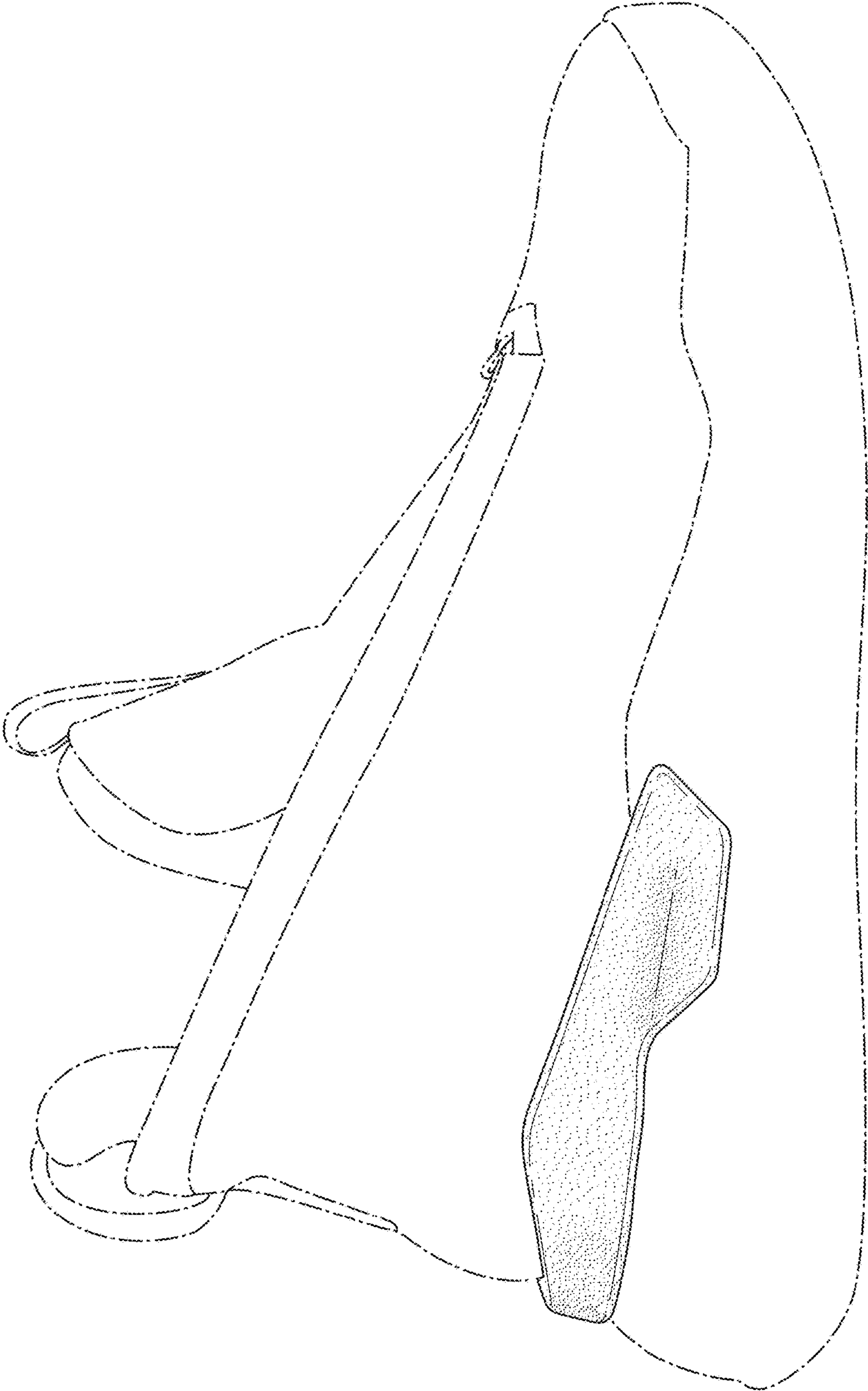
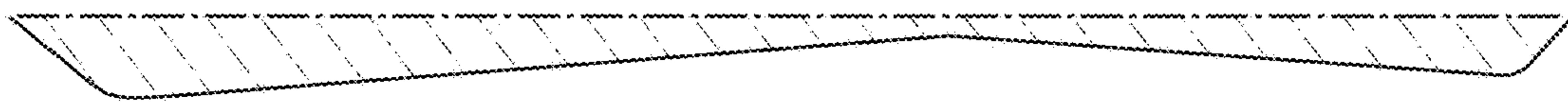
