The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe upper showing our new design;

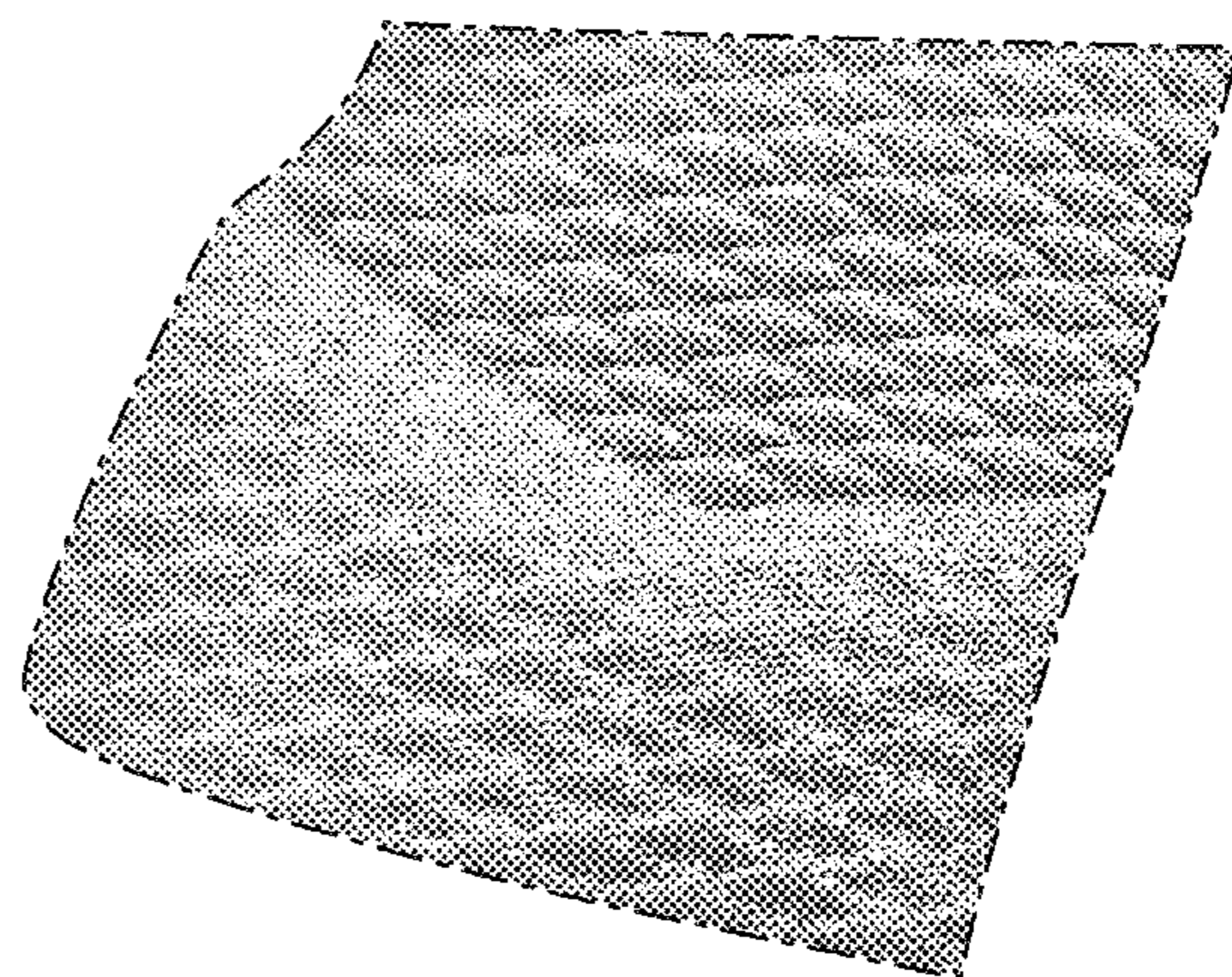
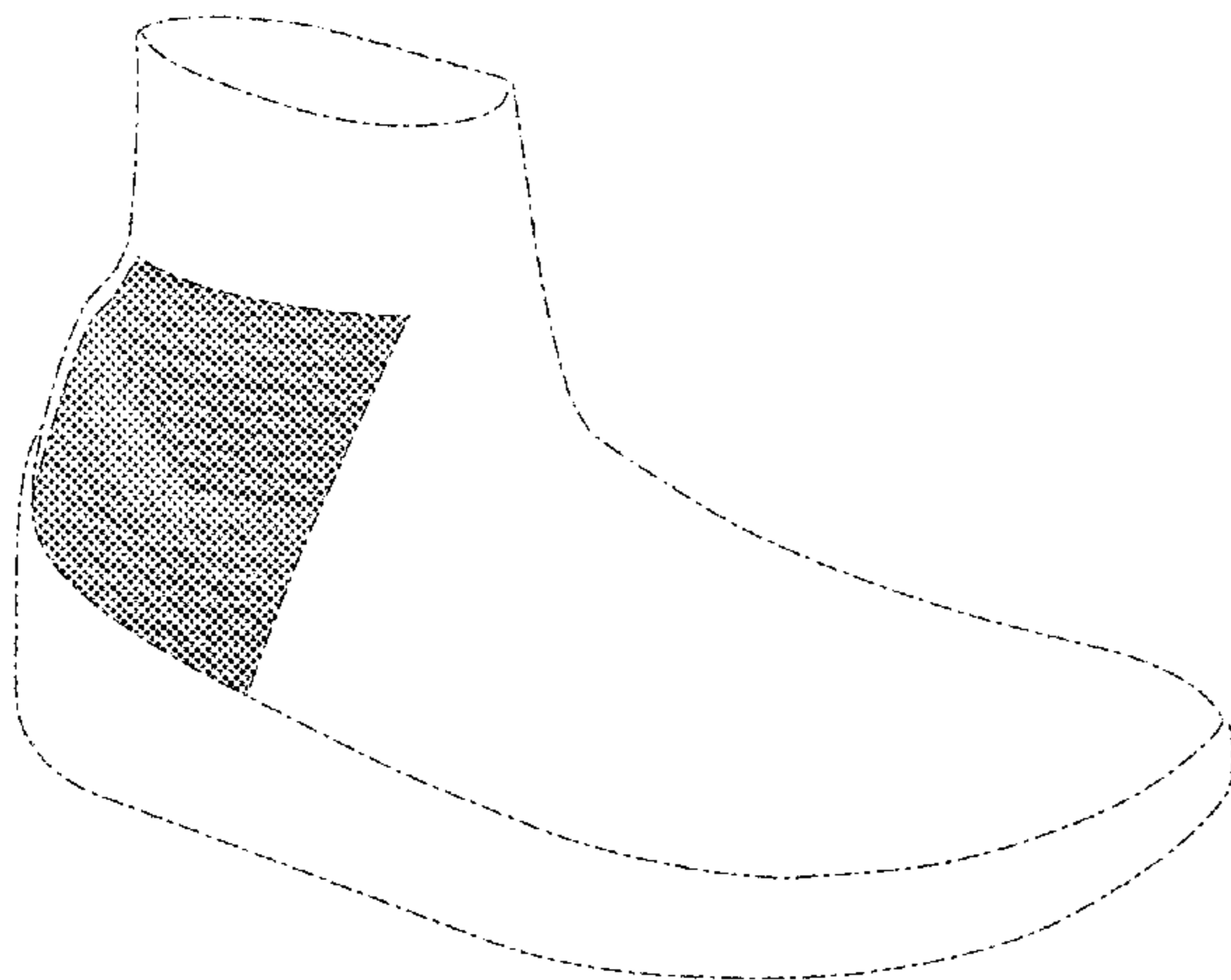
FIG. 2 is a side view thereof;

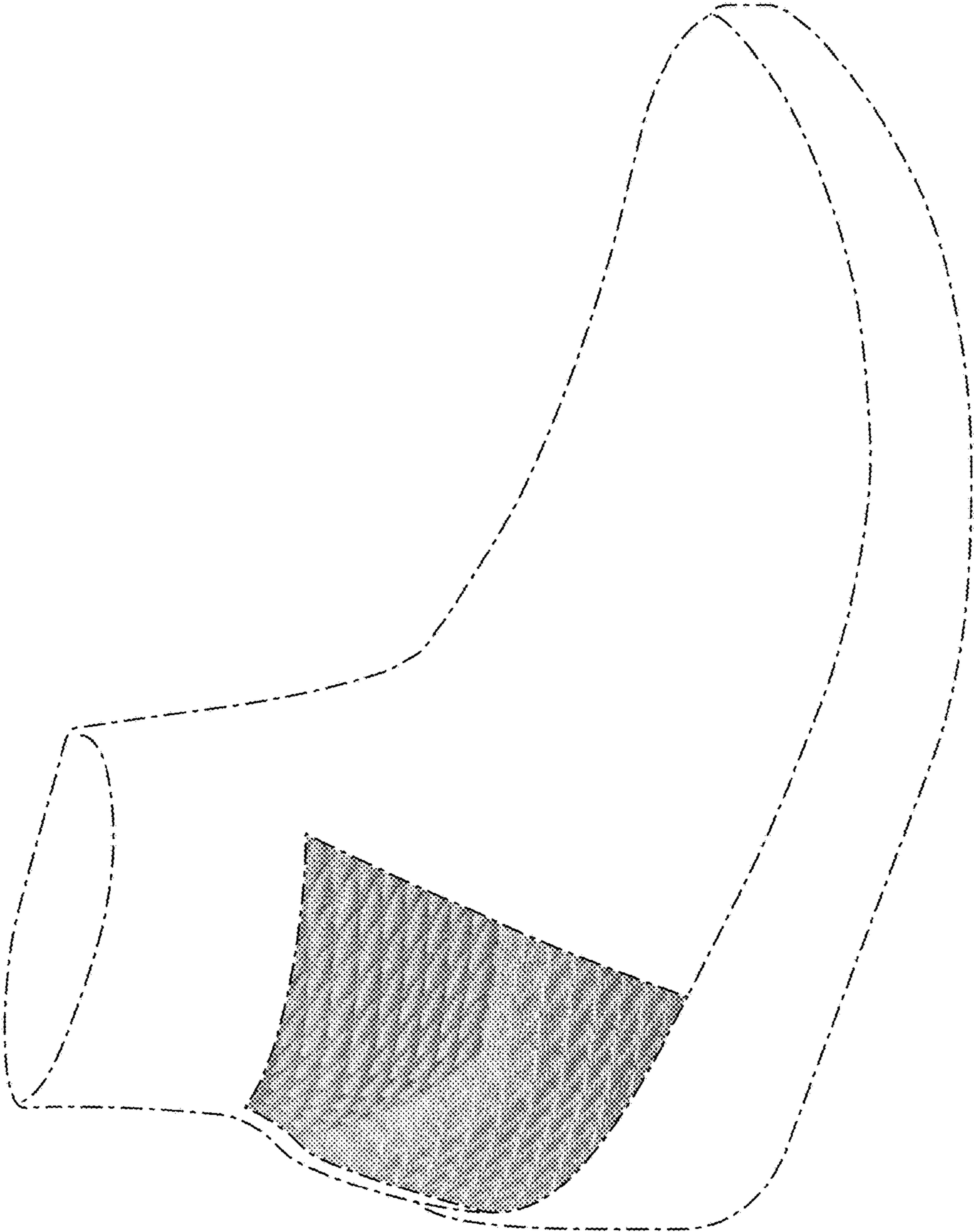

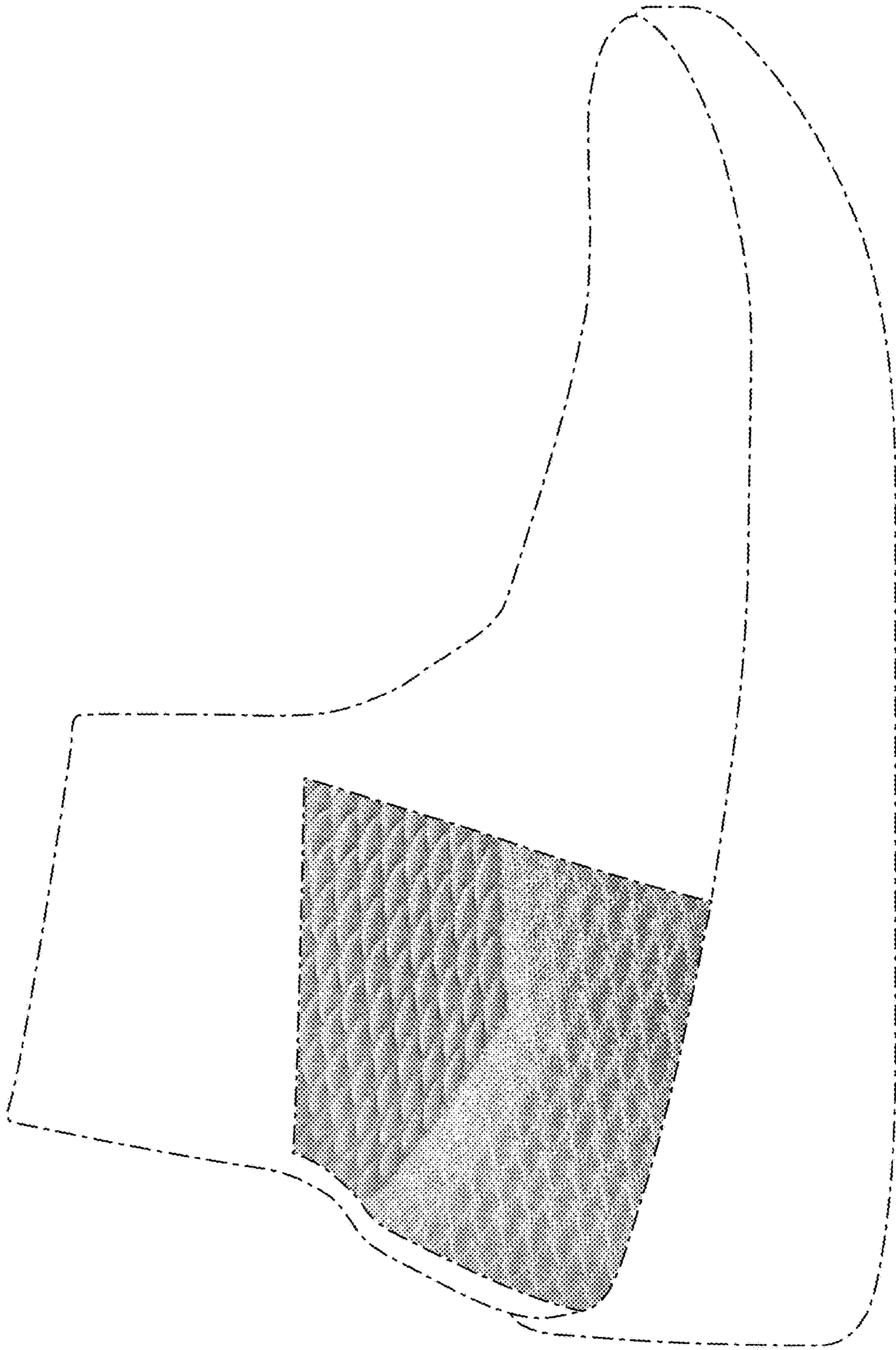

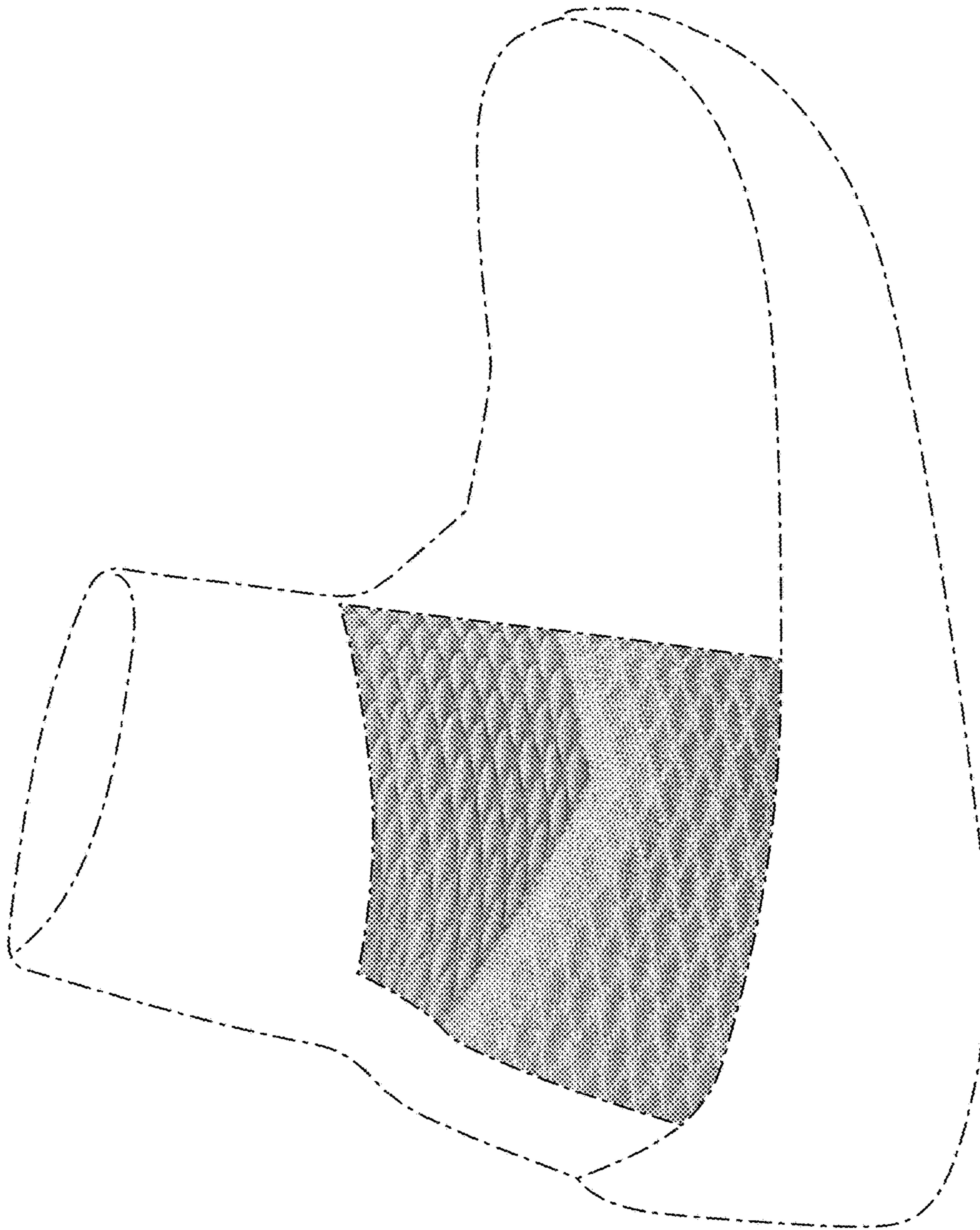

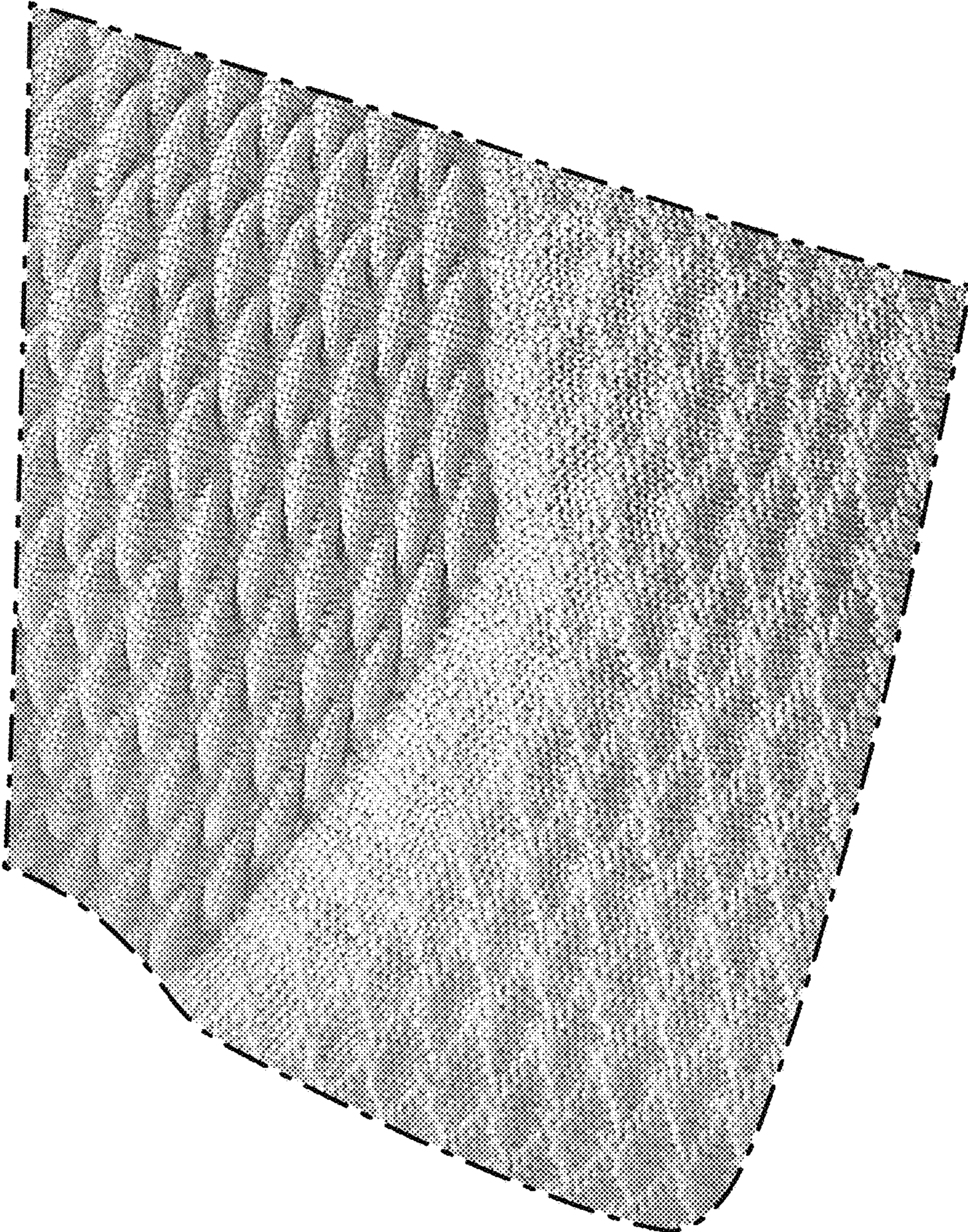
