FIG. 4 is an opposite side rear perspective view thereof;

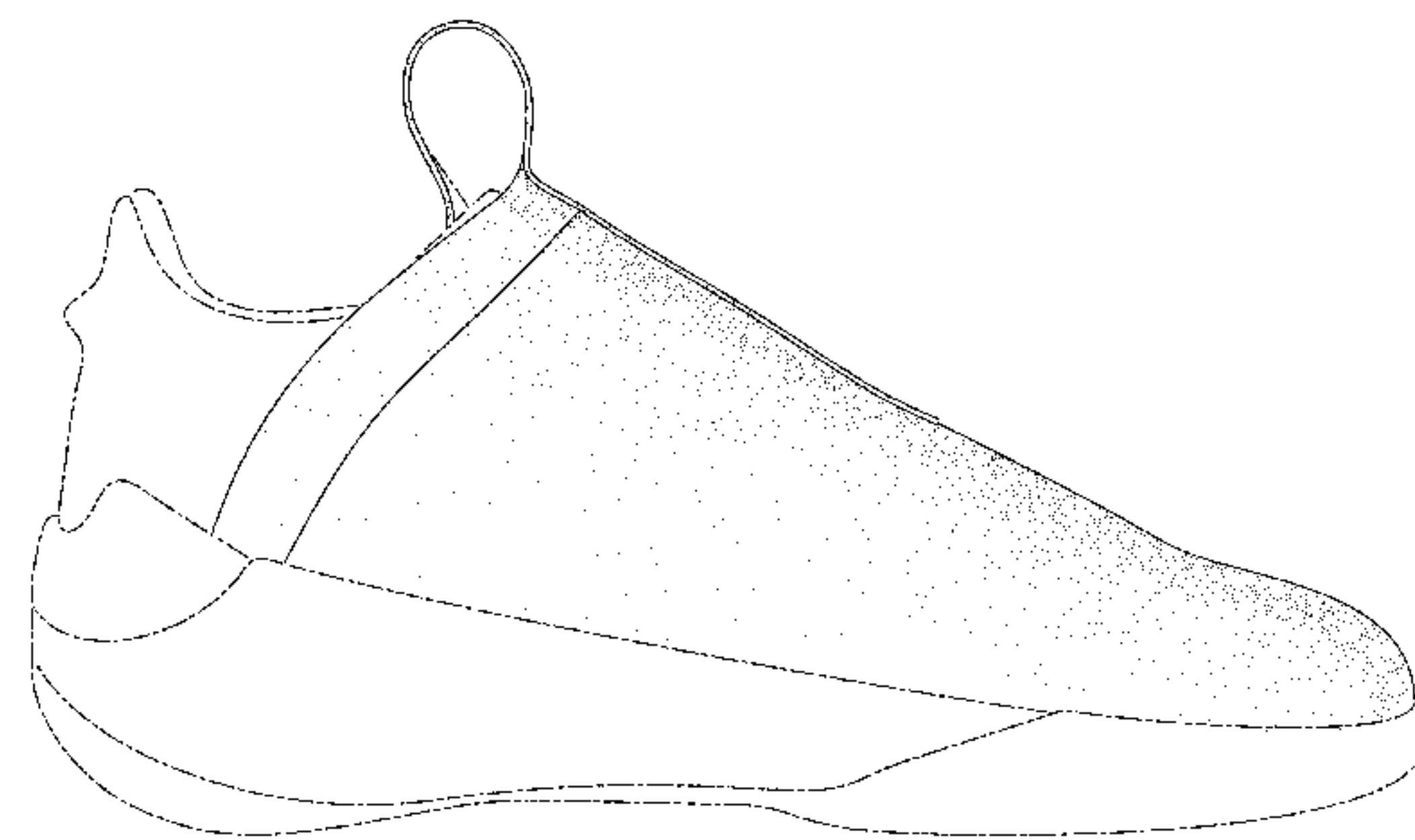
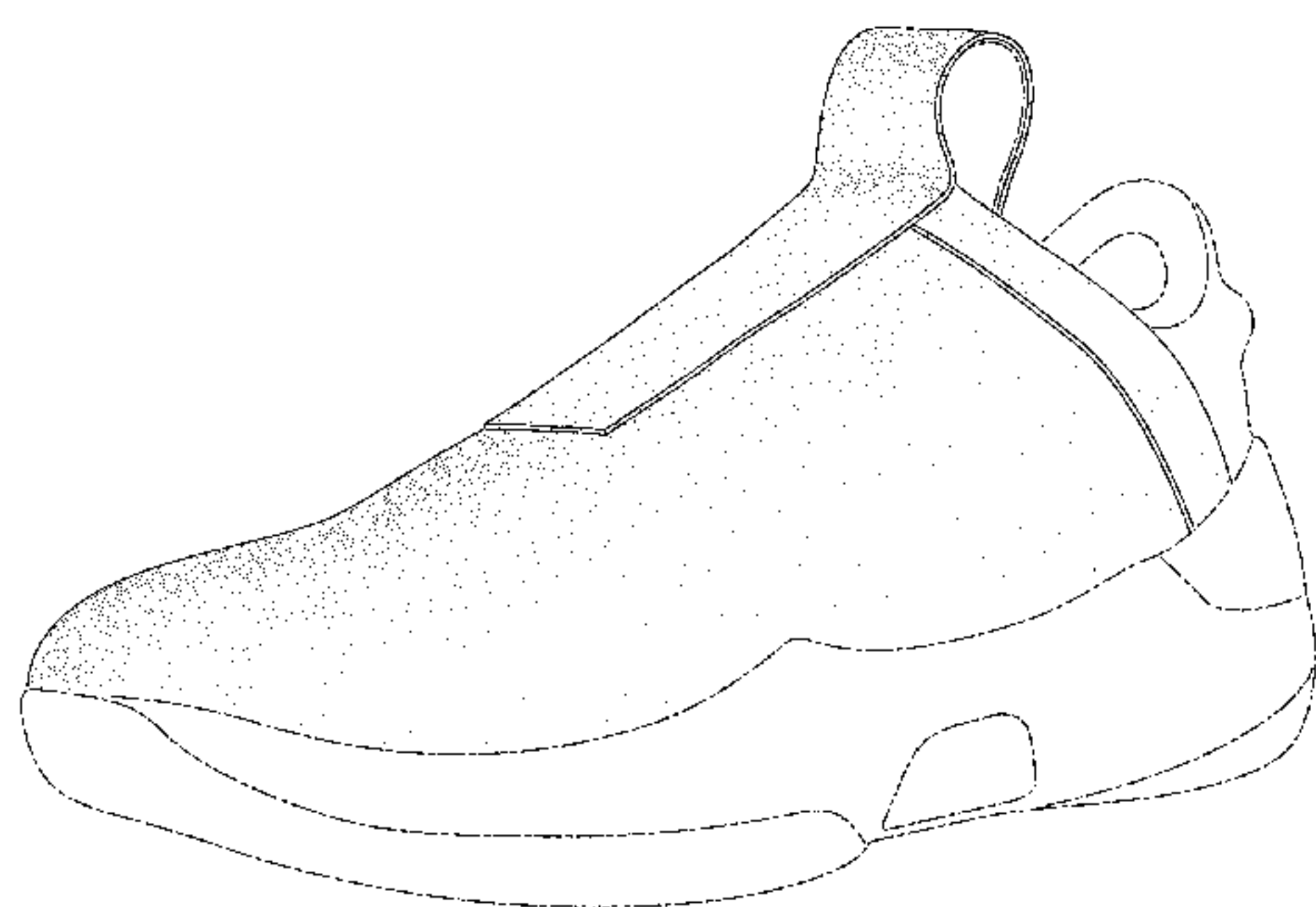
FIG. 5 is an opposite side view thereof;

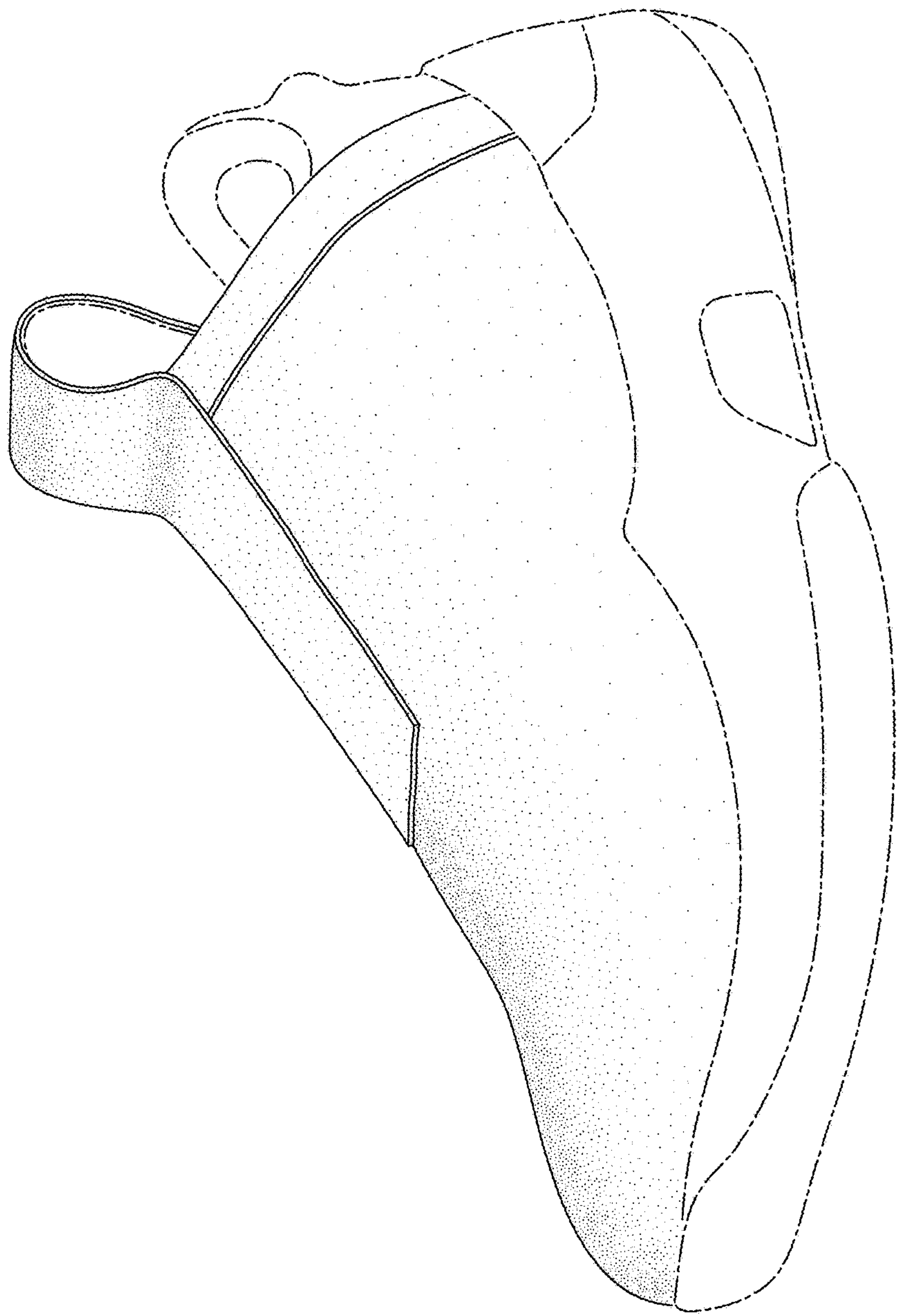

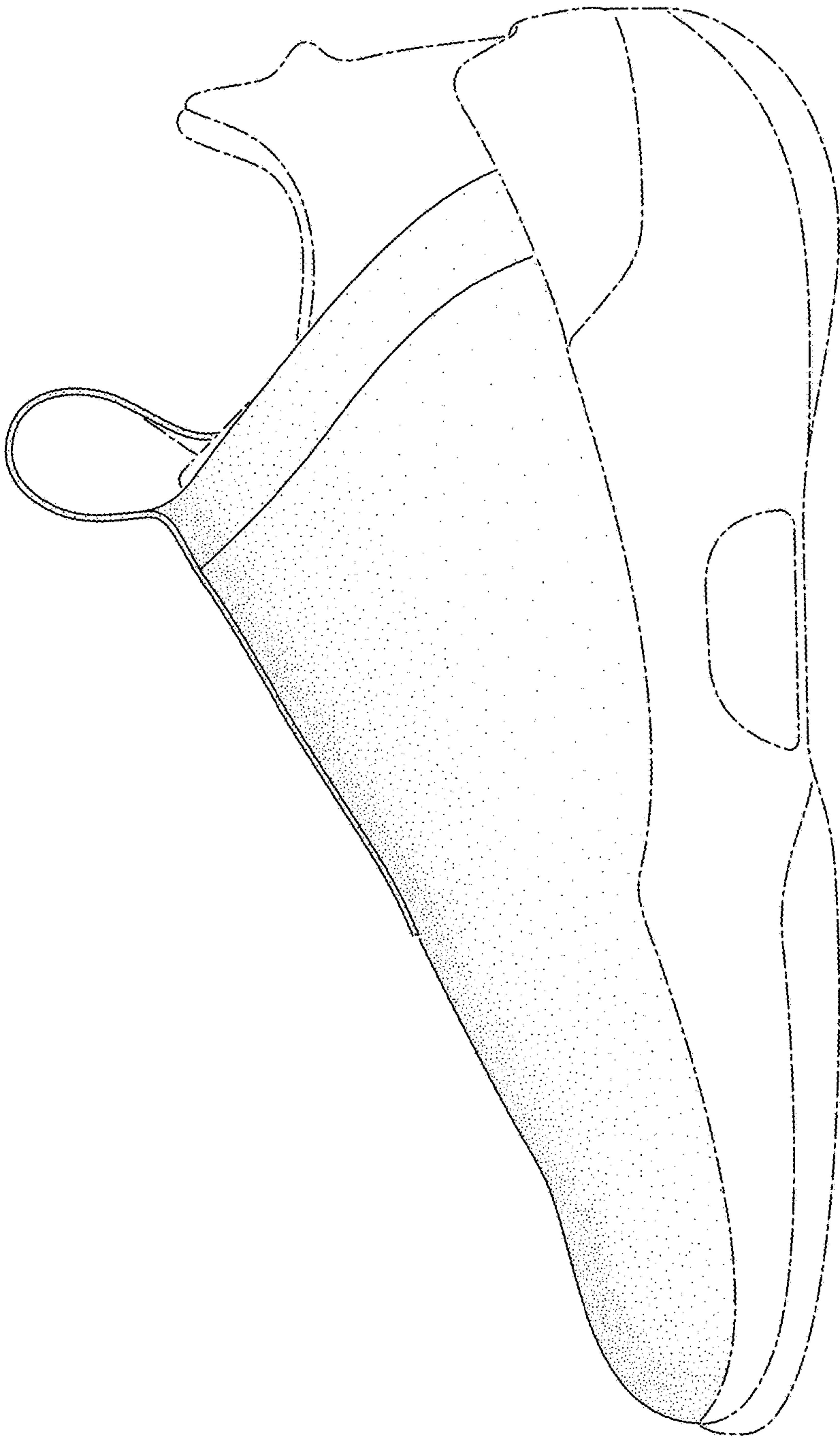

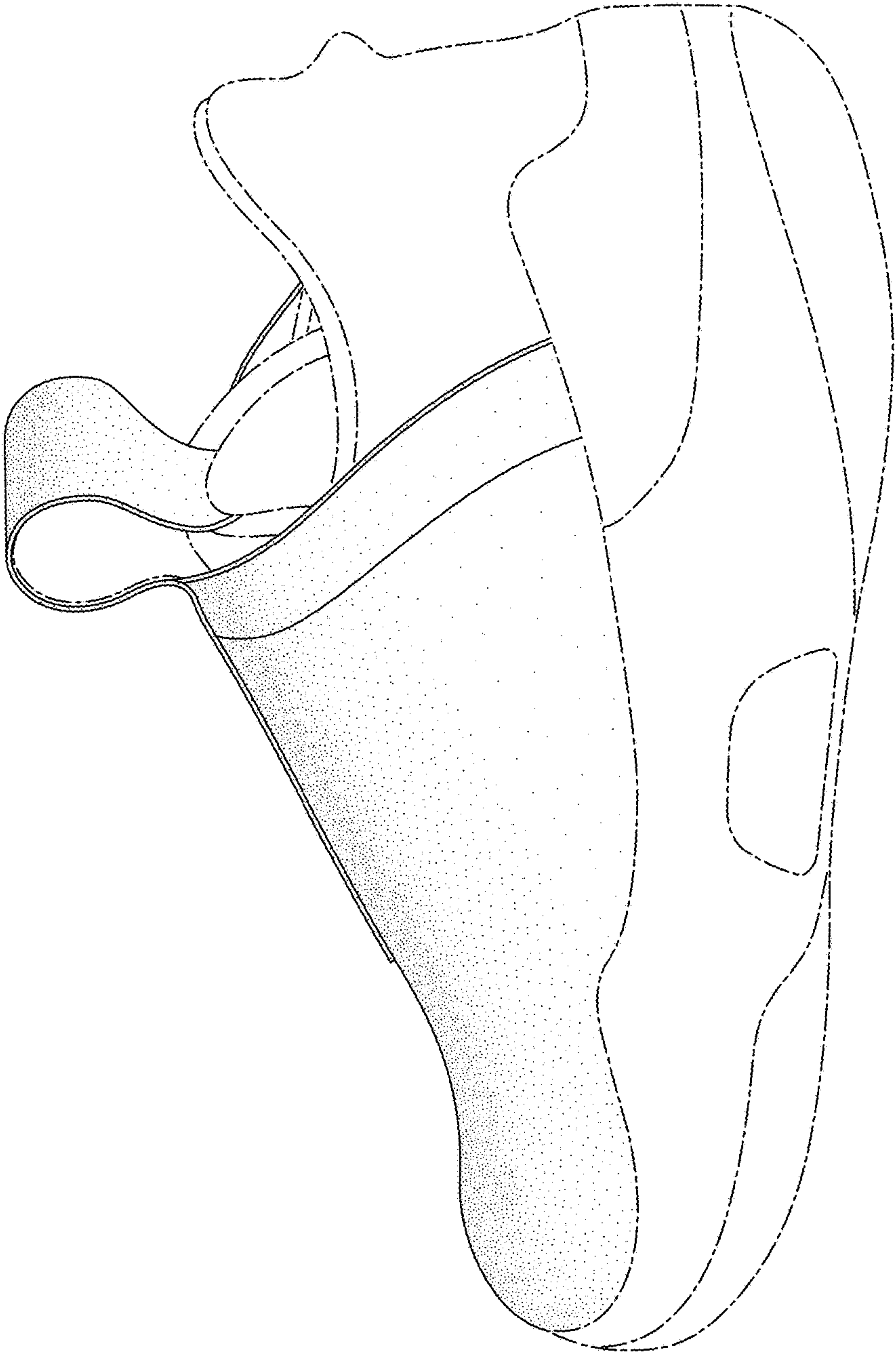

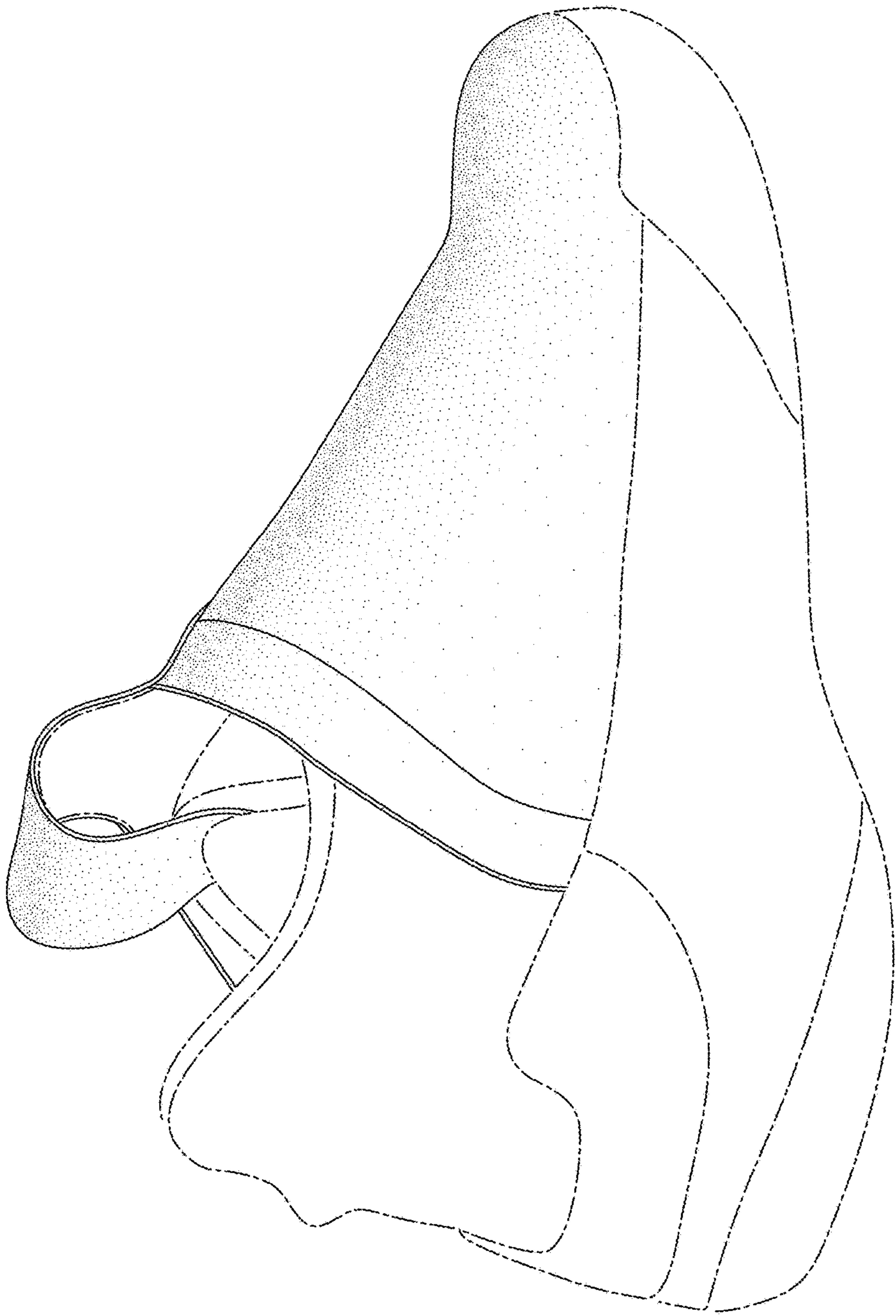

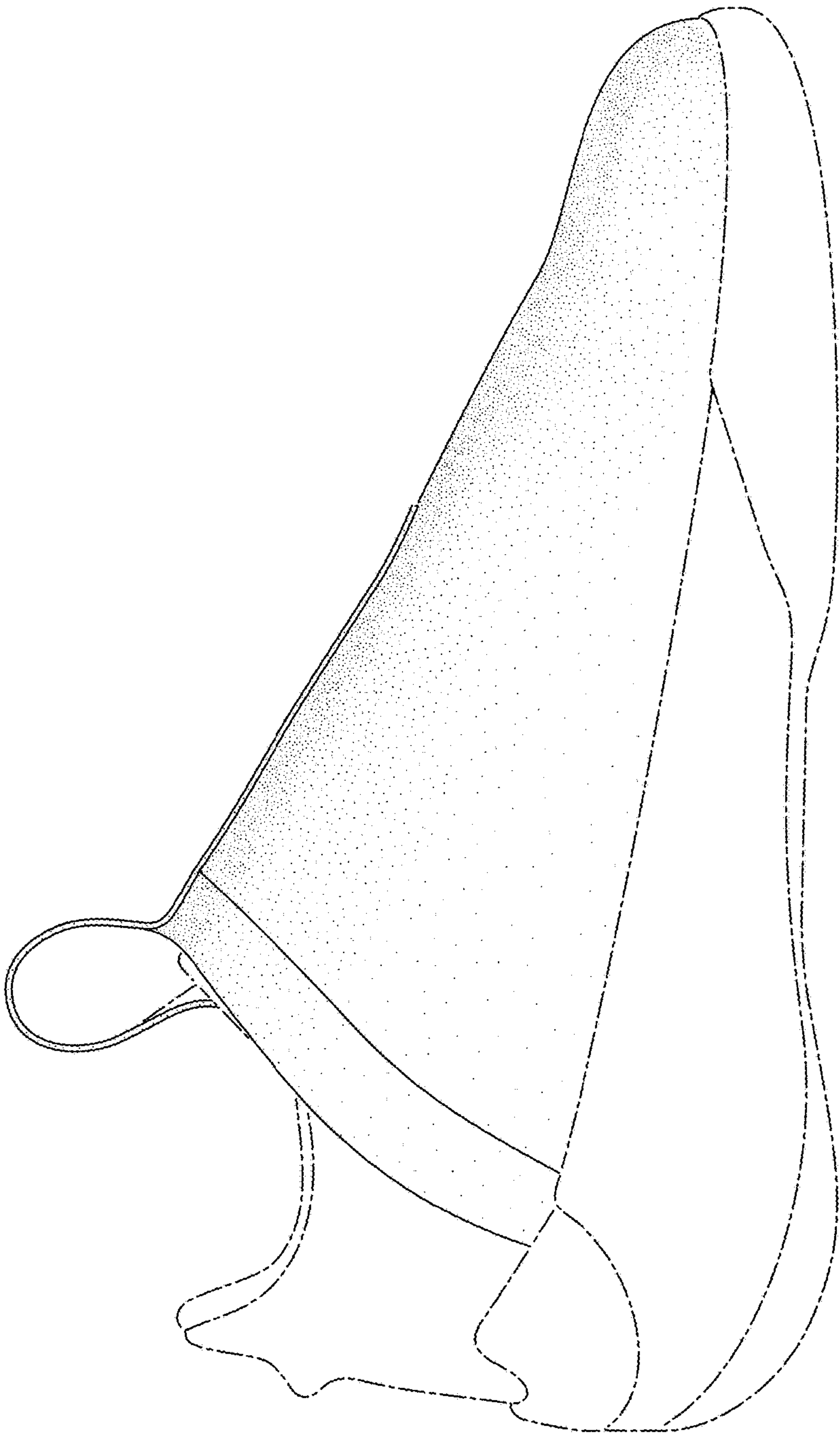

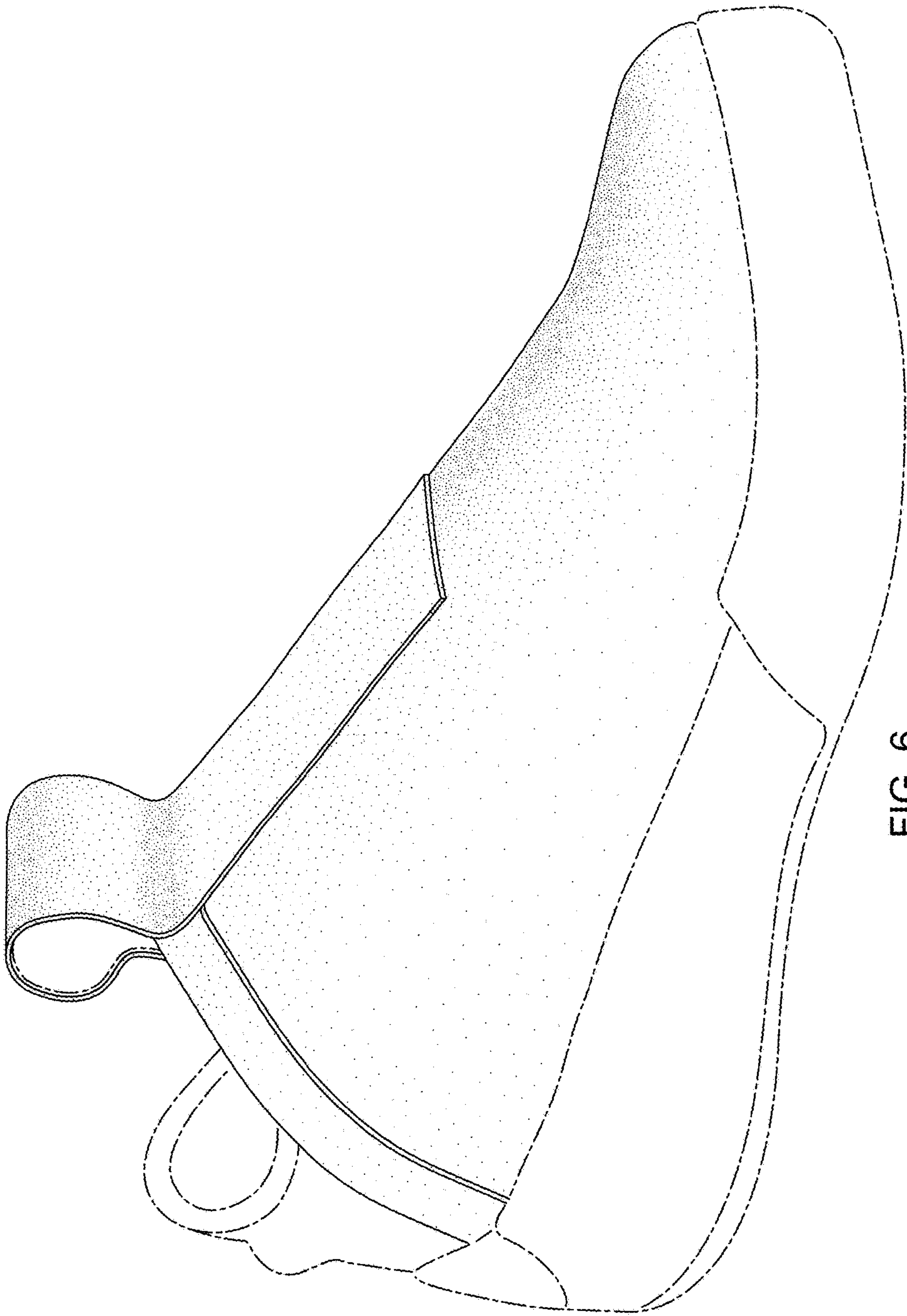

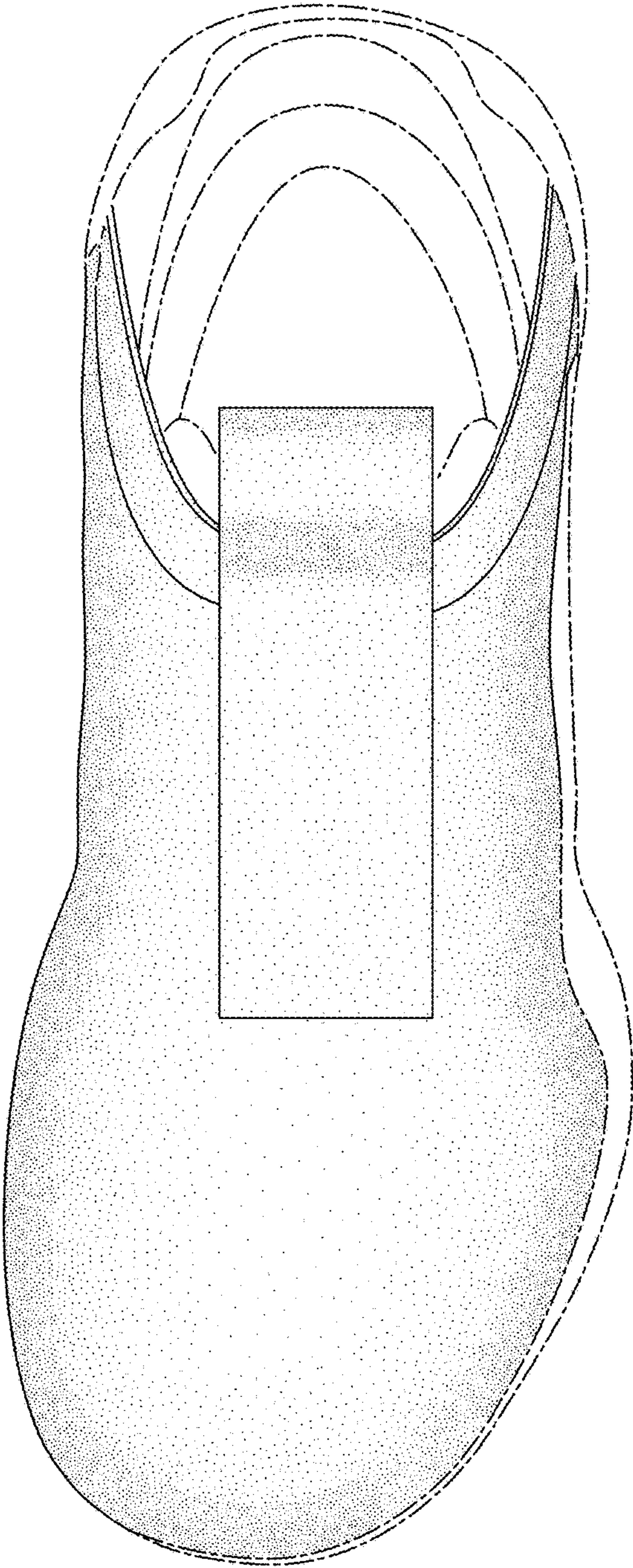
