(57) **CLAIM**

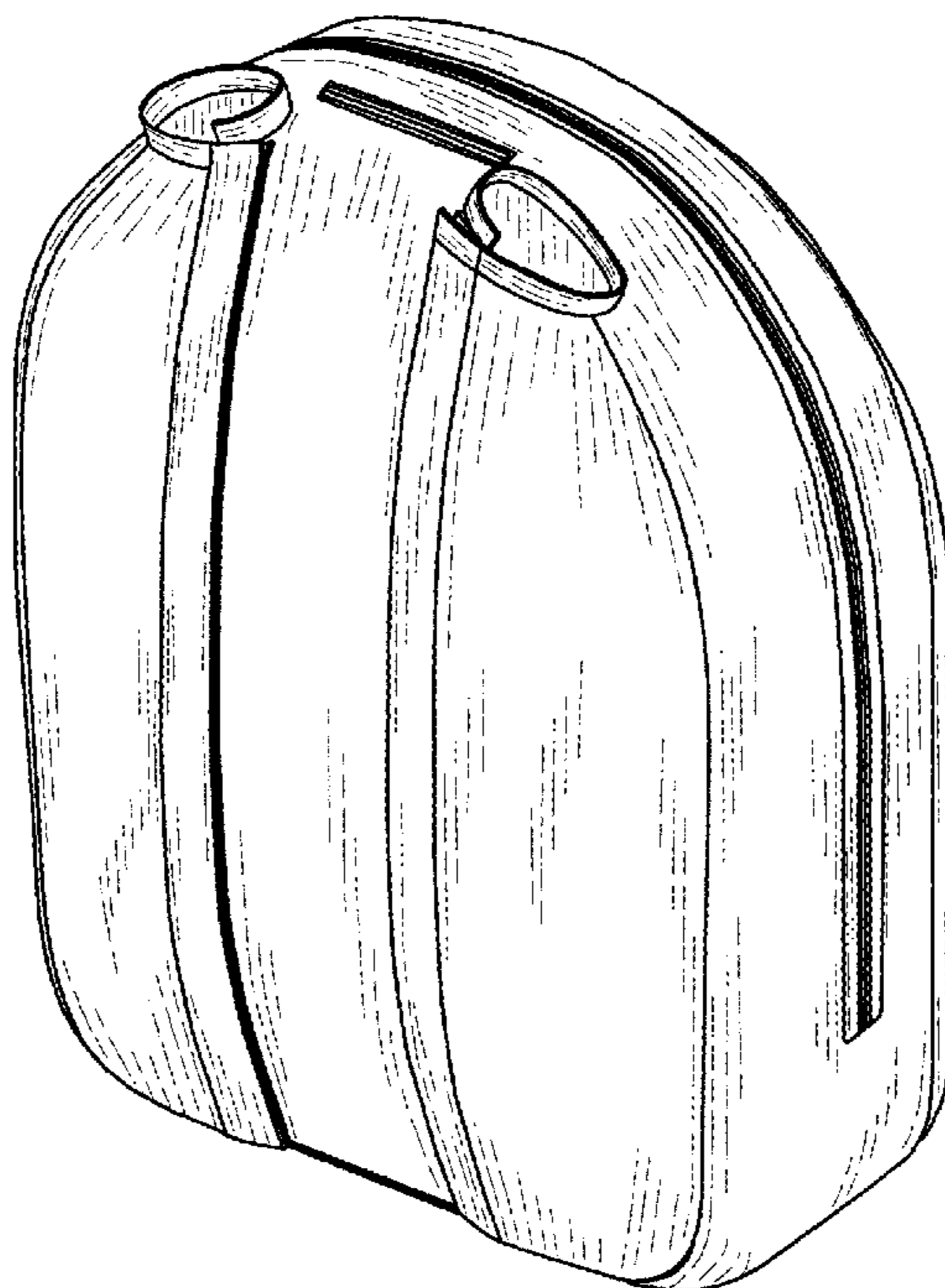
The ornamental design for a rain bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a rain bag;

 able hood deployed and a pair of flaps opened to reveal a
 plurality of hook and loop fasteners;
 FIG. 9 is a front elevational view thereof;

 FIG. 11 is a right side elevational view thereof;
 FIG. 12 is a left side elevational view thereof;
 FIG. 13 is a top plan view thereof; and,
 FIG. 14 is a bottom plan view thereof.

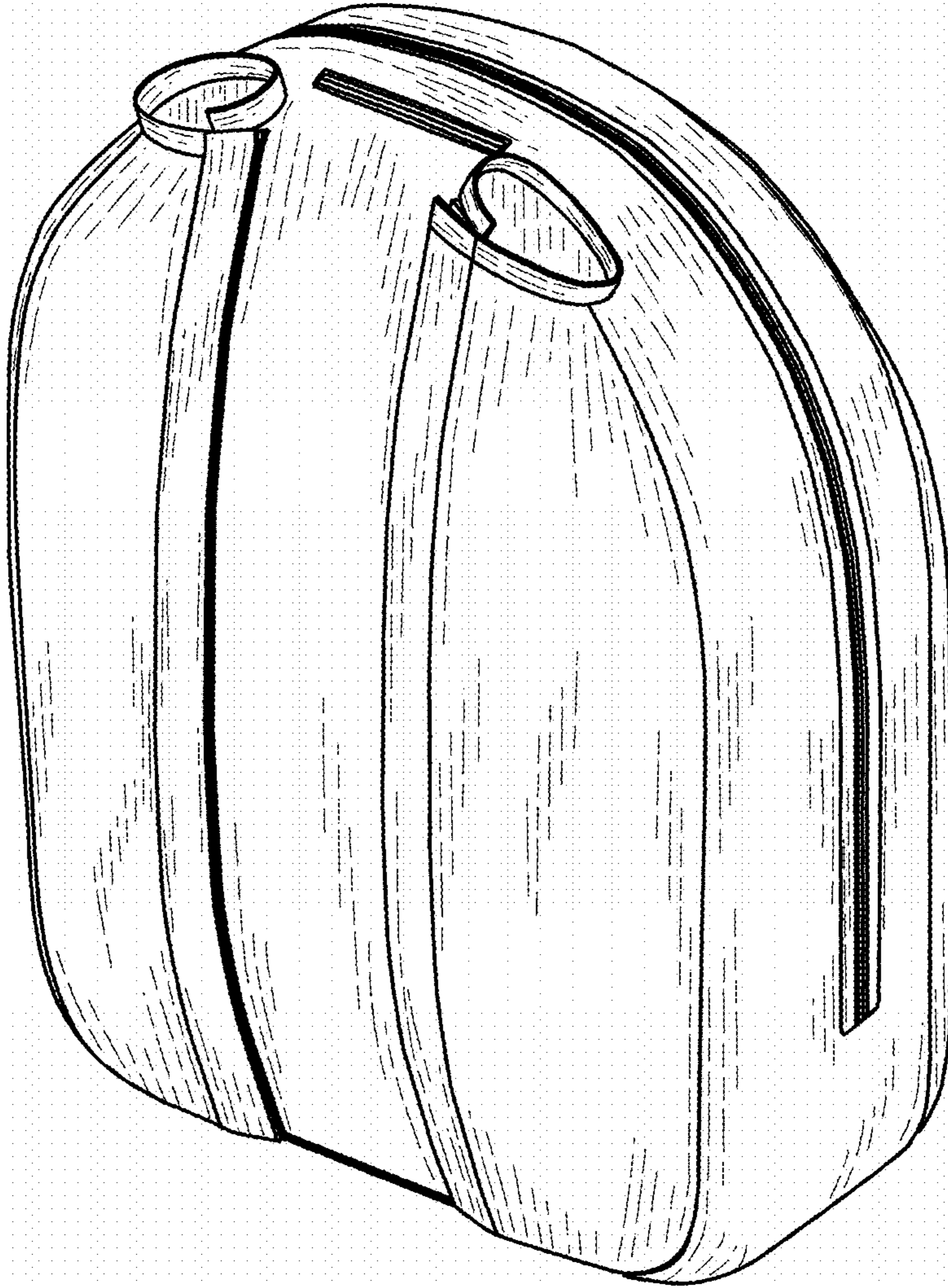

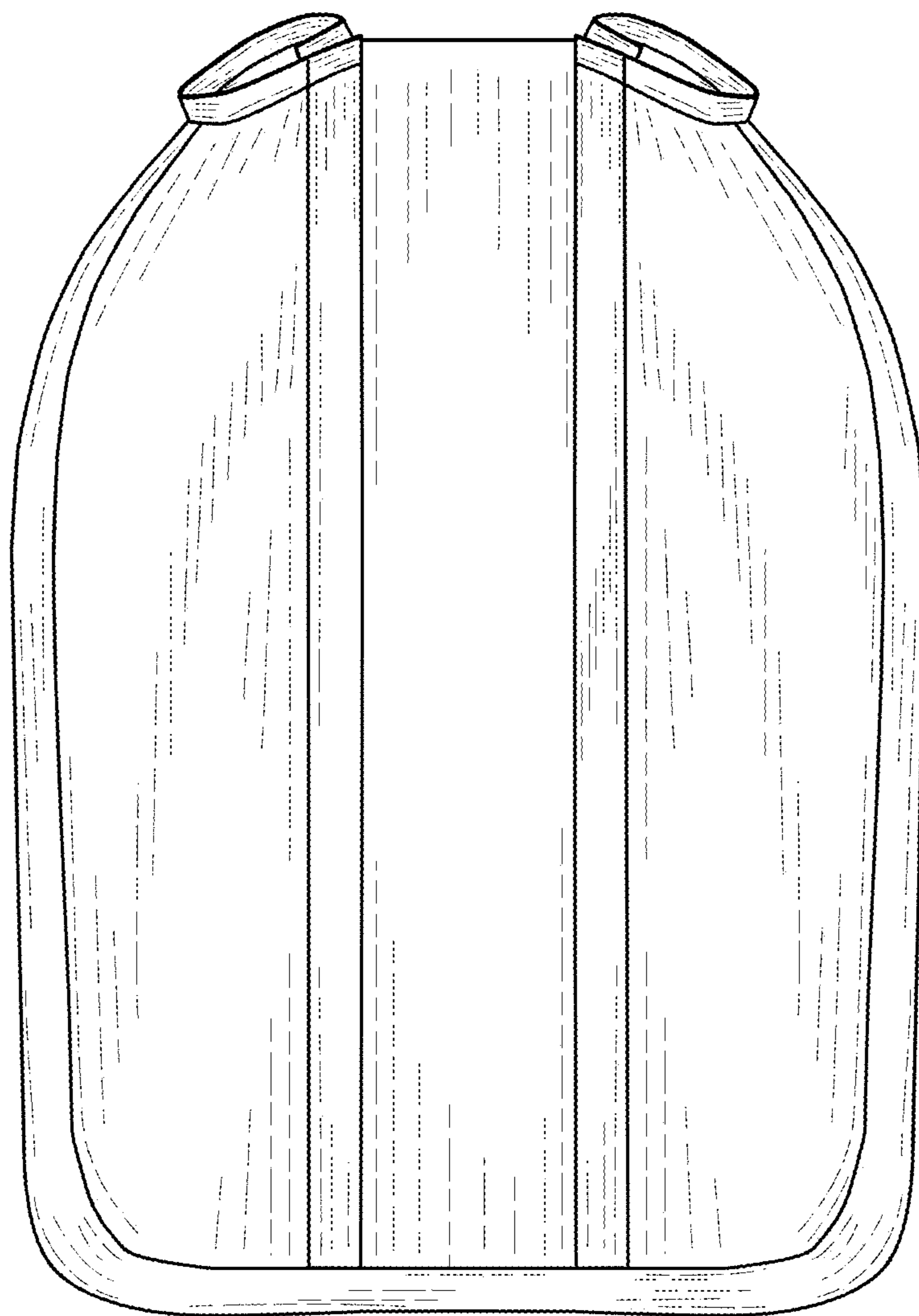

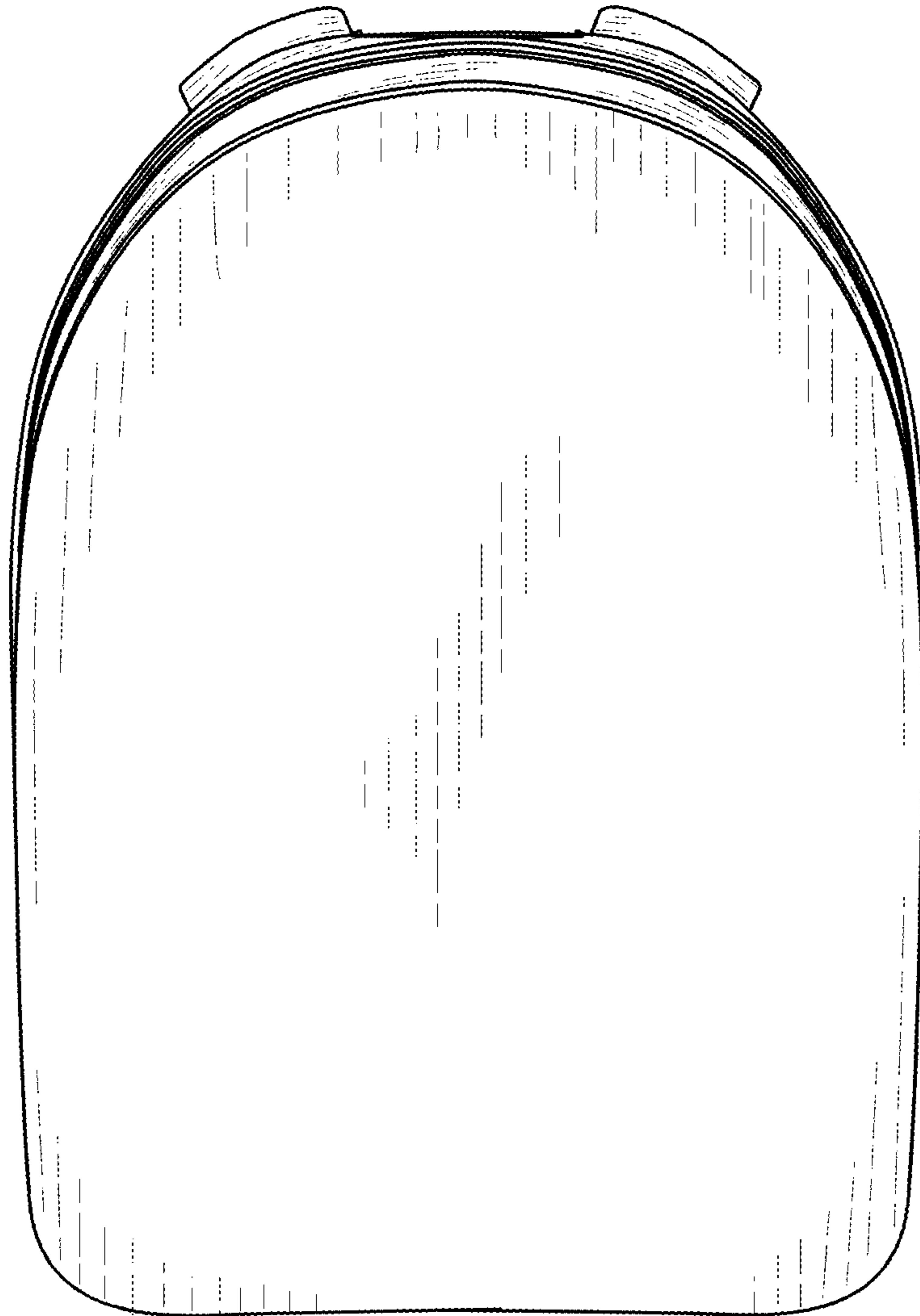

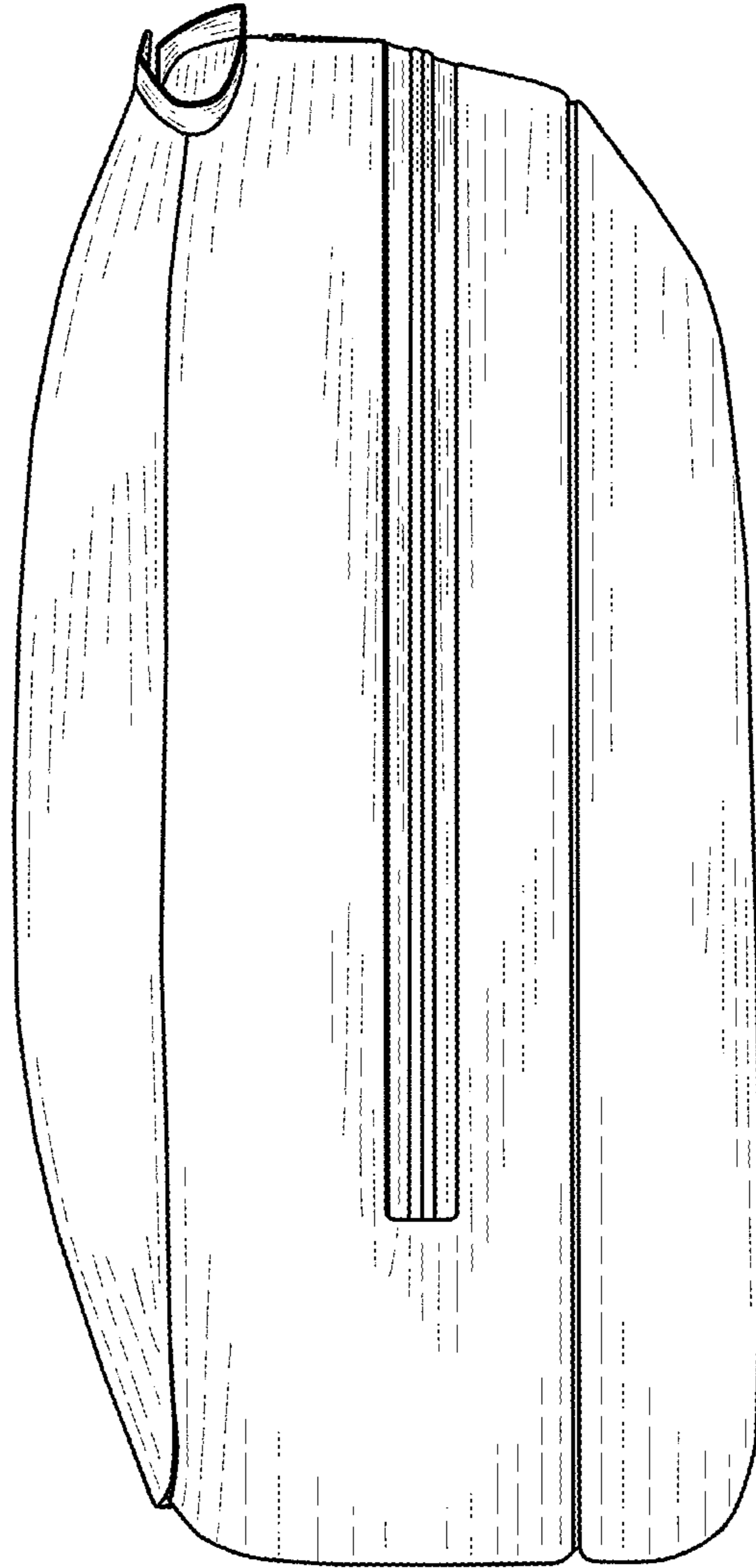

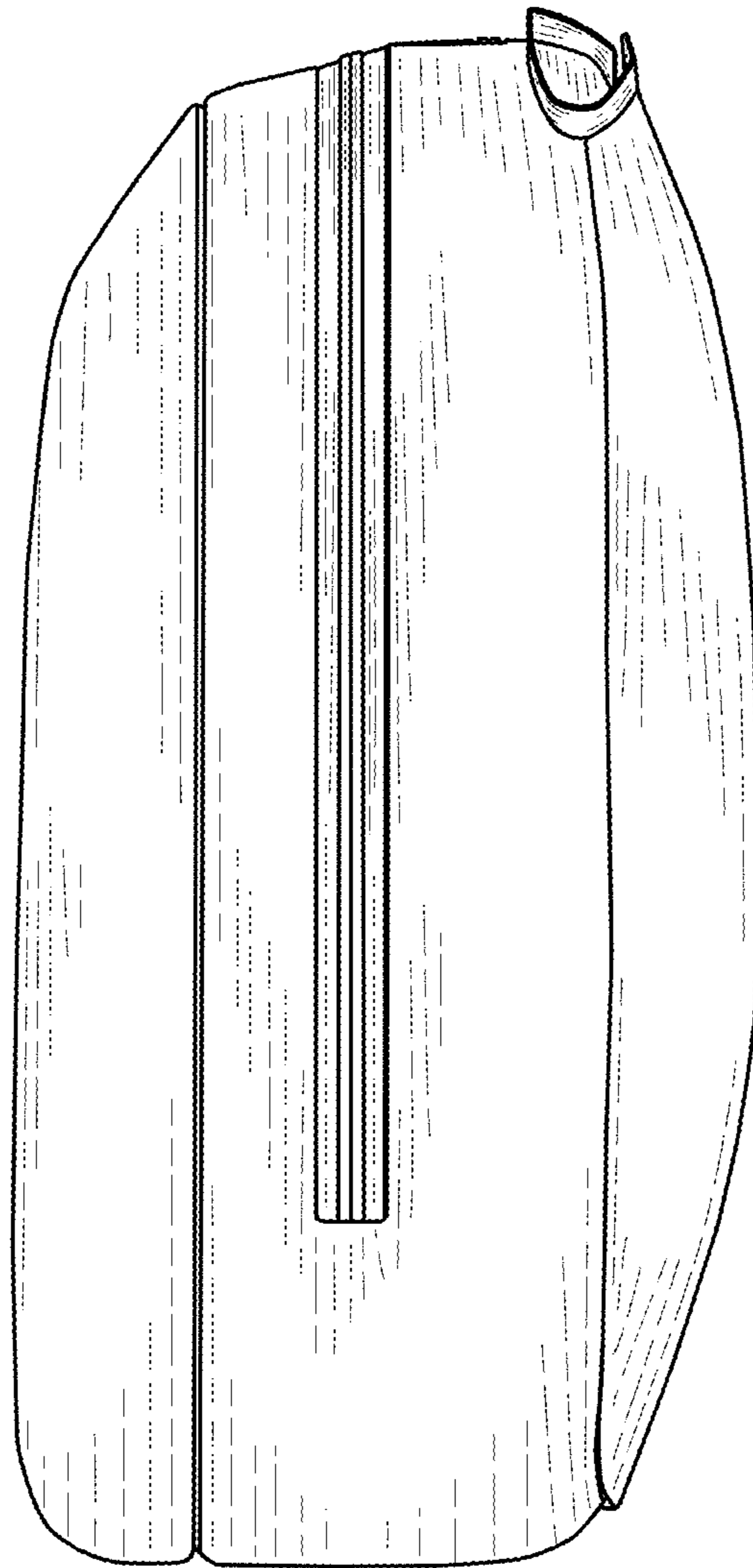

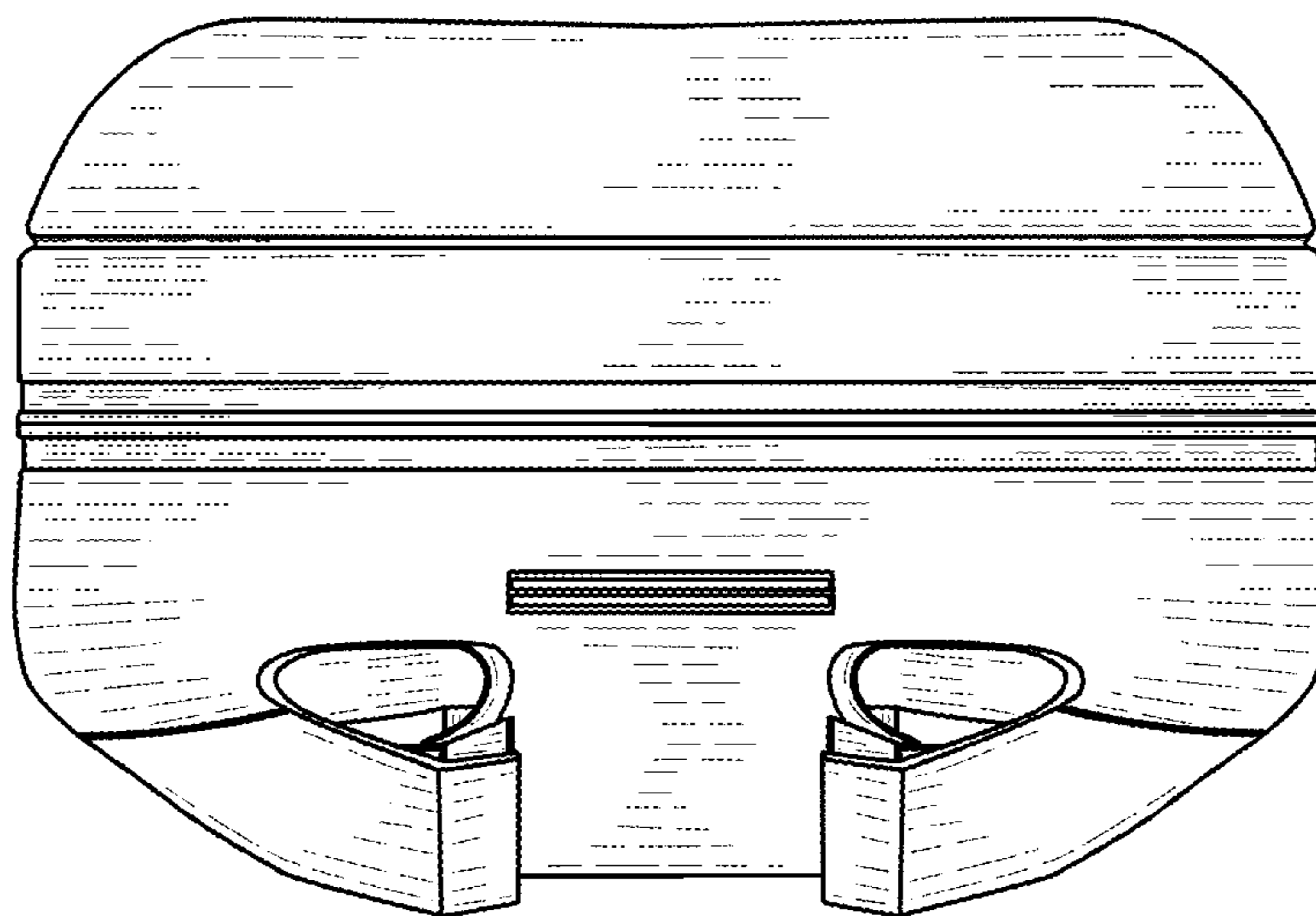

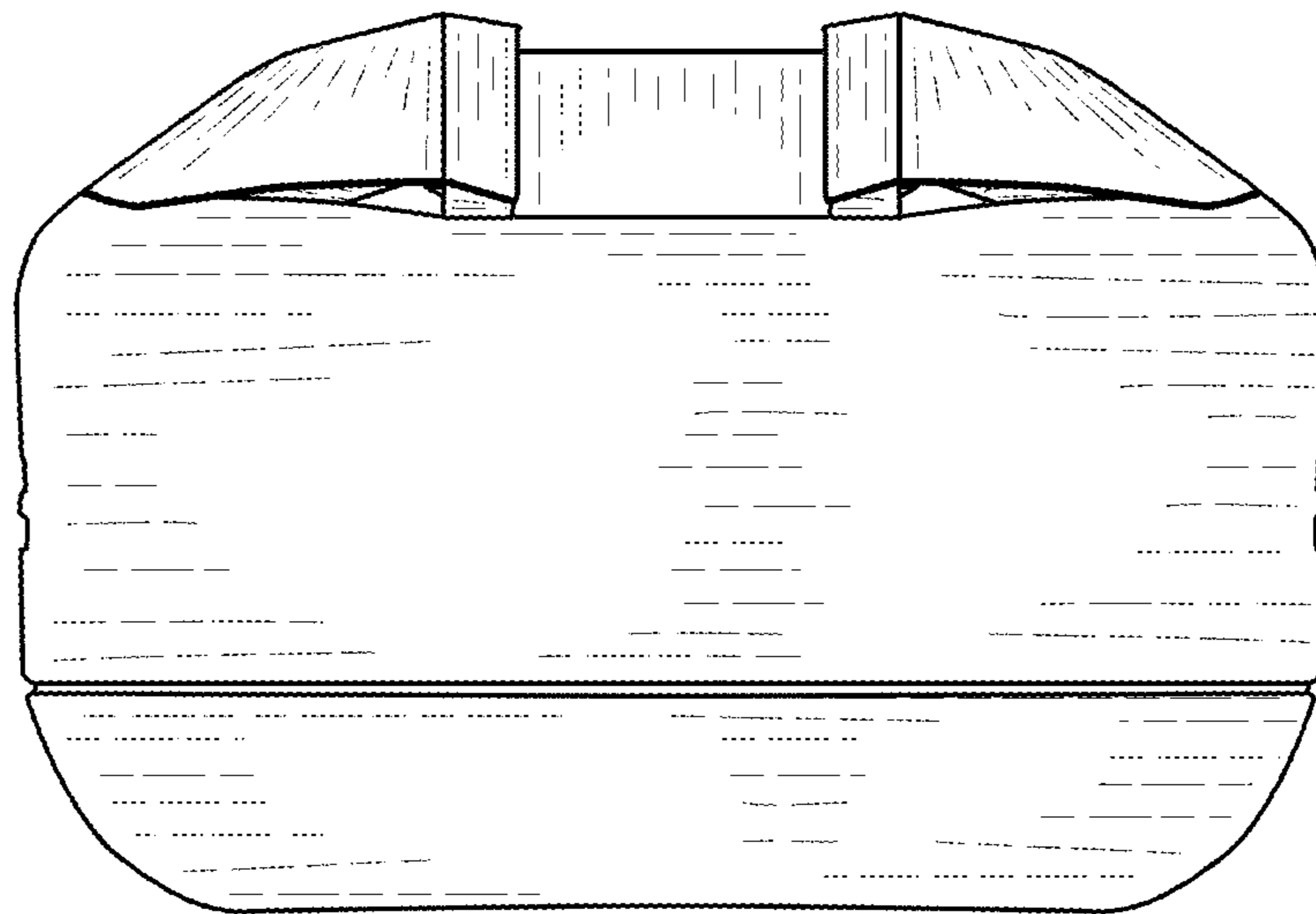

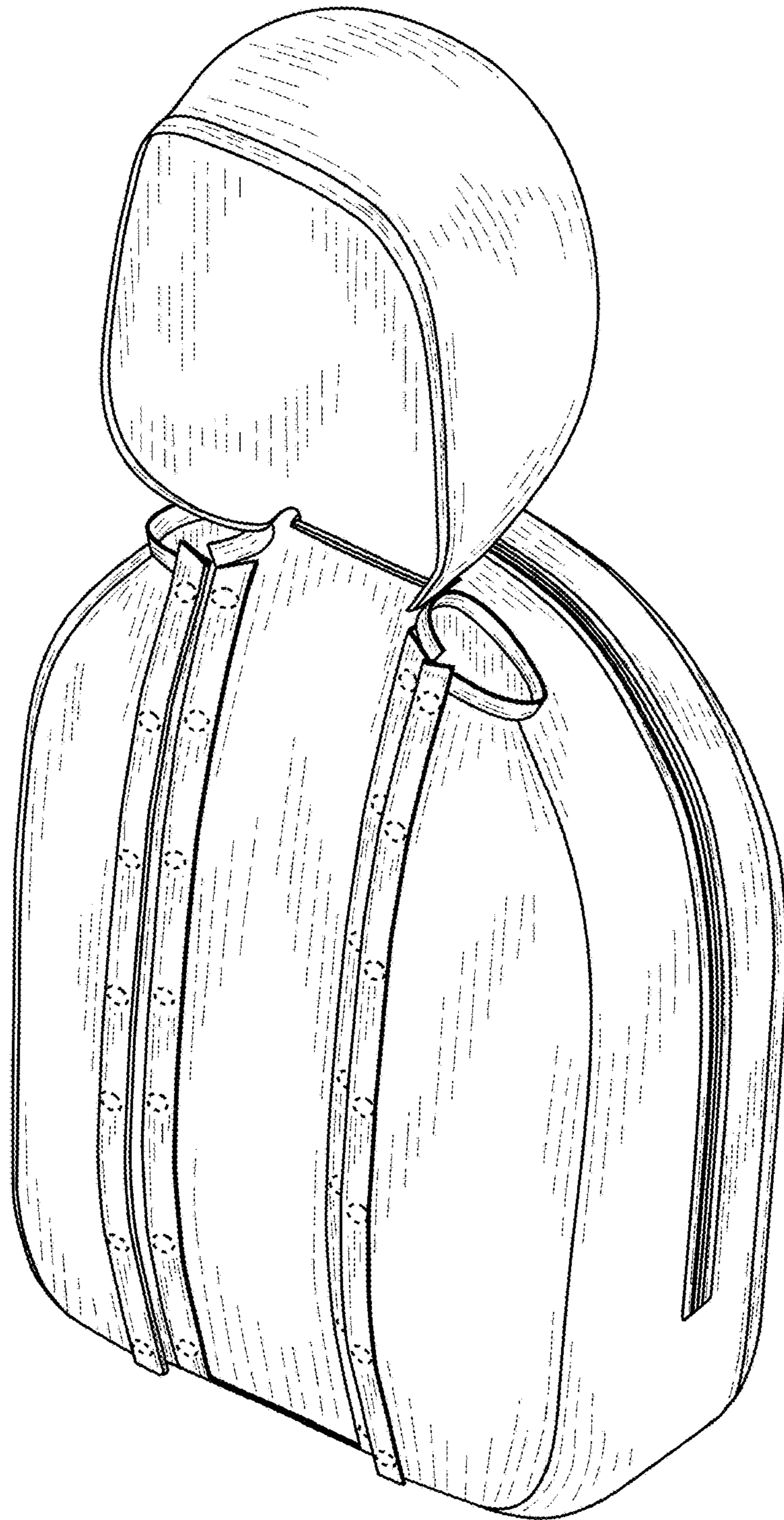

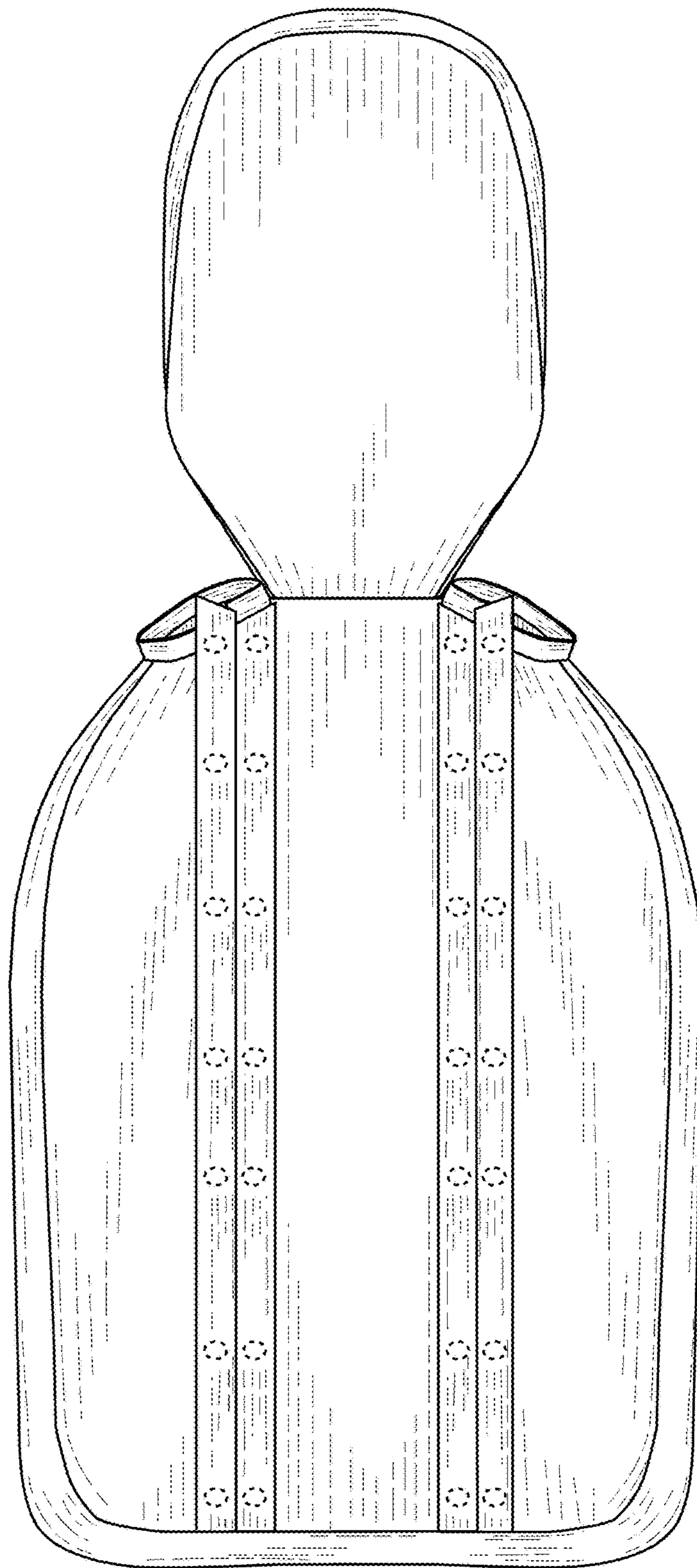

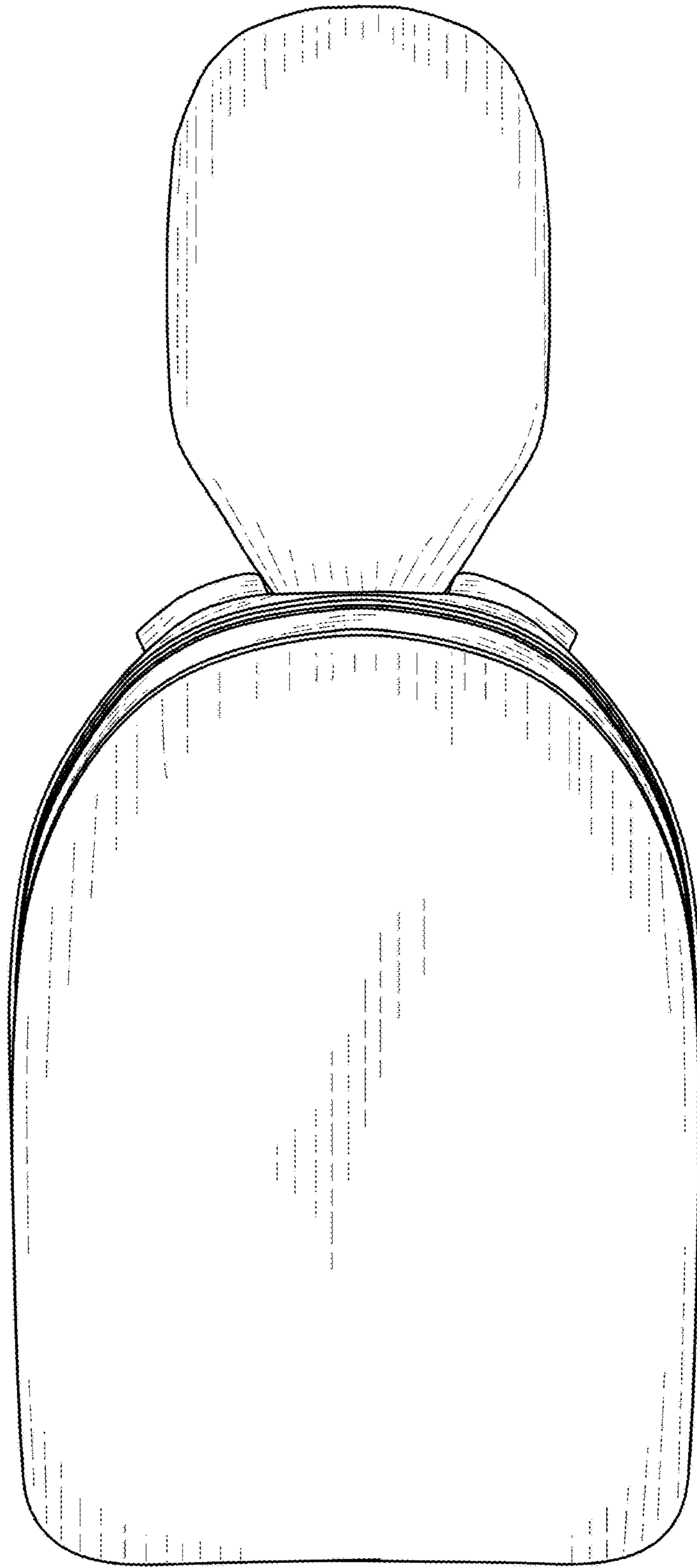

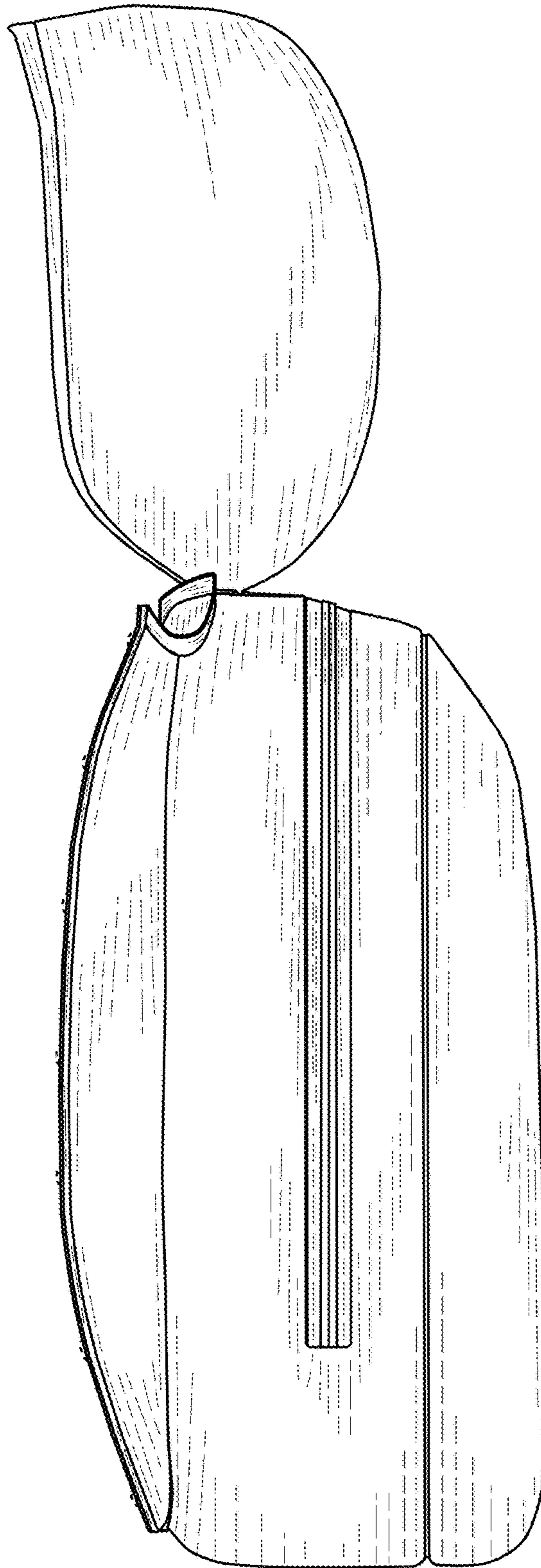

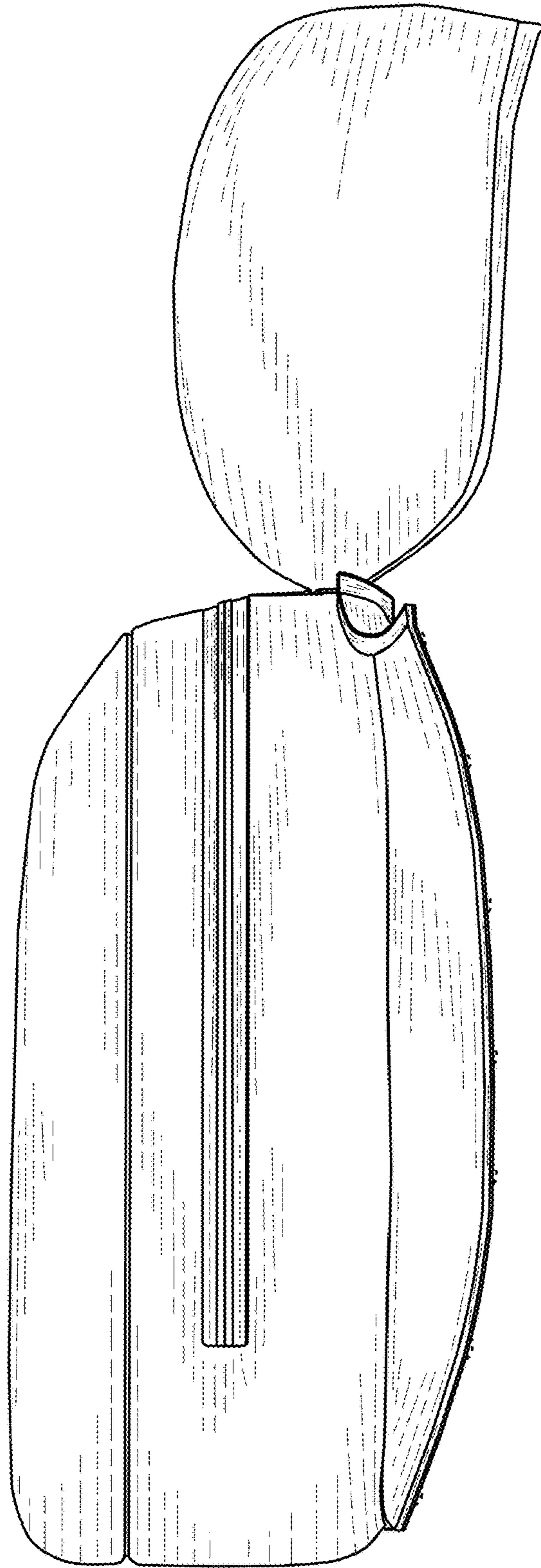

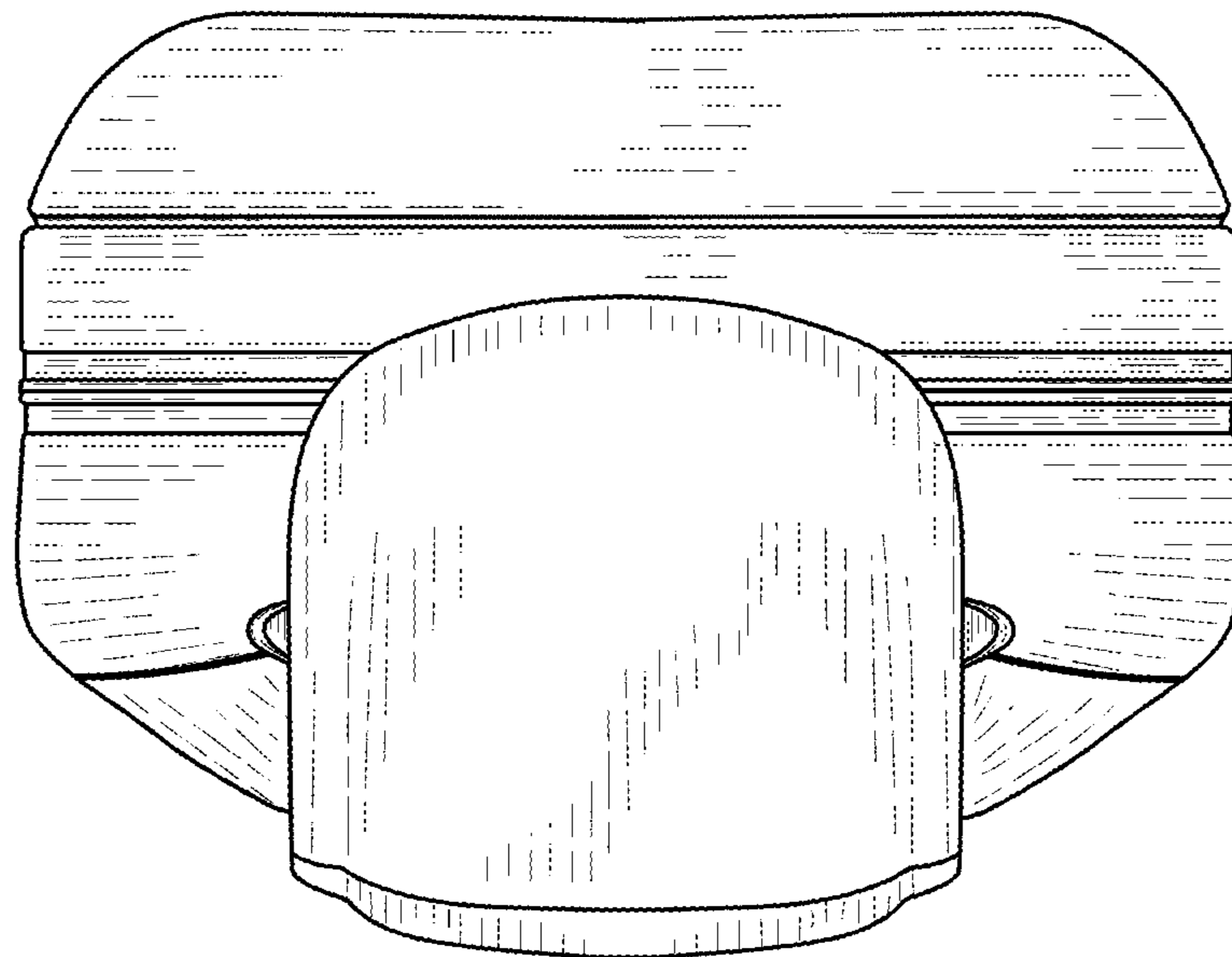

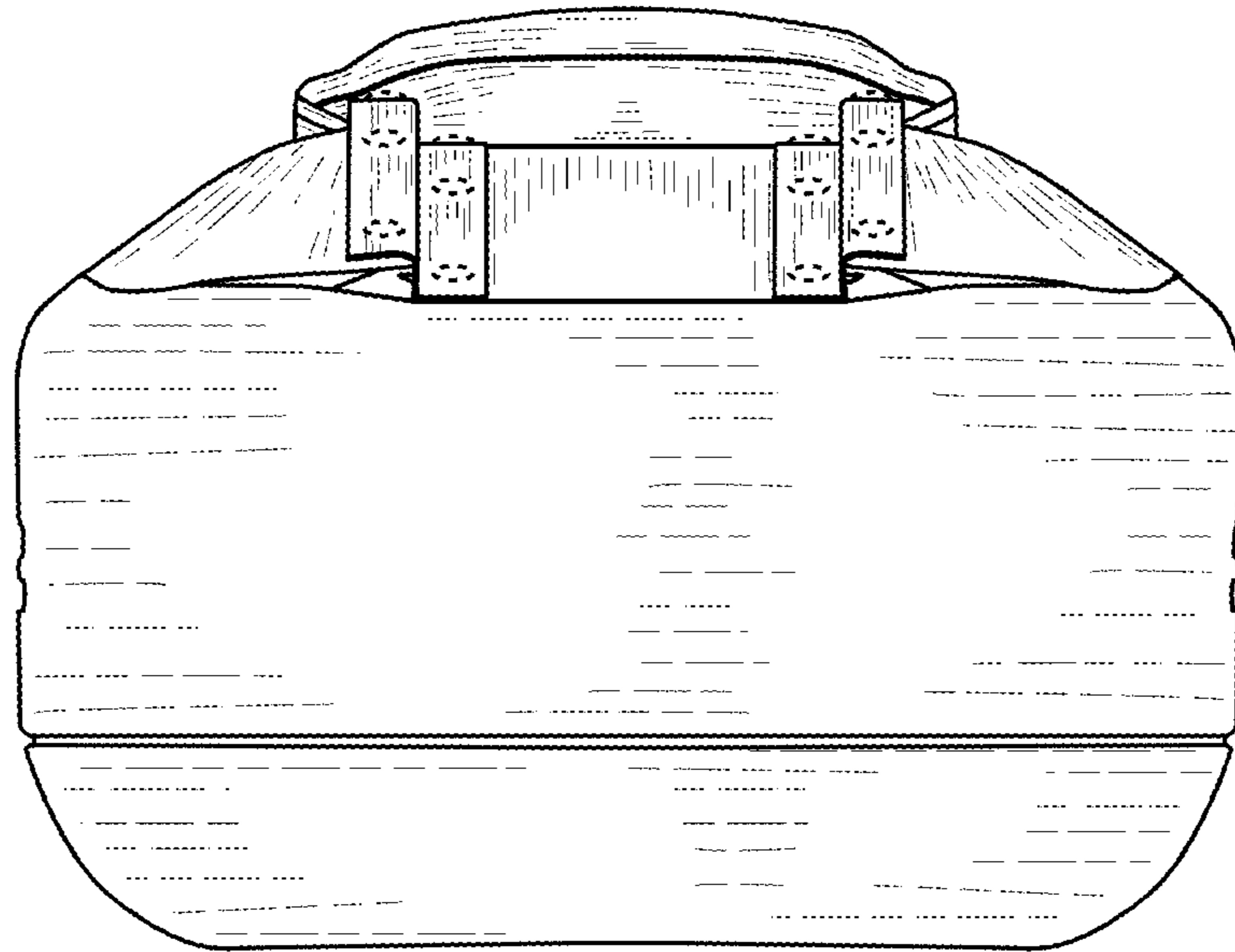
