(57) **CLAIM**

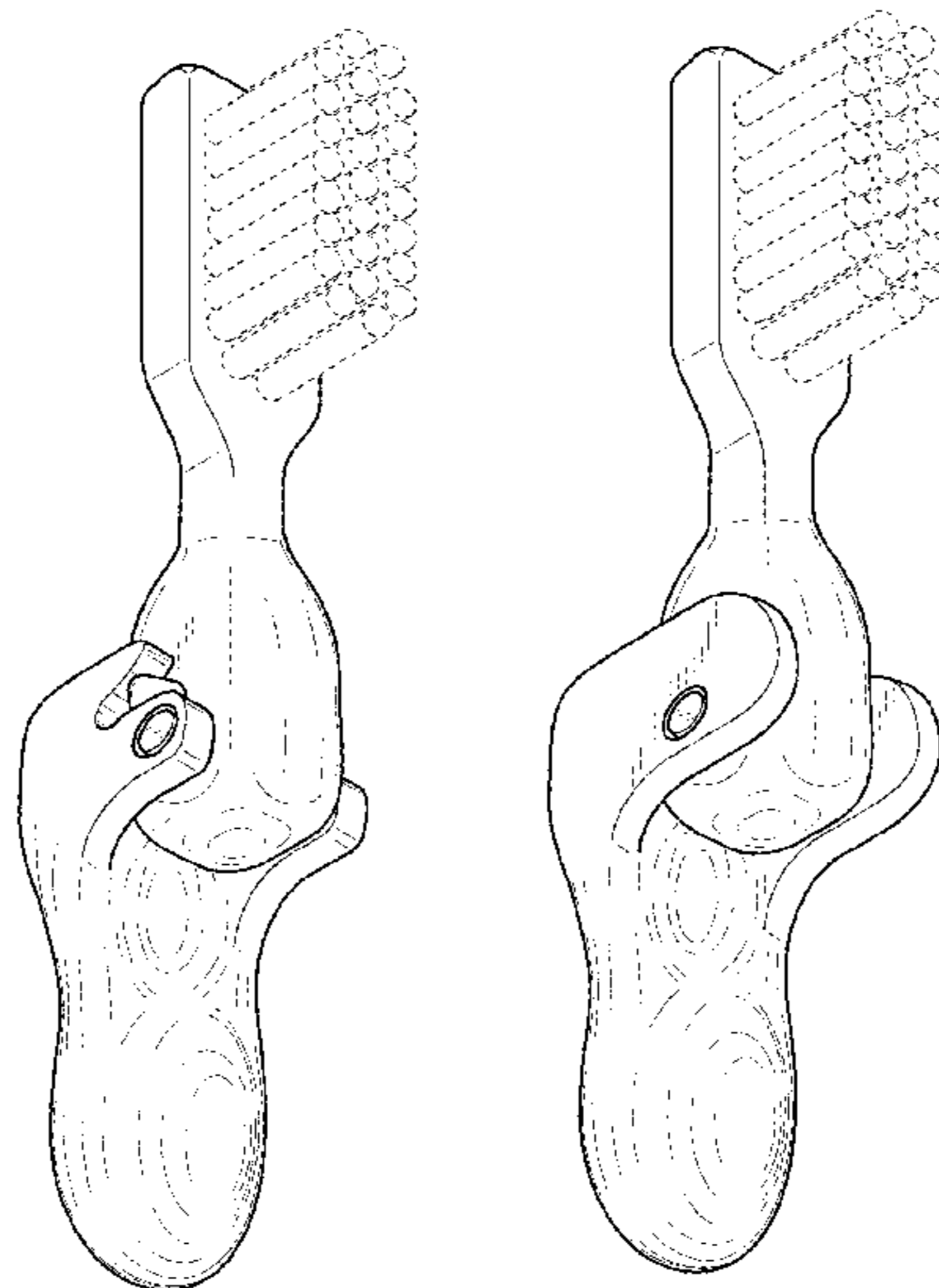
The ornamental design for a foldable toothbrush, as shown and described.

DESCRIPTION

FIG. 1 is a bottom front perspective view of a foldable toothbrush in an extended configuration, showing my design;

FIG. 2 is a top rear perspective view thereof;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a front elevation view thereof;
FIG. 6 is a rear elevation view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof;
FIG. 9 is a left side elevation view of the design shown in FIGS. 1-8 thereof, but in a folded configuration;
FIG. 10 is a right side elevation view thereof;
FIG. 11 is a front elevation view thereof;
FIG. 12 is a rear elevation view thereof;
FIG. 13 is a top plan view thereof; and
FIG. 14 is a bottom plan view thereof.
FIG. 15 is a left side elevation view thereof with the brush head portion of the handle shown in a different position;
FIG. 16 is a bottom front perspective view of an alternative embodiment of a foldable toothbrush;
FIG. 17 is a top rear perspective view thereof;
FIG. 18 is a left side elevation view thereof;
FIG. 19 is a right side elevation view thereof;
FIG. 20 is a front elevation view thereof;
FIG. 21 is a rear elevation view thereof;
FIG. 22 is a top plan view thereof;
FIG. 23 is a bottom plan view thereof;
FIG. 24 is a left side elevation view of the design shown in FIGS. 16-23 thereof, but in a folded configuration;
FIG. 25 is a right side elevation view thereof;
FIG. 26 is a front elevation view thereof;
FIG. 27 is a rear elevation view thereof;
FIG. 28 is a top plan view thereof;
FIG. 29 is a bottom plan view thereof; and,
FIG. 30 is a left side, elevation view thereof with the brush head portion of the handle shown in a different position.

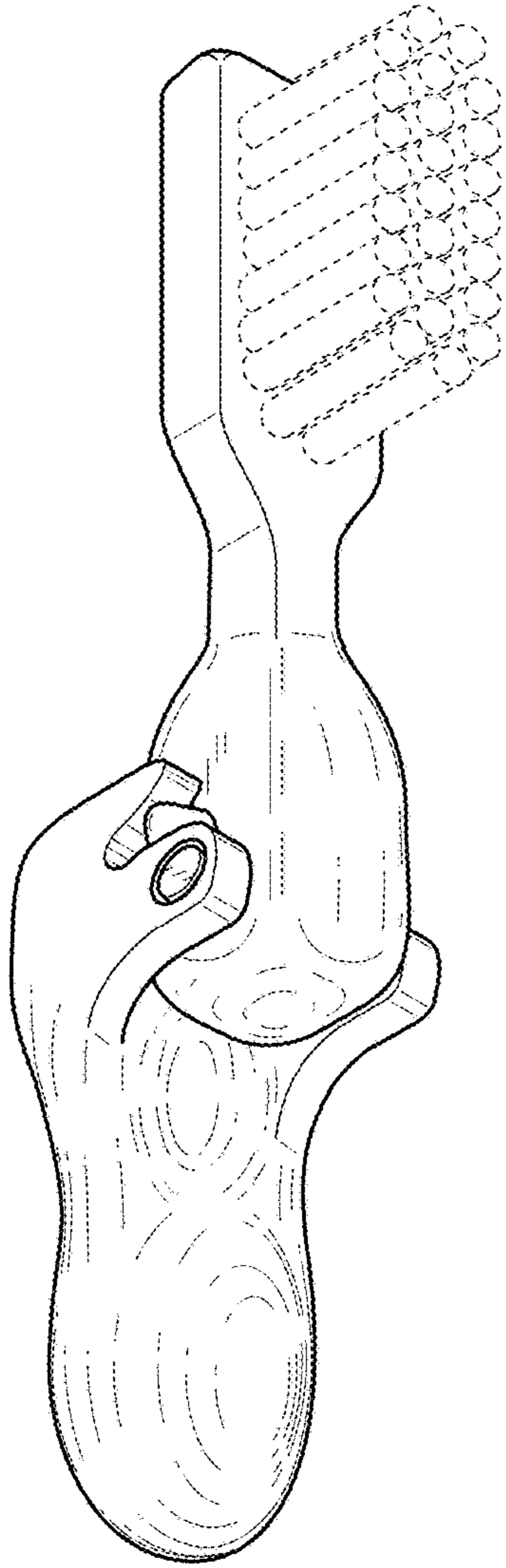

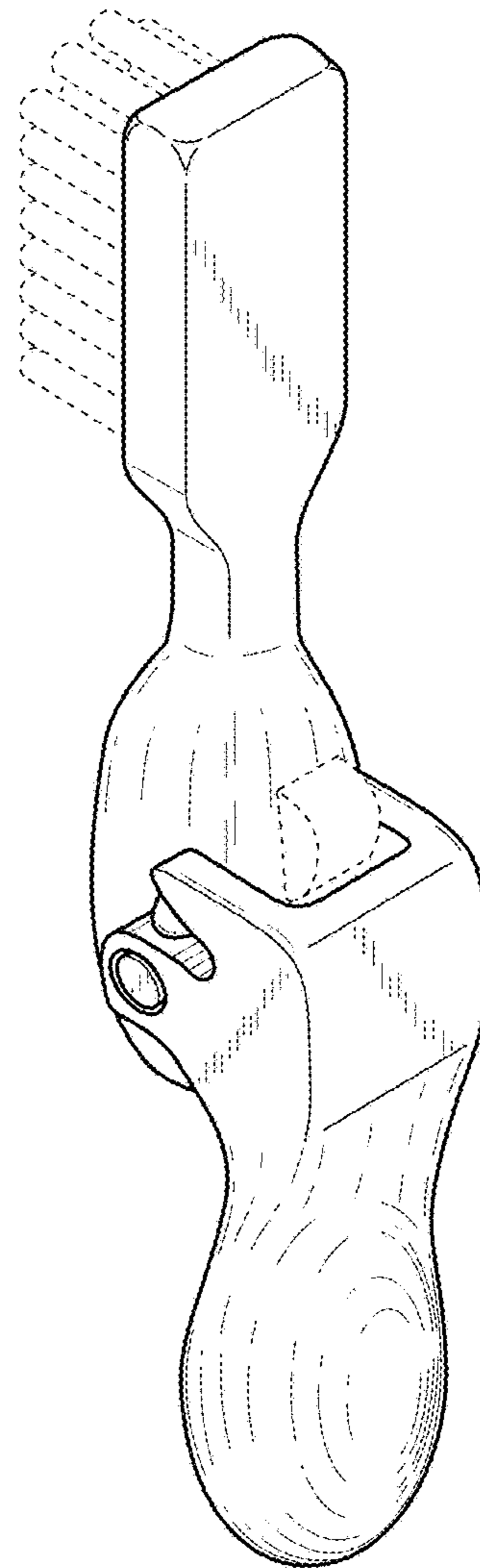

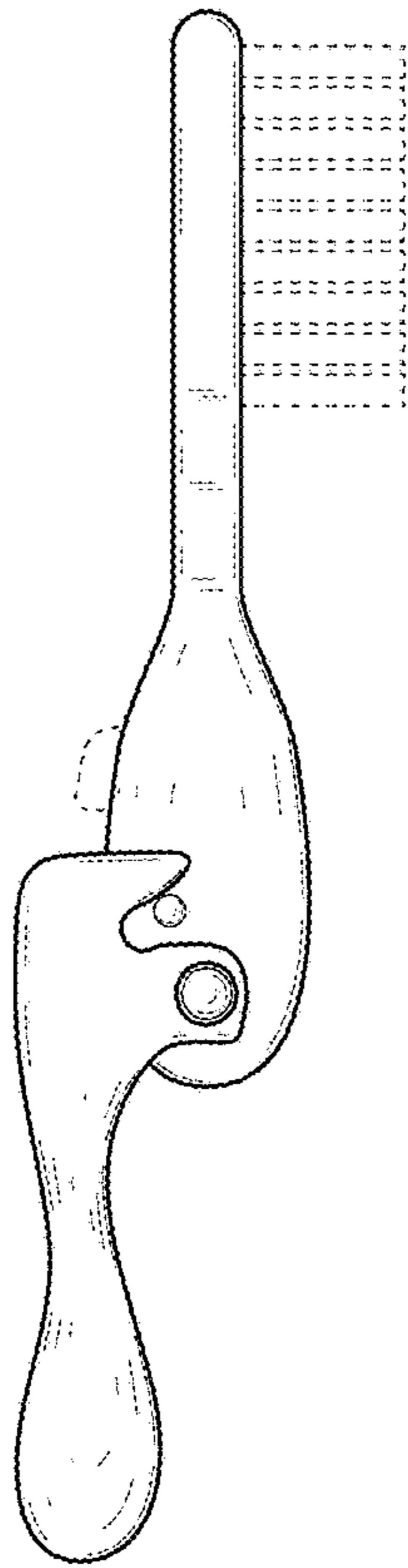

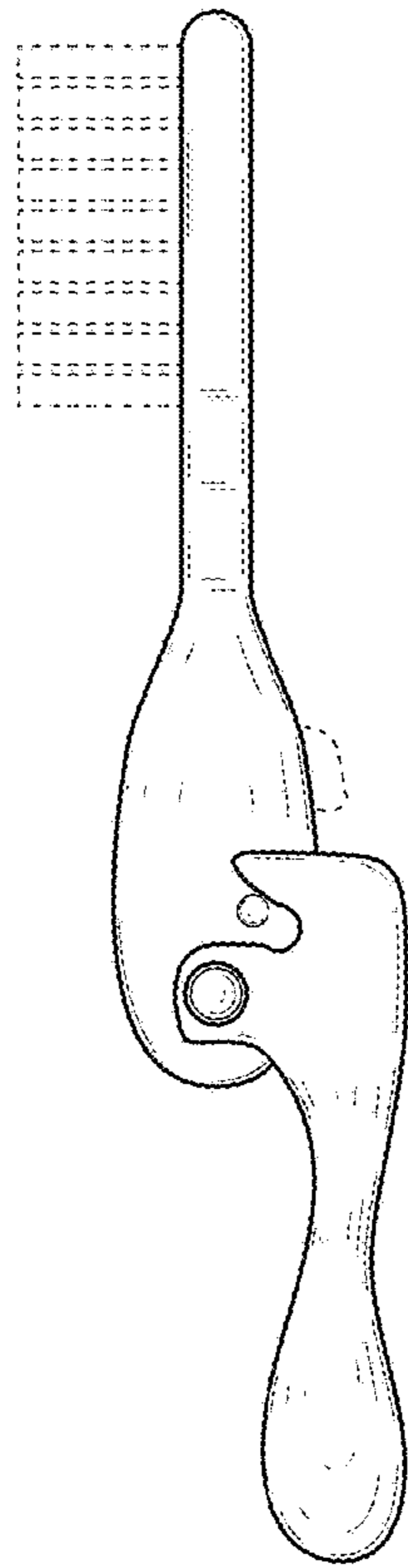

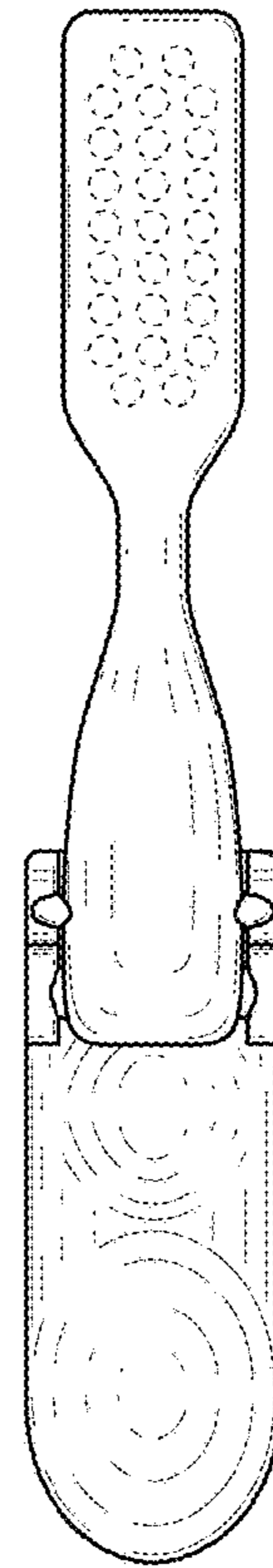

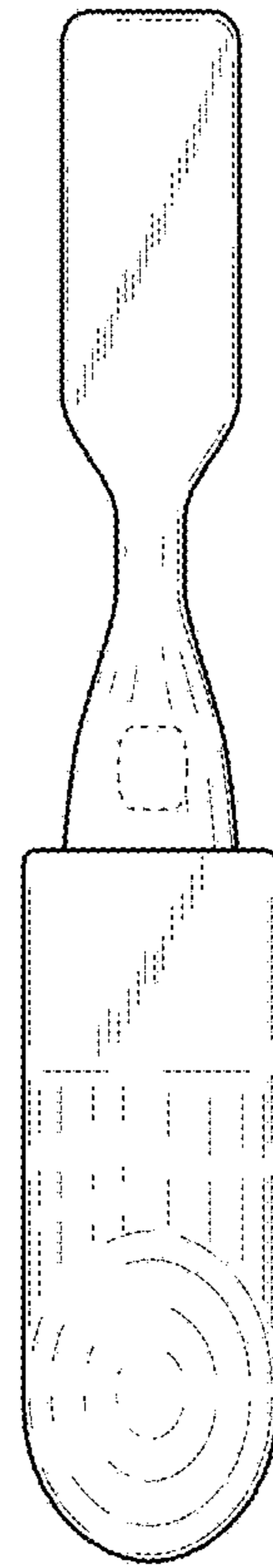

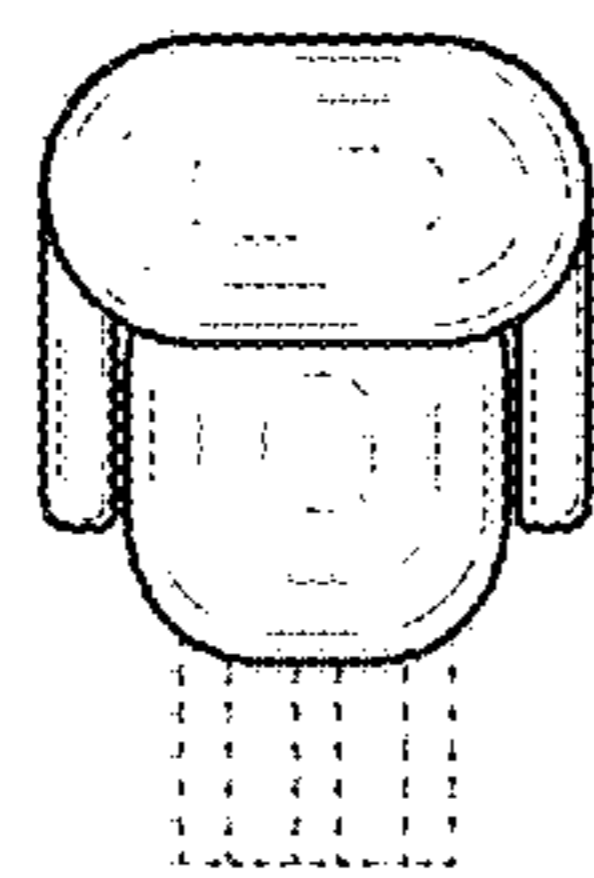

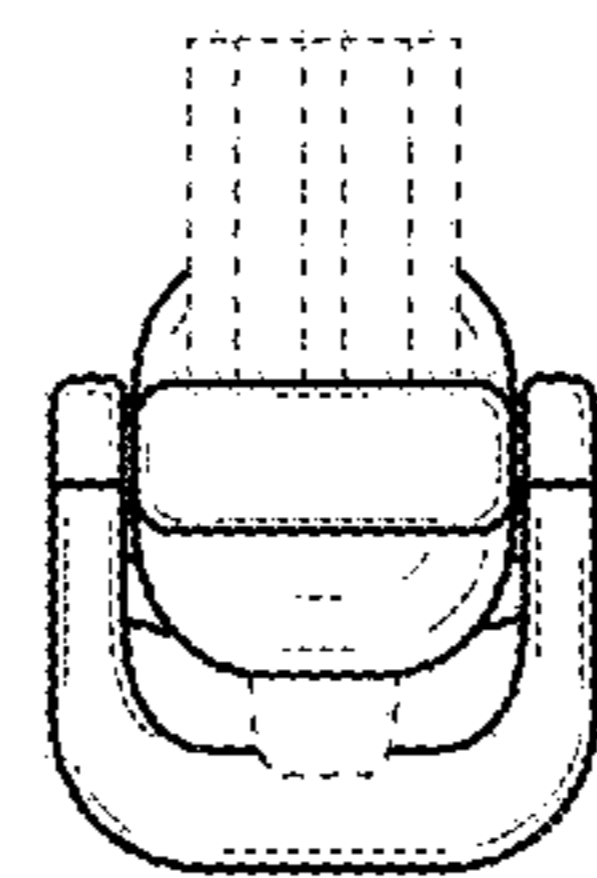

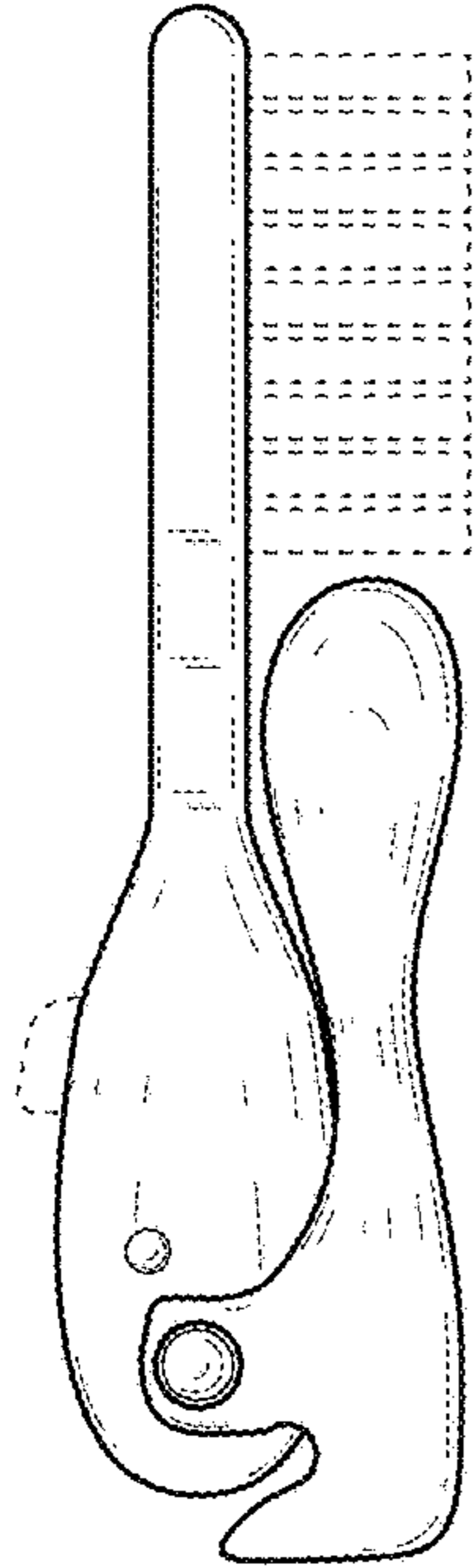

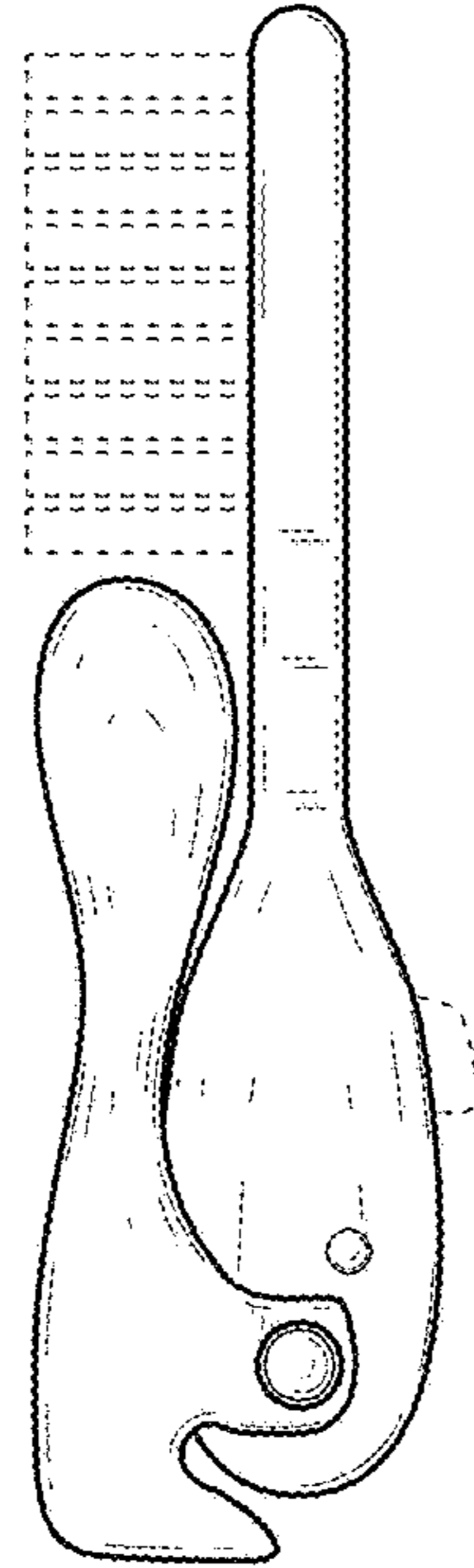

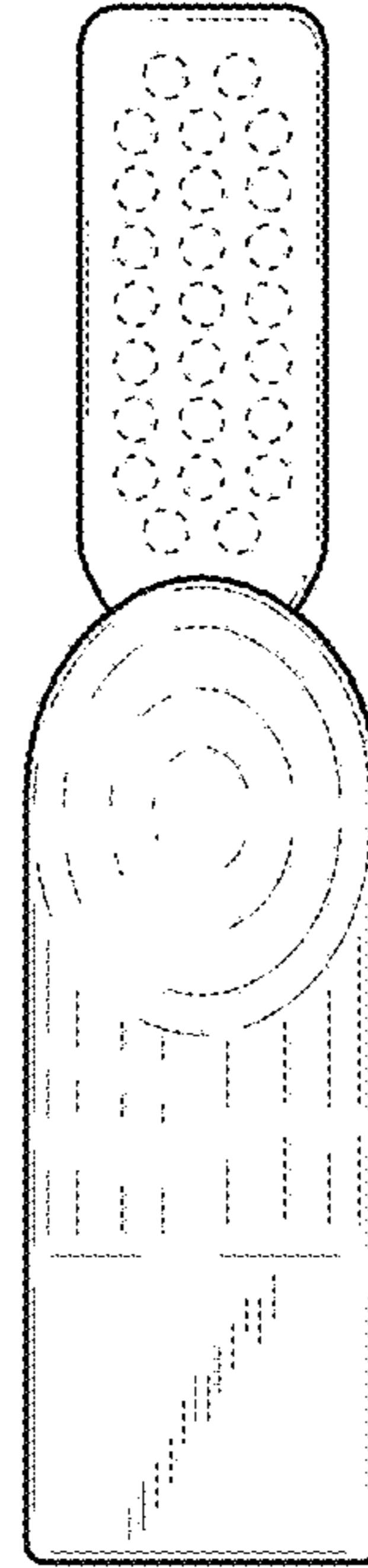

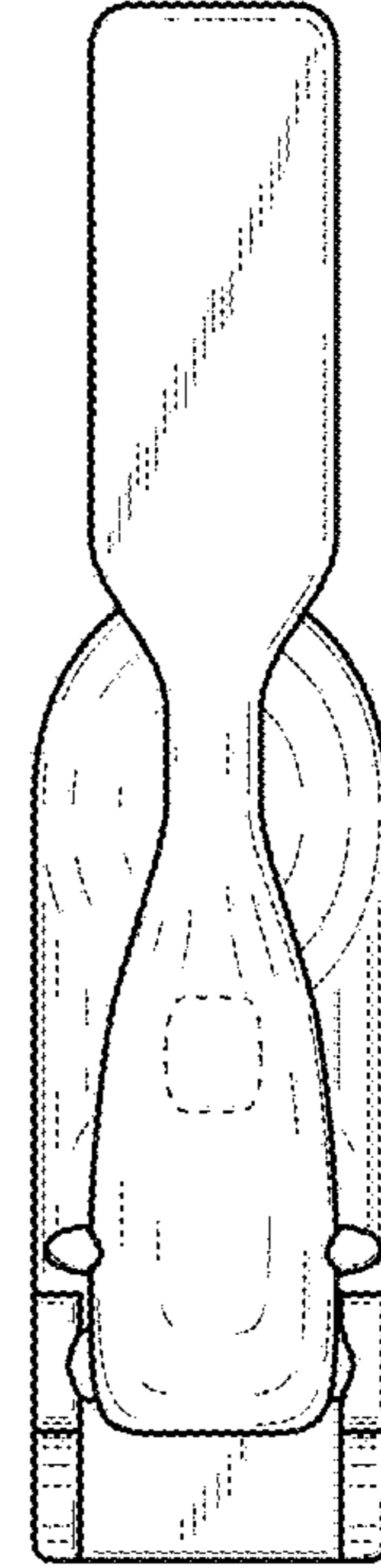

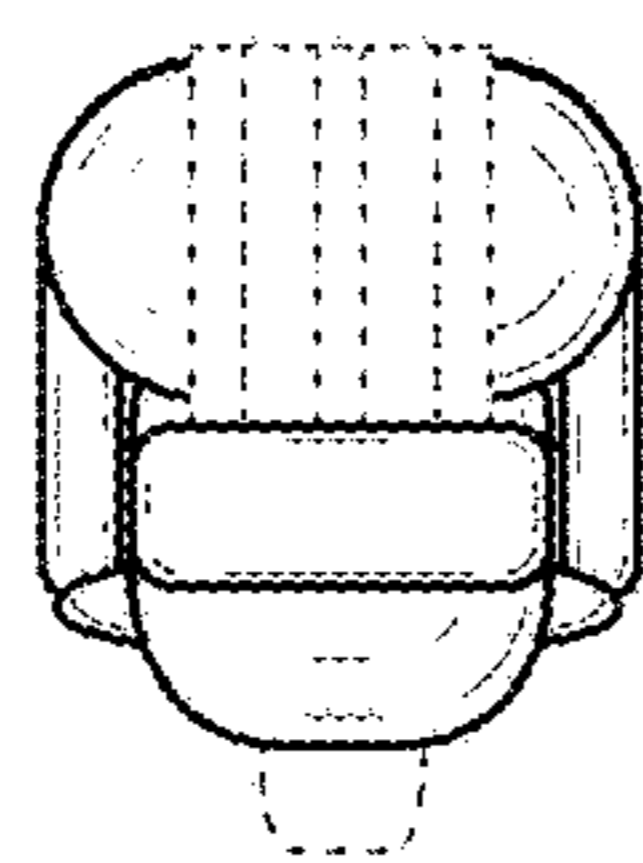

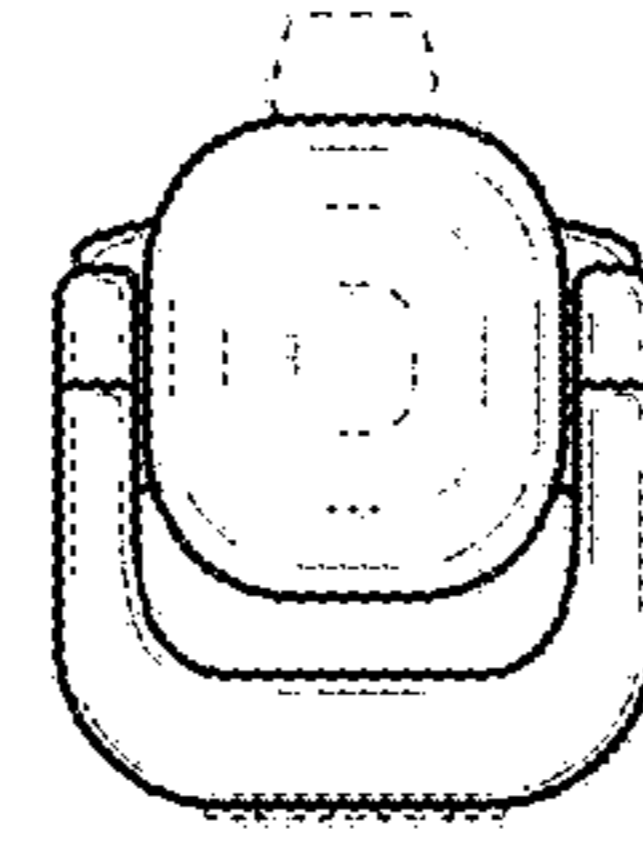

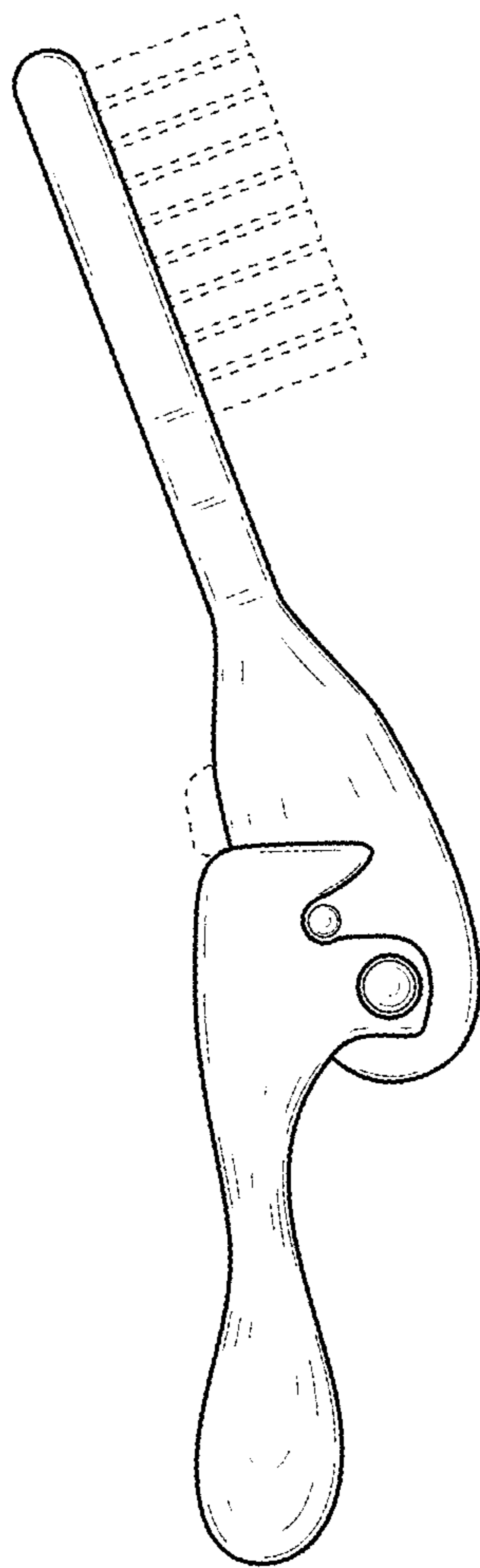

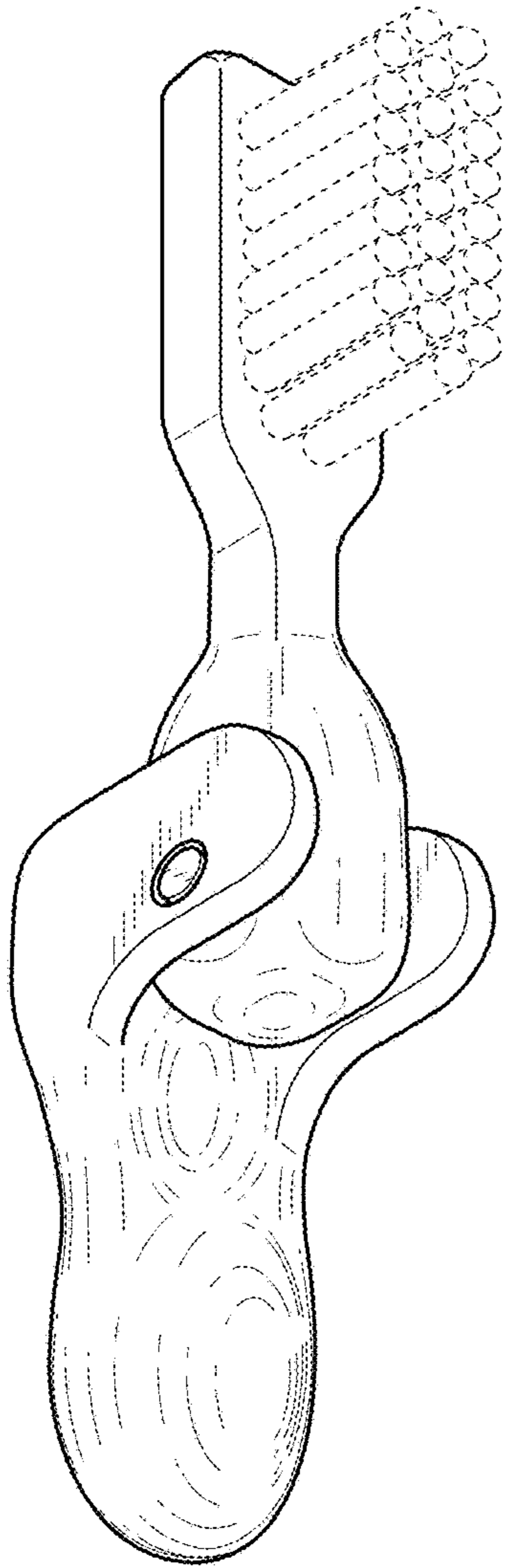

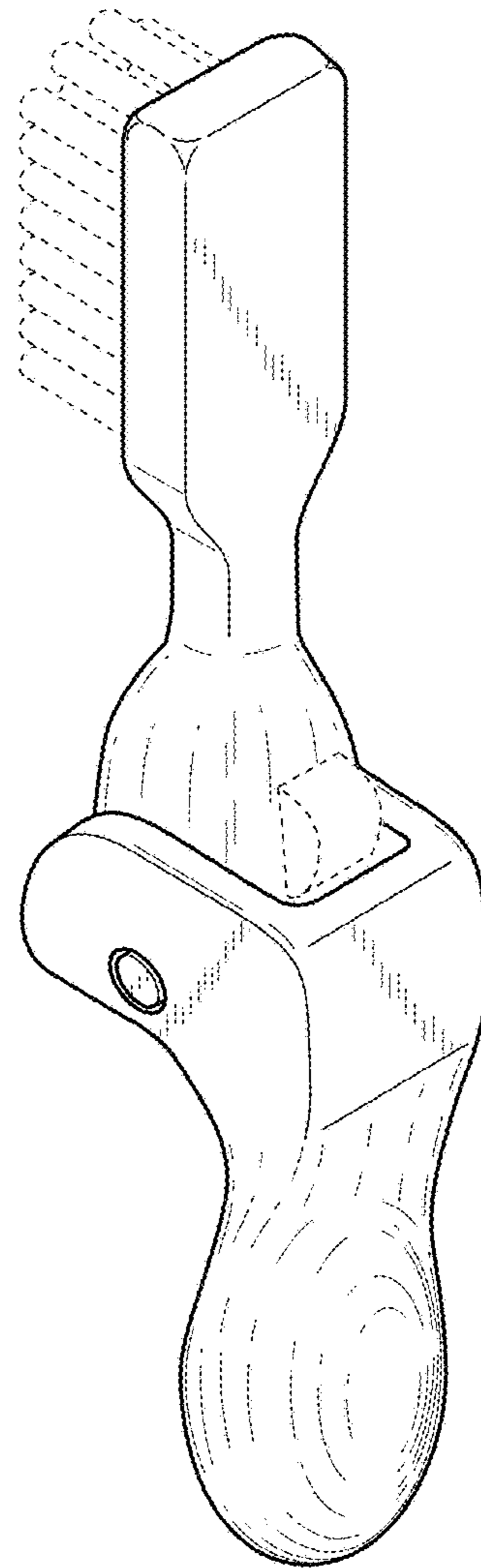

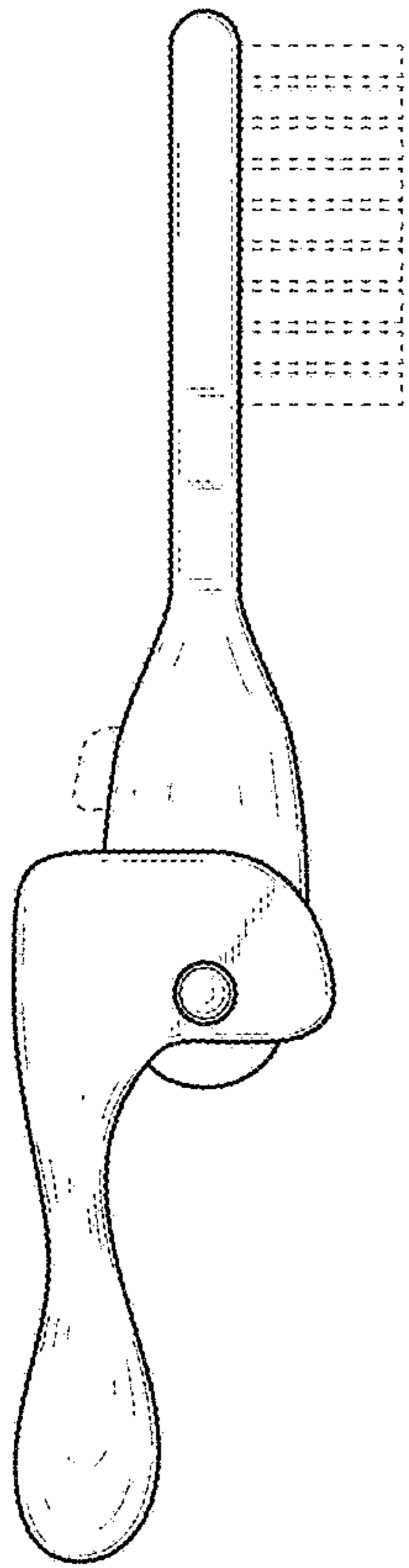

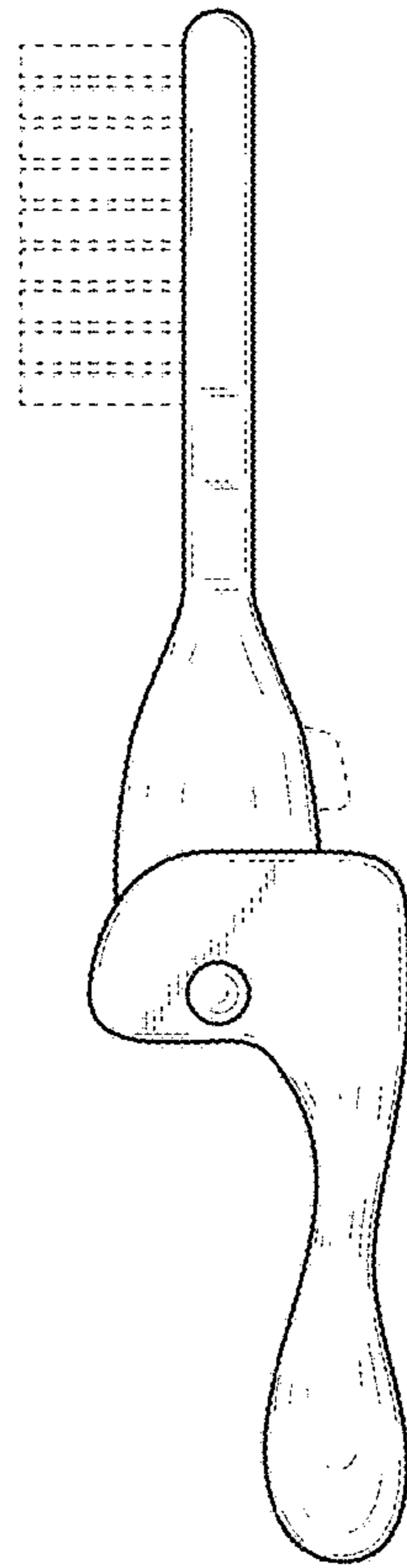

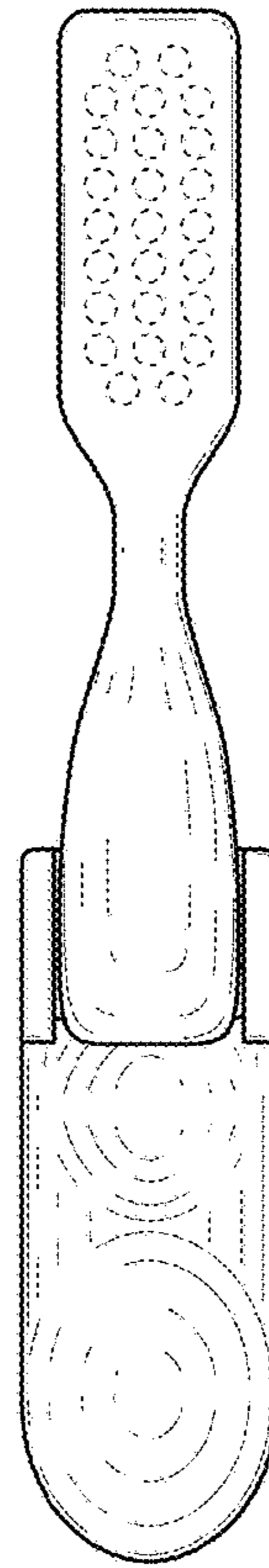

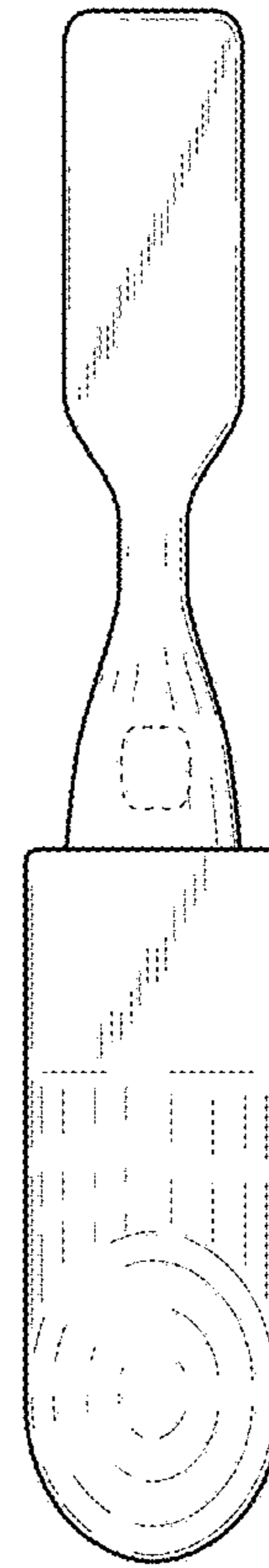

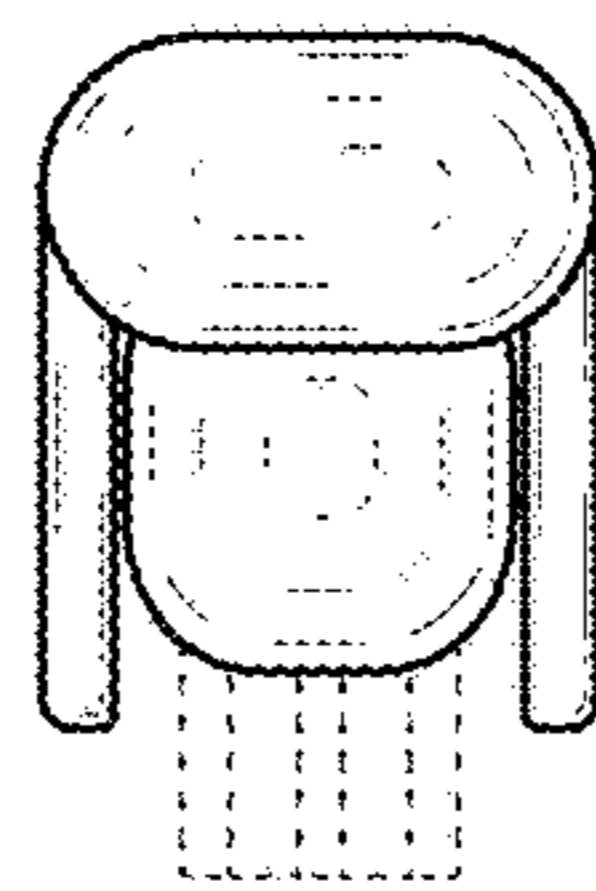

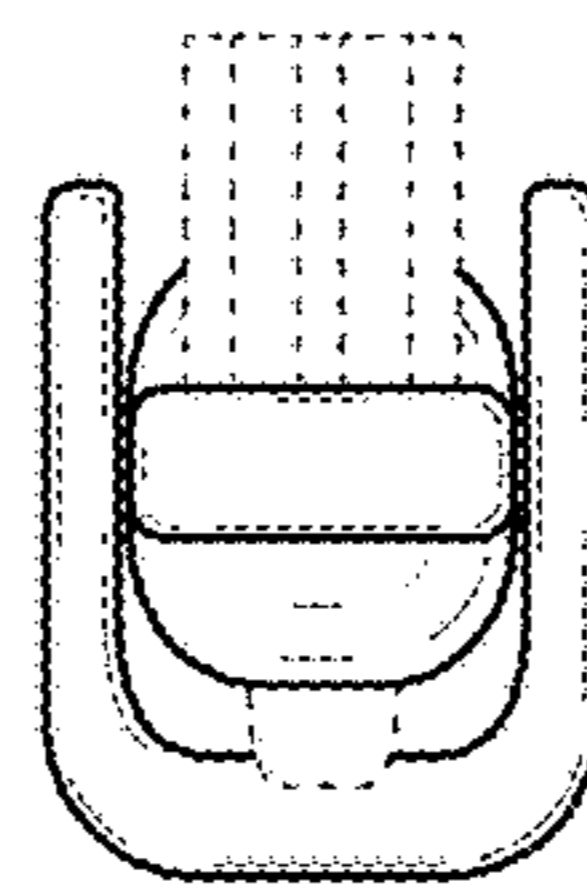

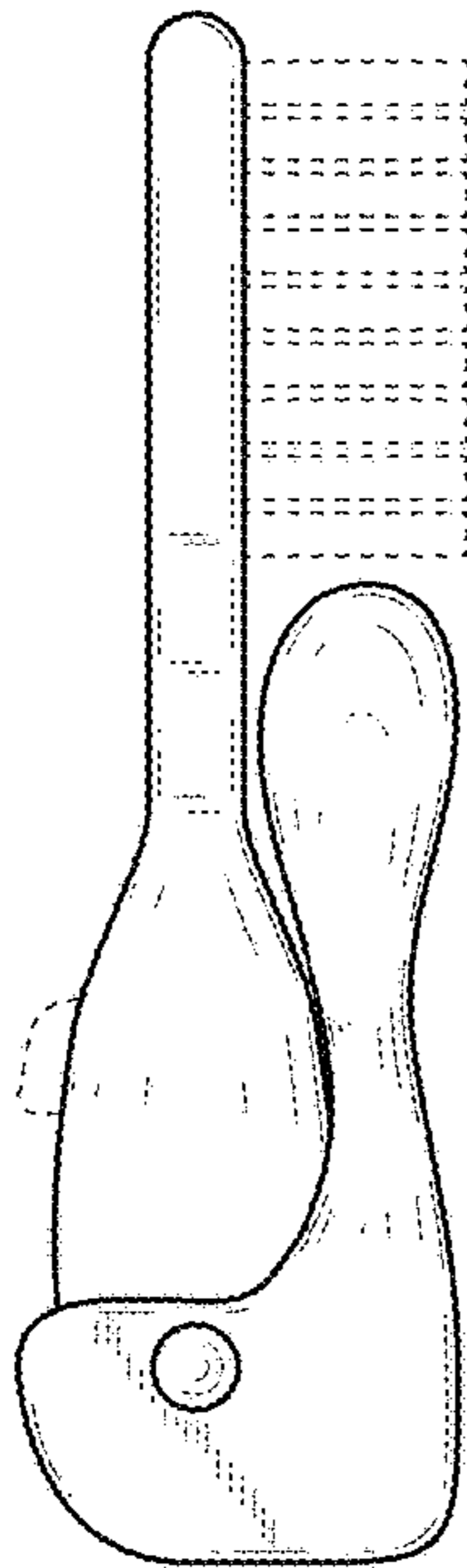

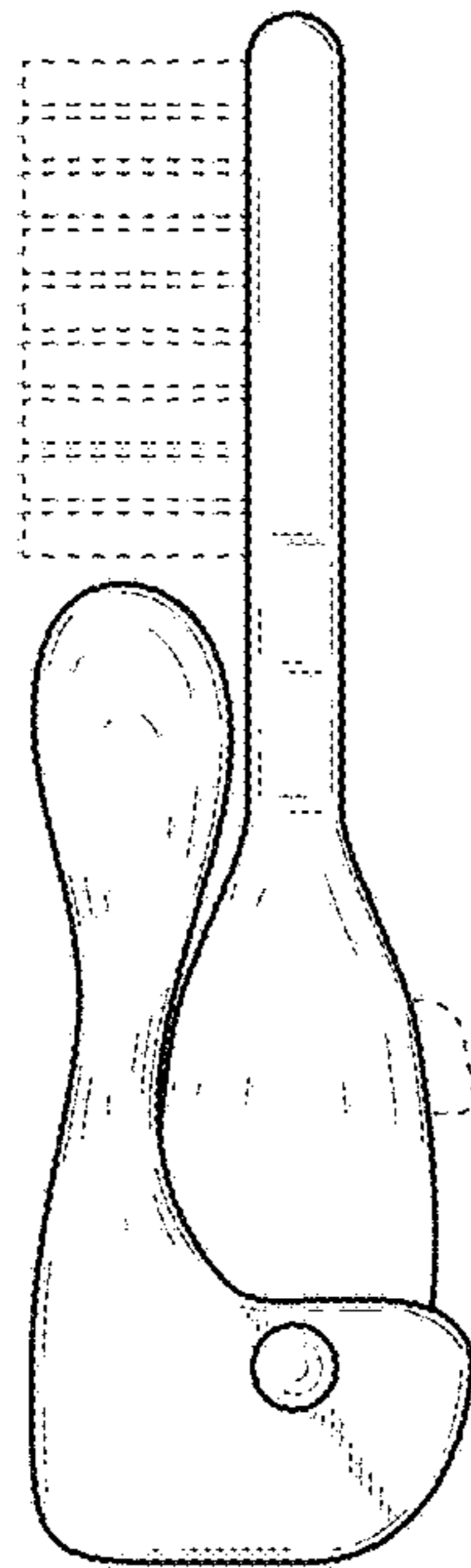

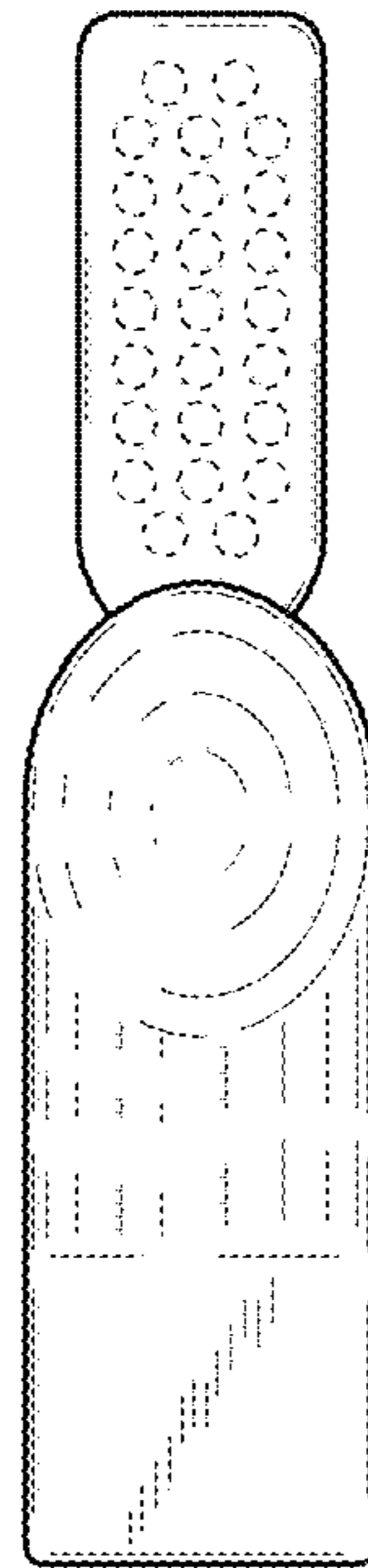

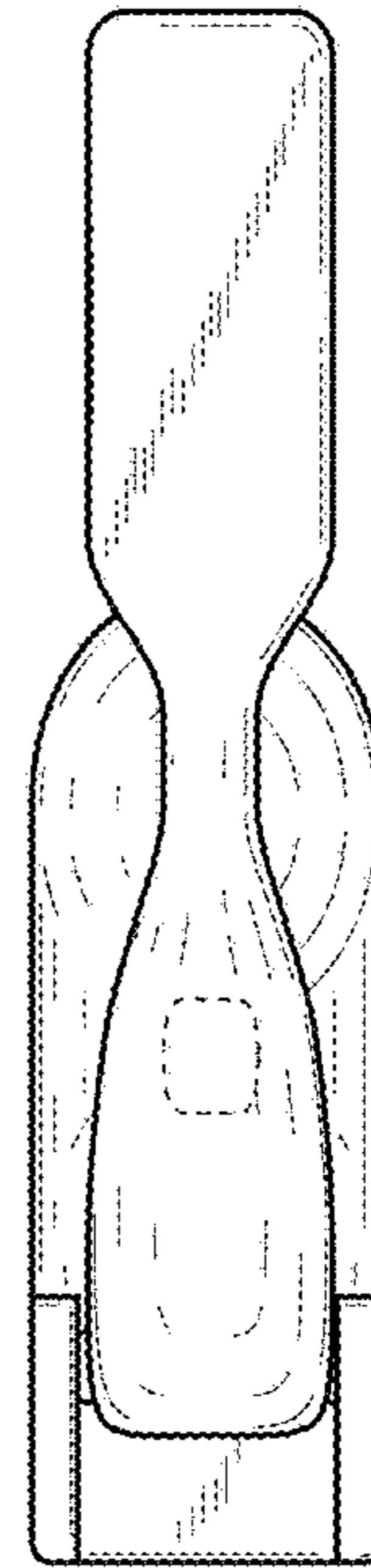

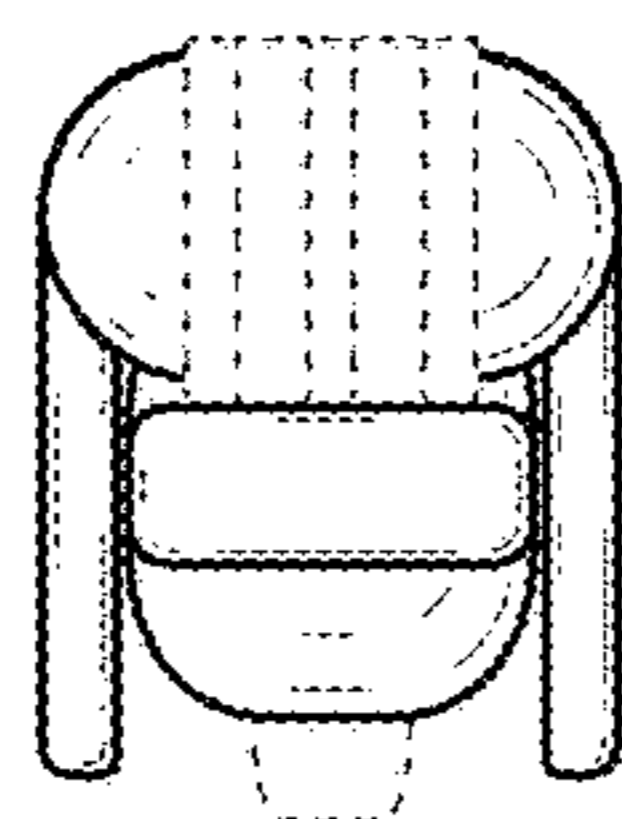

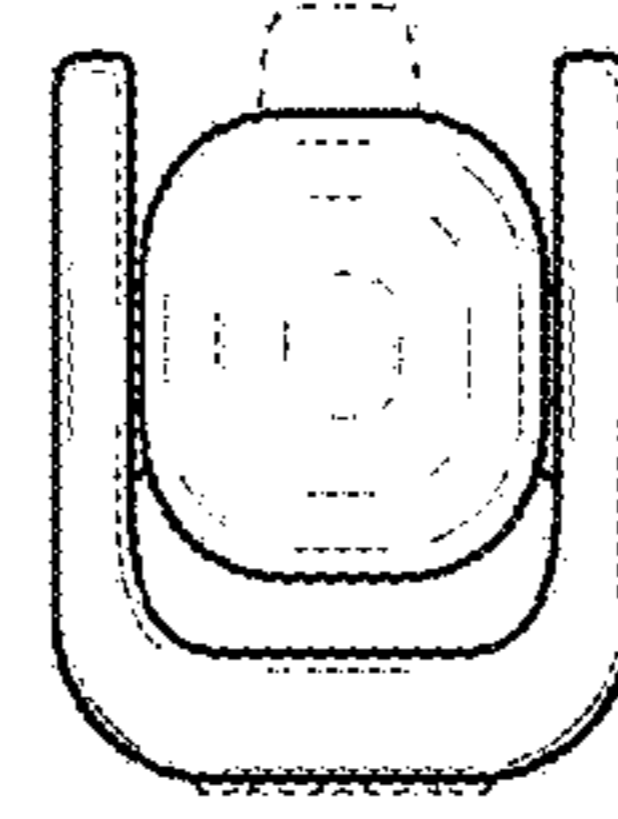

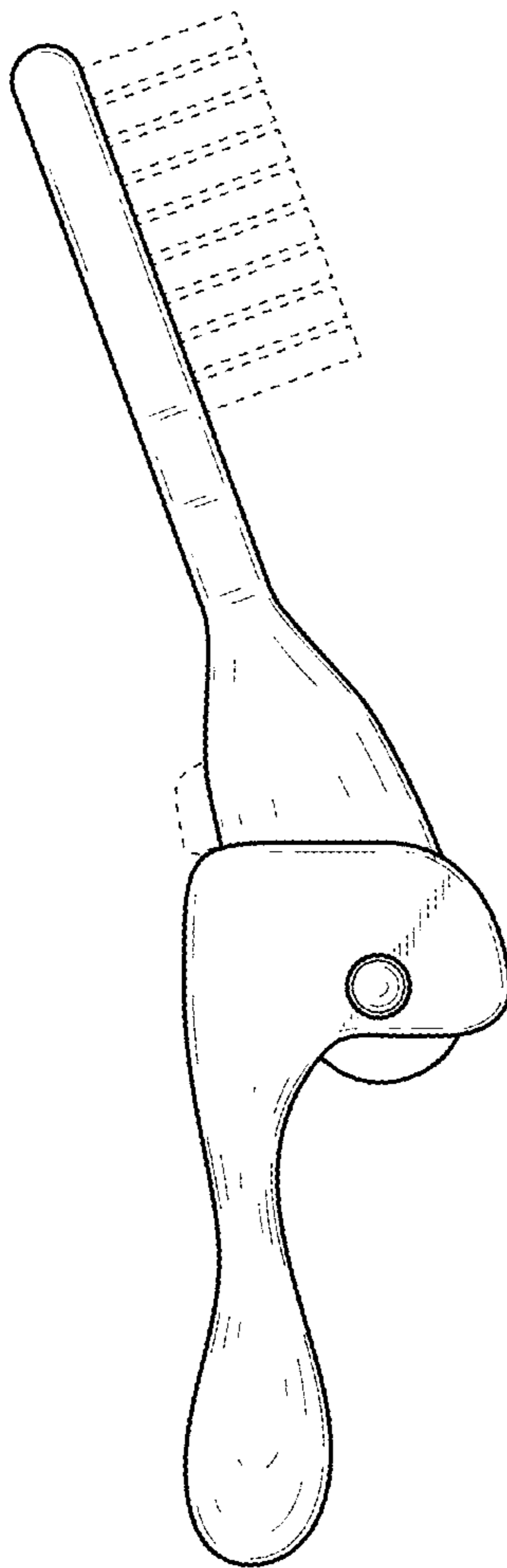
