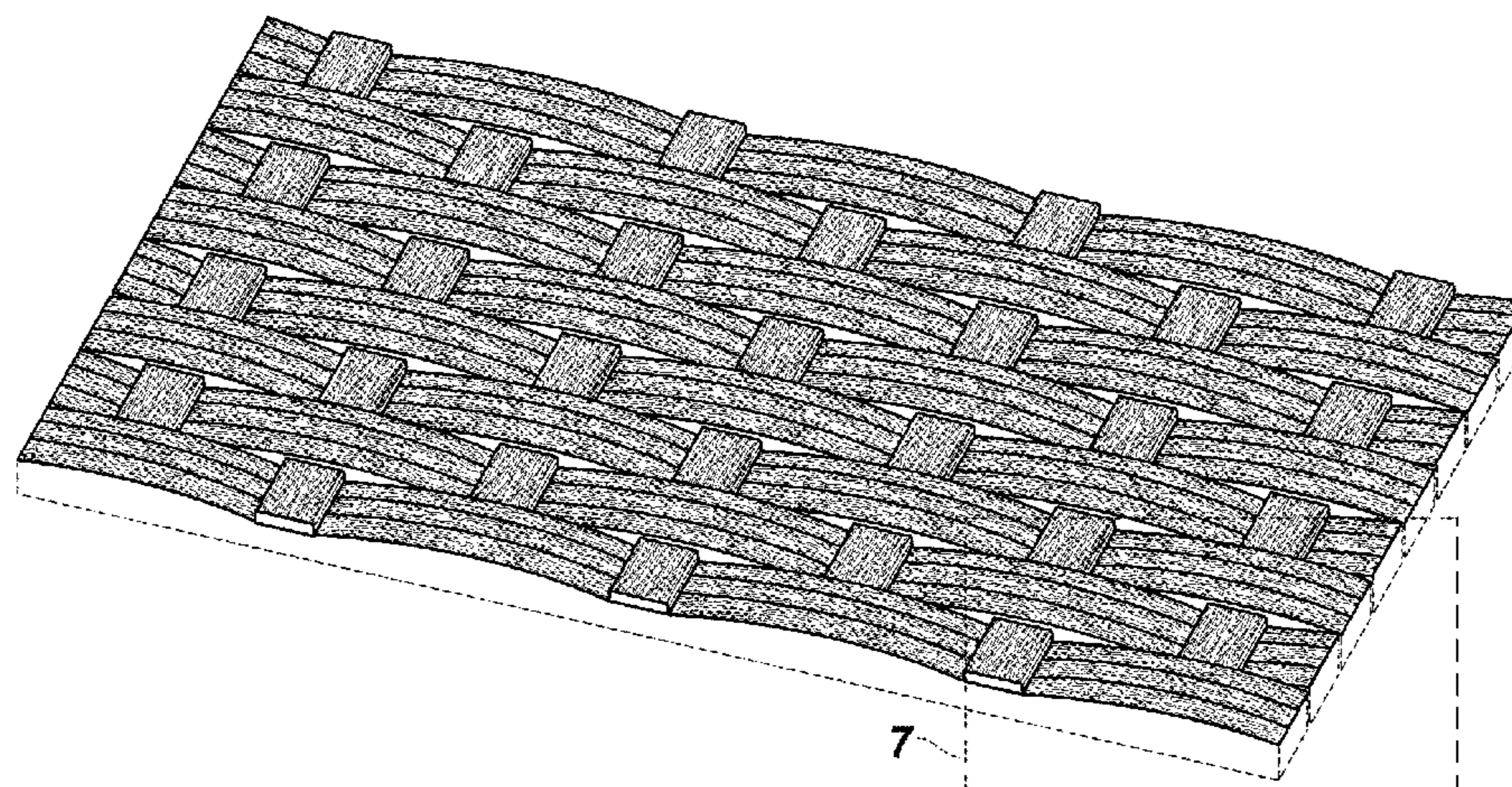
(57) **CLAIM**
 The ornamental design for a thermoplastic wicker panel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the thermoplastic wicker panel.
 FIG. 2 is a front view thereof.
 FIG. 3 is a bottom view thereof.
 FIG. 4 is a top view thereof.
 FIG. 5 is a right side view thereof.
 FIG. 6 is a left side view thereof.
 FIG. 7 is an enlarged detail view of area 7 taken from FIG. 1; and,
 FIG. 8 is an enlarged detail view of area 8 taken from FIG. 5.
 The solid lines depict the boundaries to the claim. The broken lines and the areas underneath the sold line boundaries form no part of the claimed design. In addition, the rear view of the thermoplastic wicker panel shown in FIGS. 1-6 is intentionally omitted and does not comprise additional features of the claimed design.

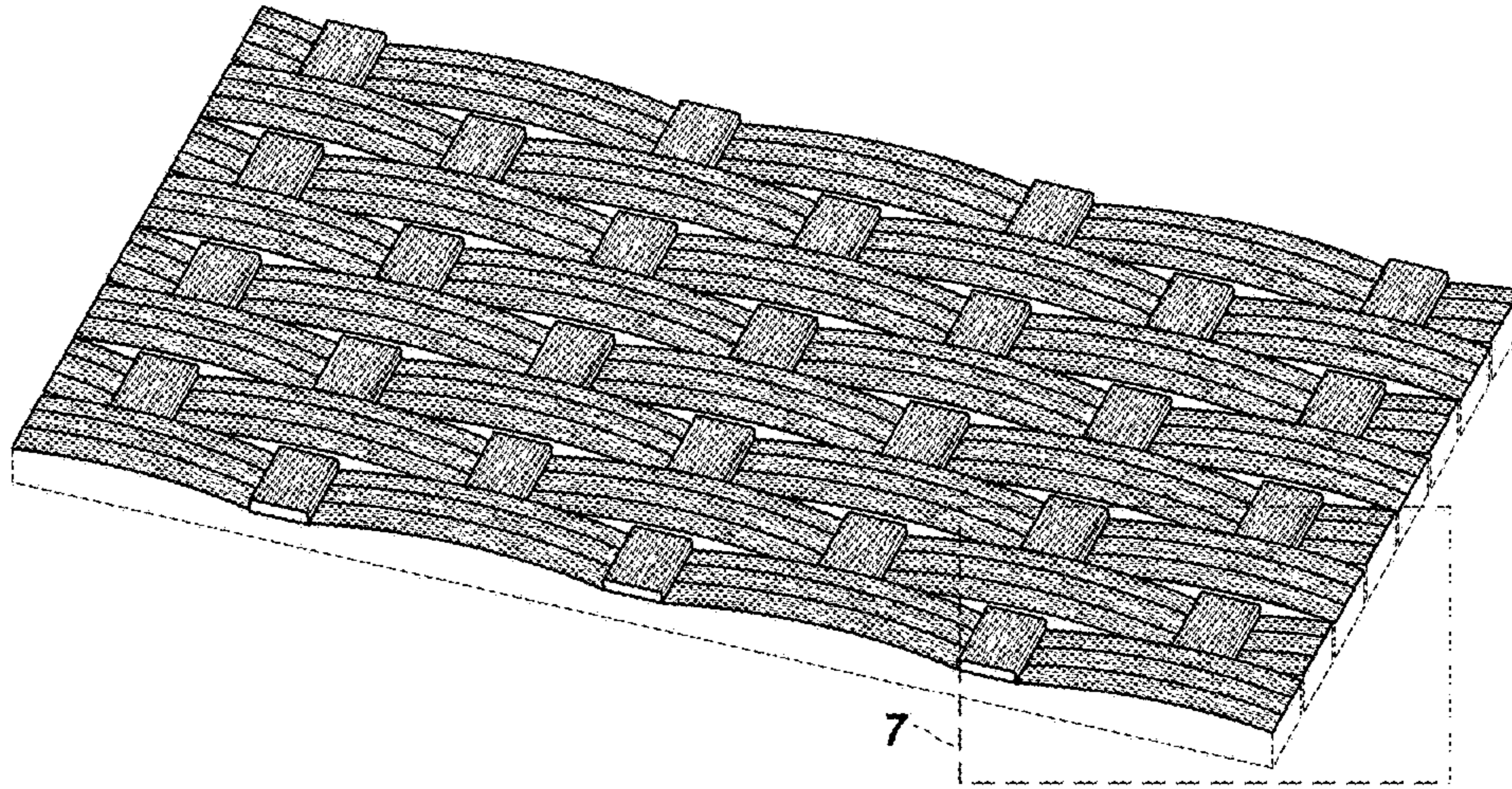

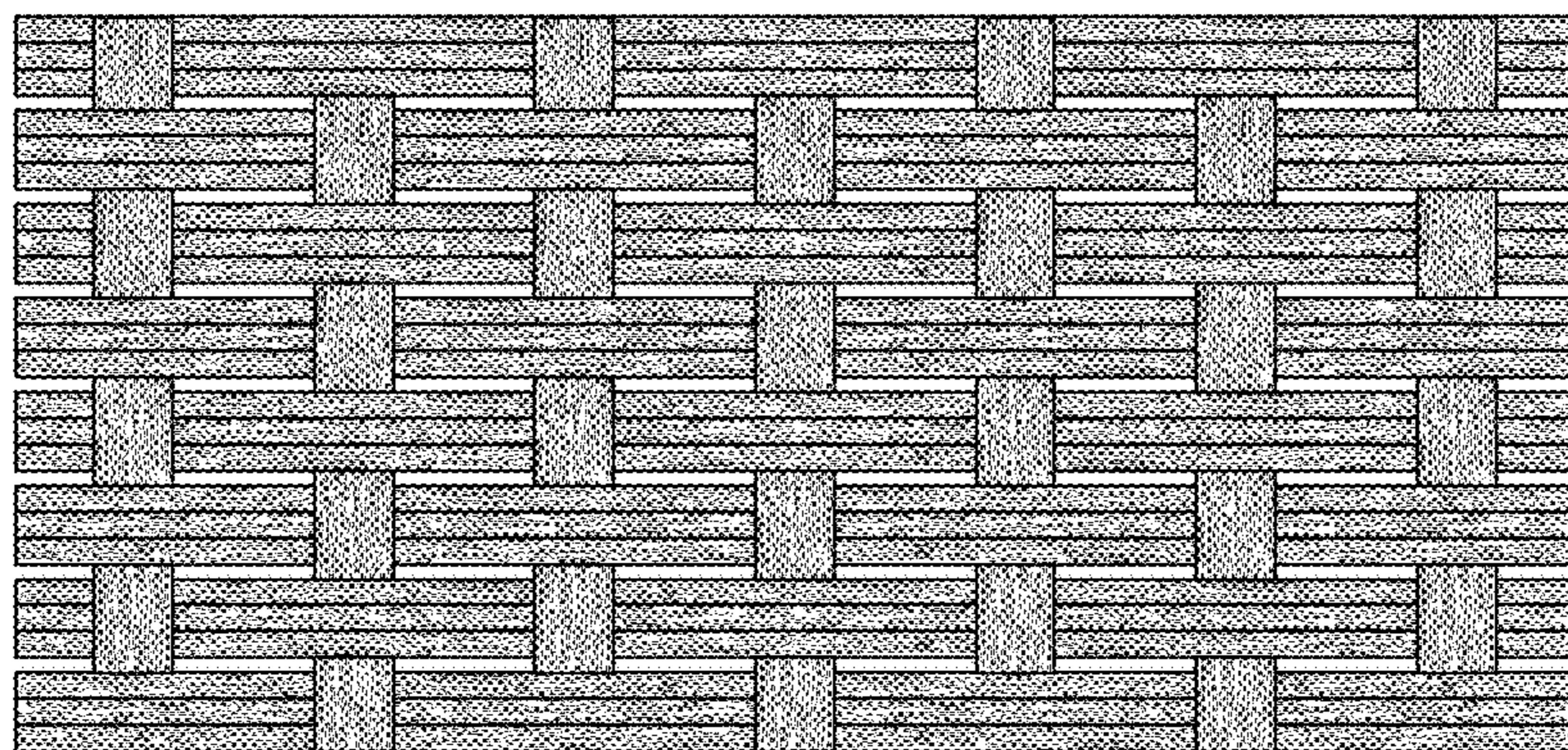

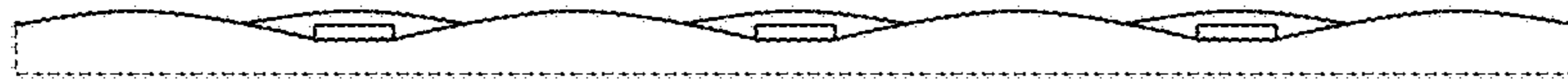

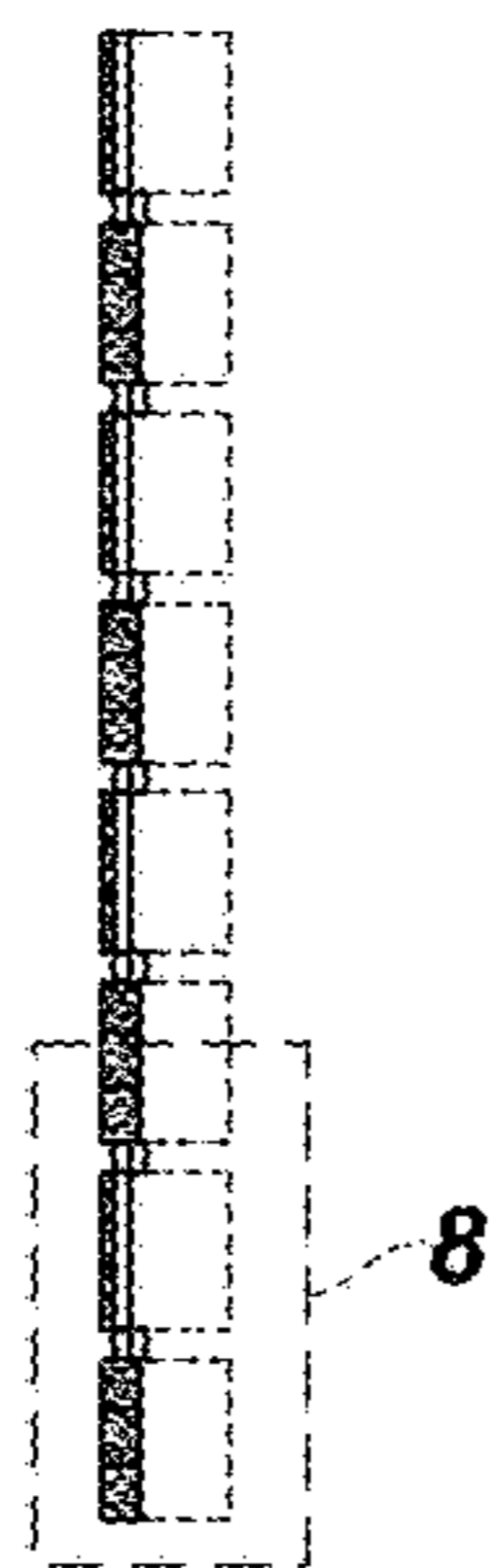

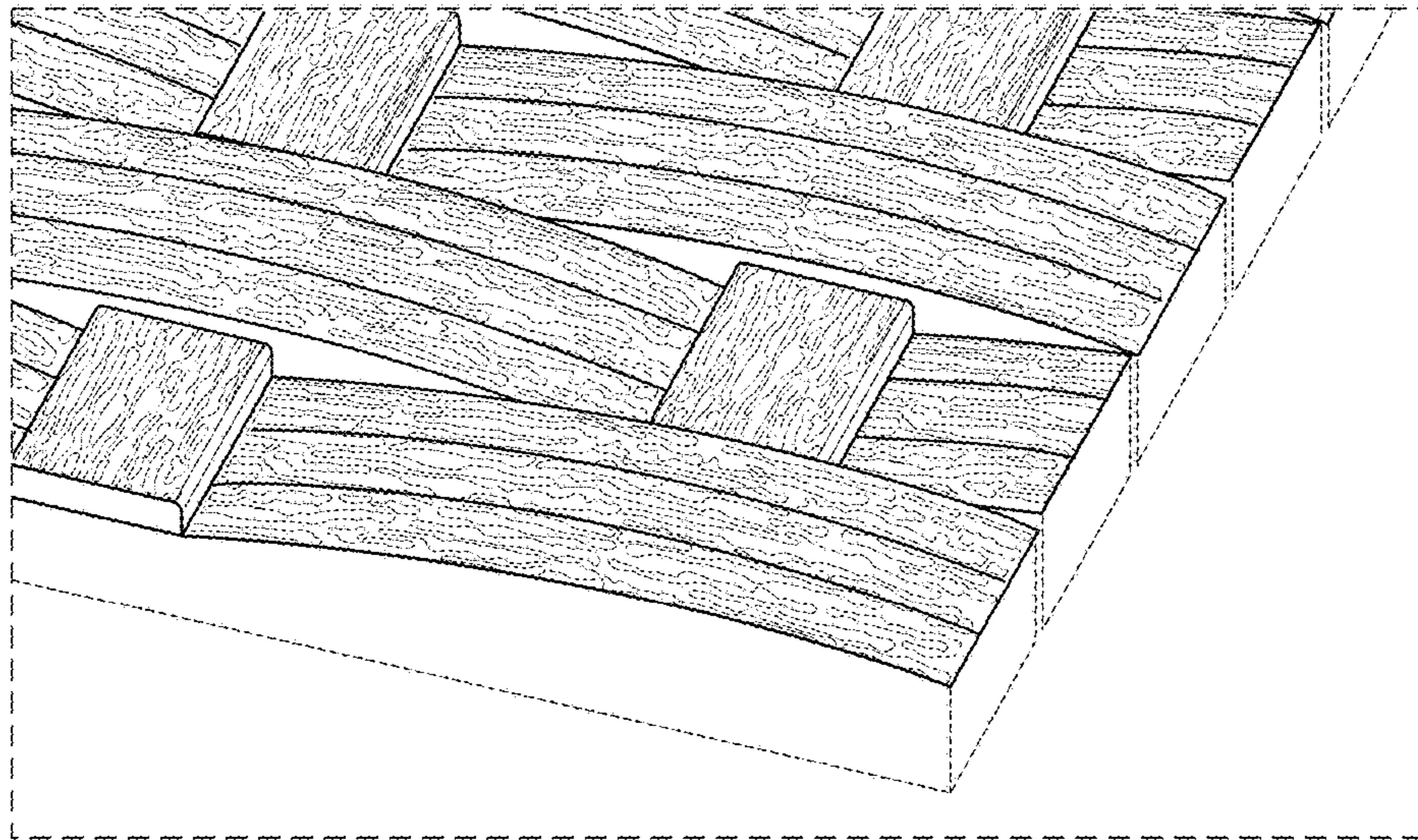

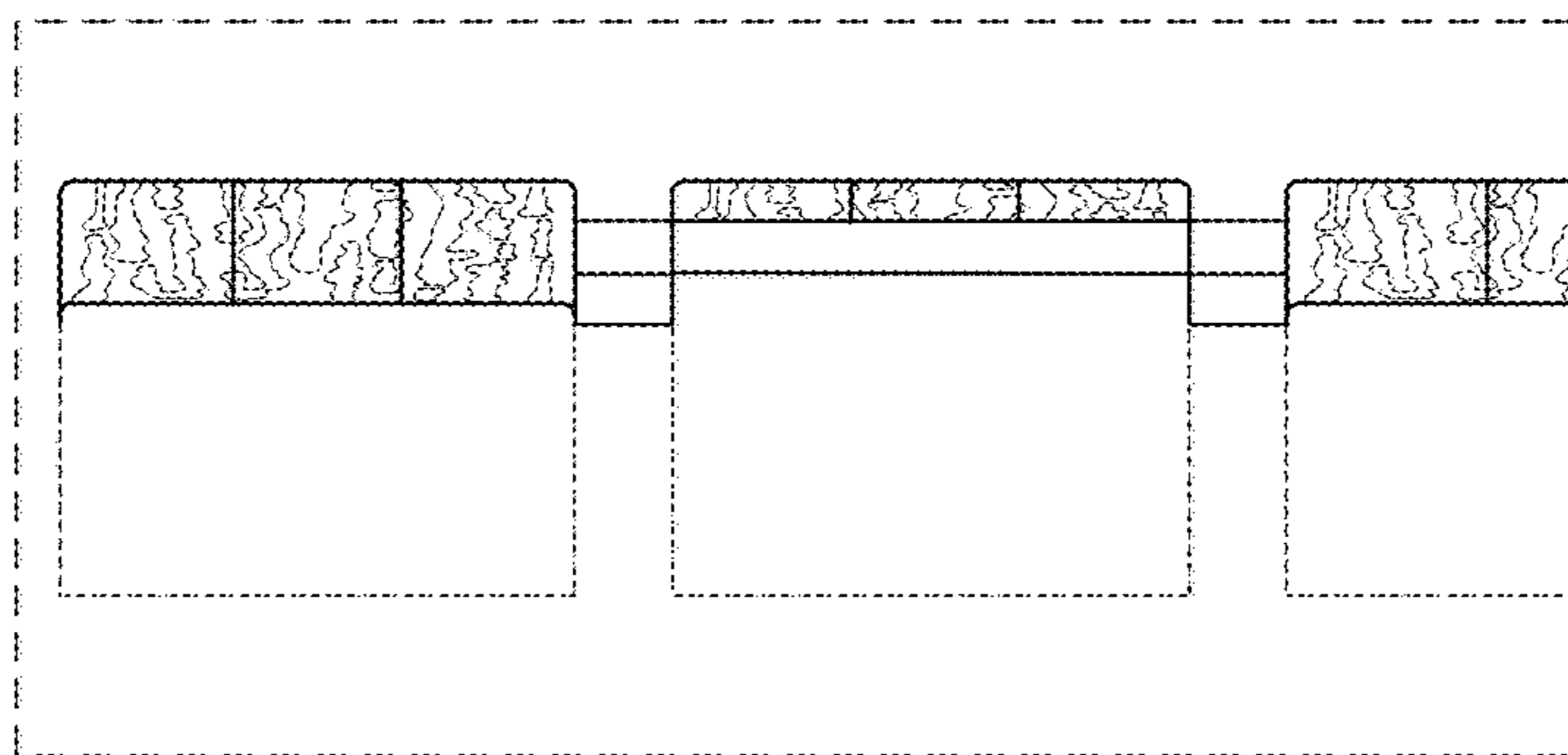
