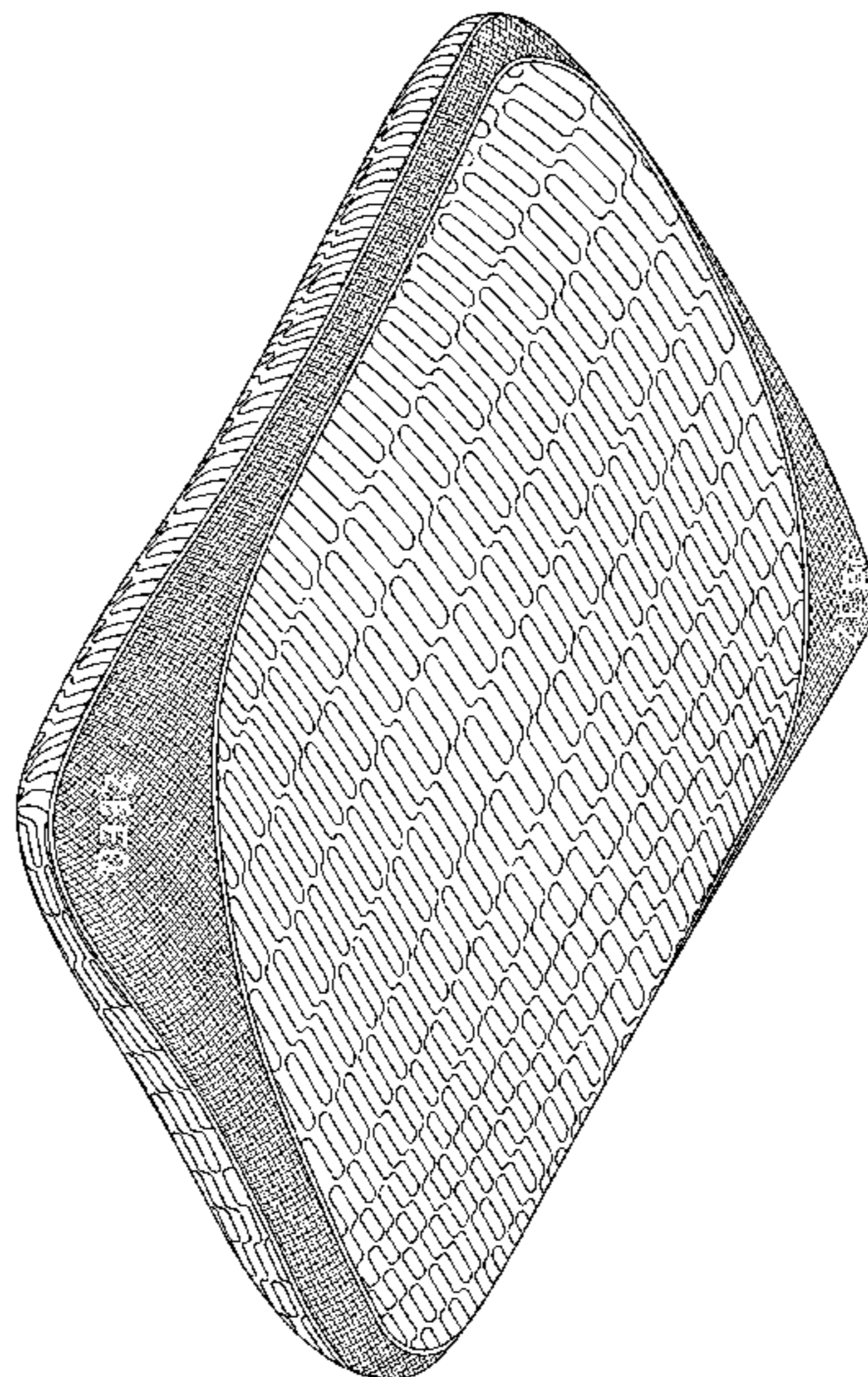

DESCRIPTION

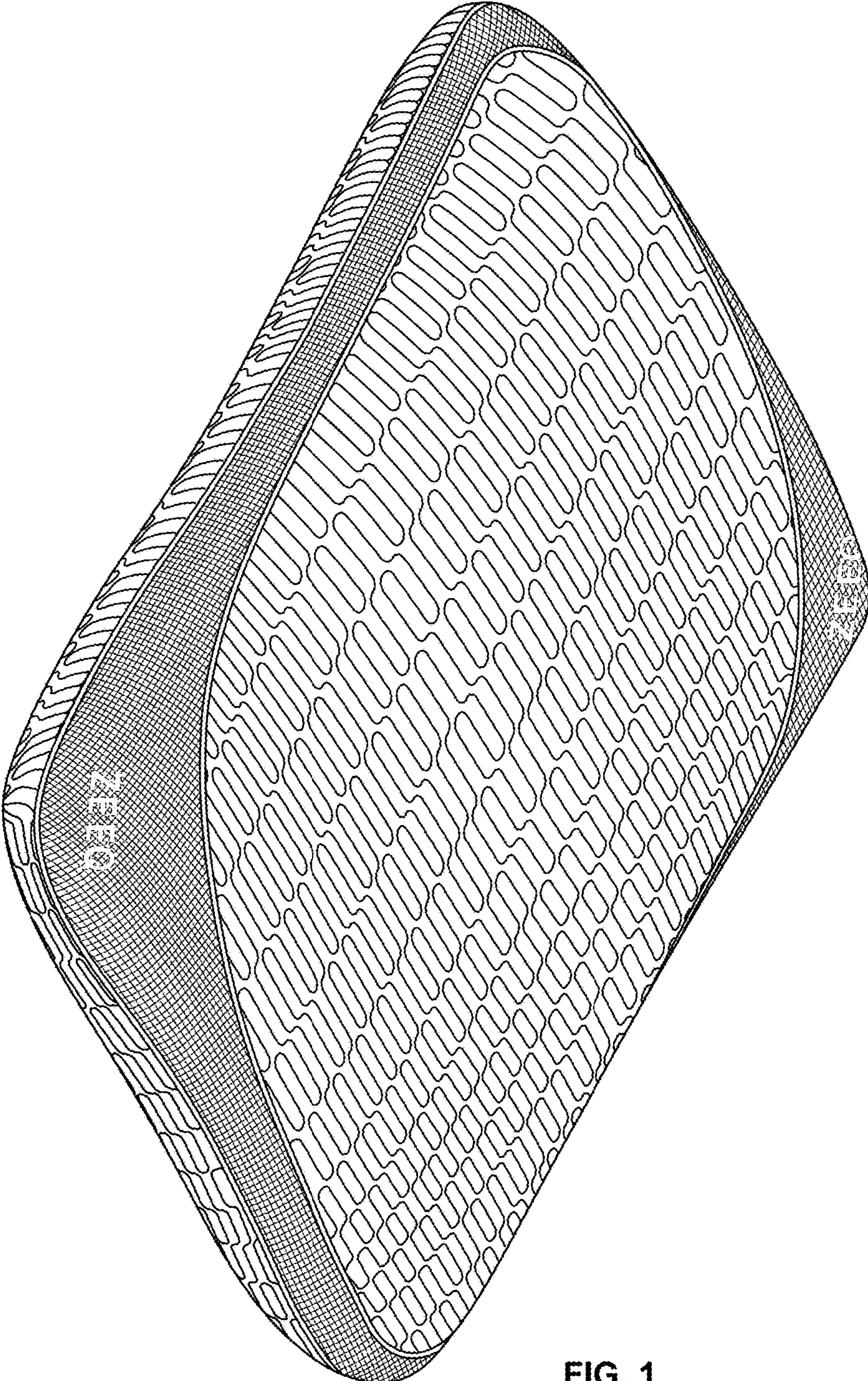

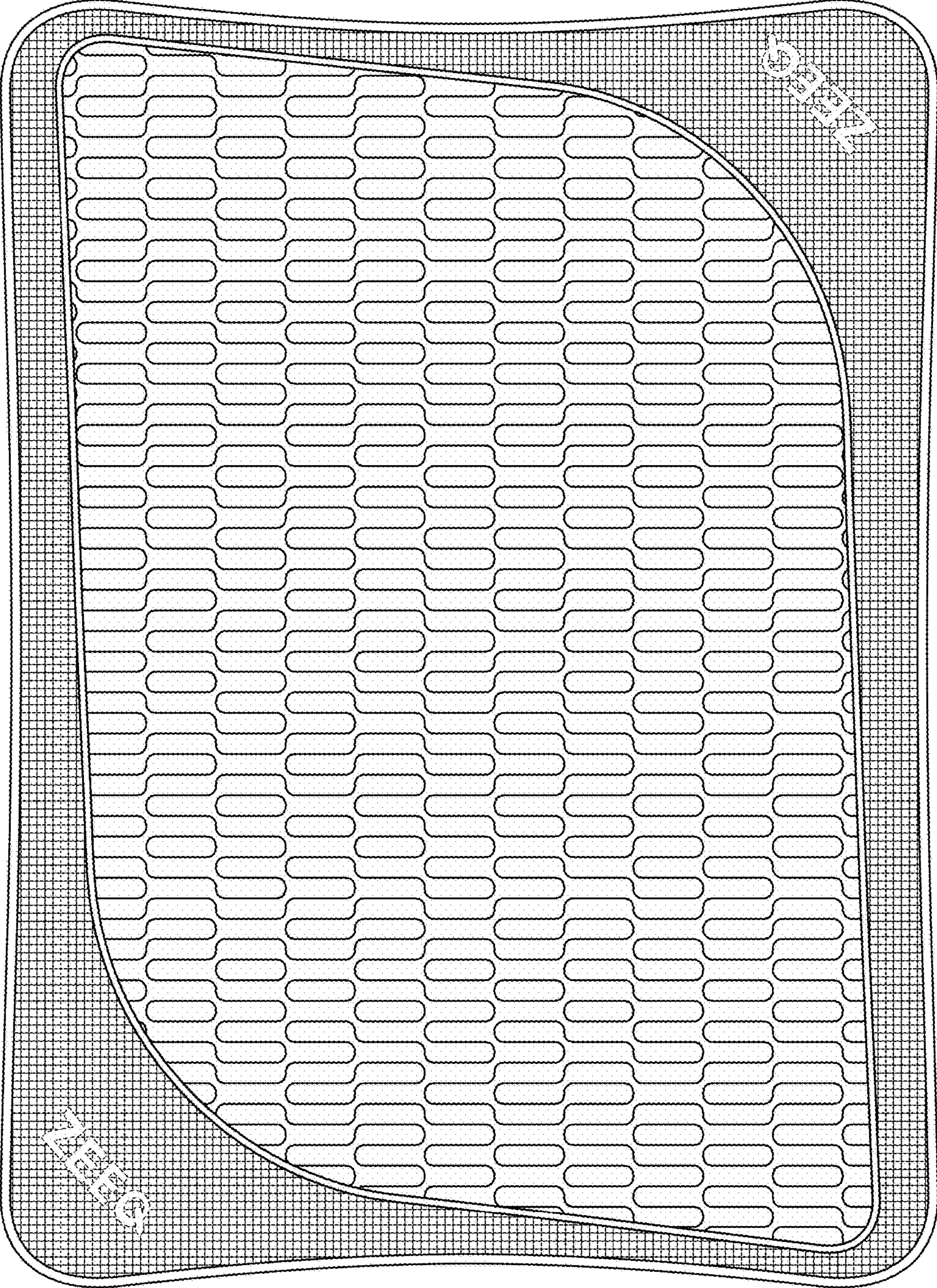

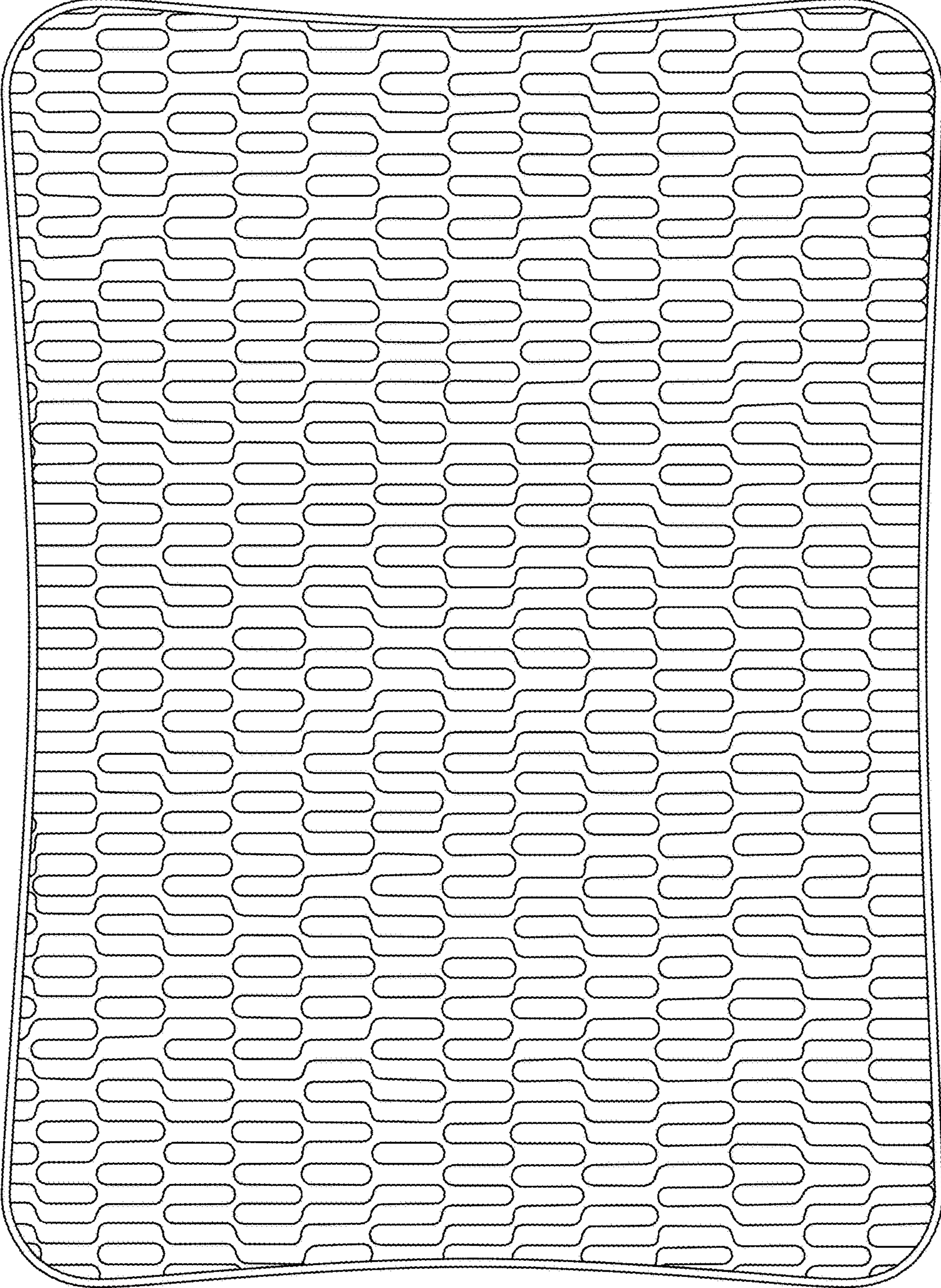

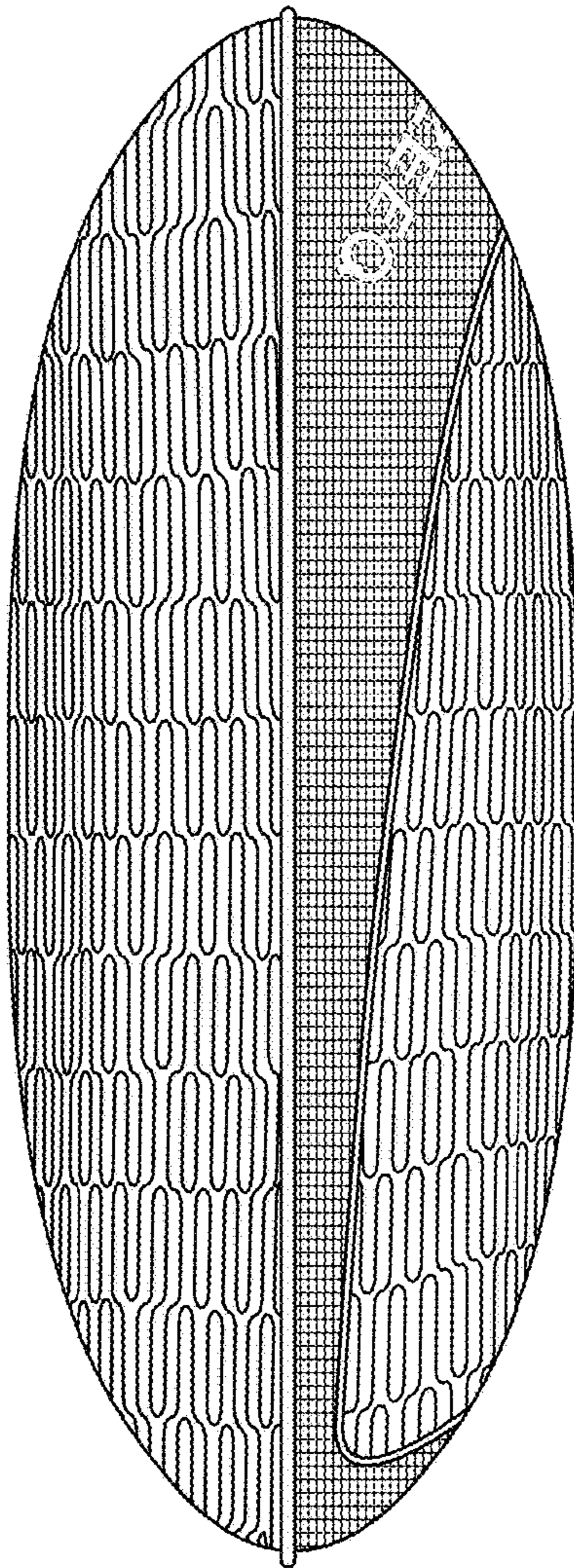

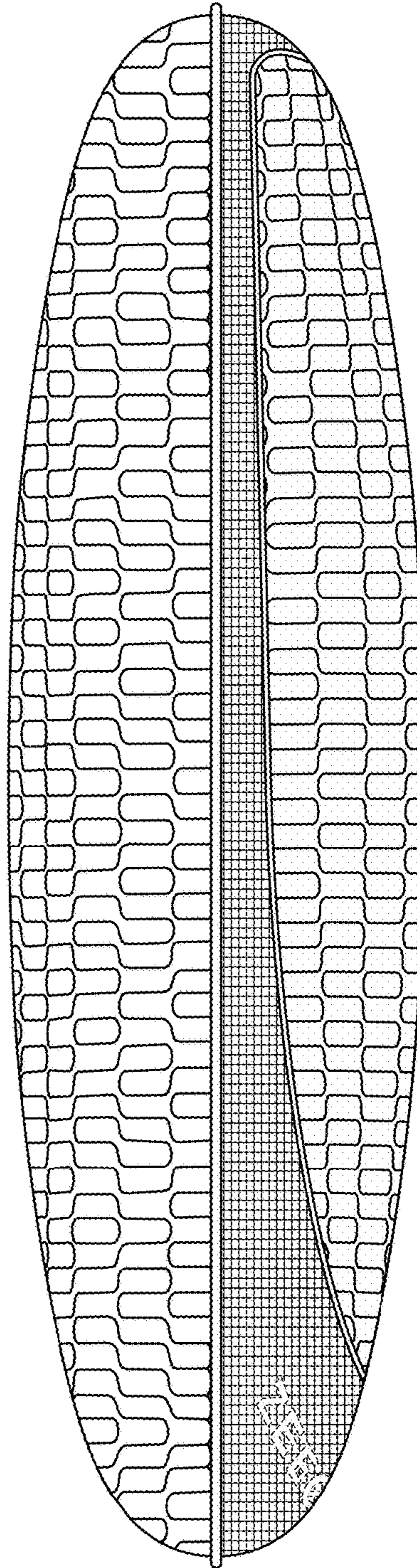
