The ornamental design for a grilling apparatus, as shown and described.

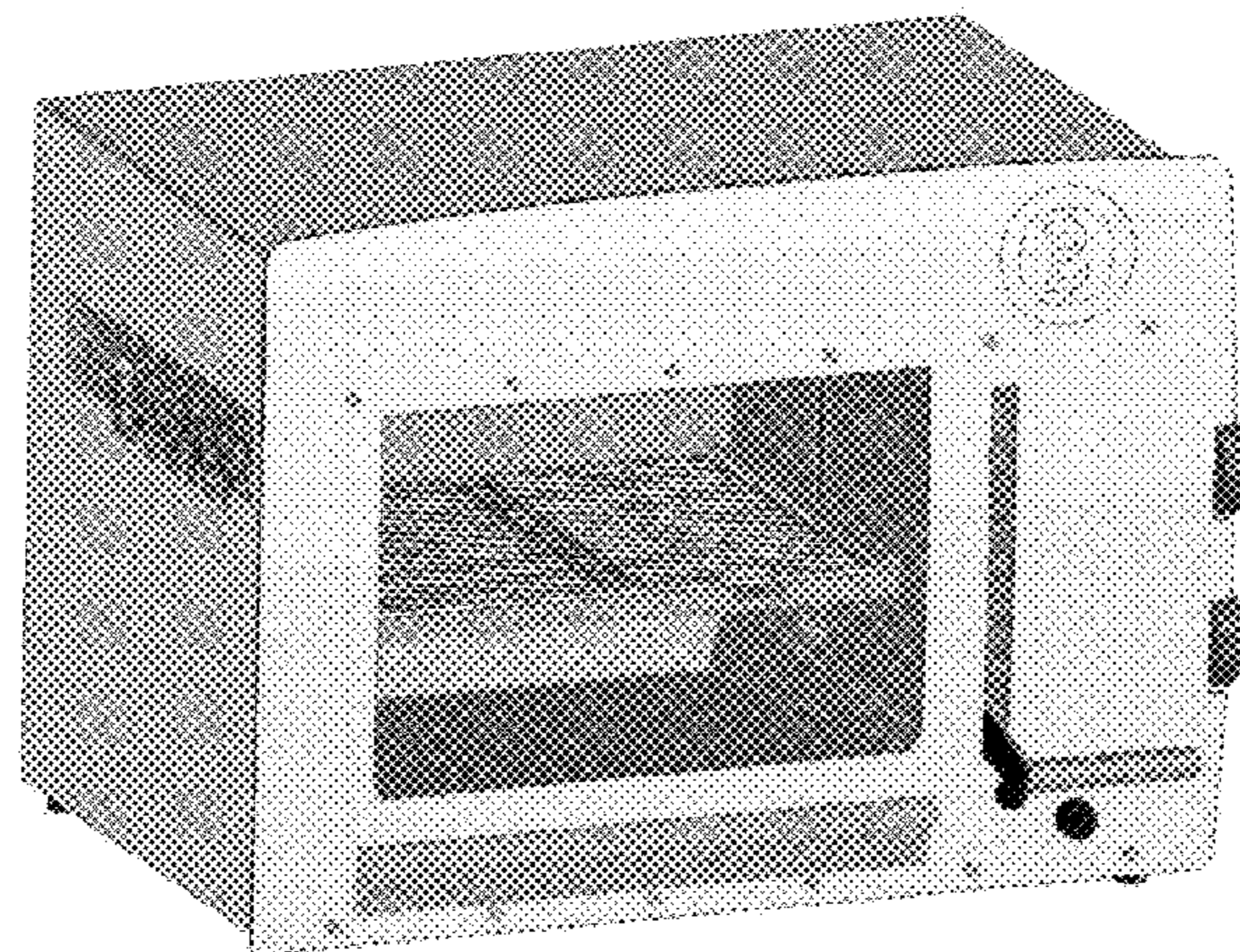
DESCRIPTION

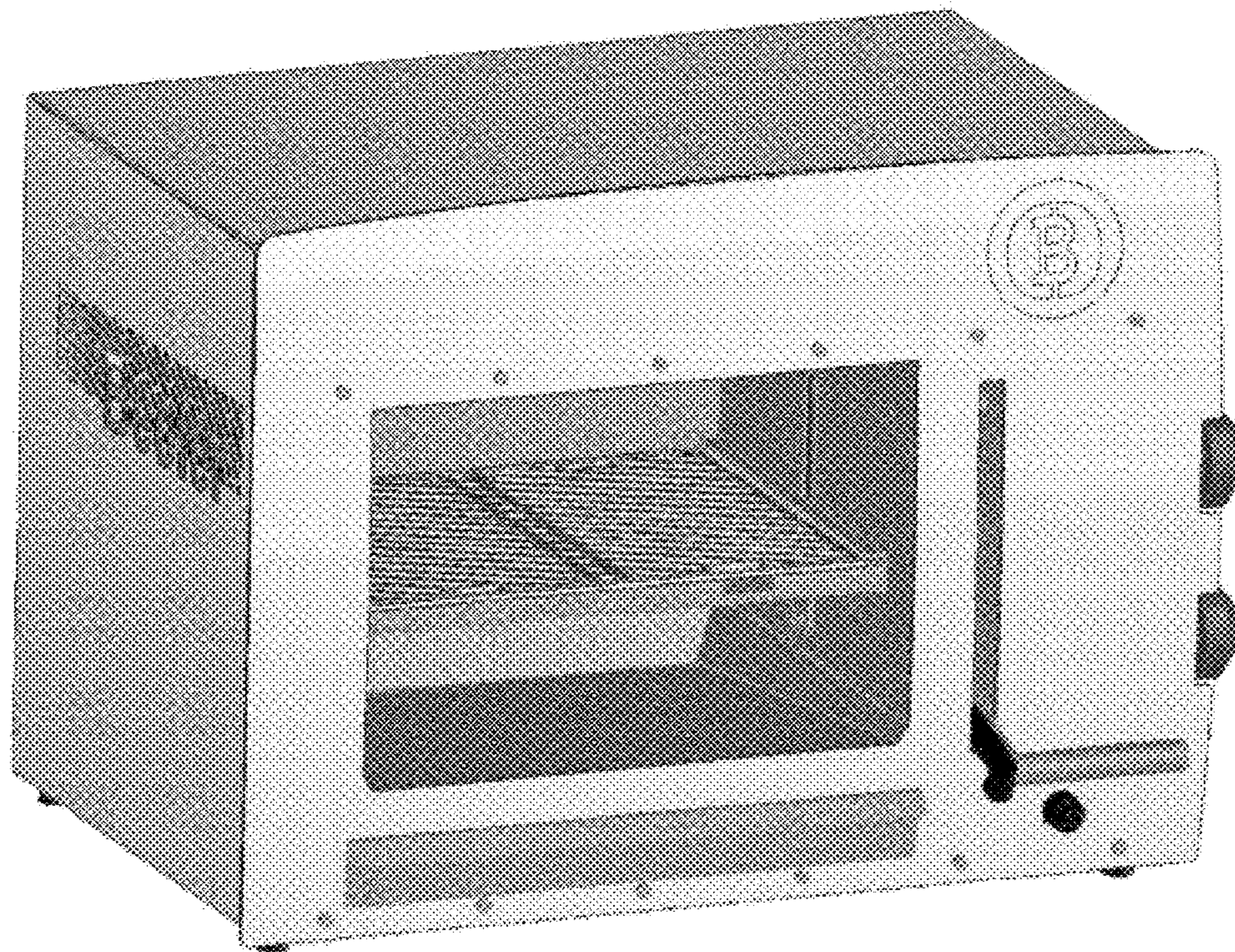
