The ornamental design for a cap for a medicine container, as shown and described.

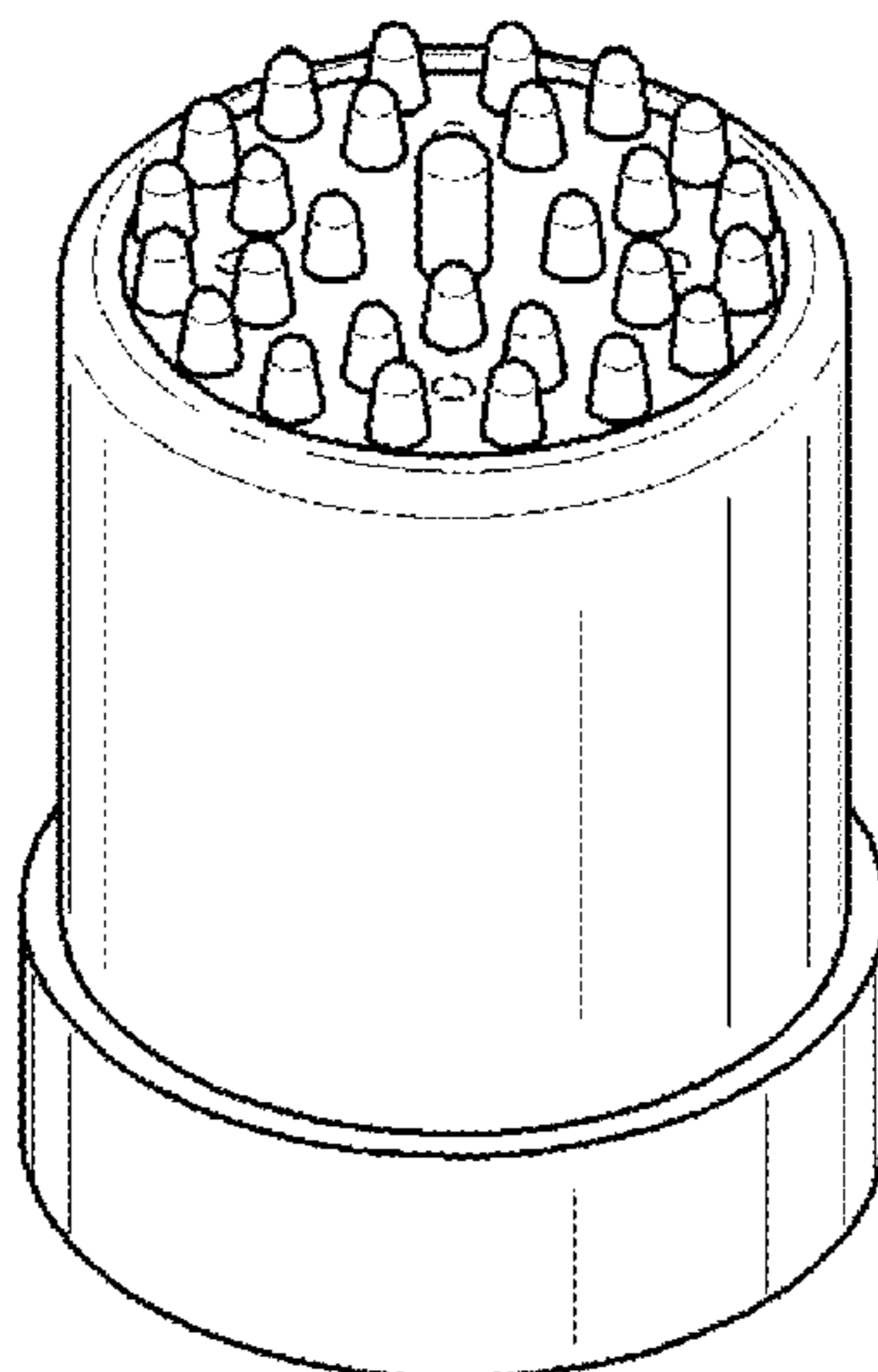

DESCRIPTION

FIG. 1 is a perspective view of a cap for a medicine container showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;

FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,

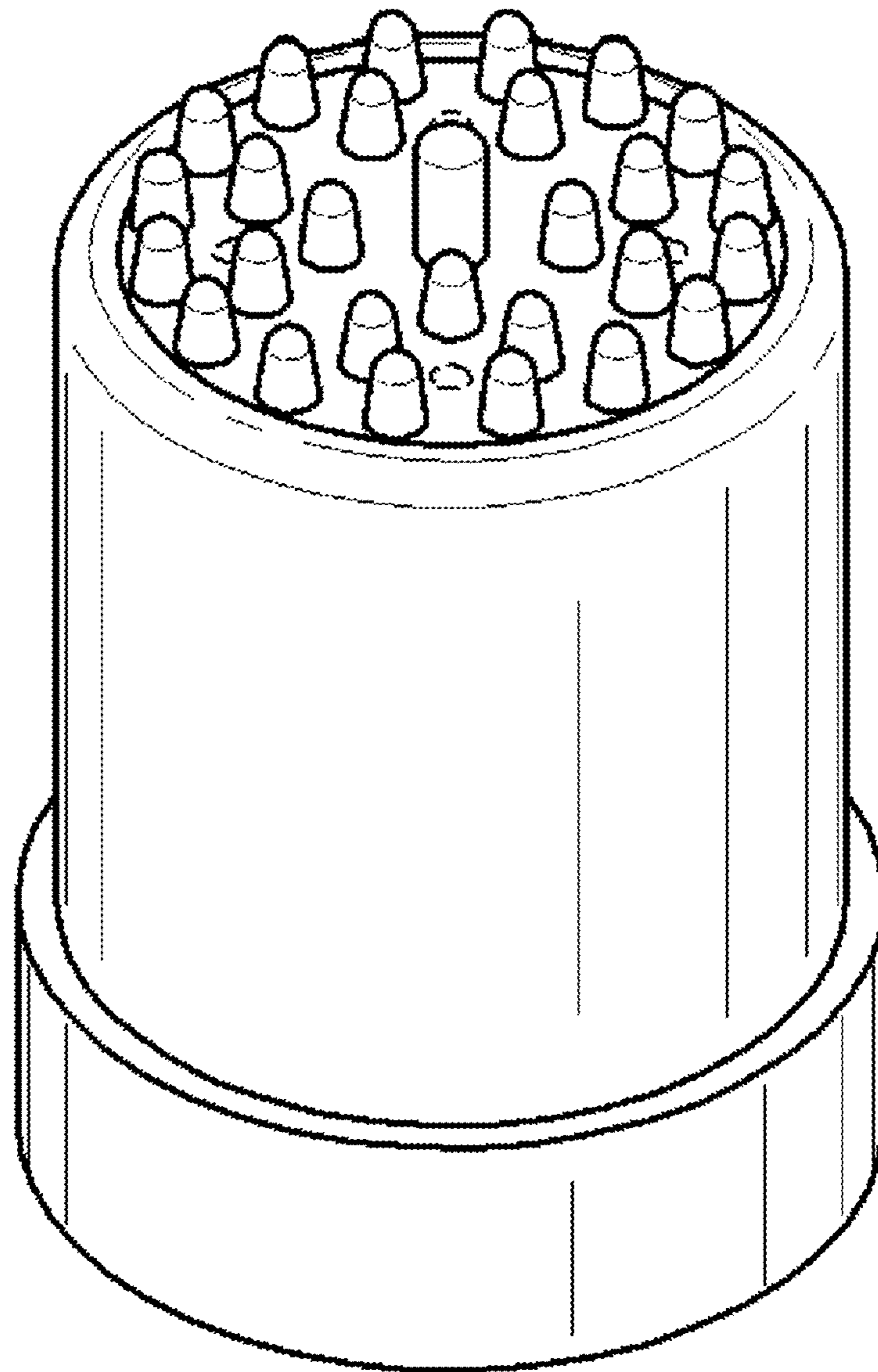

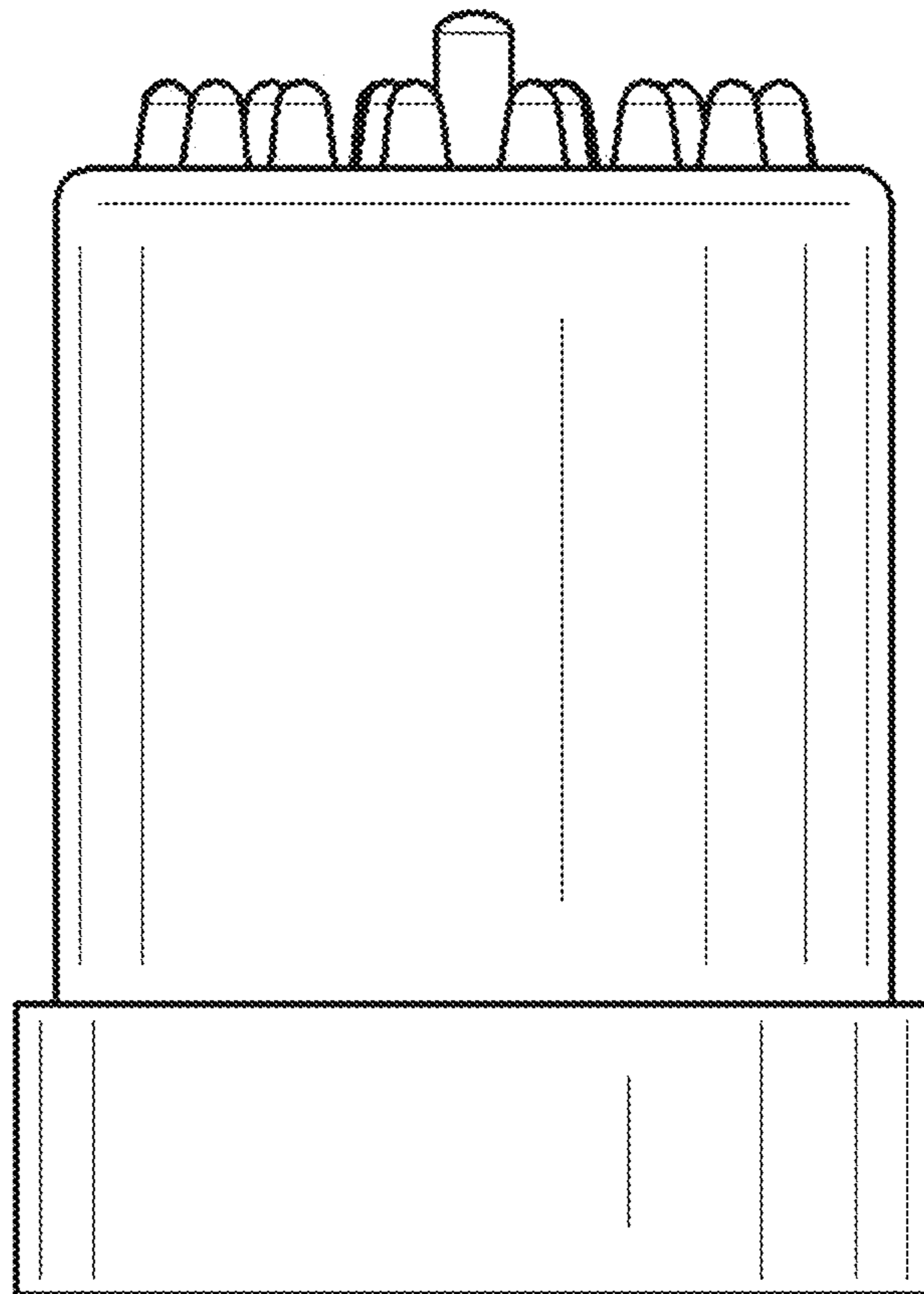

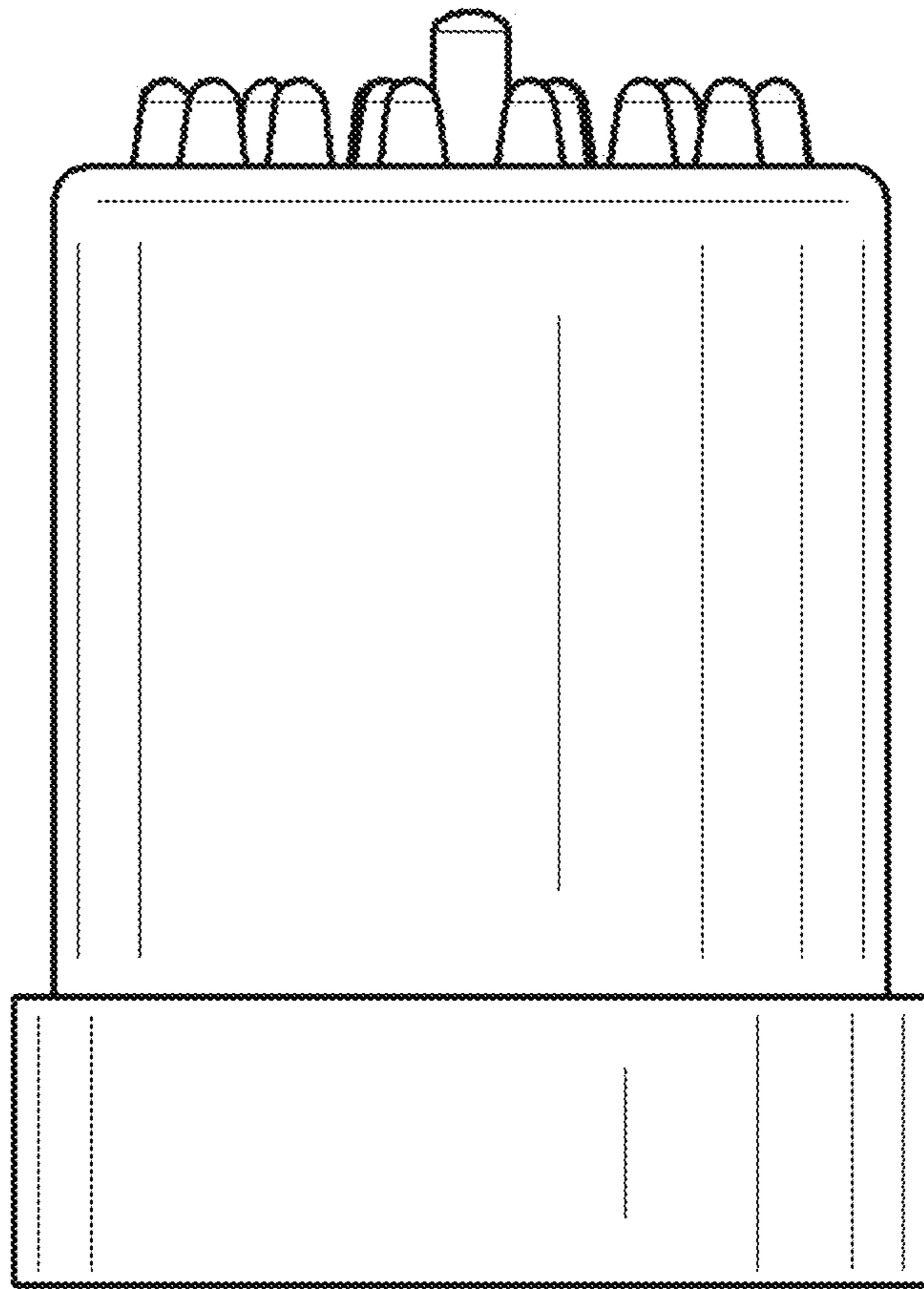

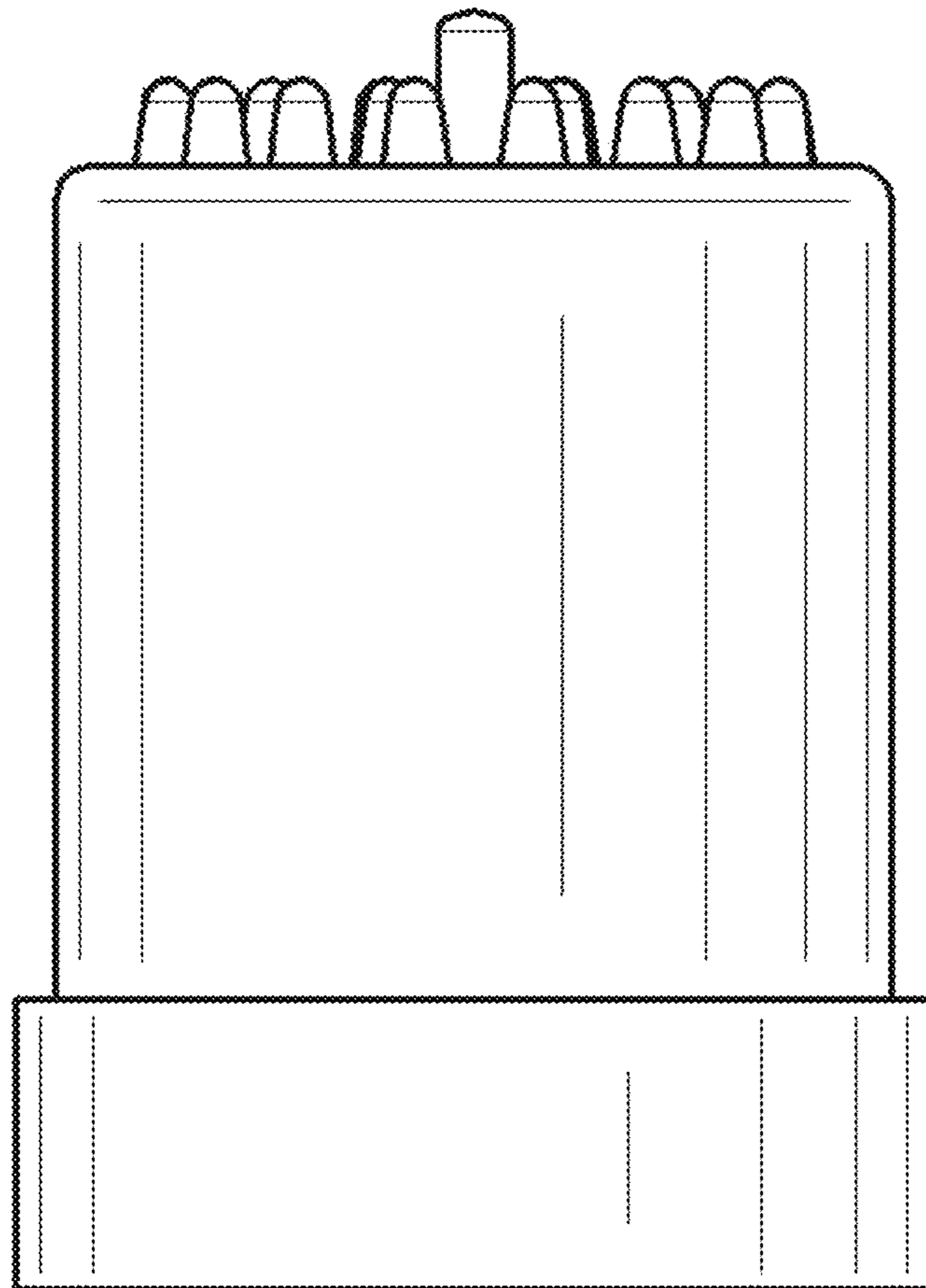

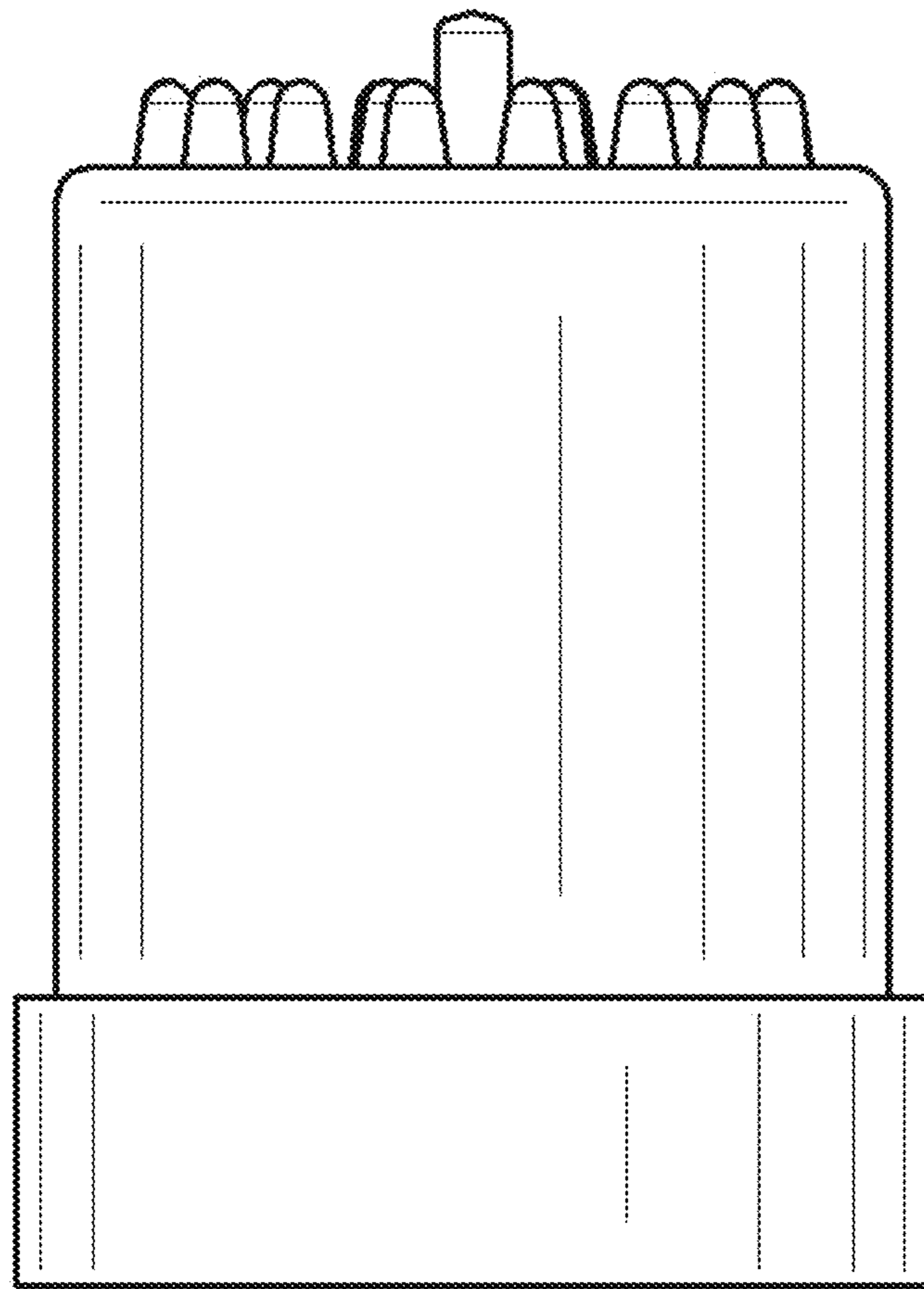

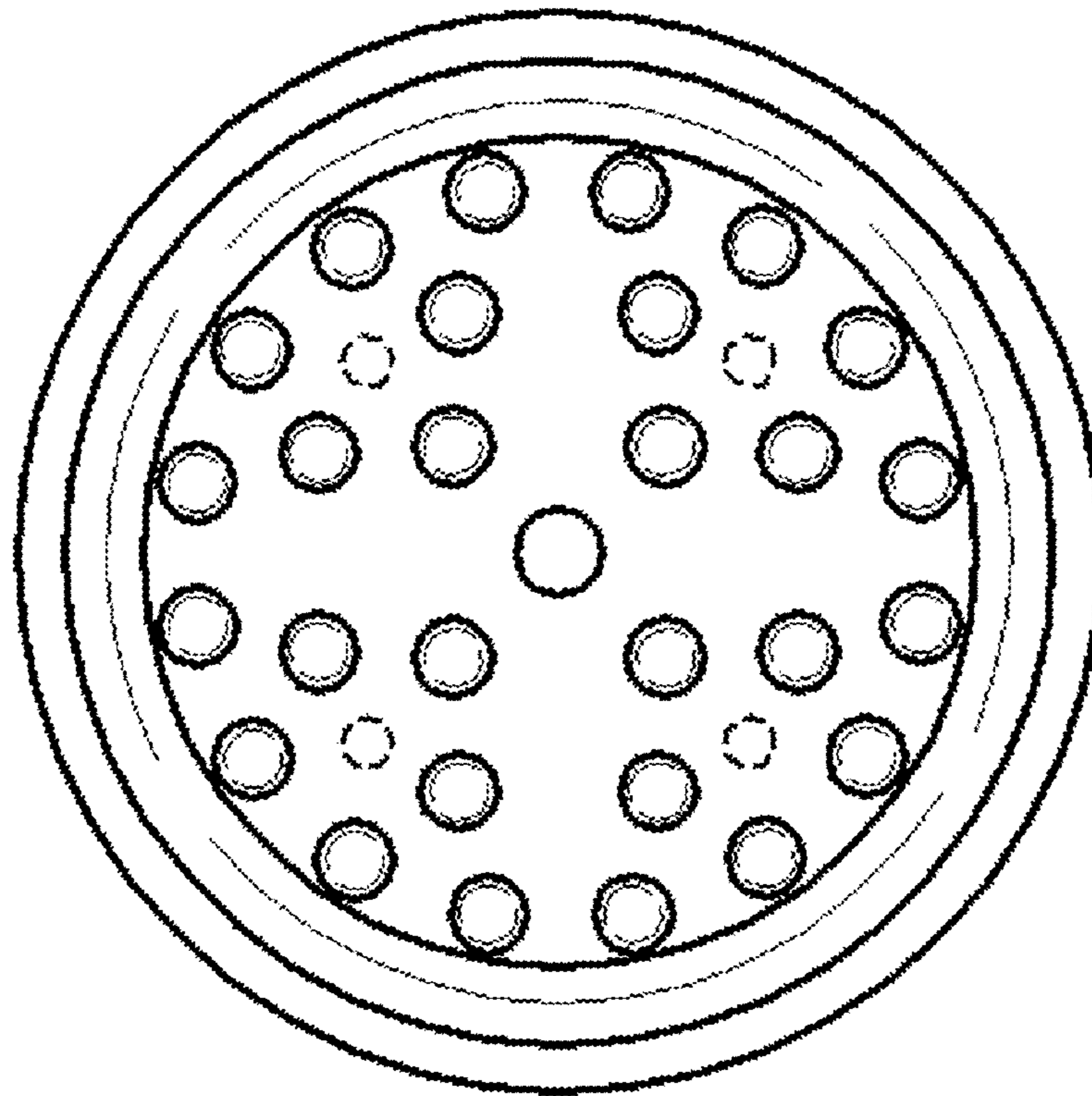

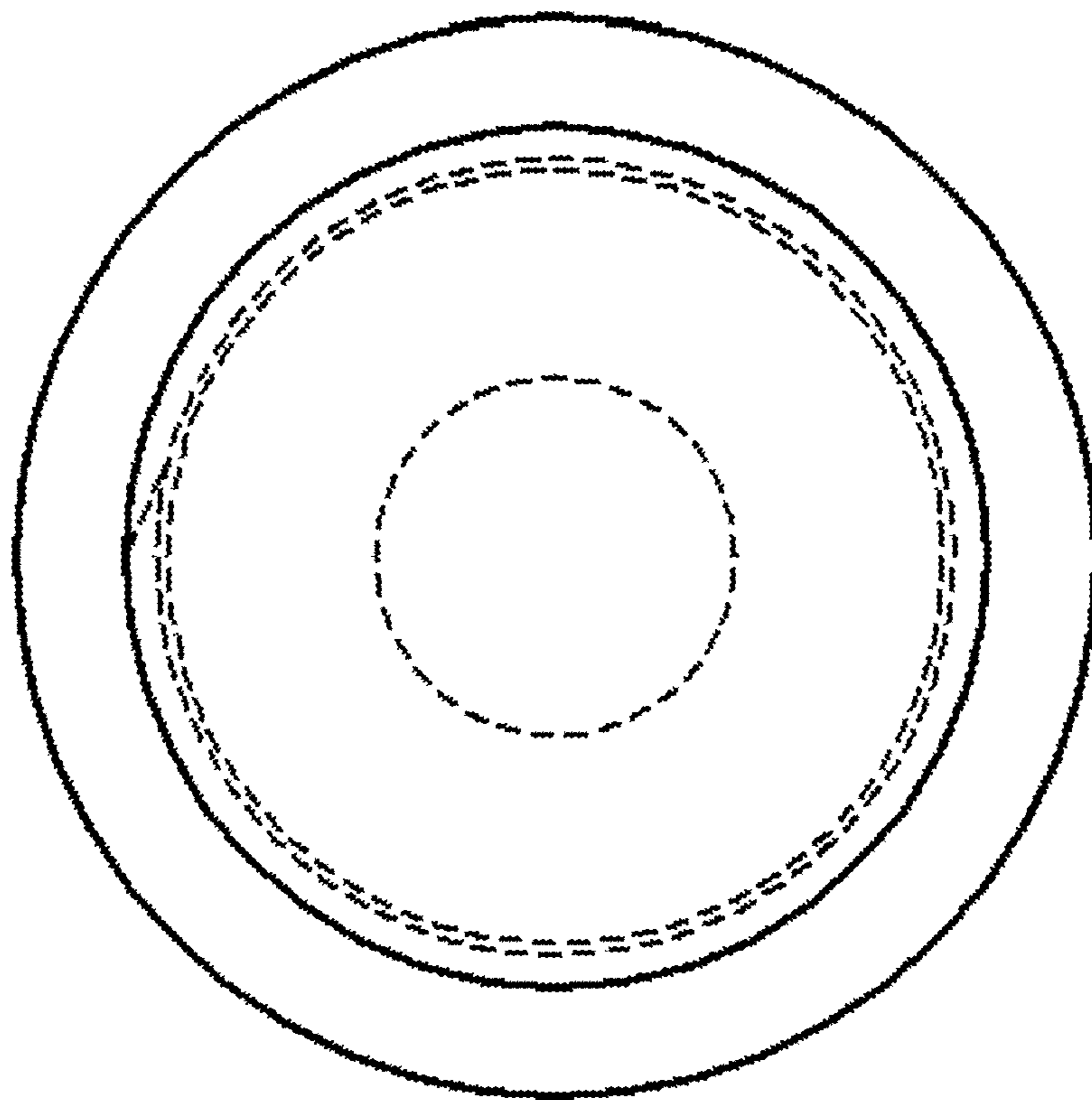
