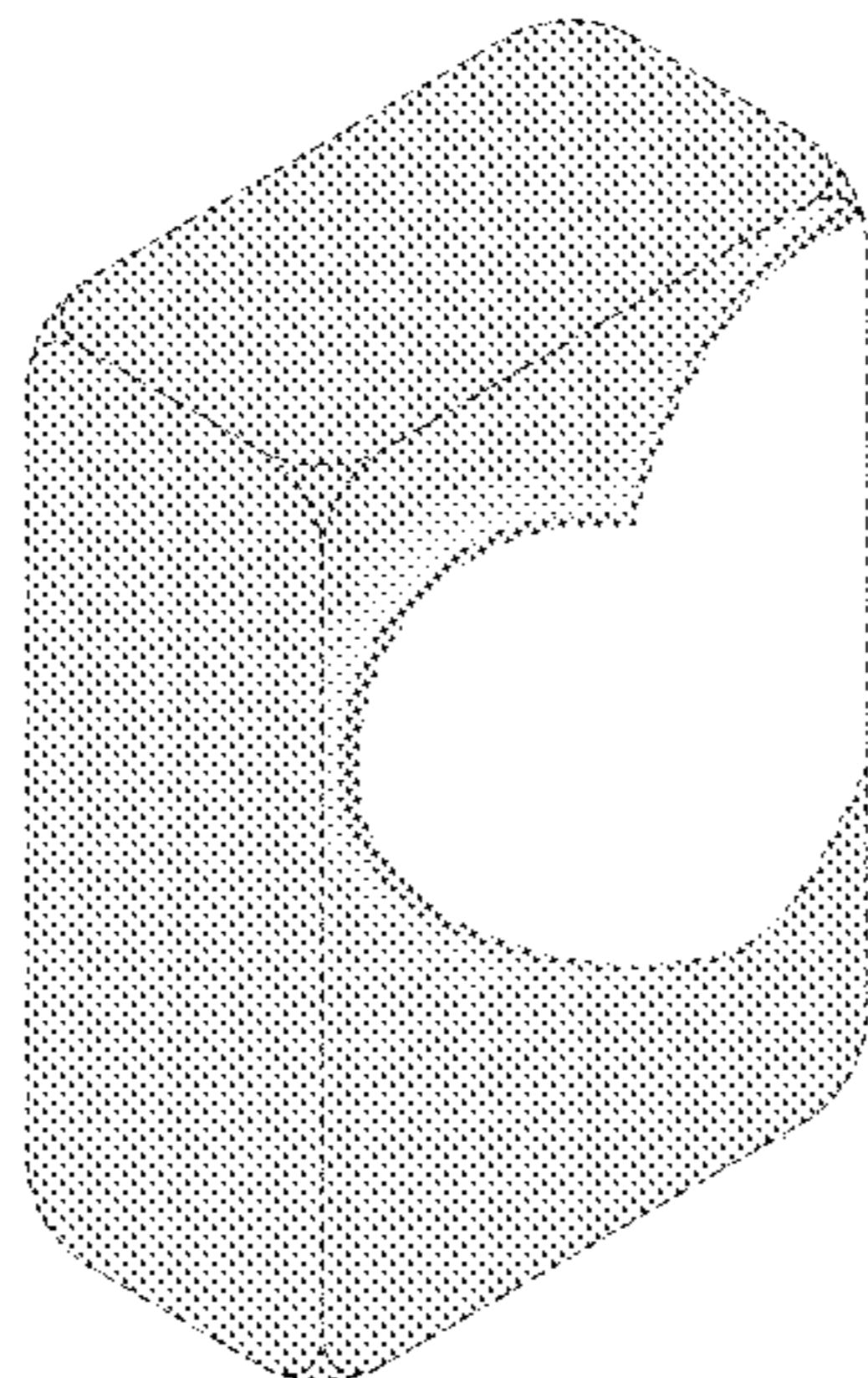


FIG. 18 is a left side view of the embodiment of the package shown in FIG. 15;

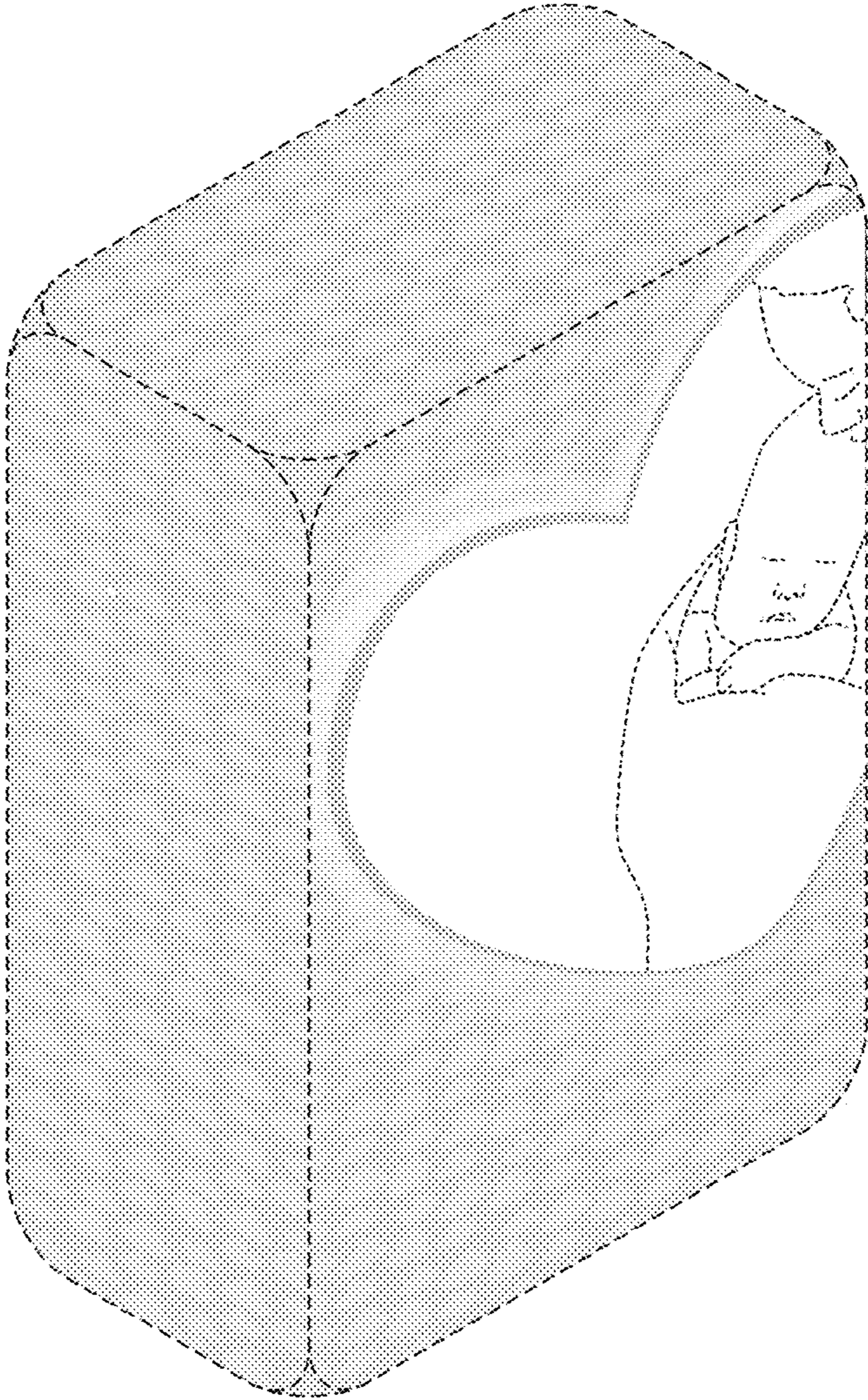

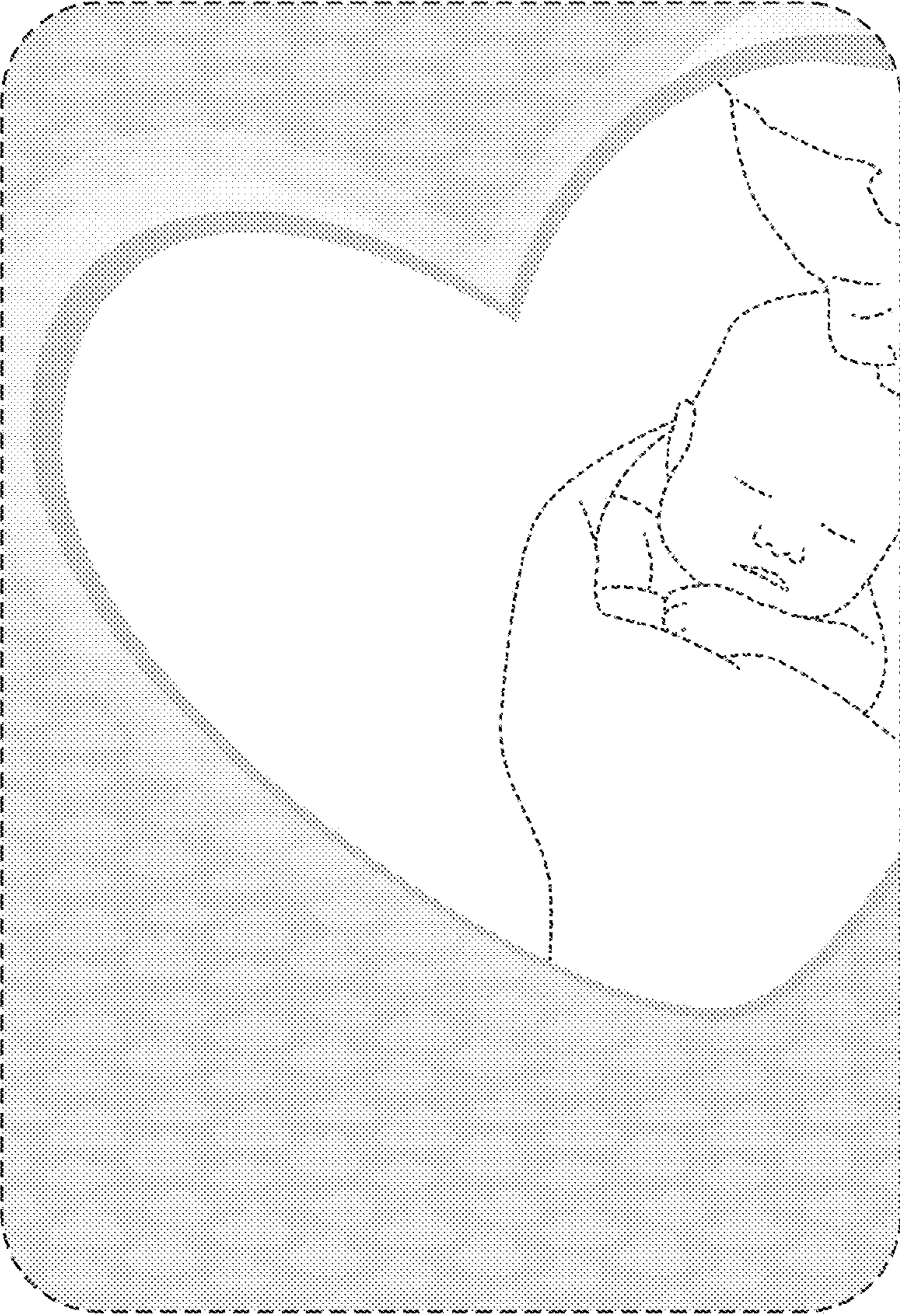

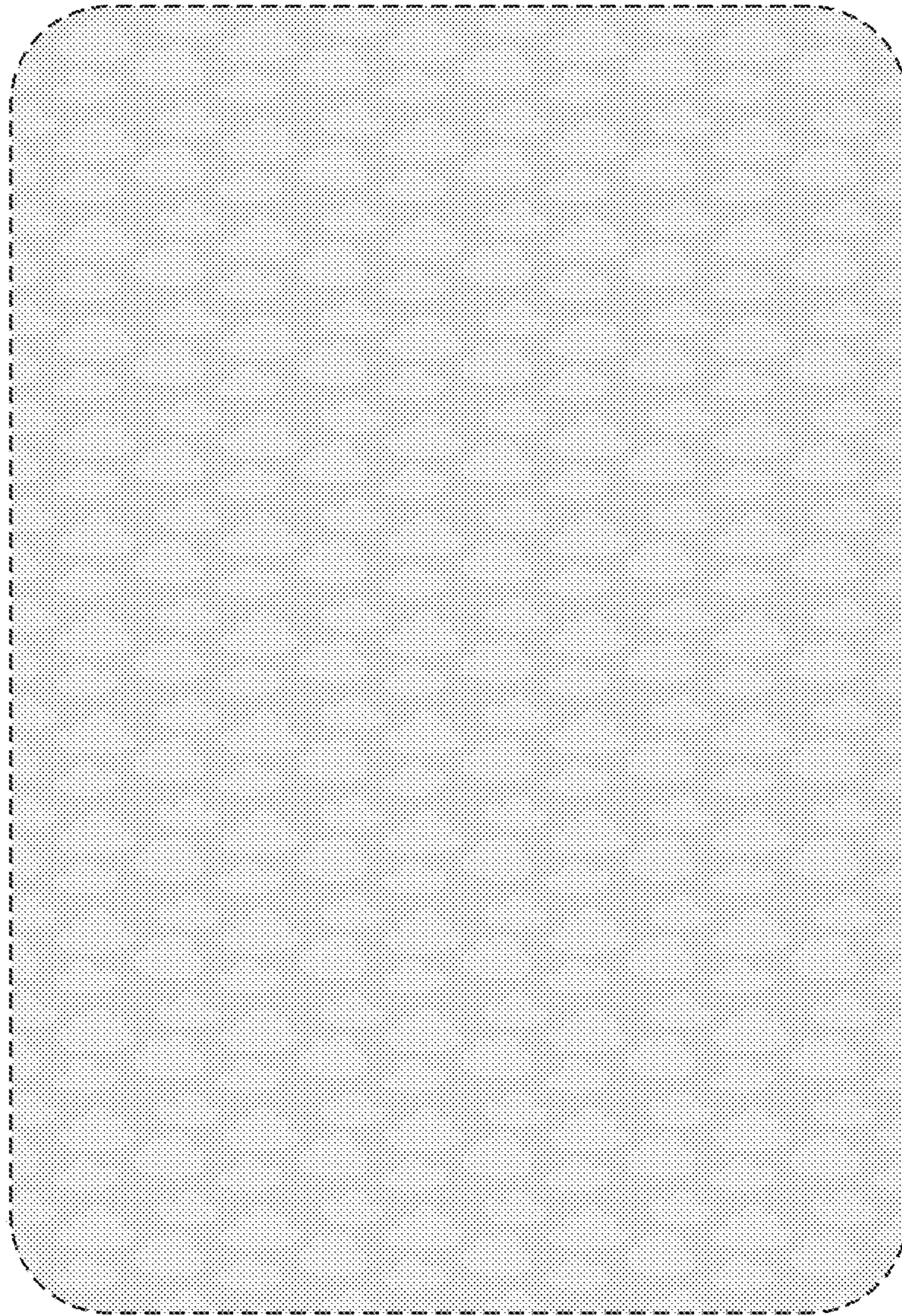

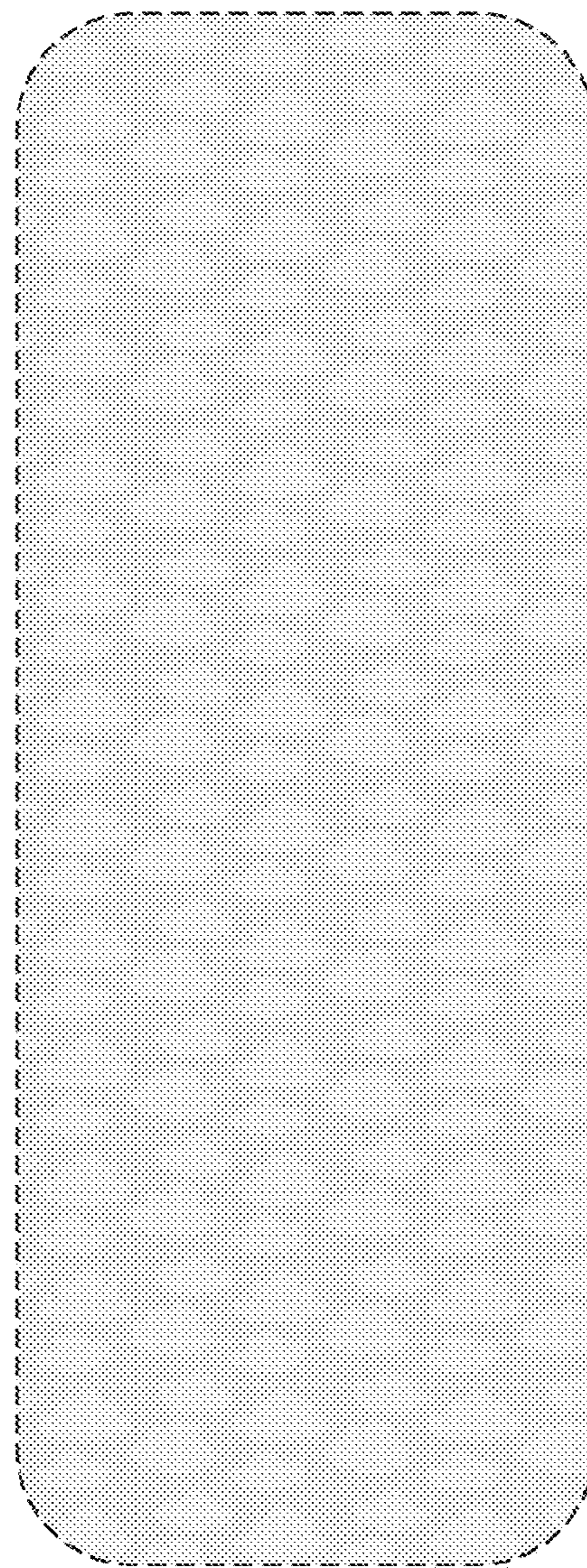

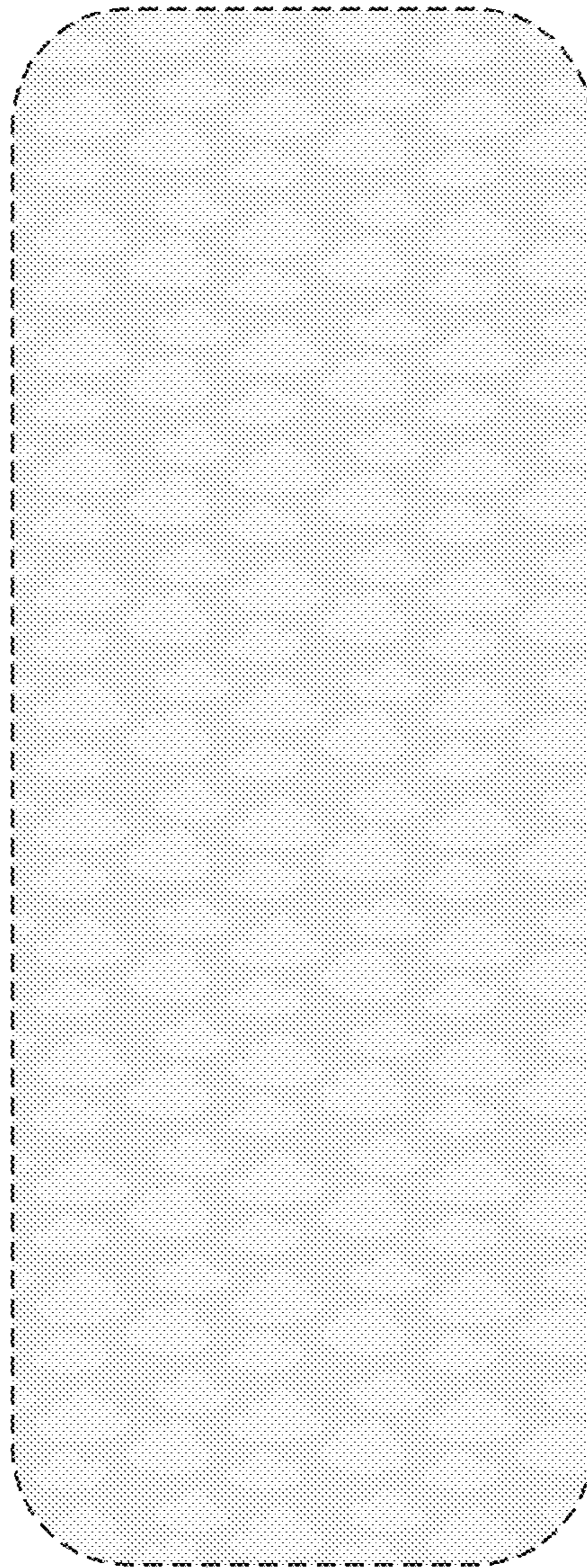

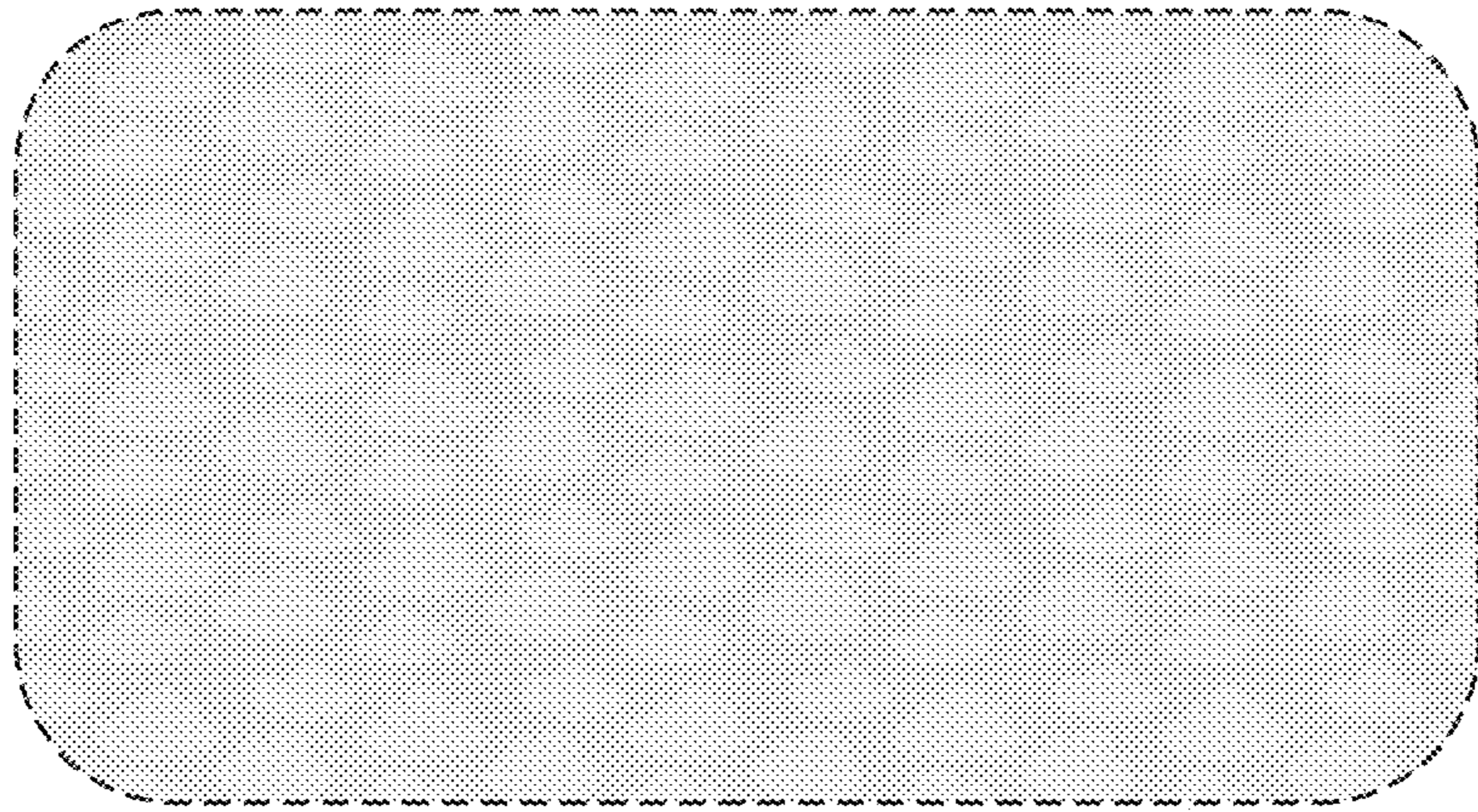

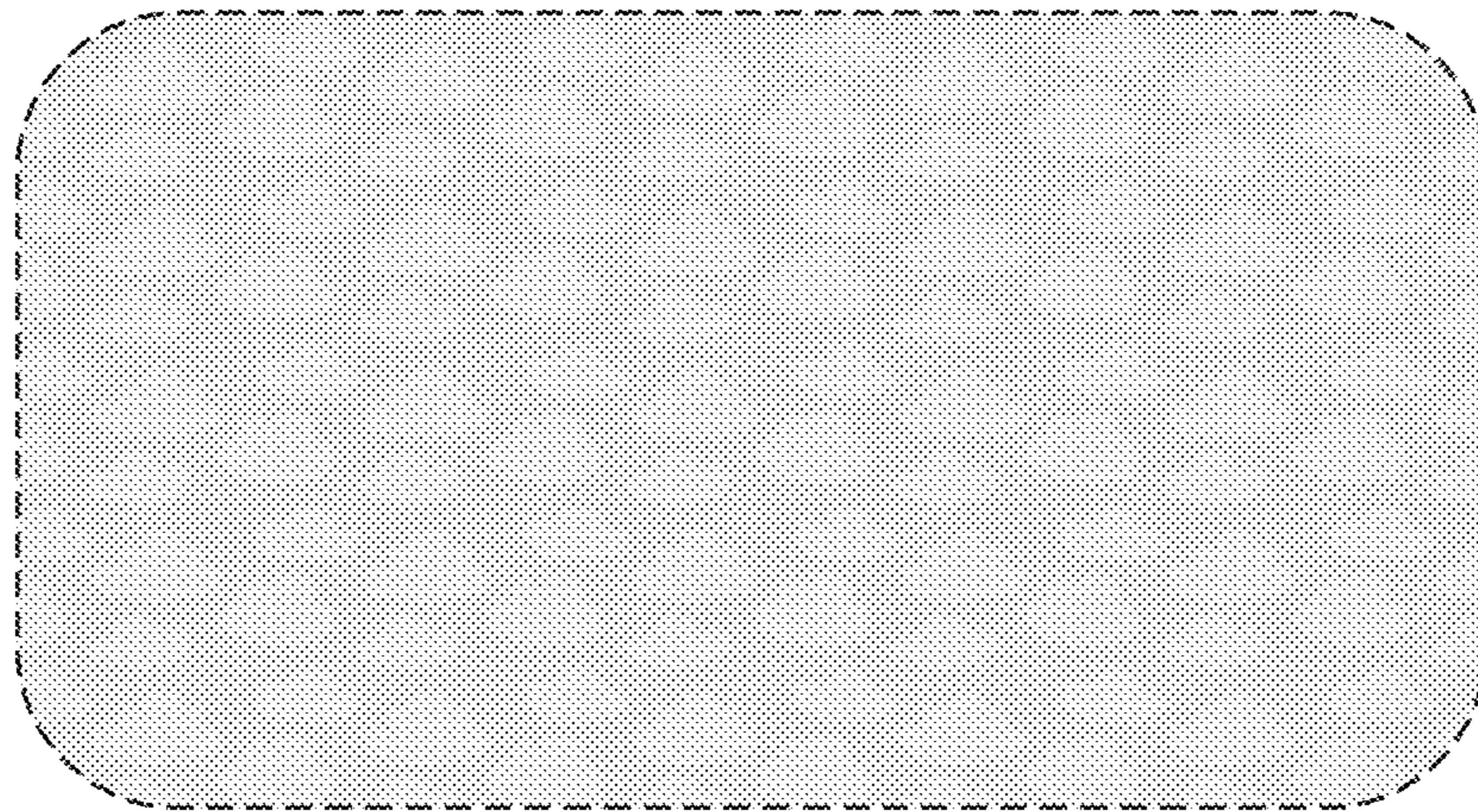

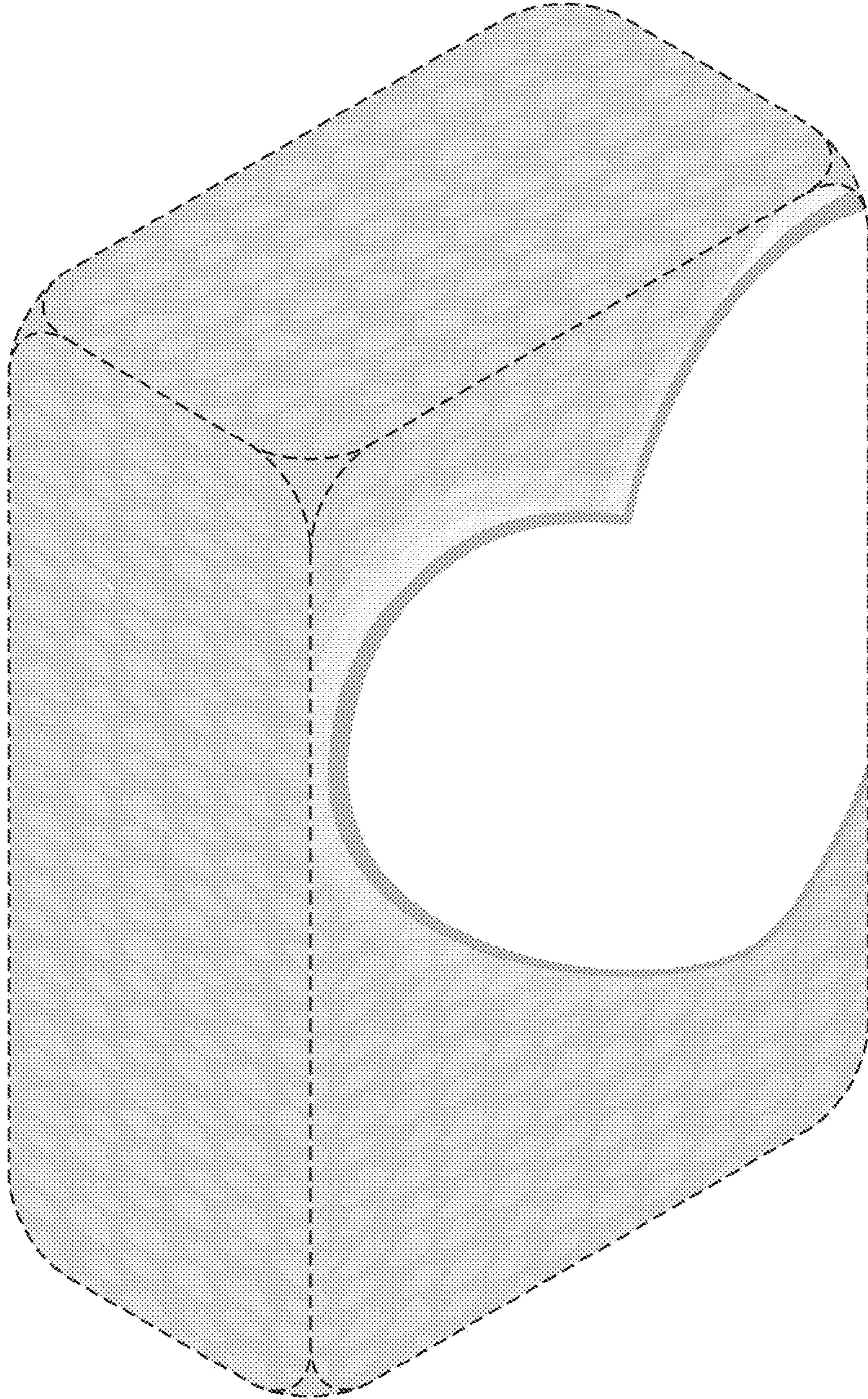

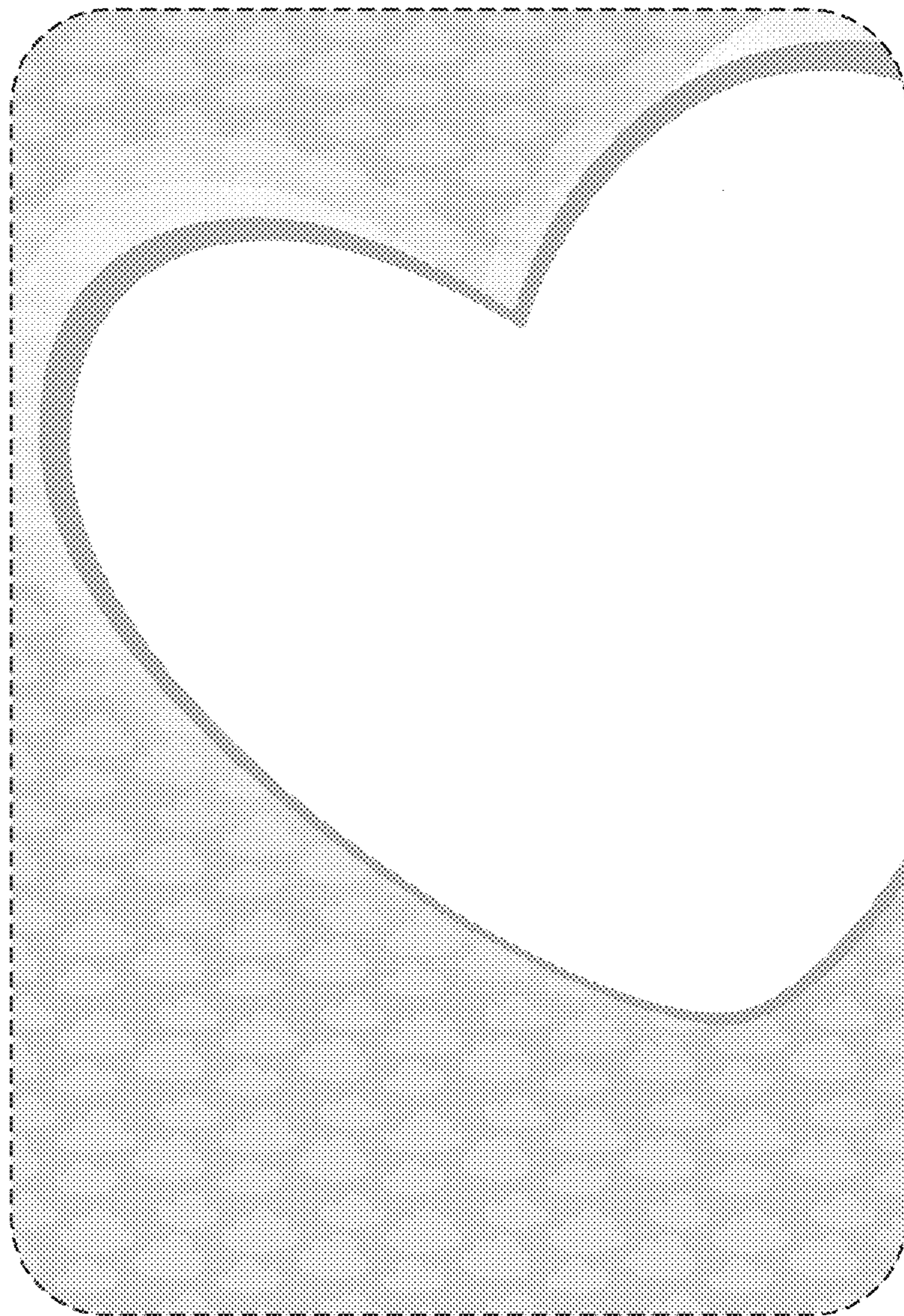

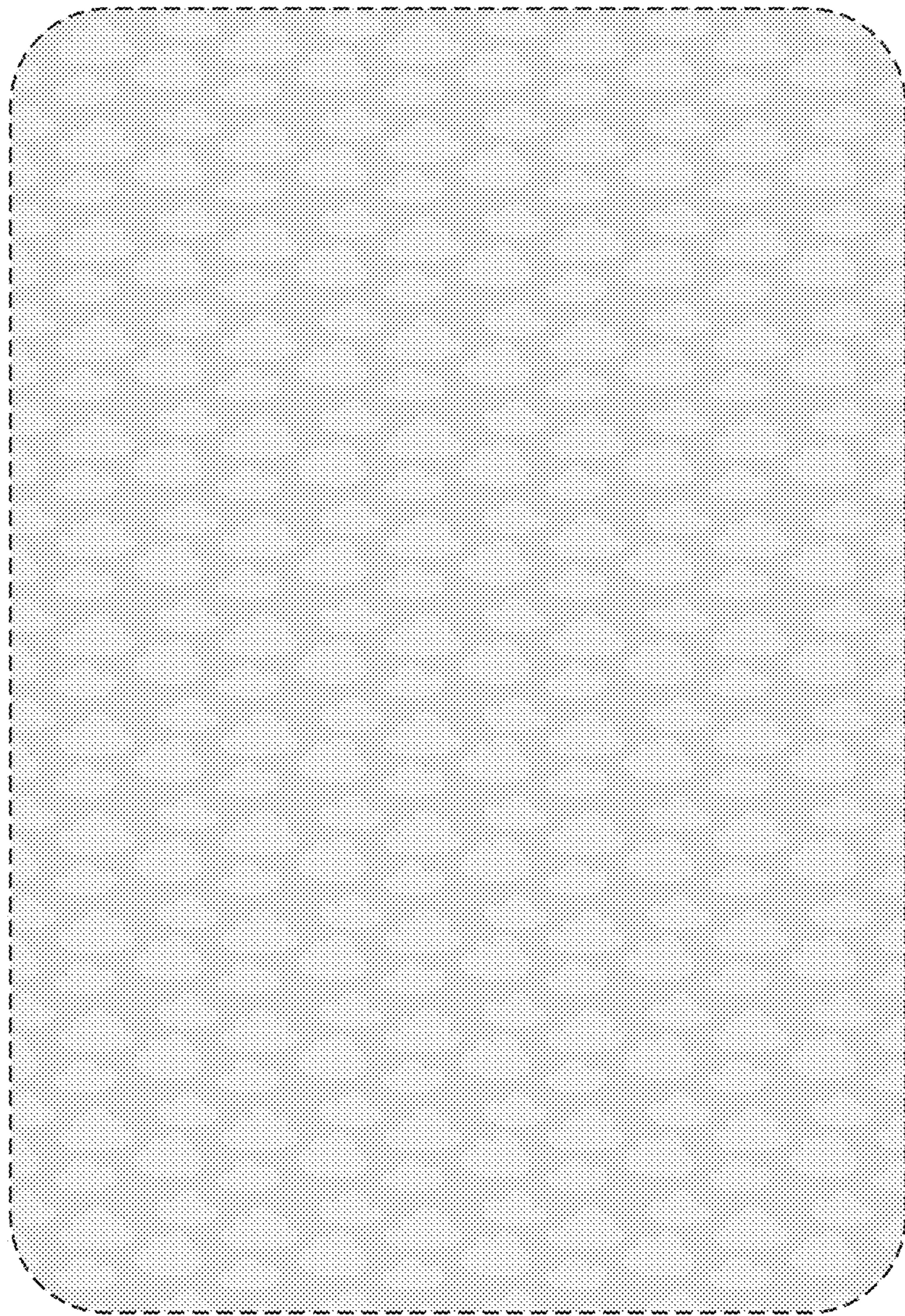

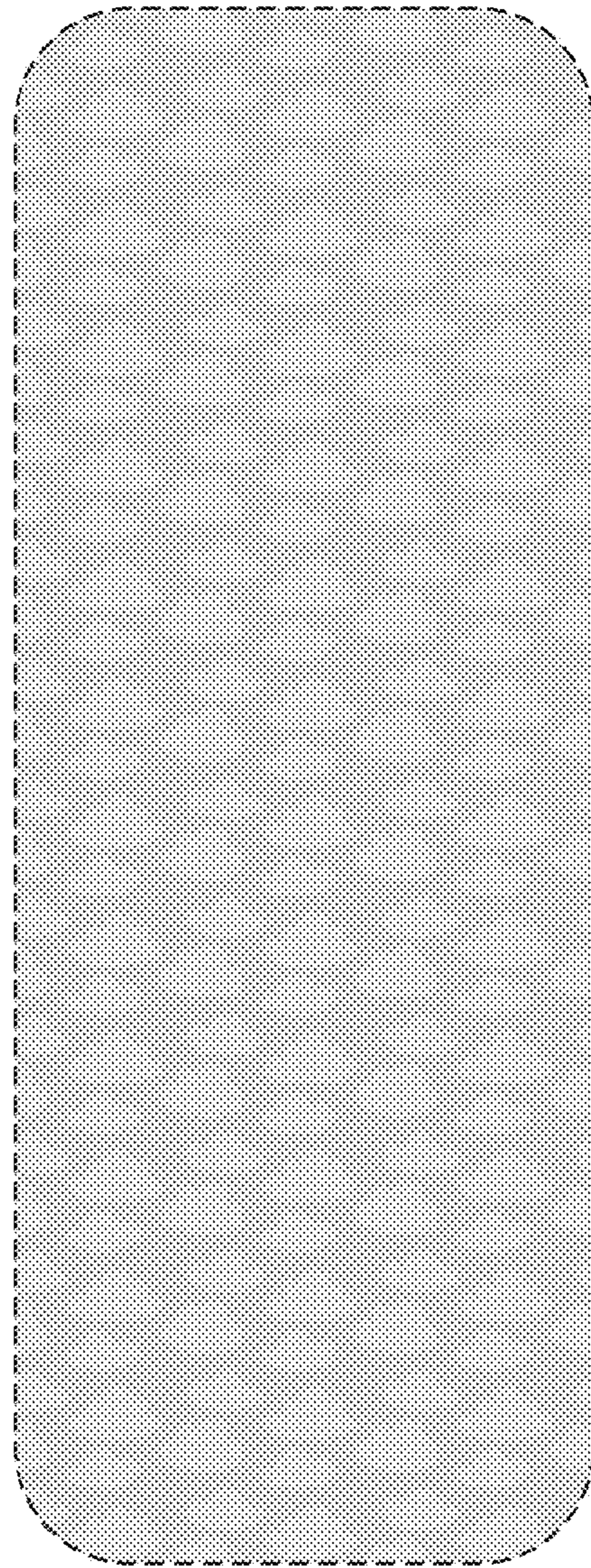

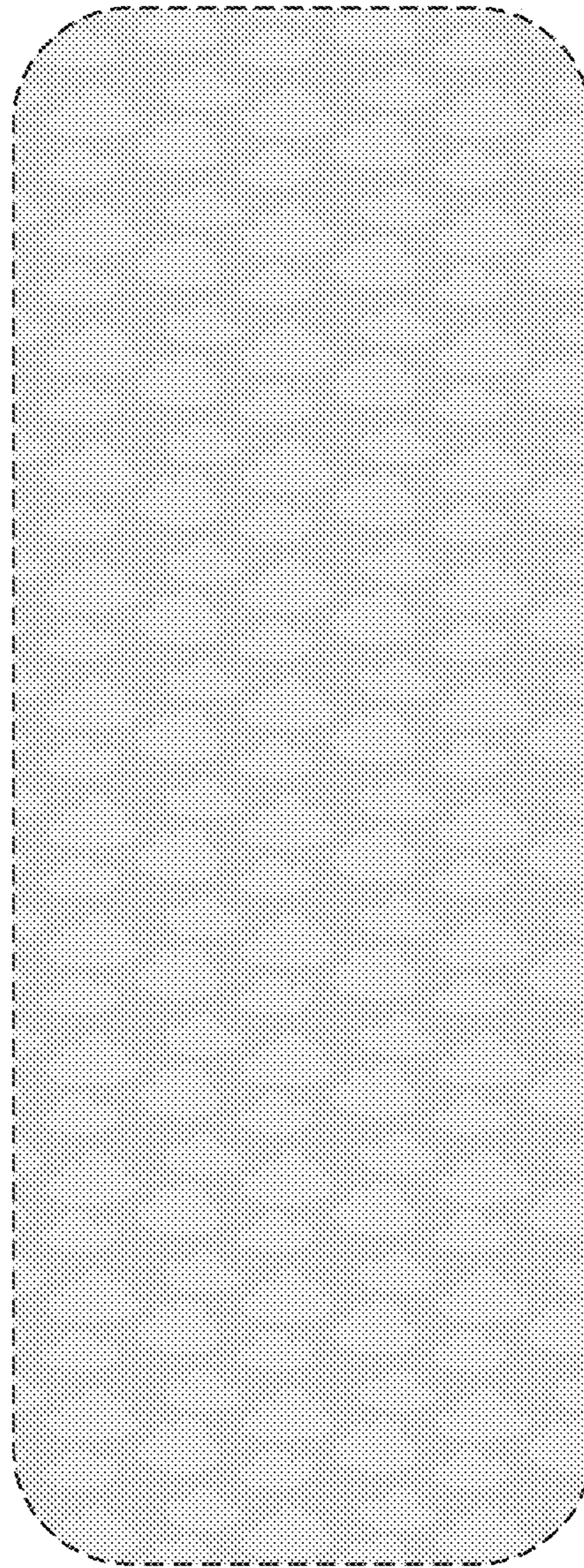

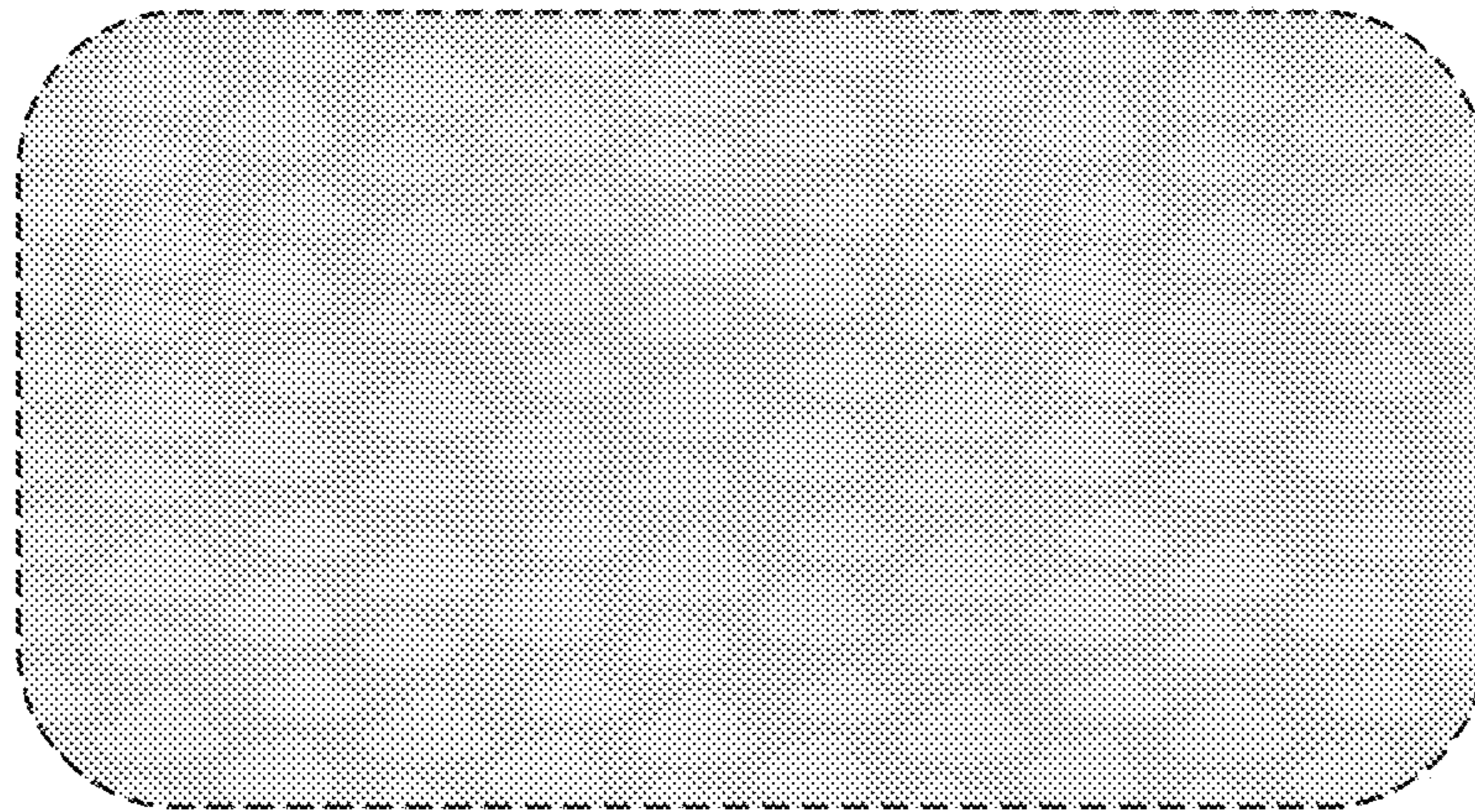

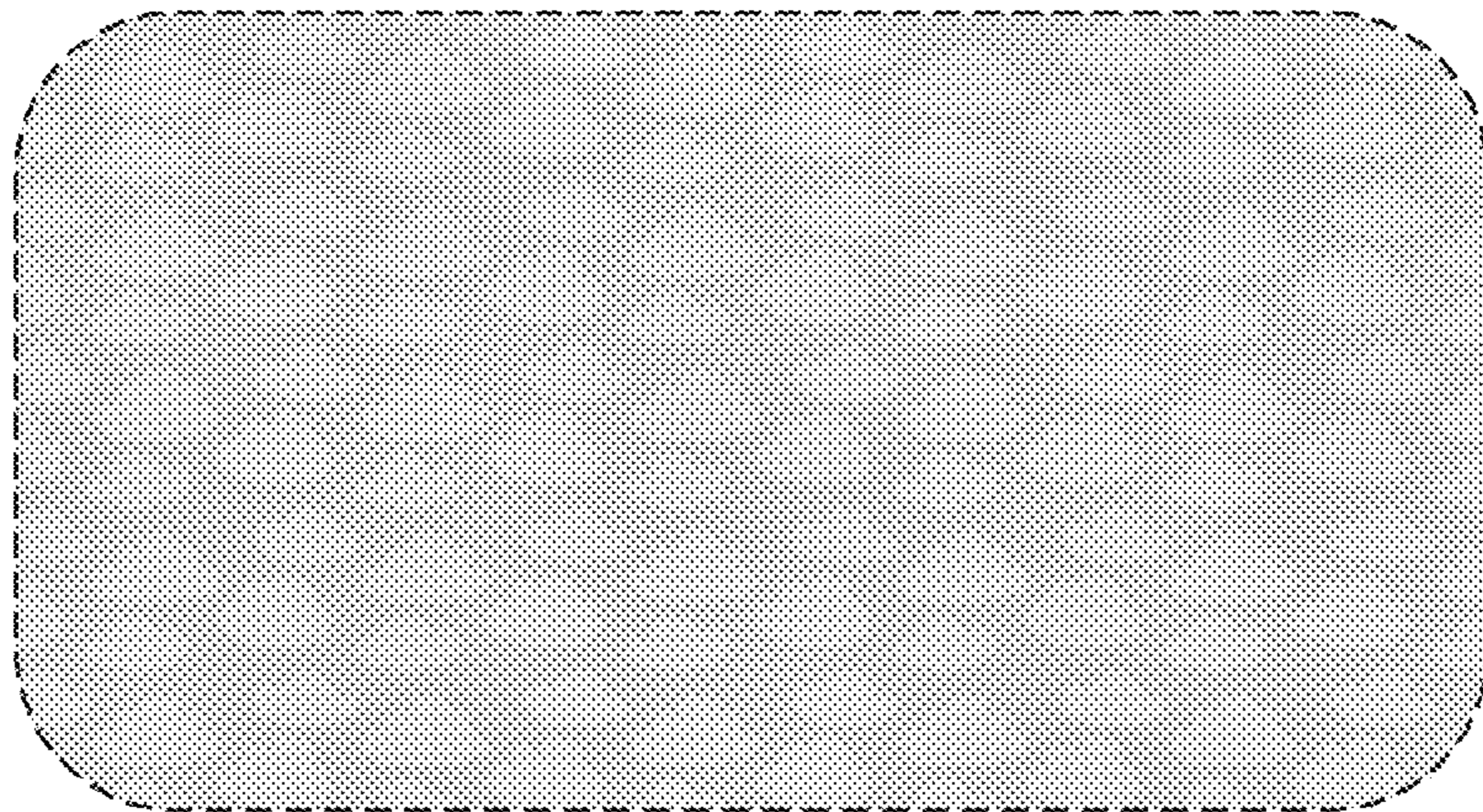

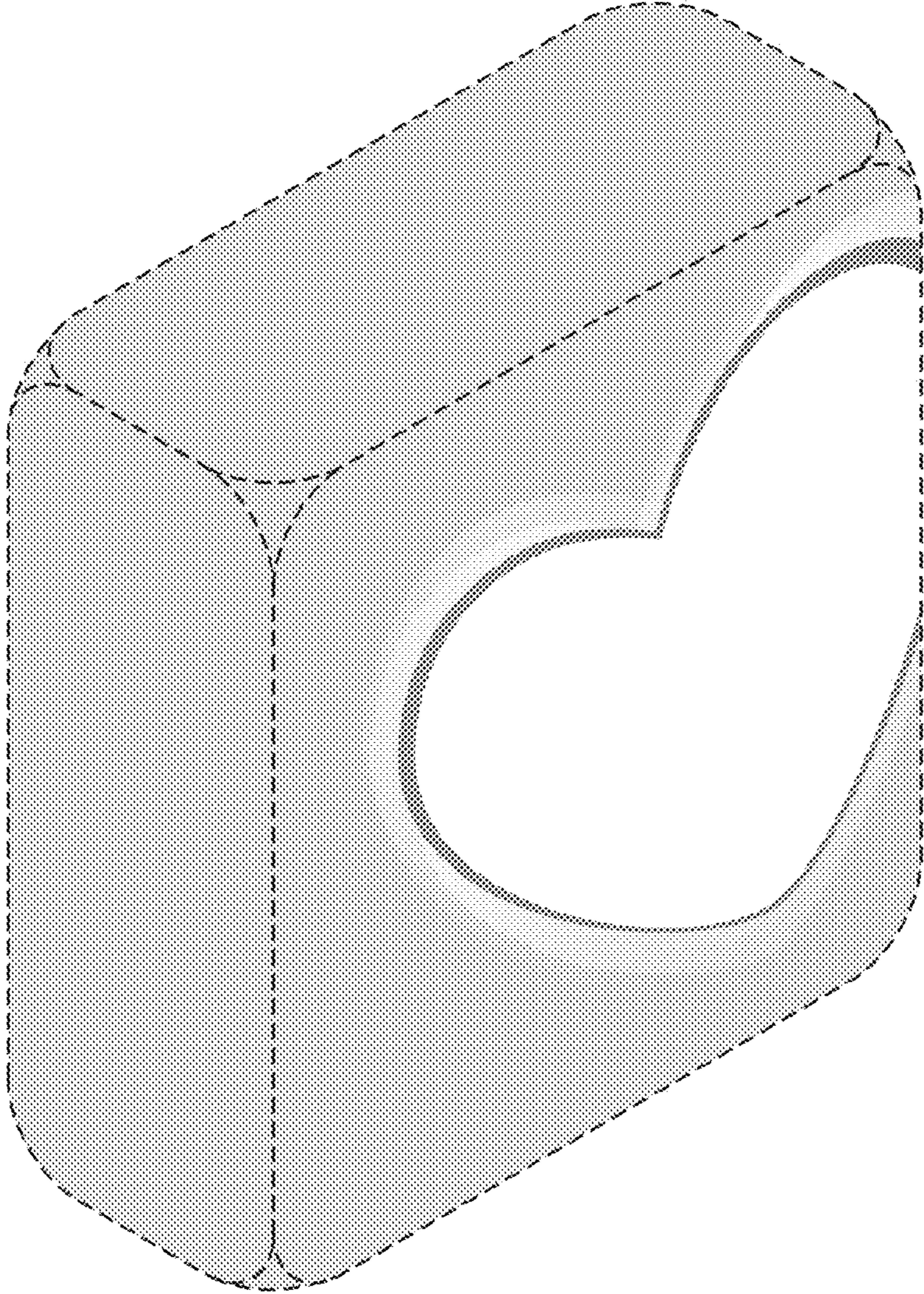

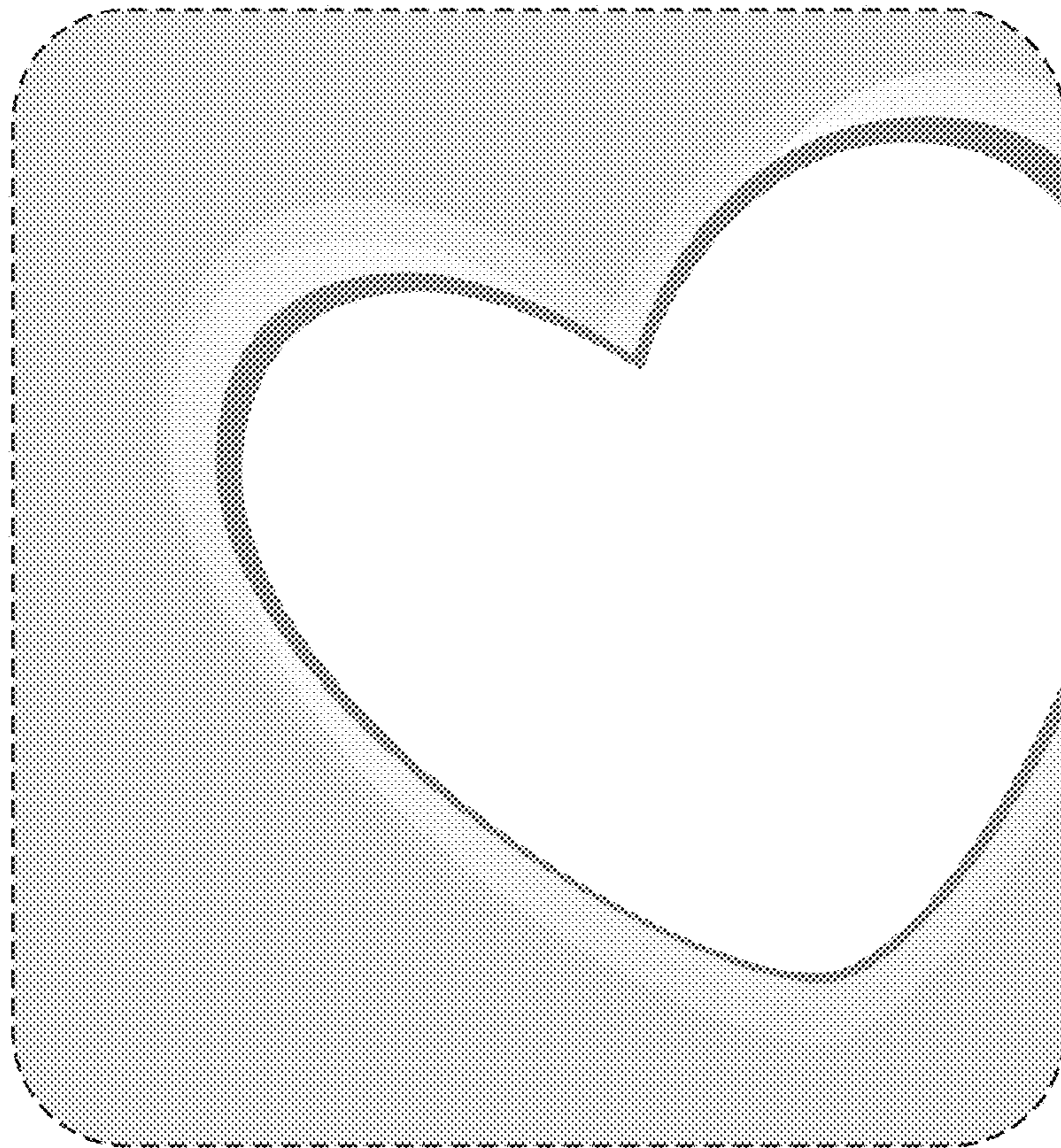

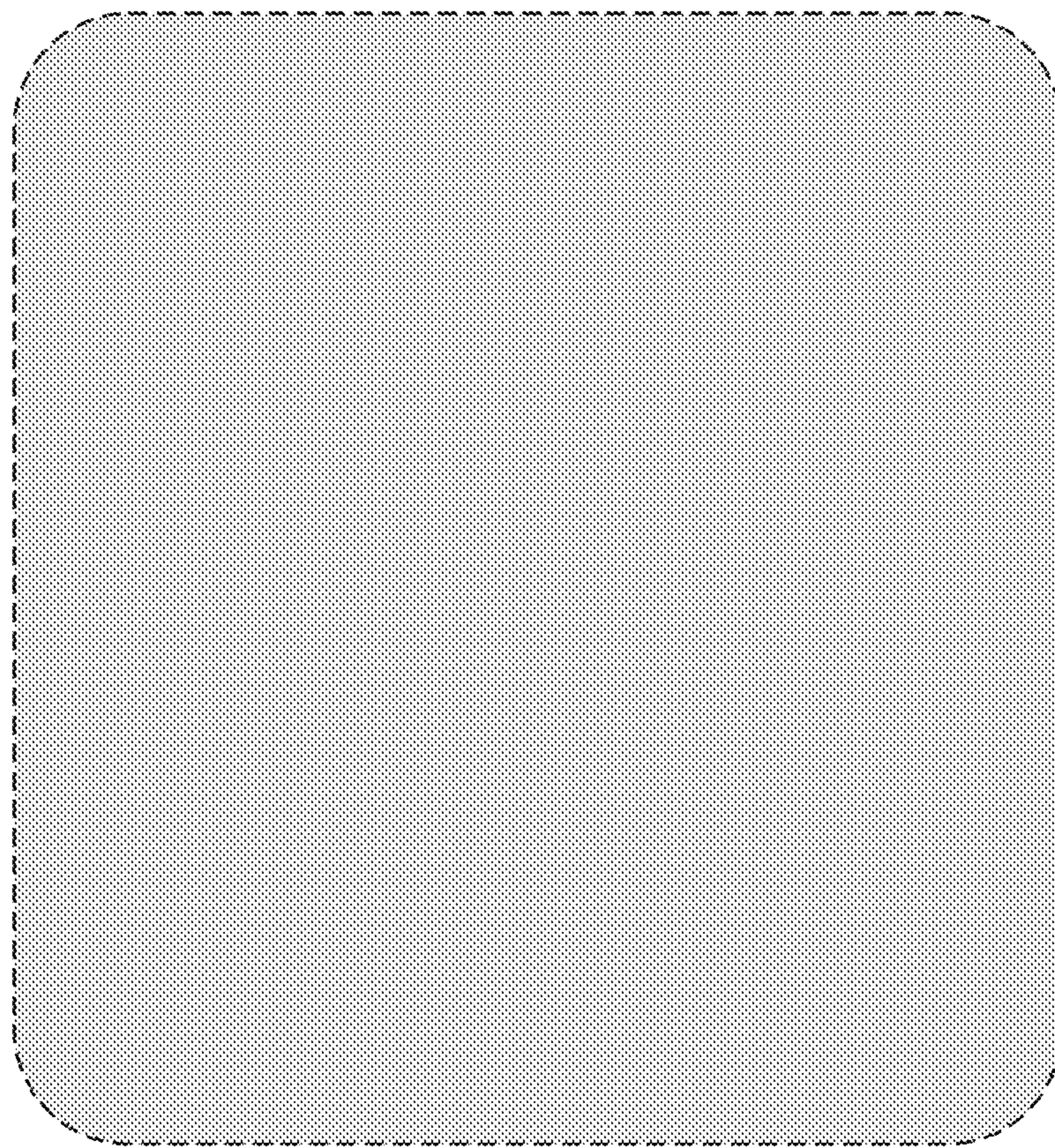

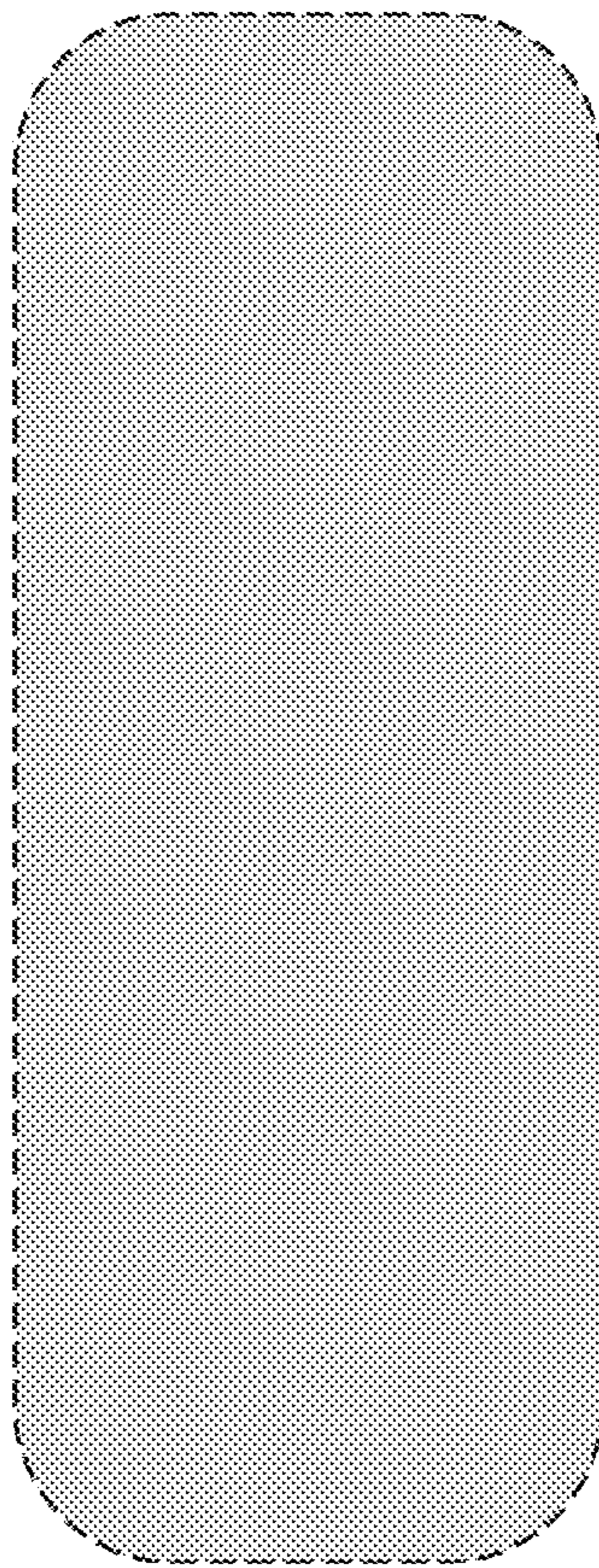

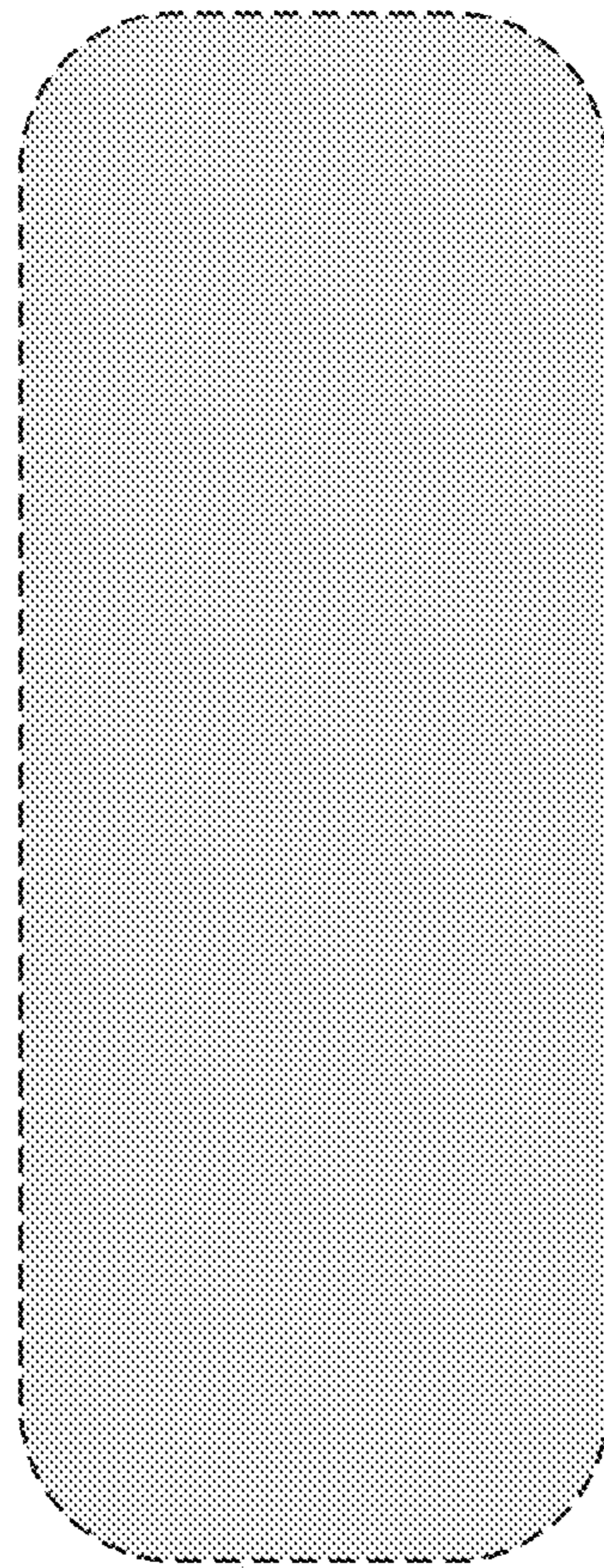

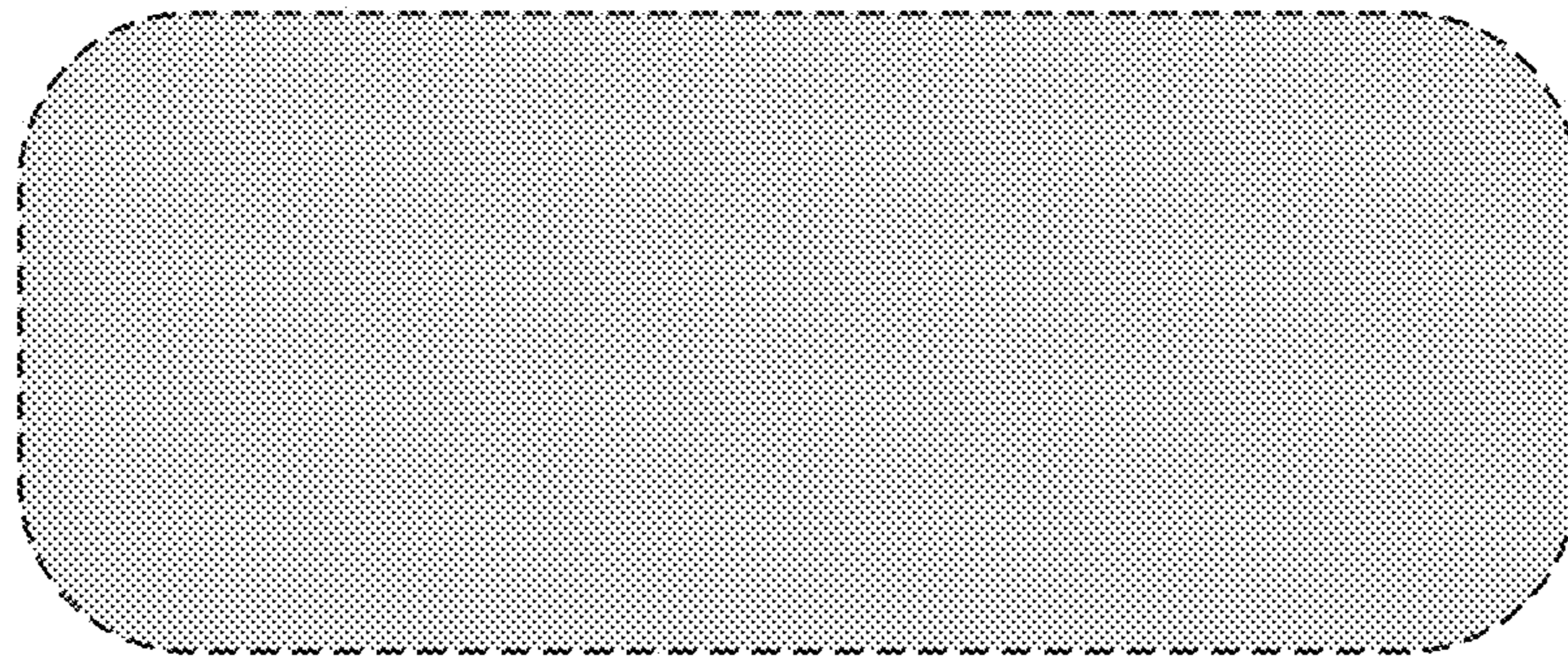

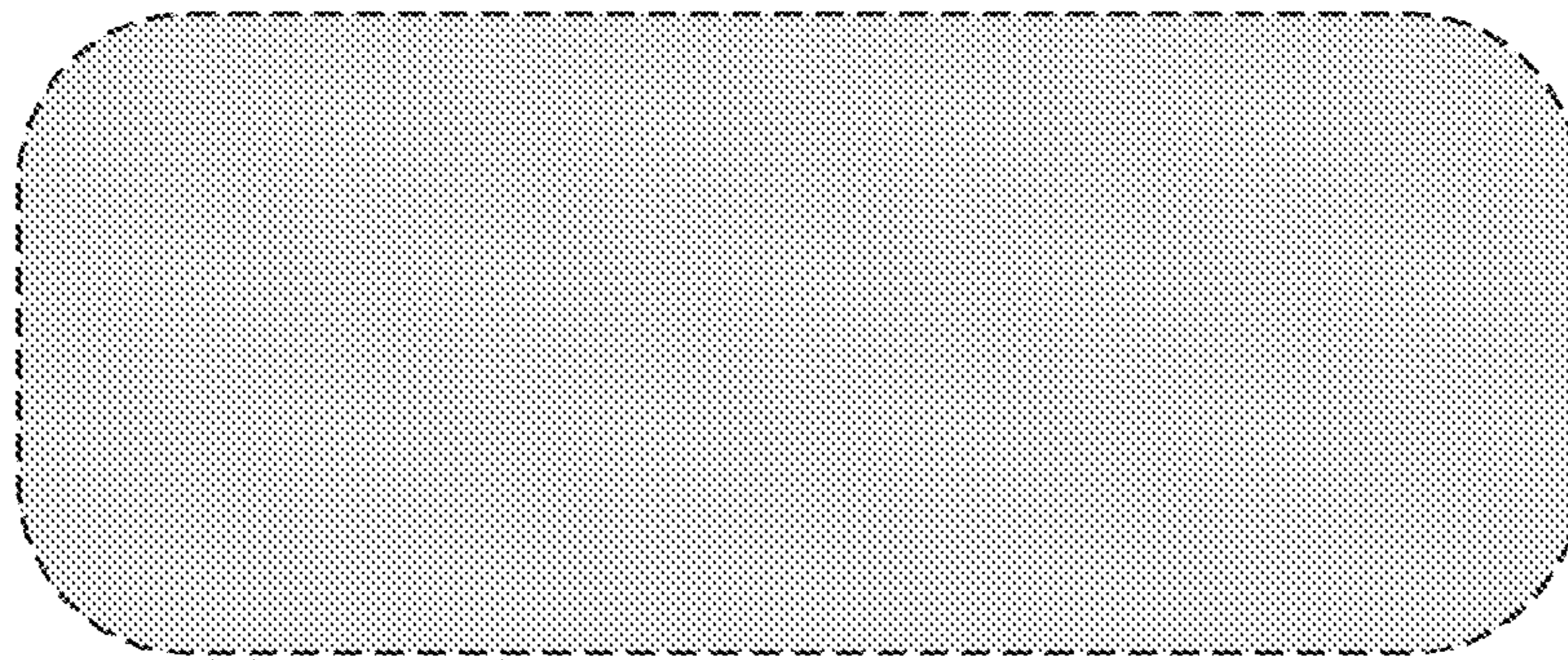
