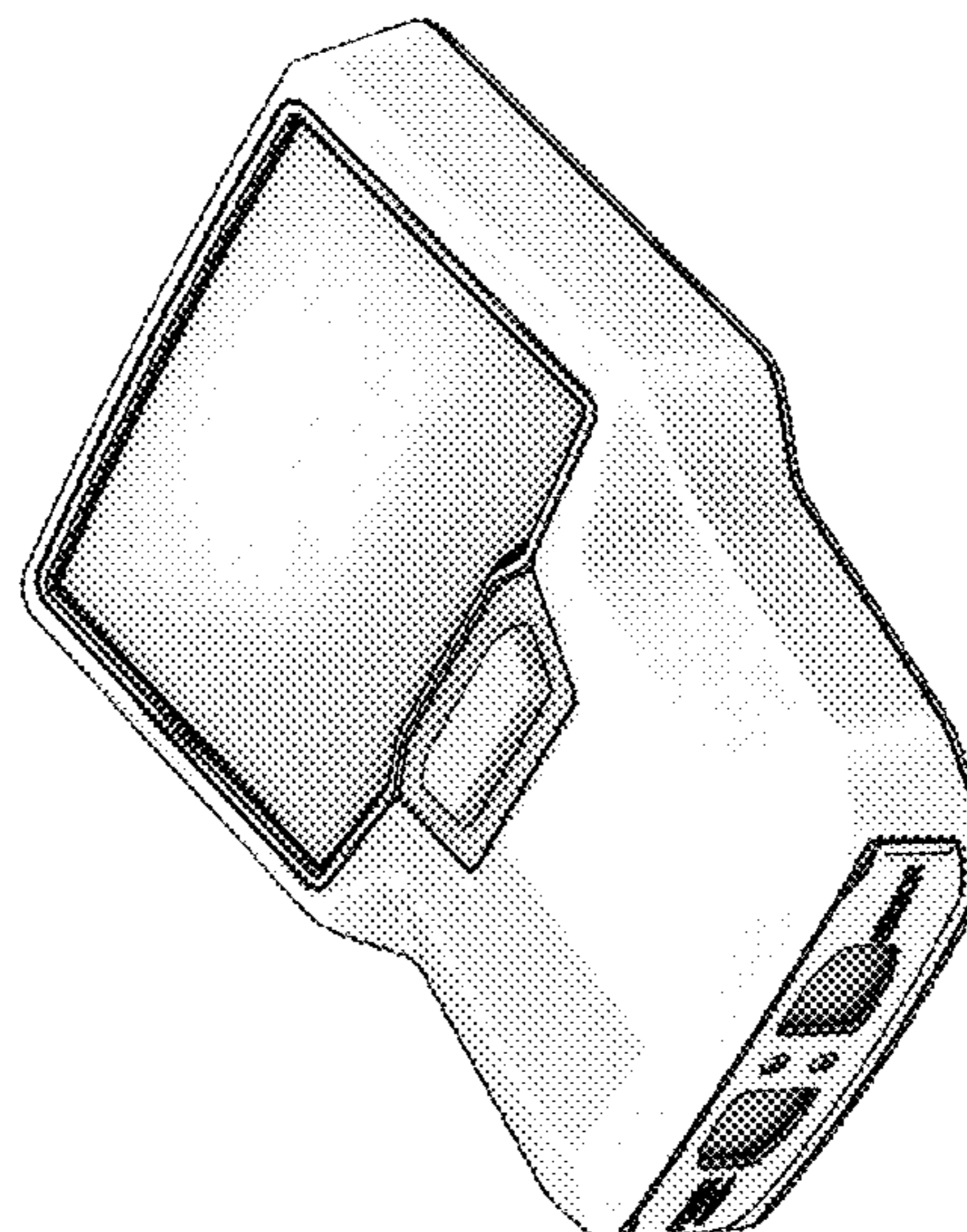
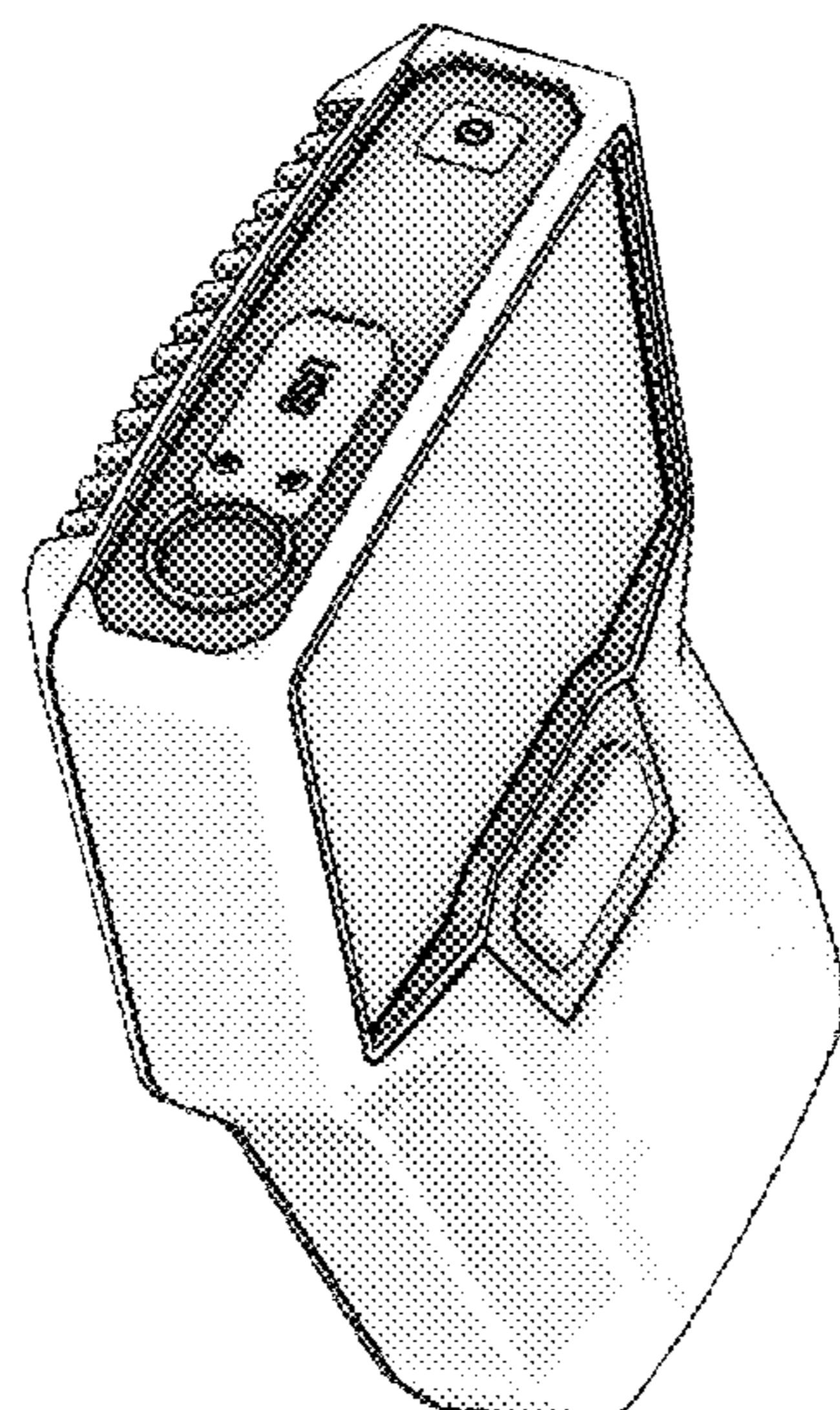
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a bottom plan view of a new design for an oscillograph;  
FIG. 2 is a perspective view from above and to the front right side thereof;  
FIG. 3 is a right side view thereof;  
FIG. 4 is a perspective view from below and to the front left side thereof;  
FIG. 5 is a front elevation view thereof;  
FIG. 6 is a top plan view thereof; and,

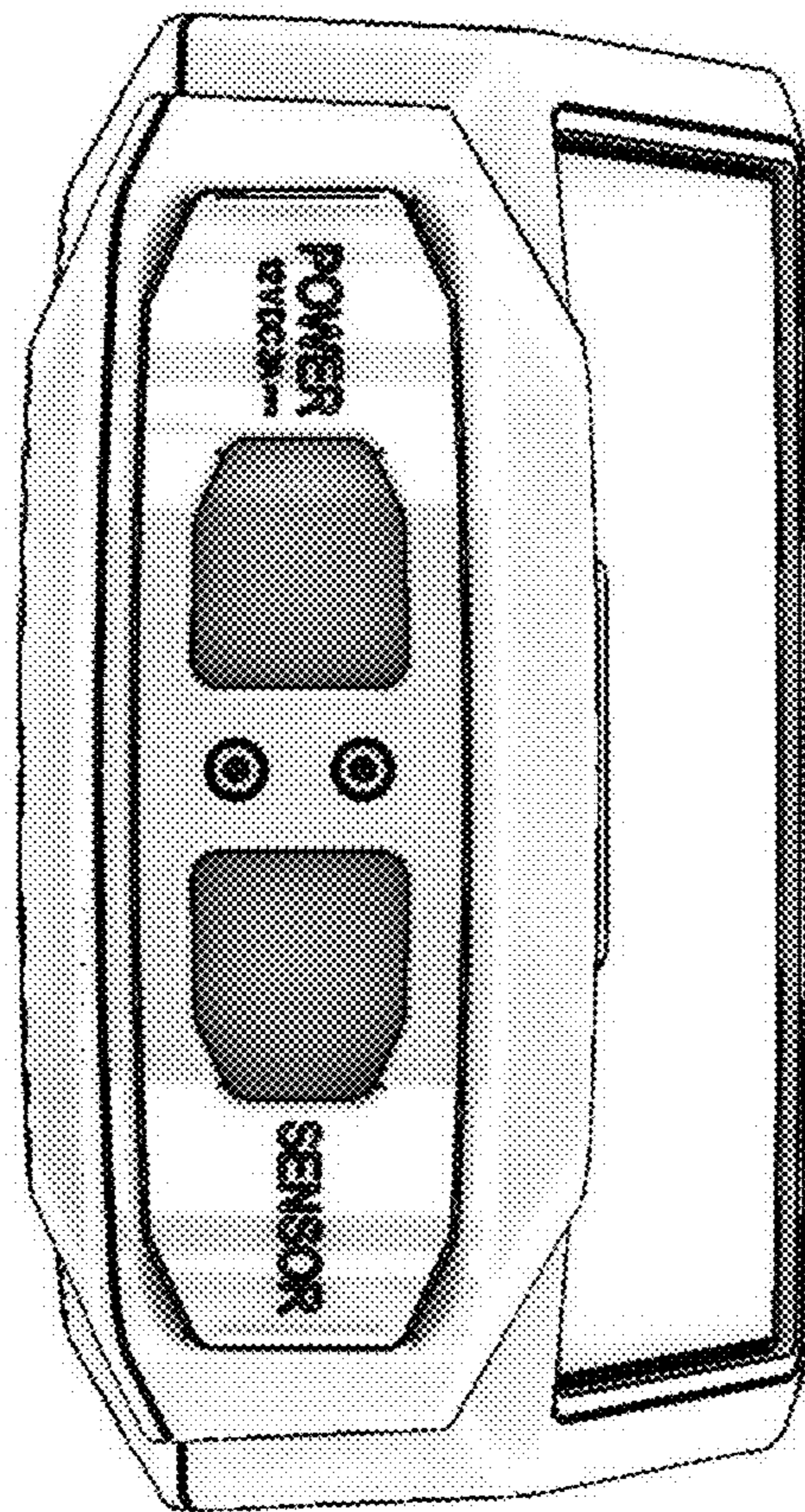

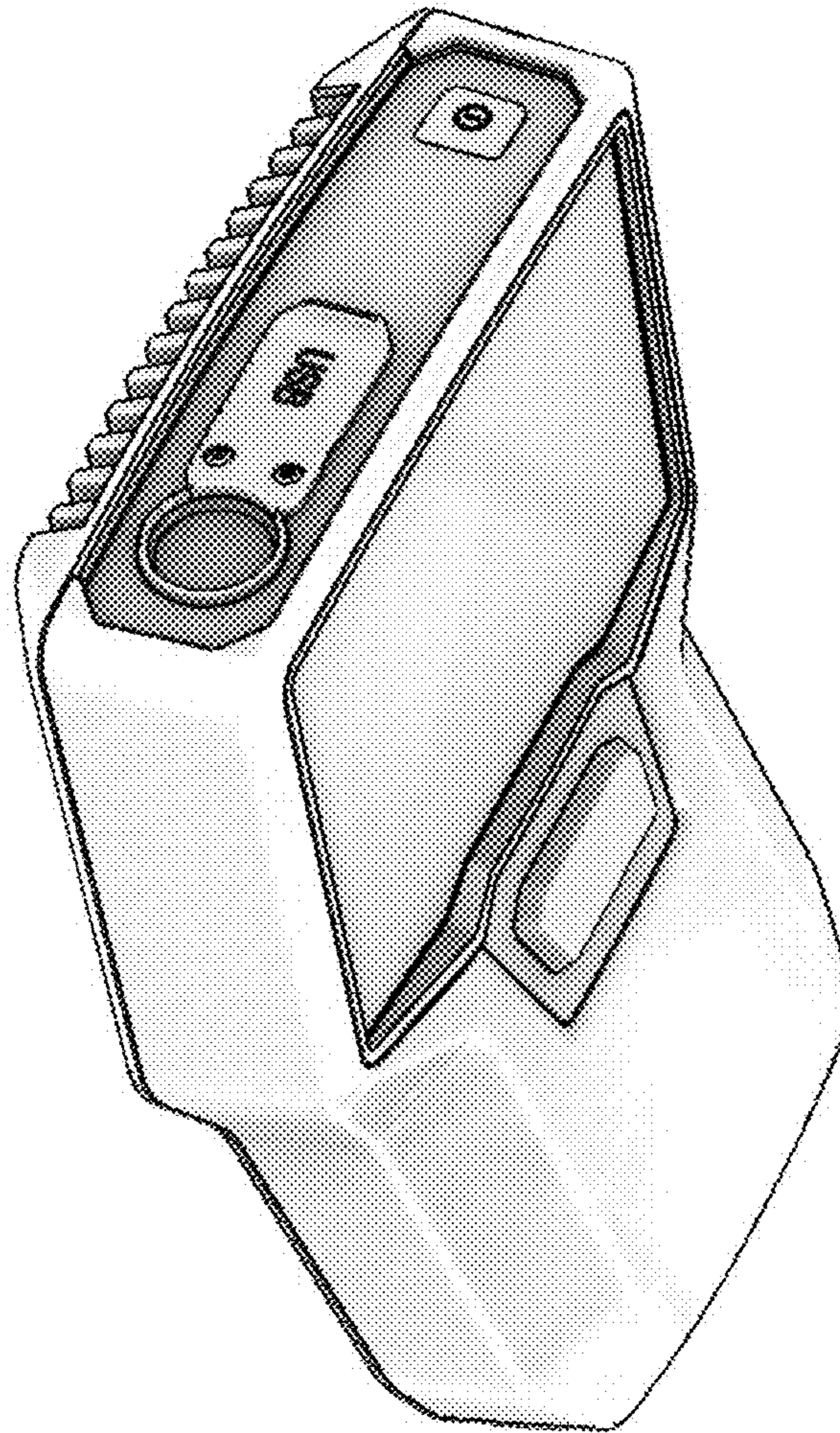

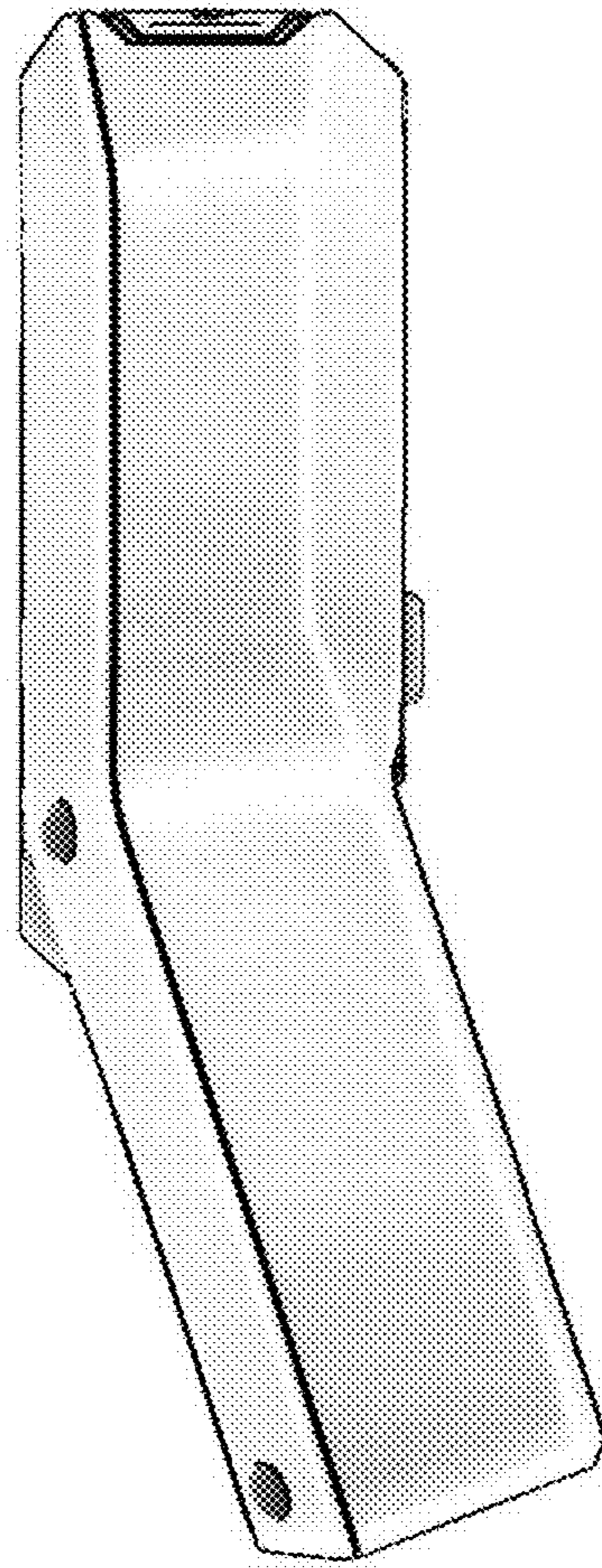

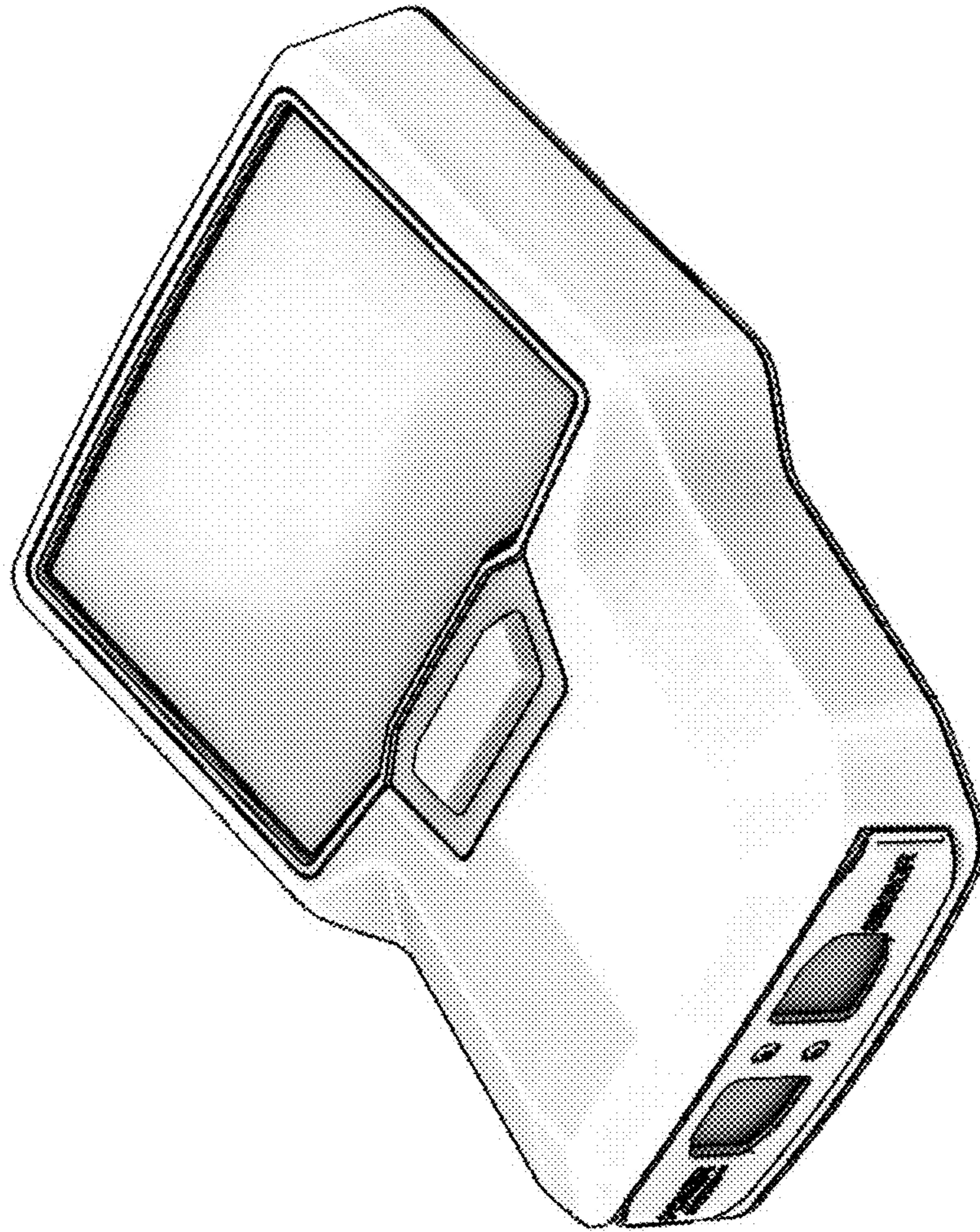

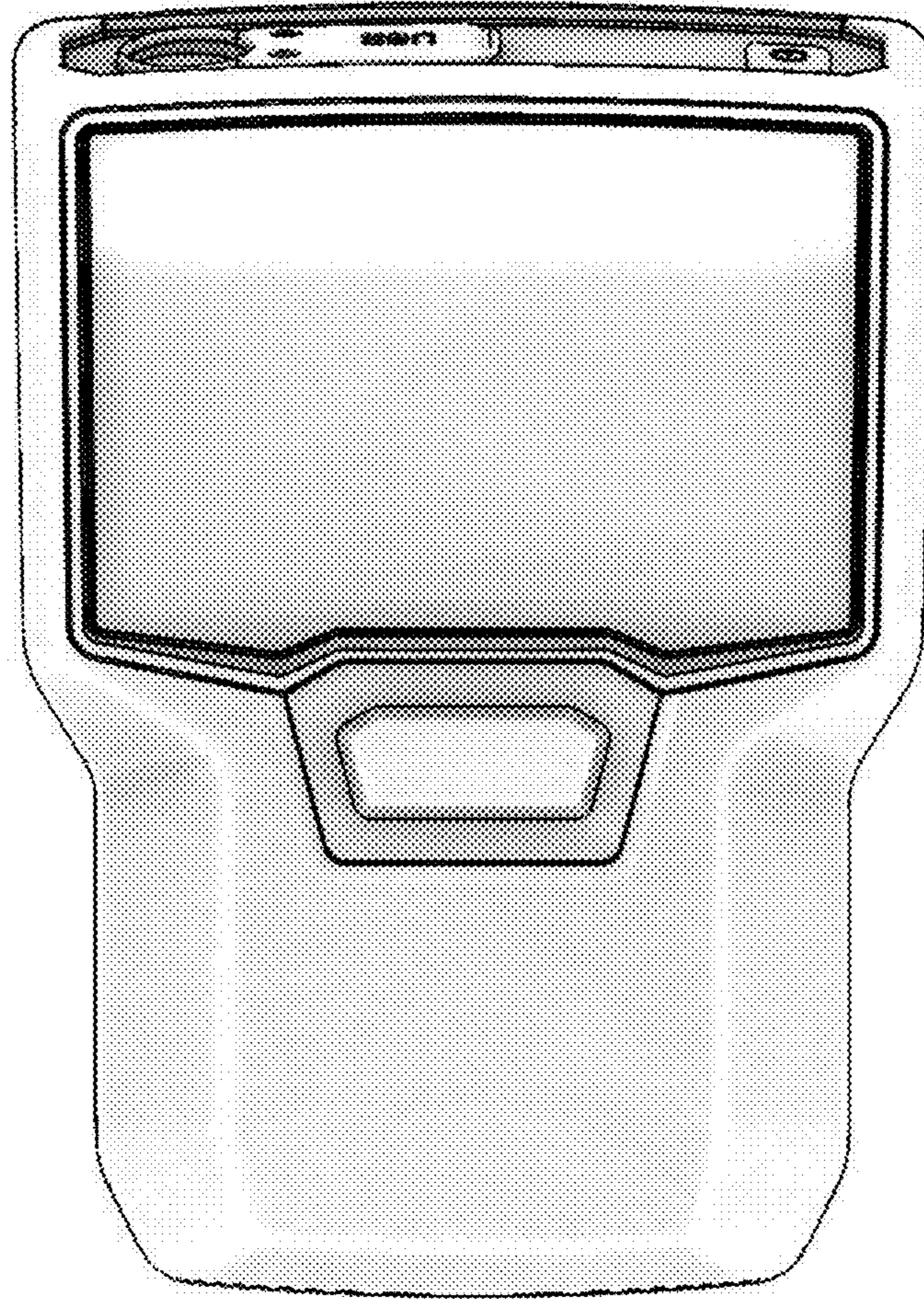

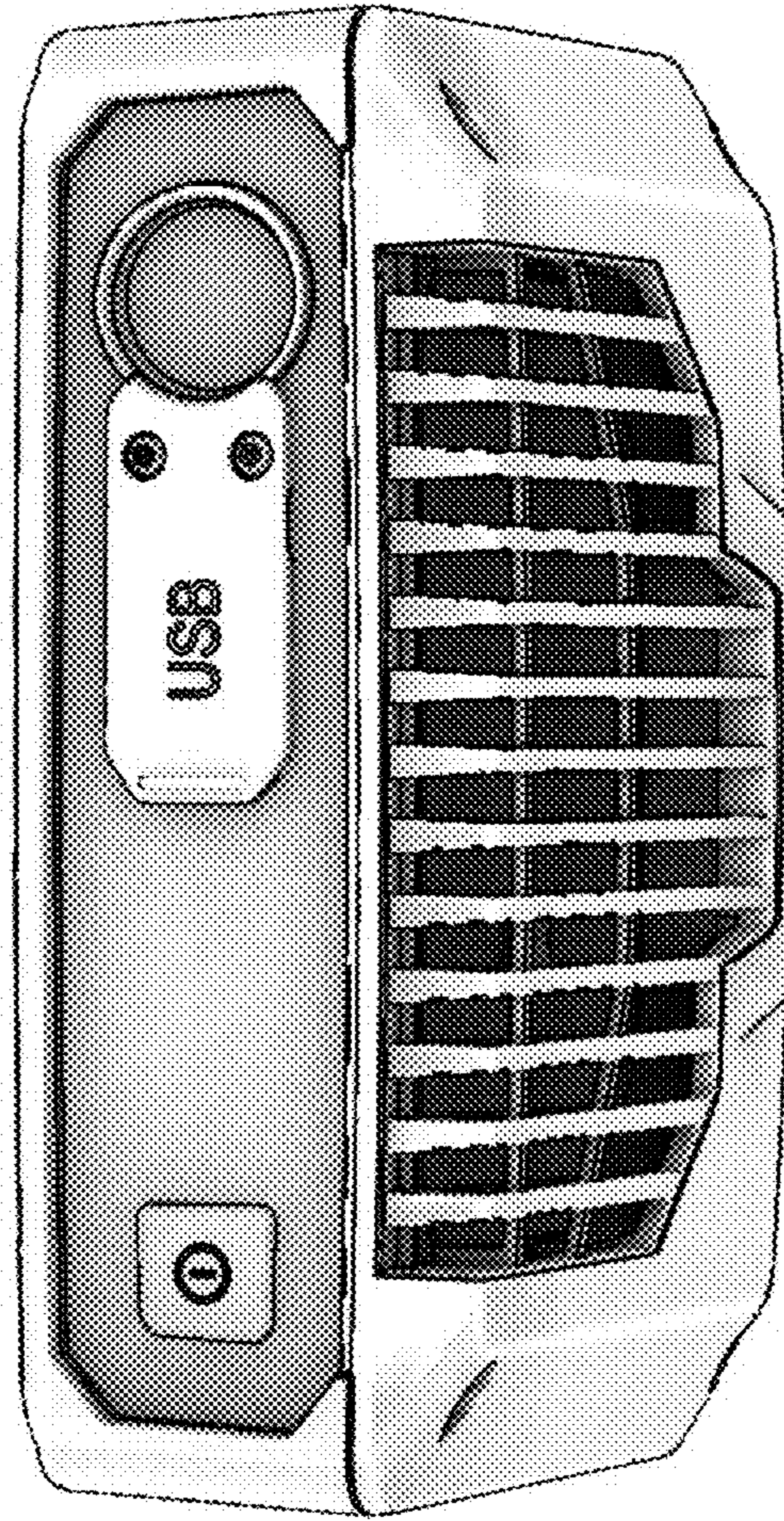

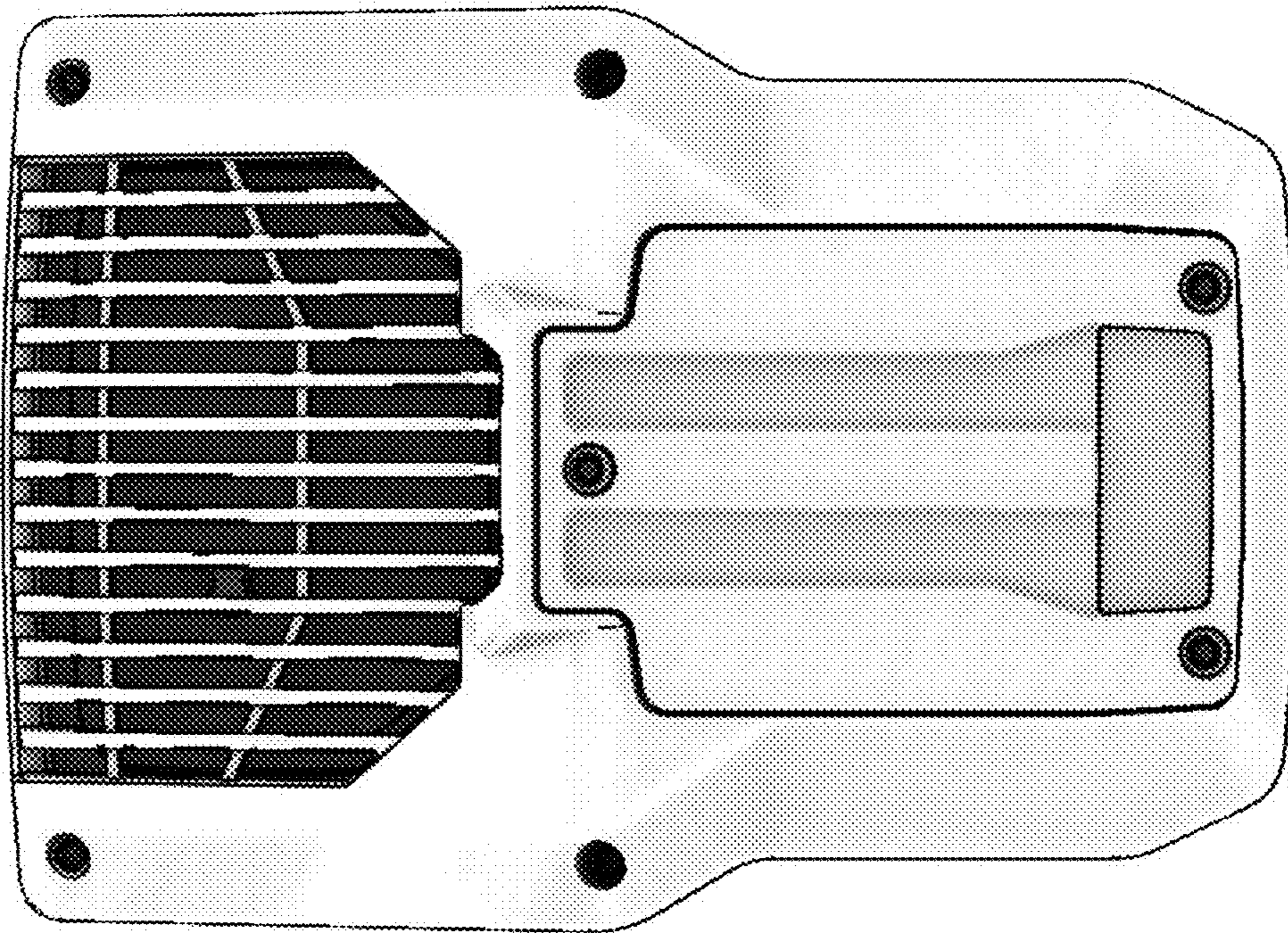
