(57) **CLAIM**

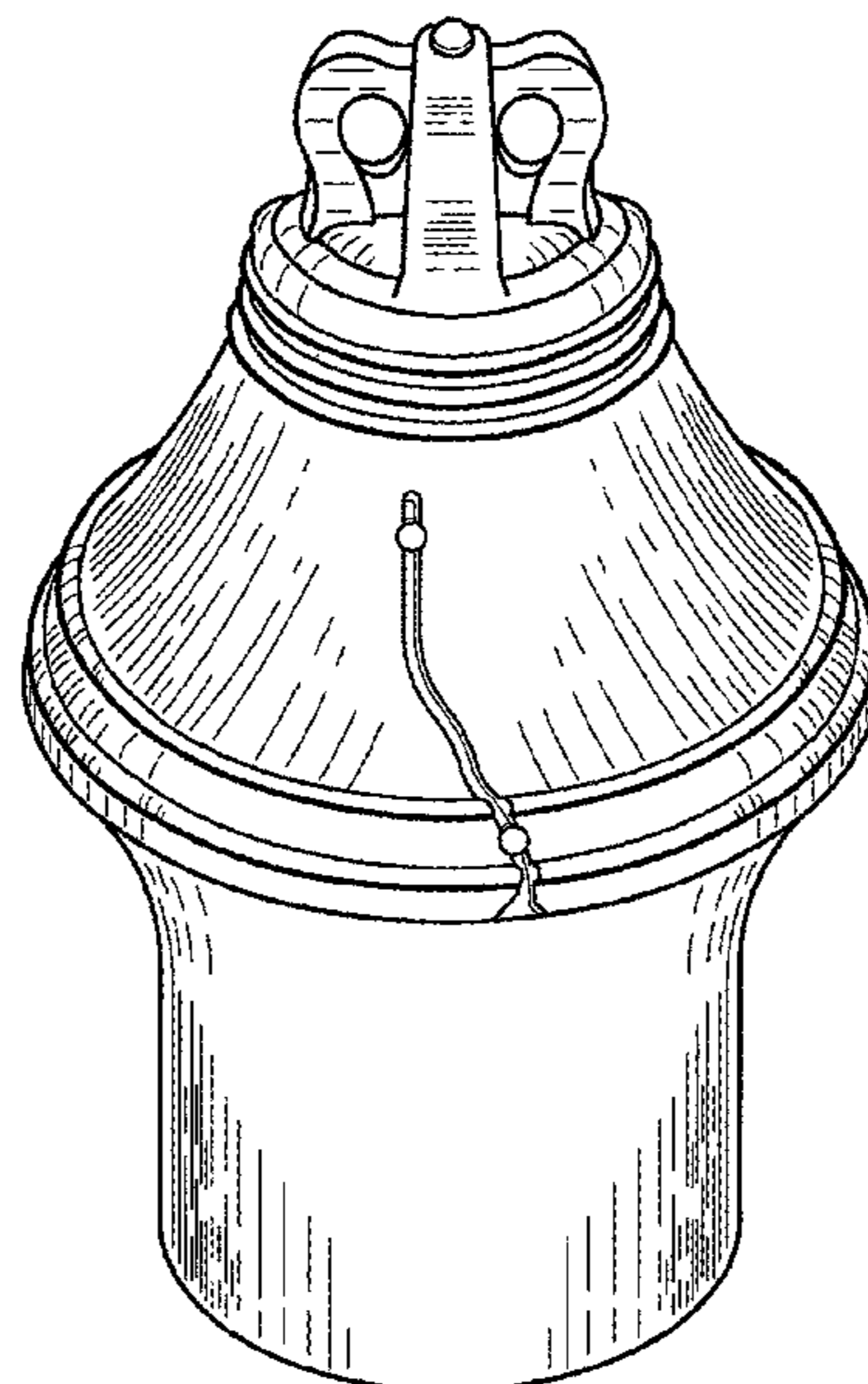
The ornamental design for a traffic bollard, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a traffic bollard showing my new design.
FIG. 2 is the rear view thereof.

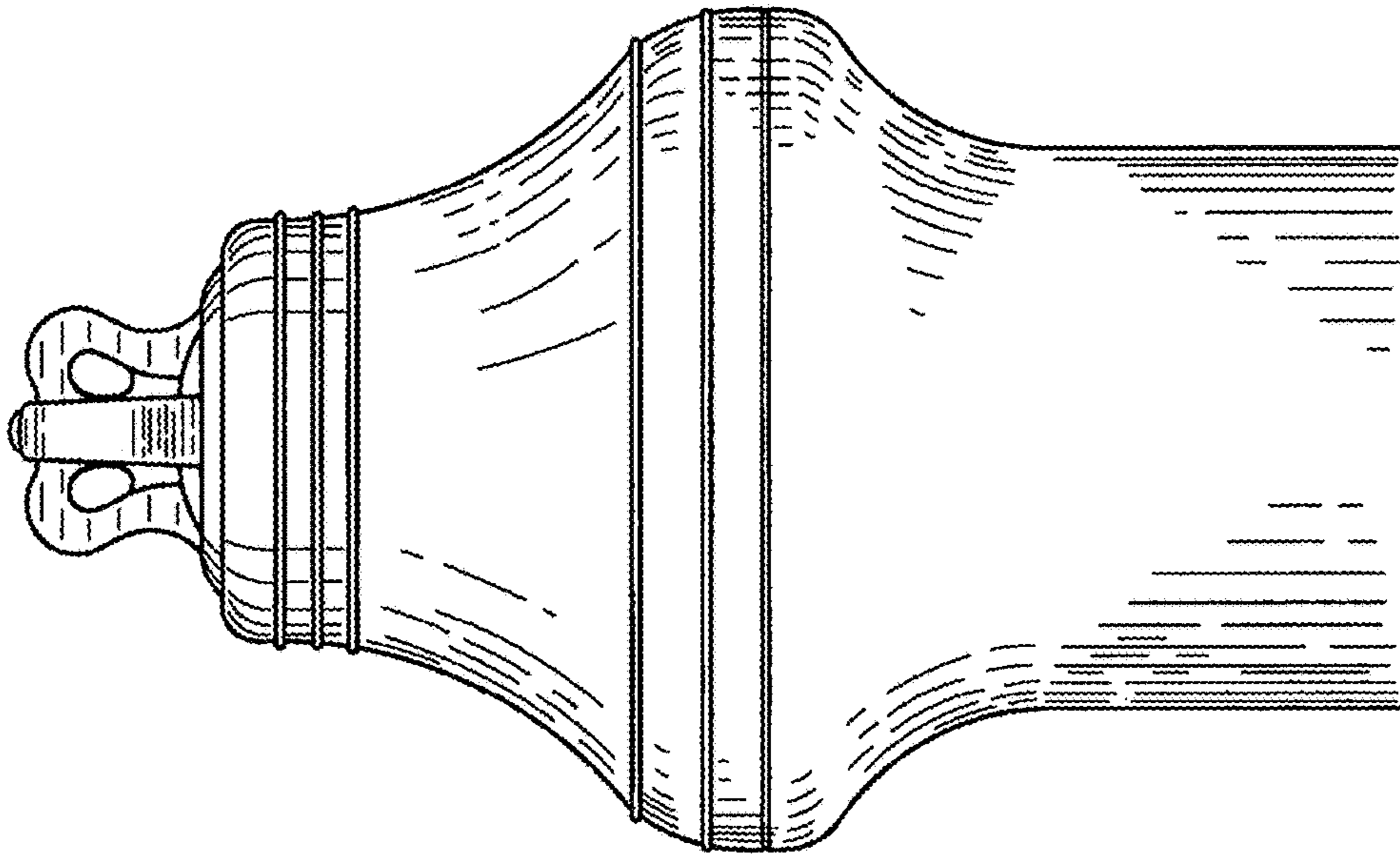

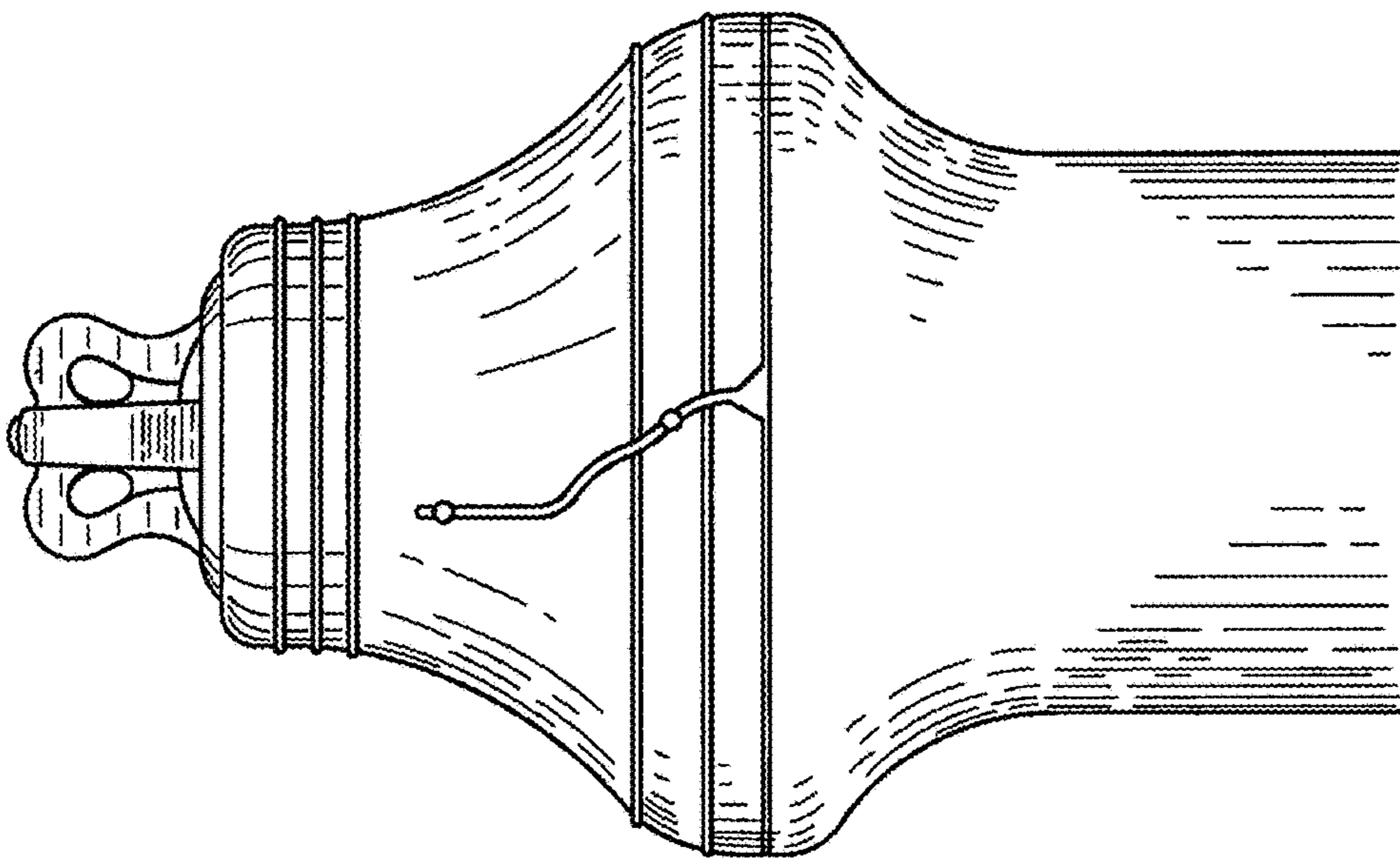

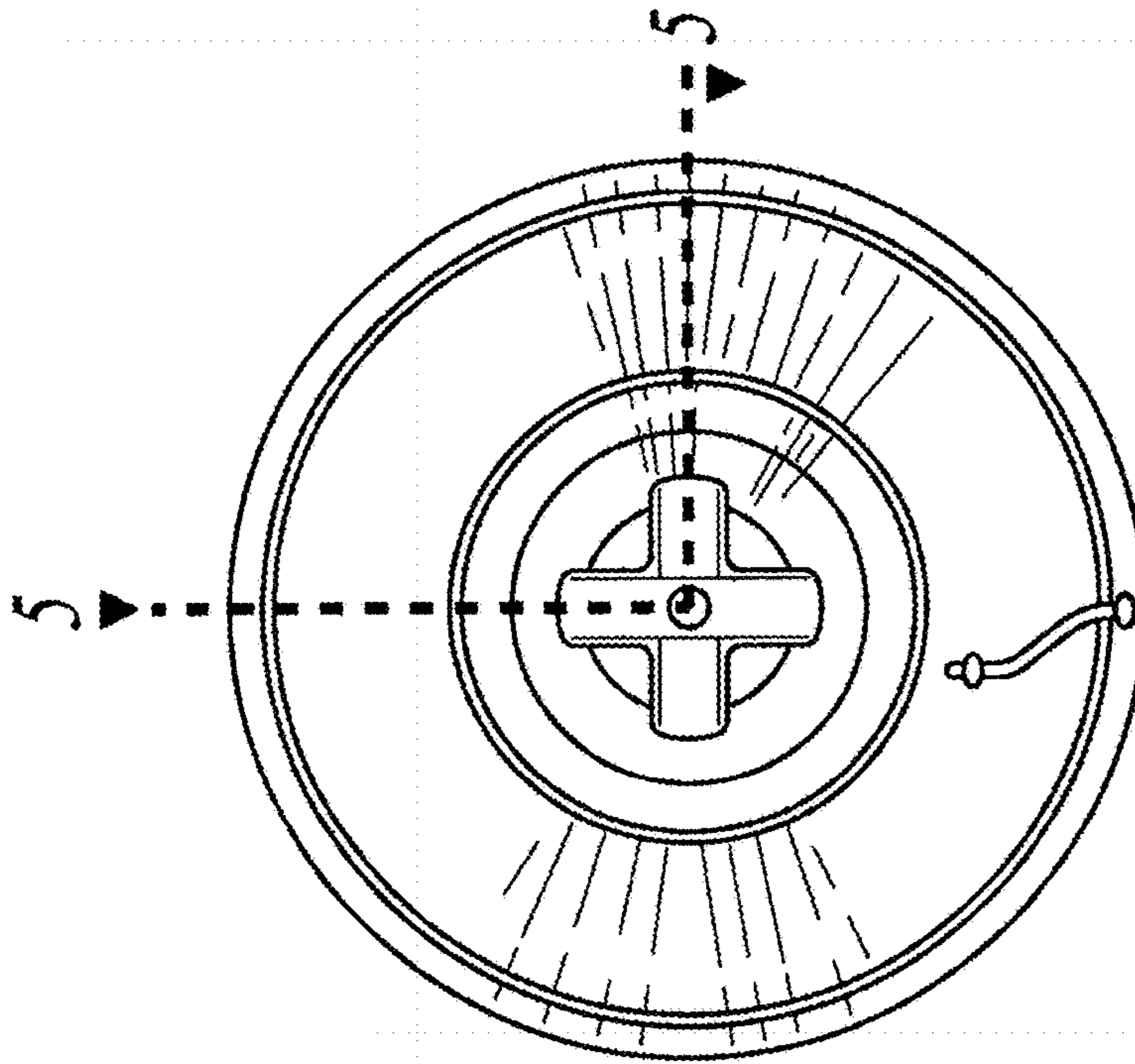

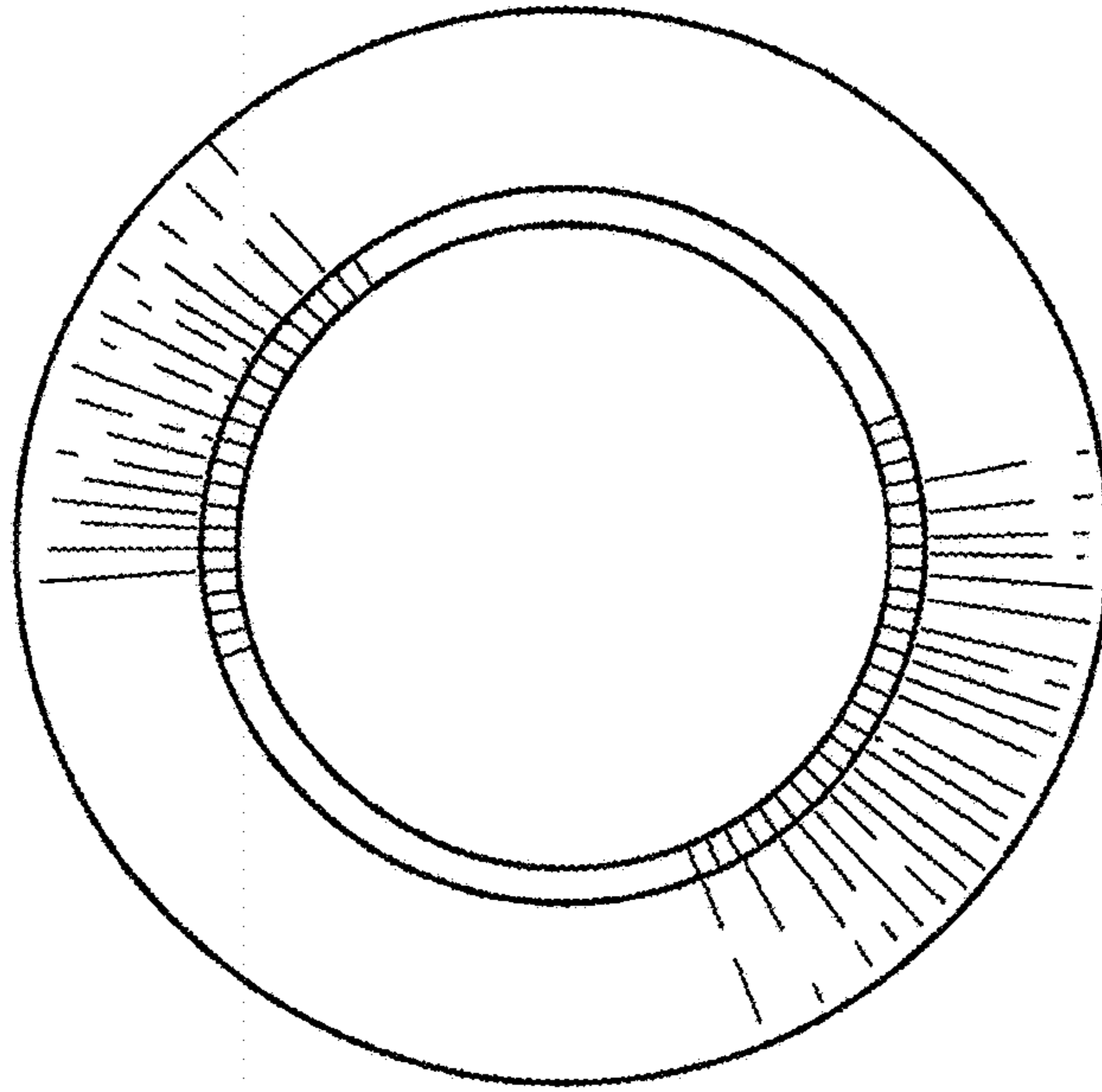

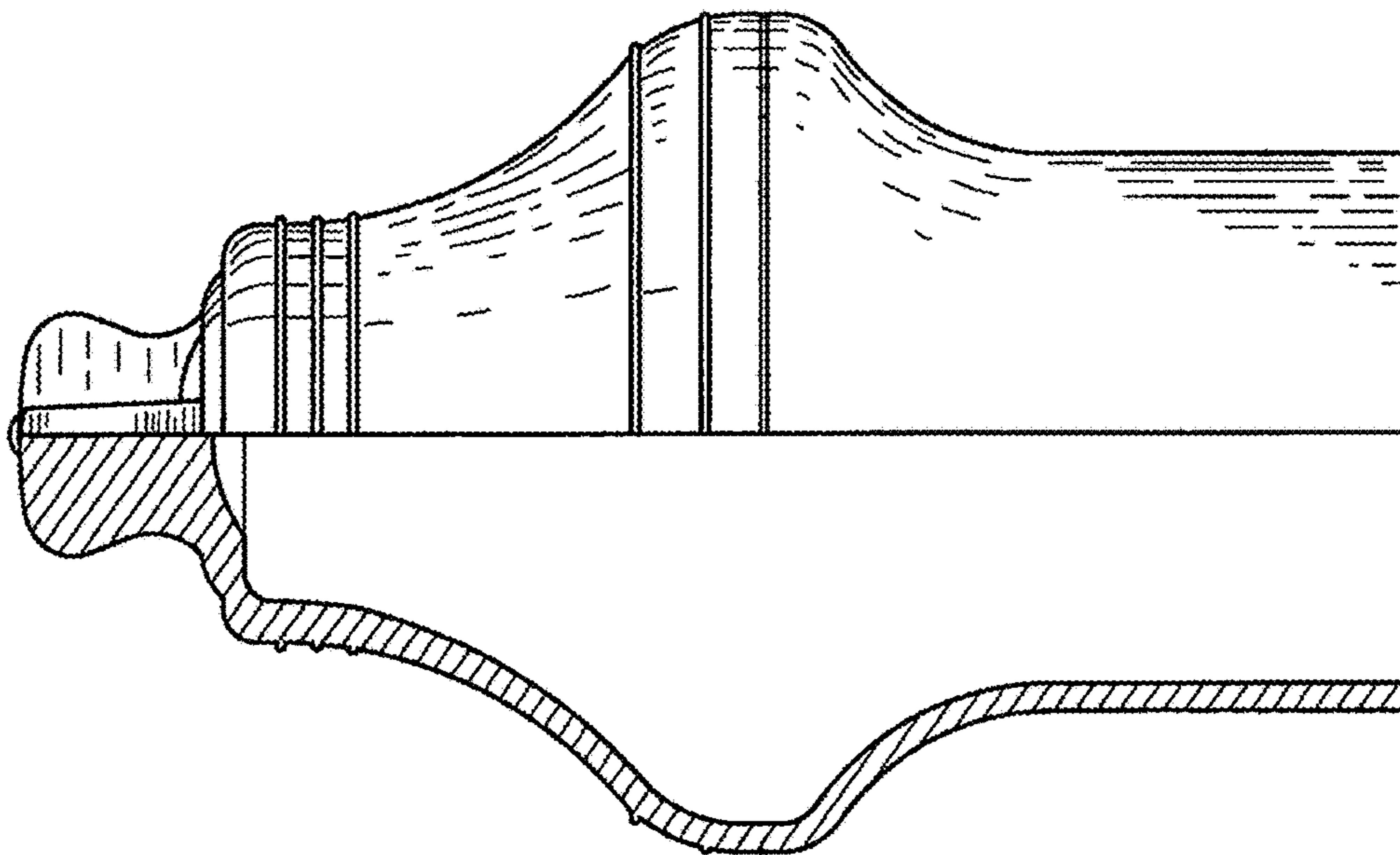

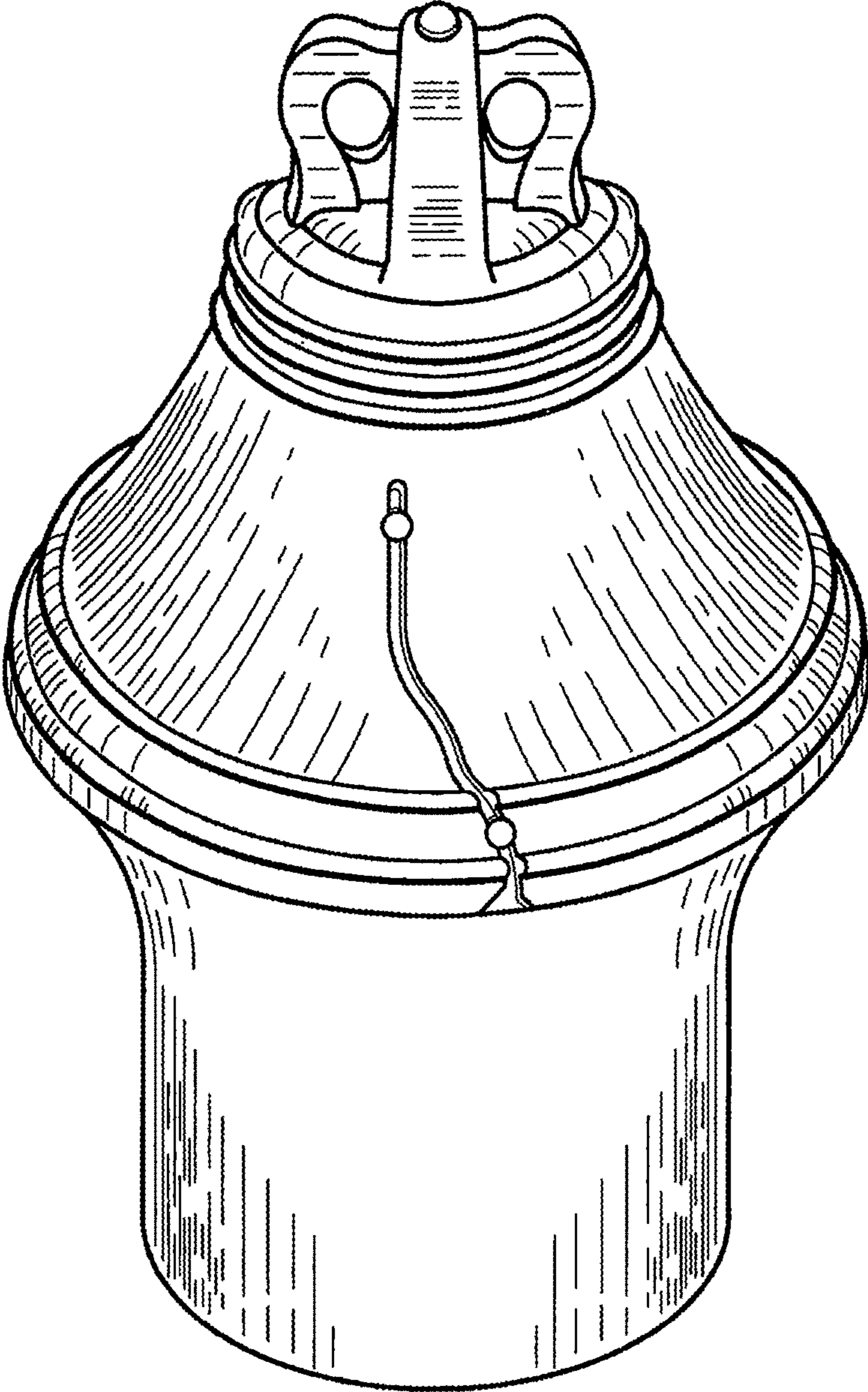
