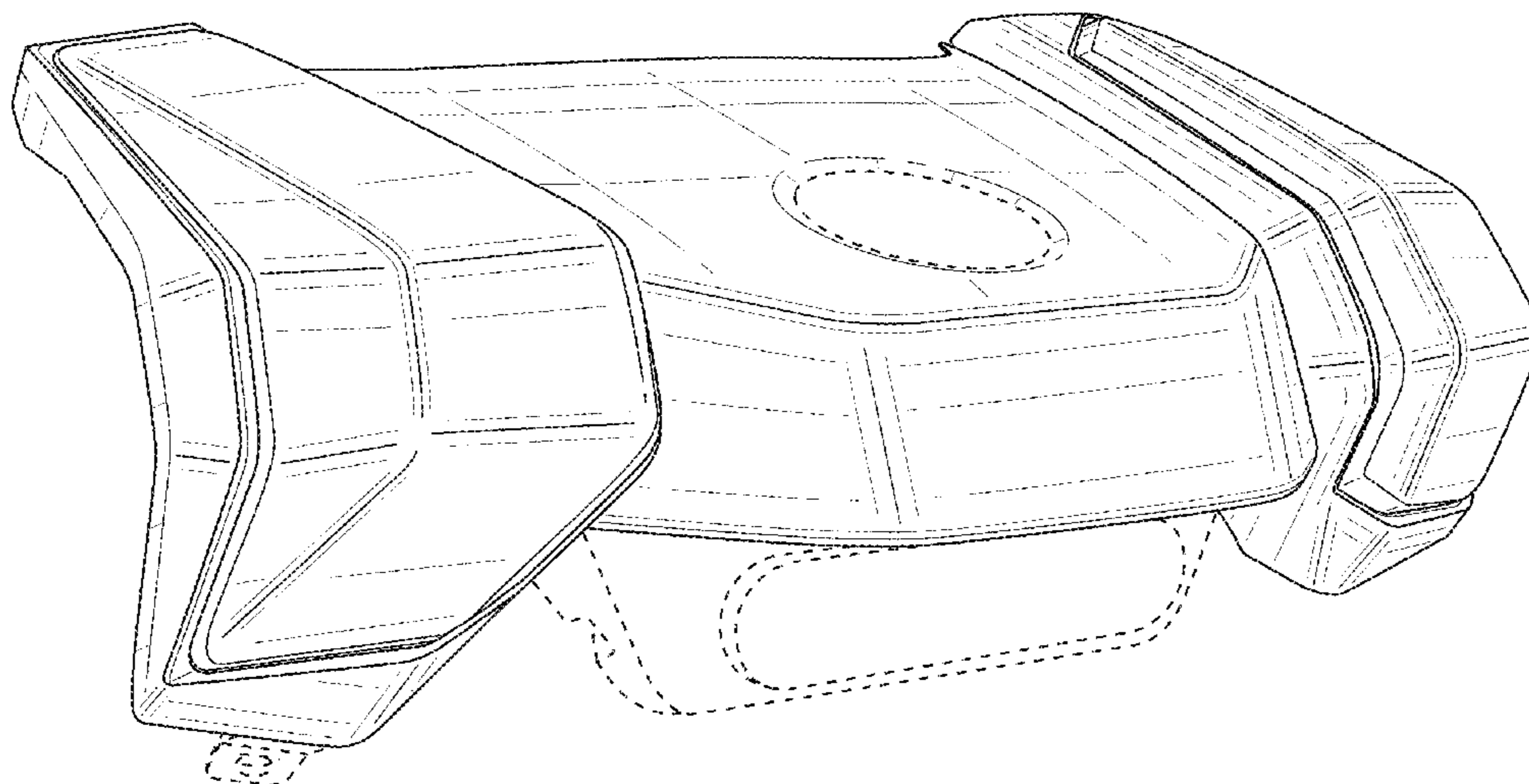

DESCRIPTION
FIG. 1 is a perspective view taken from a front, right side of a vehicle rear module according to our design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. In the Figures, where shown, the dashed lines showing additional structure of the vehicle rear module are for illustrative purposes only and form no part of the claimed design.

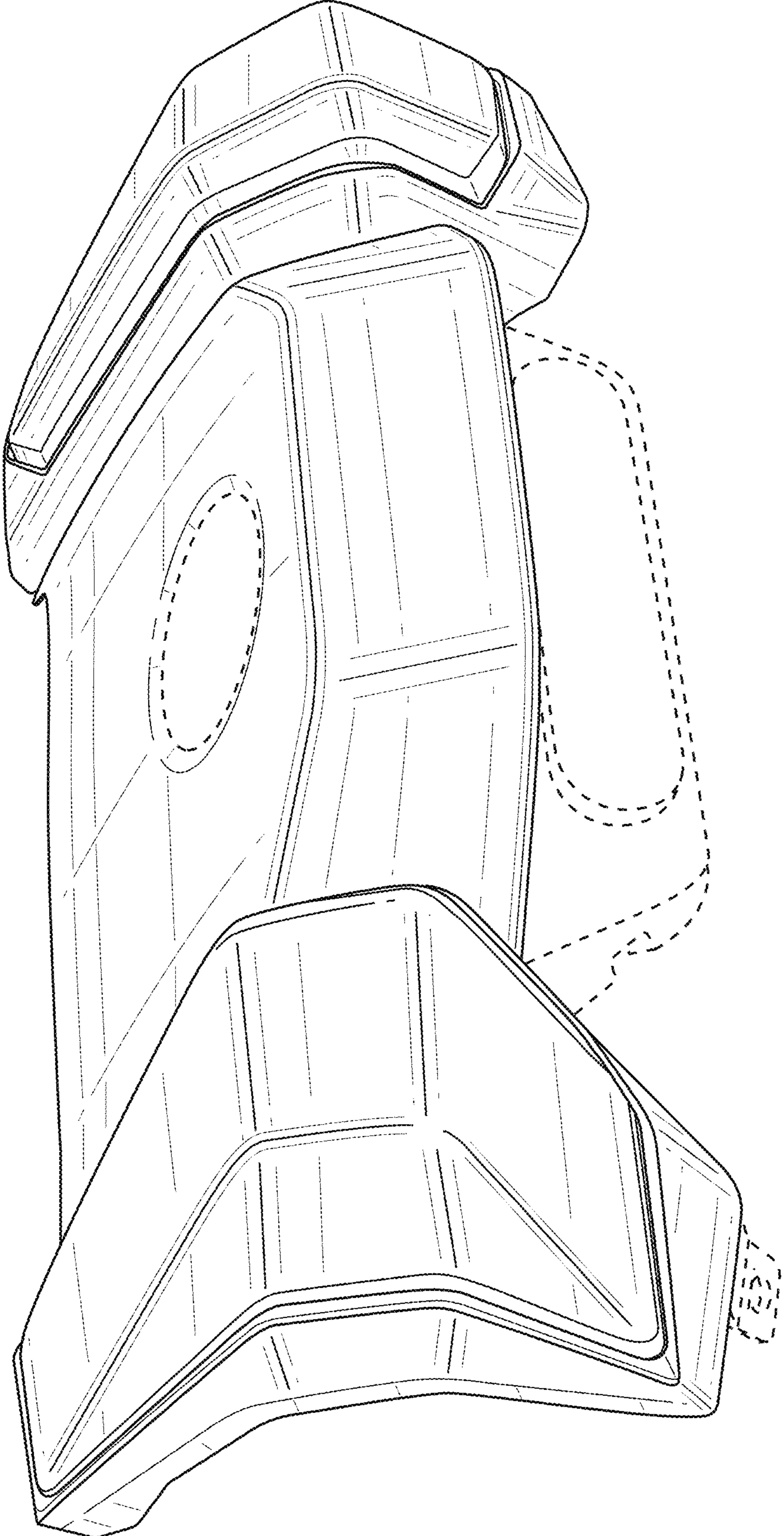

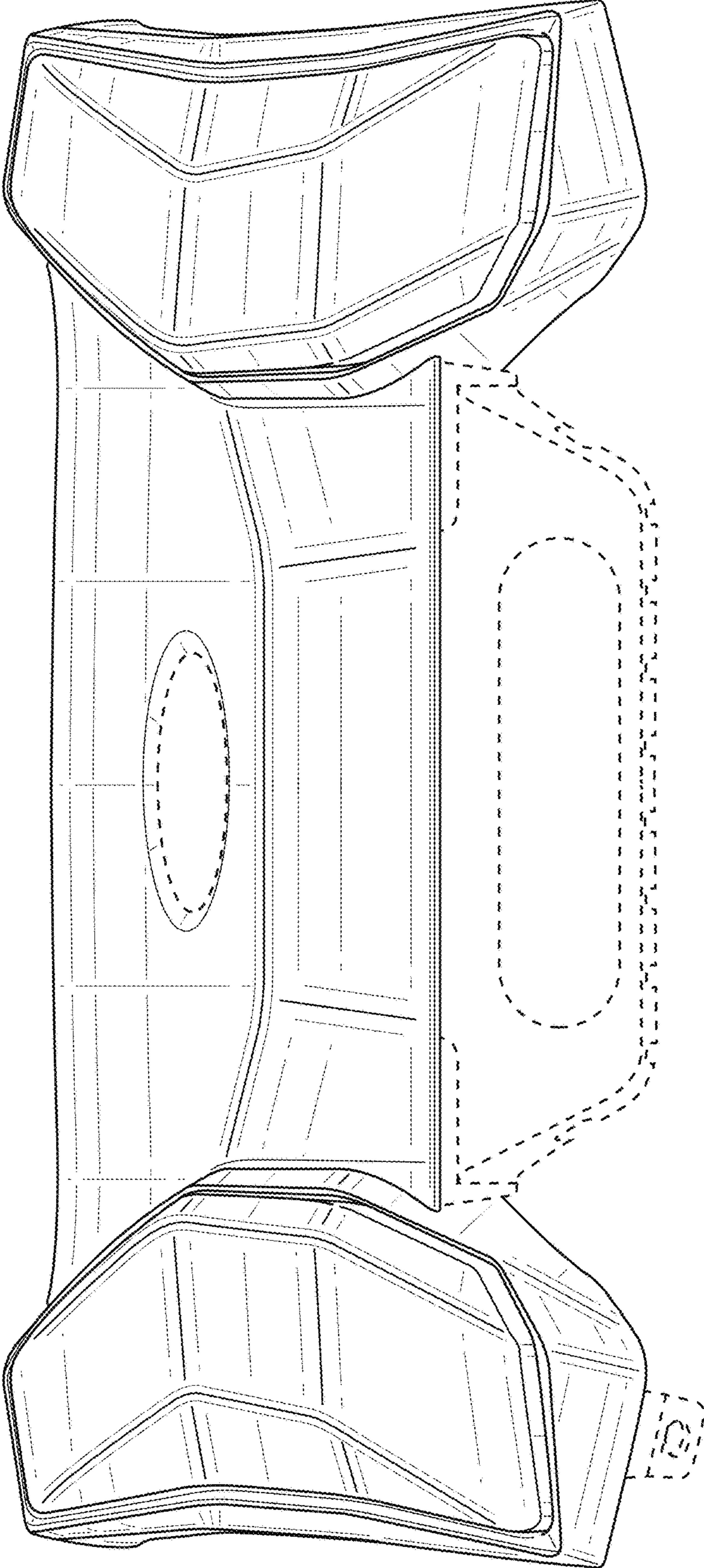

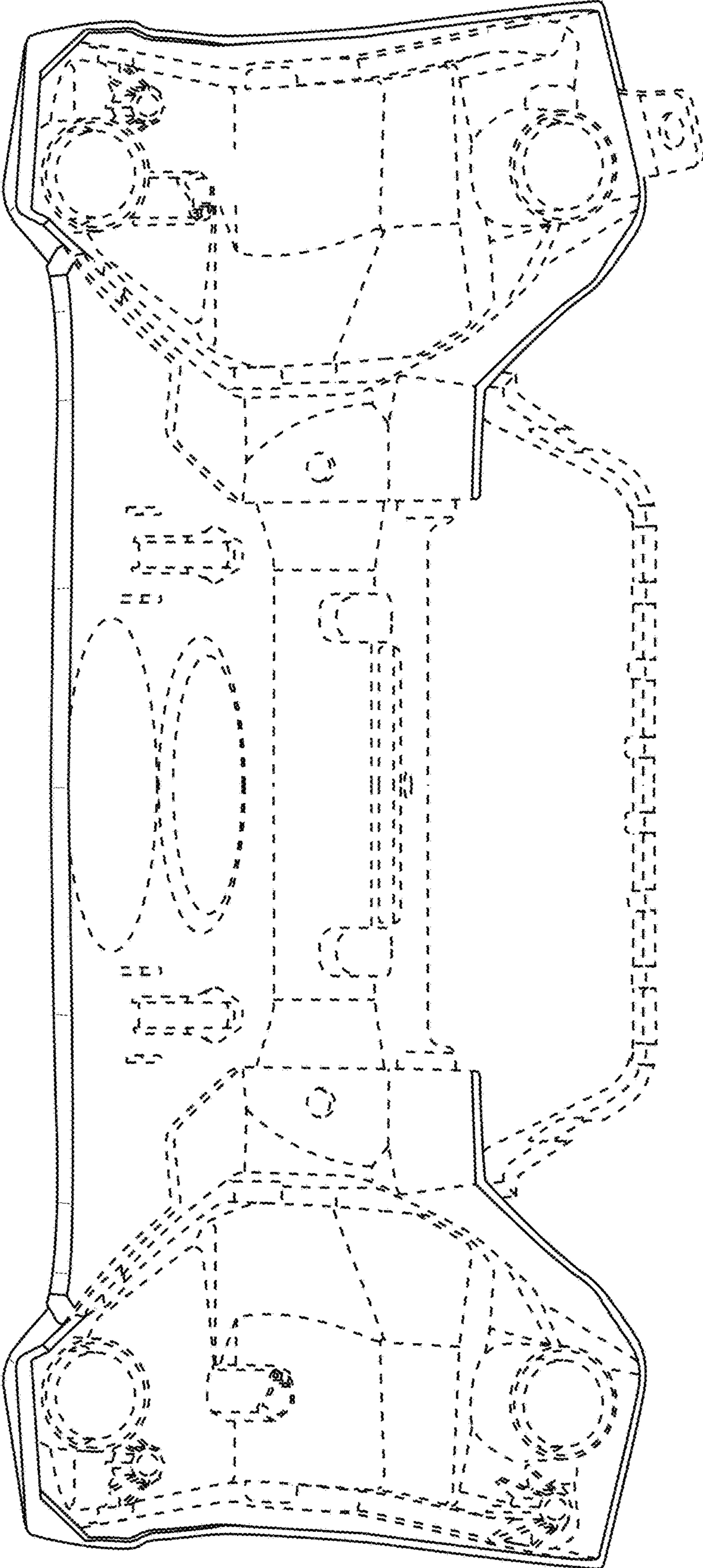

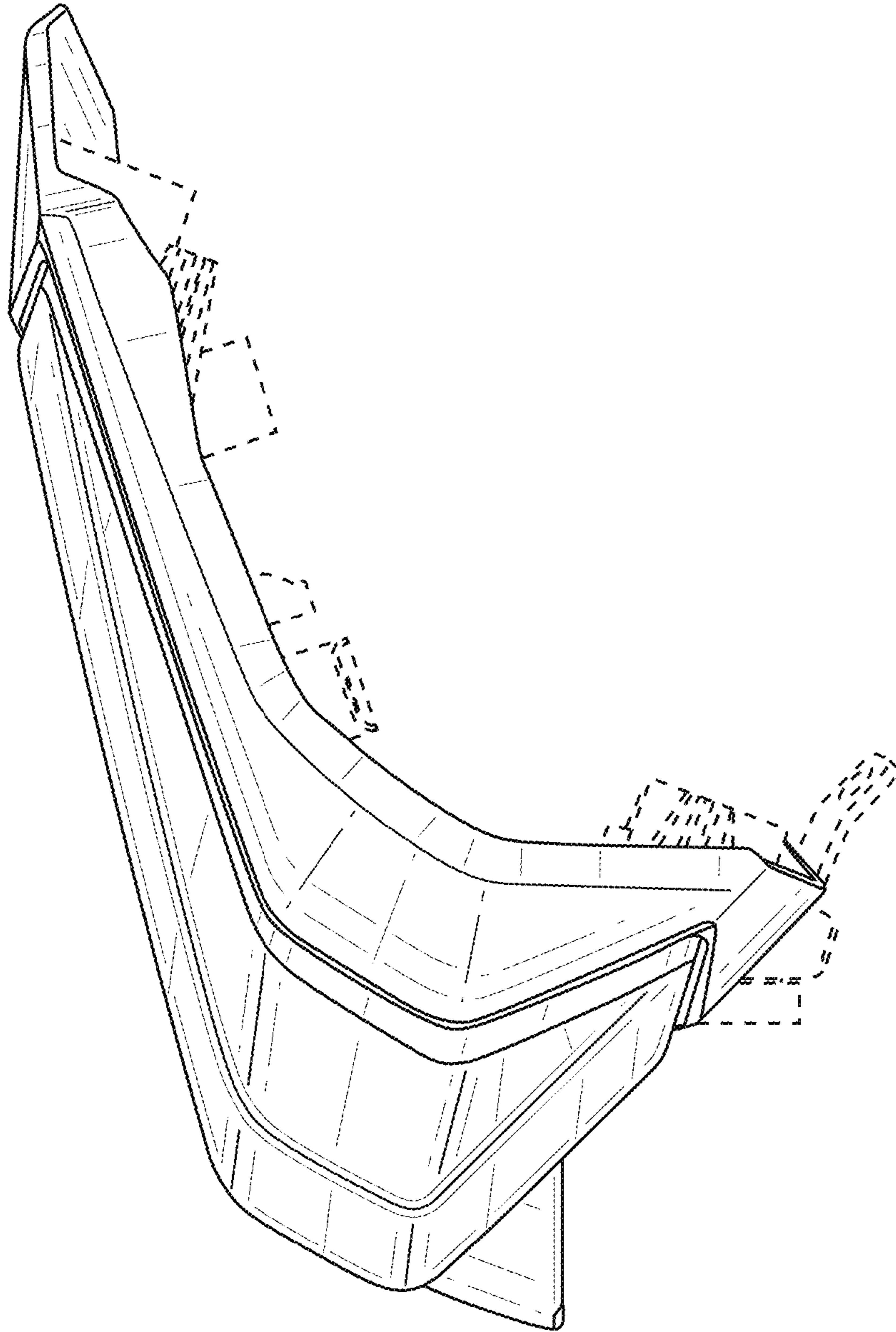

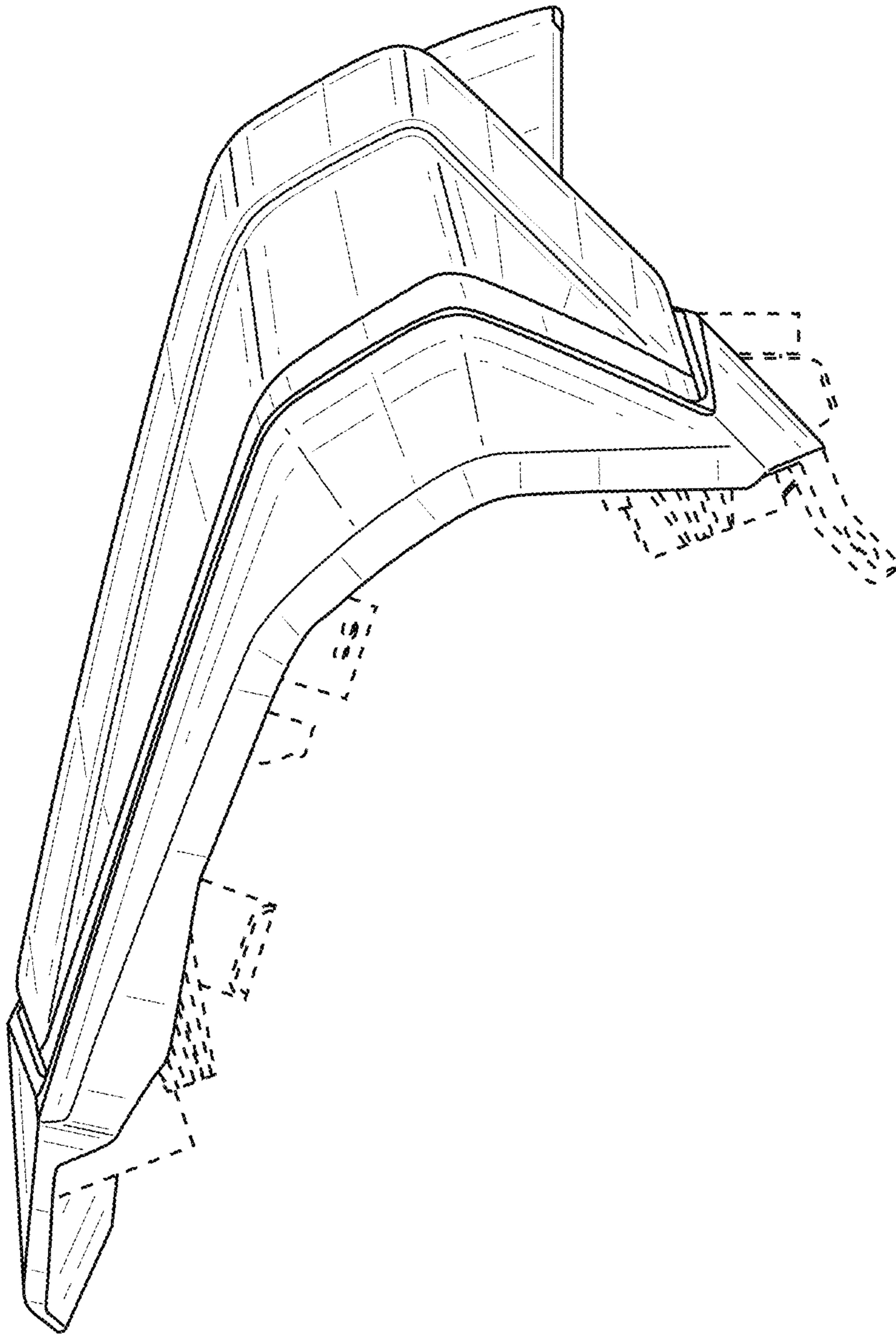

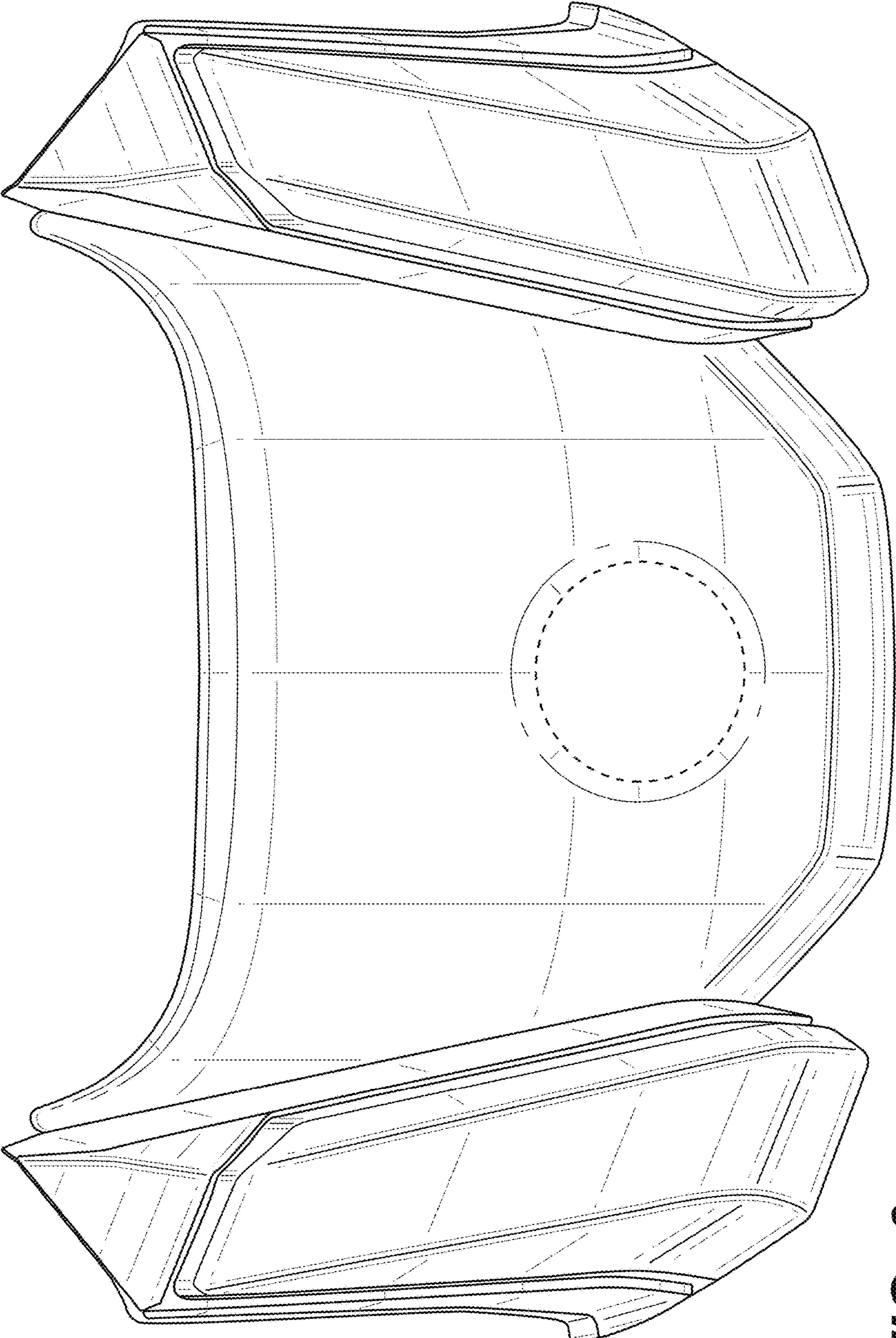

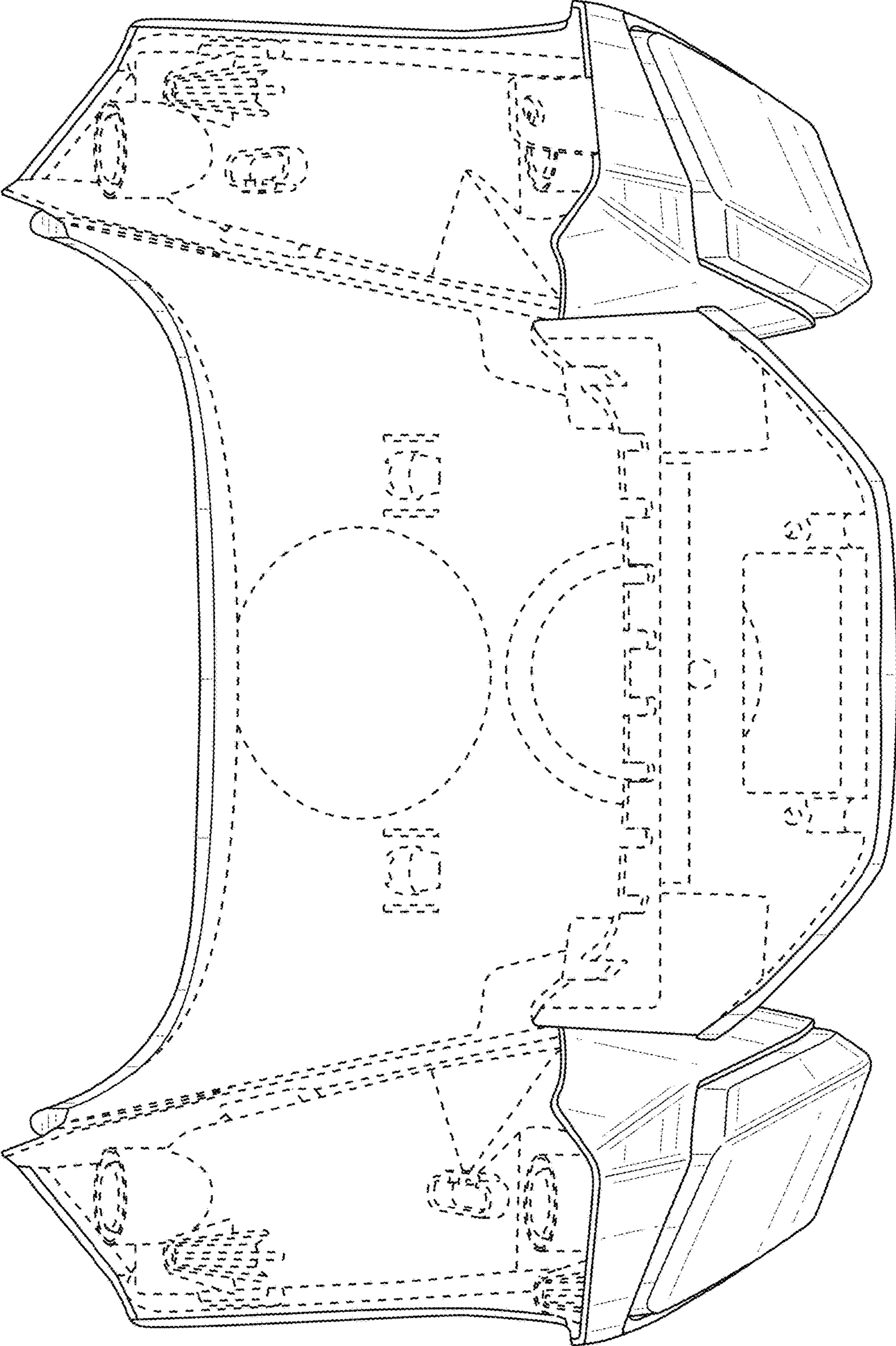
