(57) **CLAIM**

The ornamental design for an all-terrain vehicle tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an all-terrain vehicle tire showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a left view thereof;
FIG. 4 is a partially enlarged view of the indicated area “4” in the FIG. 1; and,
FIG. 5 is a partially enlarged view of the indicated area “5” in the FIG. 2.
The dot-dash broken lines indicating an enlargement portion of the design form no part of the claimed design.

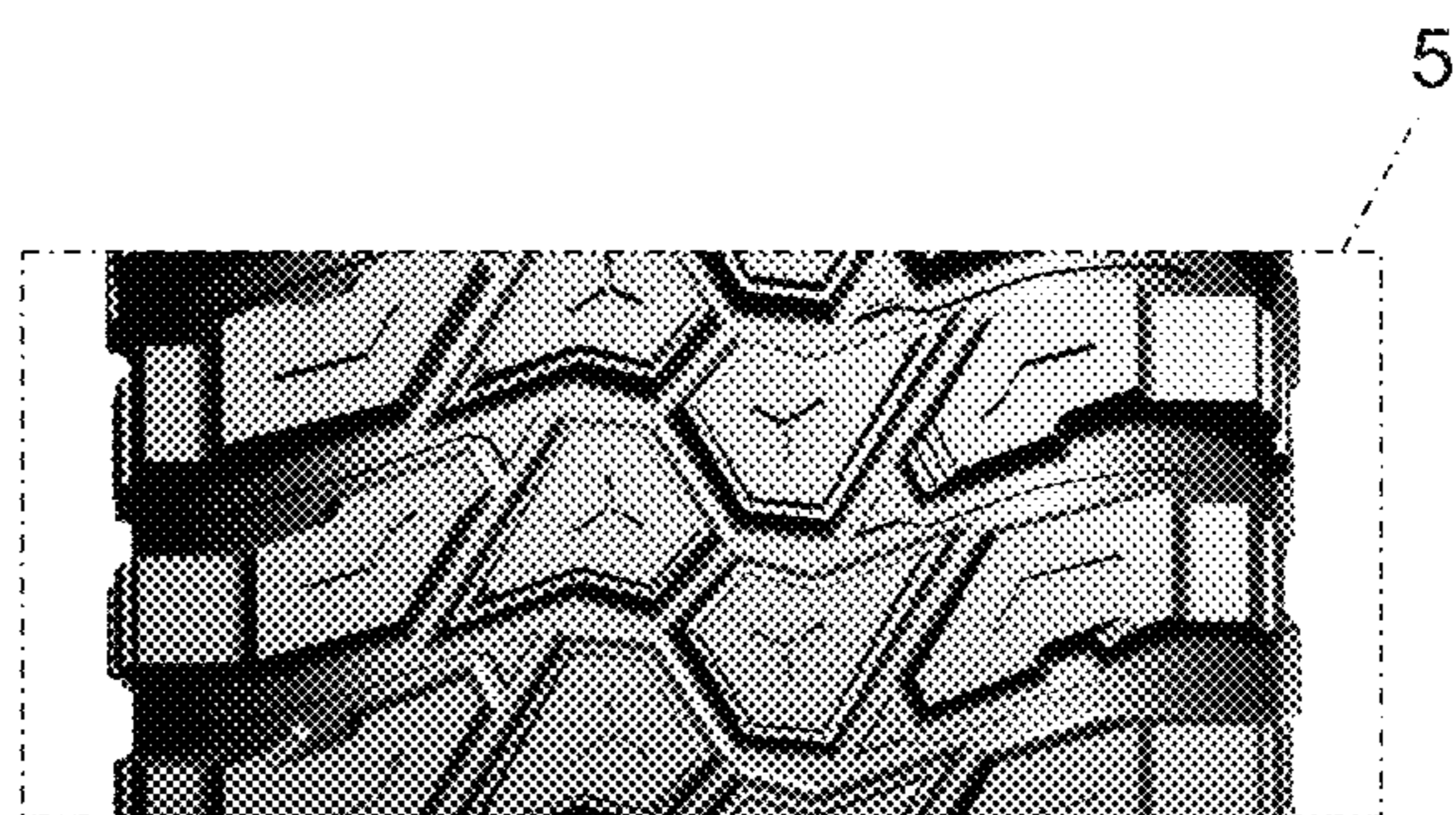

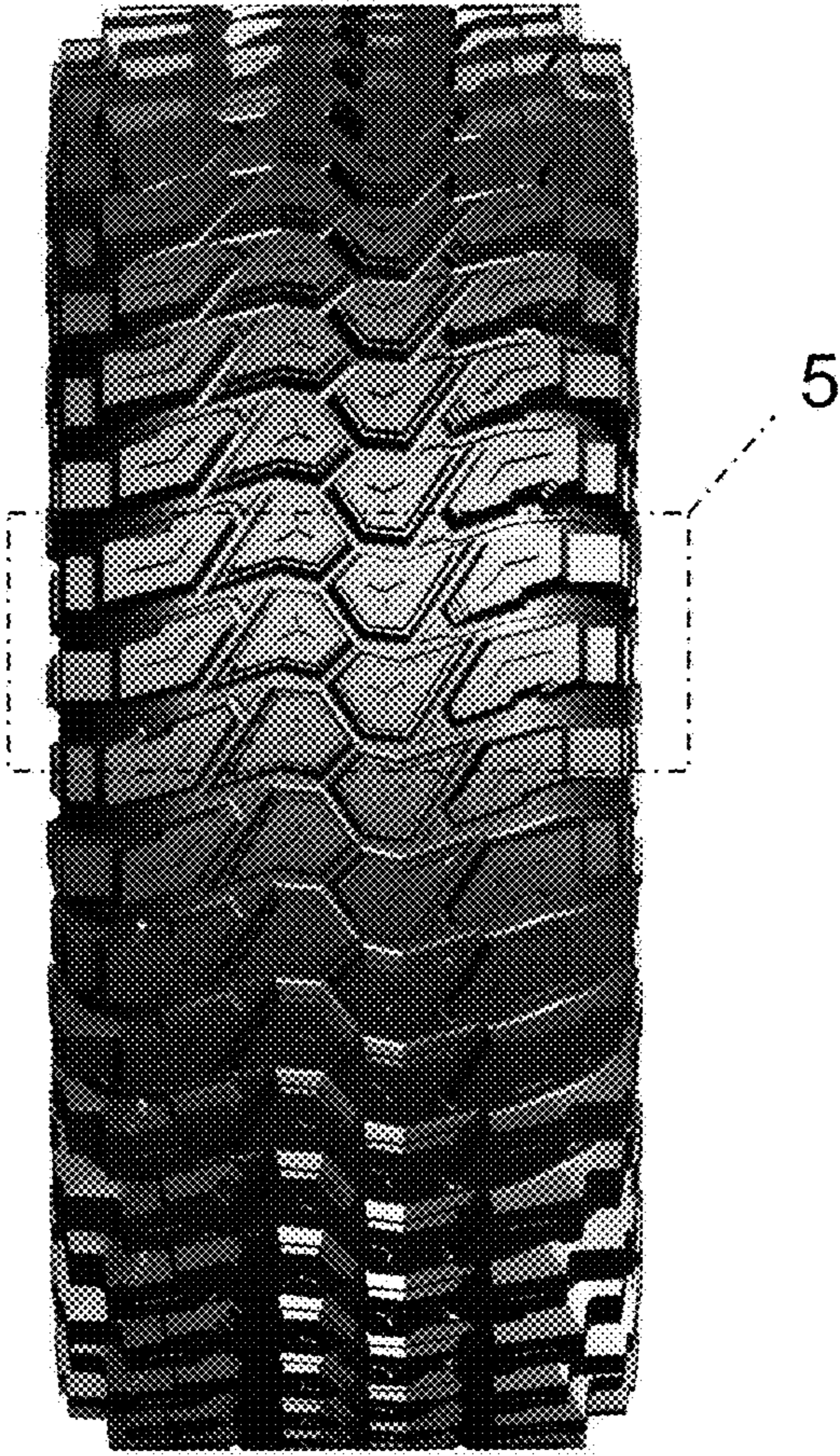

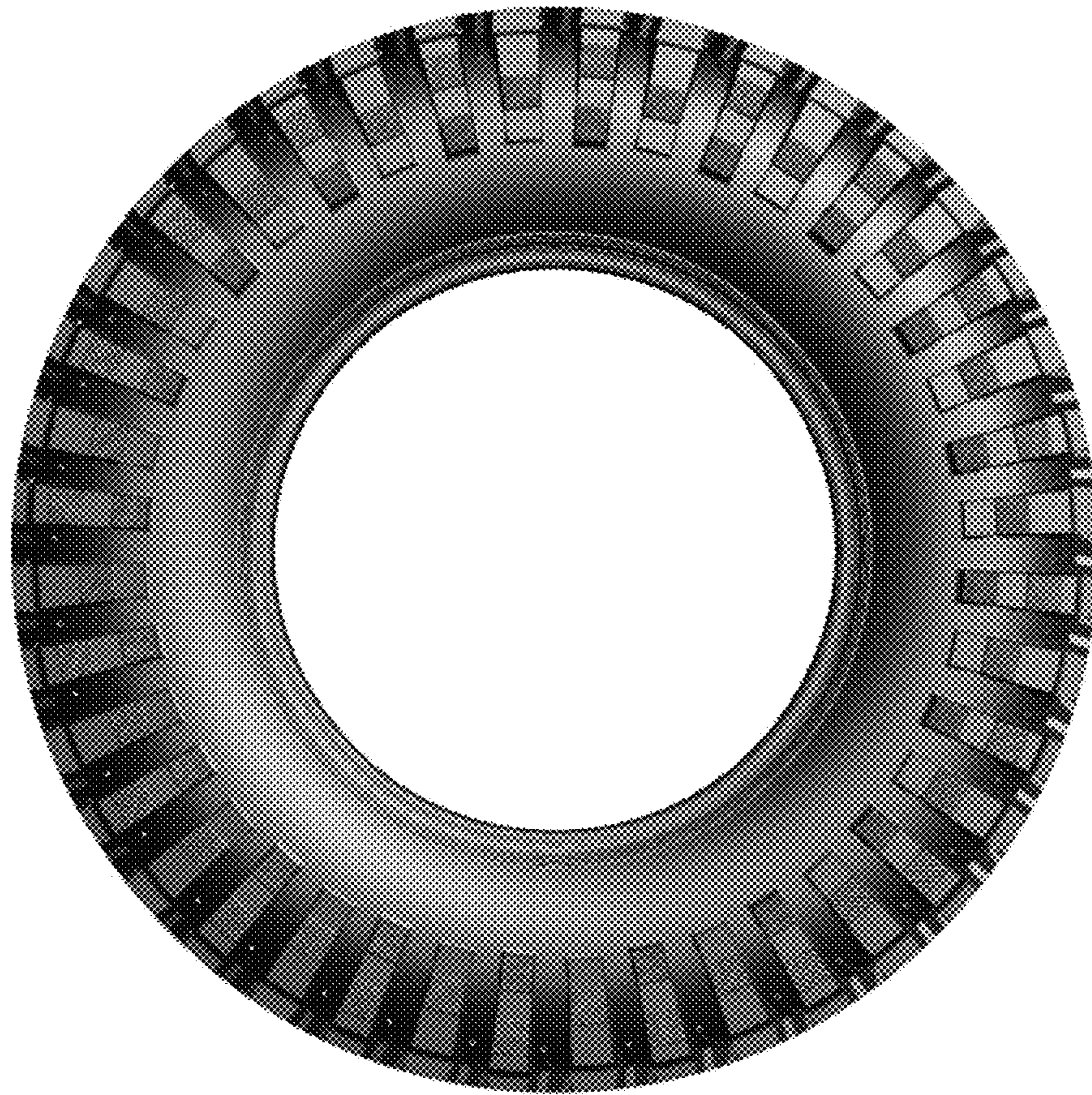

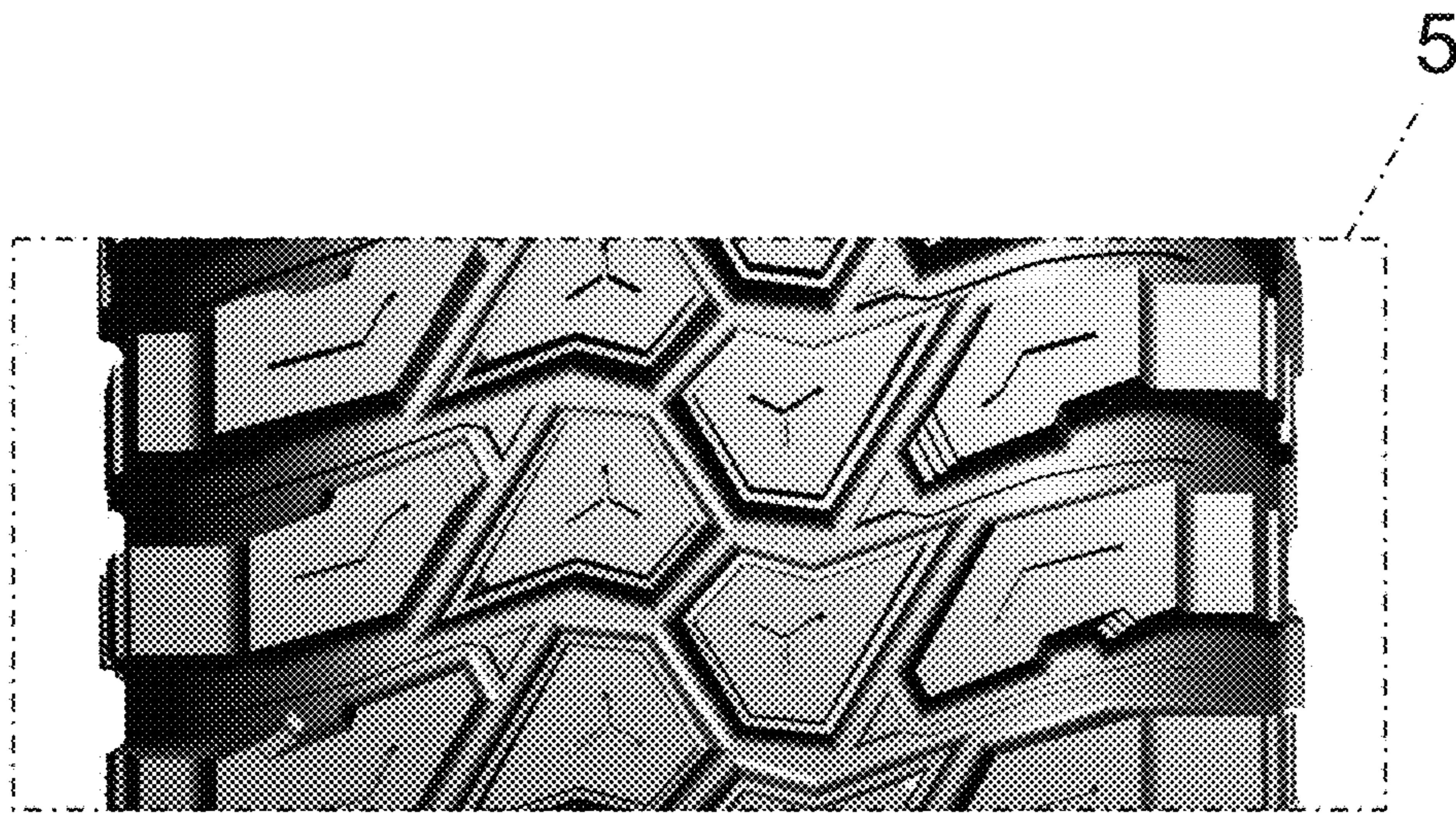
