 FIG. 8 is a bottom plan view of the full-screen smartphone of FIG. 1.

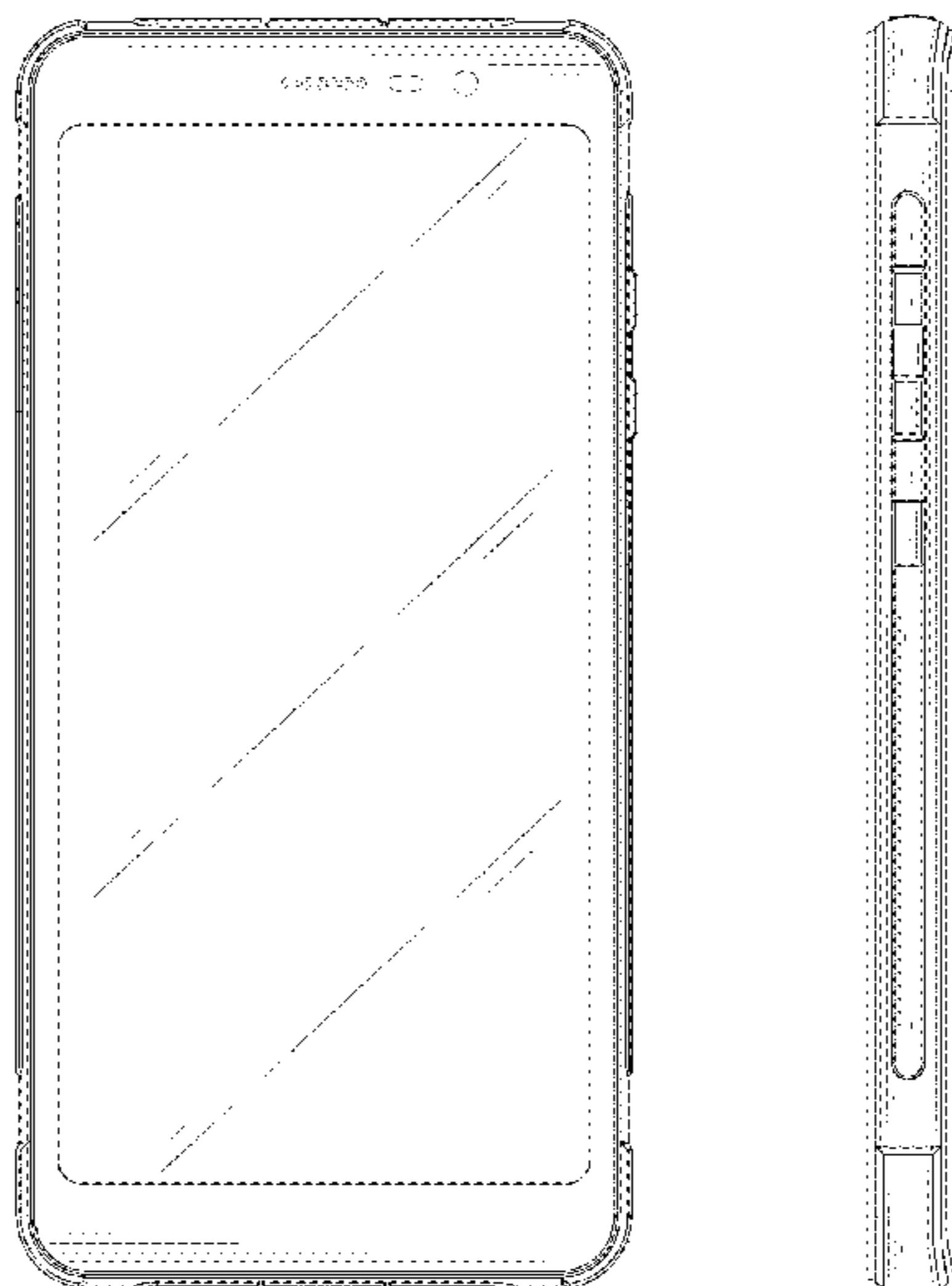

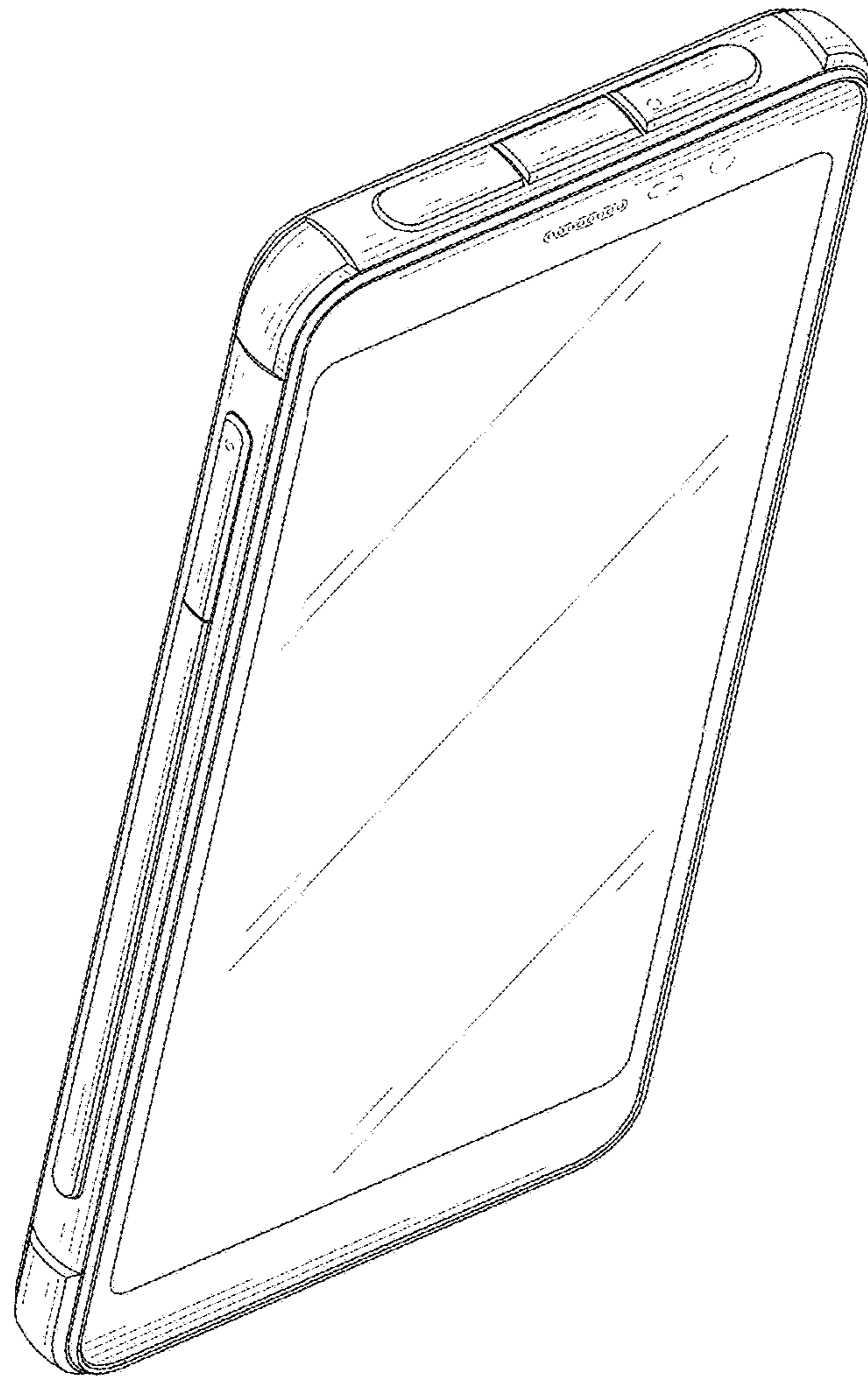

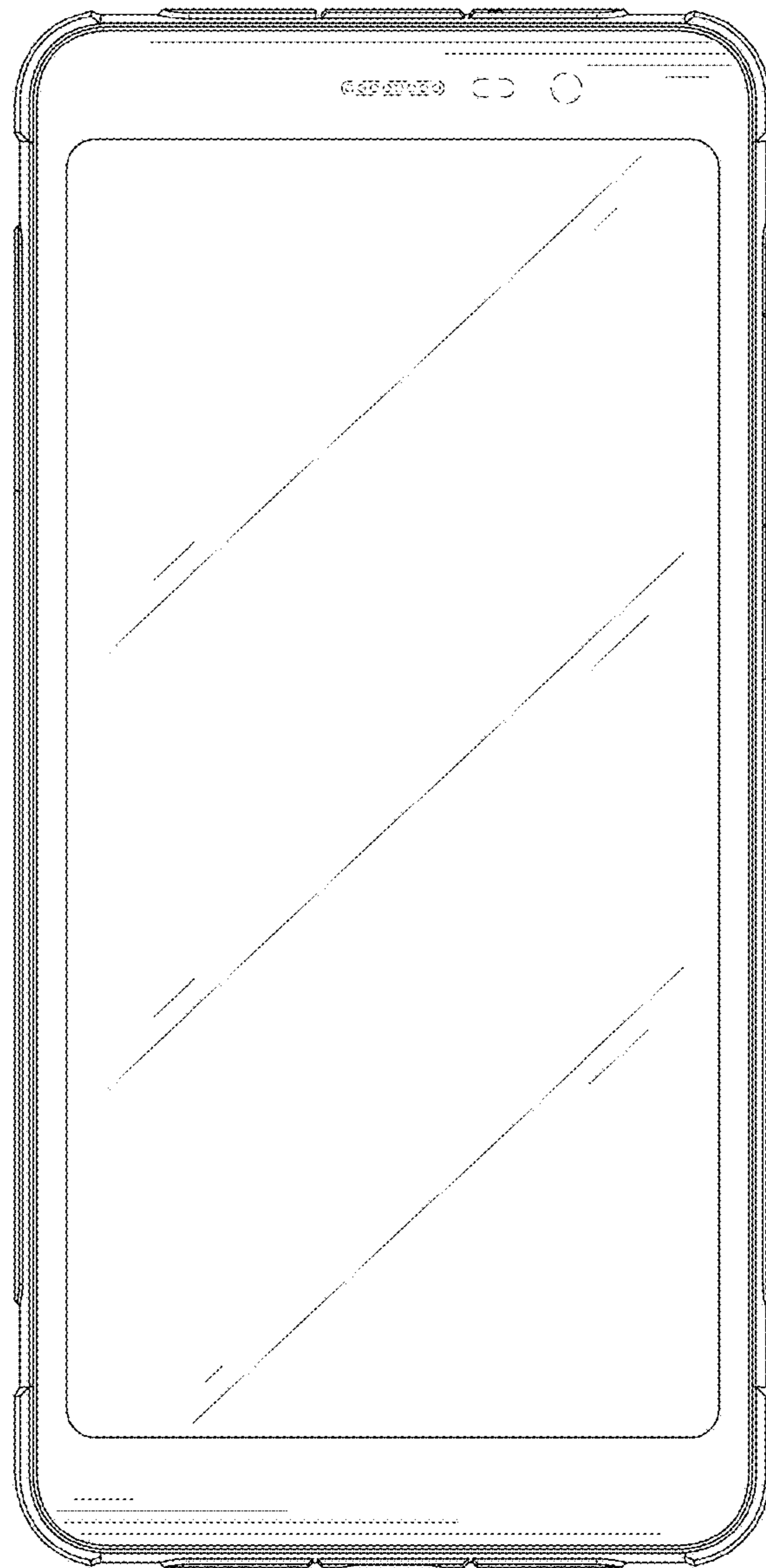

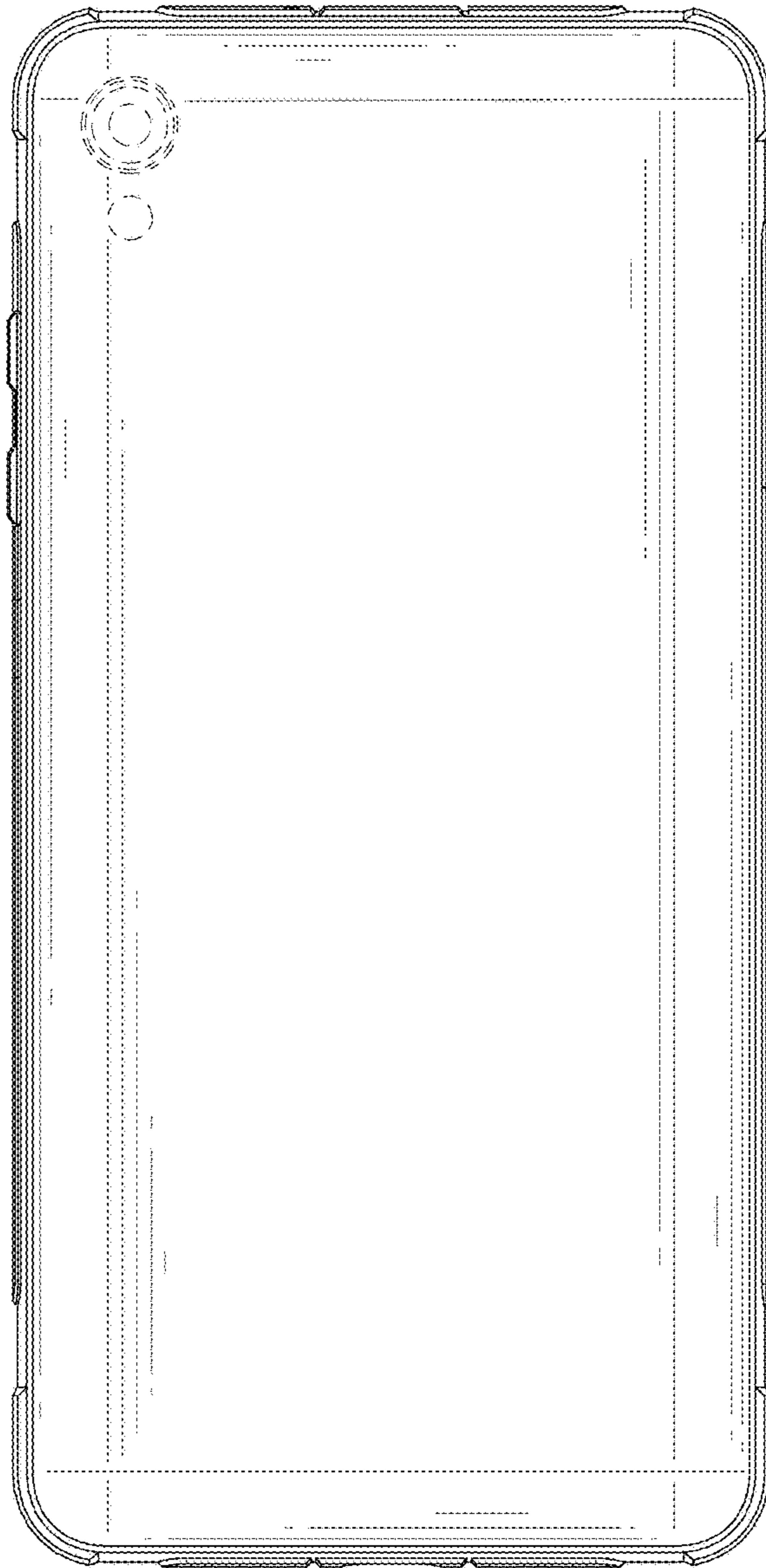

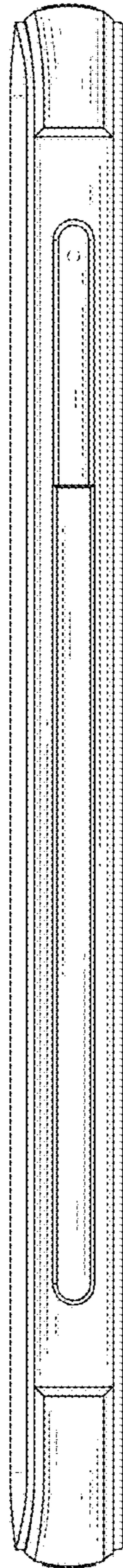

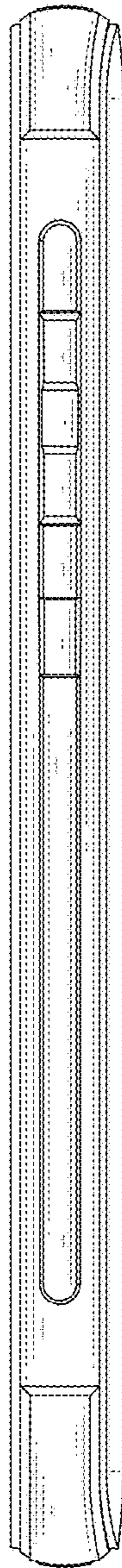

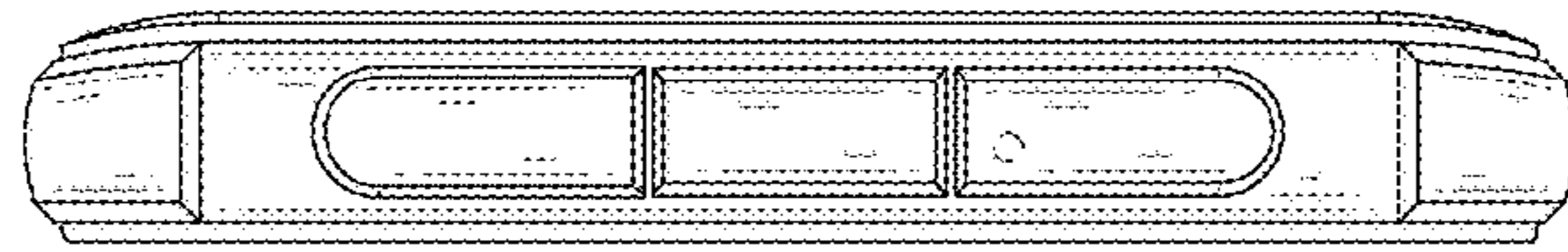

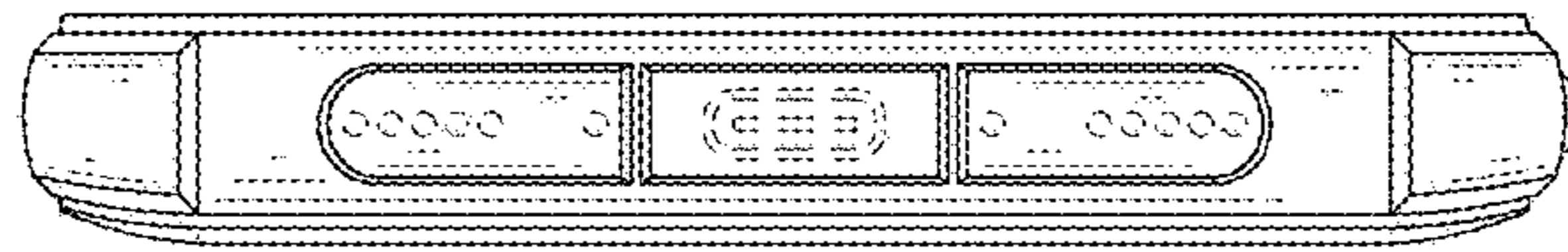
