The ornamental design for a removable bi-fold wallet phone case, as shown and described.

**DESCRIPTION**

FIG. 5 is a right side elevational view of the removable bi-fold wallet phone case thereof;

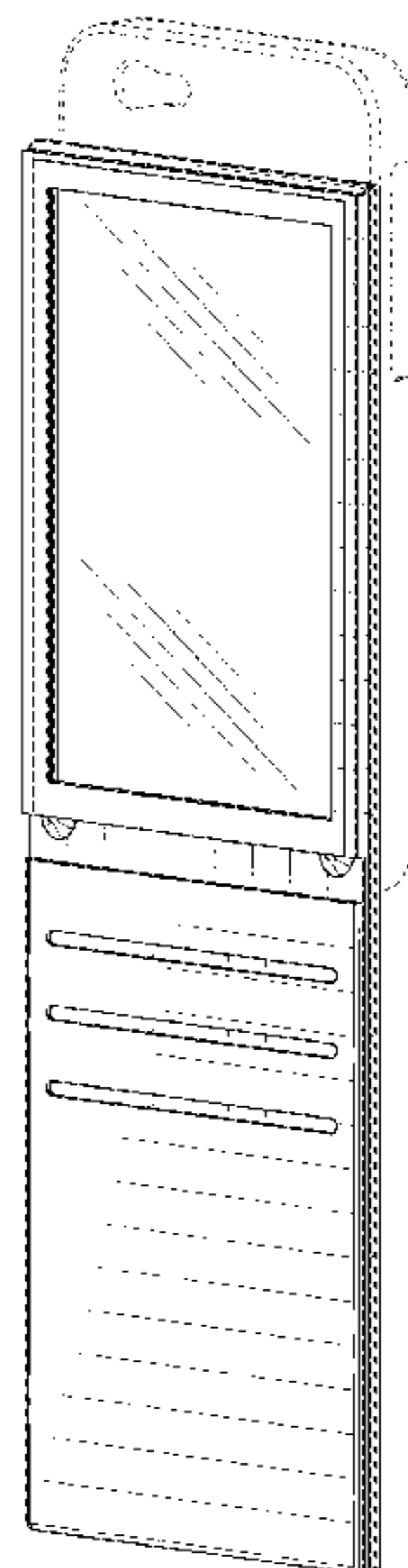
FIG. 6 is a top plan view of the removable bi-fold wallet phone case thereof;

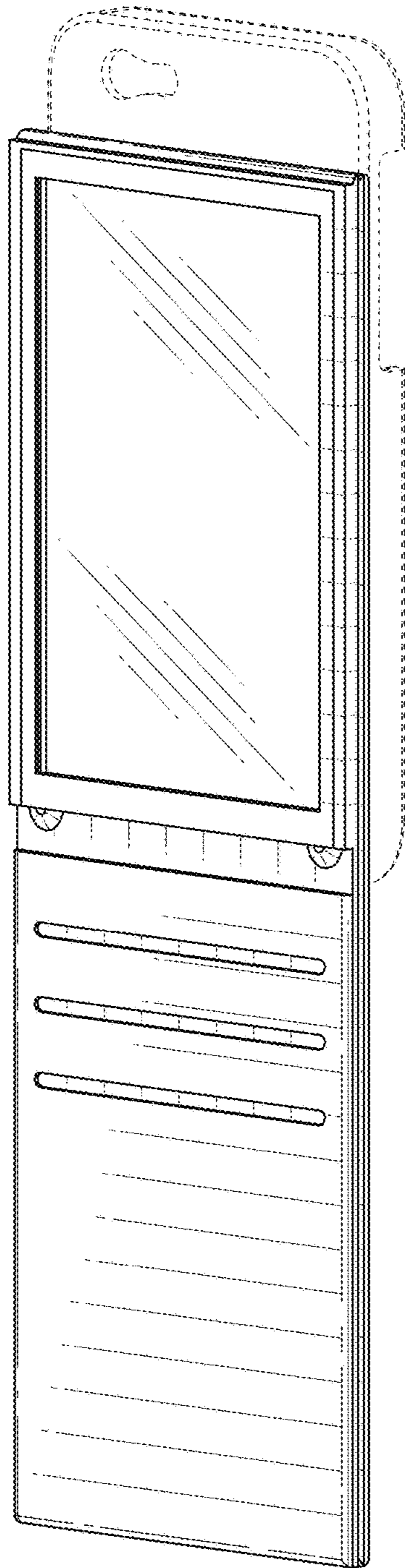

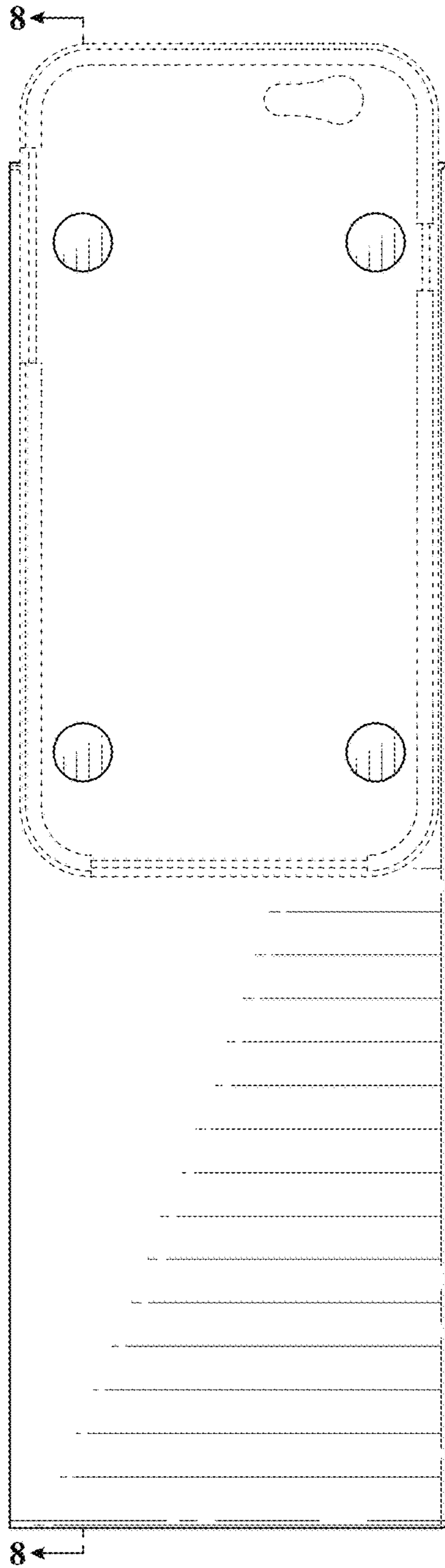
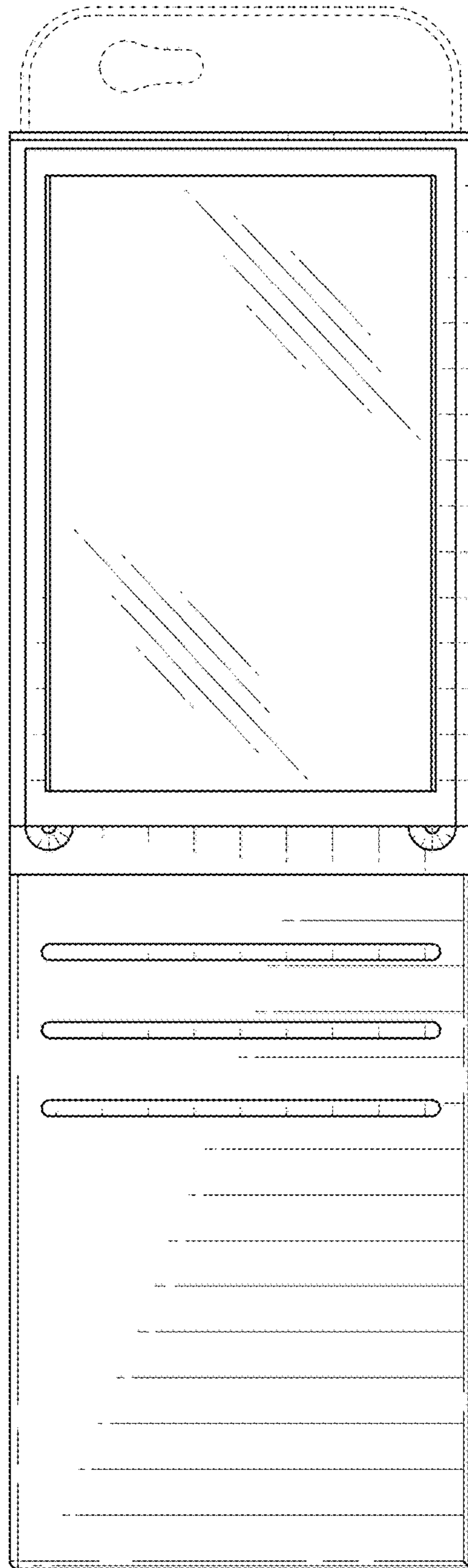
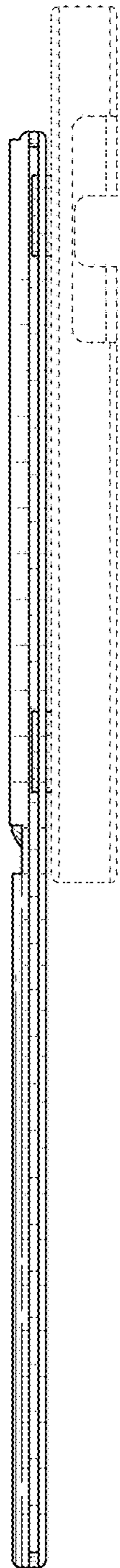


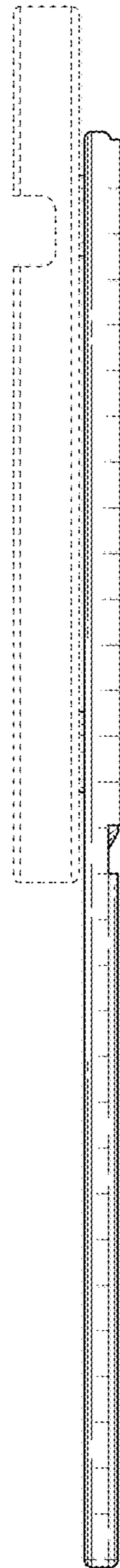

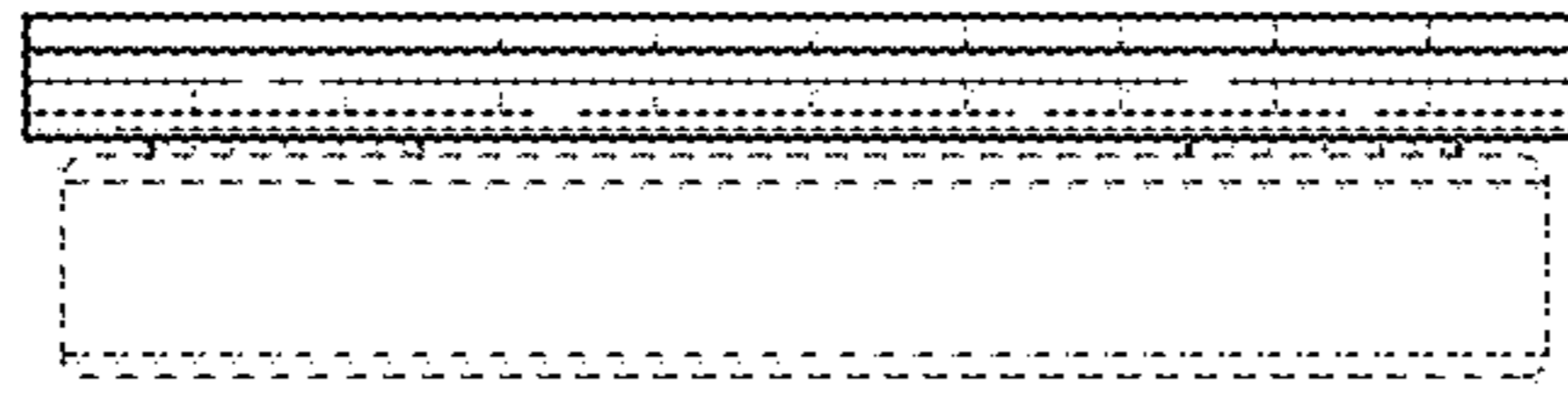

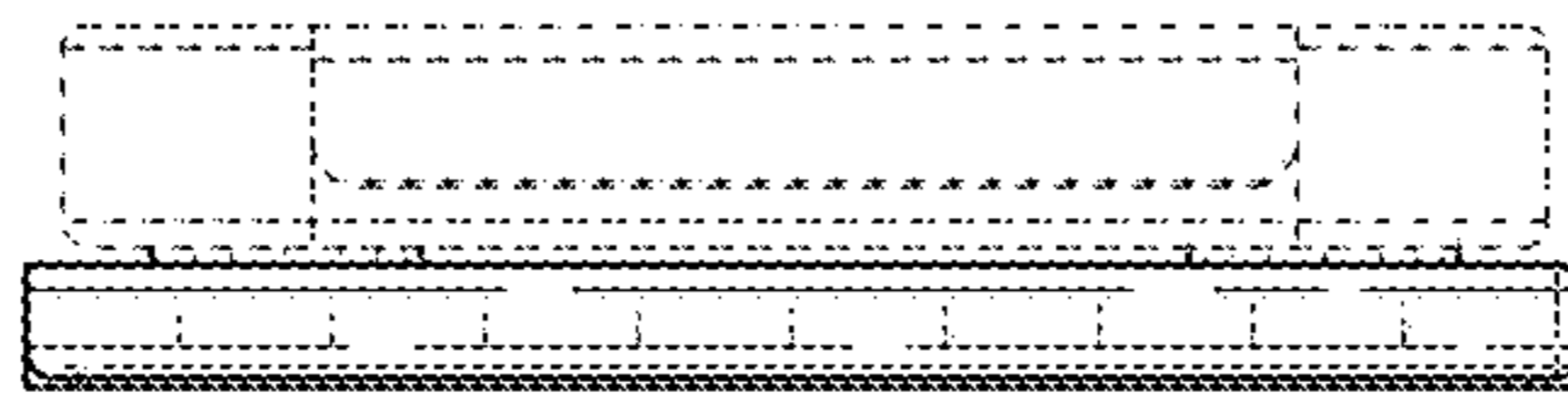
