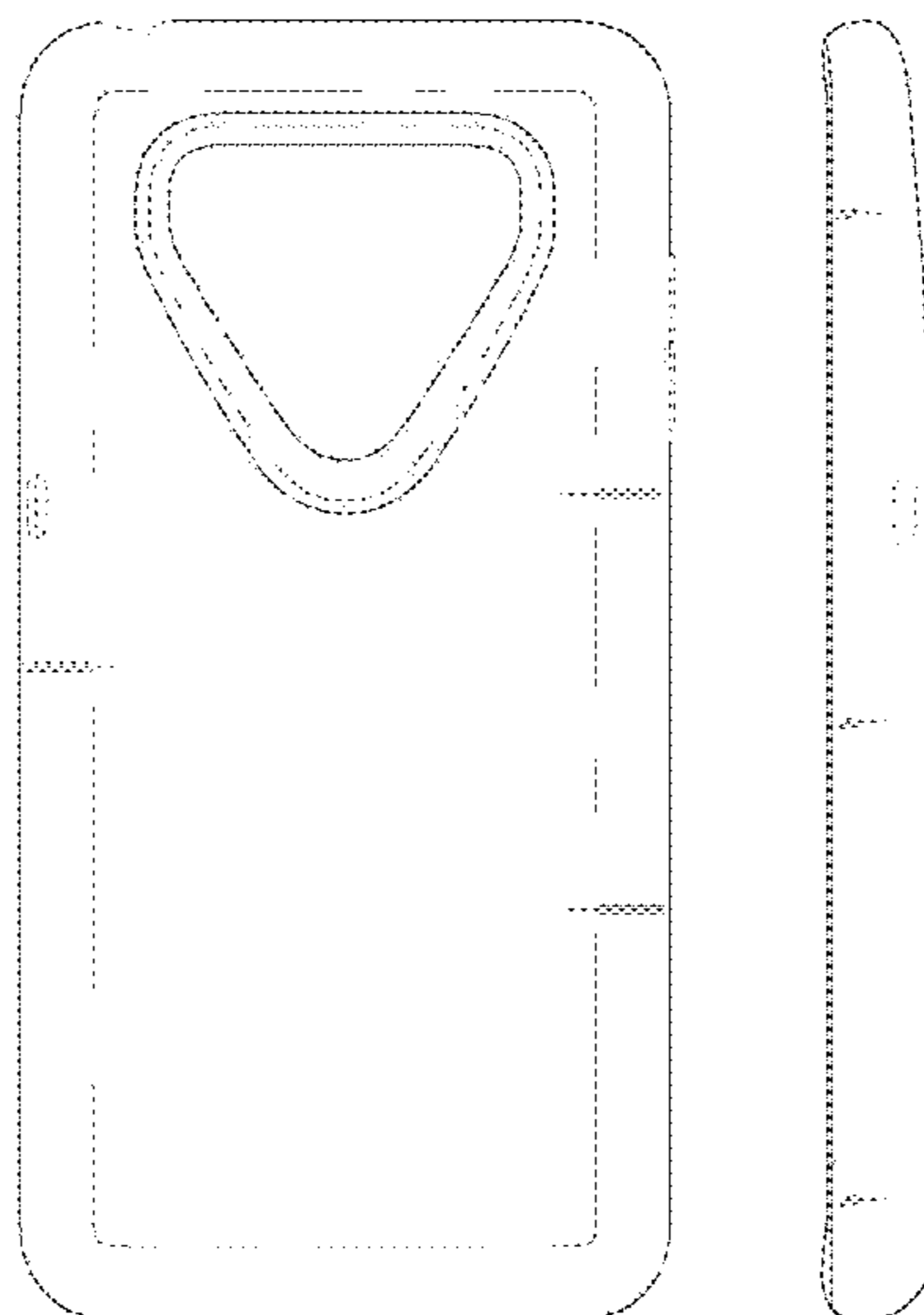
The ornamental design for a case for mobile phones, as shown and described.

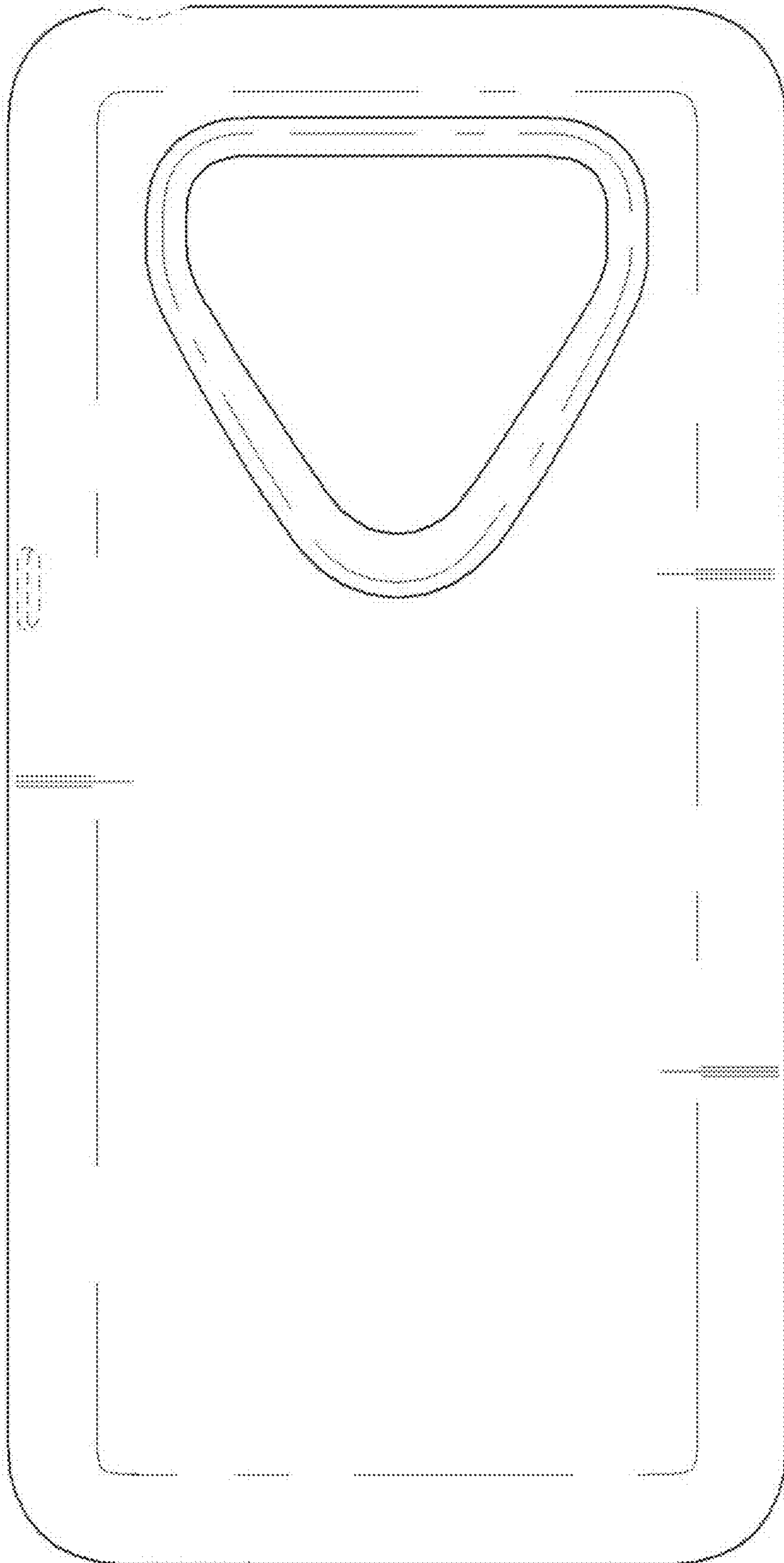

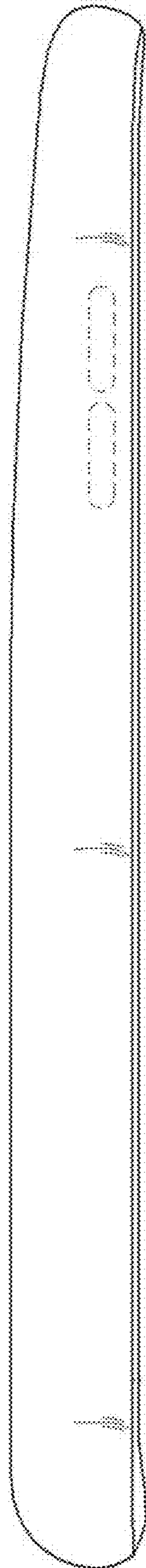

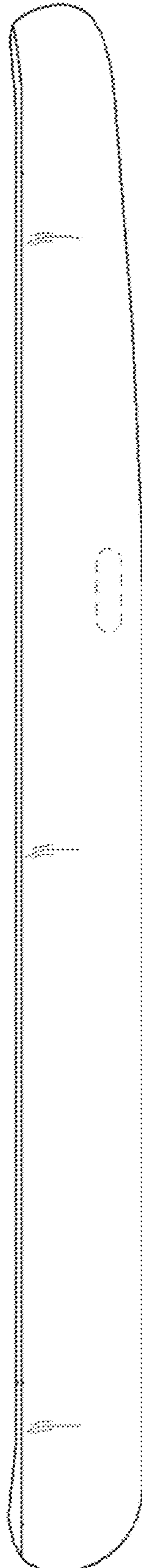

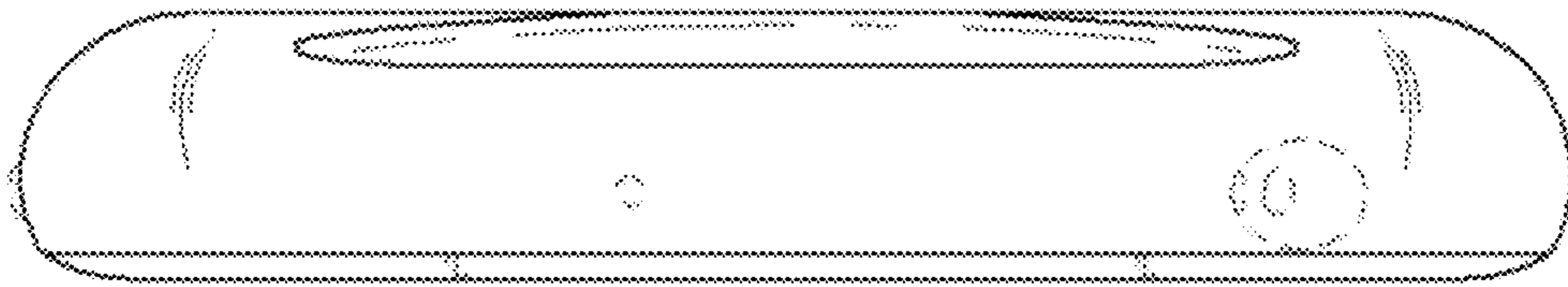

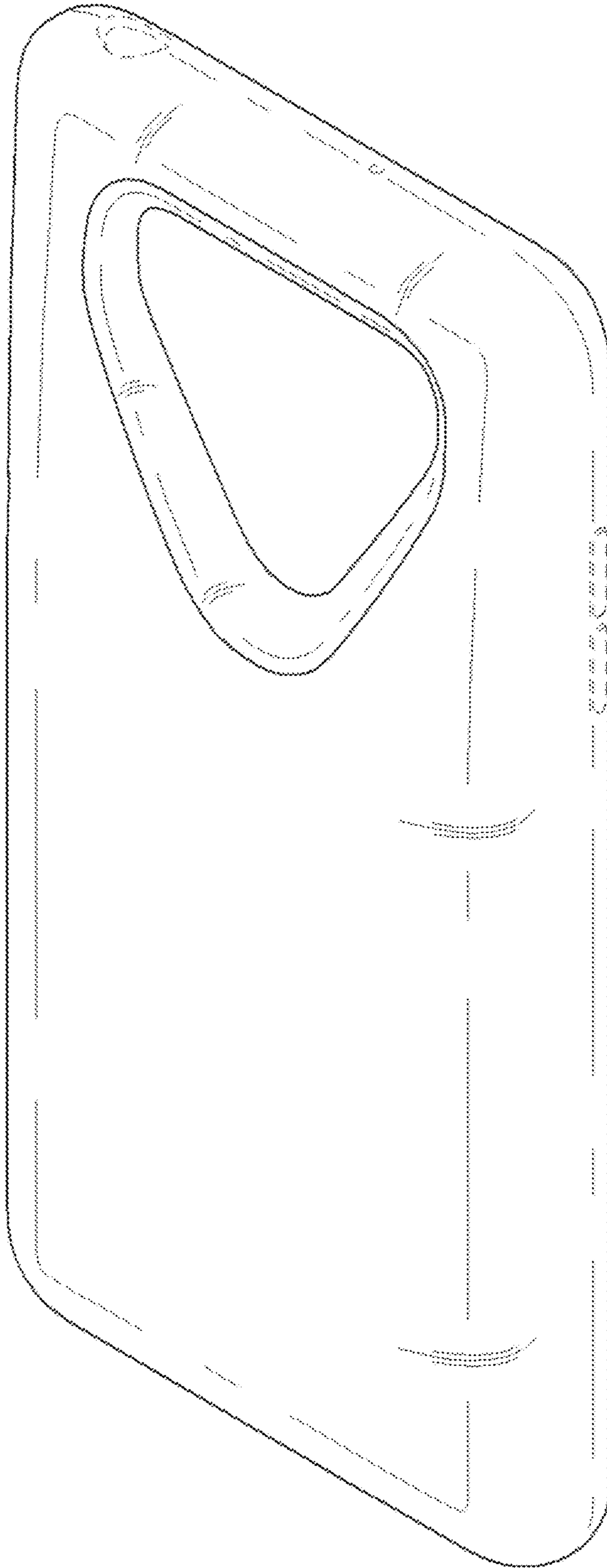
