The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

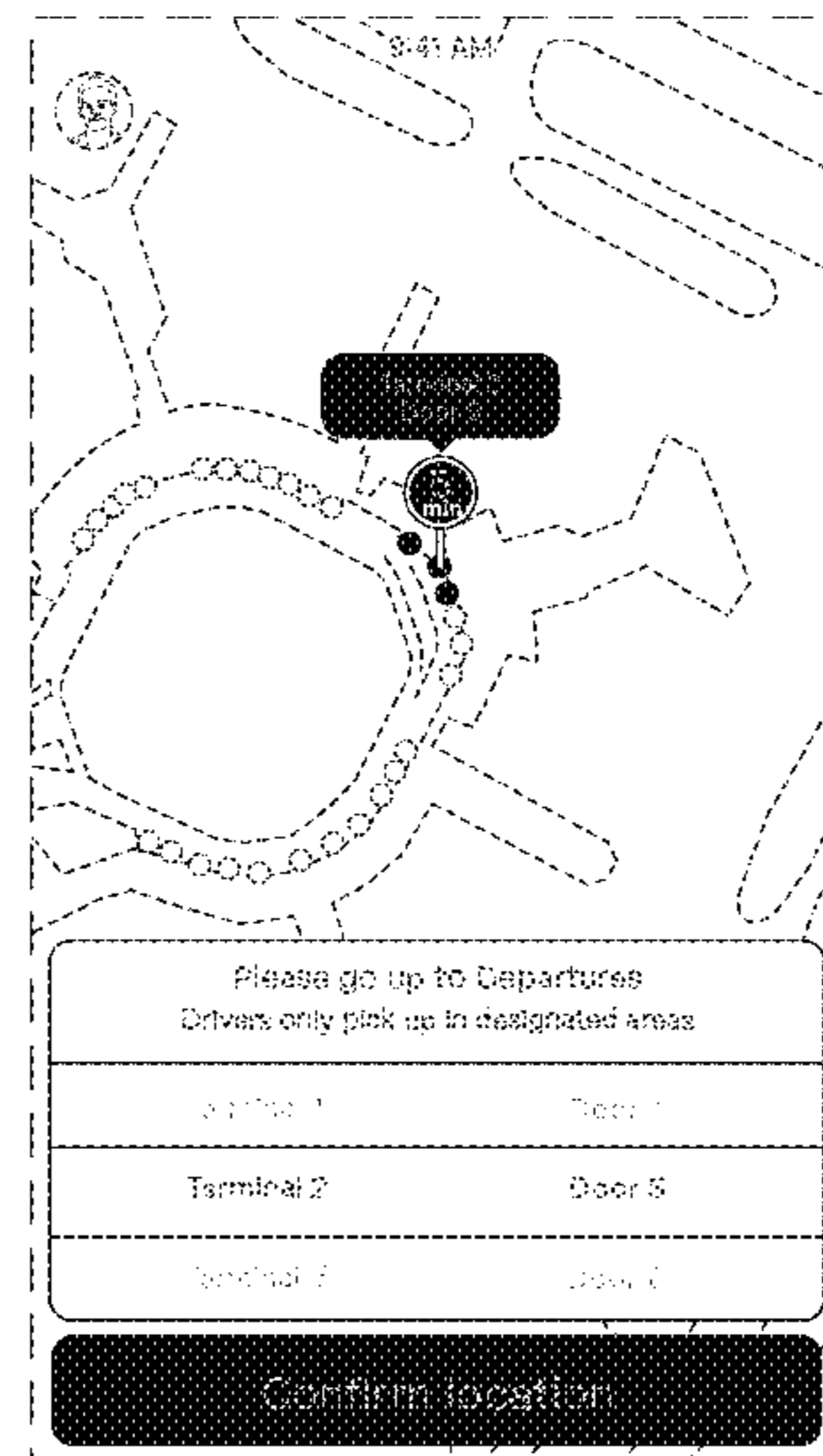
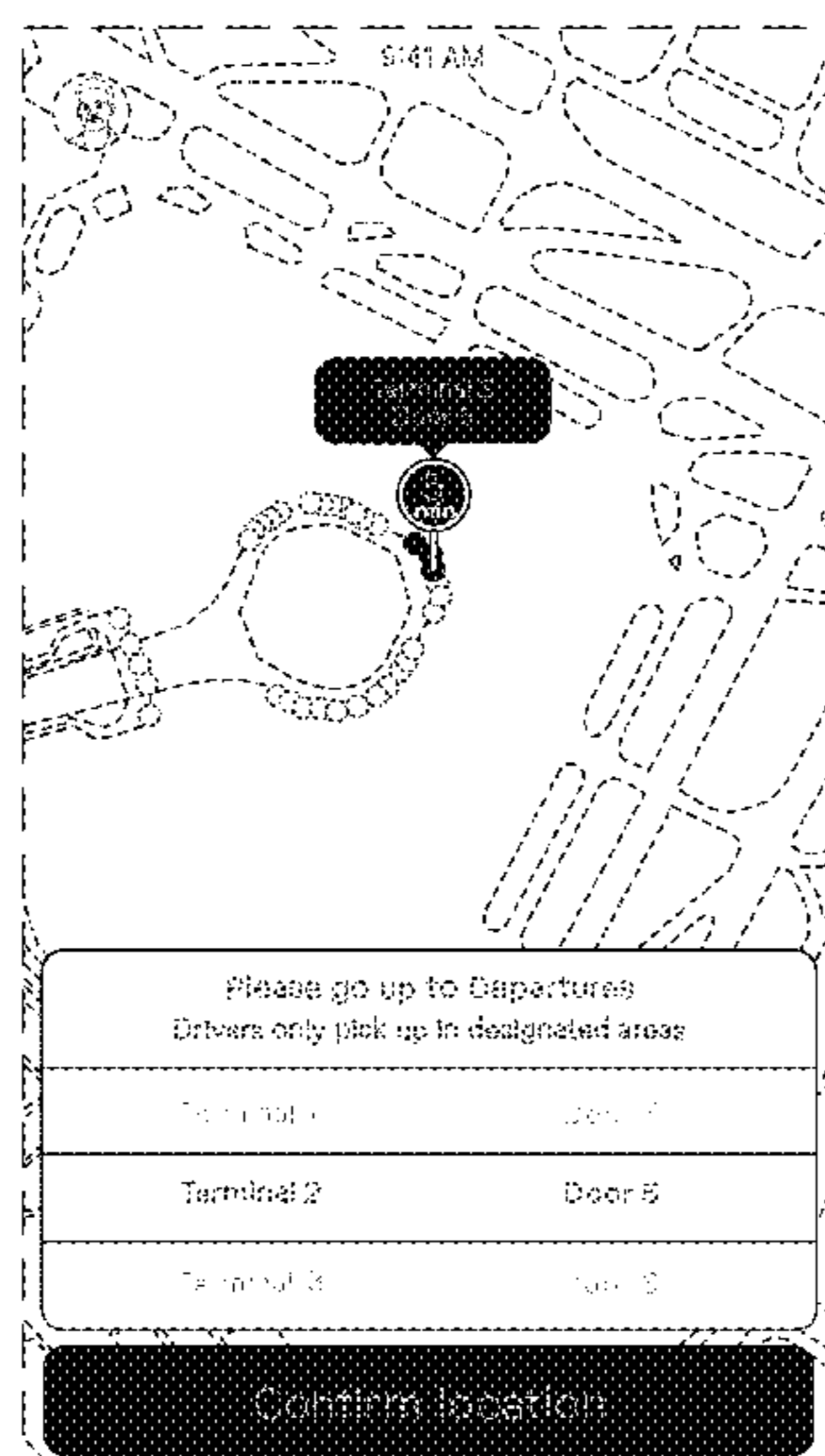
**DESCRIPTION**

FIG. 1 is a front view of a display screen or portion thereof with animated graphical user interface showing a first image in a sequence showing our new design;  
FIG. 2 is a second image in the sequence thereof;  
FIG. 3 is a third image in the sequence thereof;  
FIG. 4 is a fourth image in the sequence thereof;  
FIG. 5 is a fifth image in the sequence thereof;  
FIG. 6 is a front view of a display screen or portion thereof with animated graphical user interface showing a first image in a sequence showing our new design according to a second embodiment;  
FIG. 7 is a second image thereof; and,  
FIG. 8 is a third image thereof.

The outermost broken line showing of a display screen or portion thereof and the other broken lines showing elements of the graphical user interface illustrate portions of the article and do not form part of the claimed design.

The appearance of the animated graphical user interface transitions sequentially between FIGS. 1-5 in embodiment 1 and FIGS. 6-8 in embodiment 2. The process or period in which one image transitions to another forms no part of the claimed design.

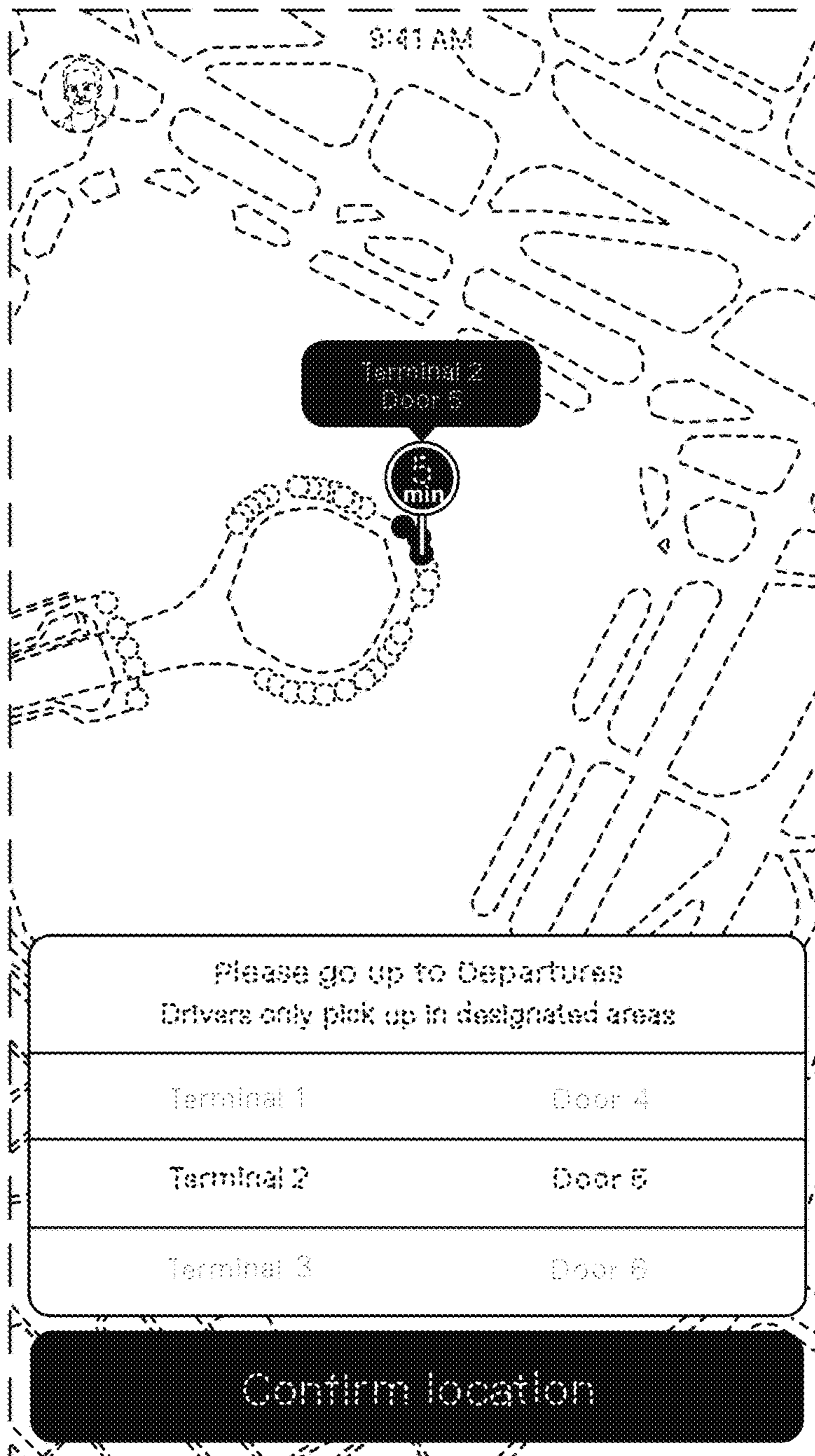

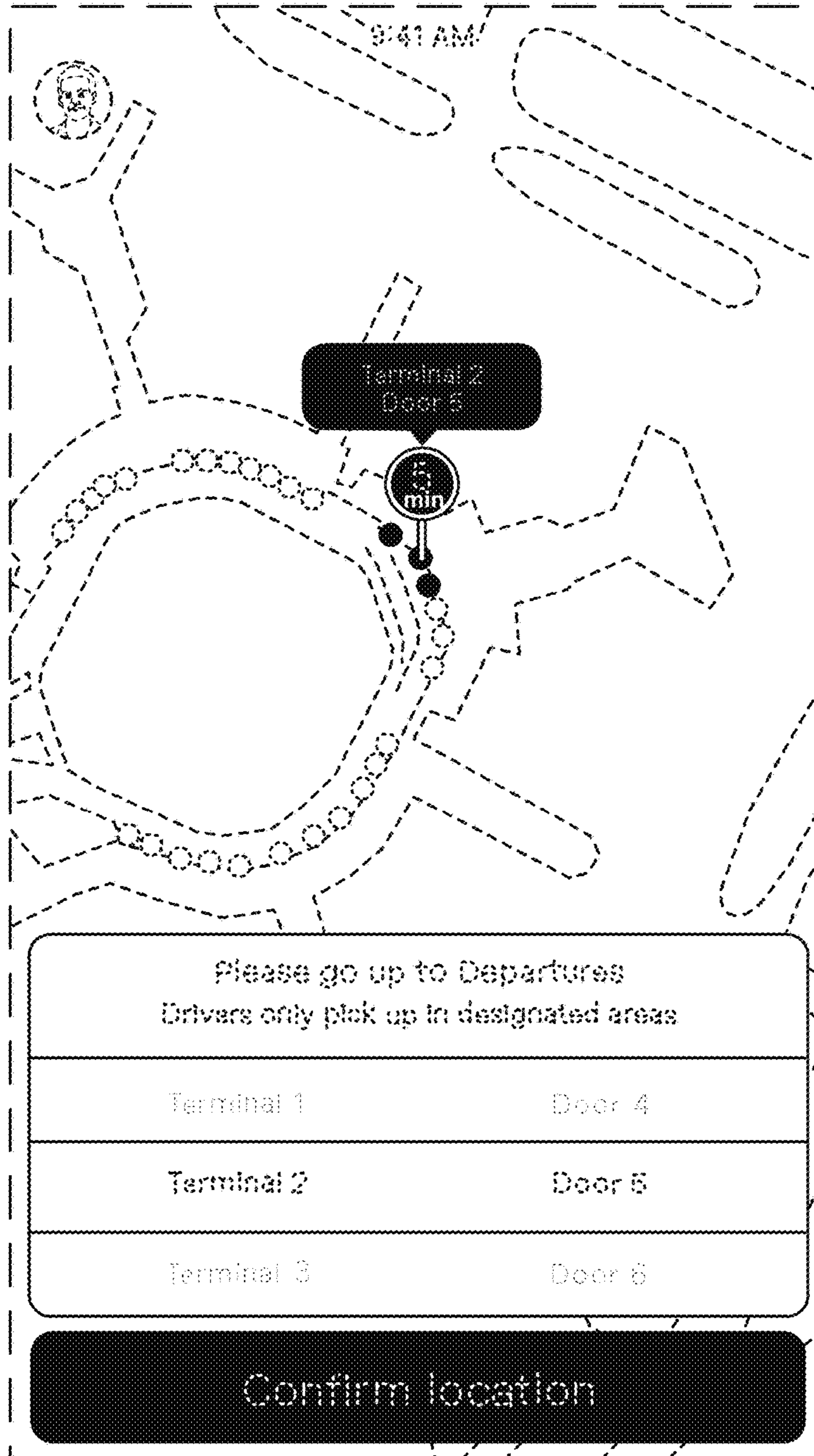

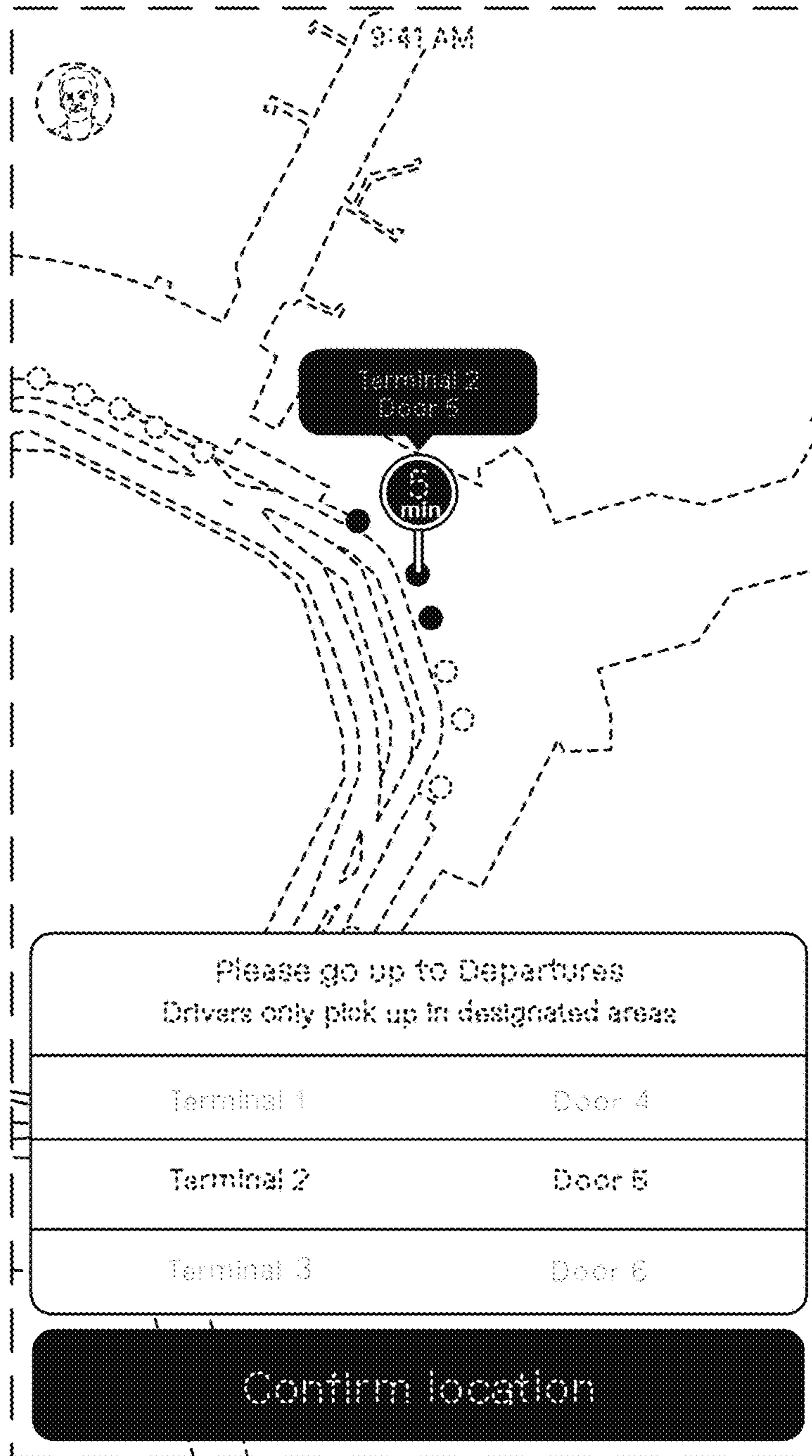

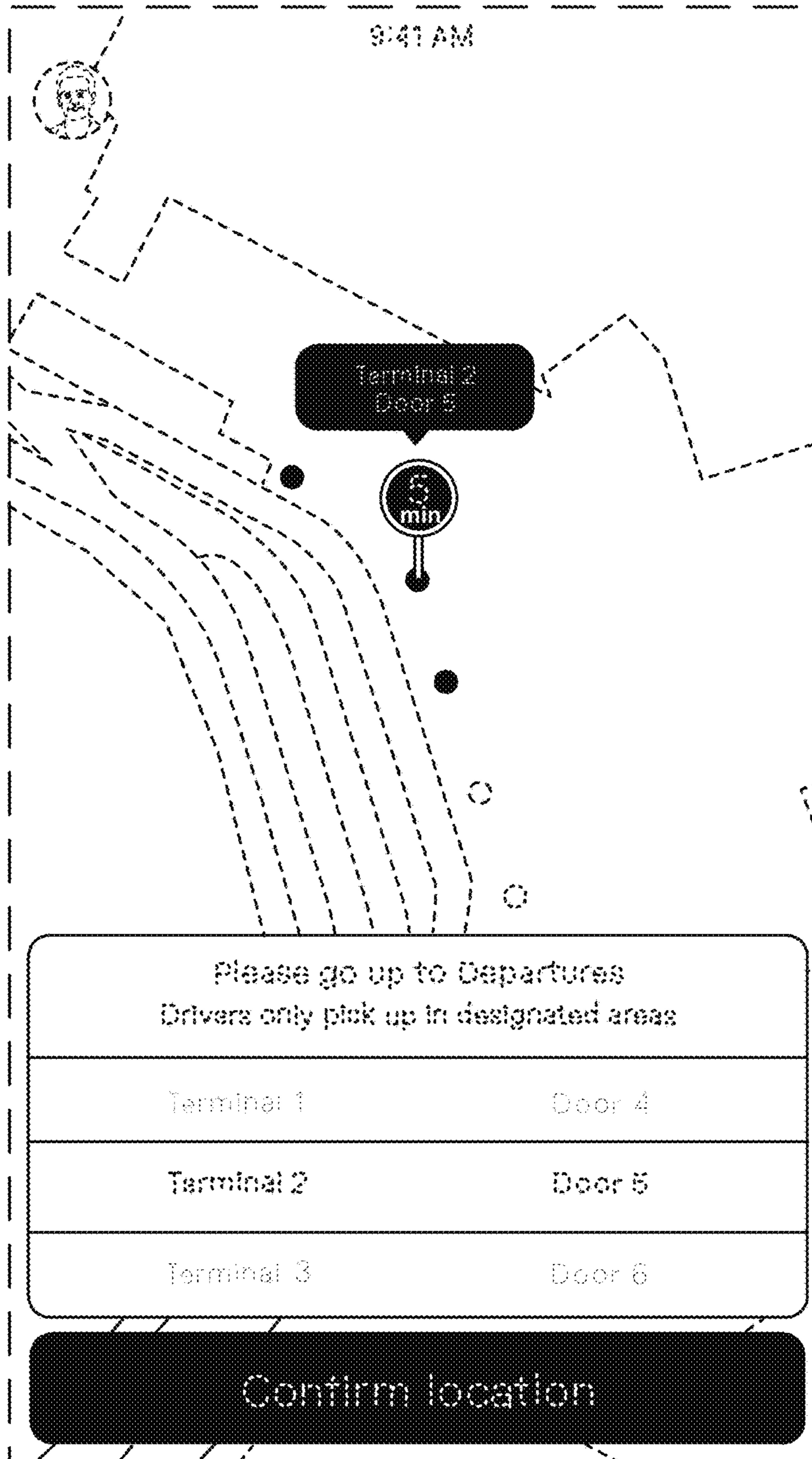

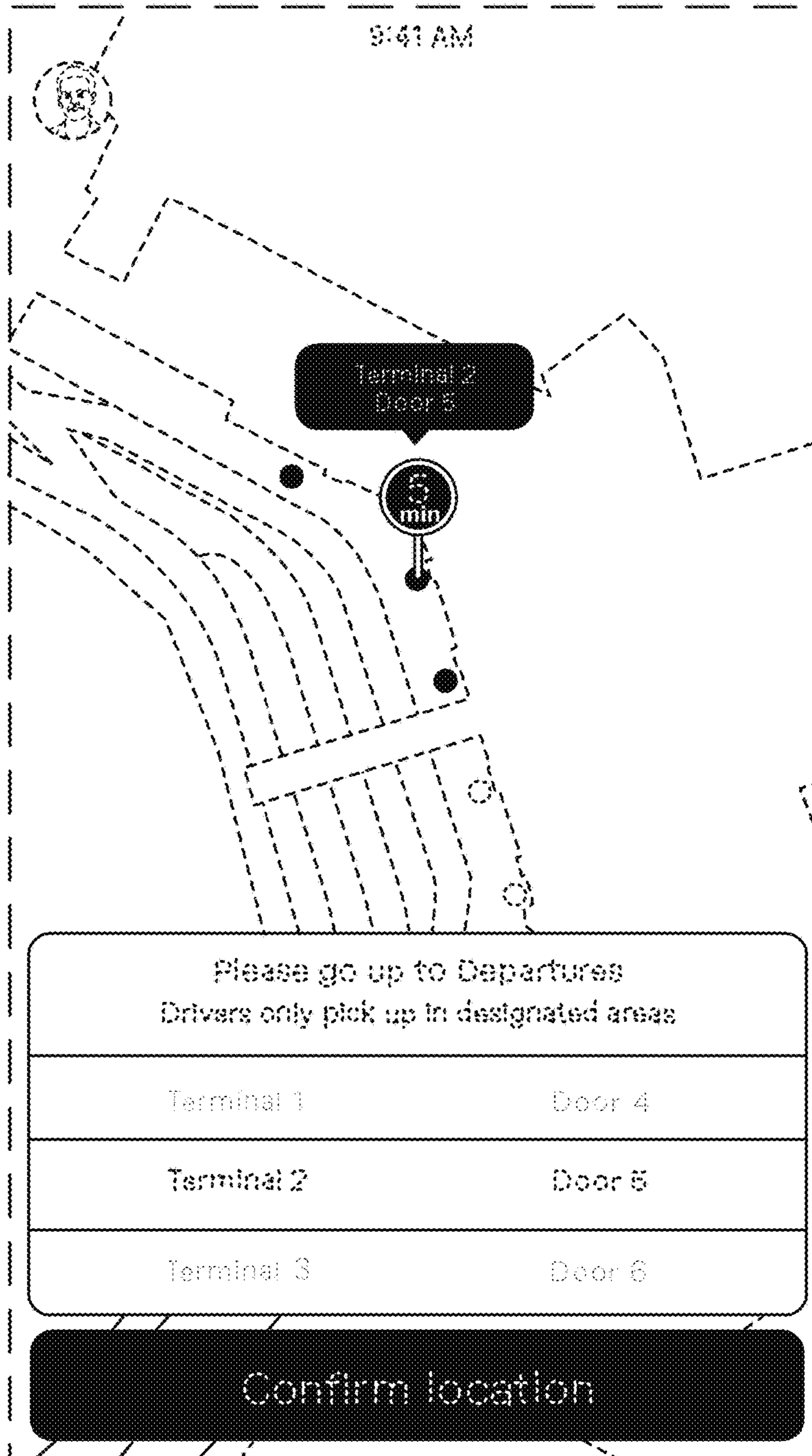

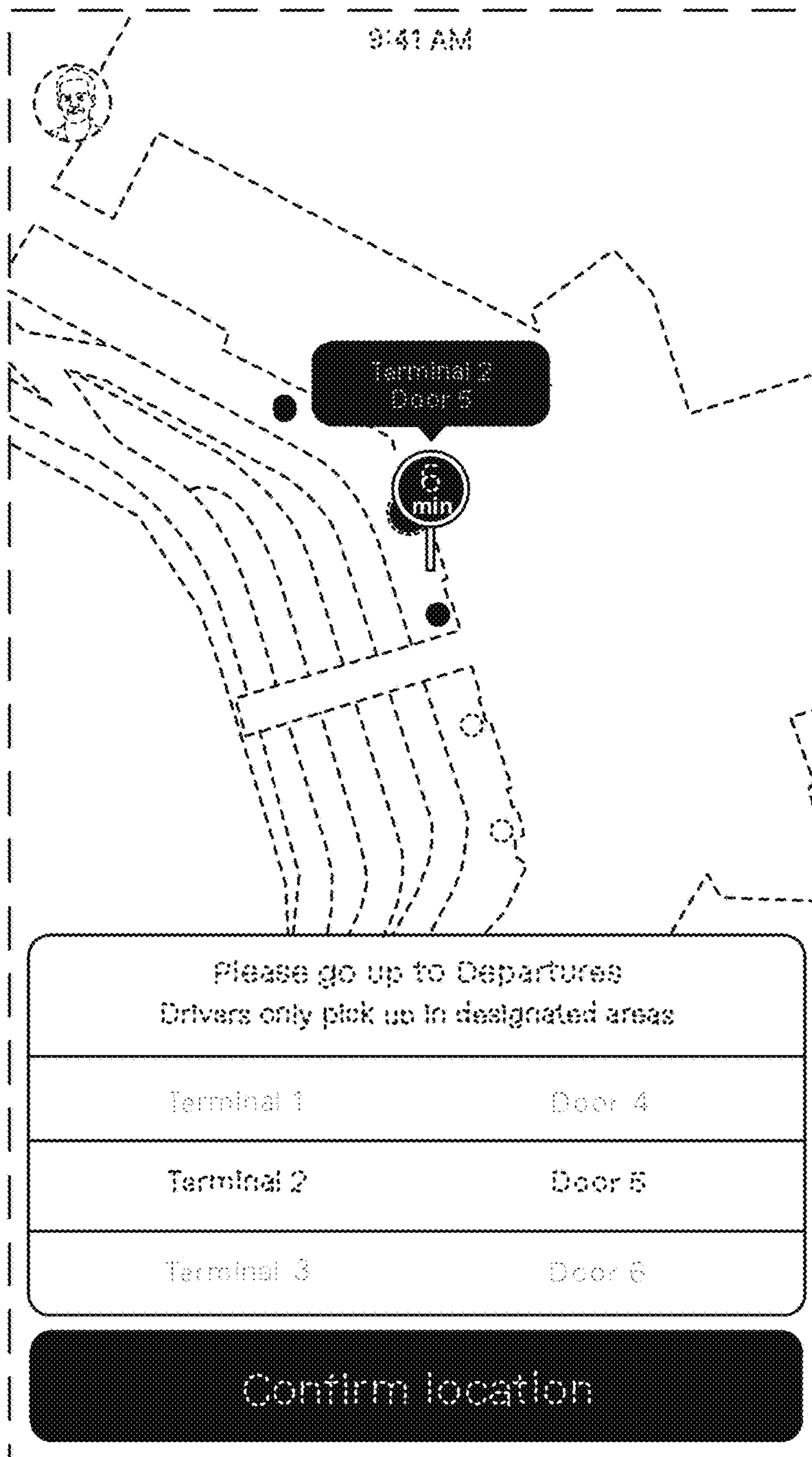

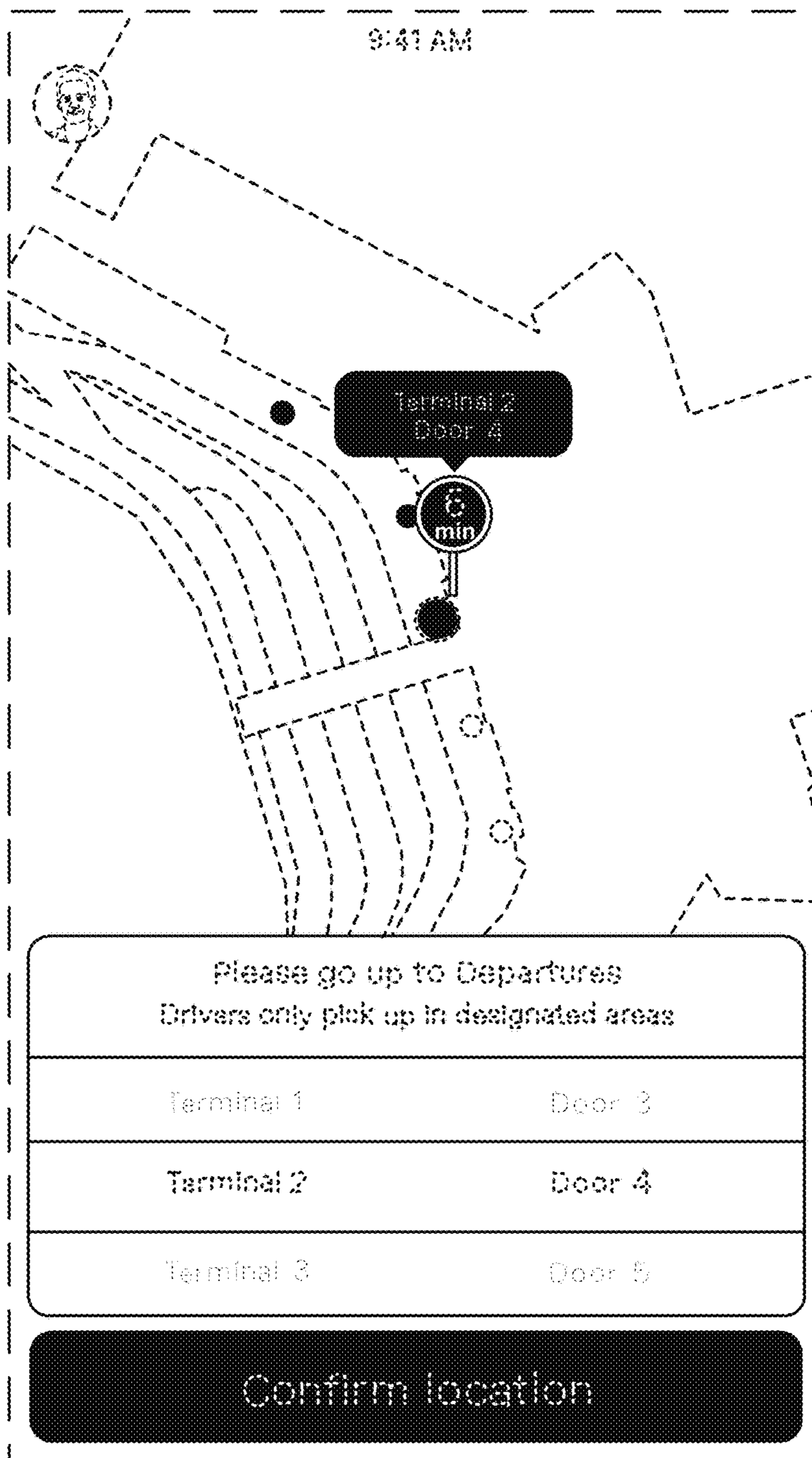

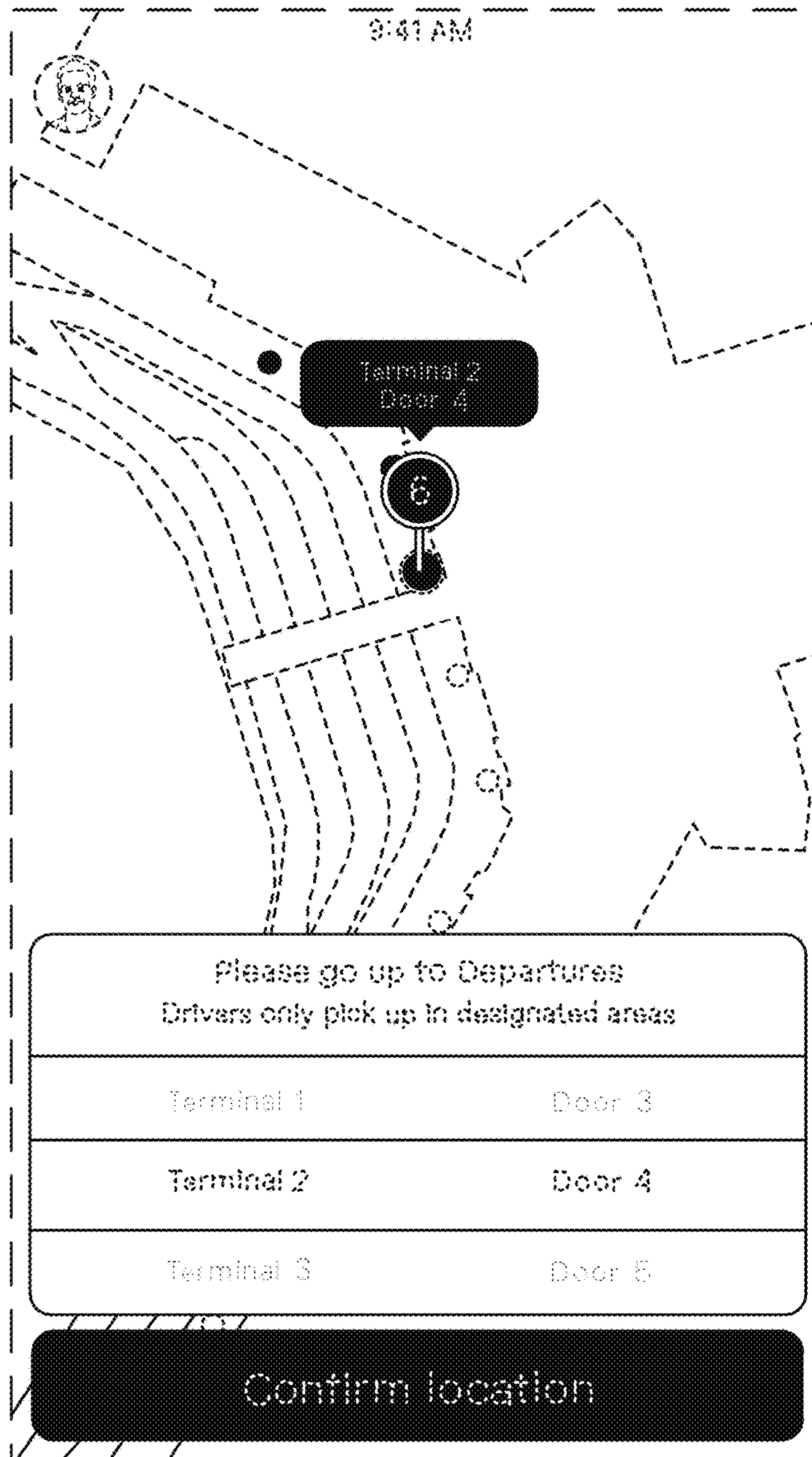
