DESCRIPTION

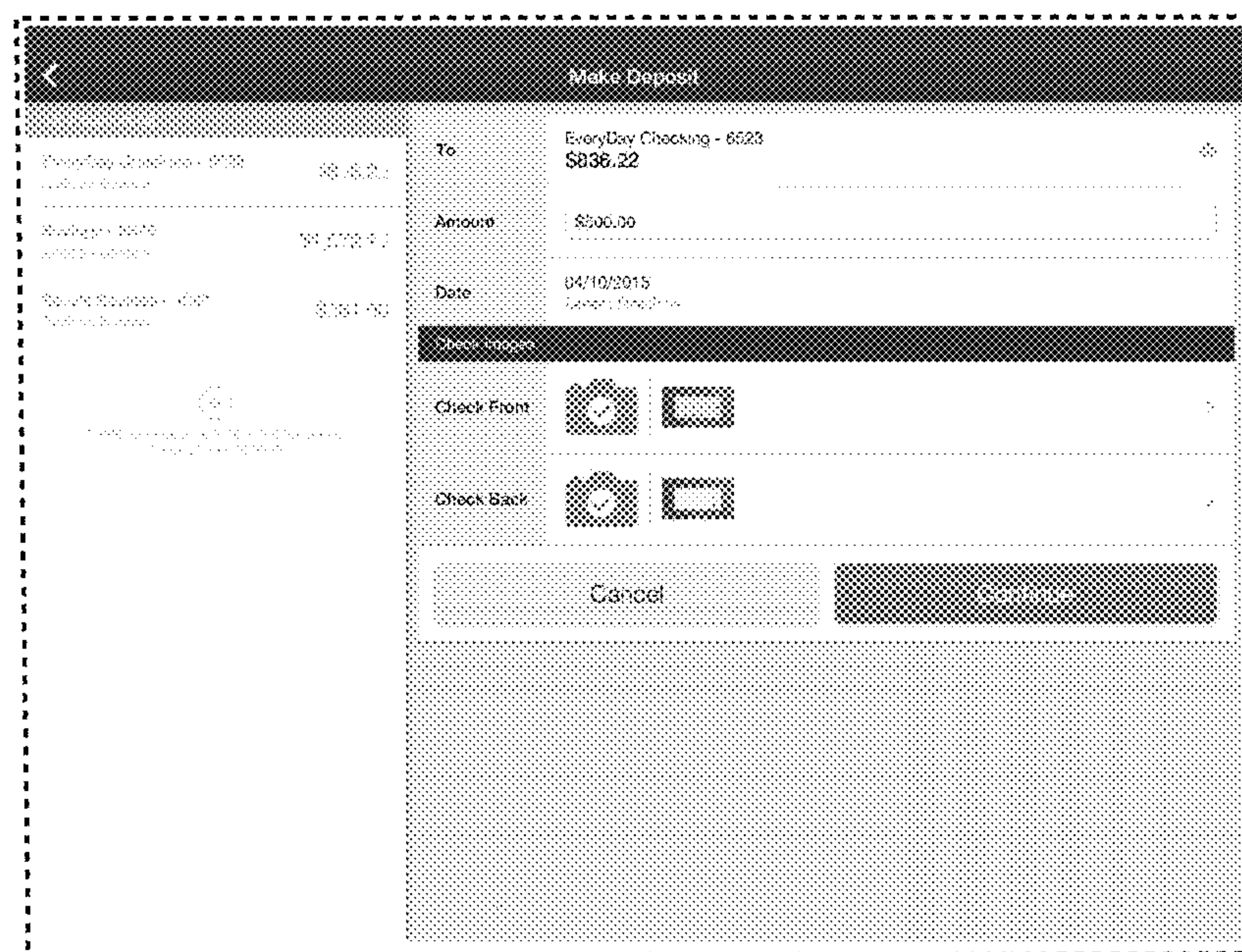
The contents of U.S. application Ser. No. 29/450,071, filed Mar. 15, 2013, are incorporated herein in their entirety.

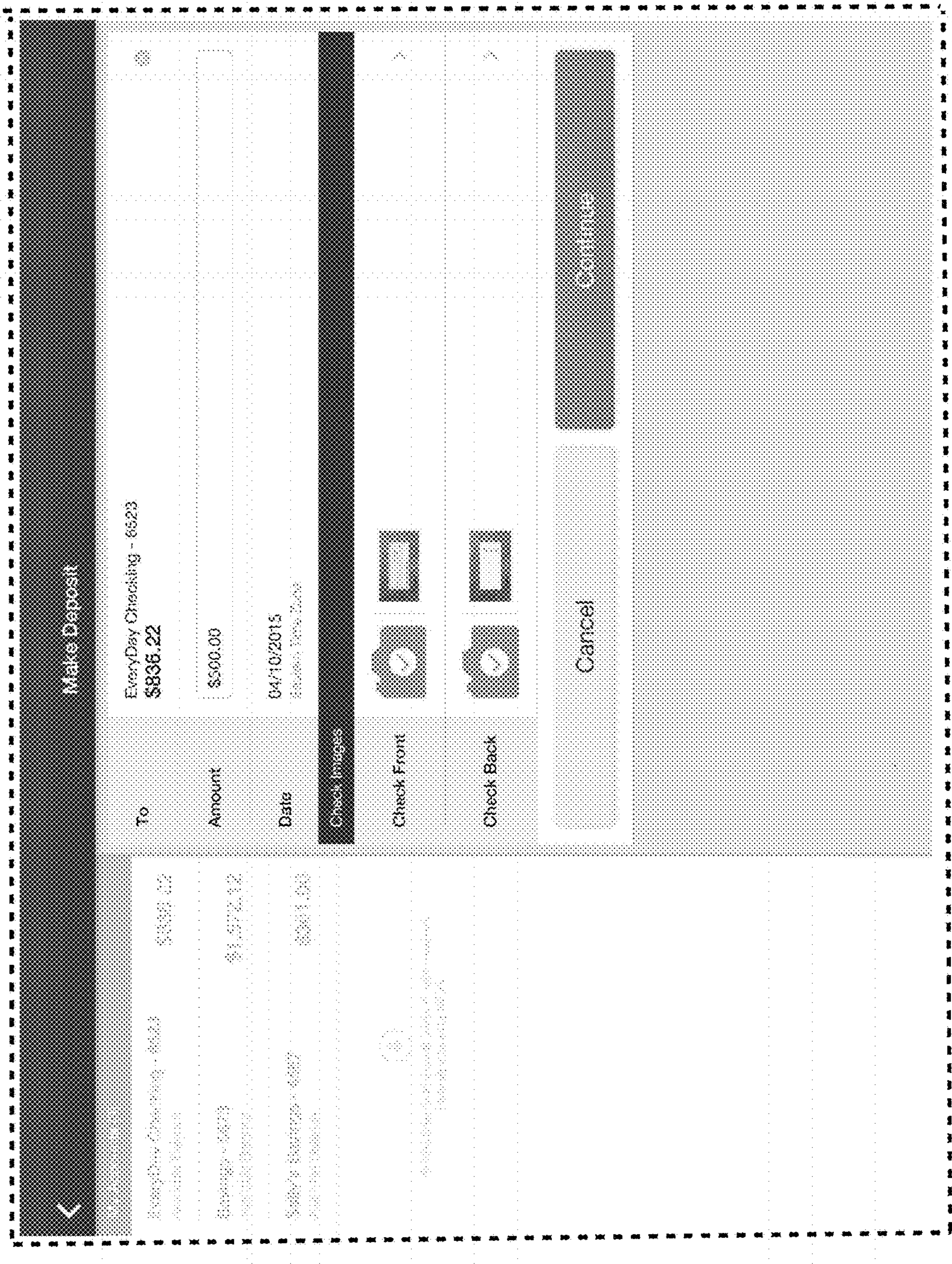

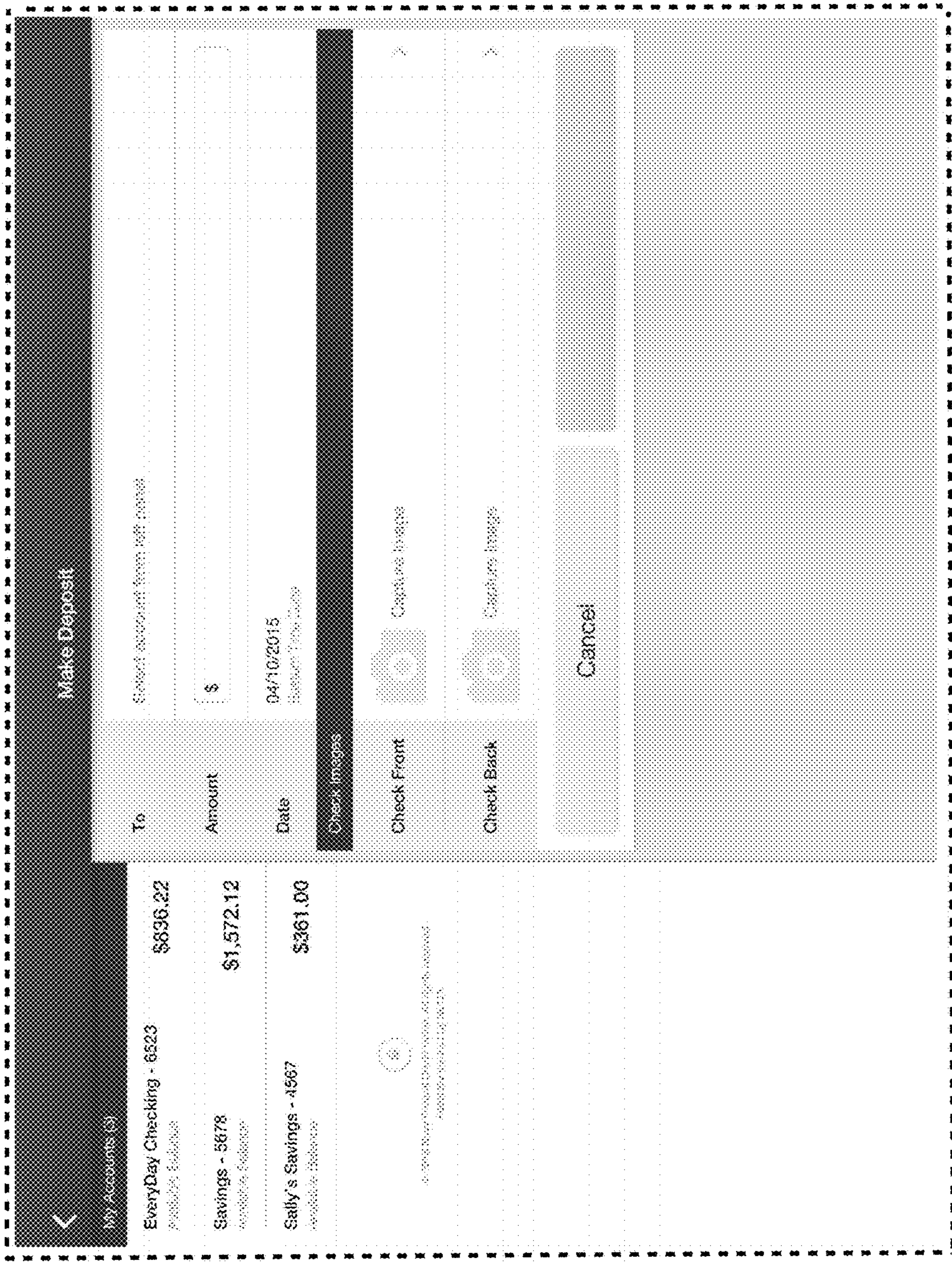
