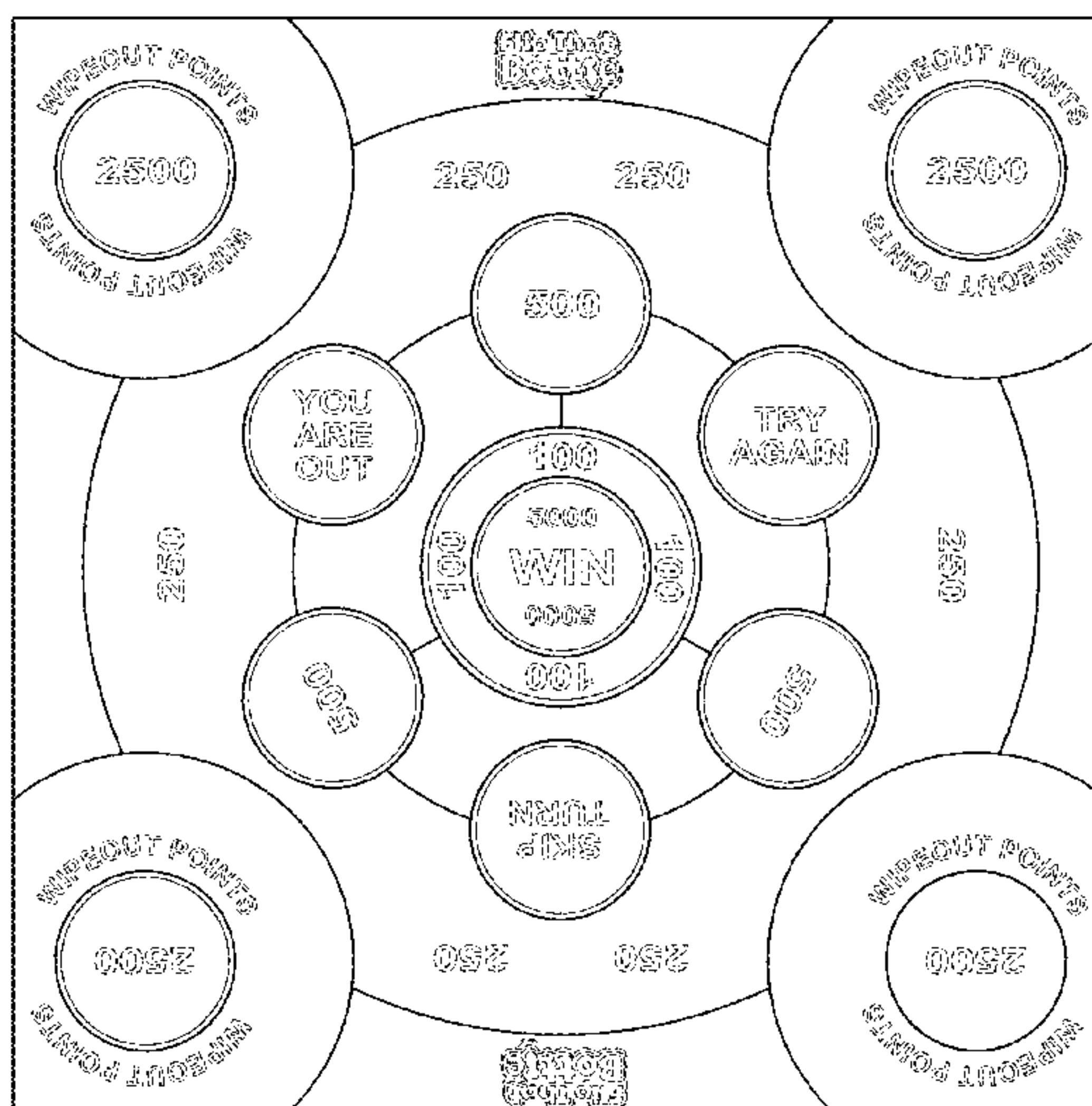
The ornamental design for a board game, as shown and described.
