We claim the ornamental design for a golf club head, as
shown and described.

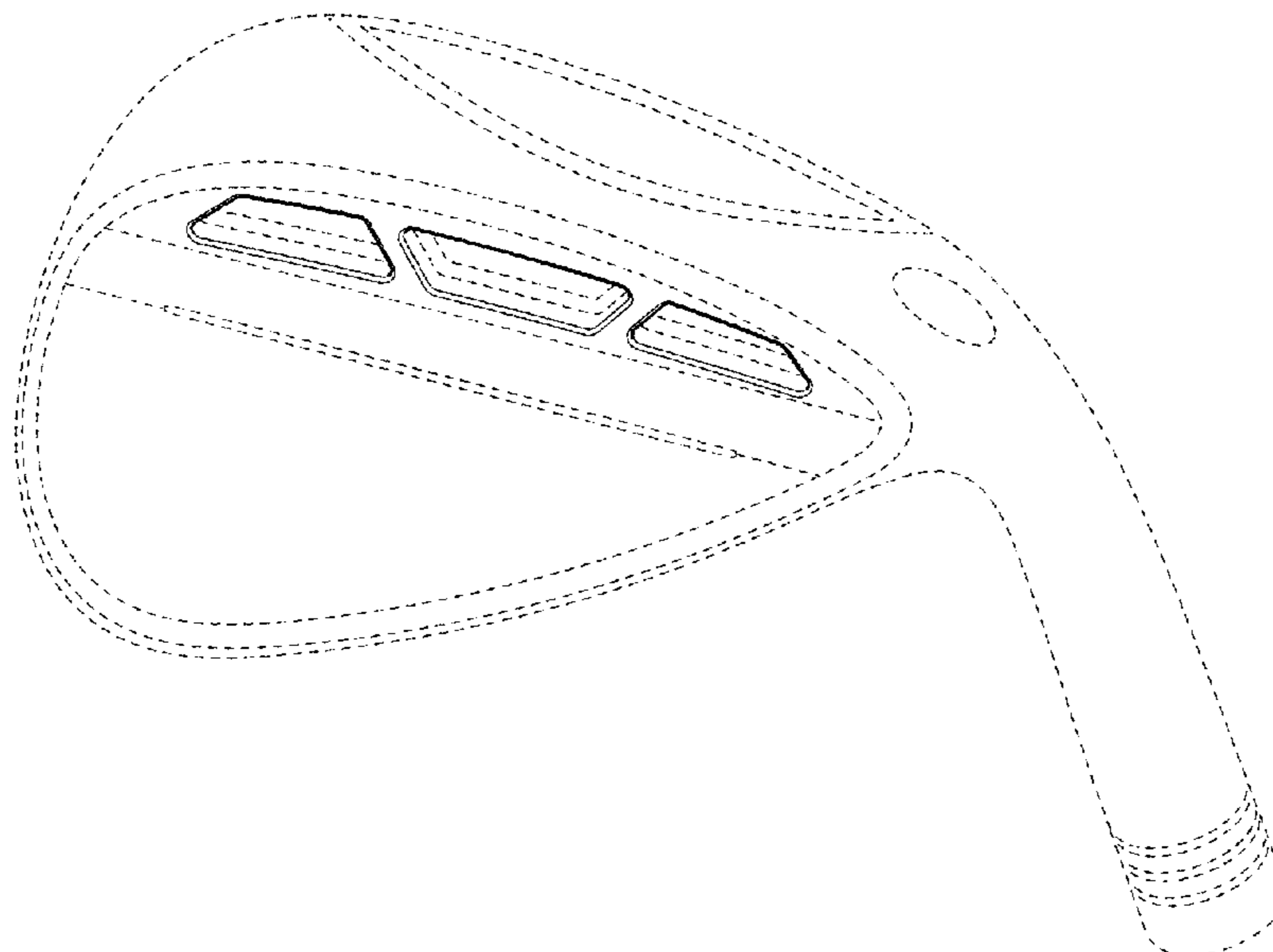
DESCRIPTION

FIG. 1 is a perspective view of a golf club head, as viewed
from the bottom, rear and one sides thereof, according to one
embodiment;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a toe side elevation view thereof;
FIG. 5 is a heel side elevation view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

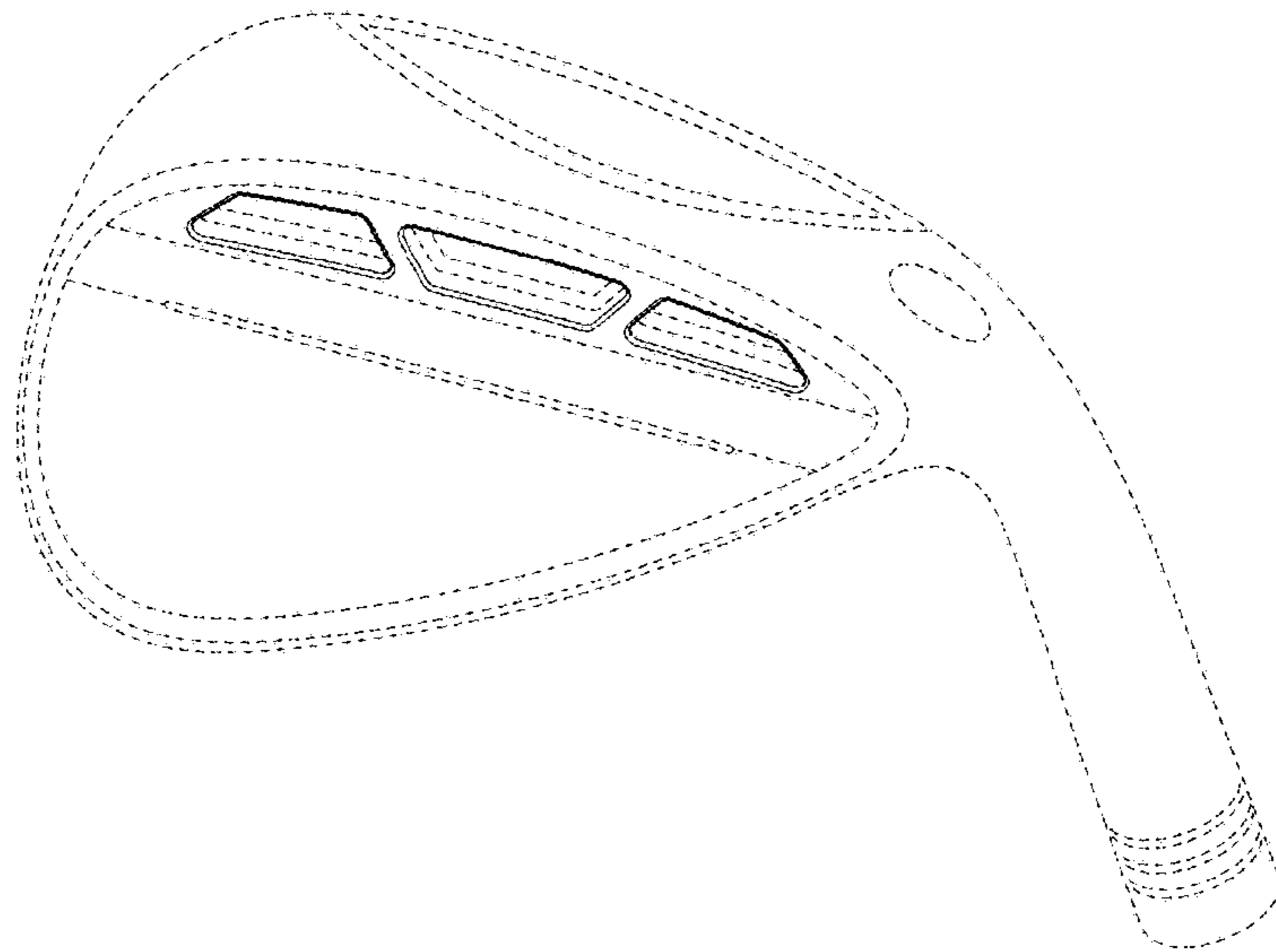

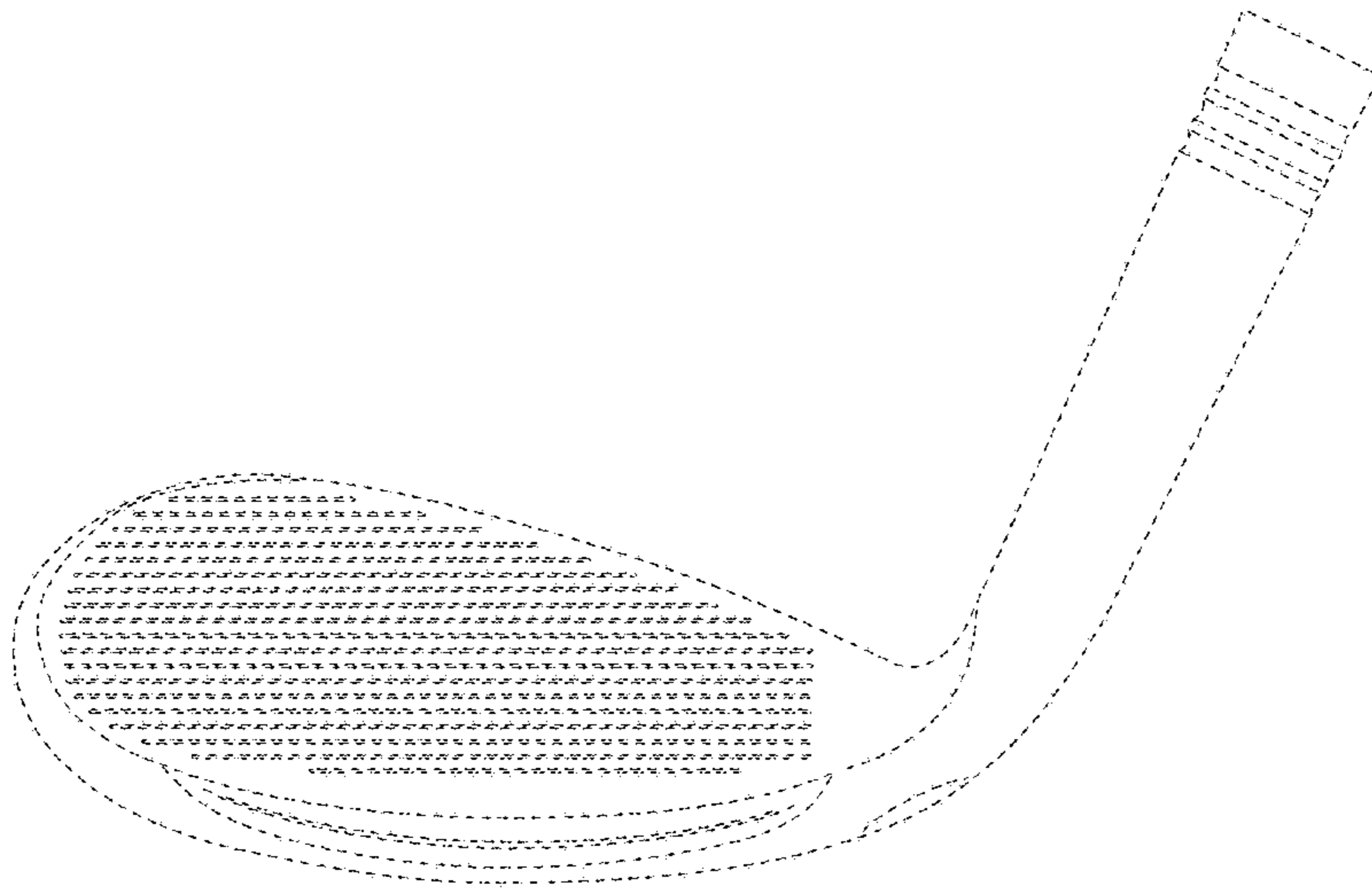

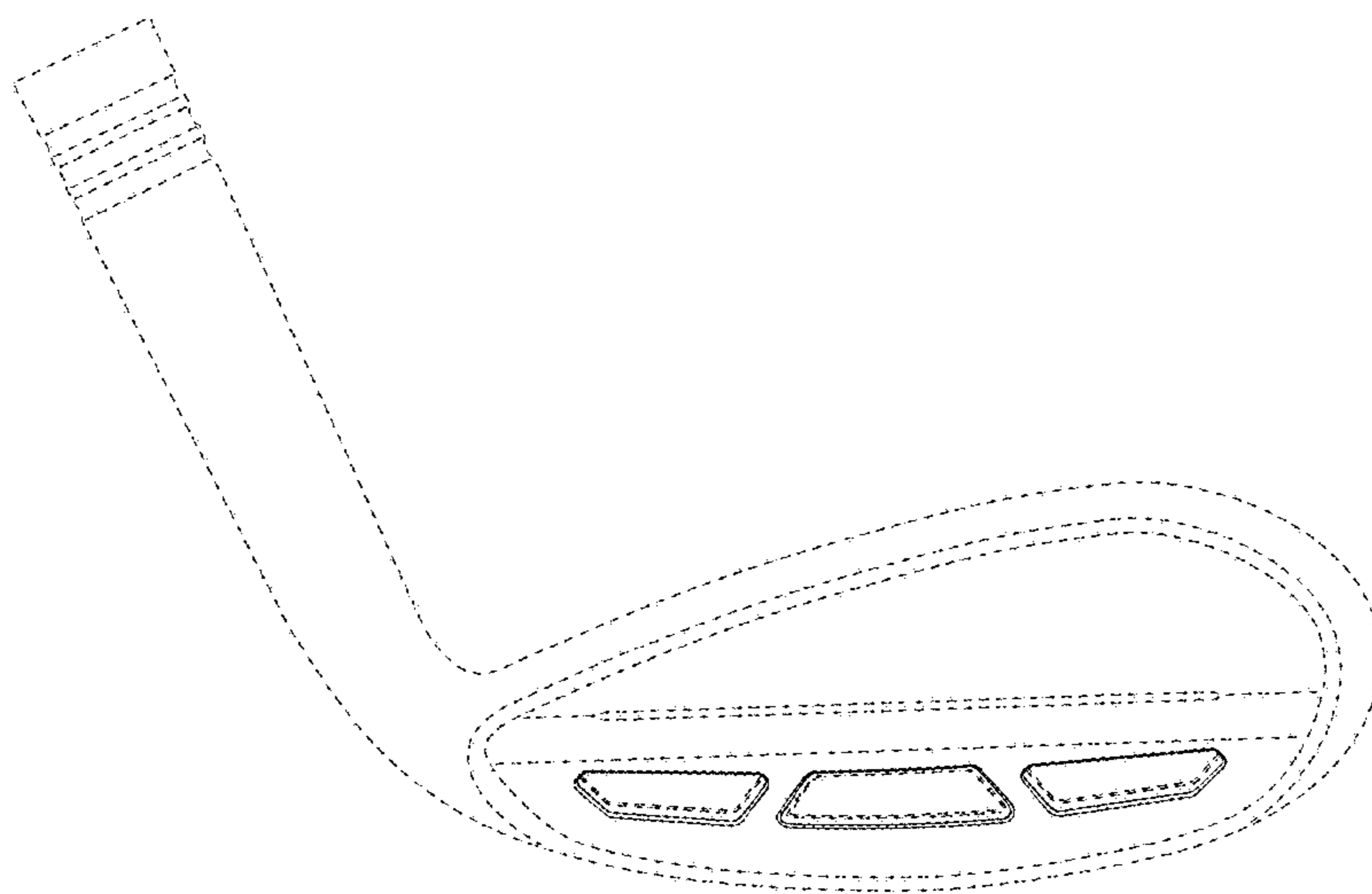

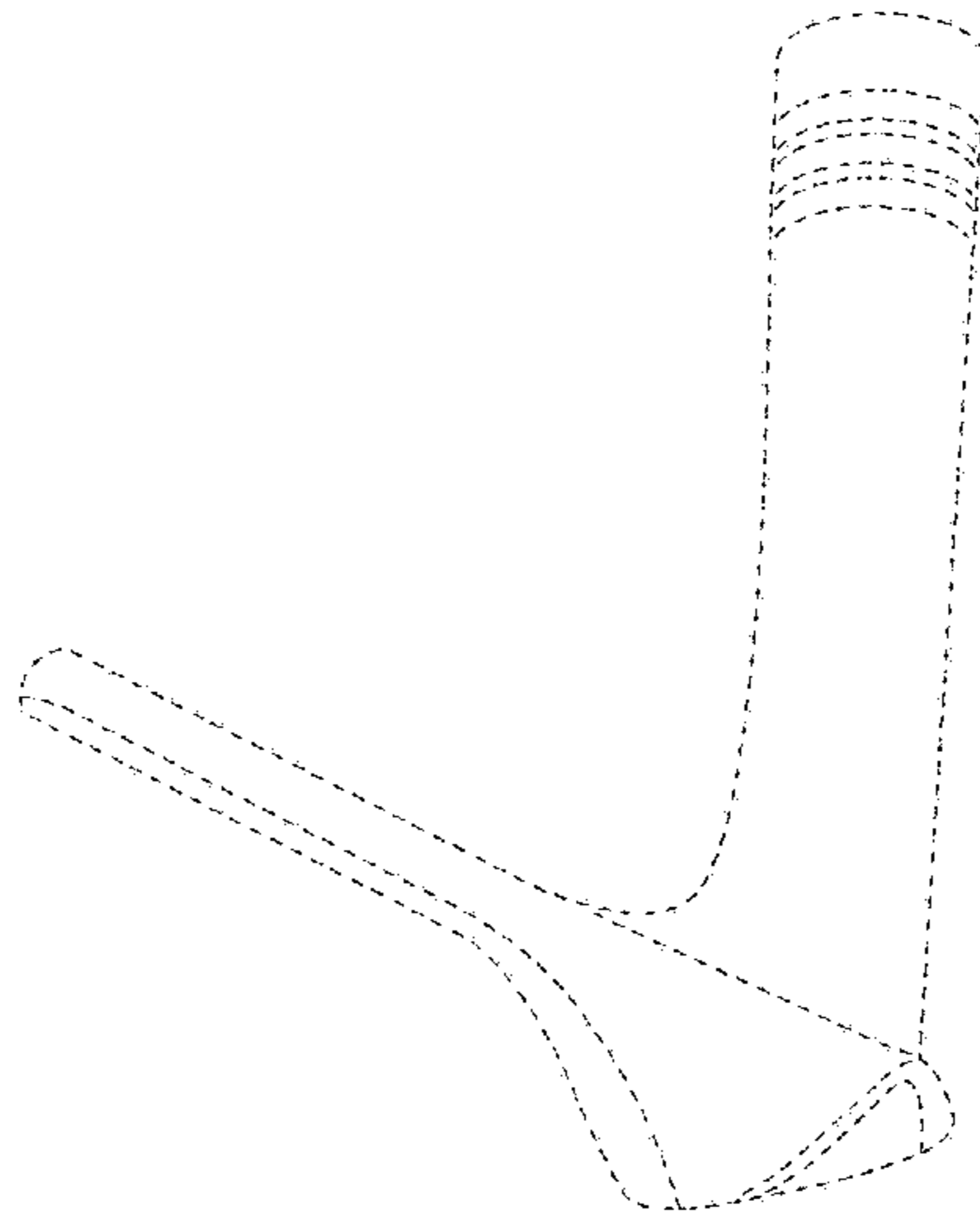

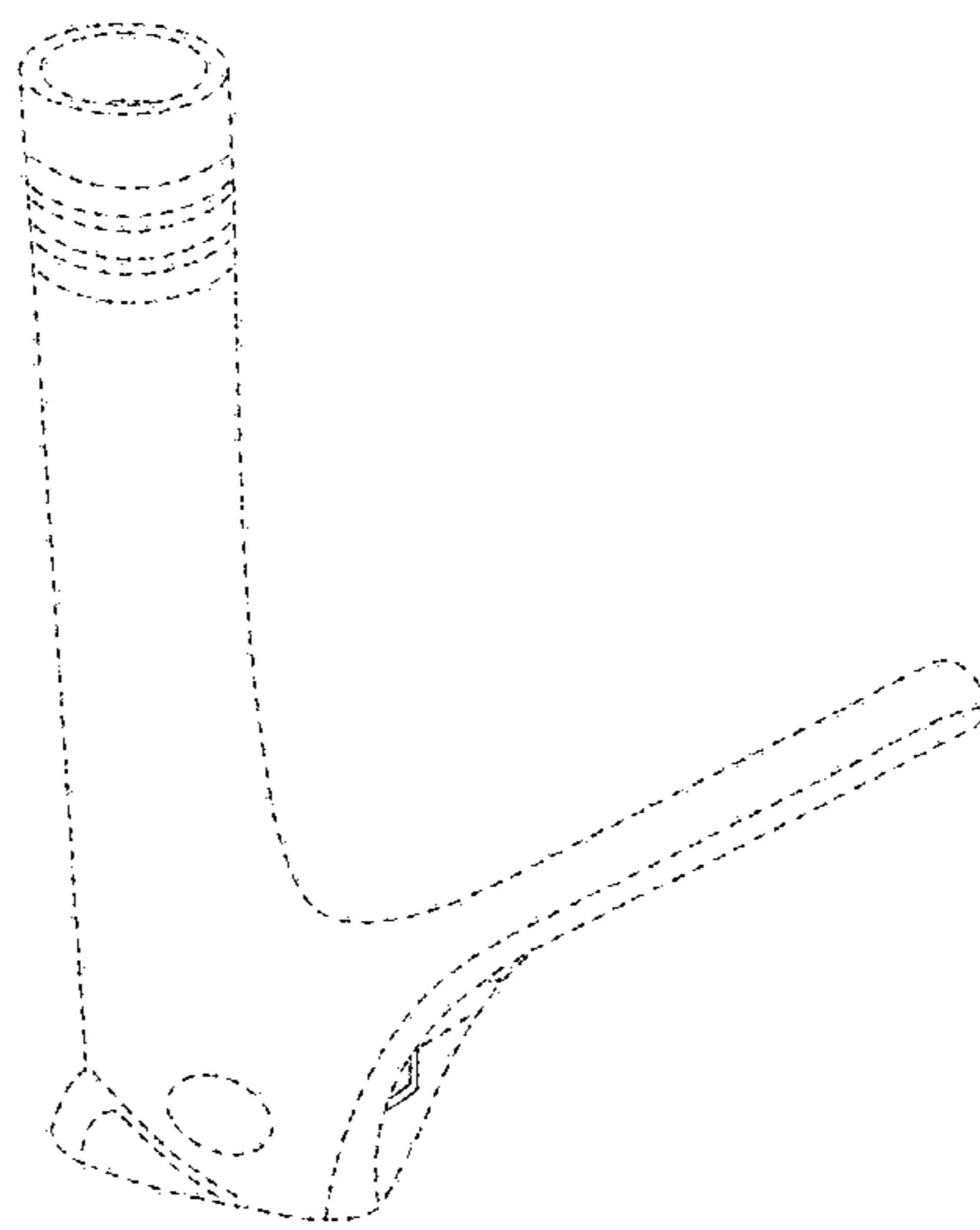

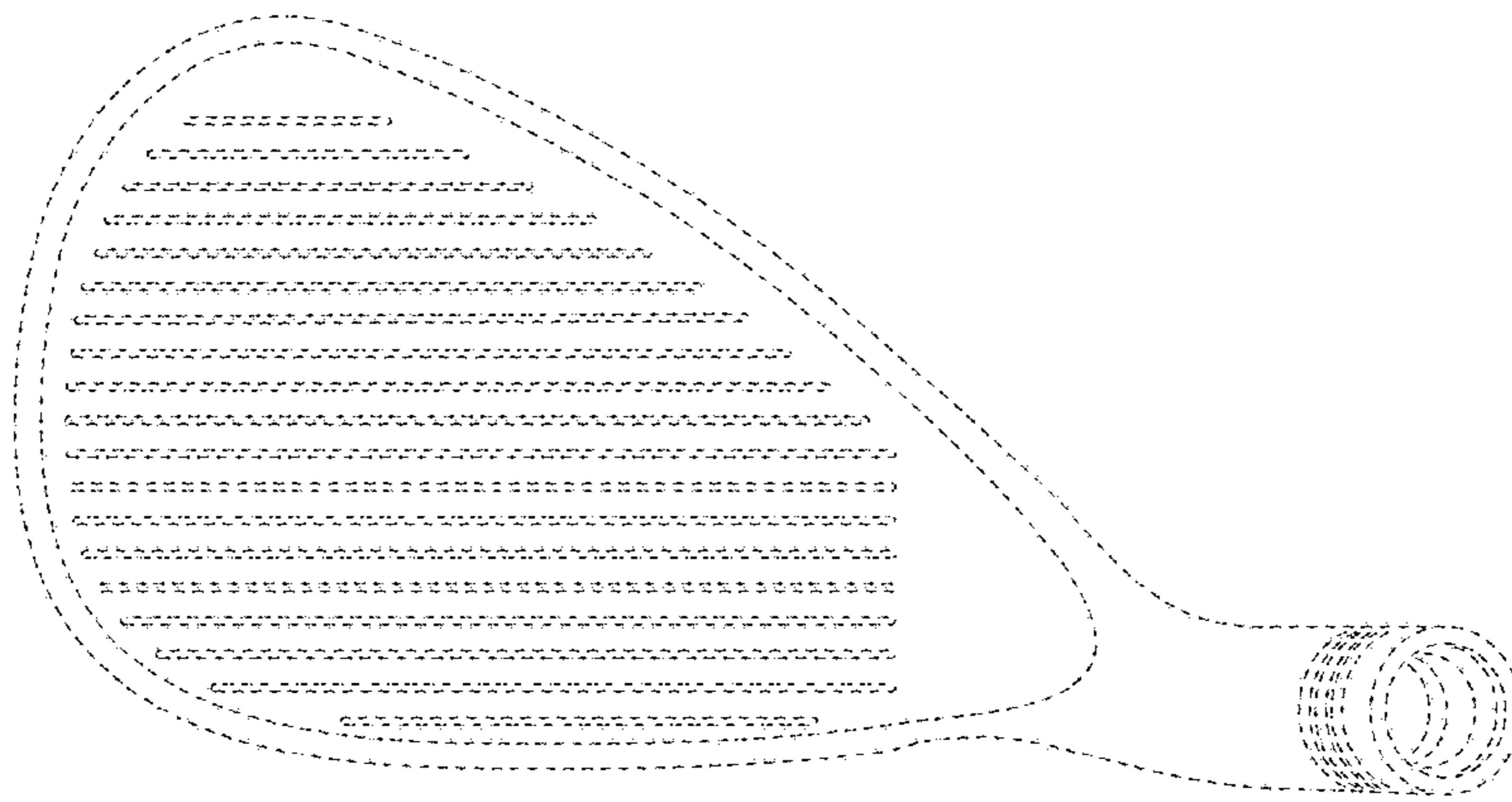

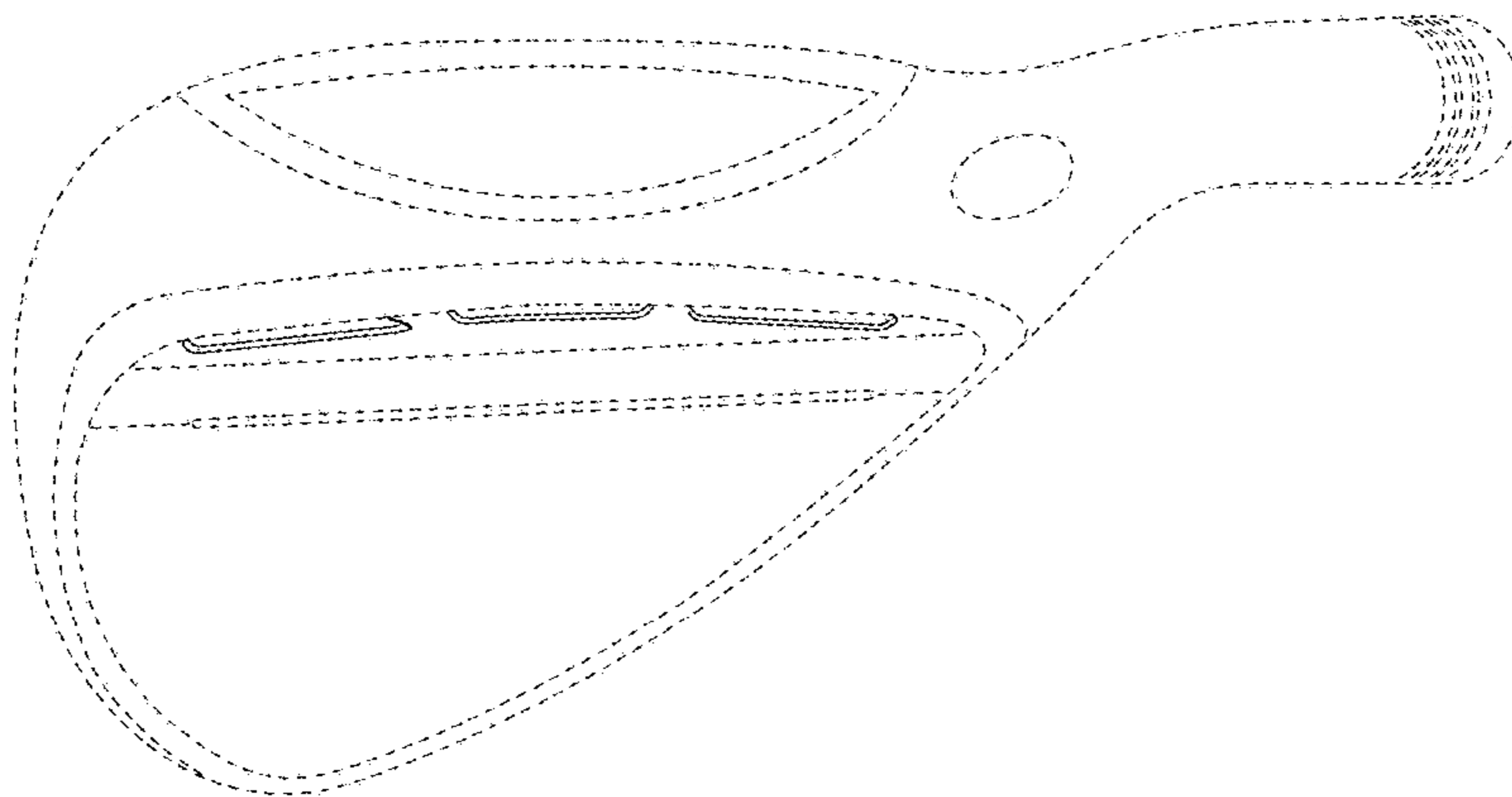
