**DESCRIPTION**

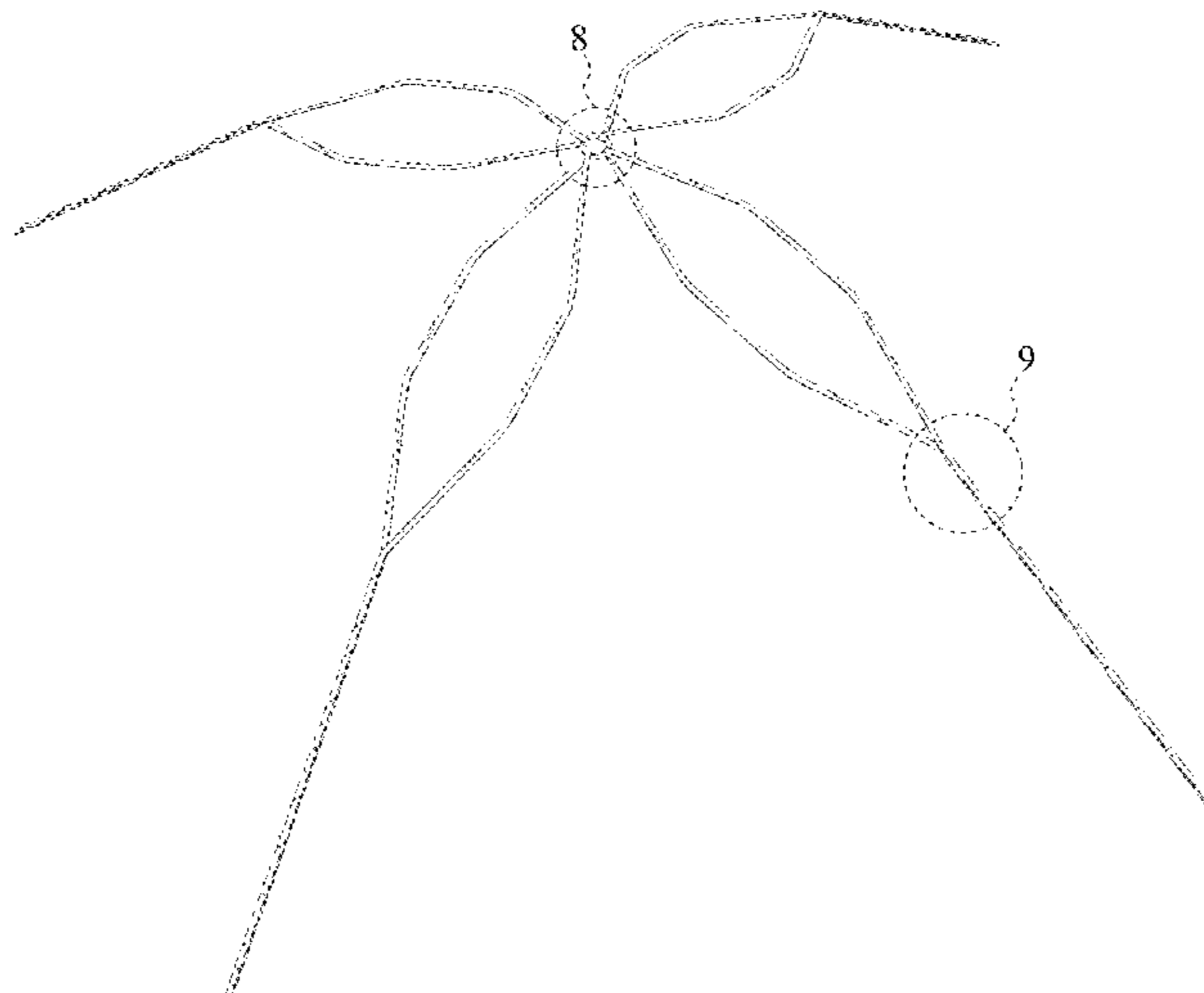
FIG. 1 is a perspective view of a tie-down strap;

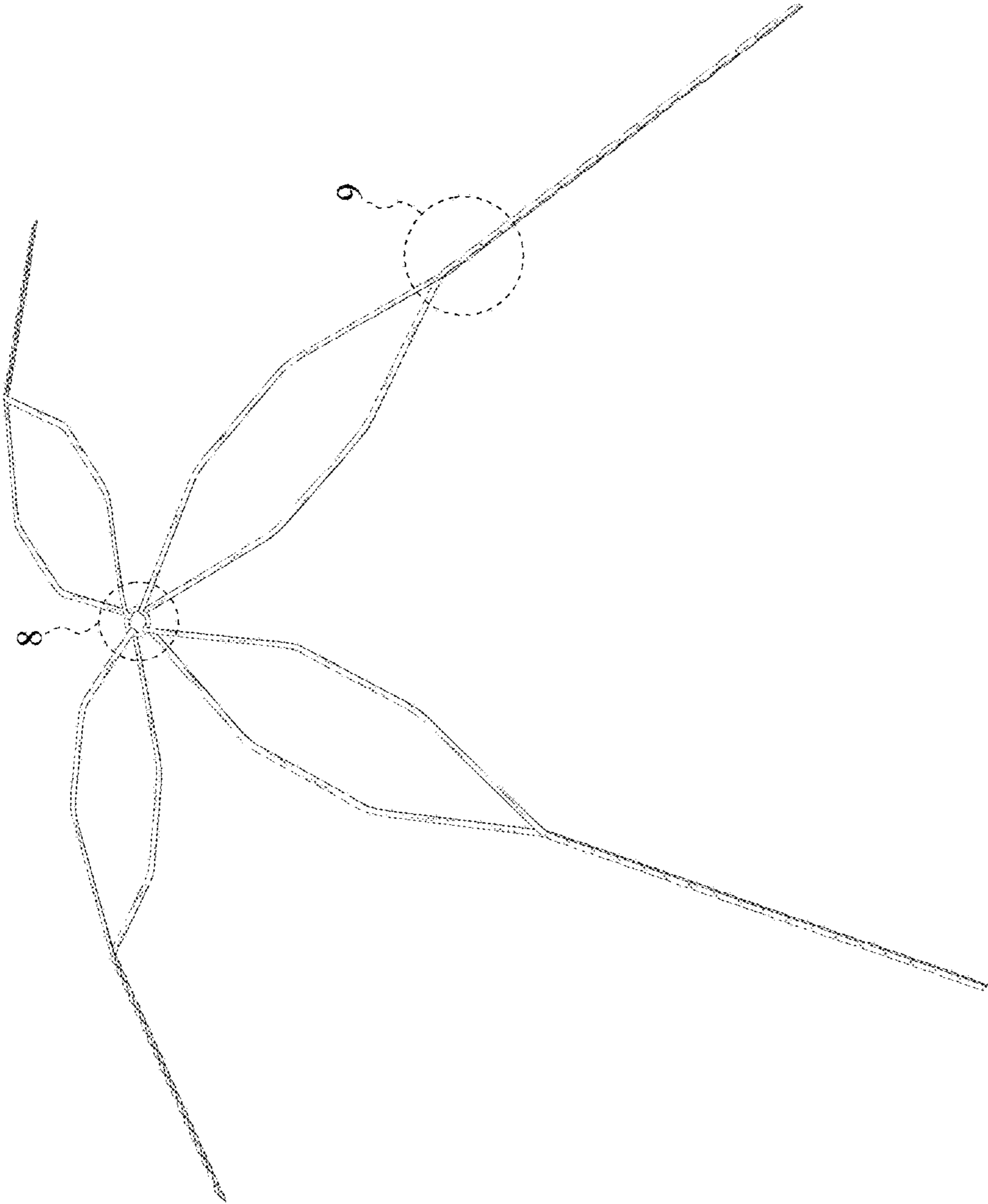

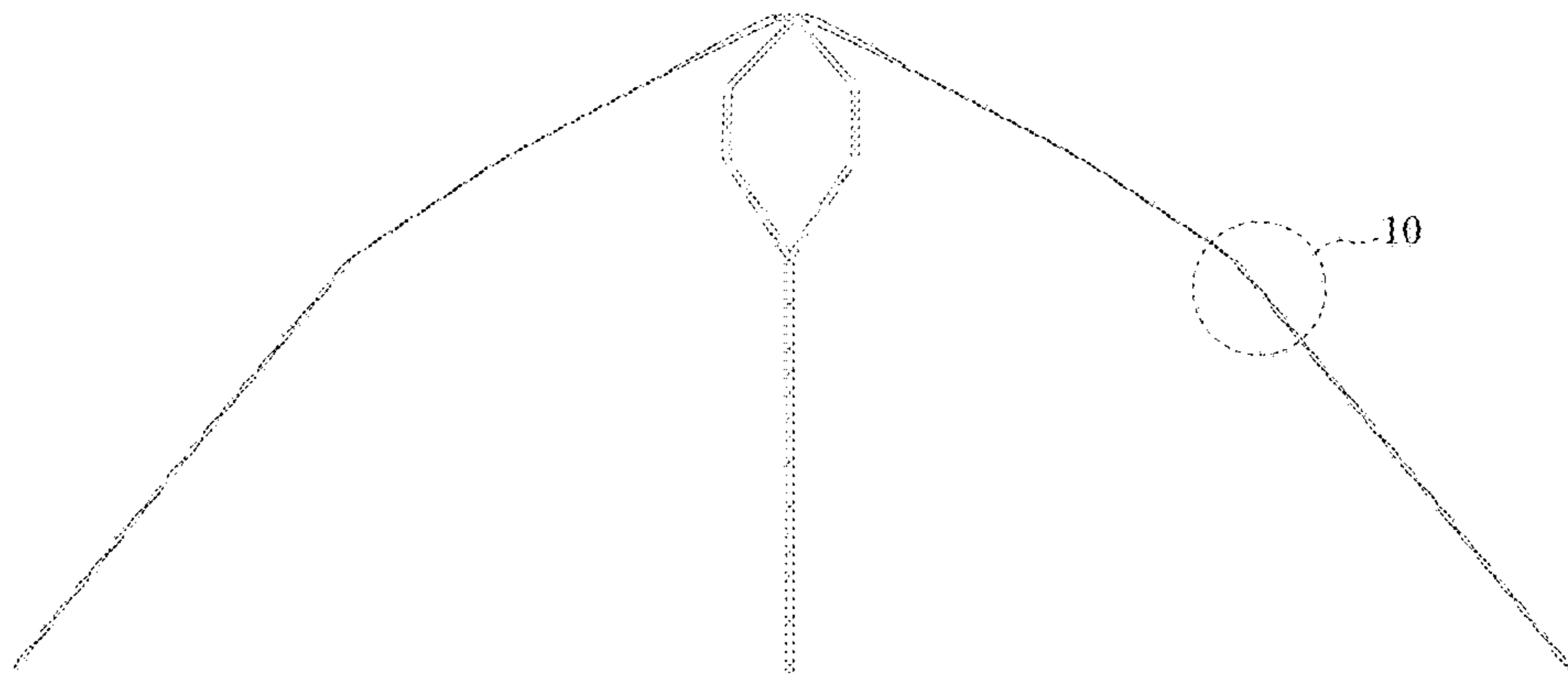

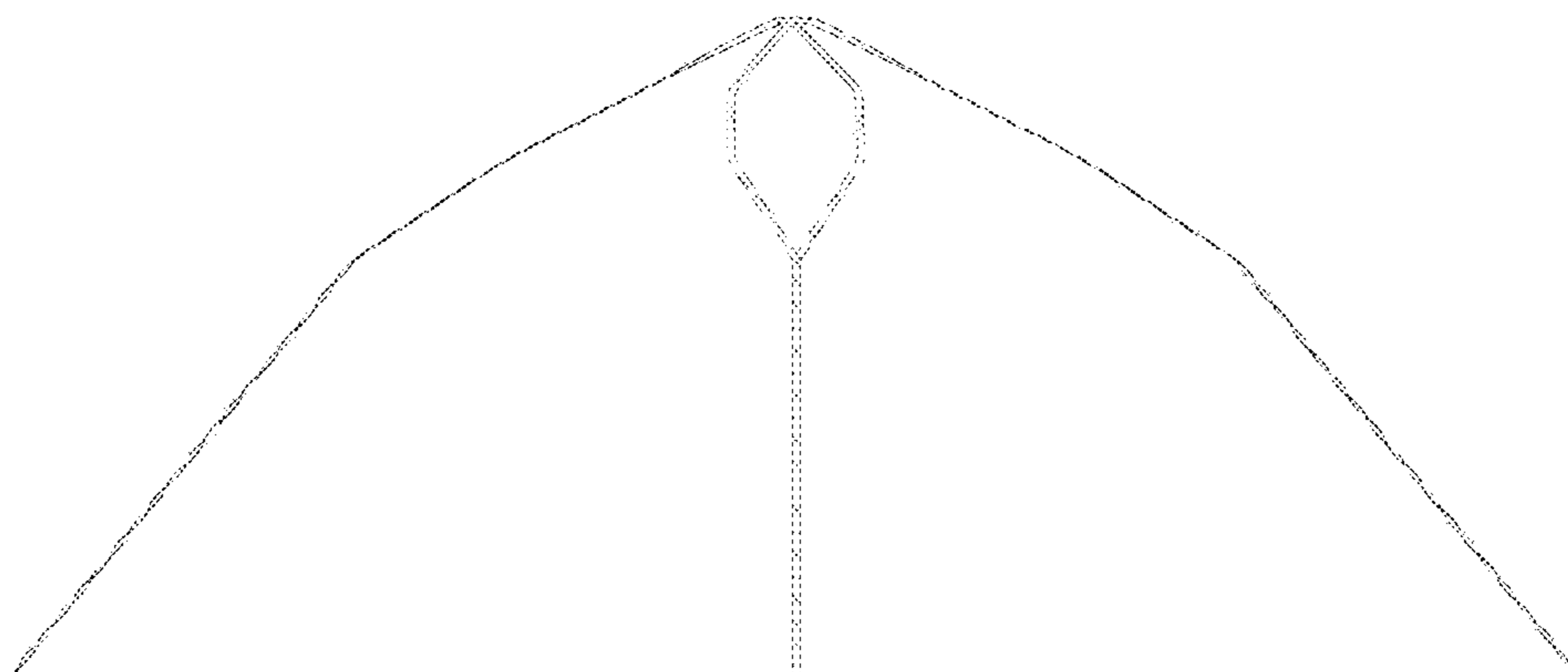

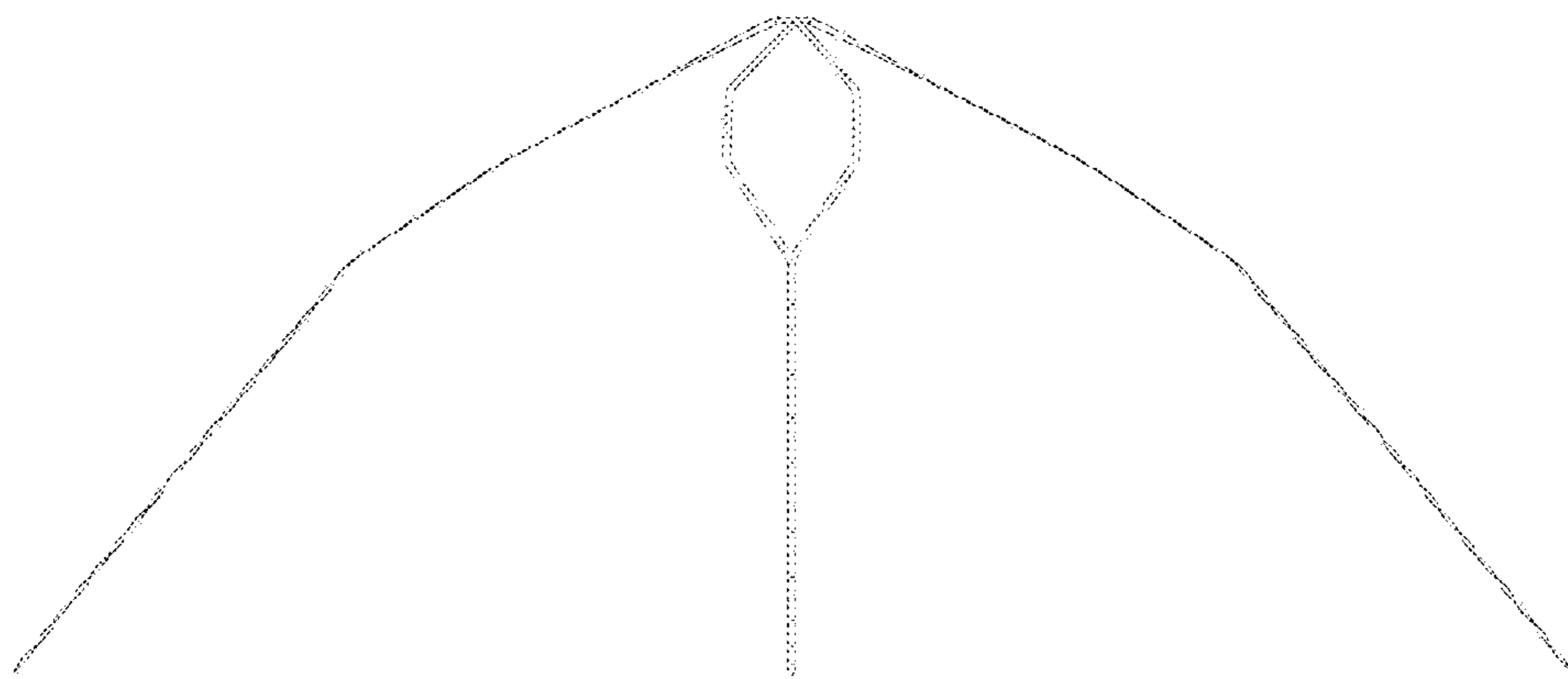

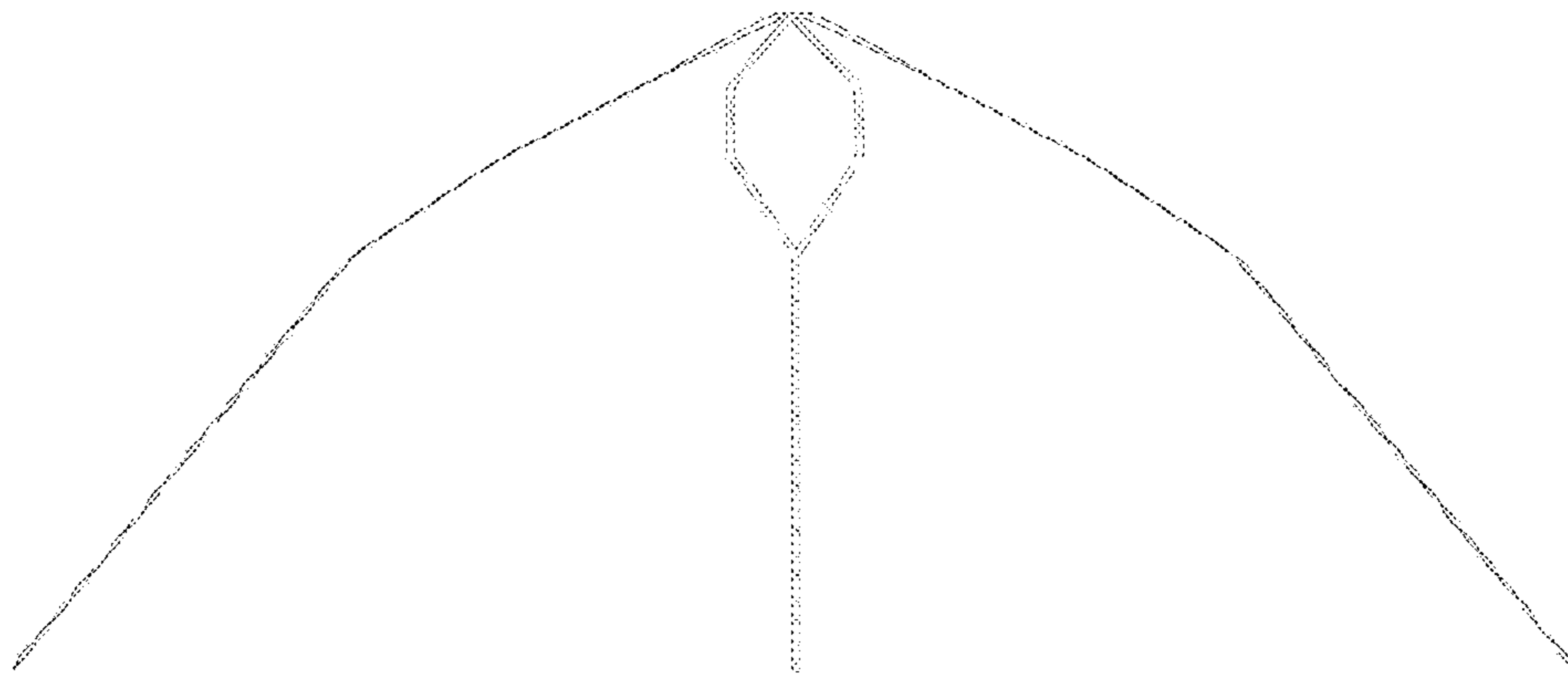

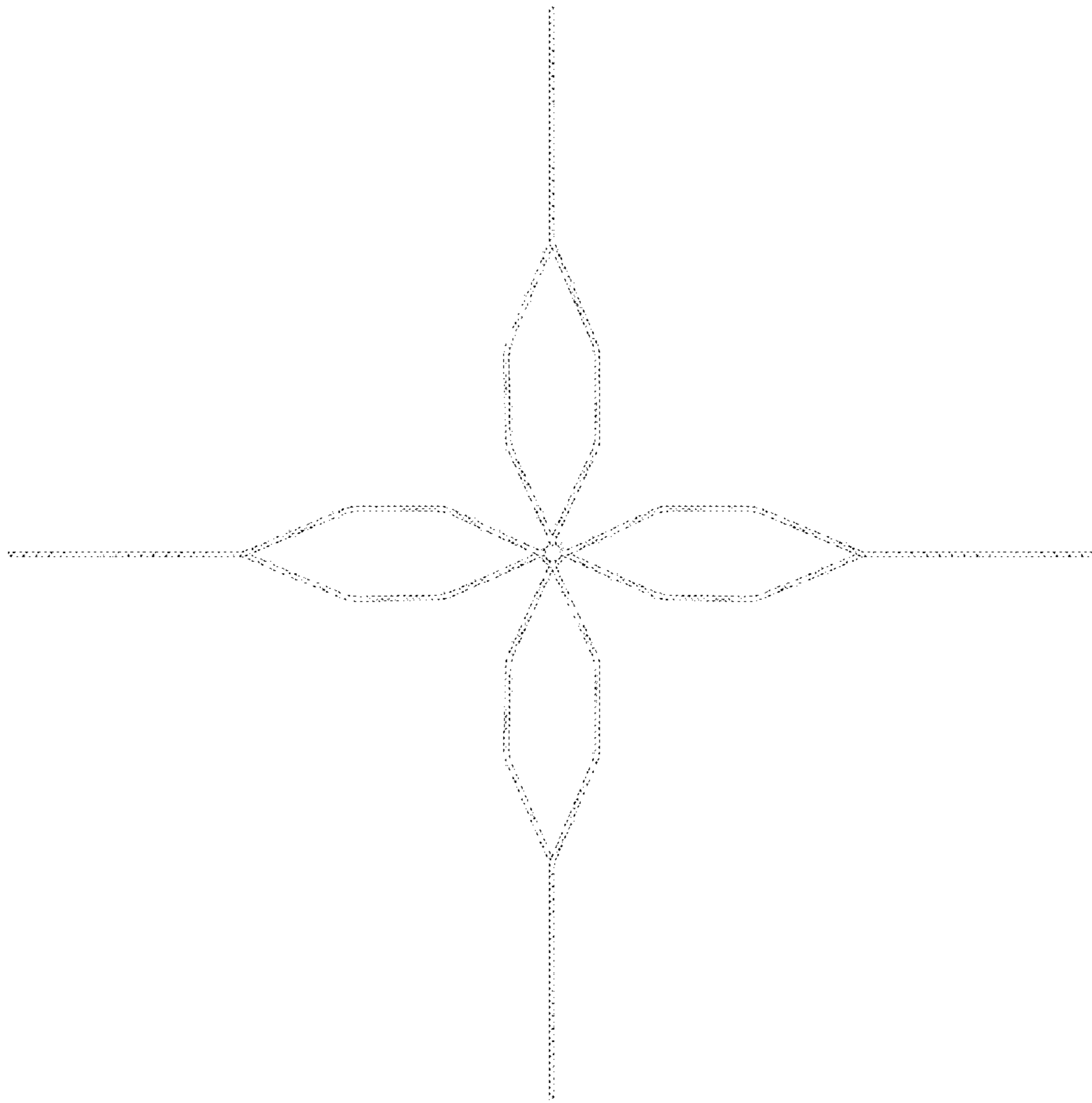

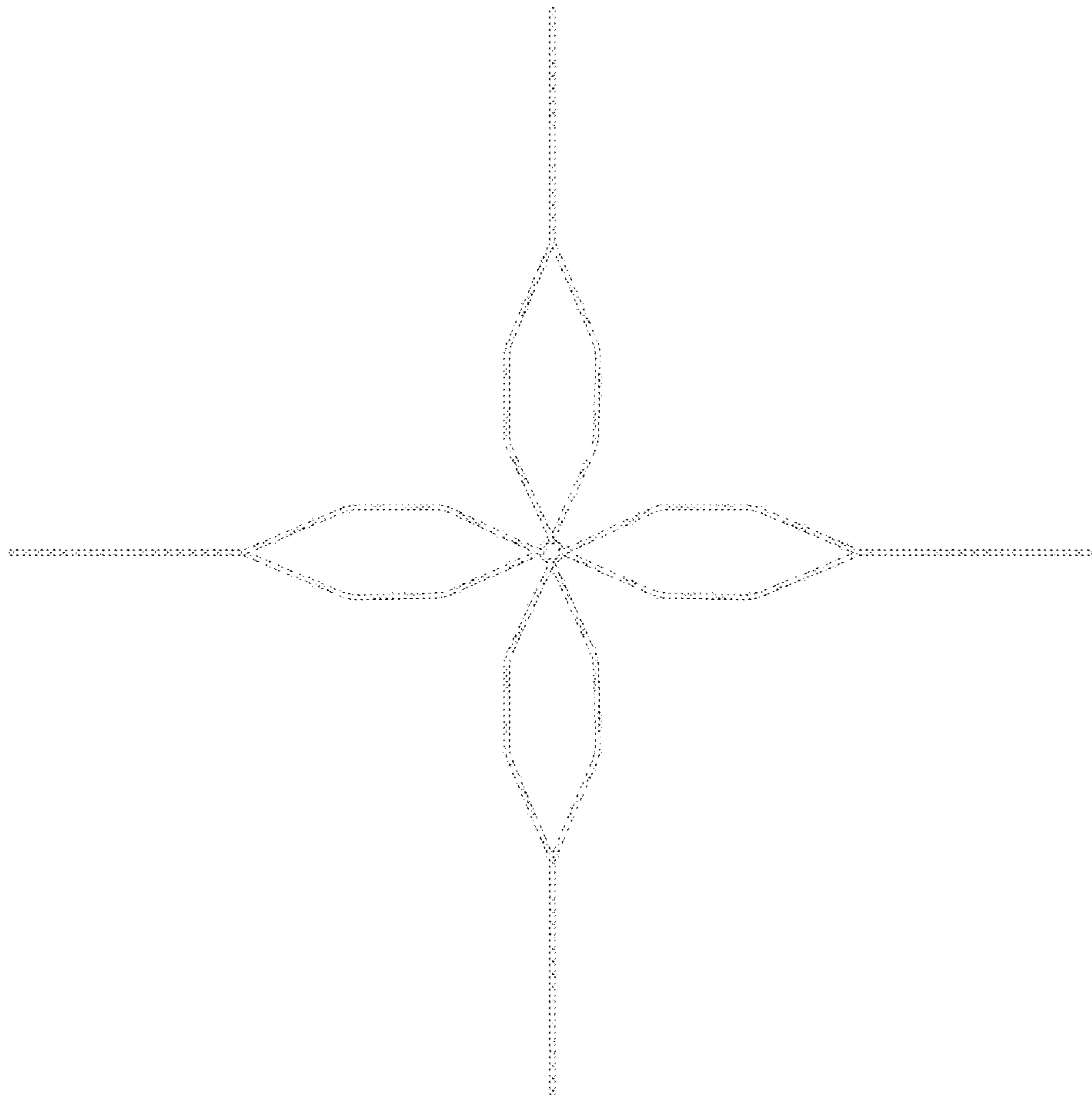

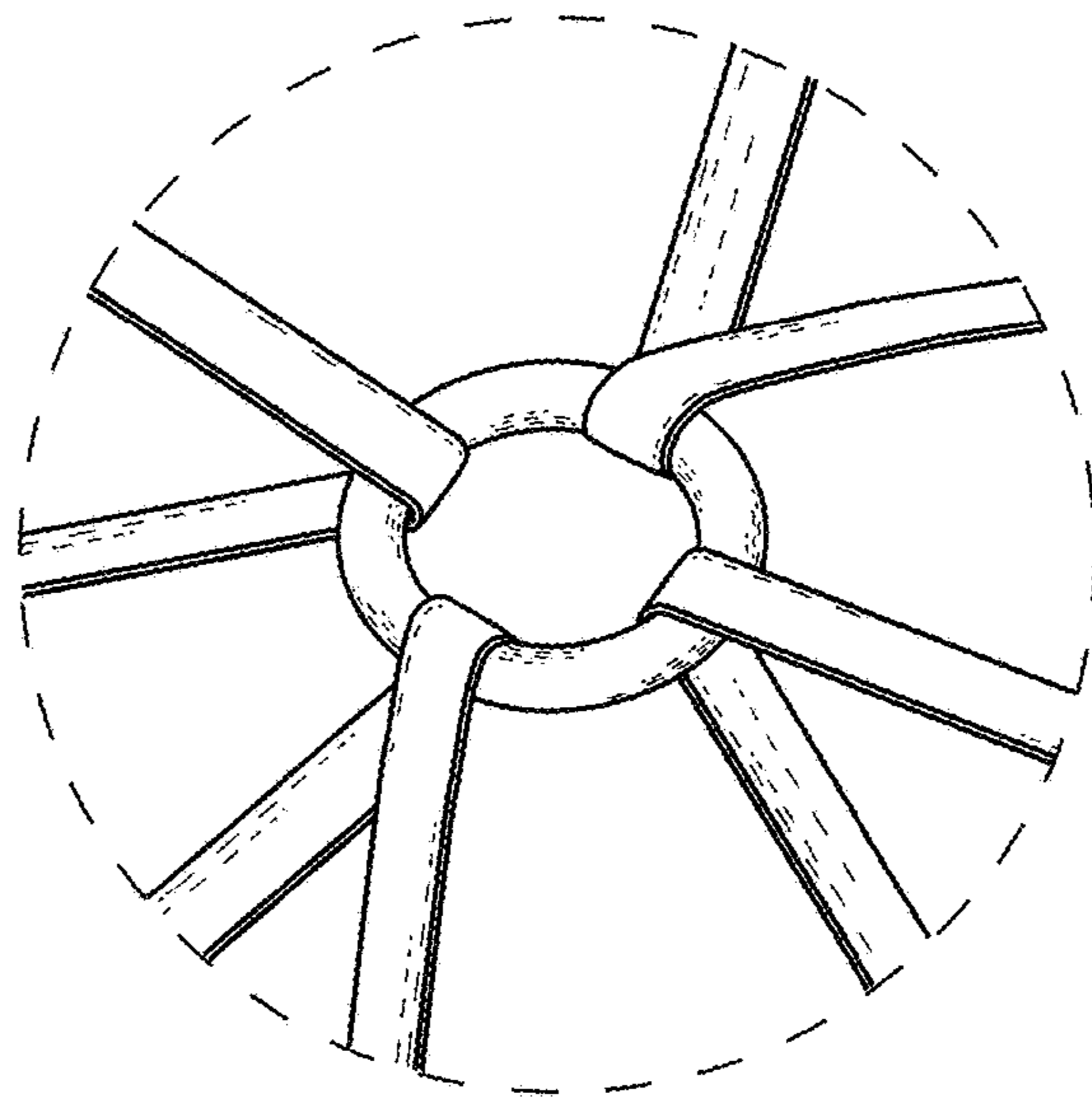

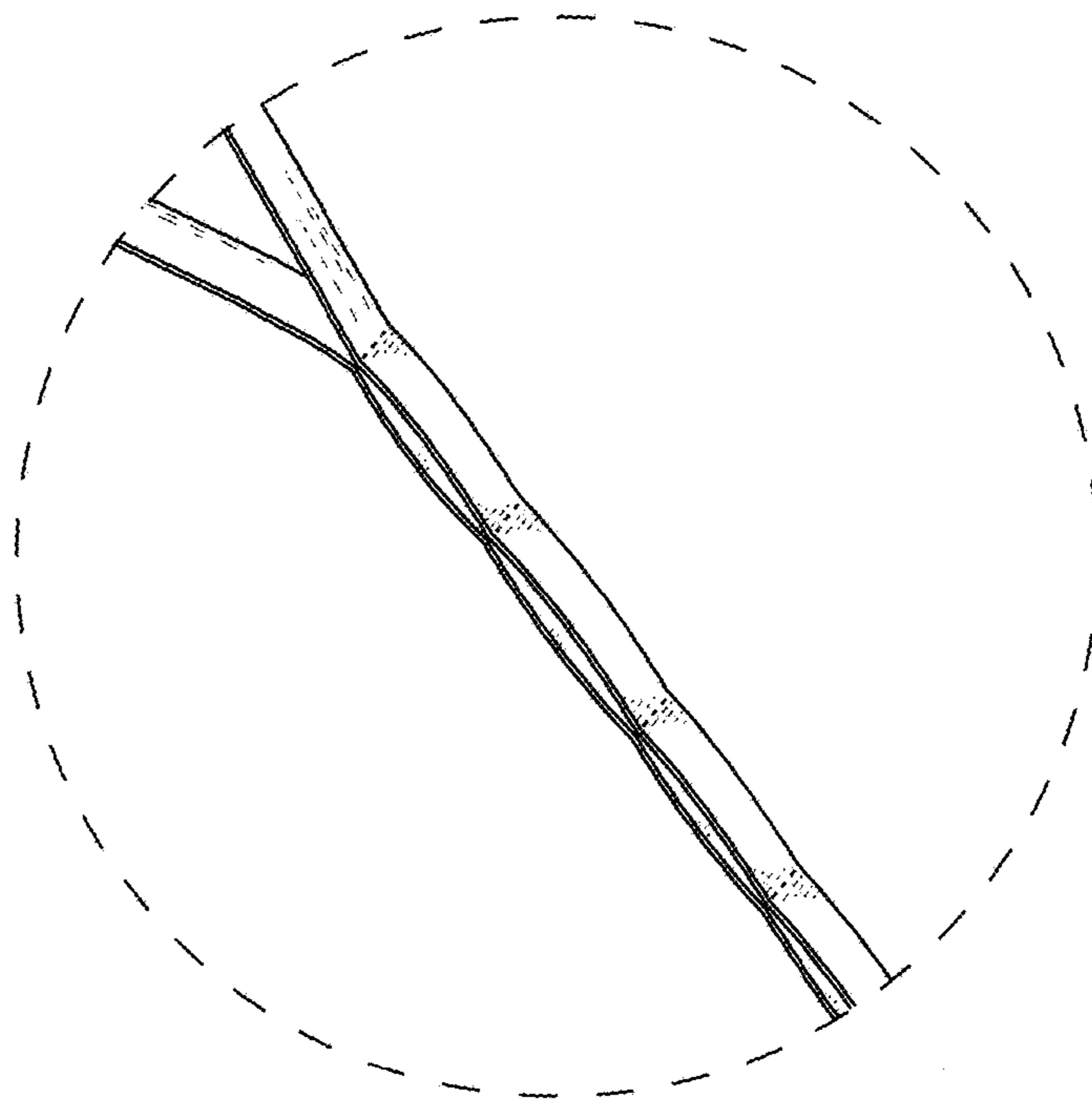

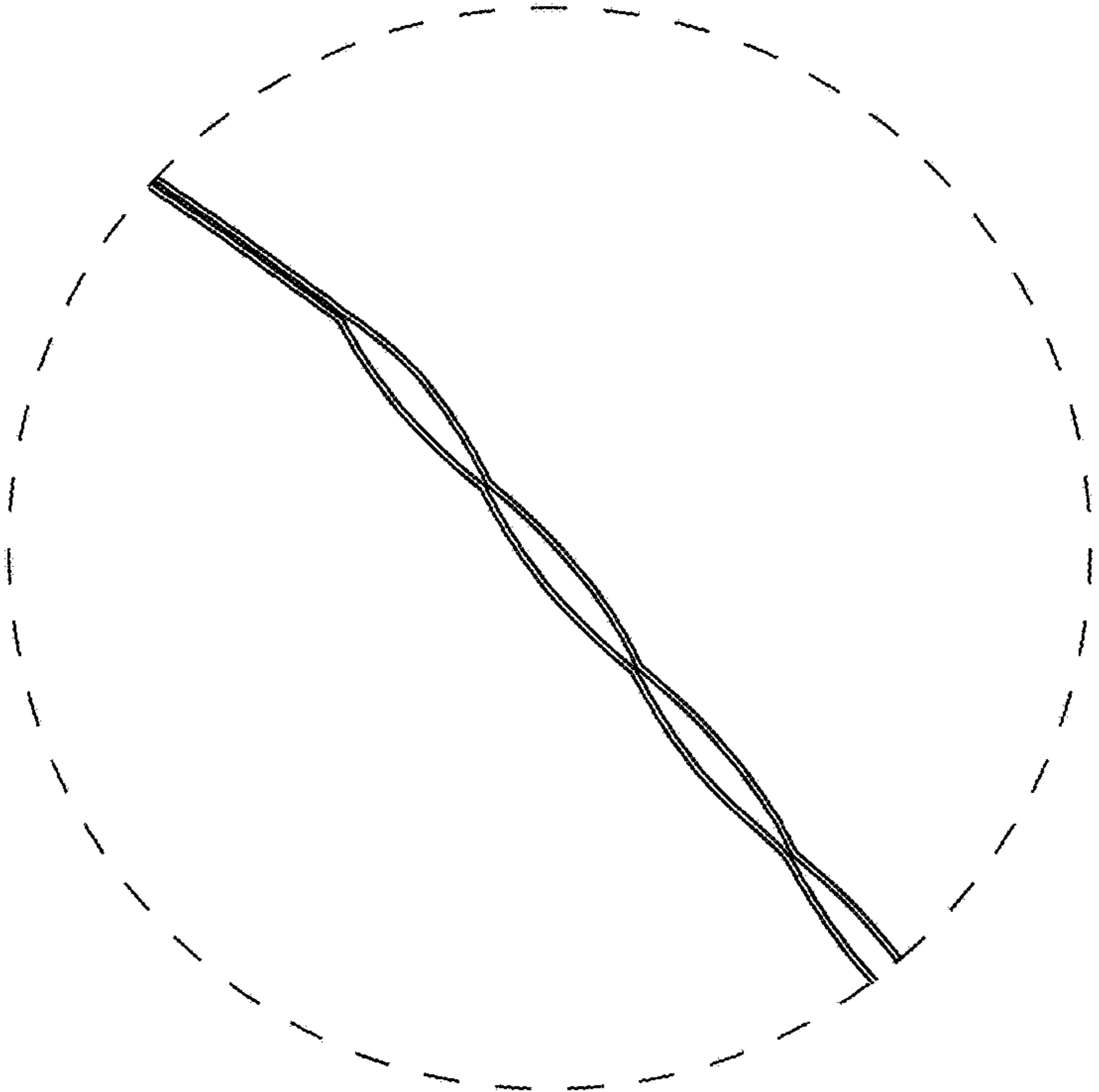
