(57) **CLAIM**

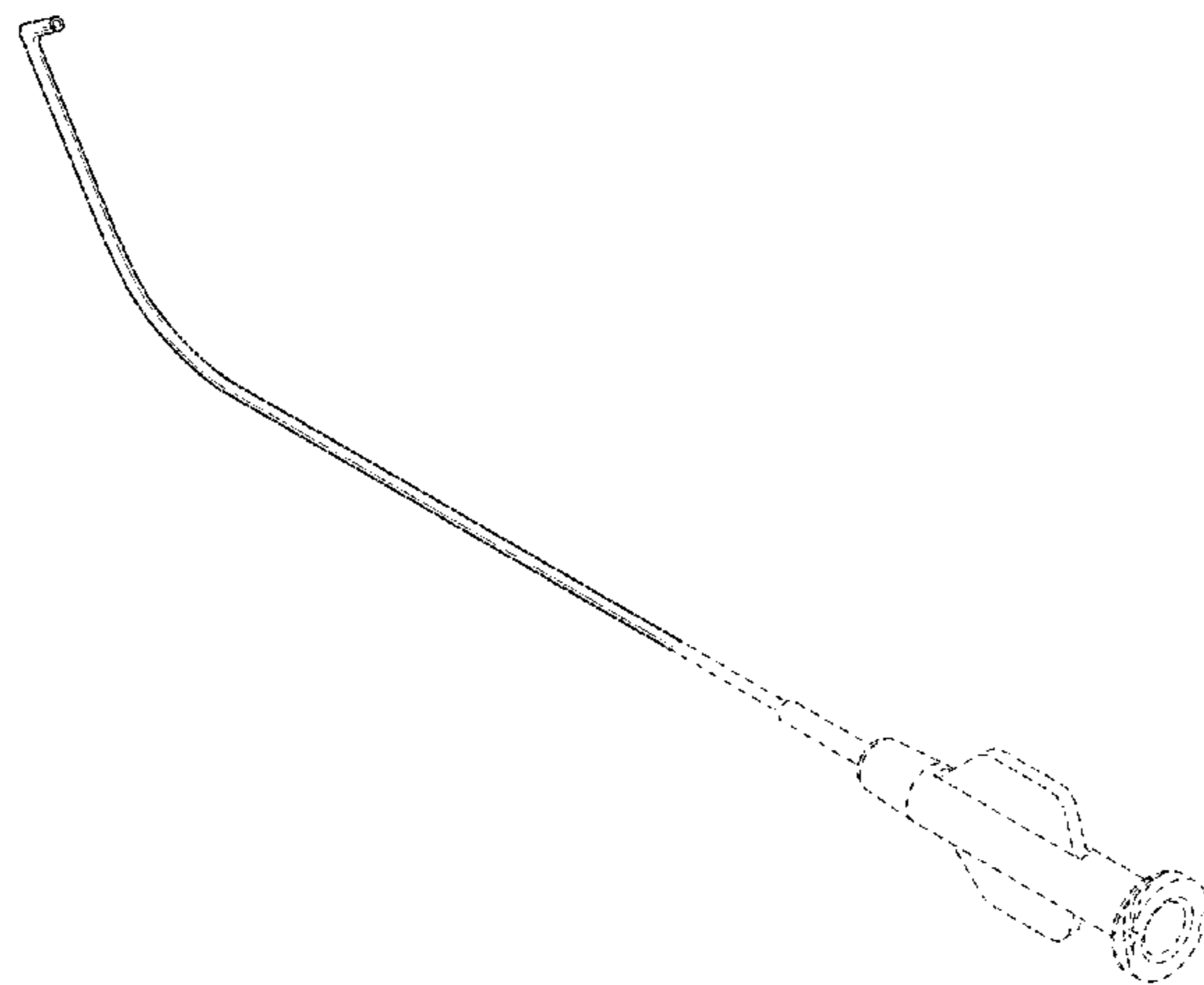
The ornamental design for a curved catheter, as shown and described.

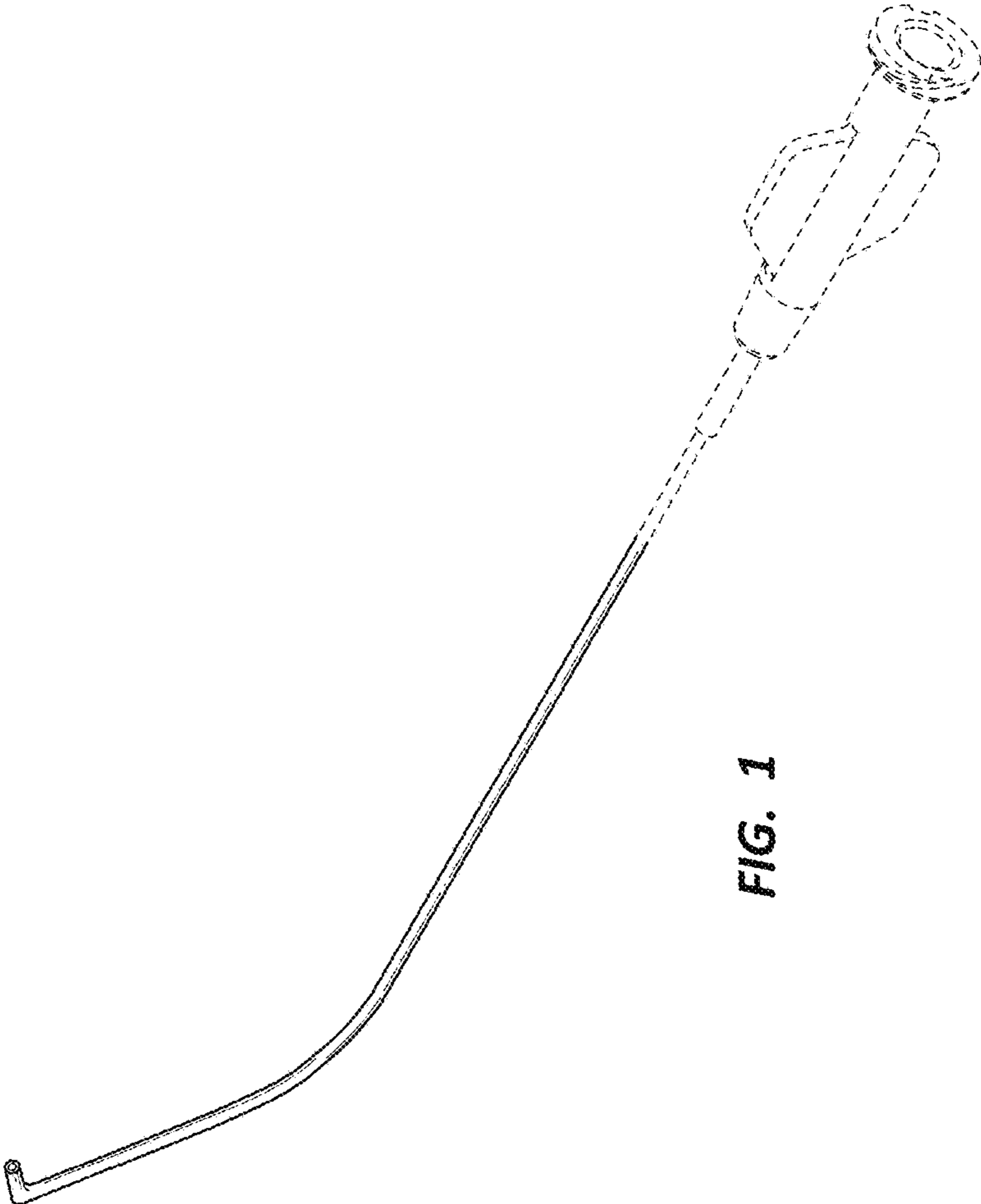

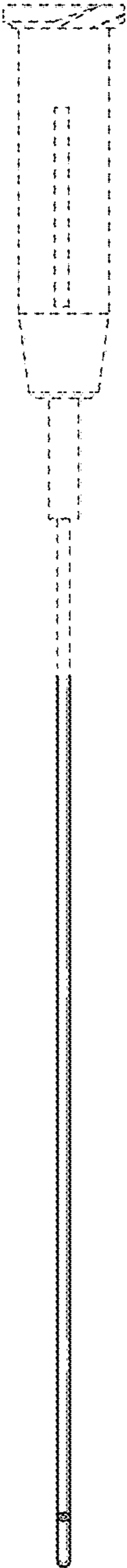

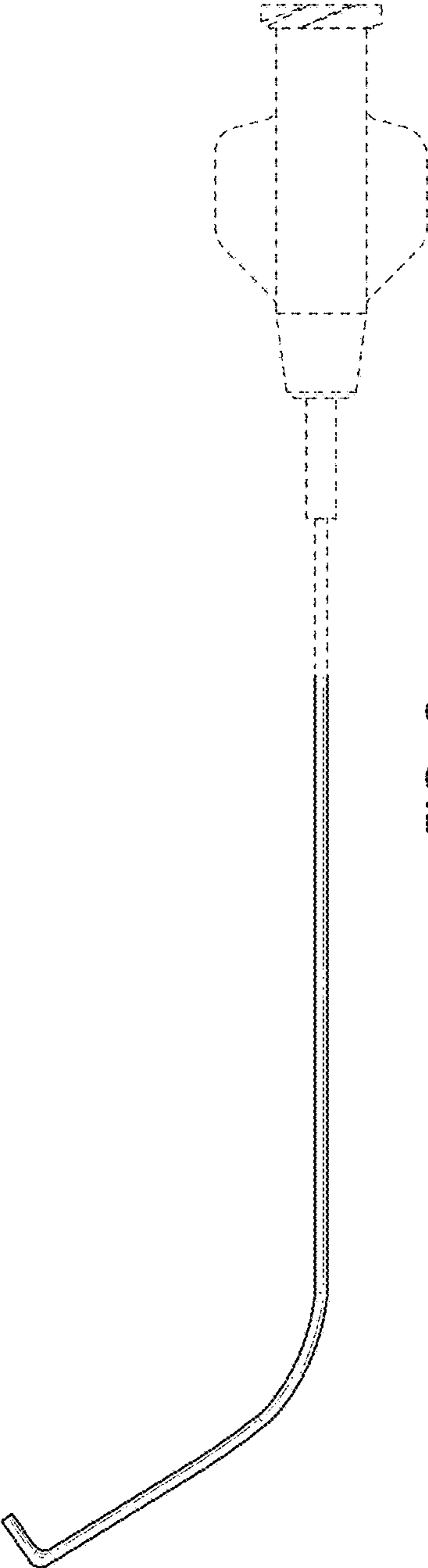

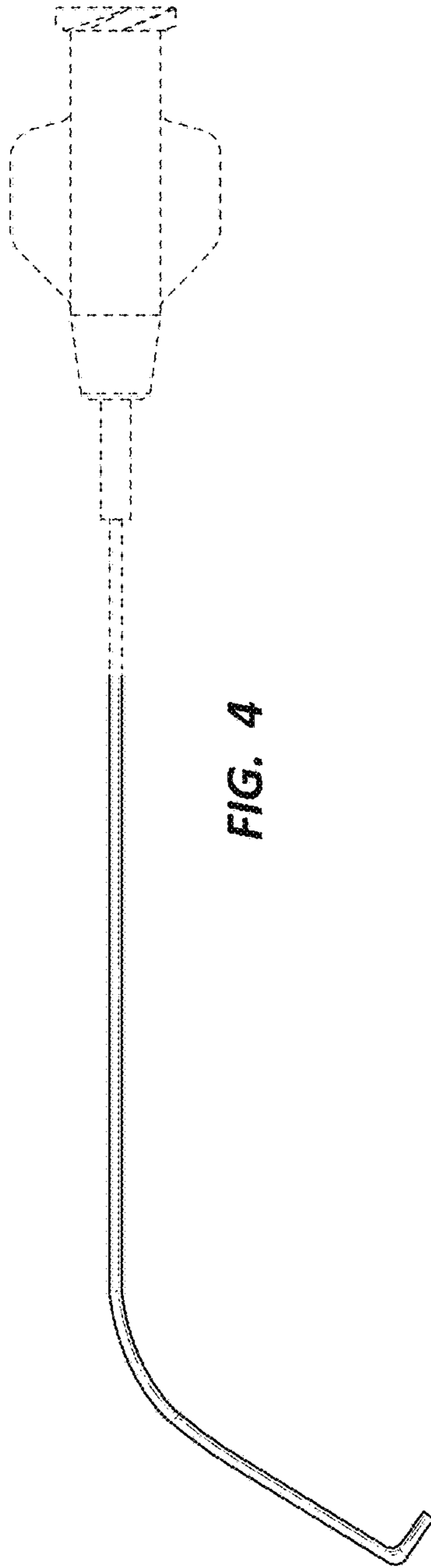

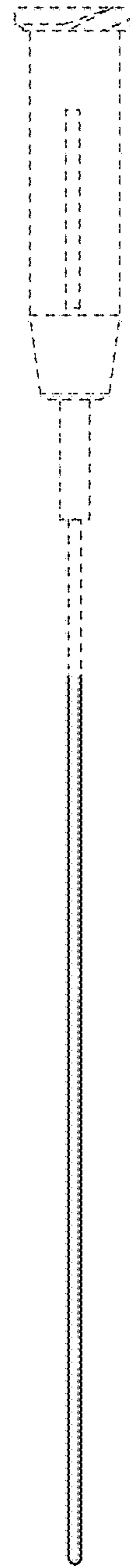

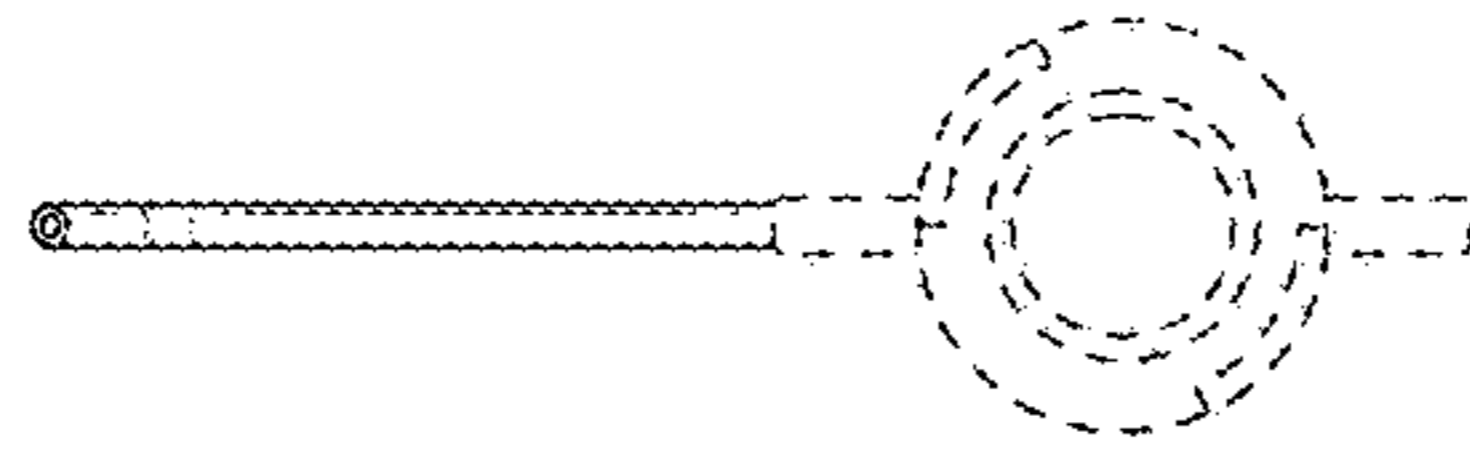

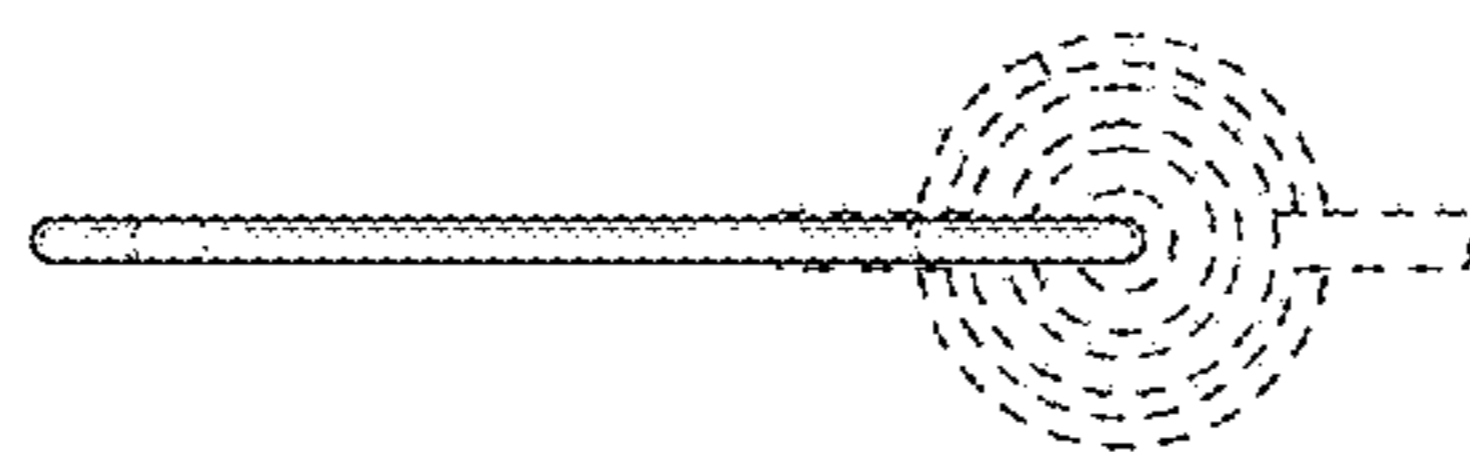
