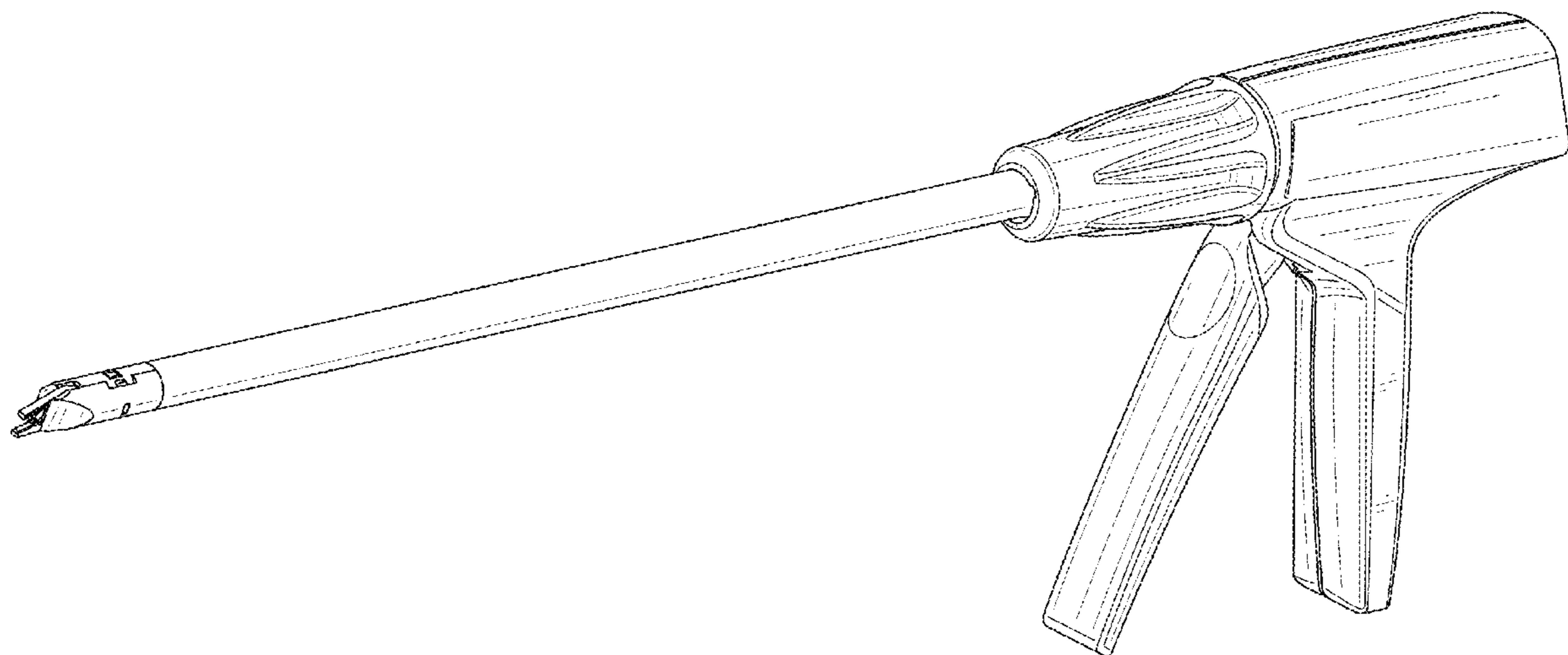
(57) **CLAIM**

The ornamental design for a surgical clip applier device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a surgical clip applier device having a new design for a rotation knob;
 FIG. 2 is a back view of the clip applier device of FIG. 1;
 FIG. 3 is a front view of the clip applier device of FIG. 1;
 FIG. 4 is a right side view of the clip applier device of FIG. 1;
 FIG. 5 is a left side view of the clip applier device of FIG. 1;
 FIG. 6 is a top view of the clip applier device of FIG. 1; and,
 FIG. 7 is a bottom view of the clip applier device of FIG. 1.

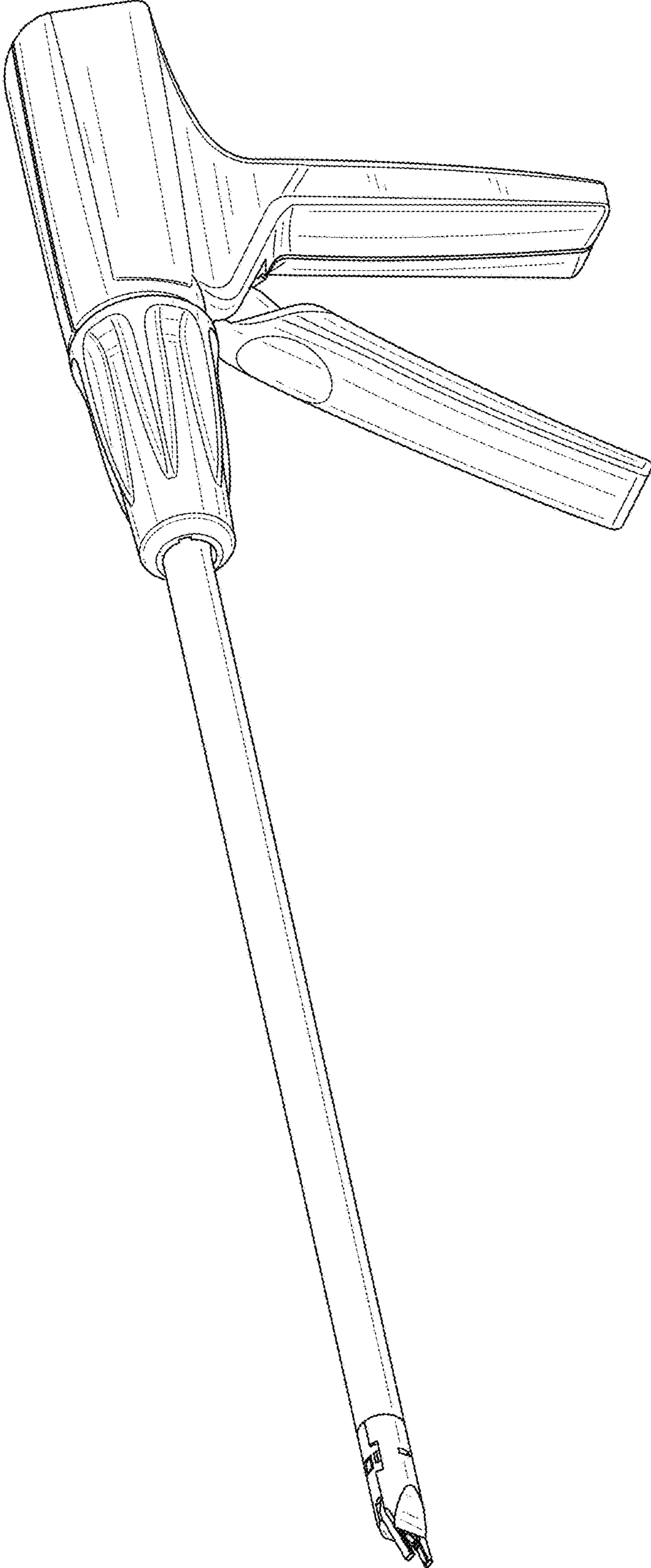

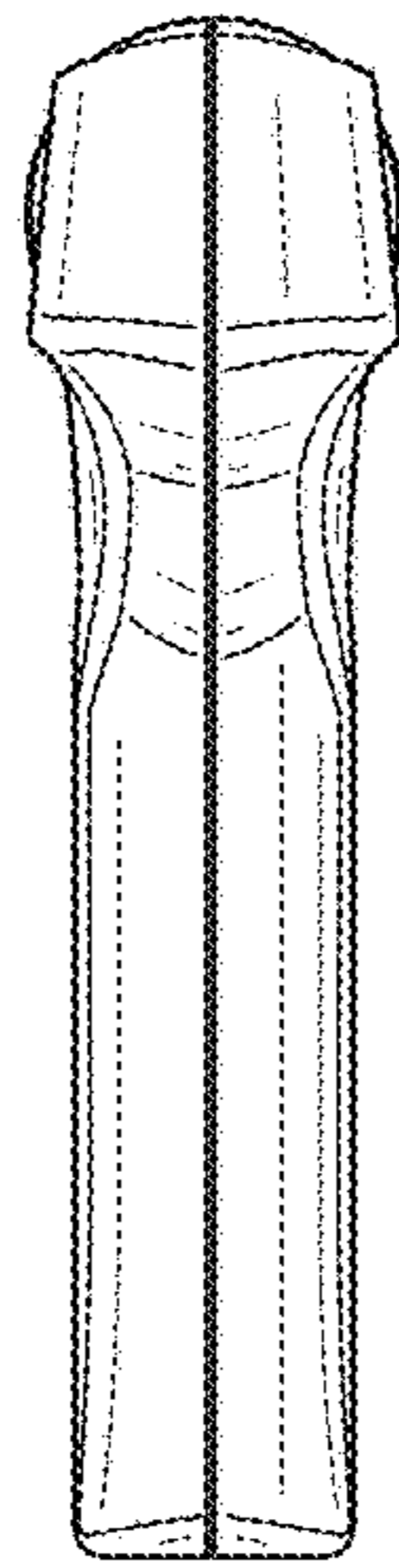

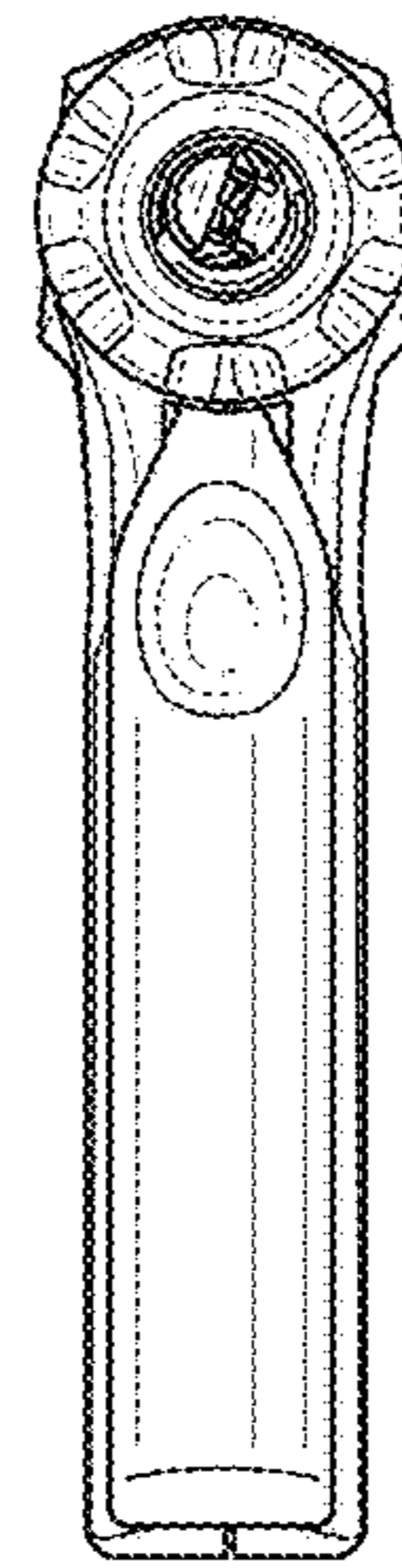

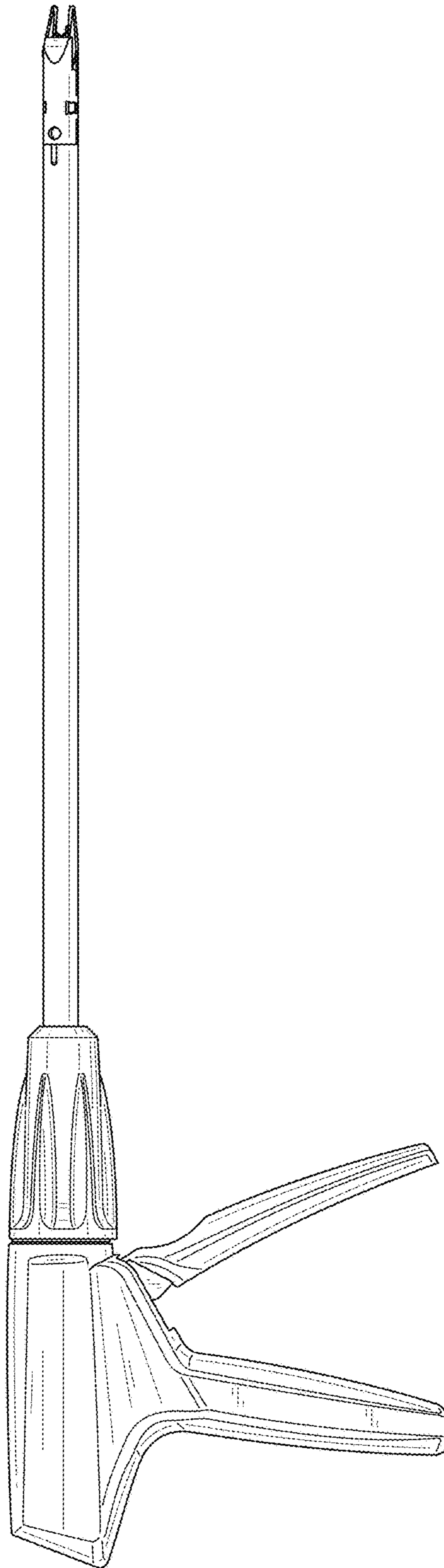

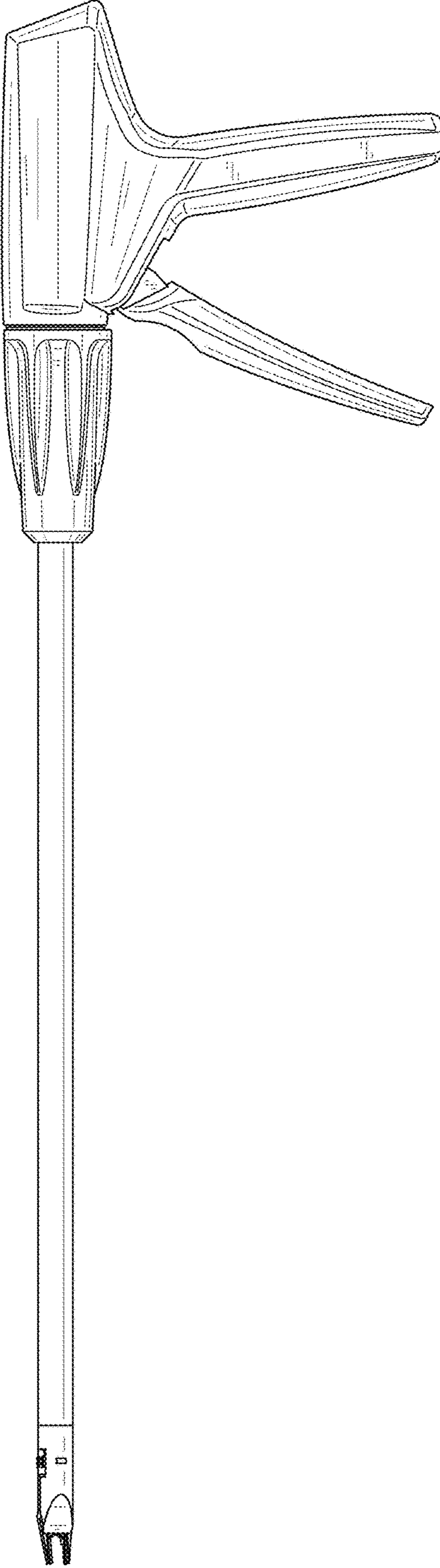

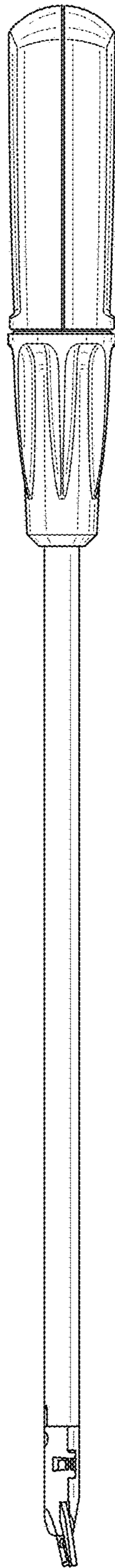

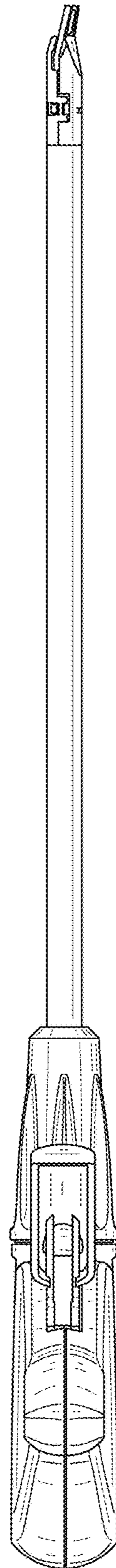
