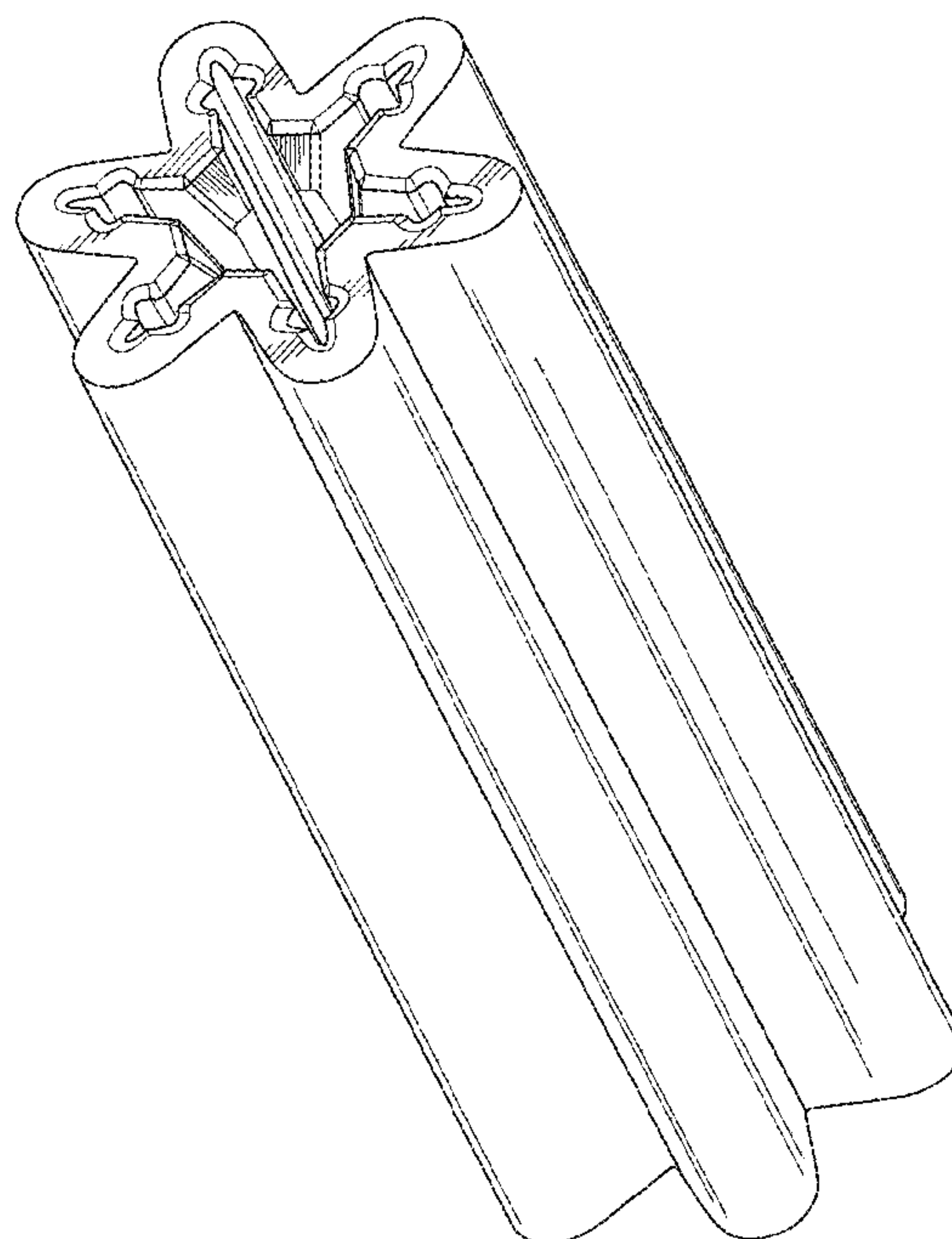
(57) **CLAIM**

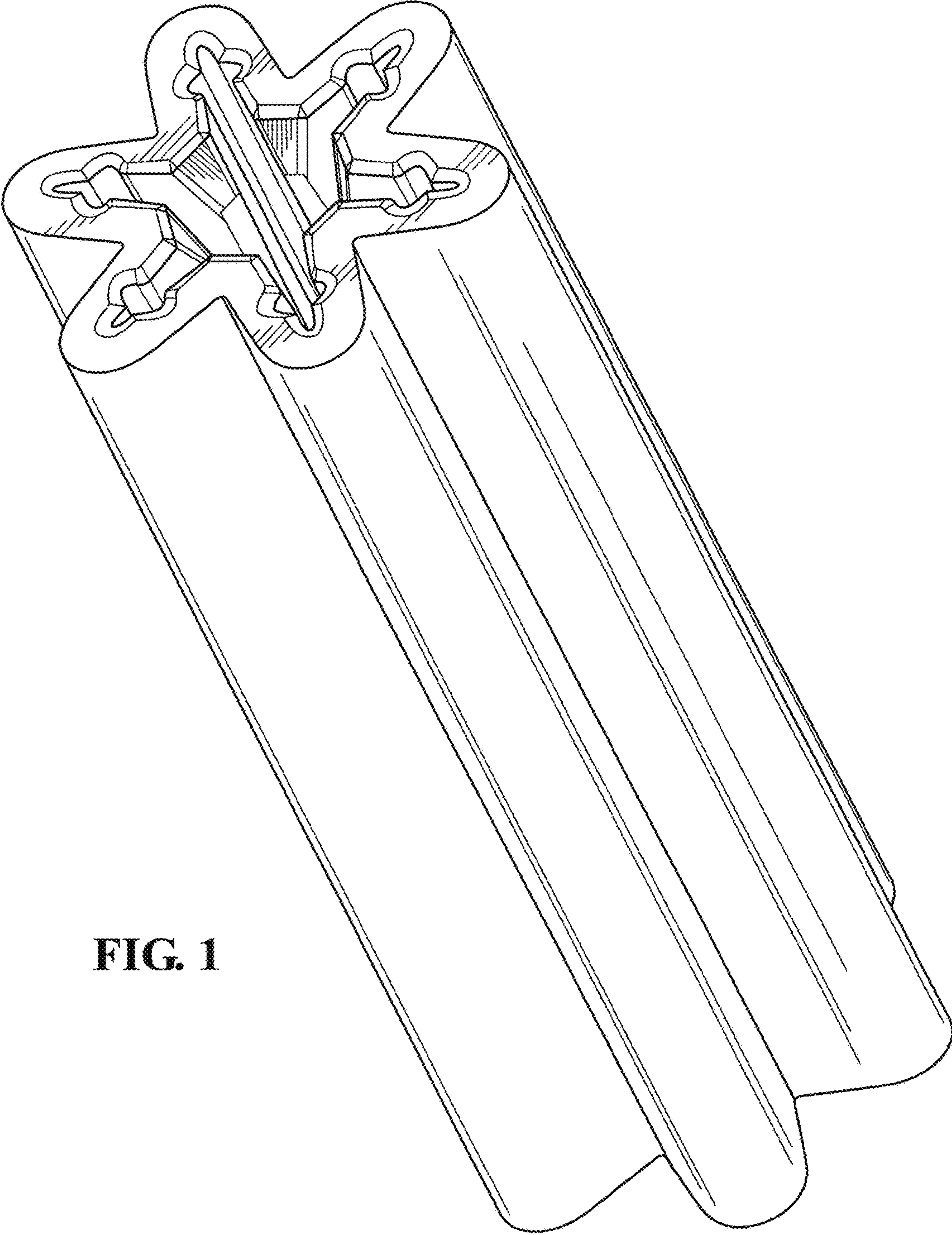
We claim the ornamental design for a star shaped collar for holding a makeup brush, as shown and described.

**DESCRIPTION**

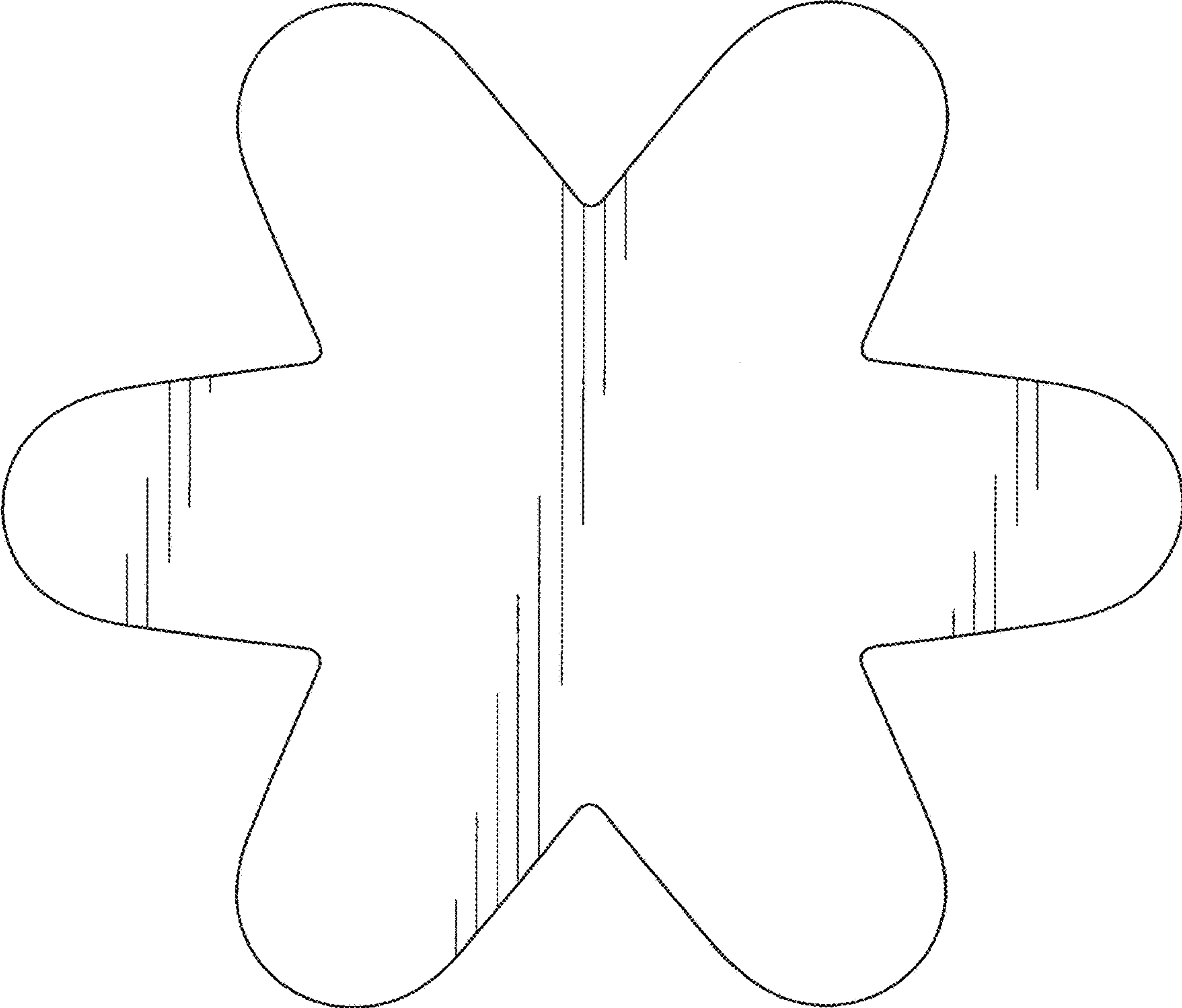
FIG. 1 is a perspective view of the star shaped collar for holding a makeup brush;

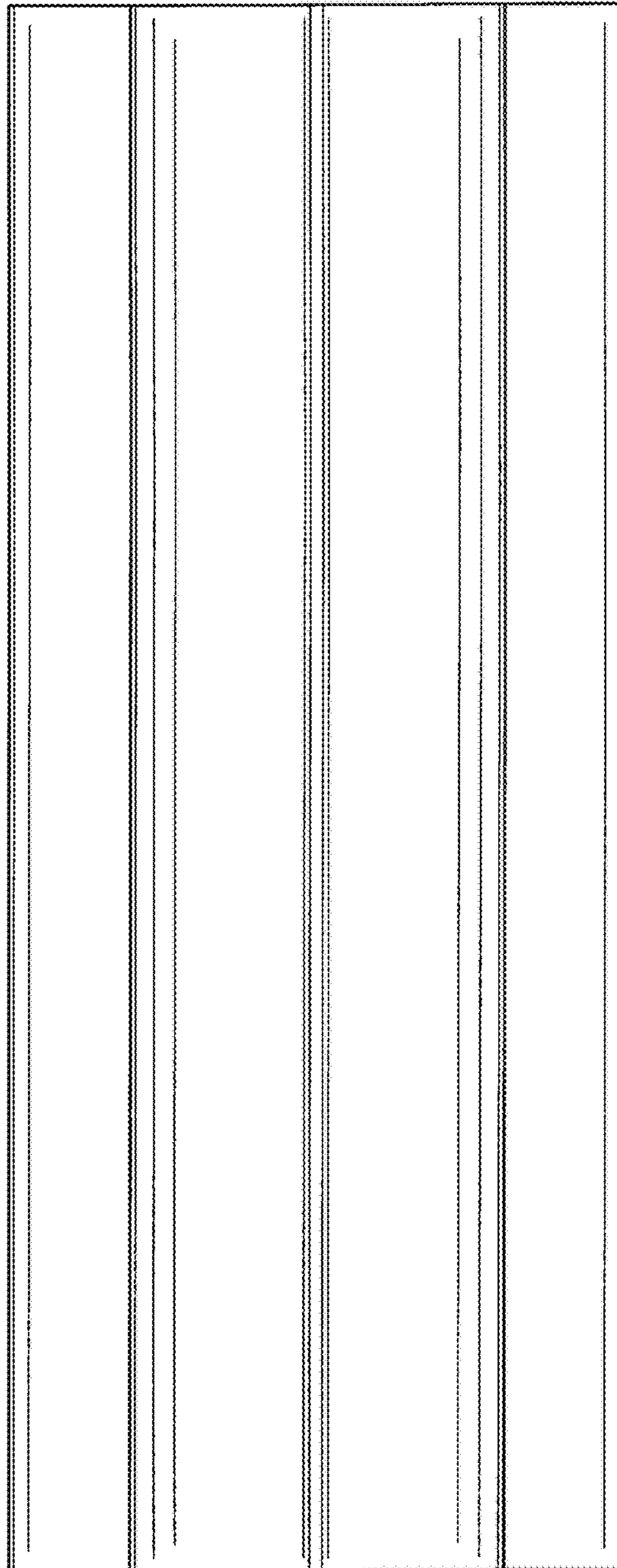

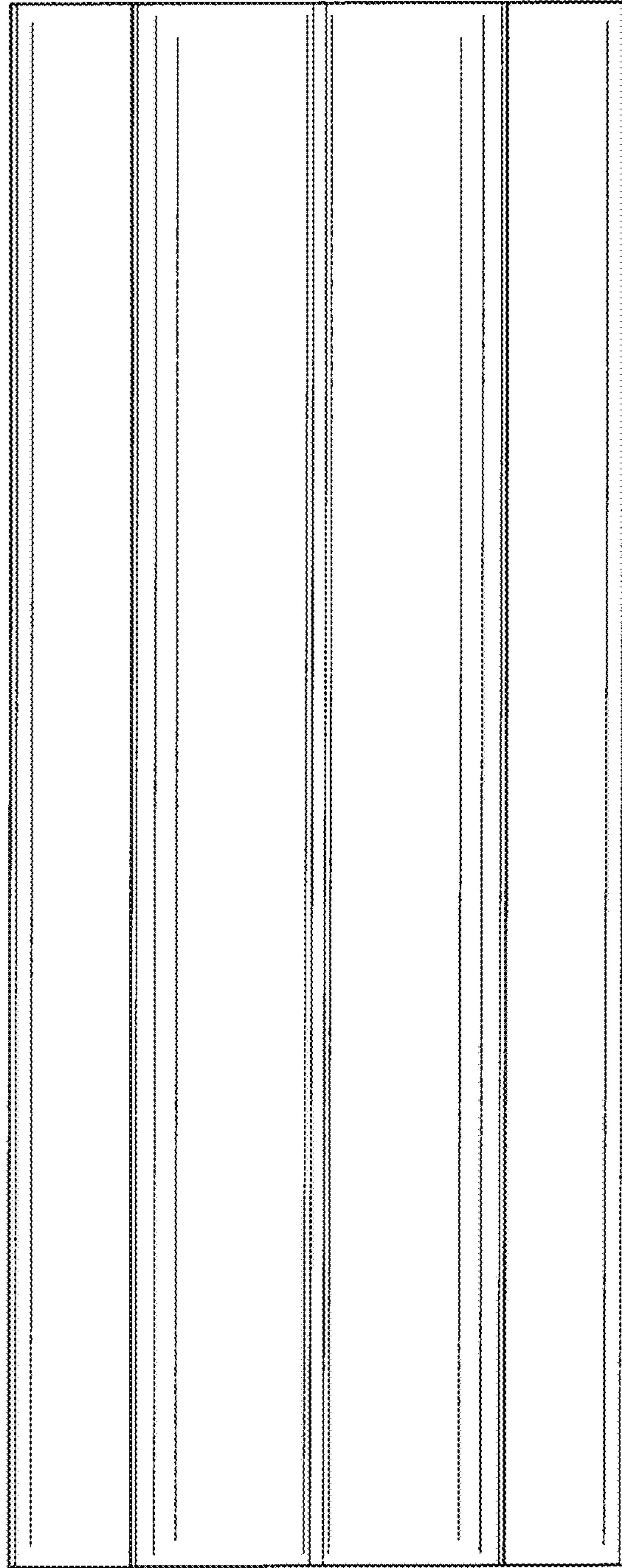
