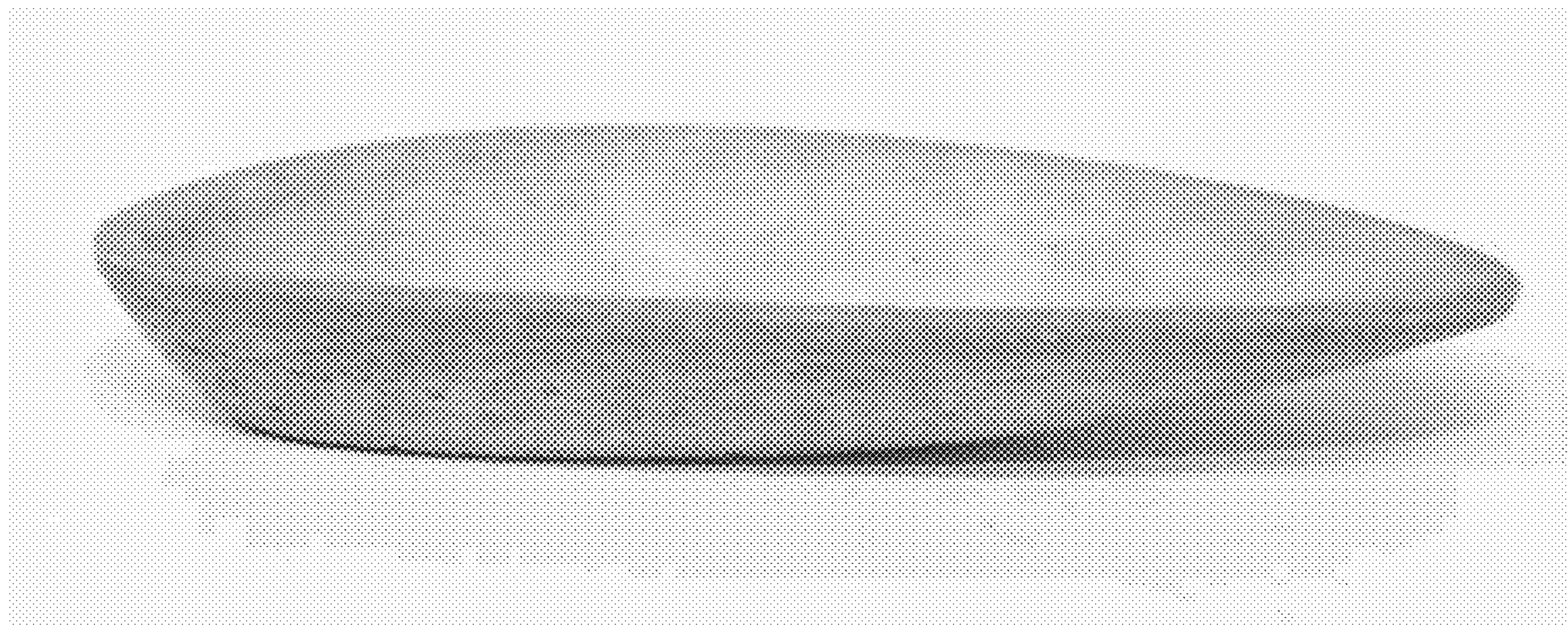

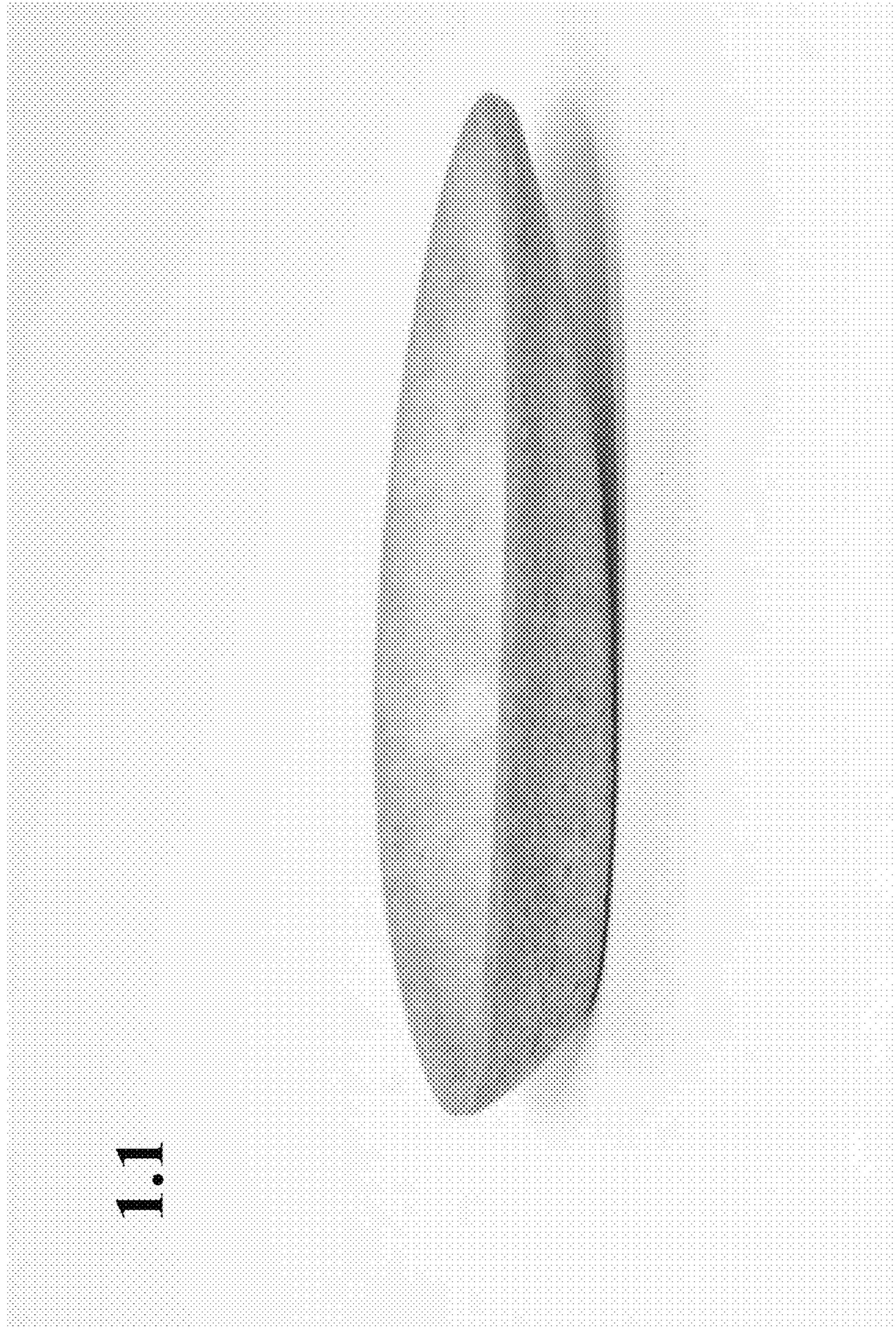
The ornamental design for a cracker, as shown and described.

DESCRIPTION

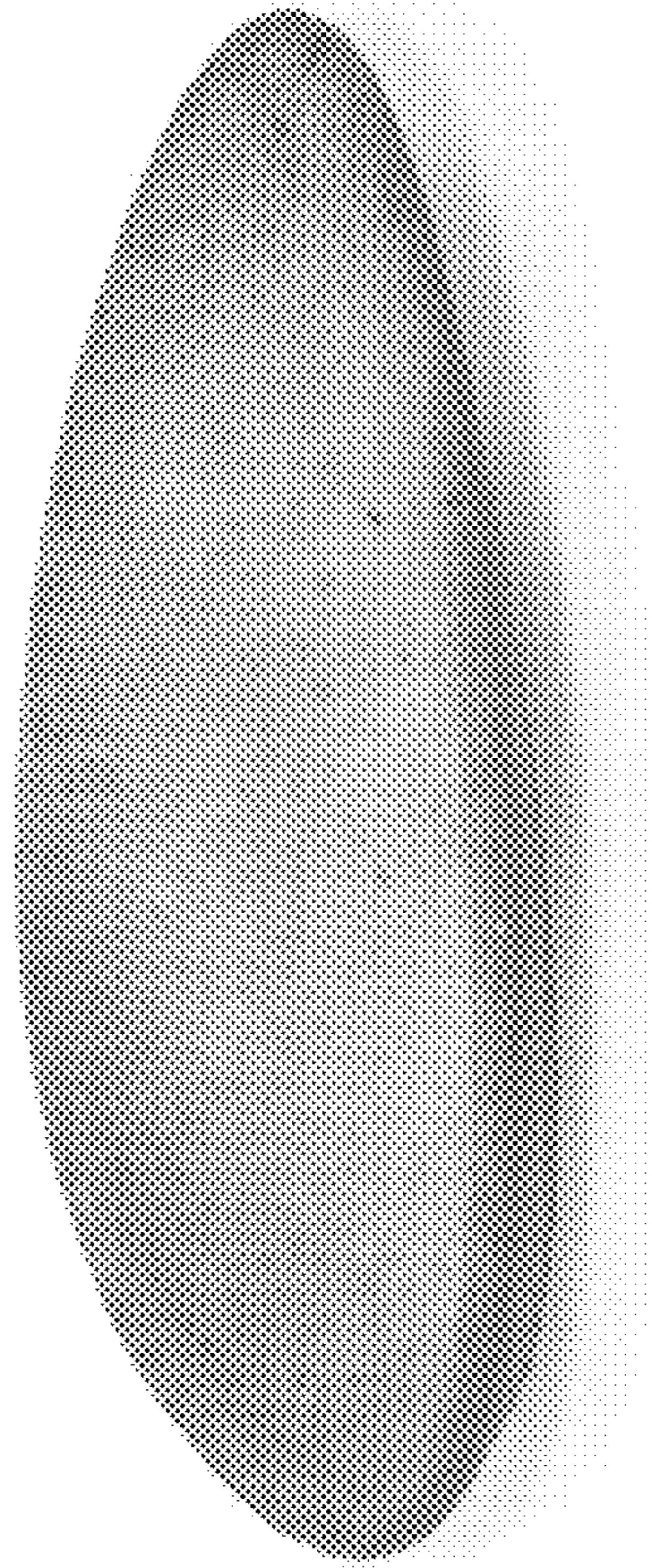
FIG. 1.1 is a top, front, right side perspective view of a cracker;
