DESCRIPTION

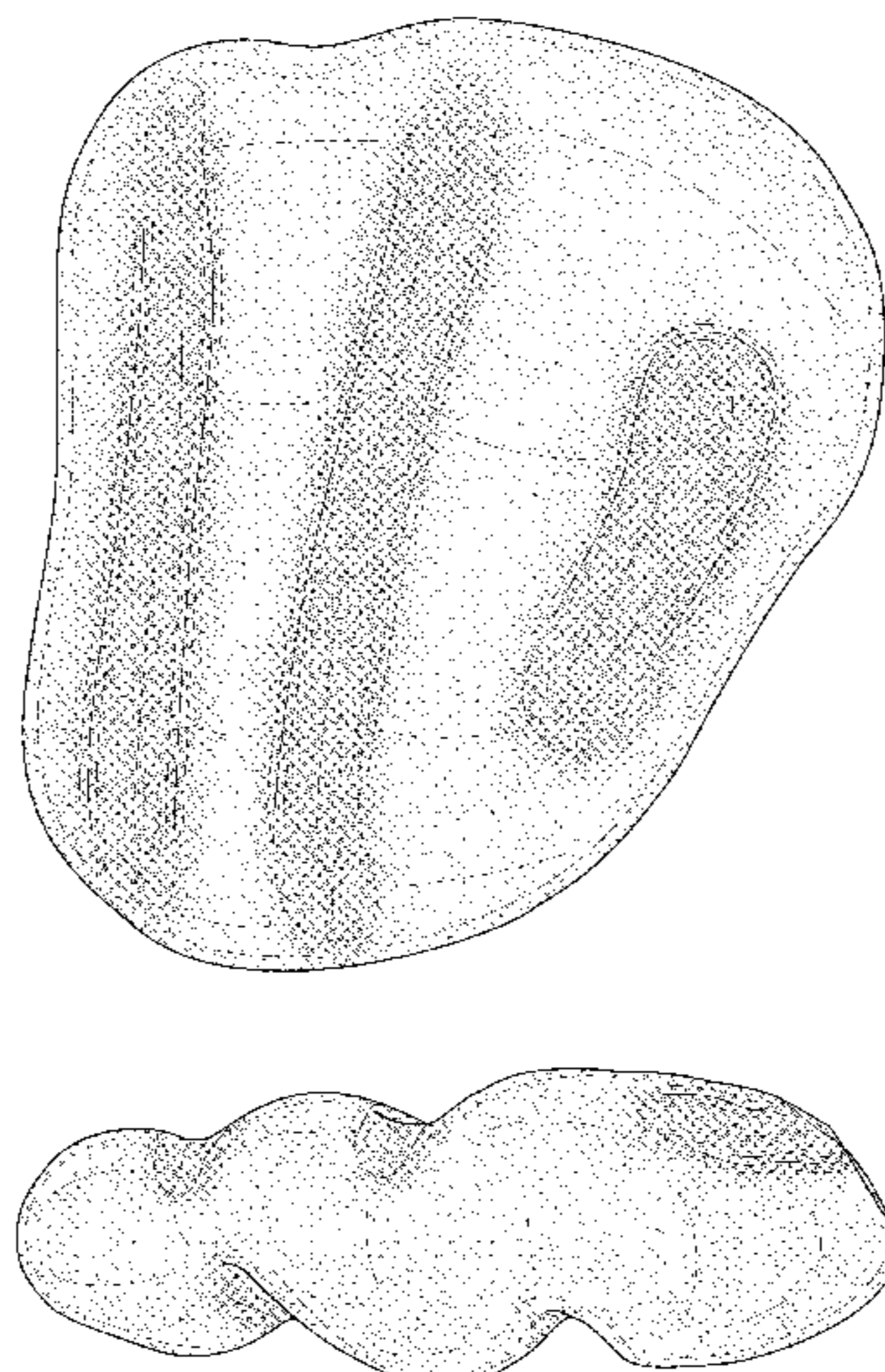
FIG. 1 is a top, front, right perspective view of a first embodiment of a pet food showing our new design;

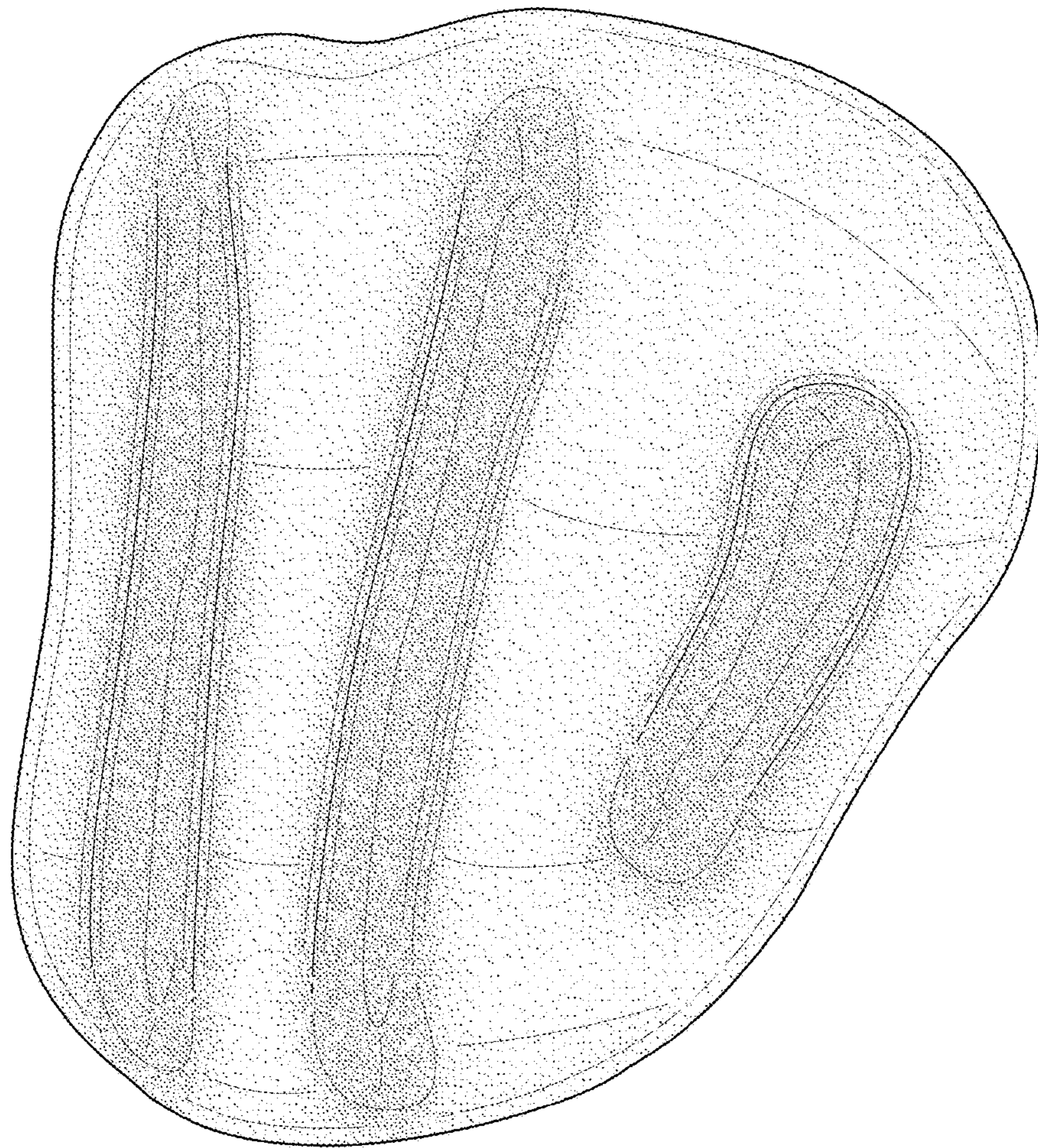

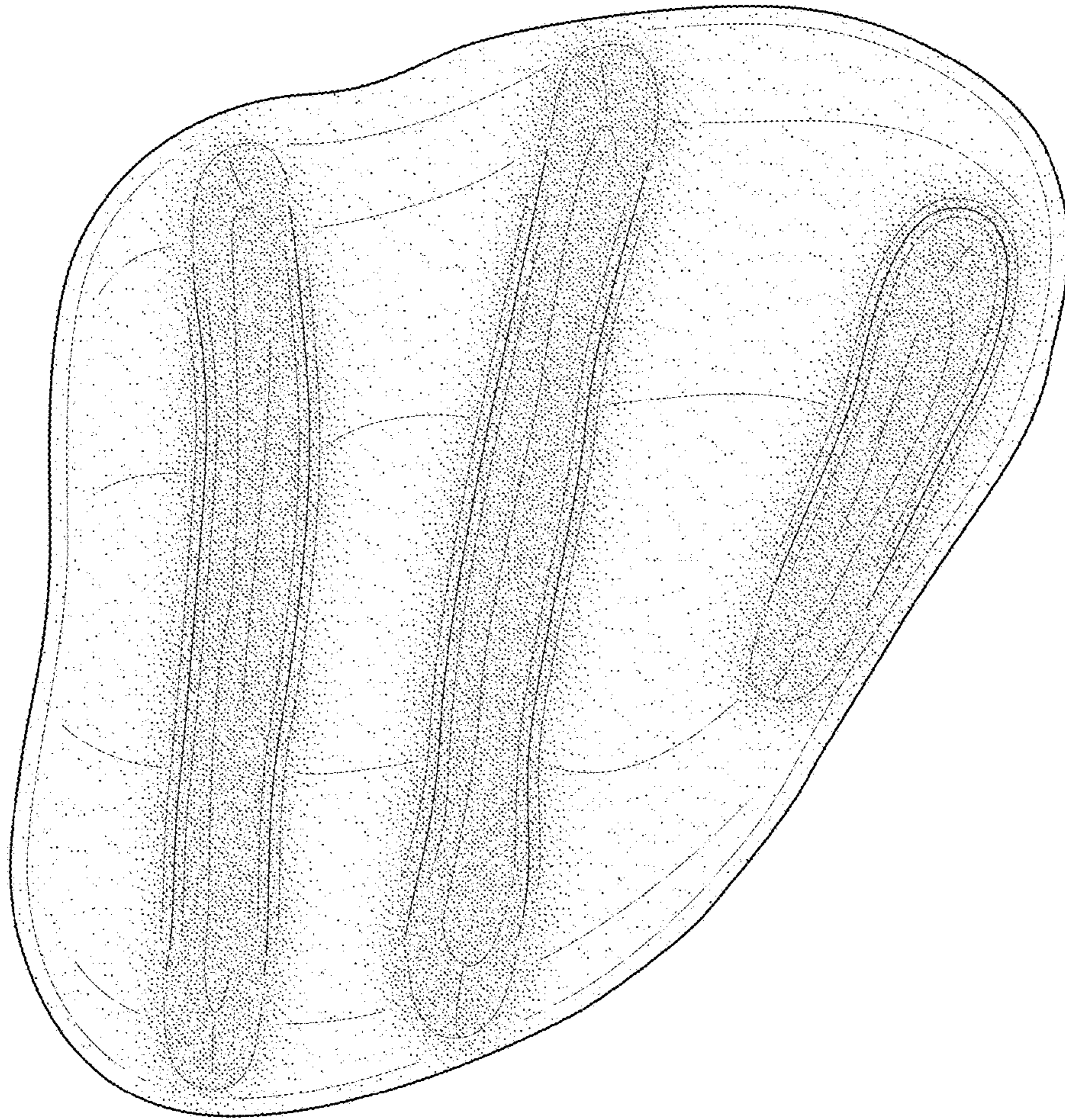

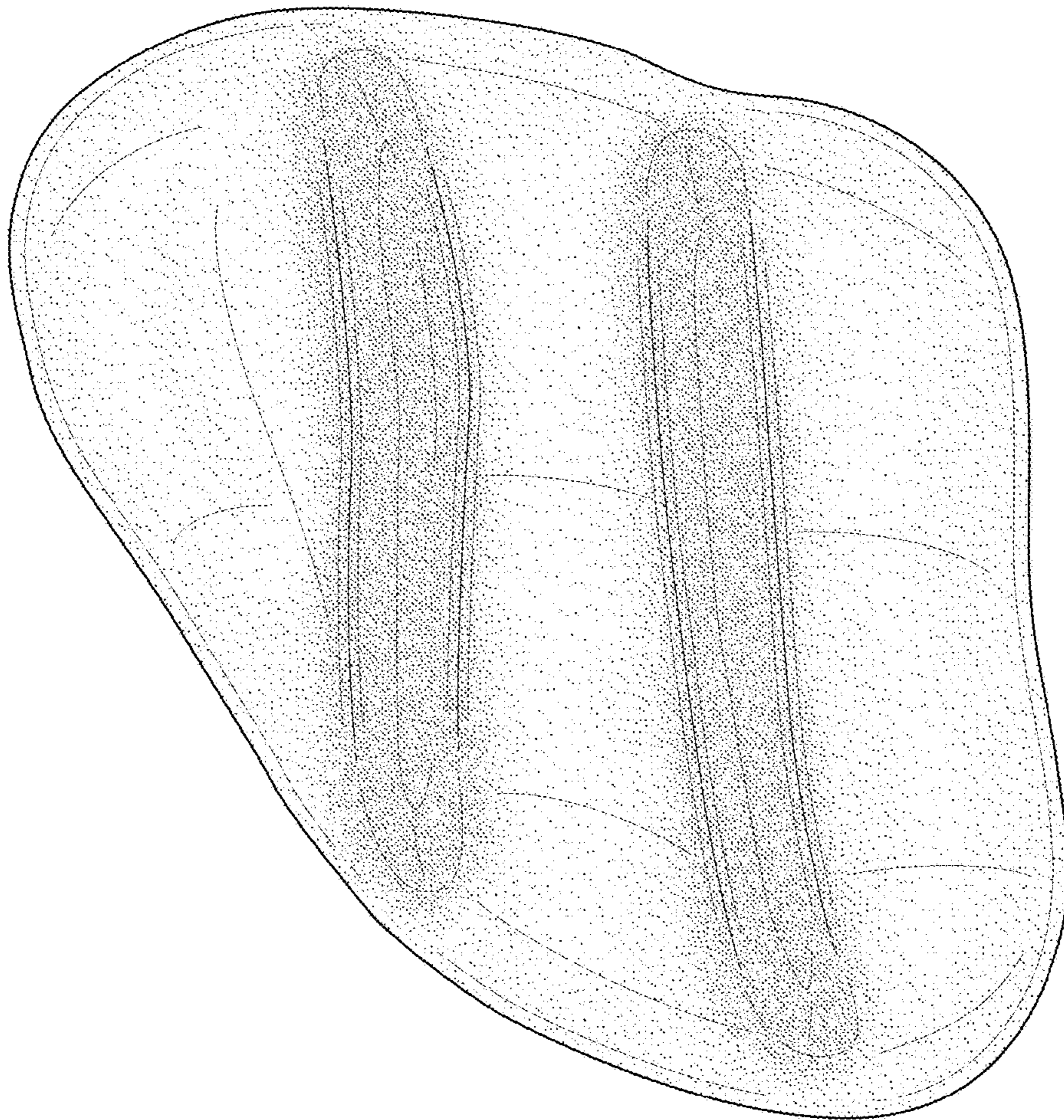

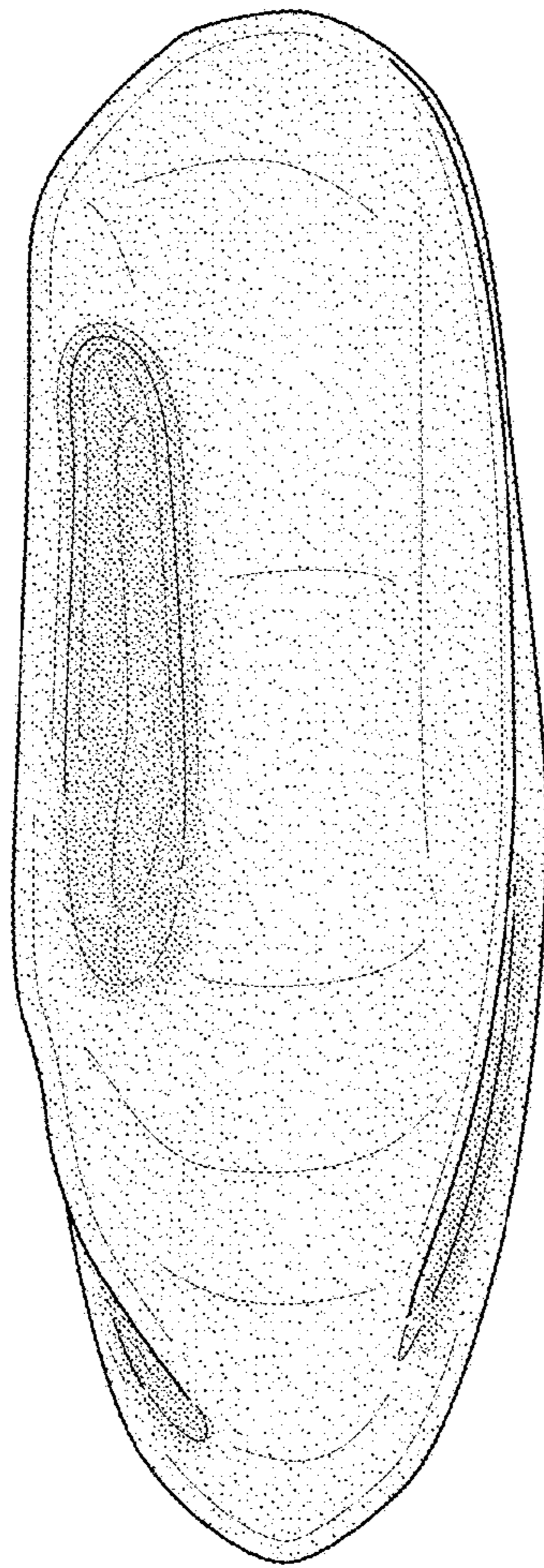

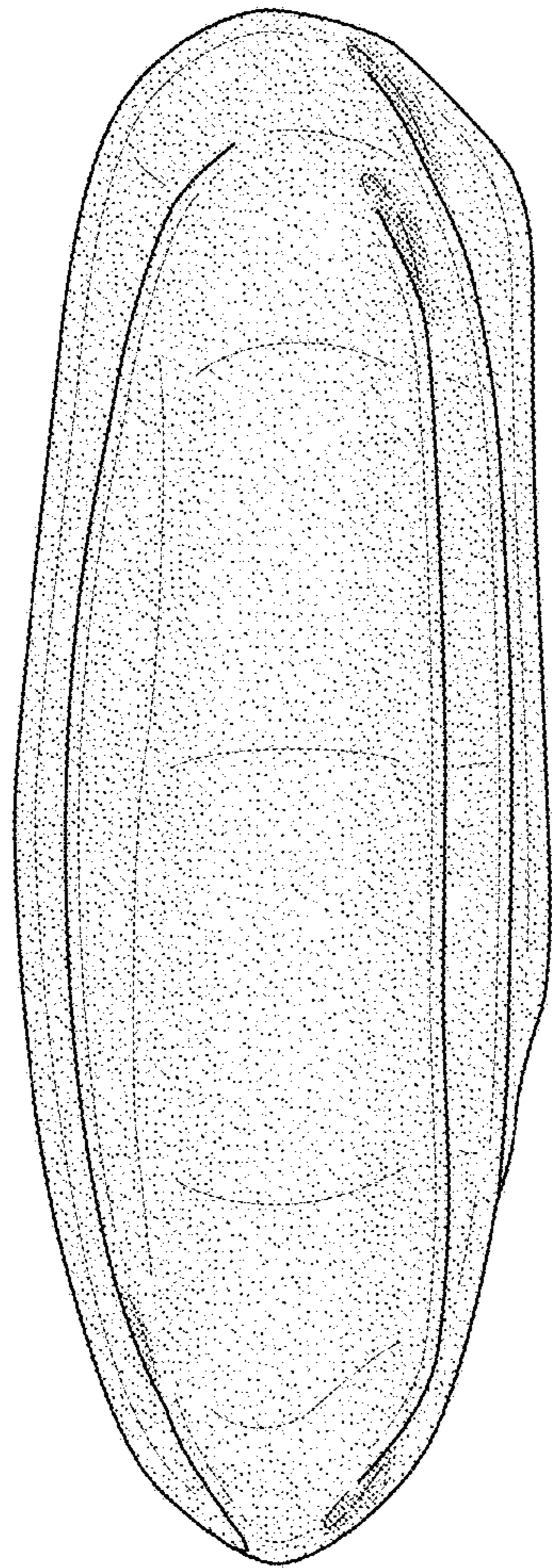

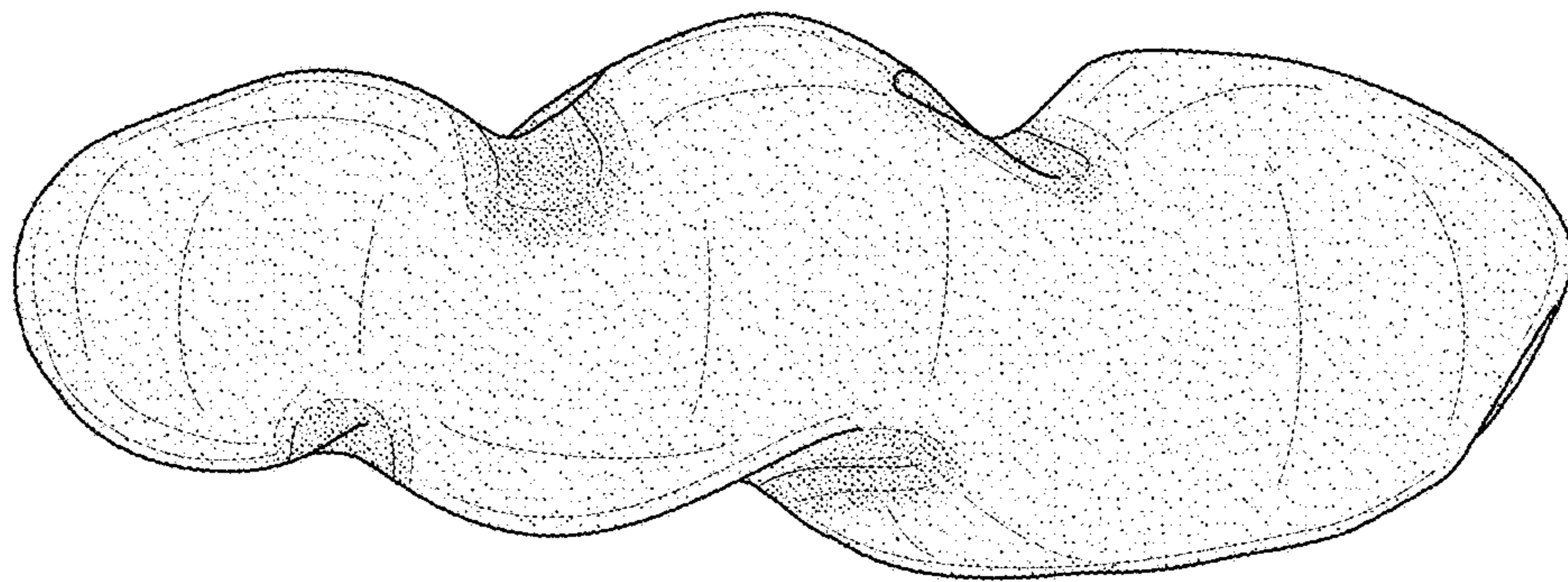

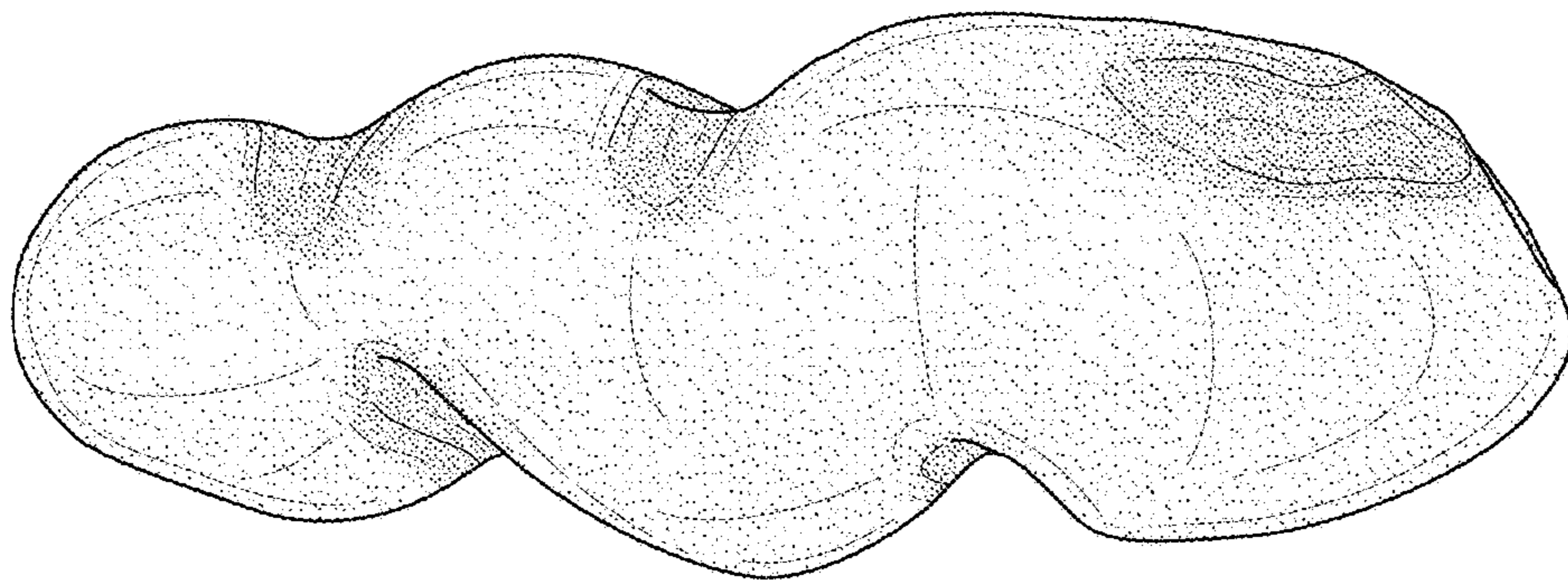

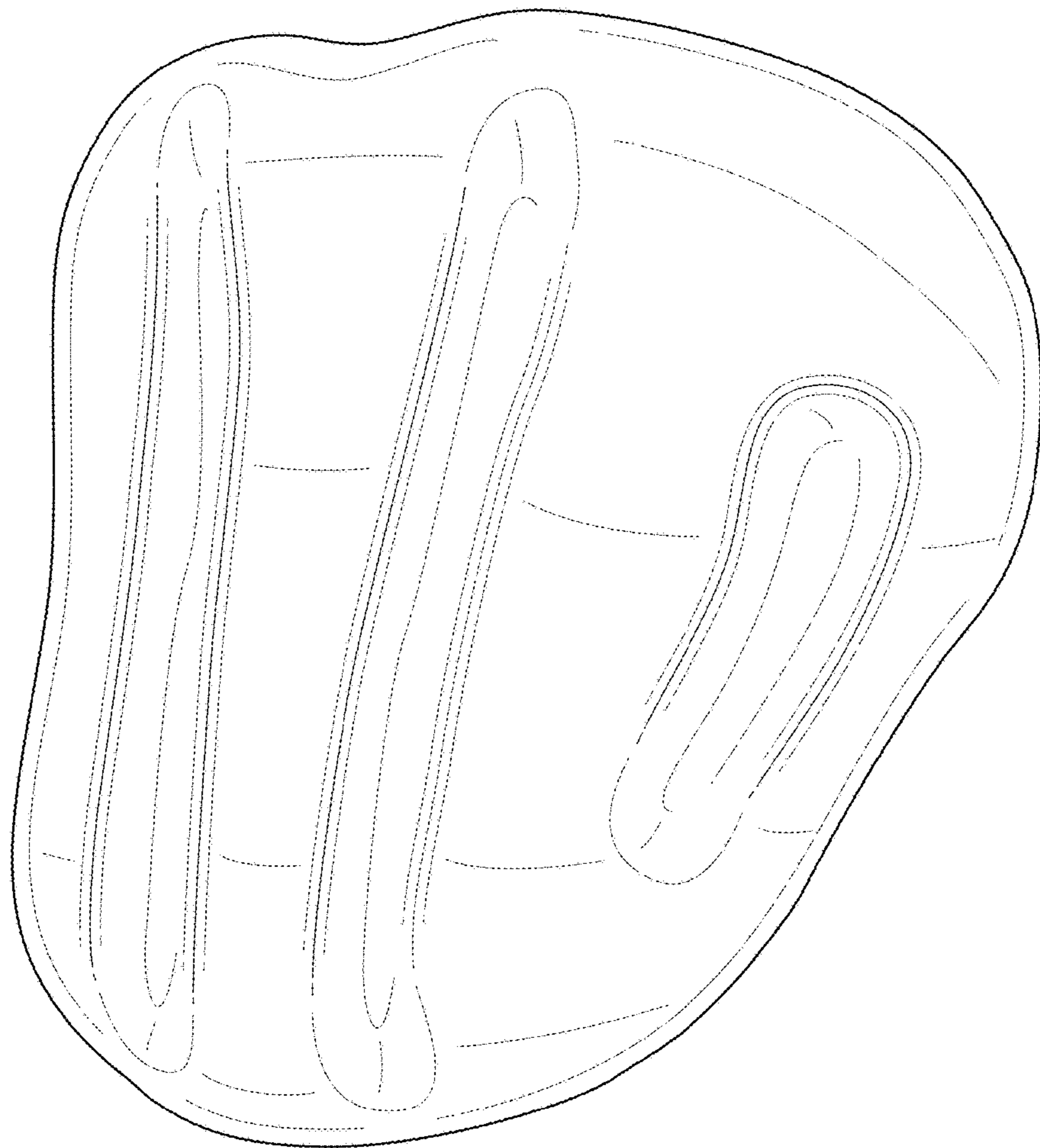

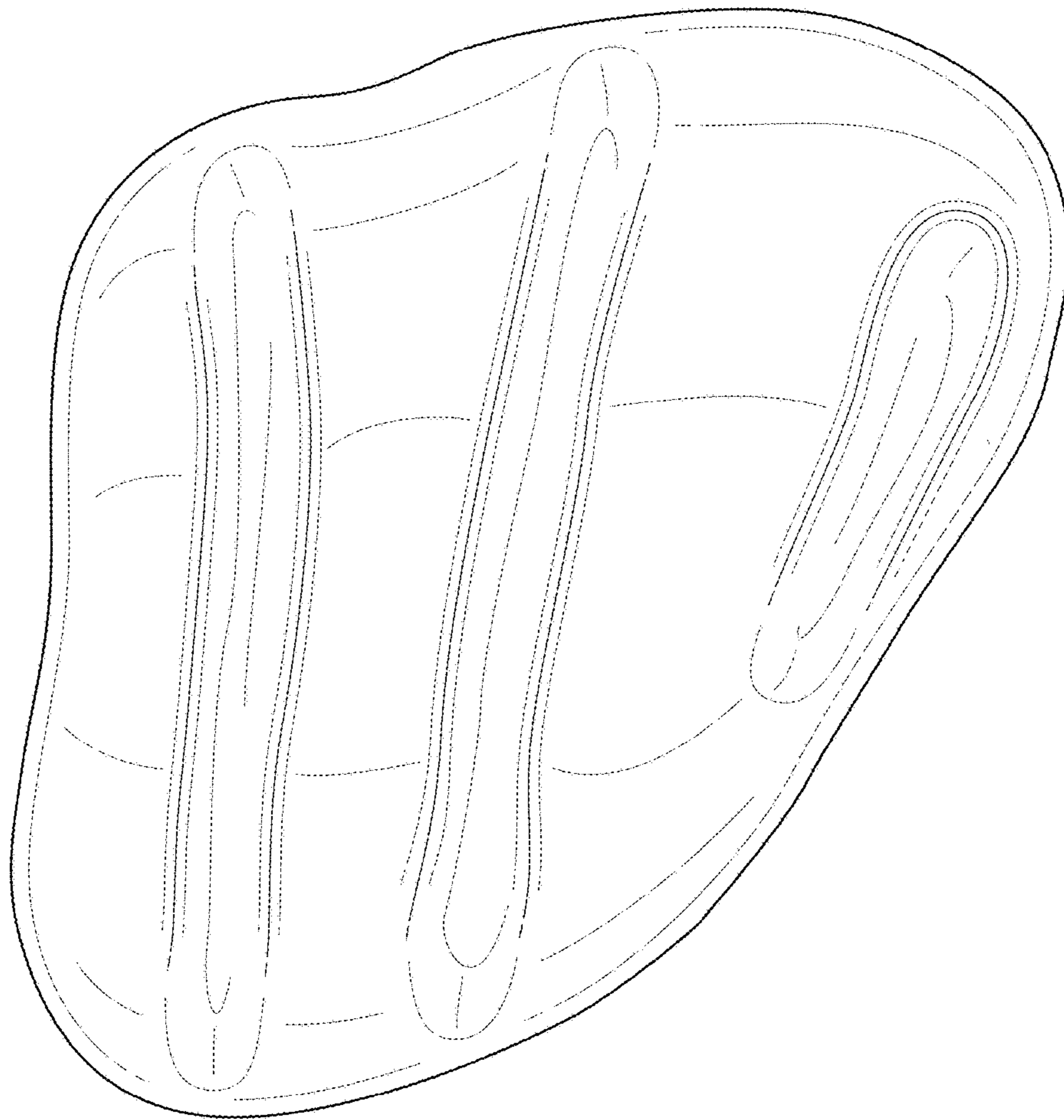

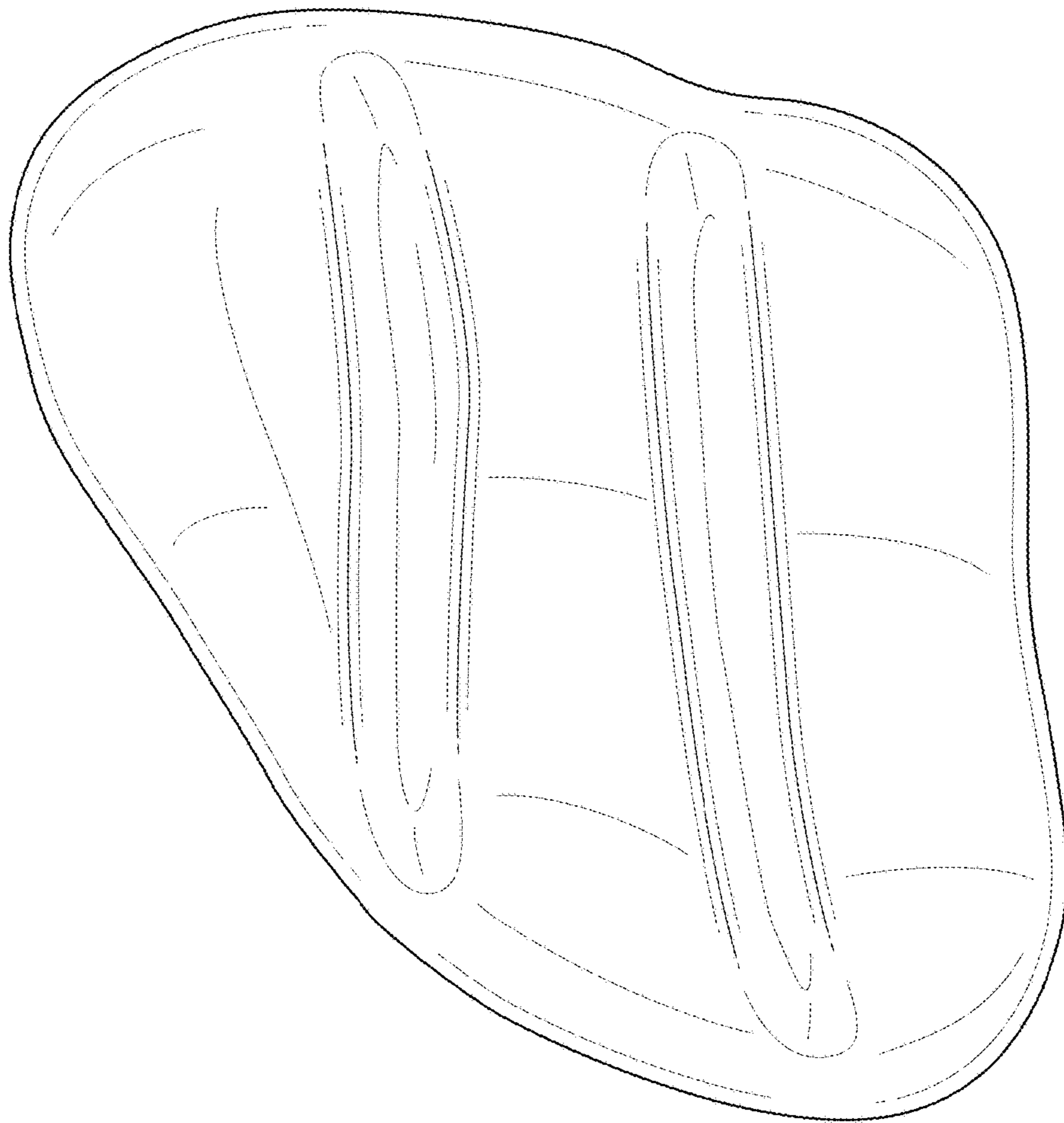

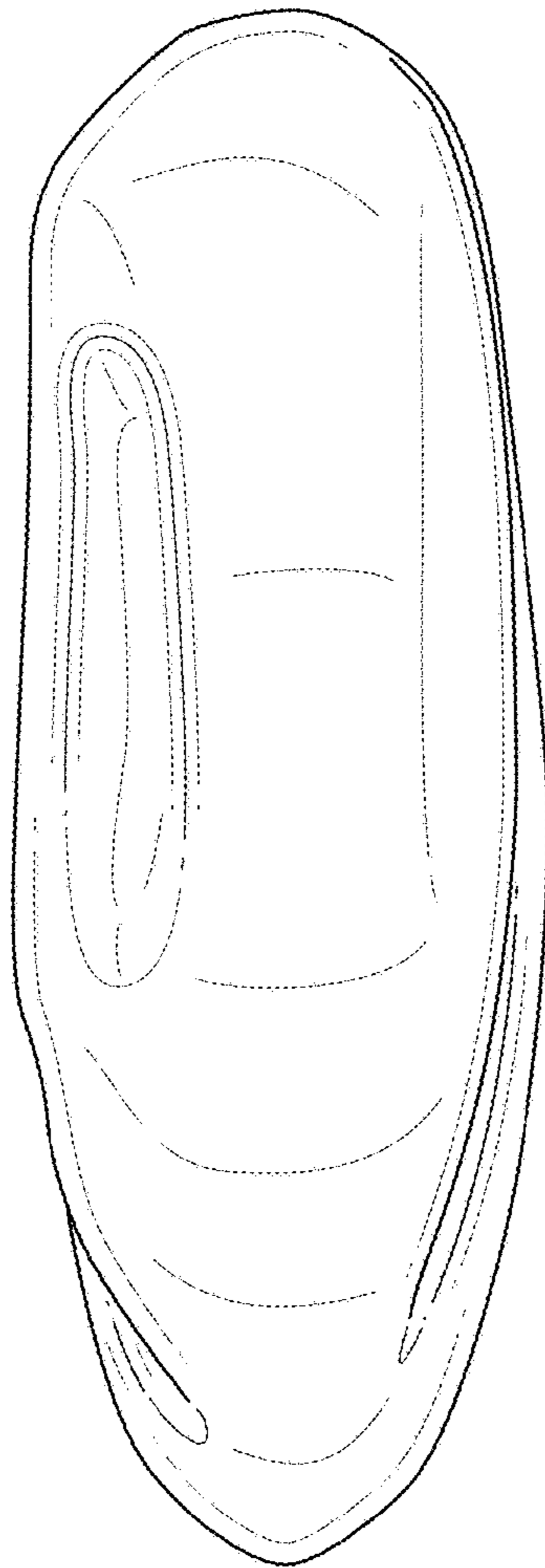

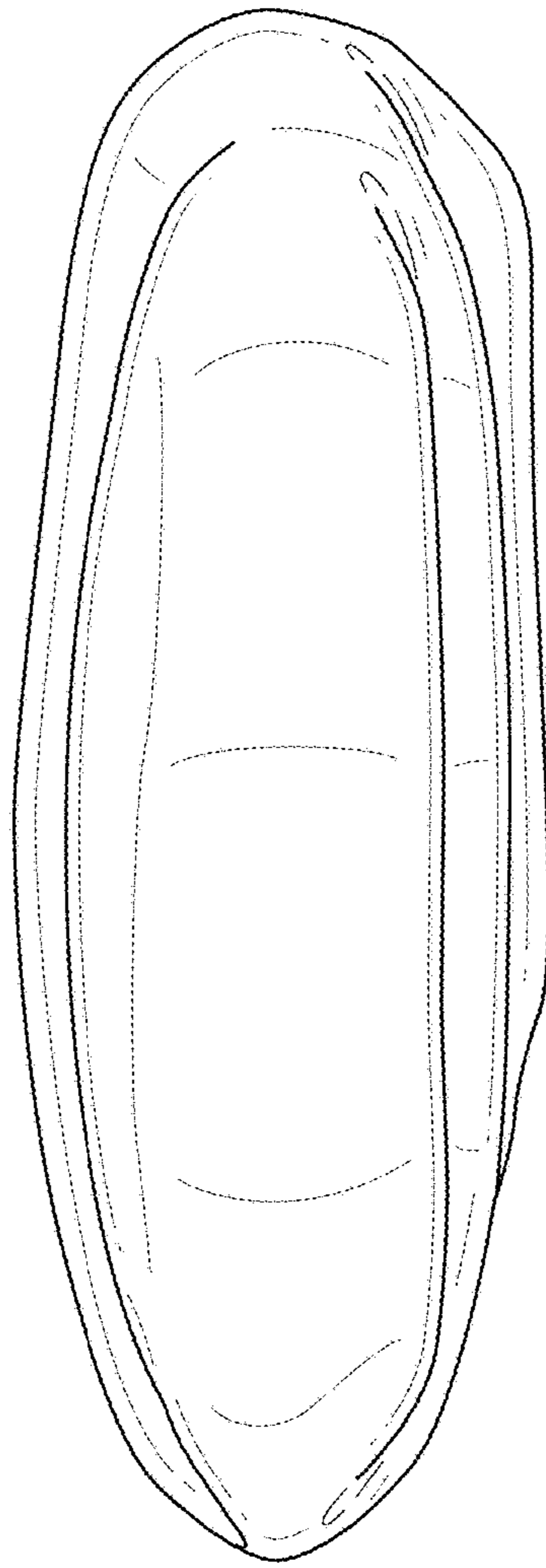

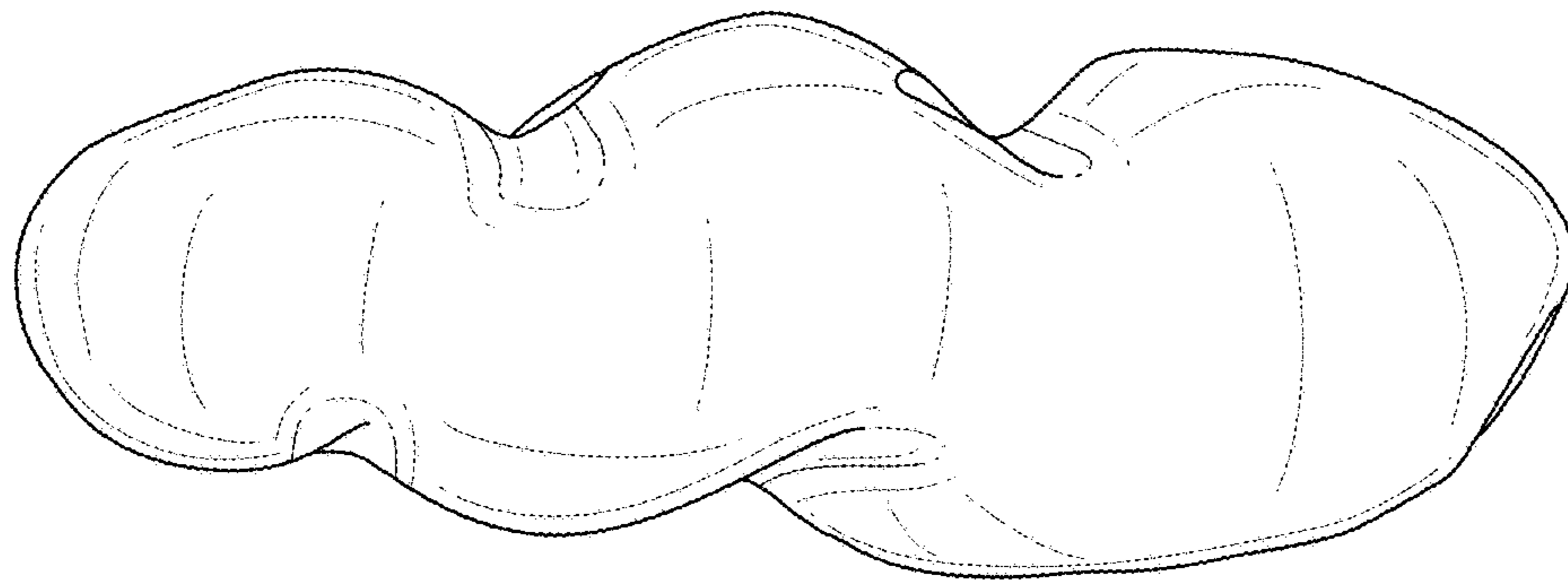

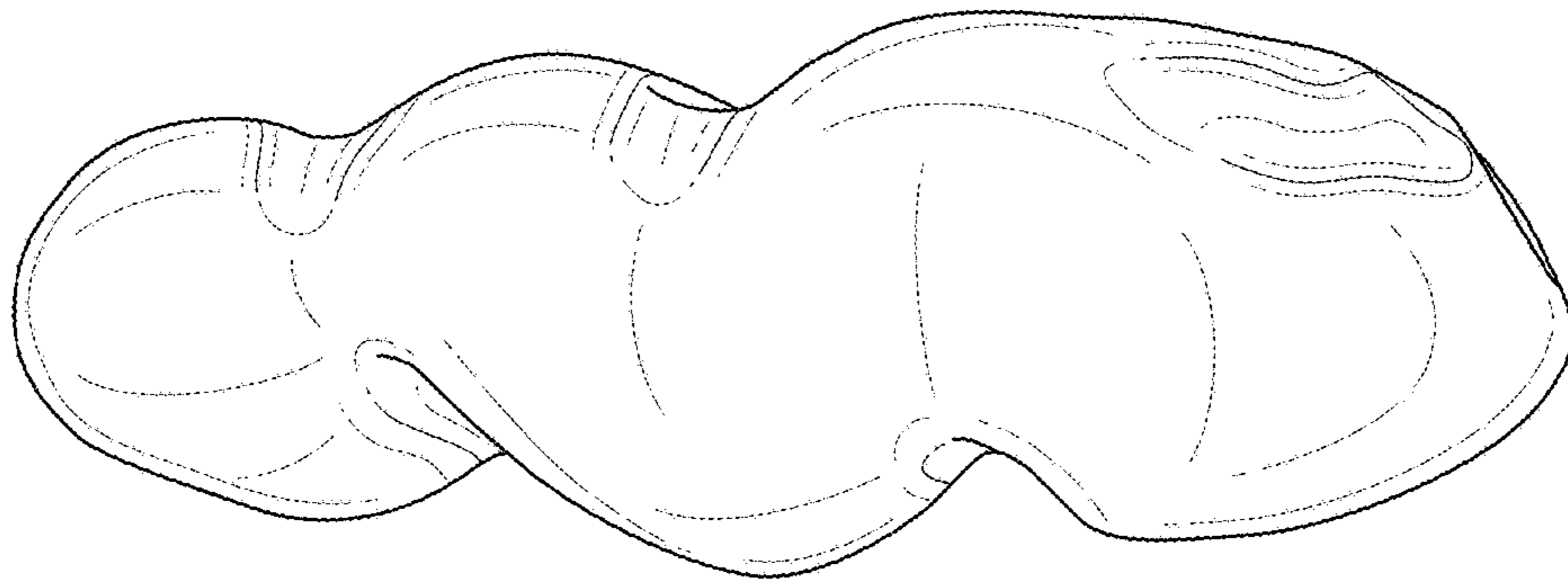
