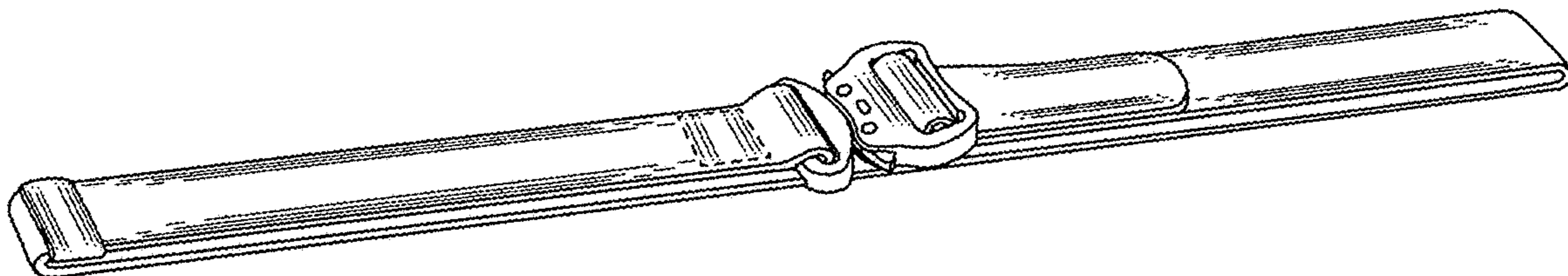
(57) **CLAIM**

I claim the ornamental design for a lap strap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a lap strap showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a perspective view thereof, shown in an alternate, open configuration.
The broken lines represent stitching and form a part of the claimed design.

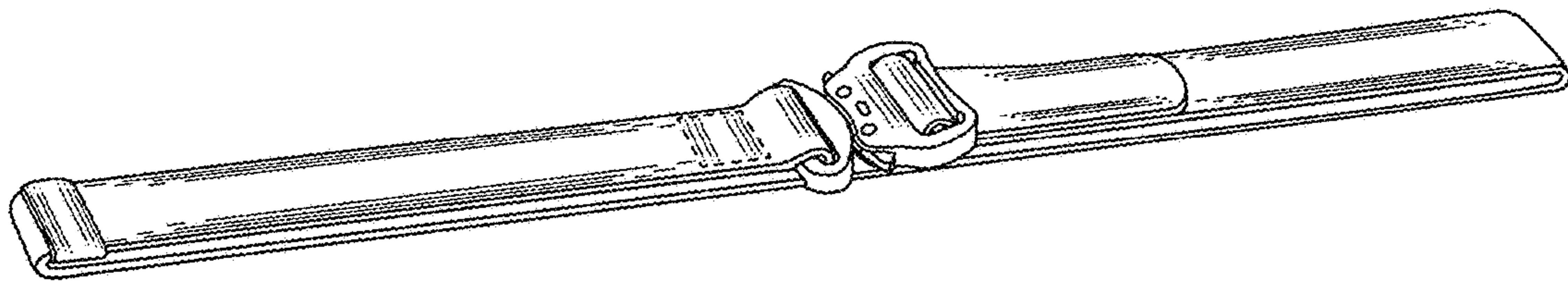

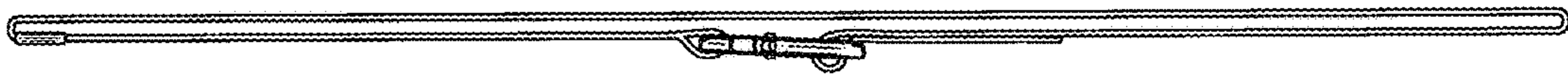

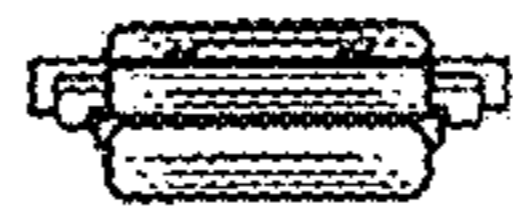

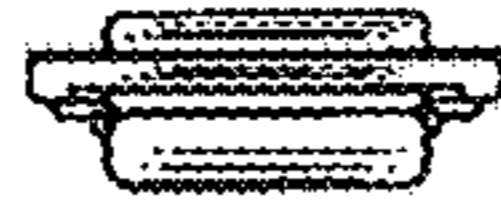

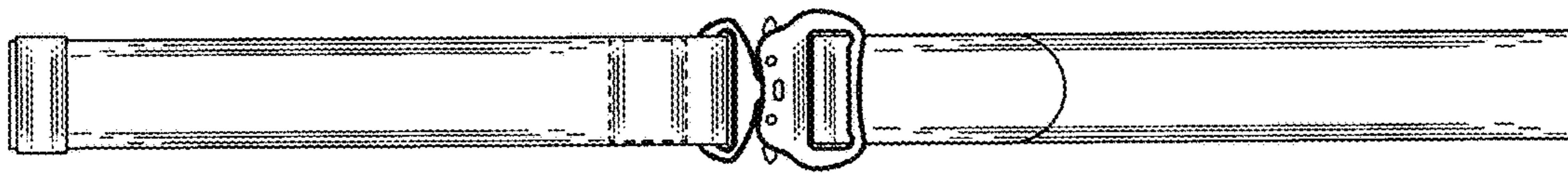

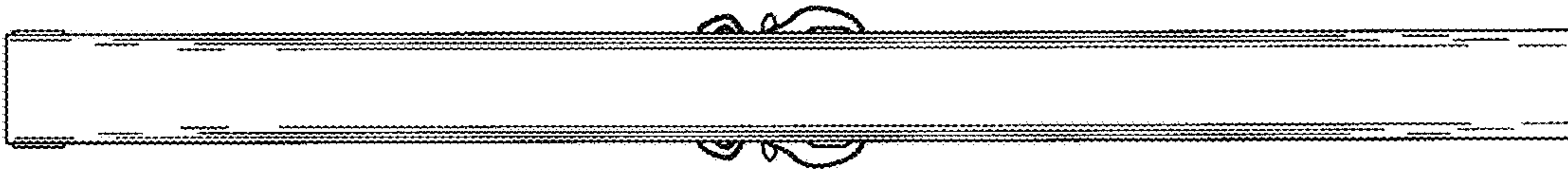

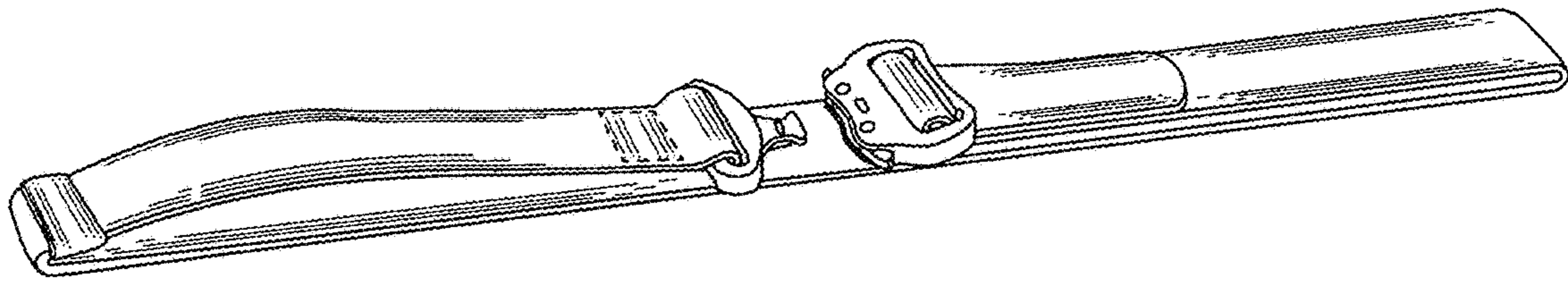
