DESCRIPTION

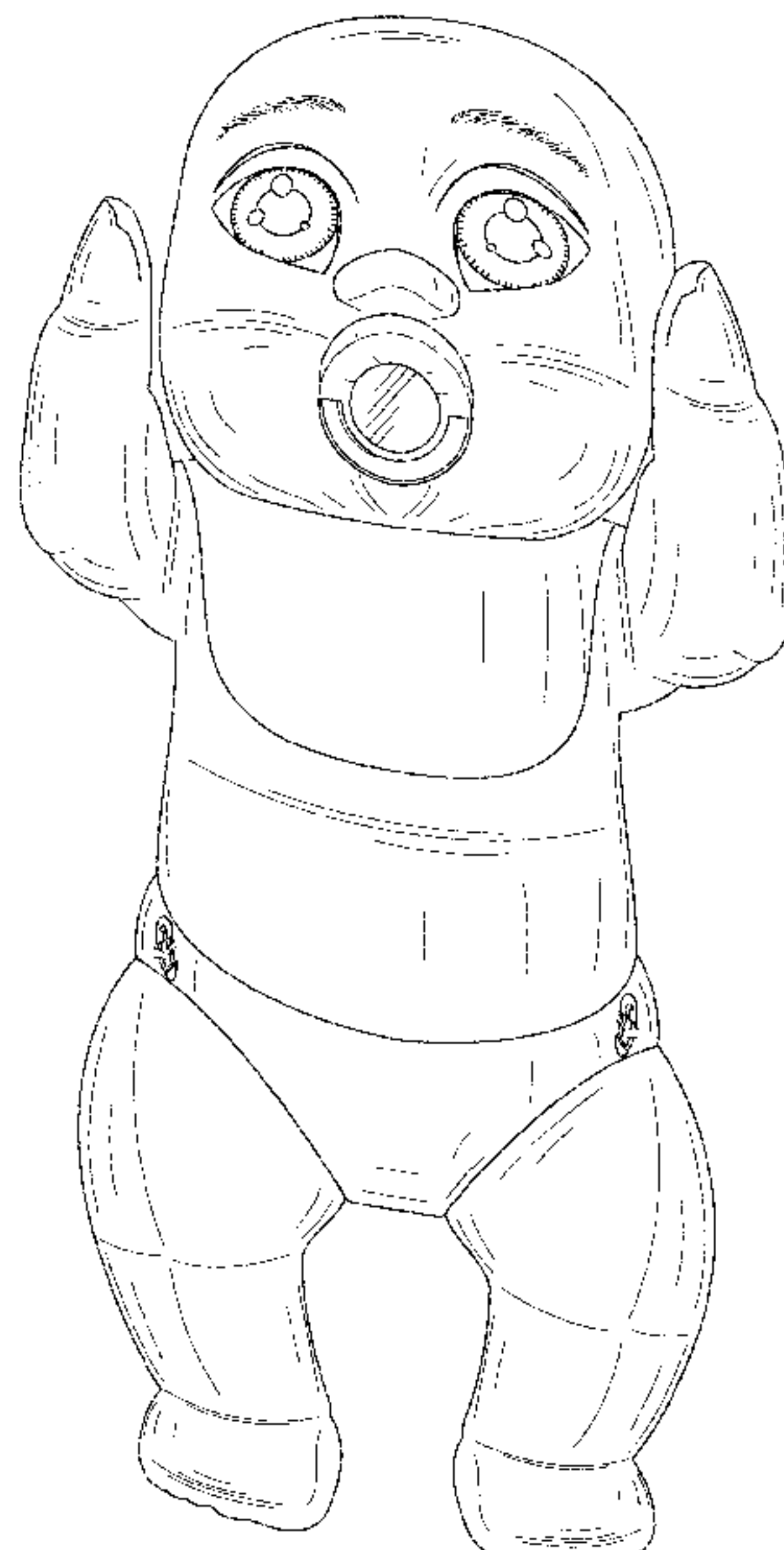
FIG. 1 is a front perspective view of an inflatable baby costume according to the present design;

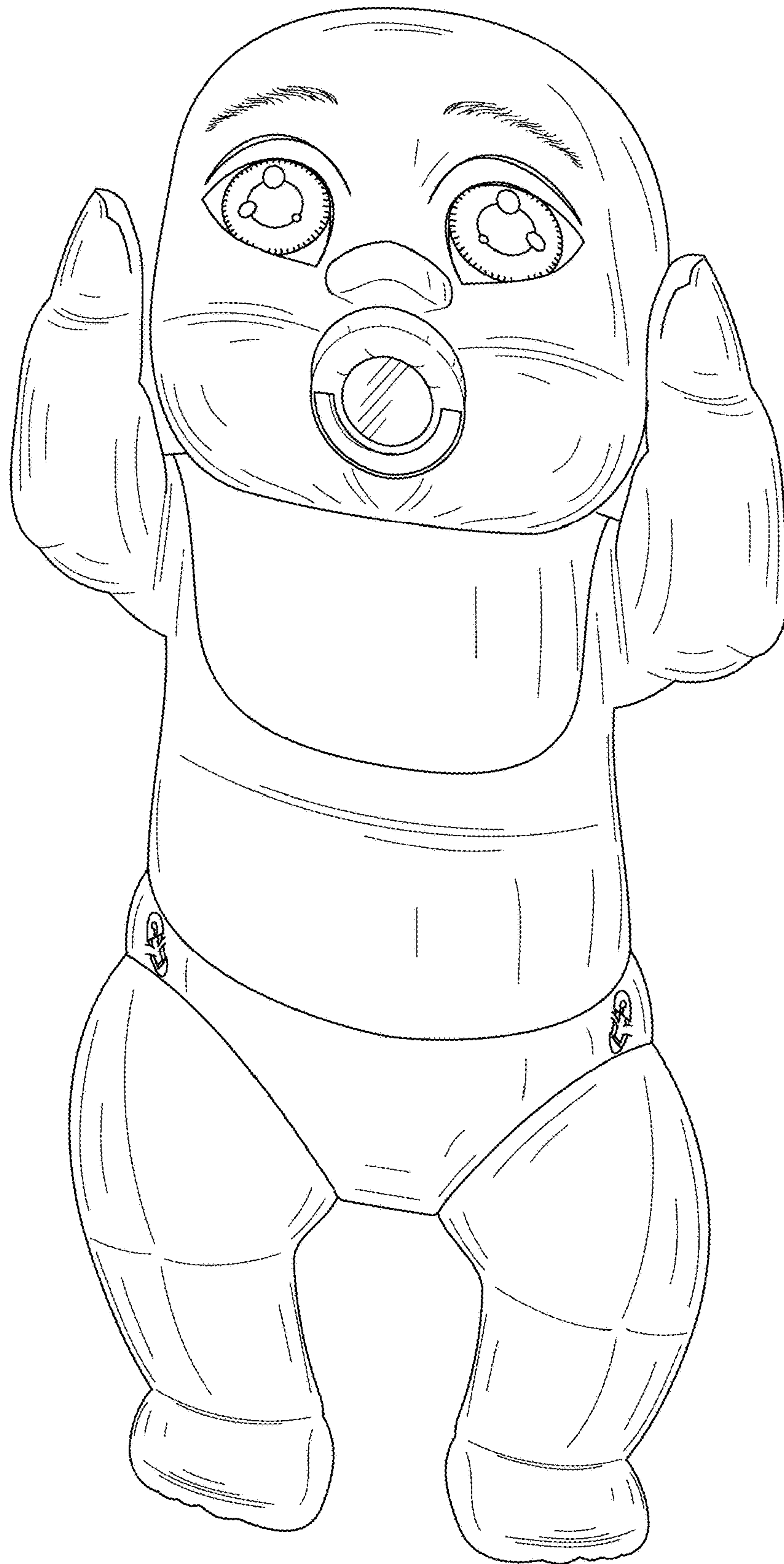

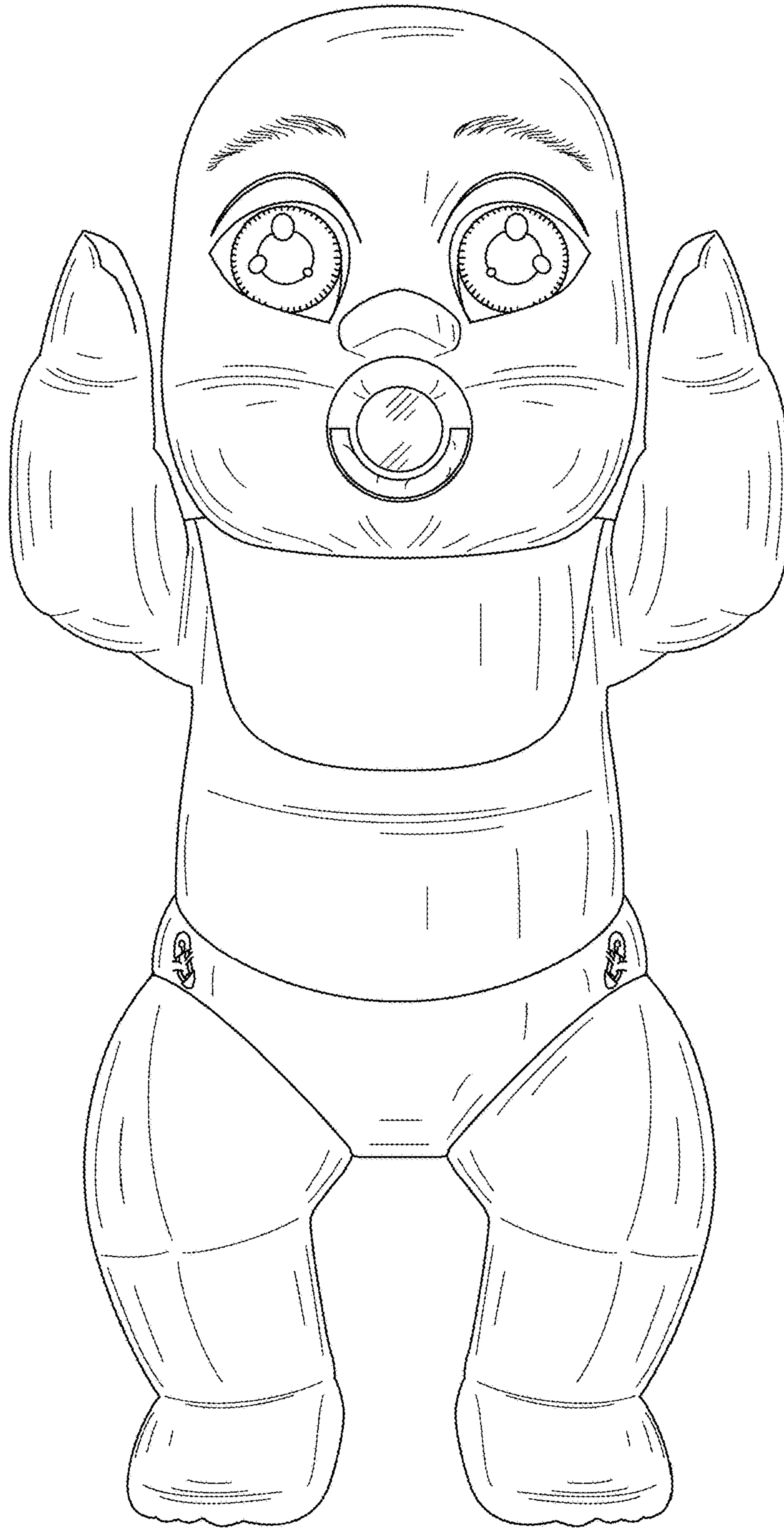

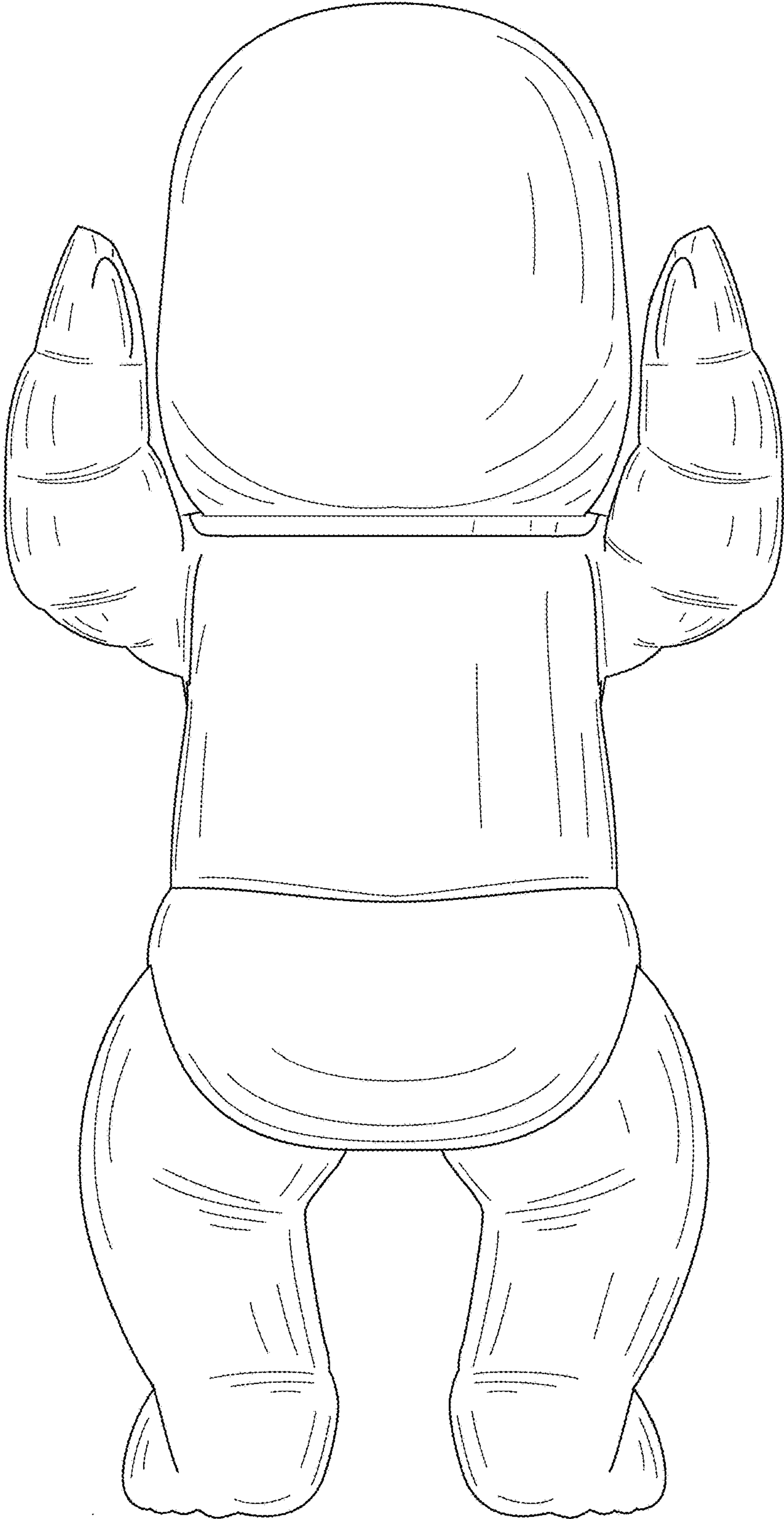

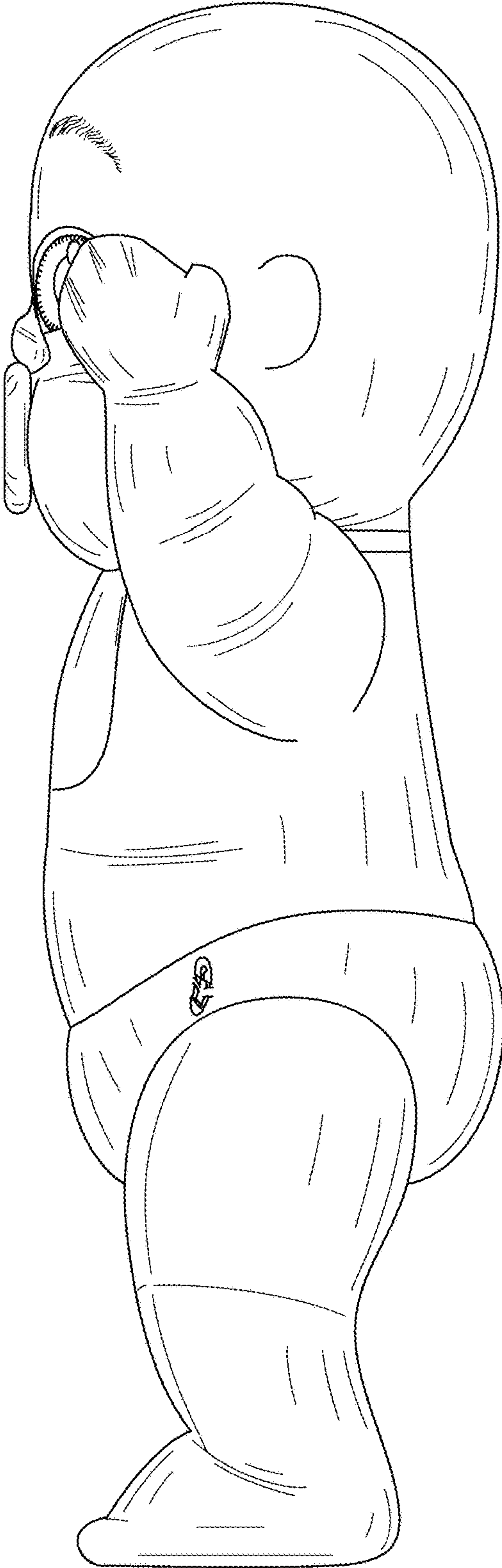

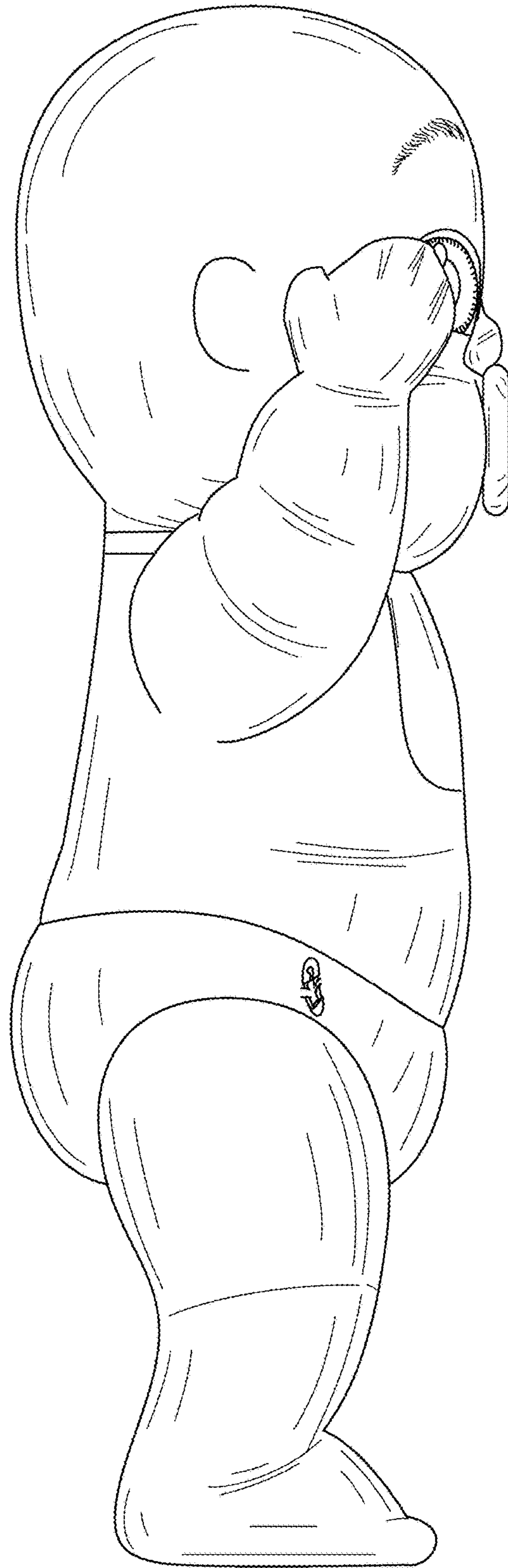

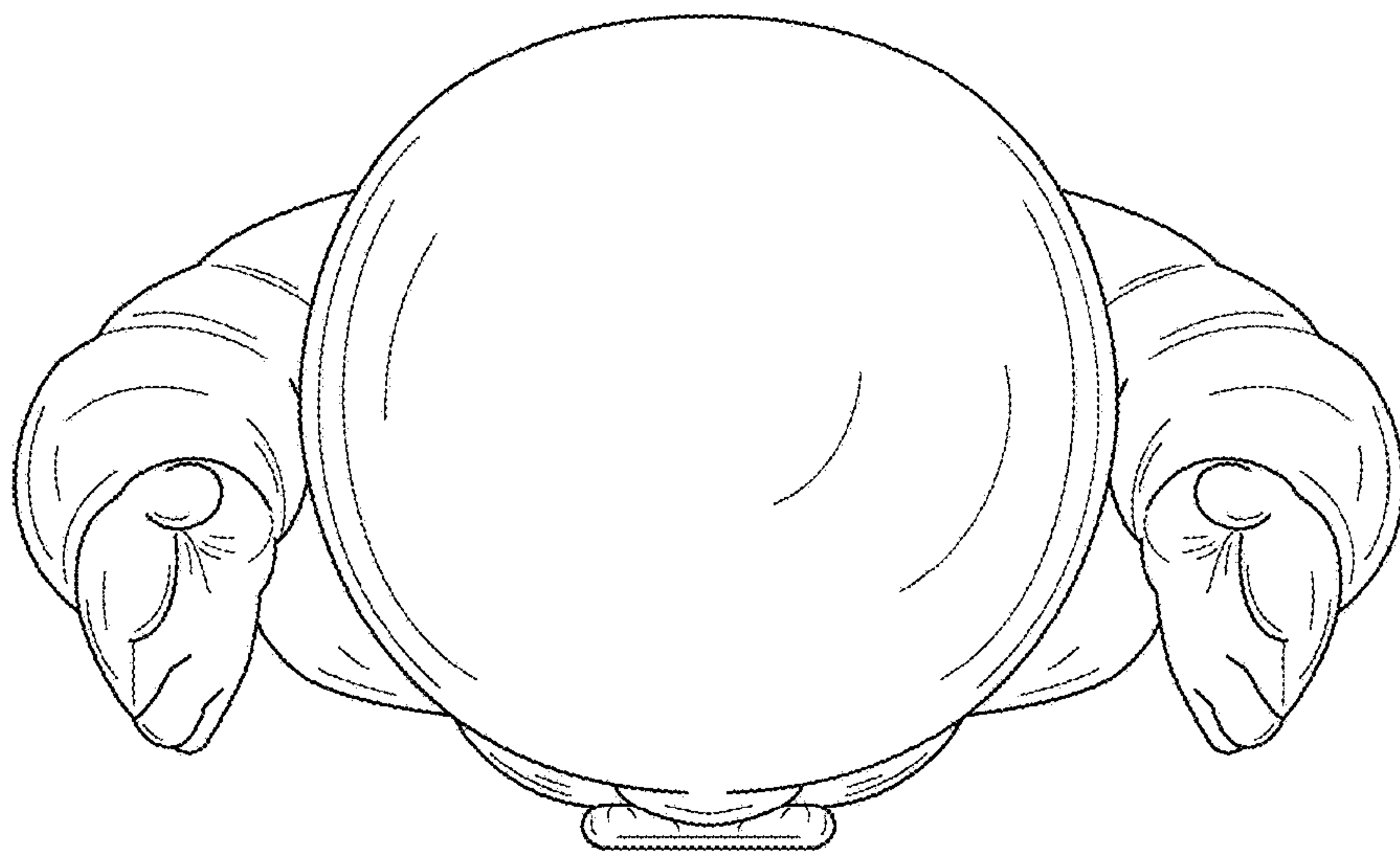

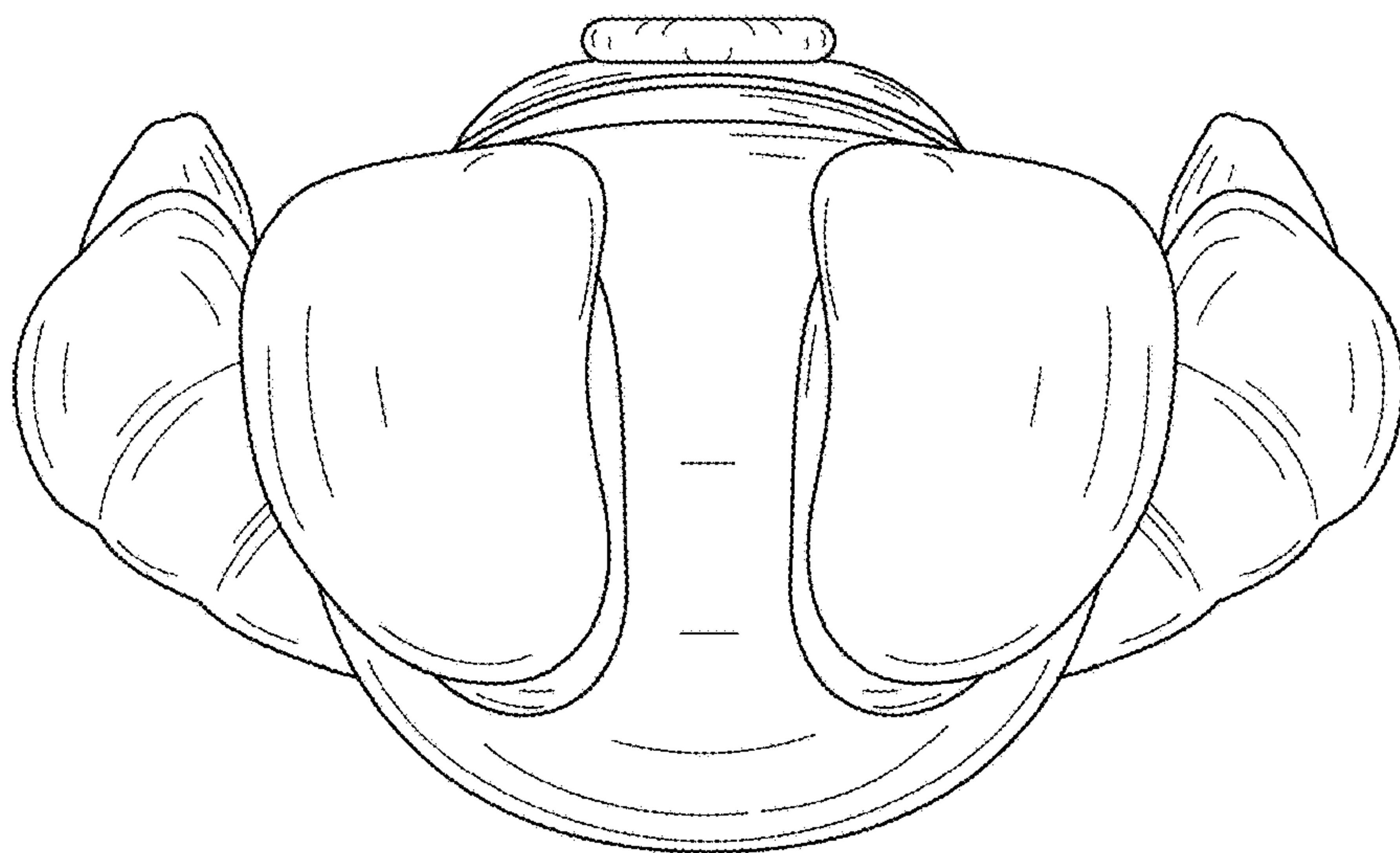
