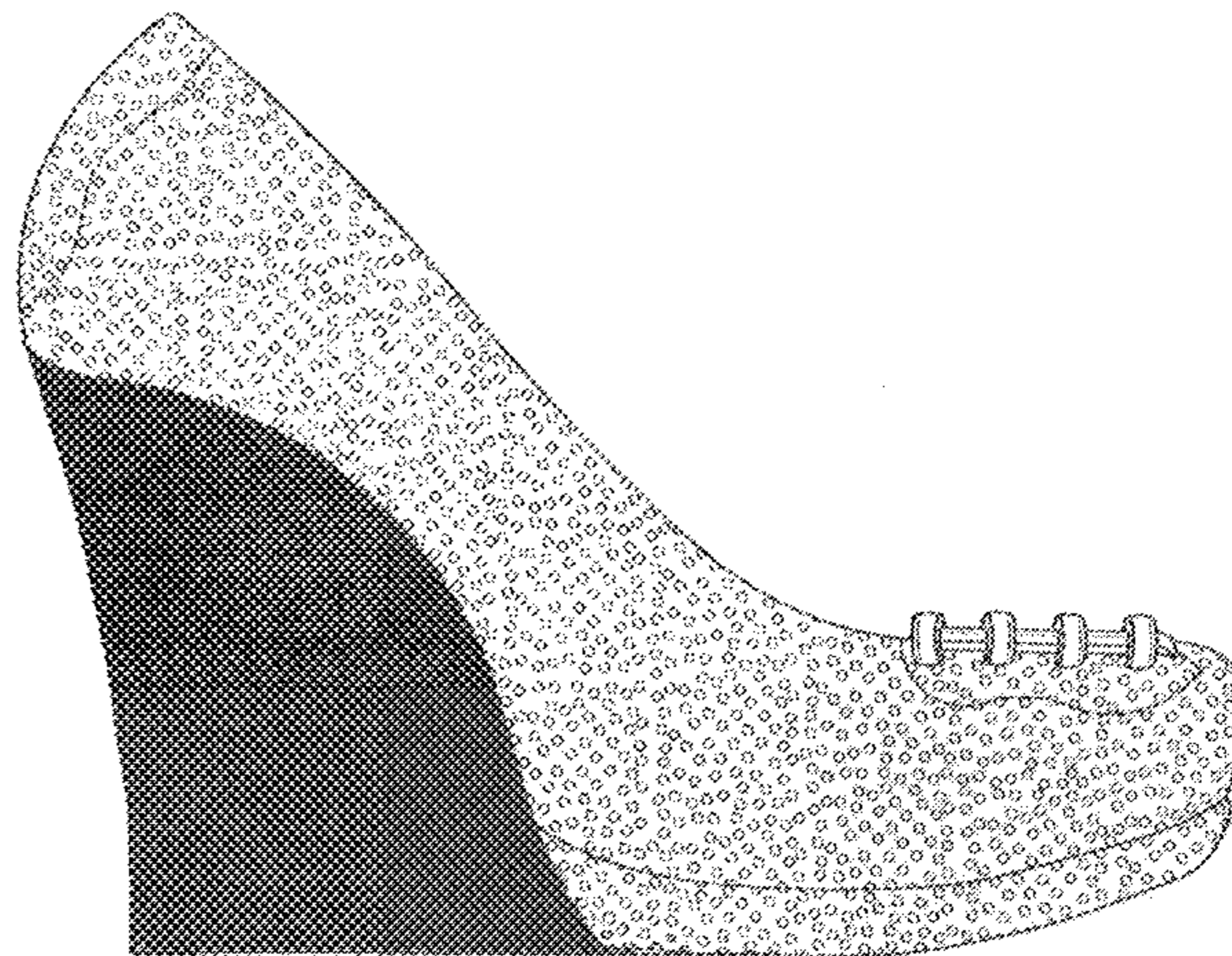
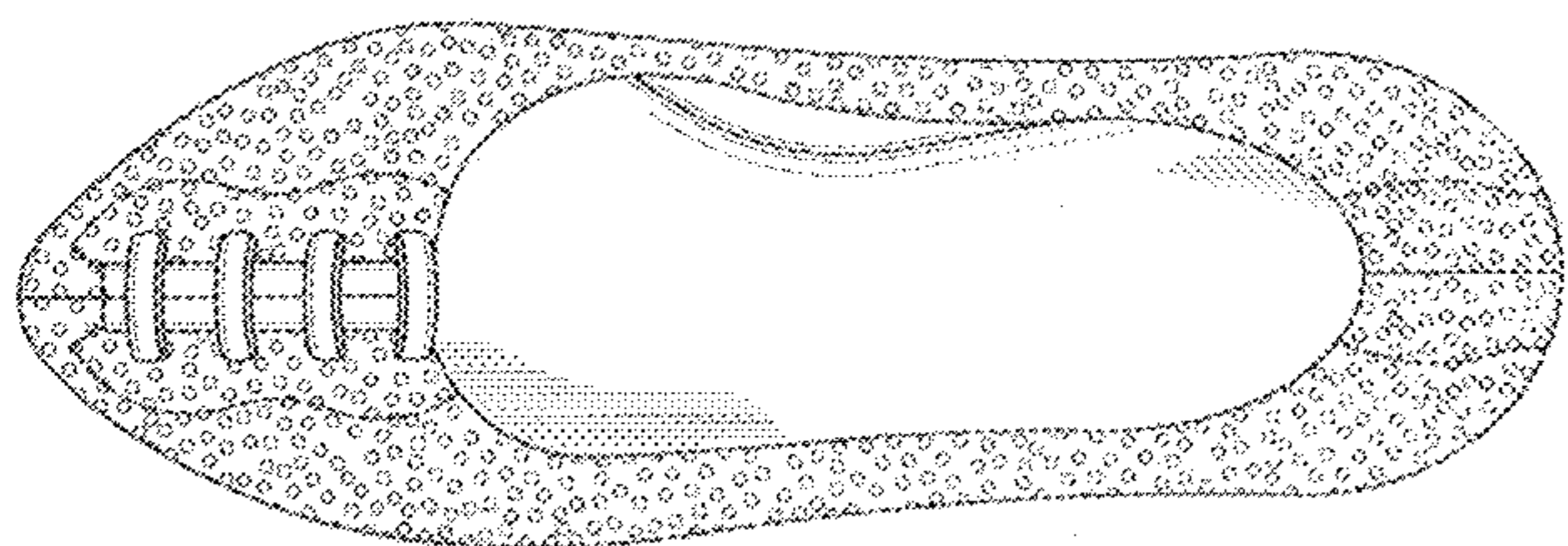
The ornamental design for a football wedge shoe, as shown.

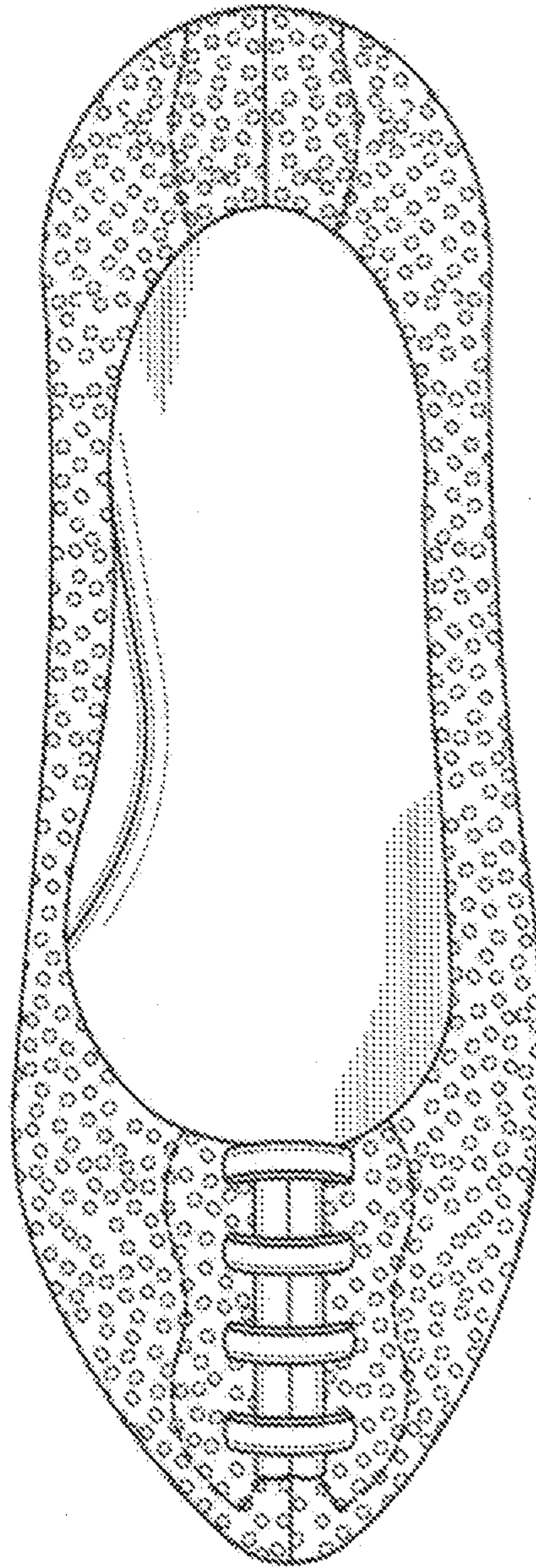

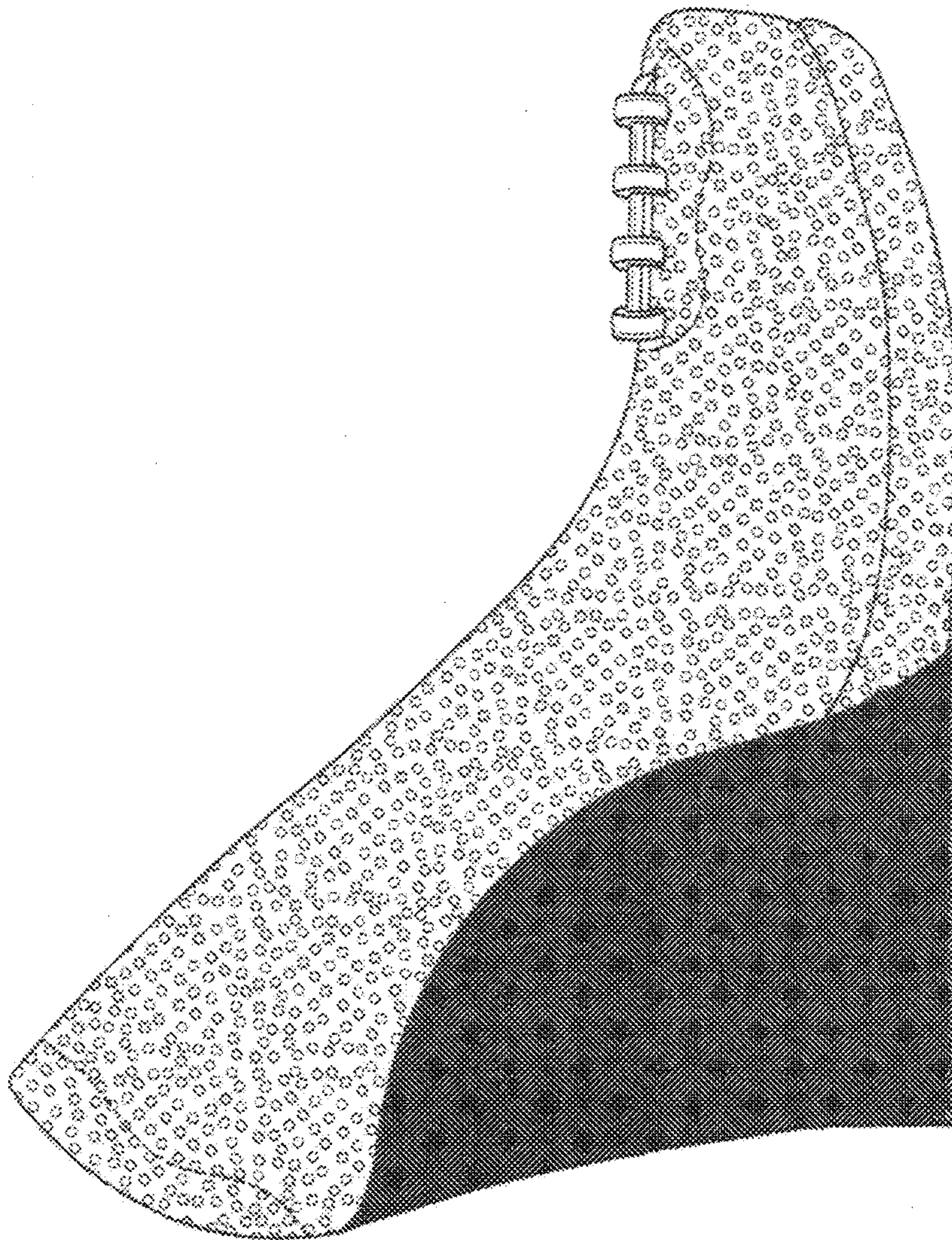

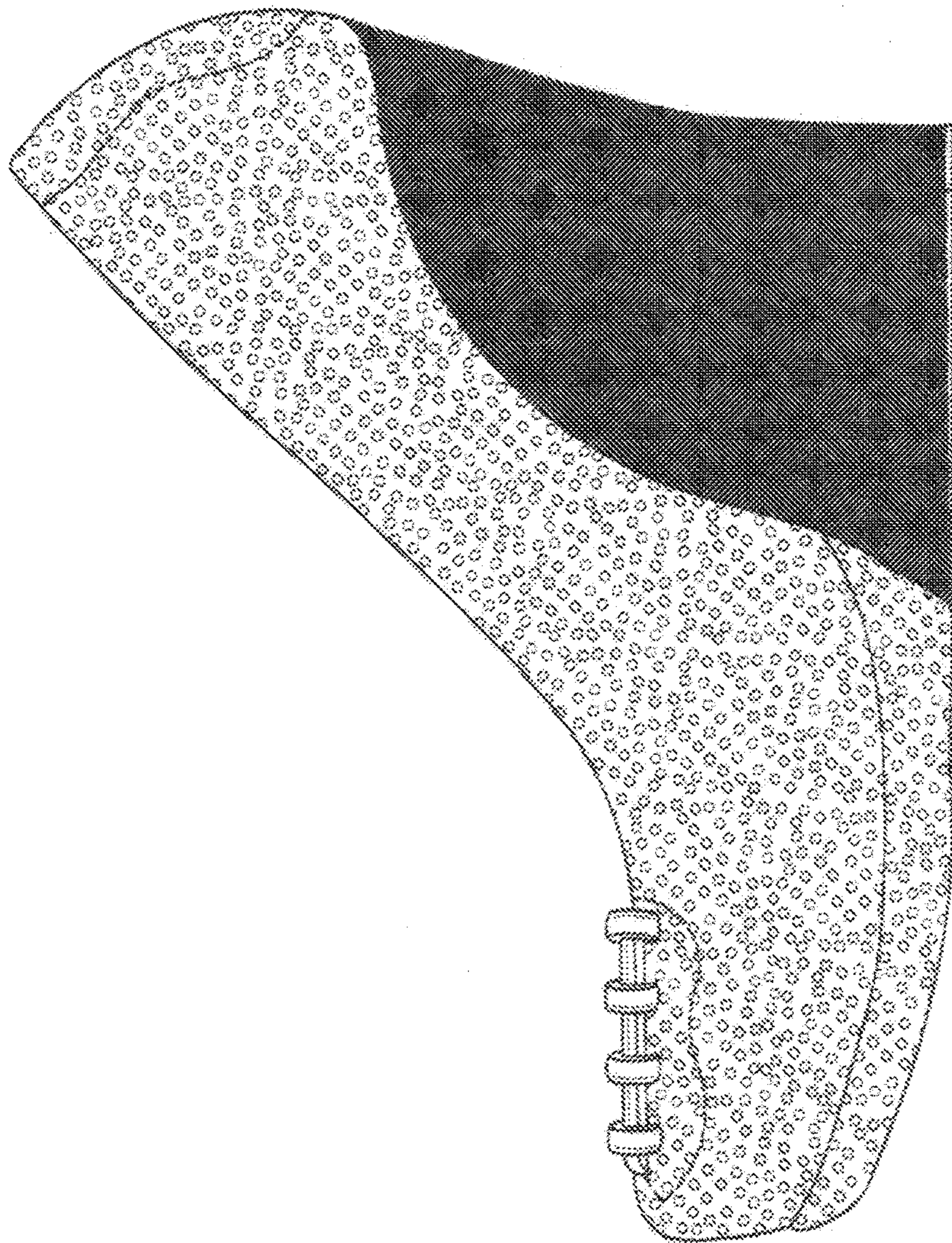

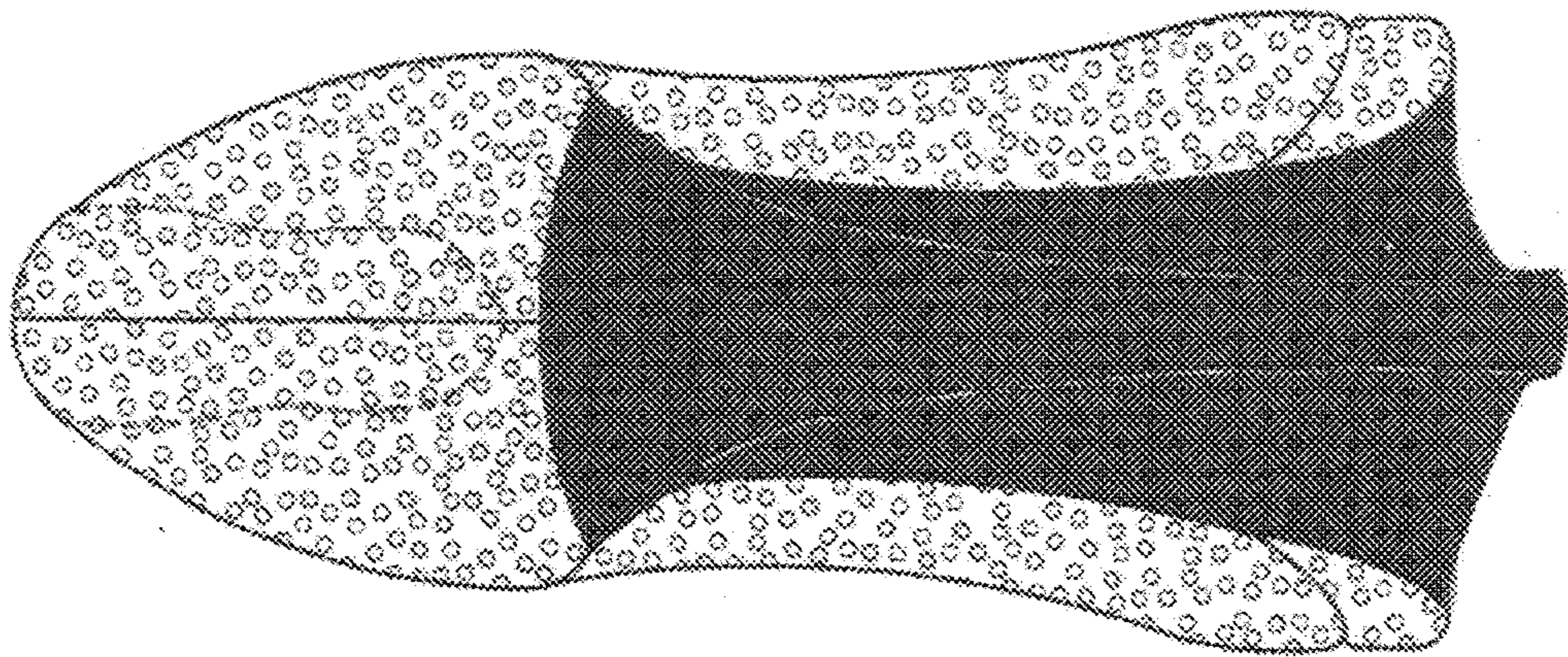
