The ornamental design for a toddler shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a toddler shoe; FIG. 2 is a left side elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; and, FIG. 6 is a top plan view thereof. The broken line showing of an outsole, laces, and zipper pull is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

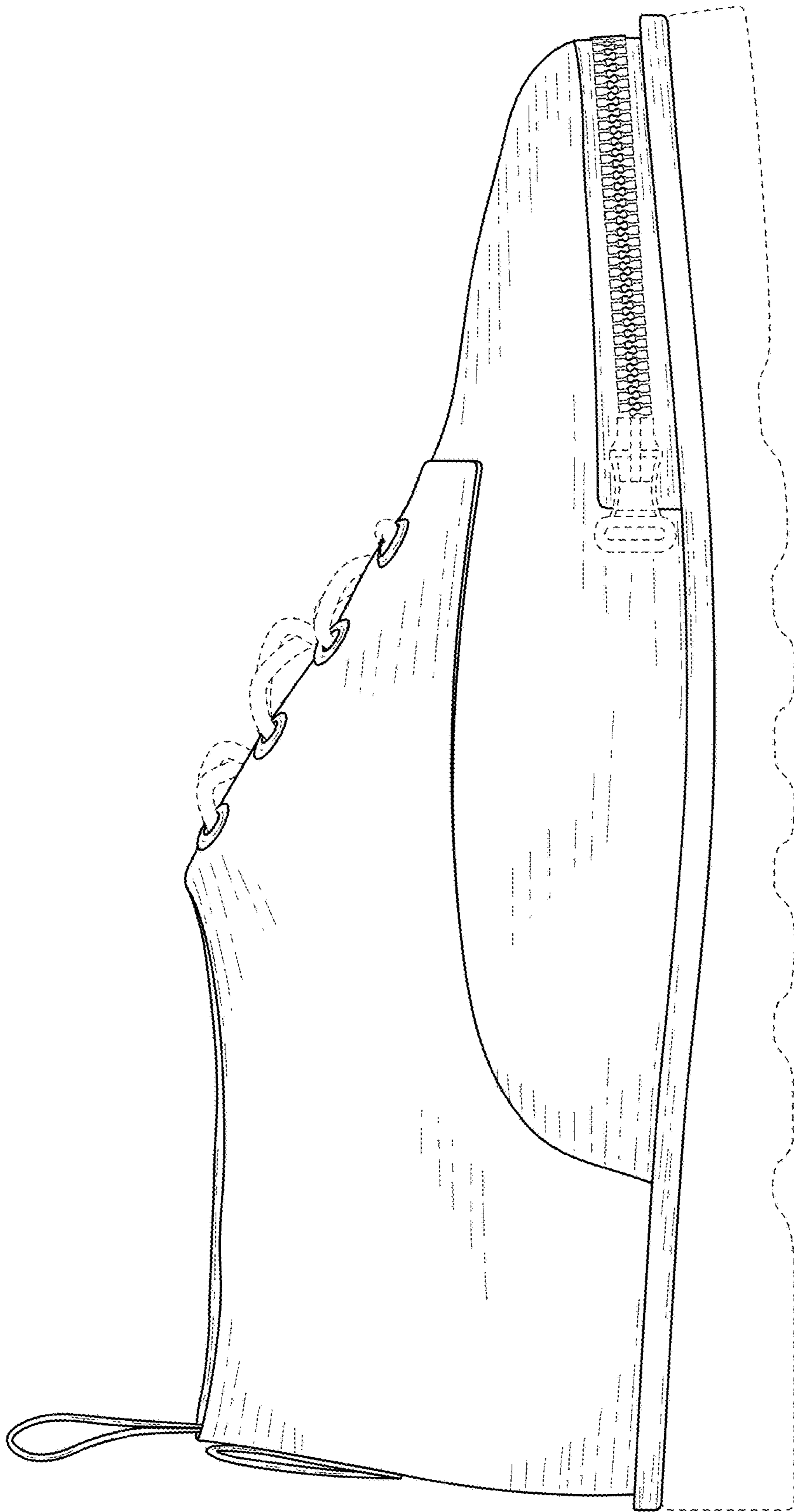

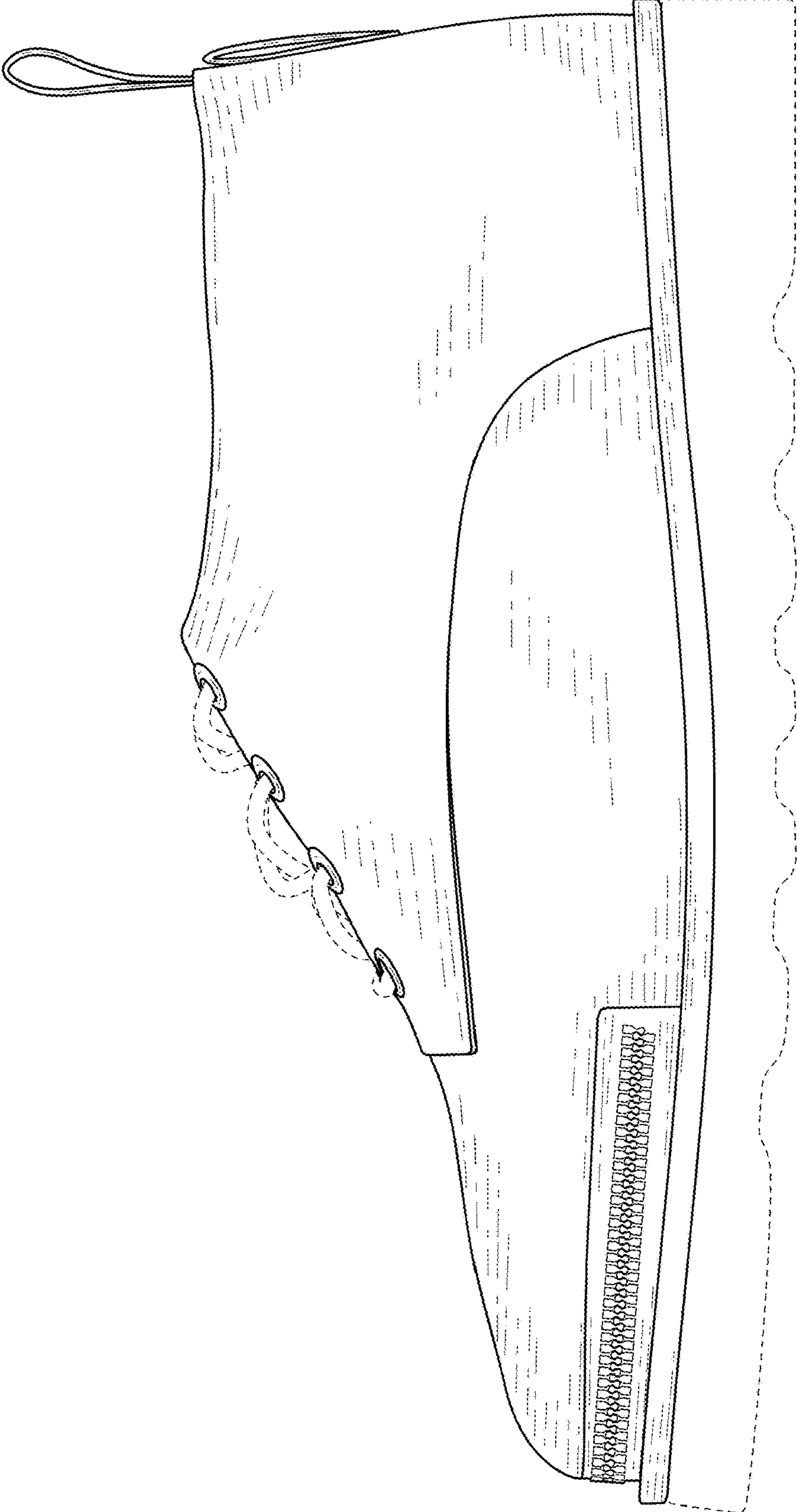

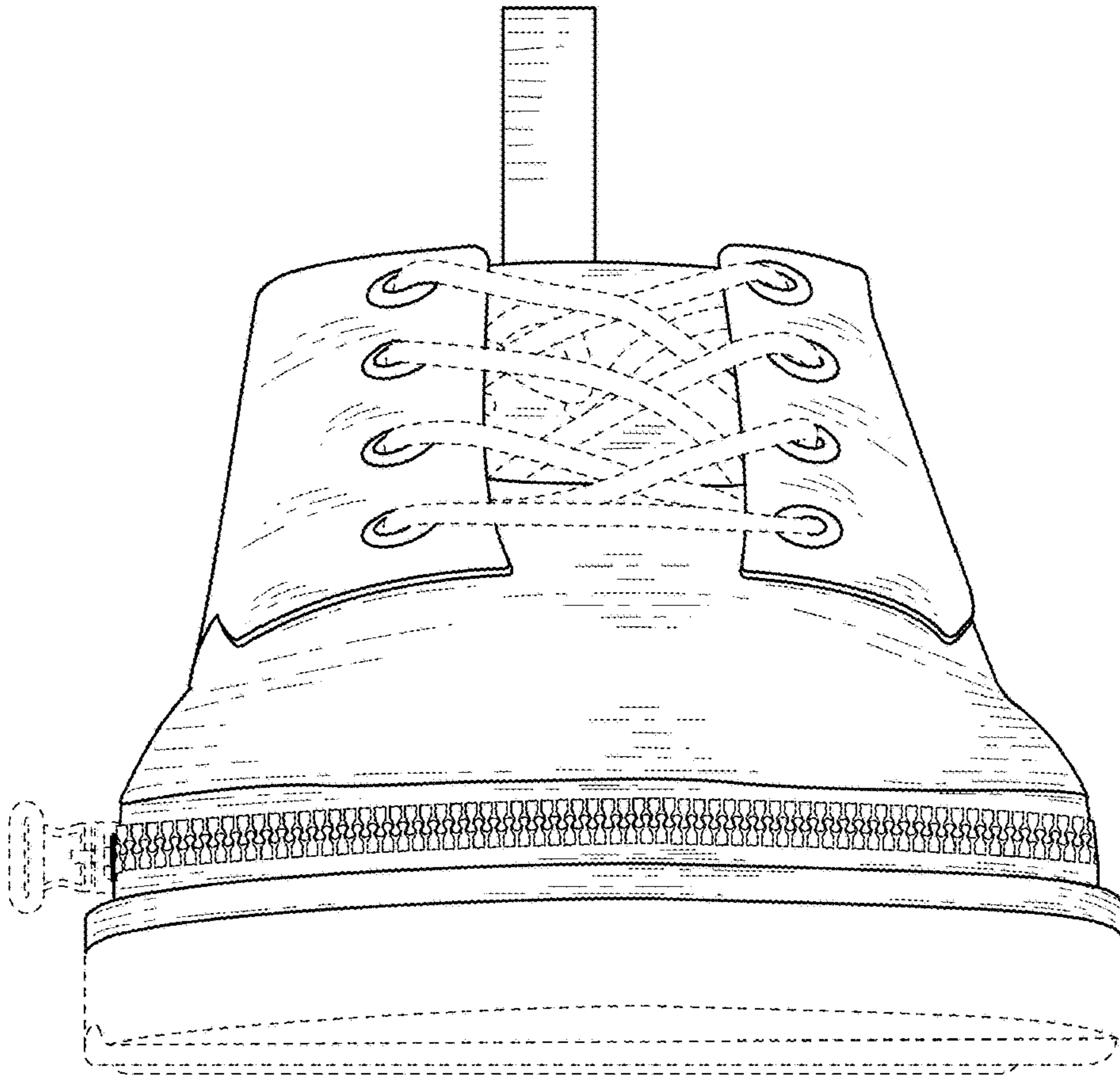

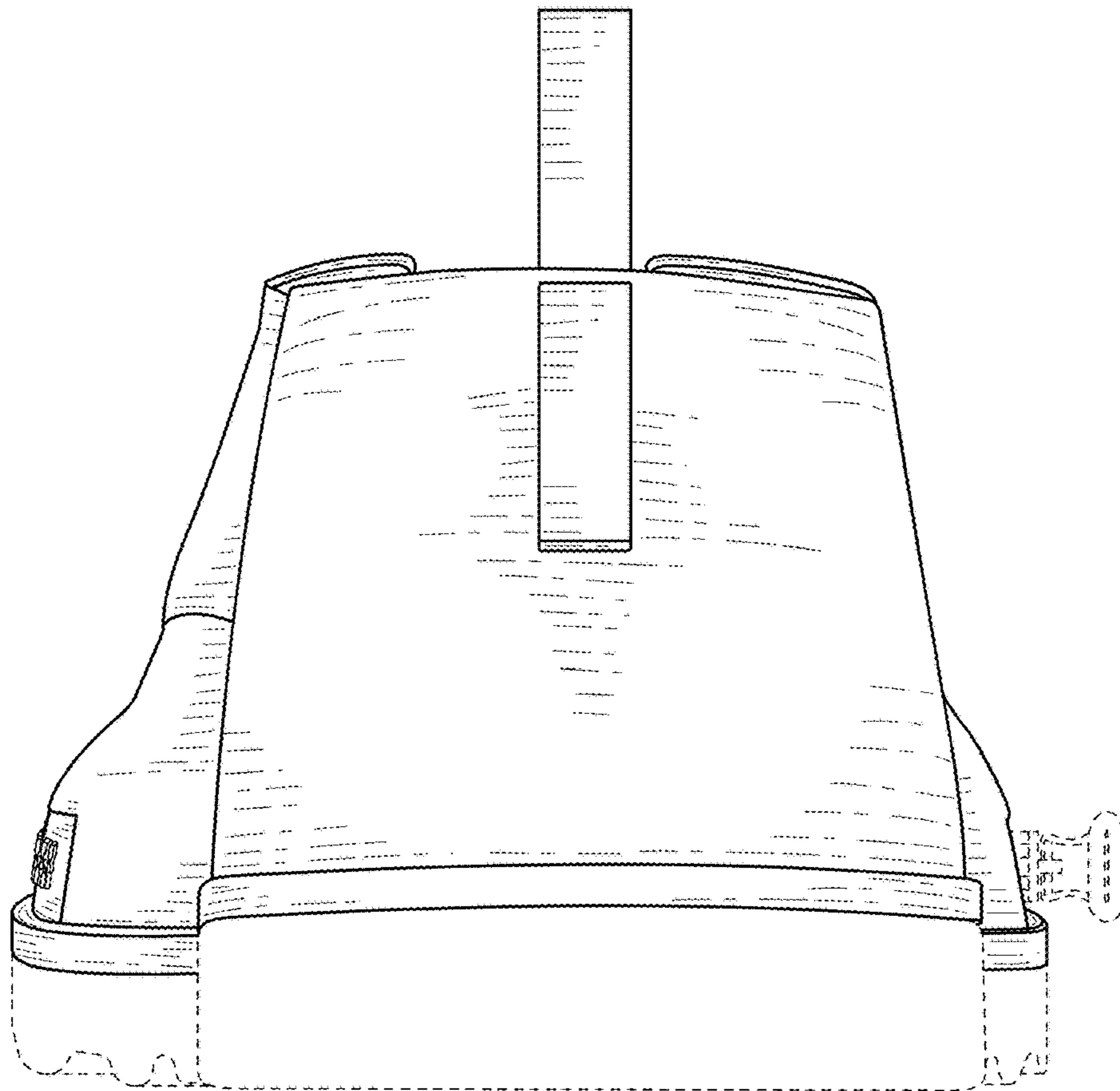

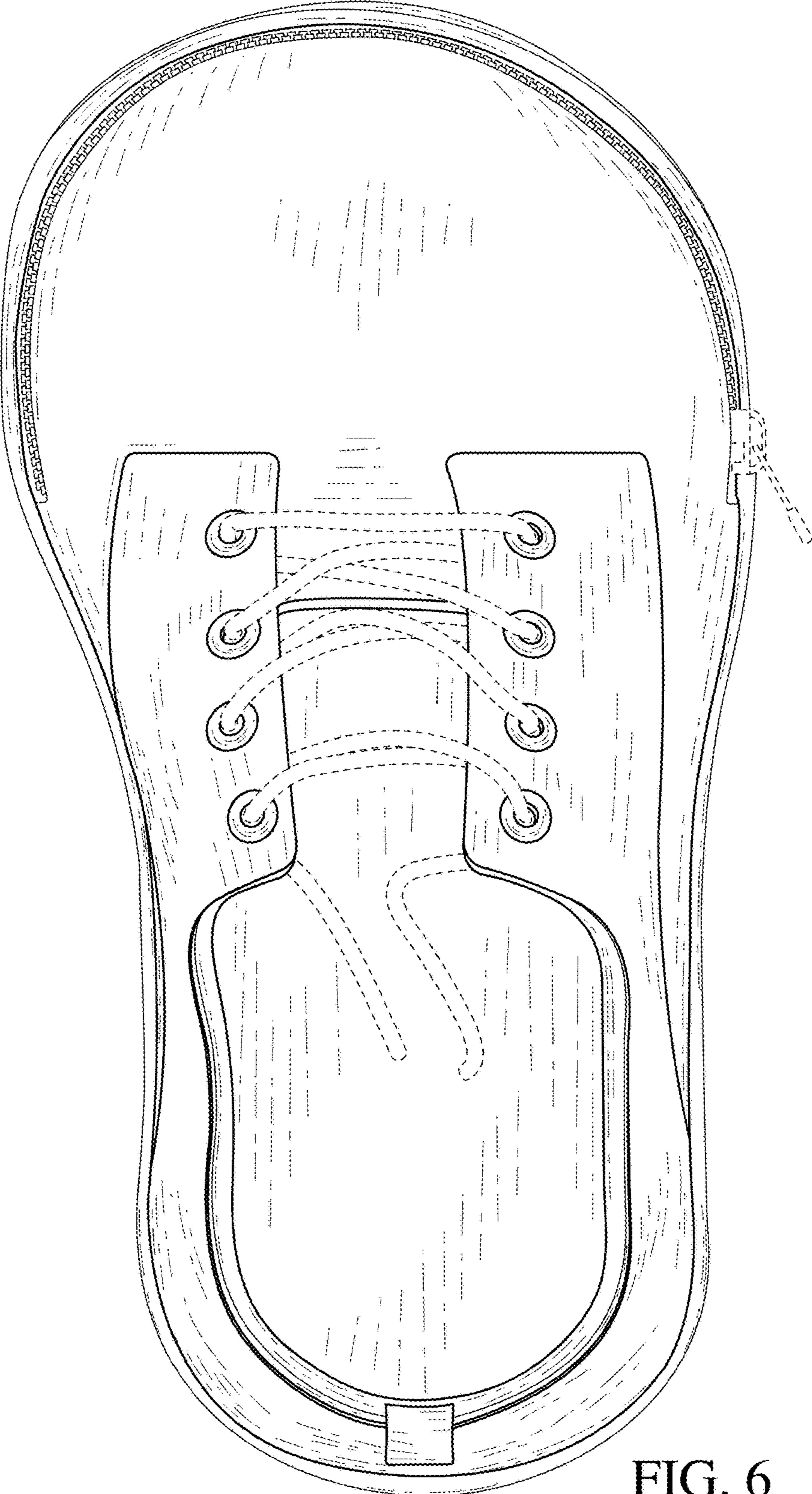
