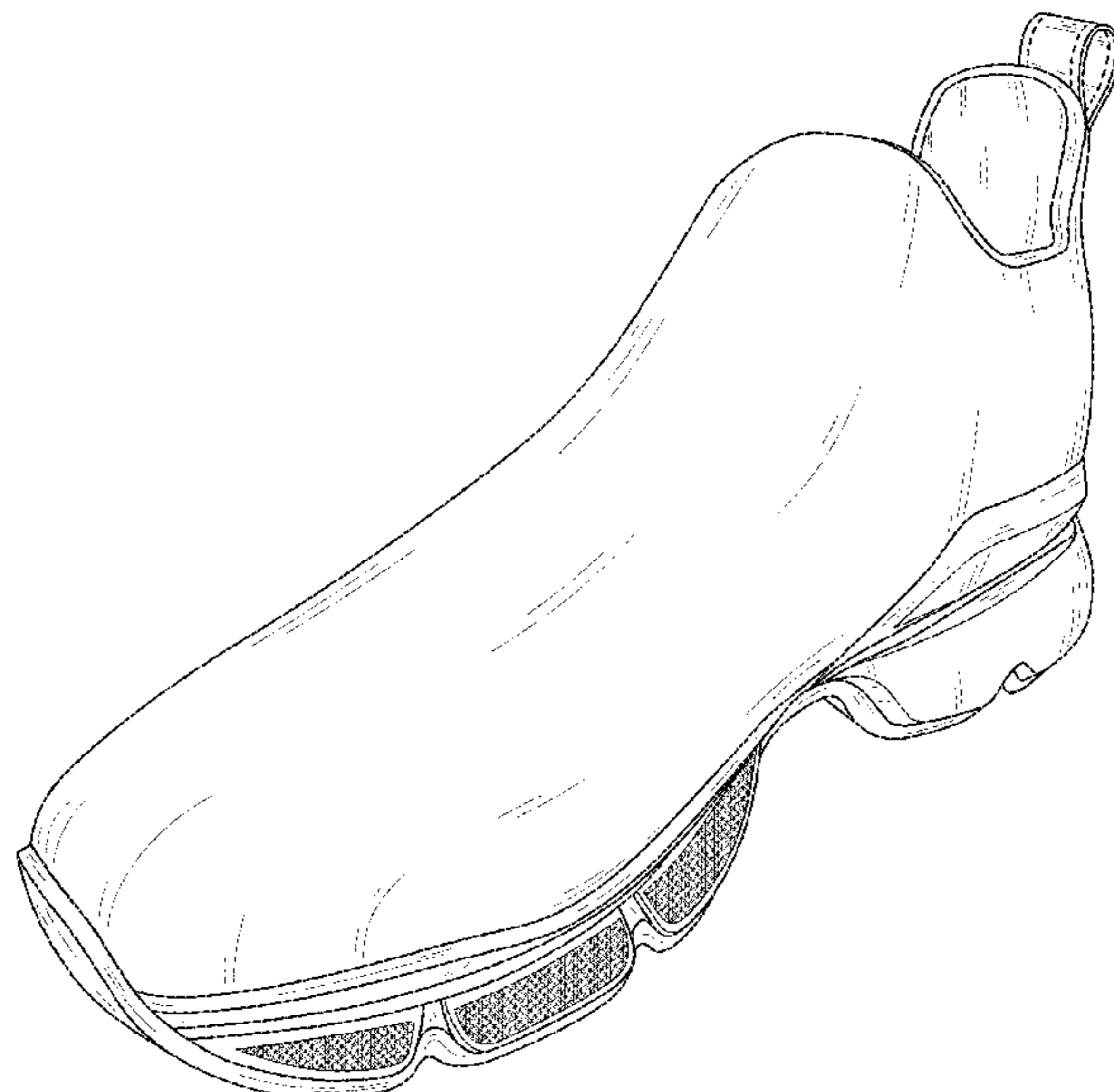
(57) **CLAIM**

The ornamental design for a footwear, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a footwear, showing my new design;  
FIG. 2 is a front view of the footwear shown in FIG. 1;  
FIG. 3 is a rear view of the footwear shown in FIG. 1;  
FIG. 4 is a right side view of the footwear shown in FIG. 1;  
FIG. 5 is a left side view of the footwear shown in FIG. 1;  
FIG. 6 is a top view of the footwear shown in FIG. 1; and,  
FIG. 7 is a bottom view of the footwear shown in FIG. 1.  
The broken lines in the drawings illustrate stitching.  
The dense cross-hatched shading in the drawings reflect a tactile surface texture in this area of the footwear.  
It is to be understood that the design also encompasses the footwear upper and/or the sole portion separate and apart from any other features.

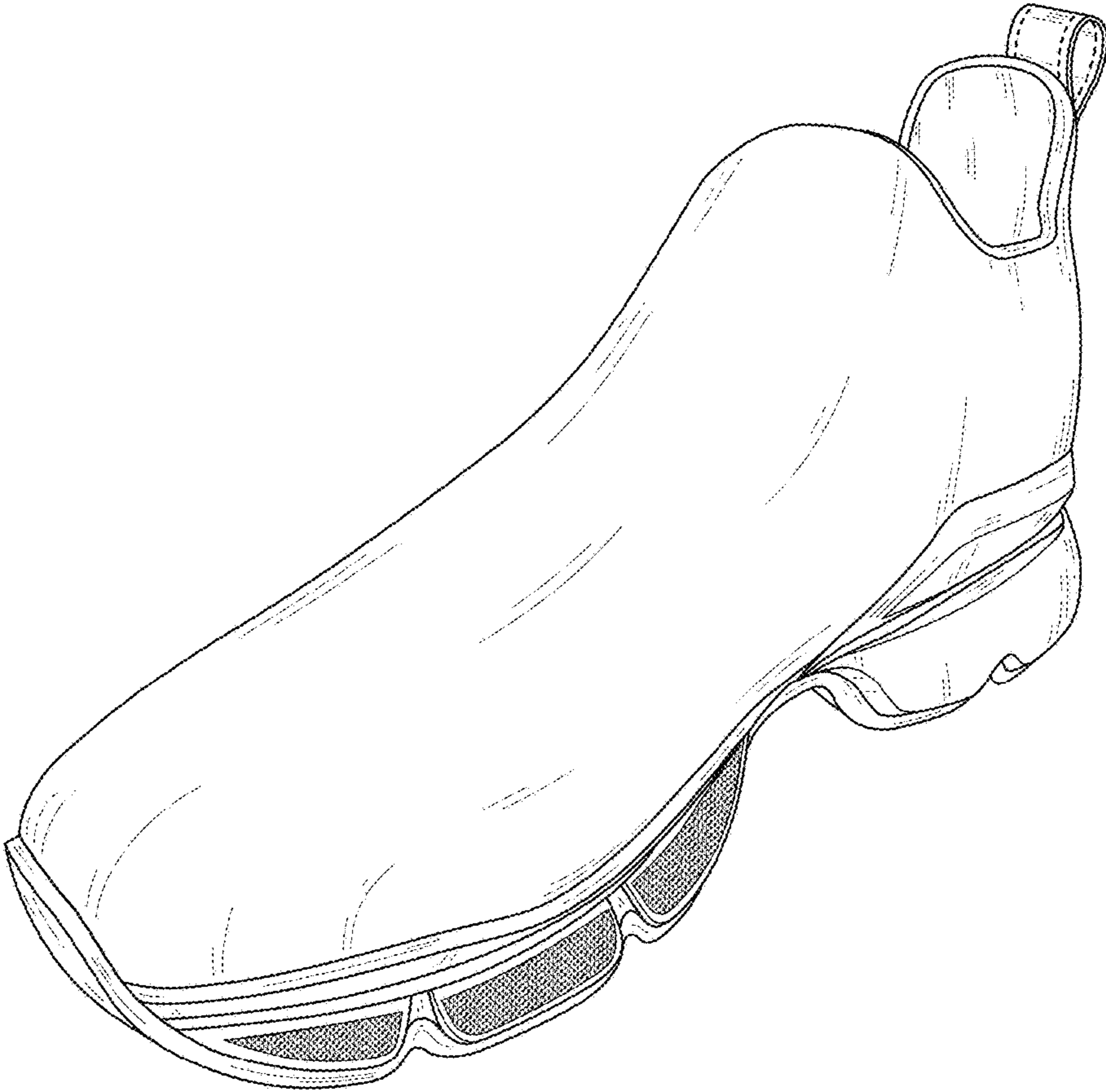

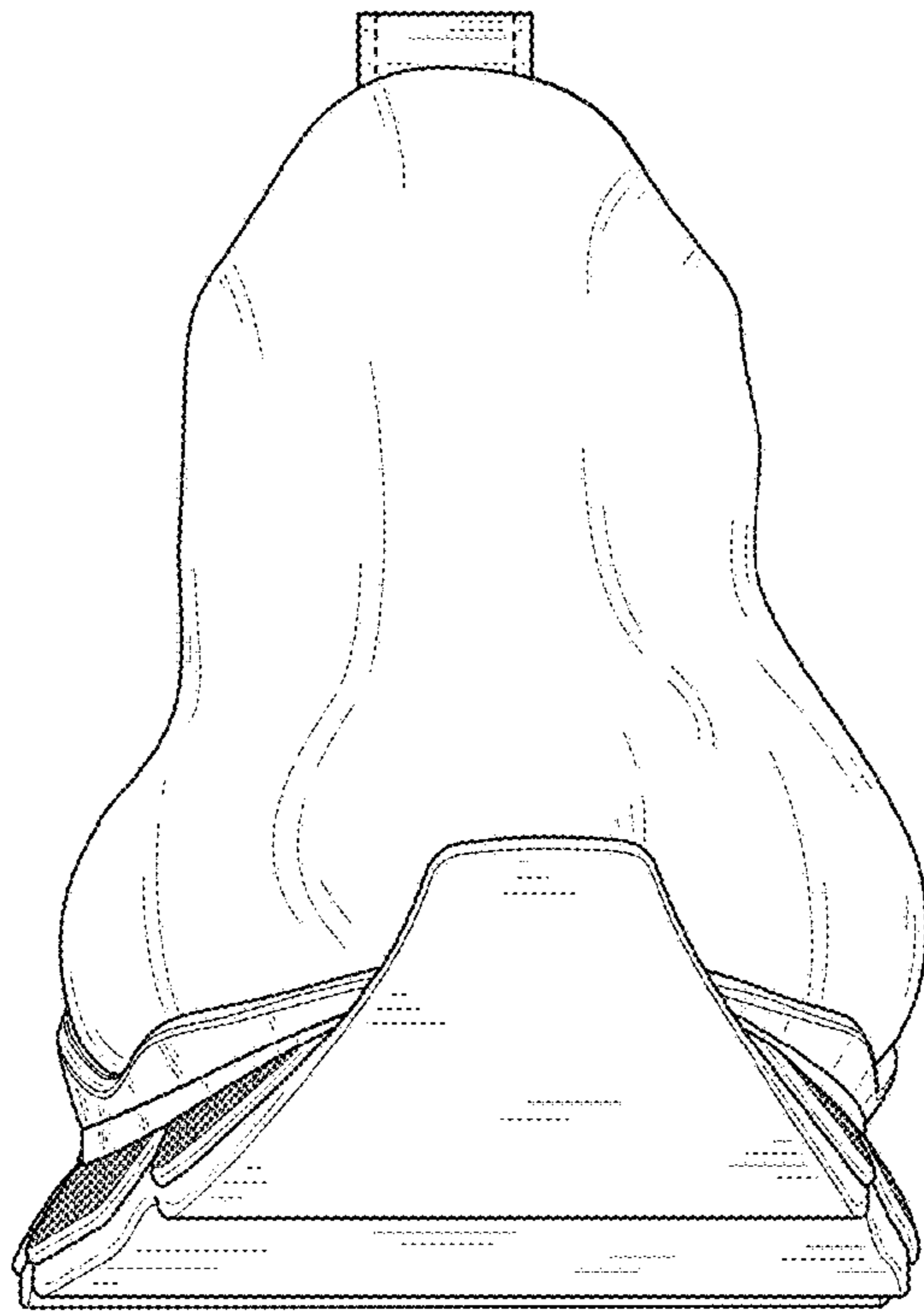

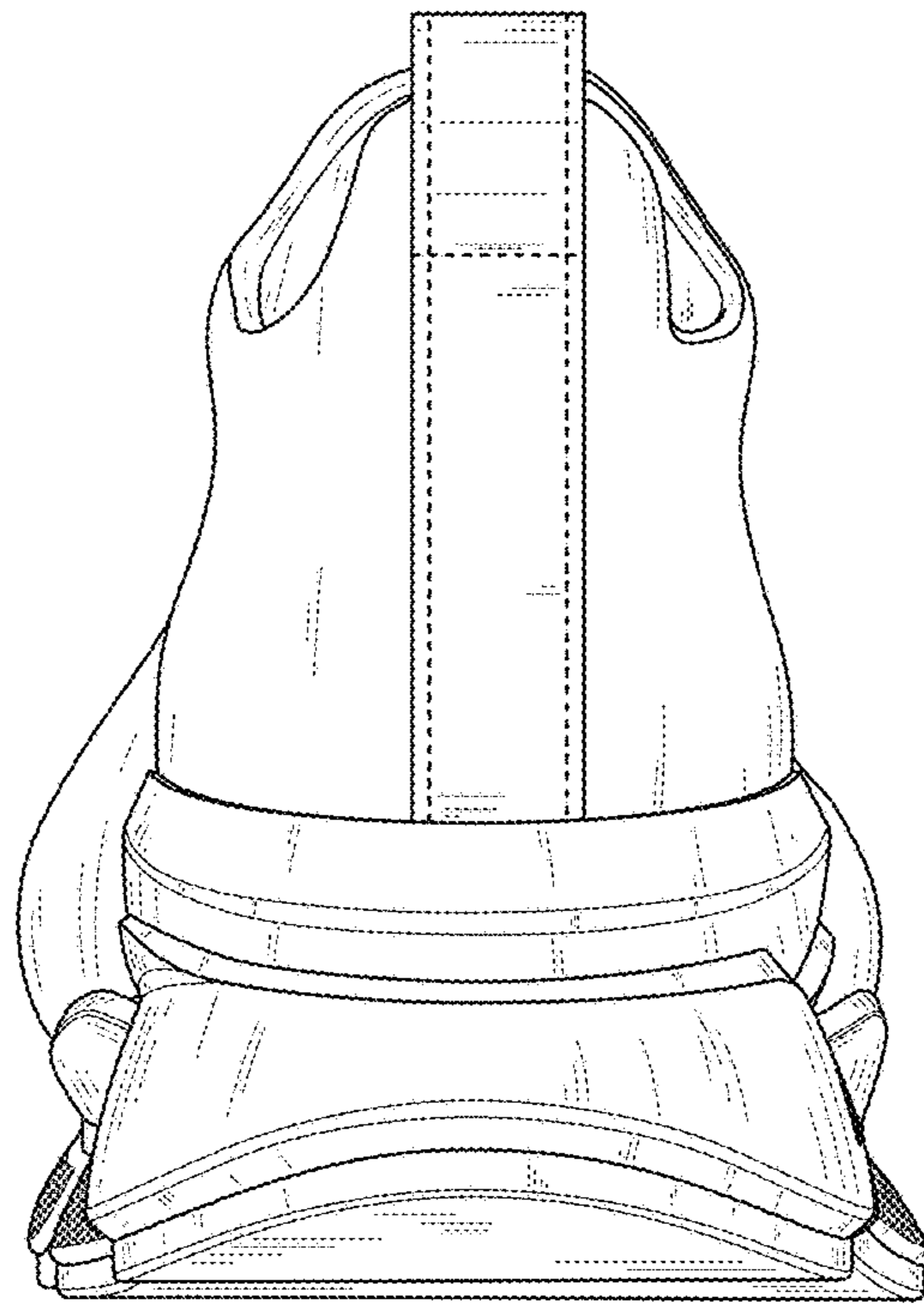

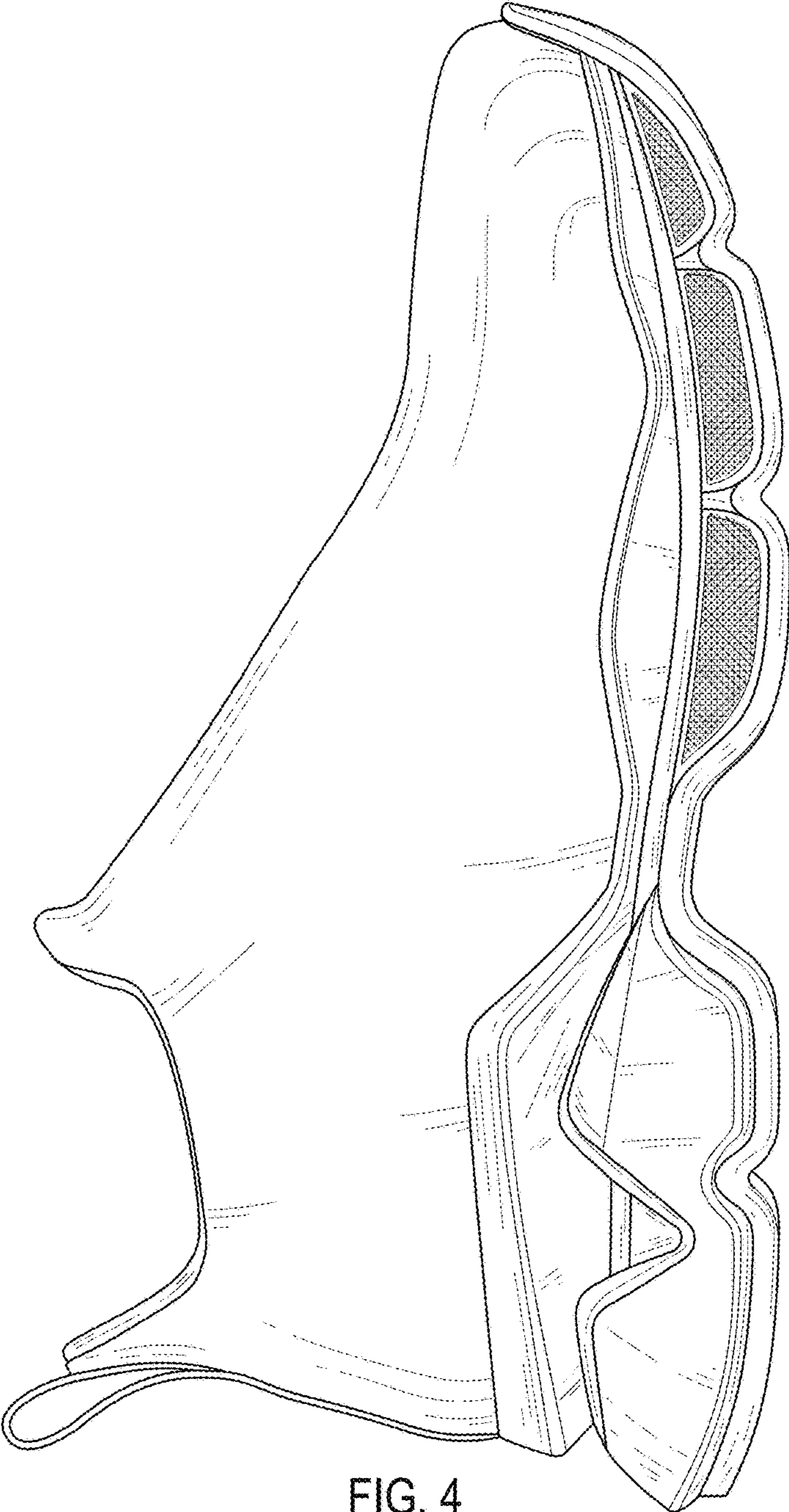

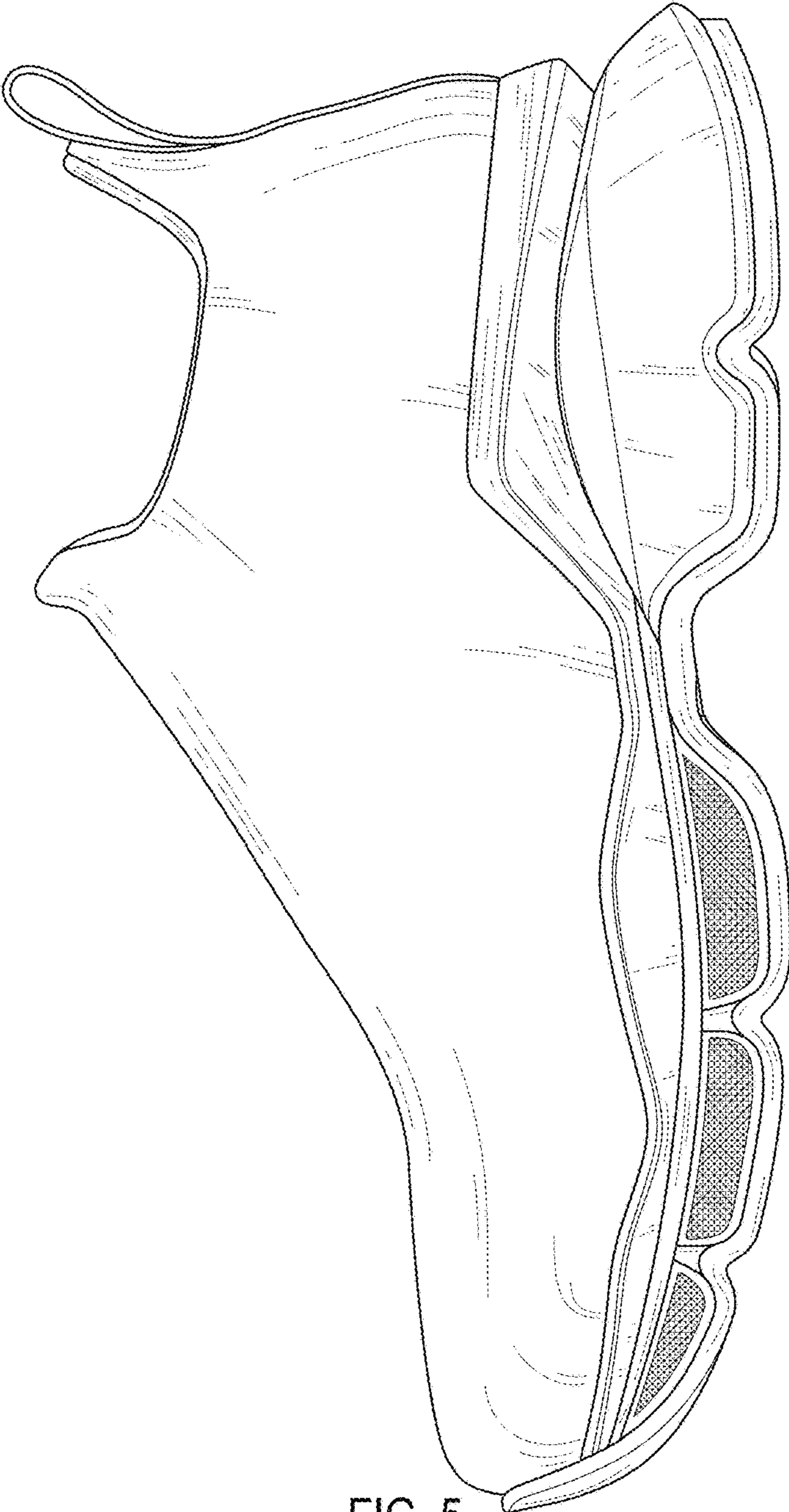

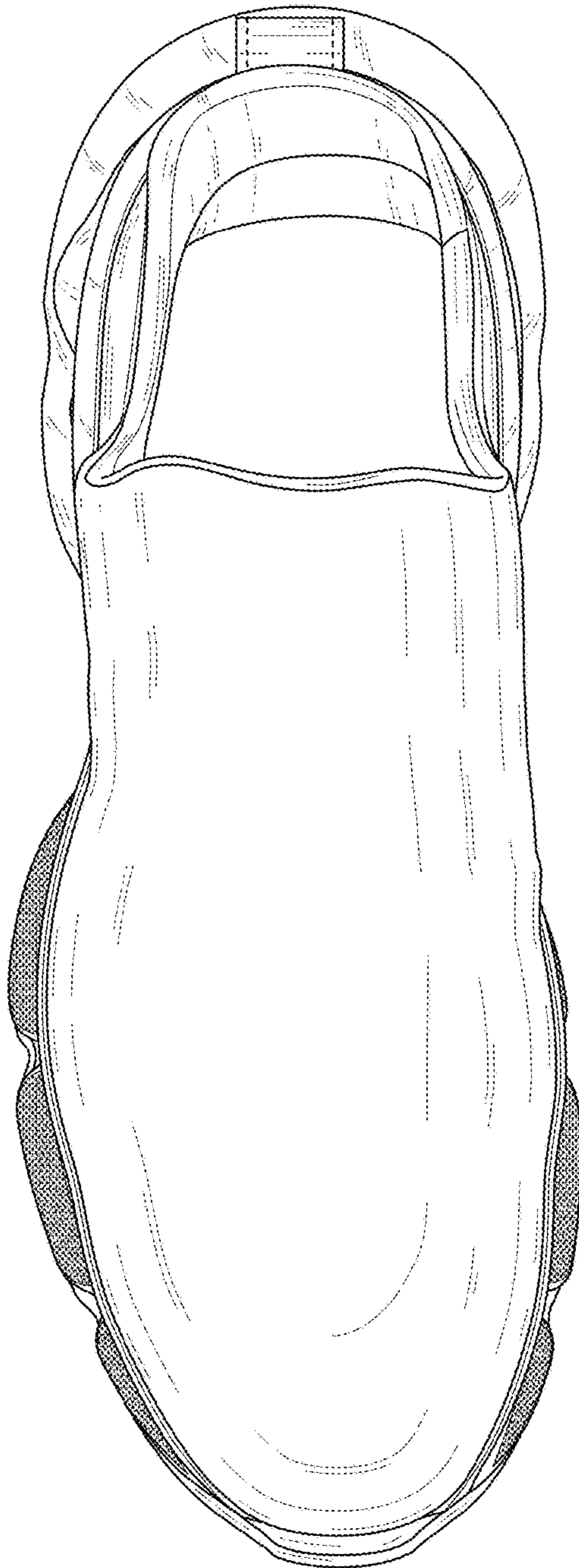

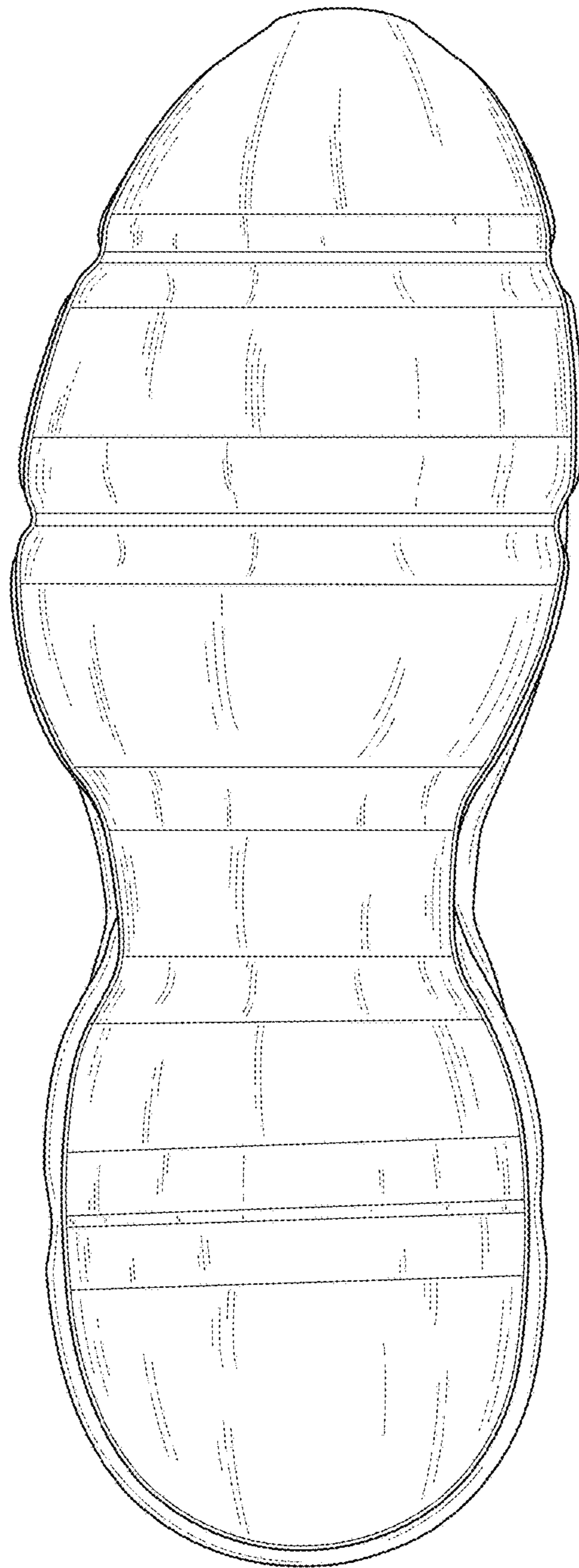
