**DESCRIPTION**

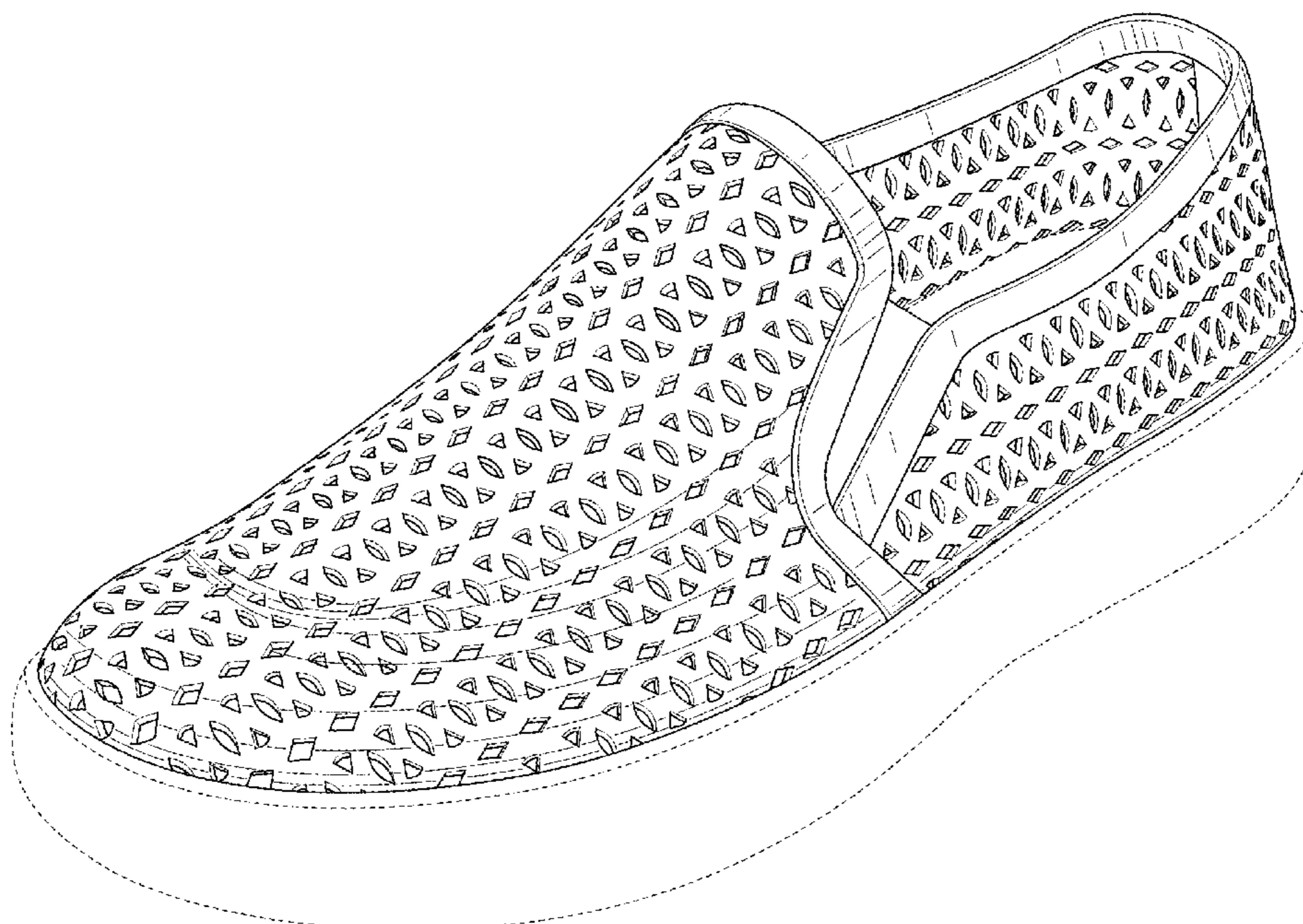
FIG. 1 is a perspective view of an upper for a shoe in accordance with my new design;

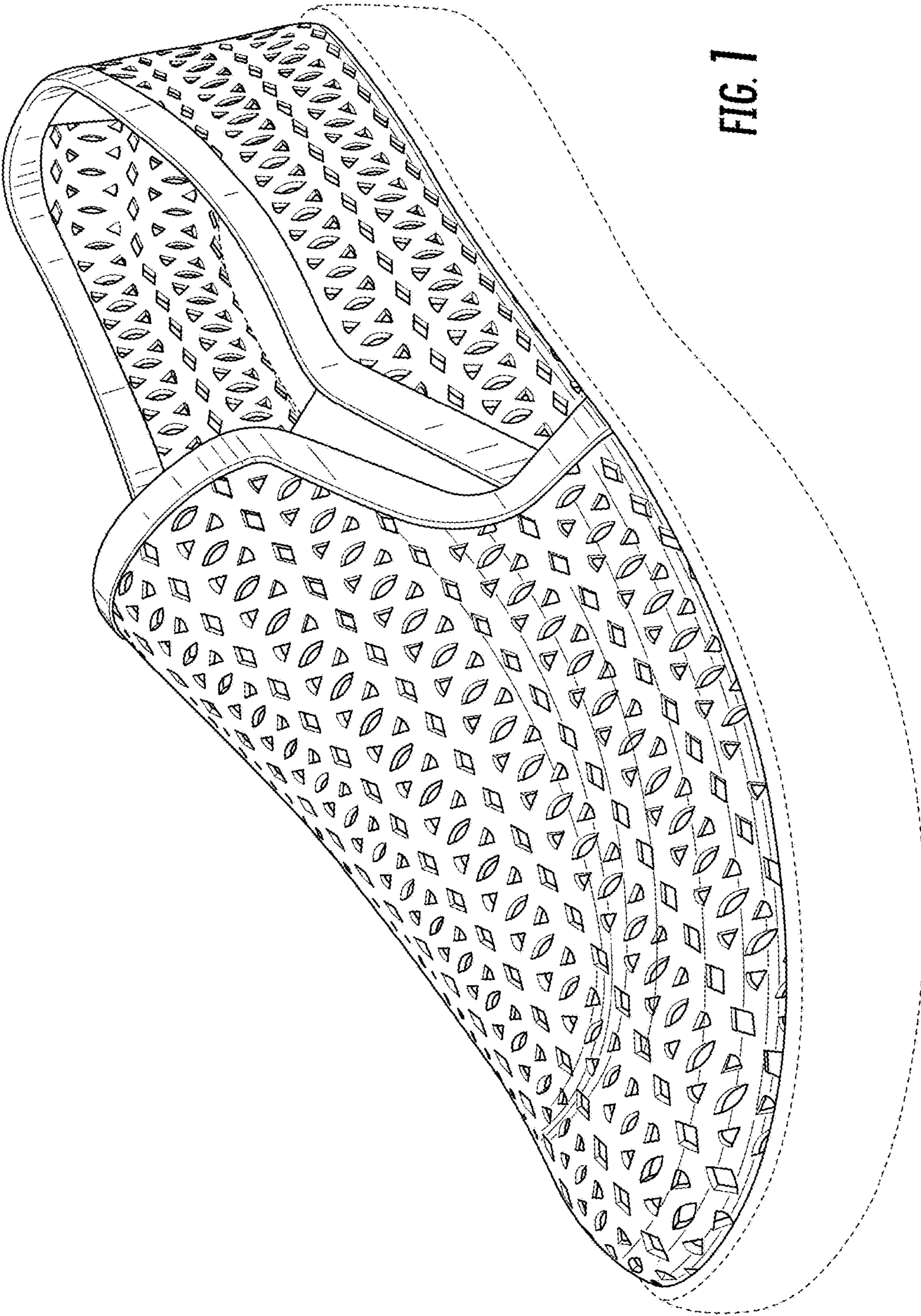
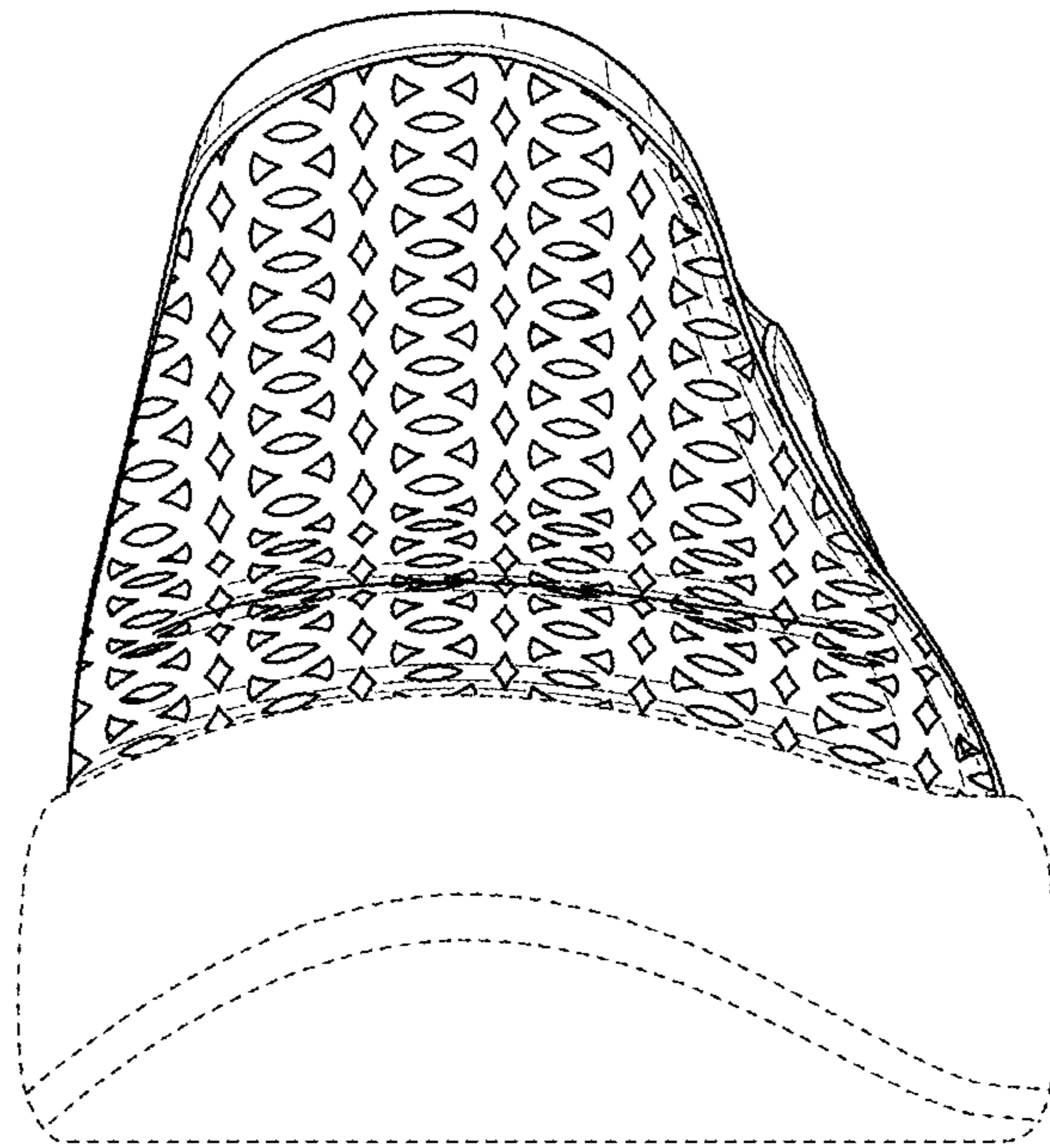
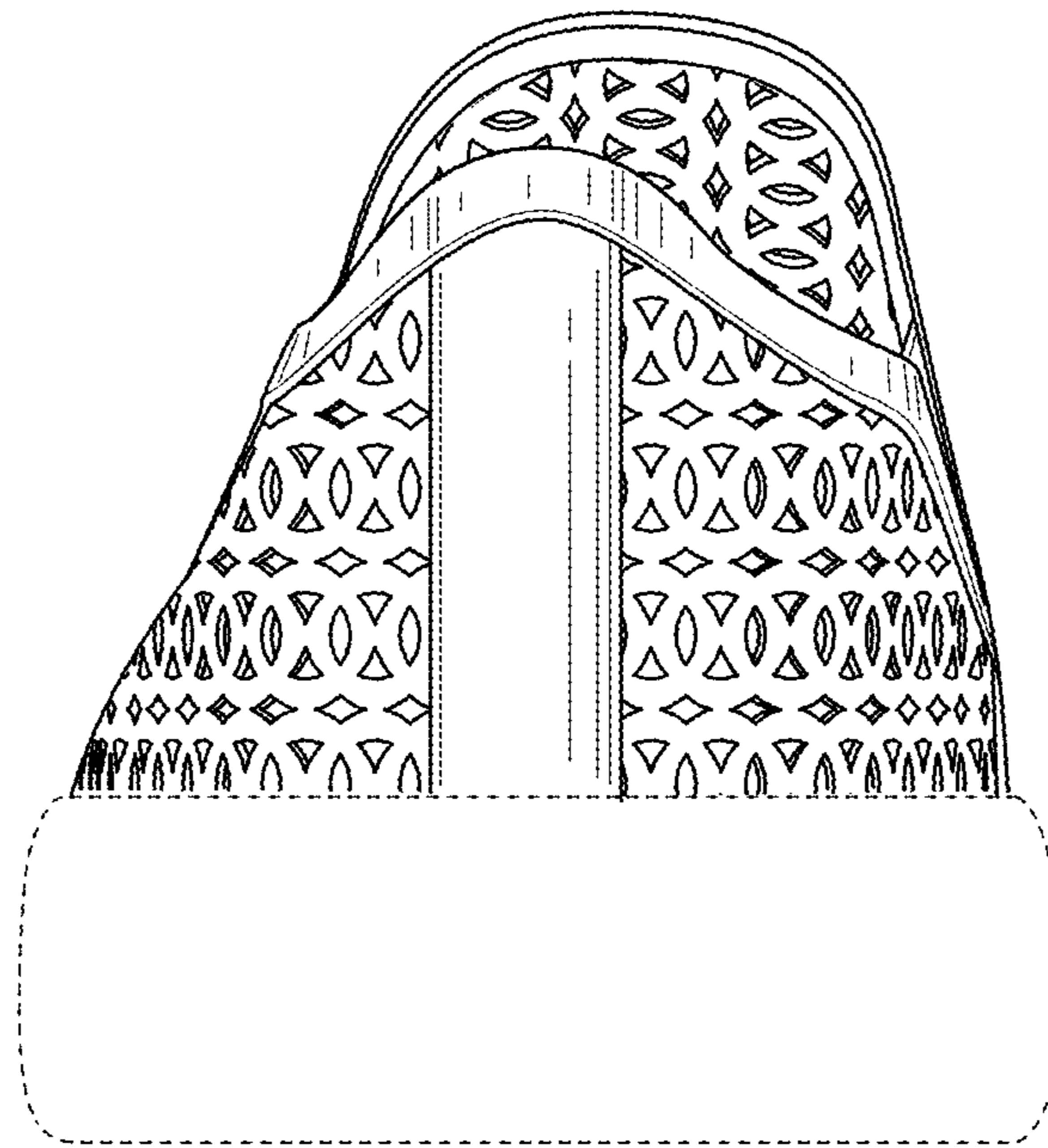

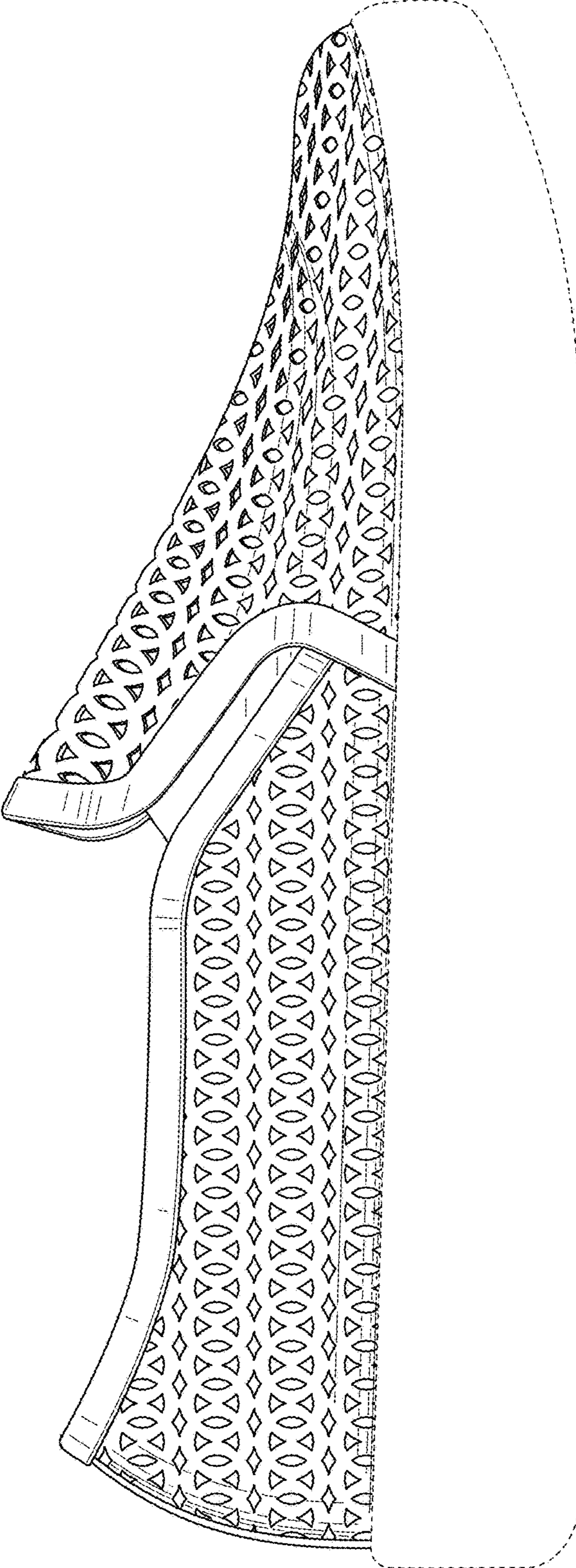

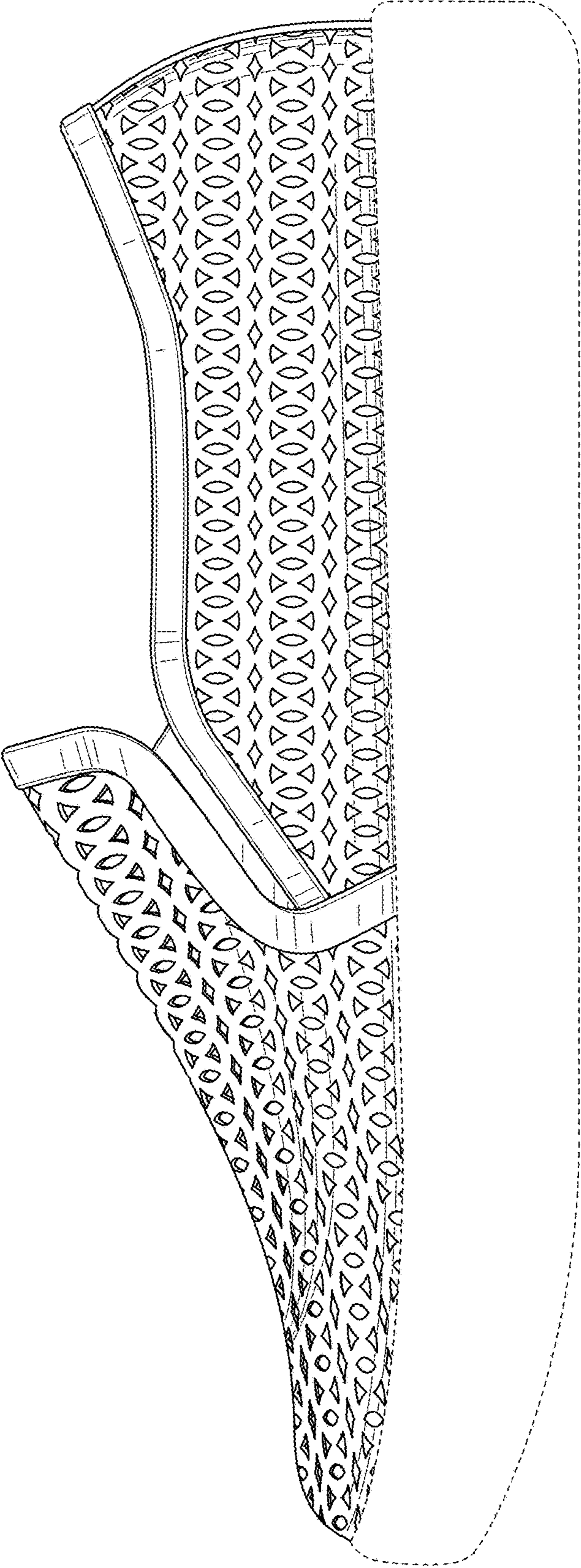

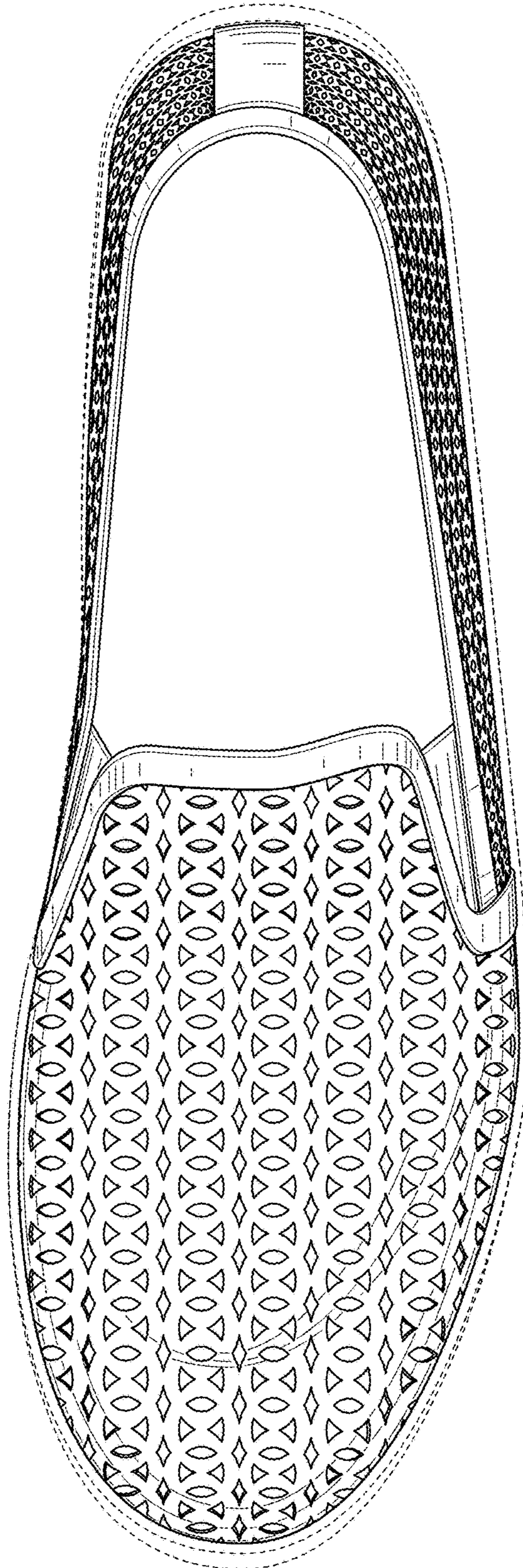
