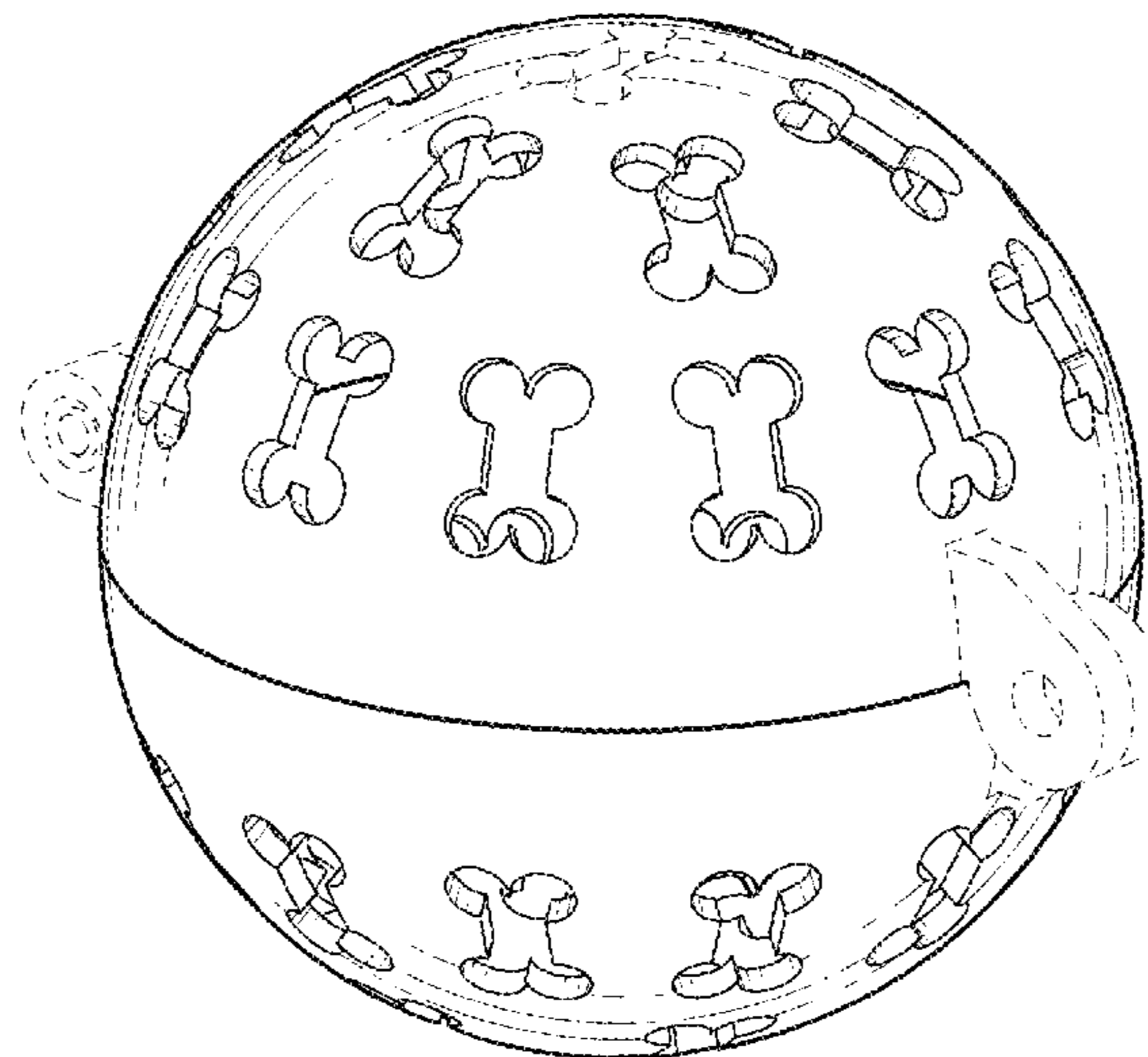
(57) **CLAIM**

The ornamental design for a ball holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a ball holder showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a front perspective view of the ball holder of FIG. 1 in a partial open position;
FIG. 7 is an another perspective view of the ball holder of FIG. 1 in a partial open position;
FIG. 8 is a top plan view of the ball holder of FIG. 1 in a complete open position;
FIG. 9 is a perspective view of the ball holder of FIG. 1 in a partial open position, showing a tennis ball therein in phantom;
FIG. 10 is a perspective view of the ball holder of FIG. 1, showing a joint lock in phantom; and,
FIG. 11 is a perspective view of the ball holder of FIG. 1, showing a dog in phantom.

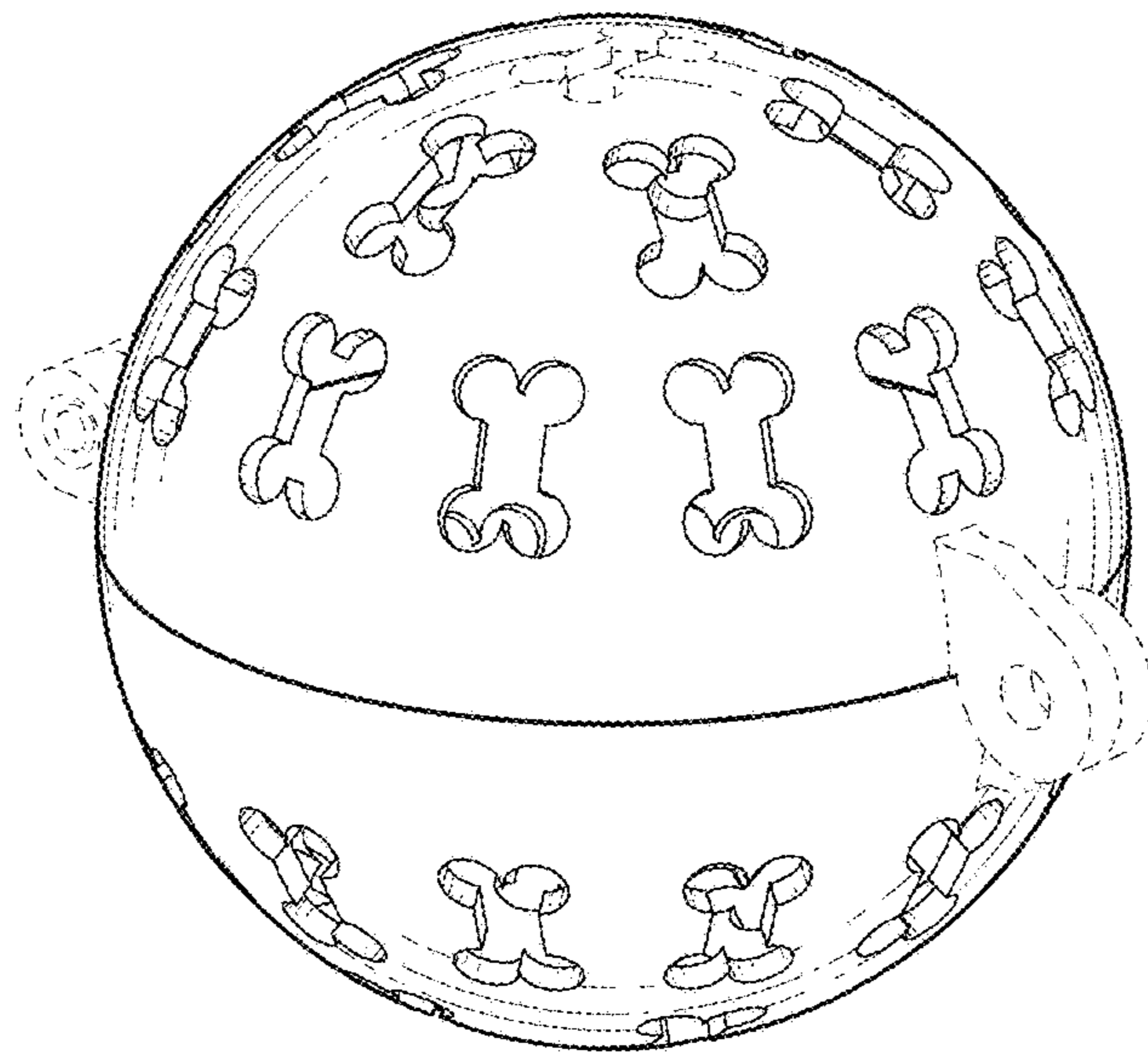

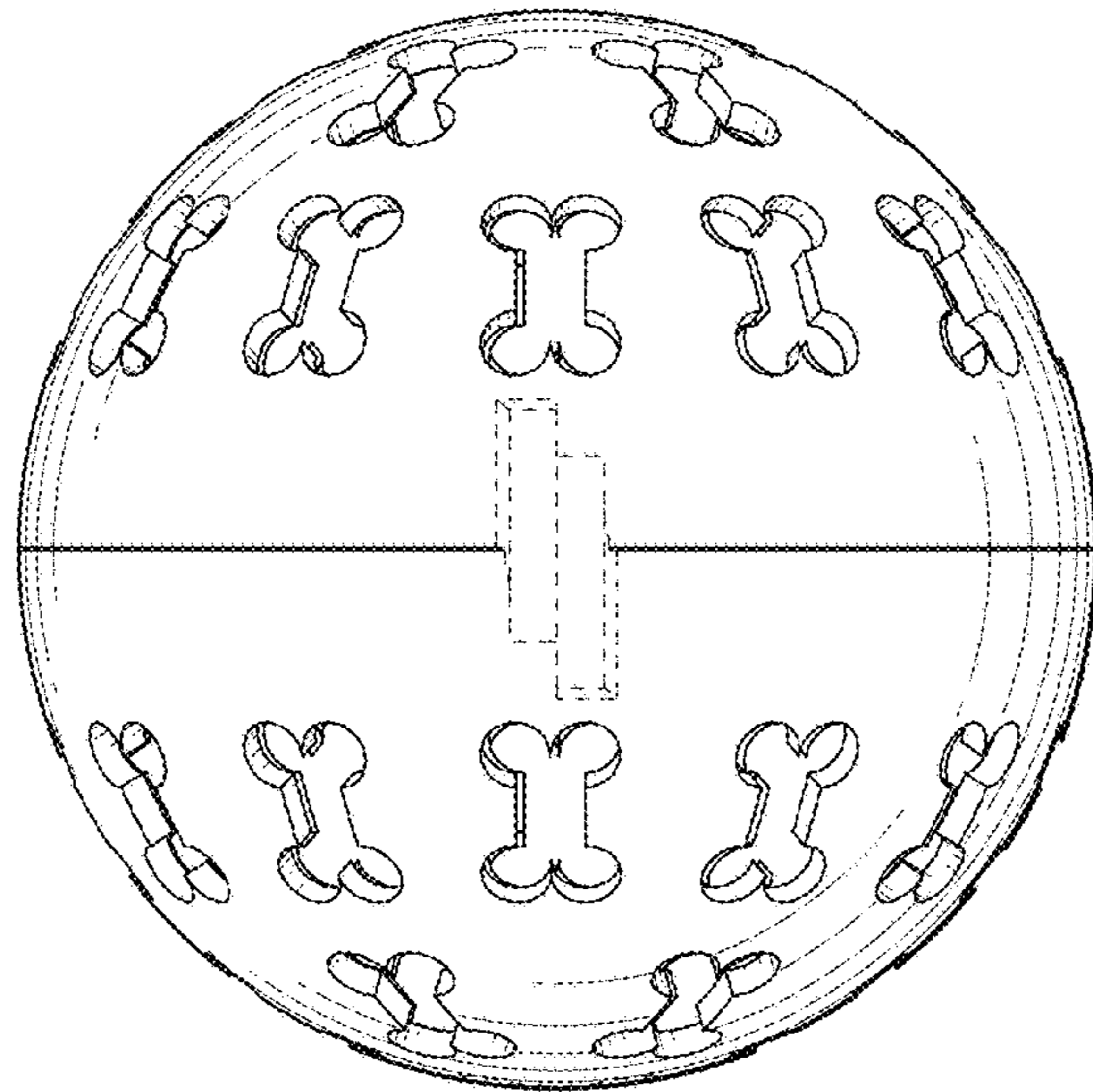

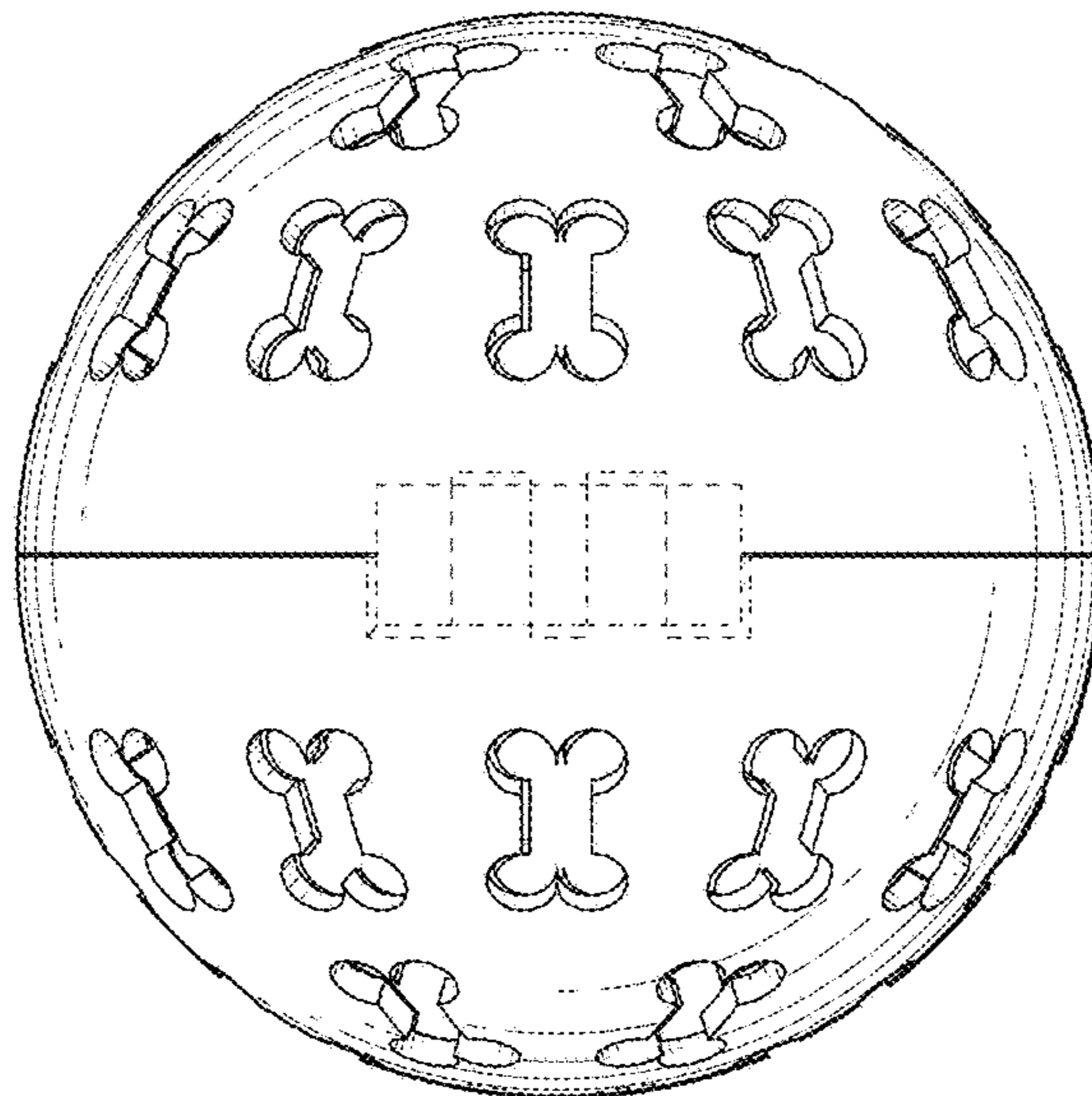

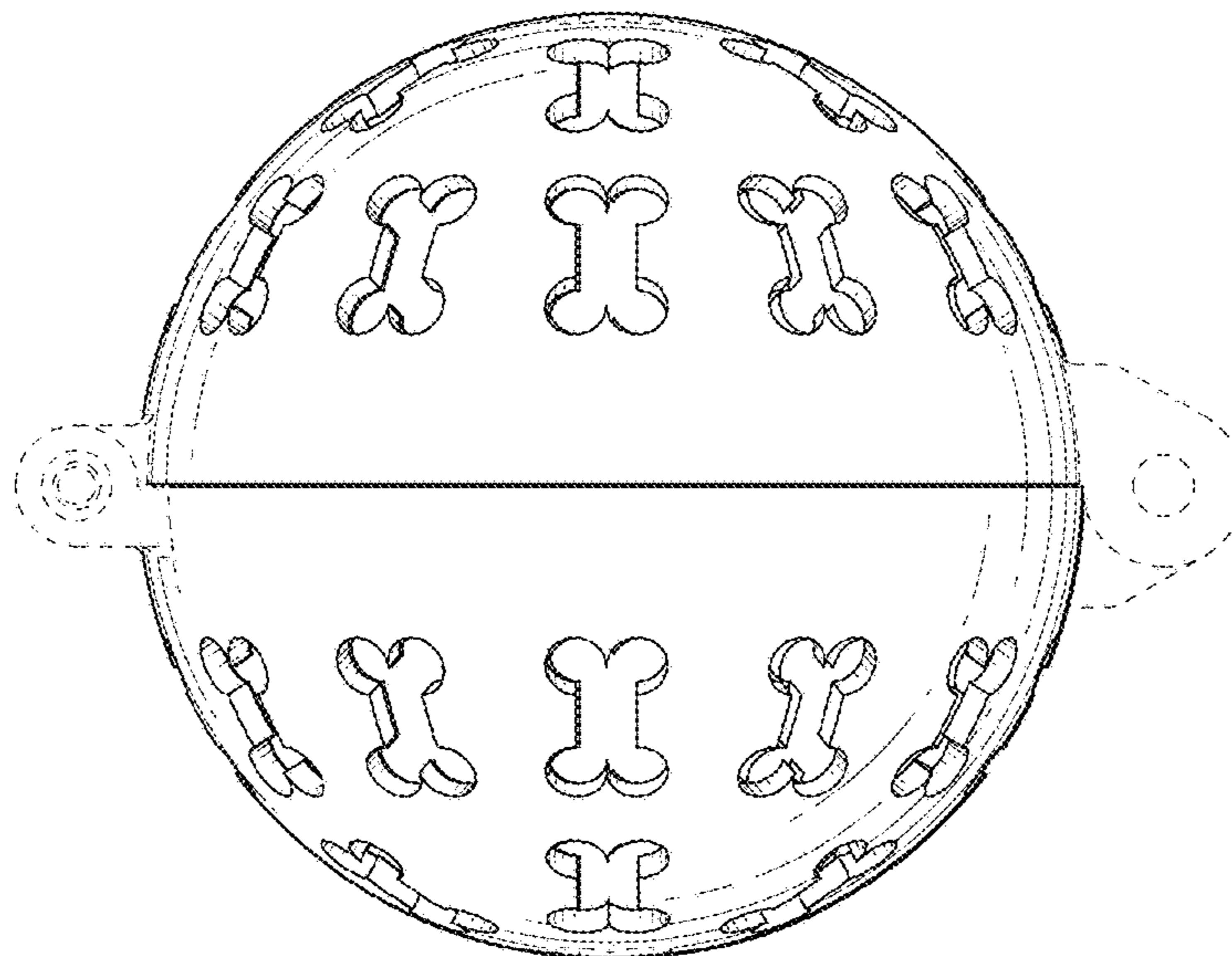

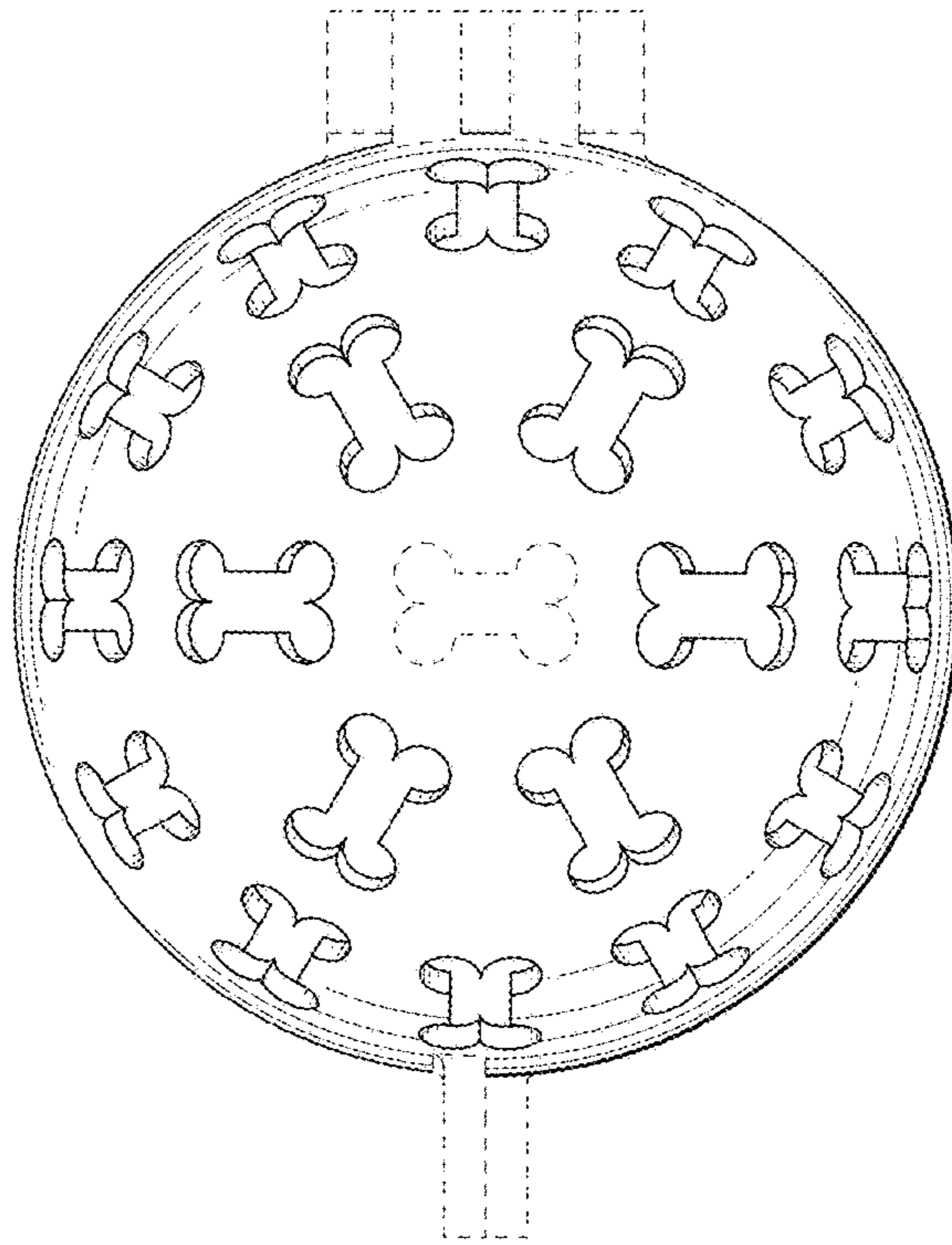

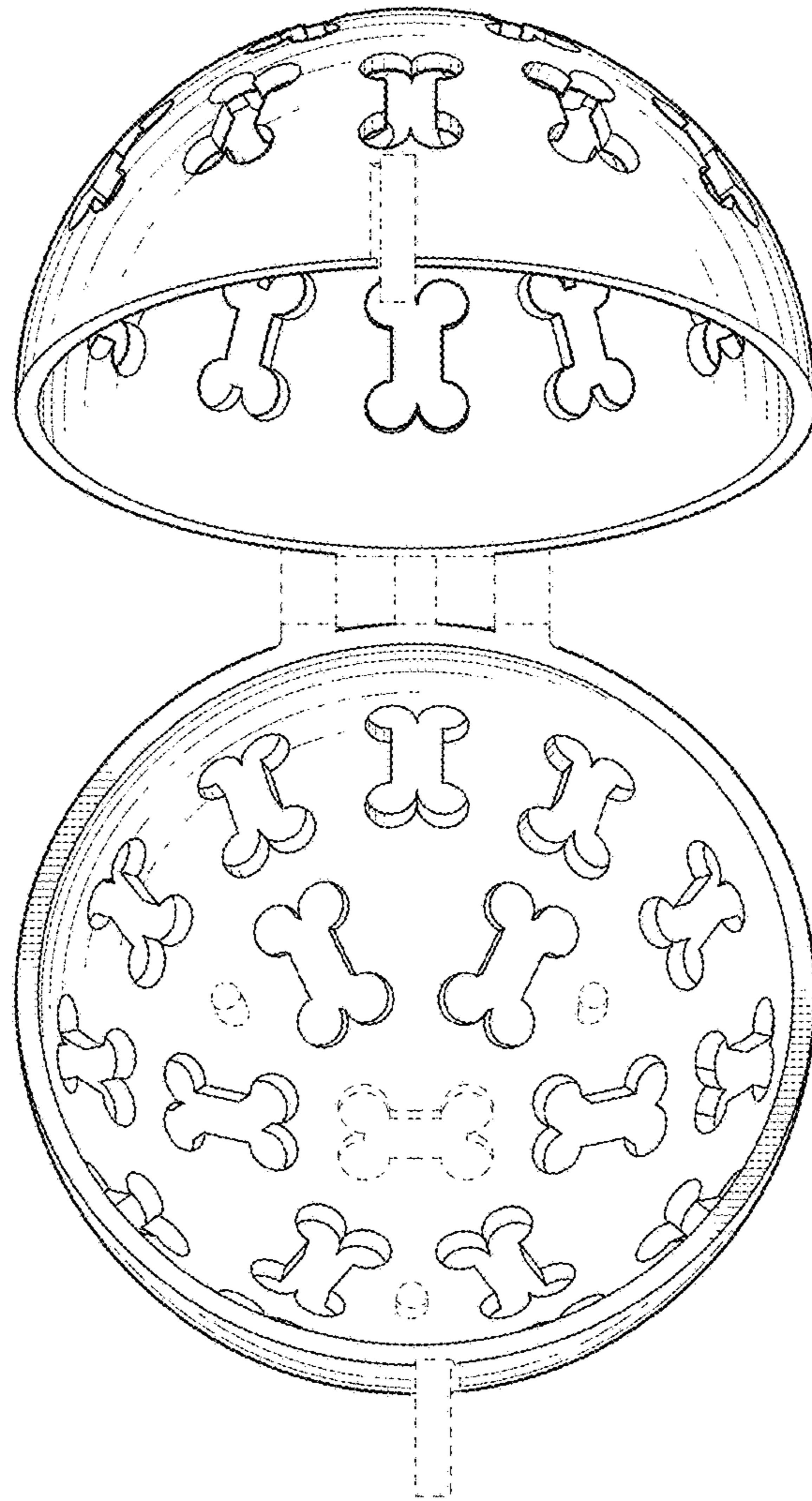

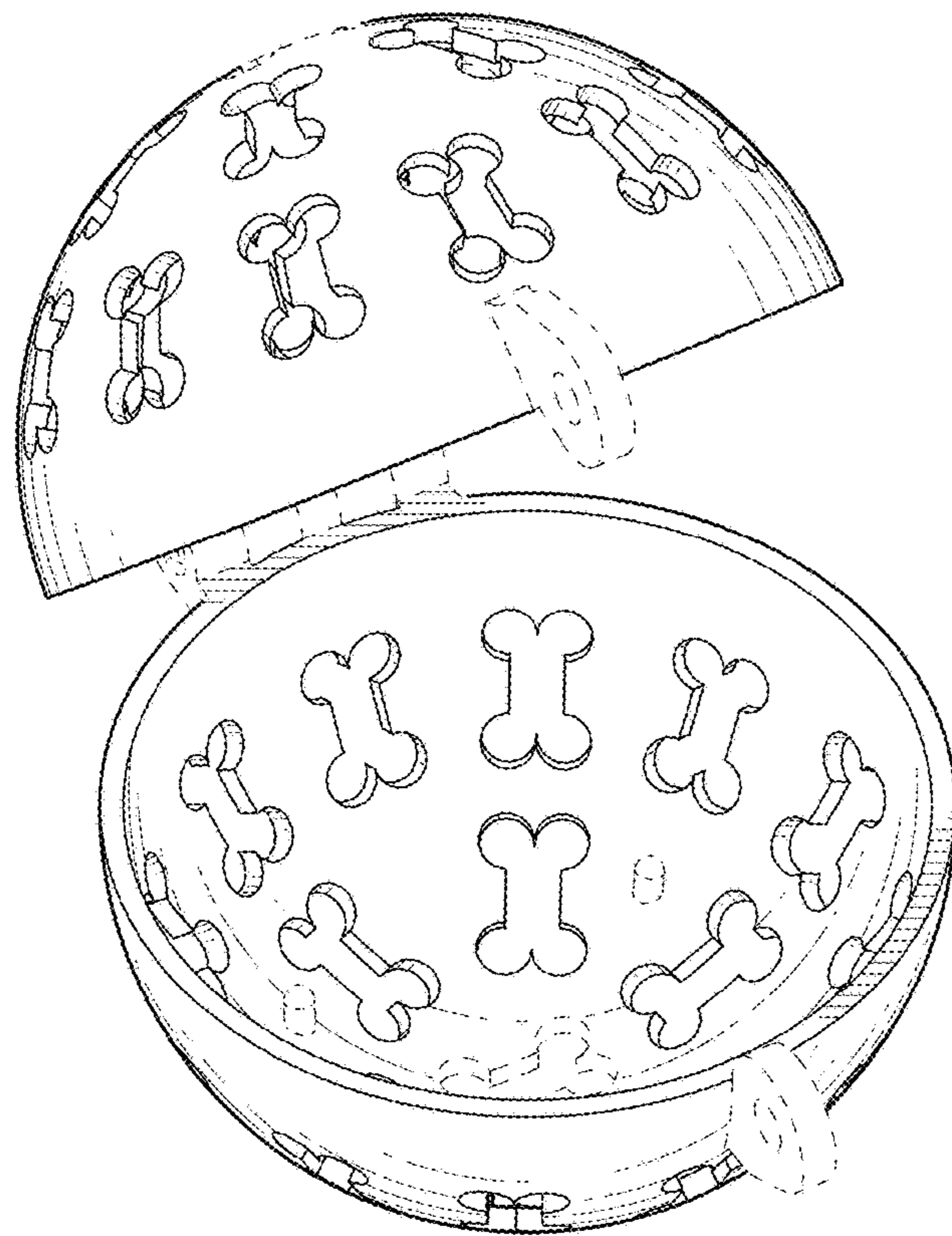

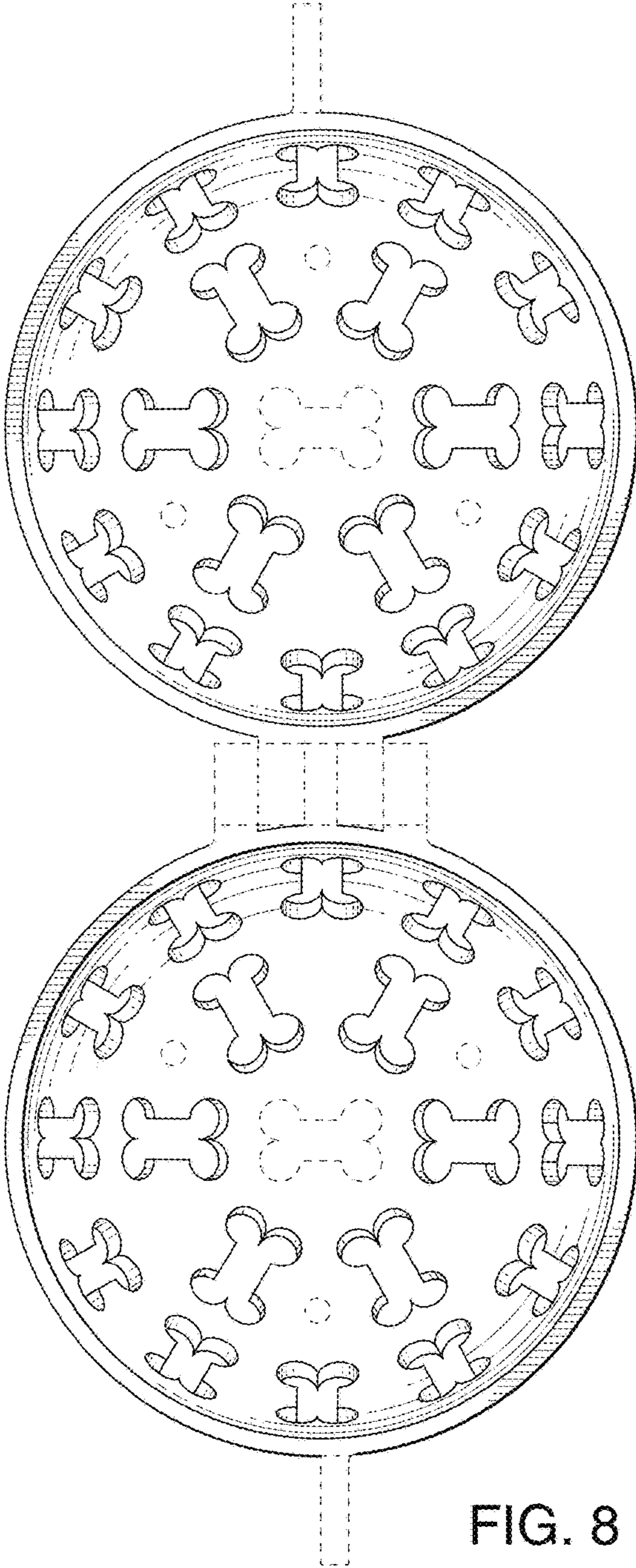

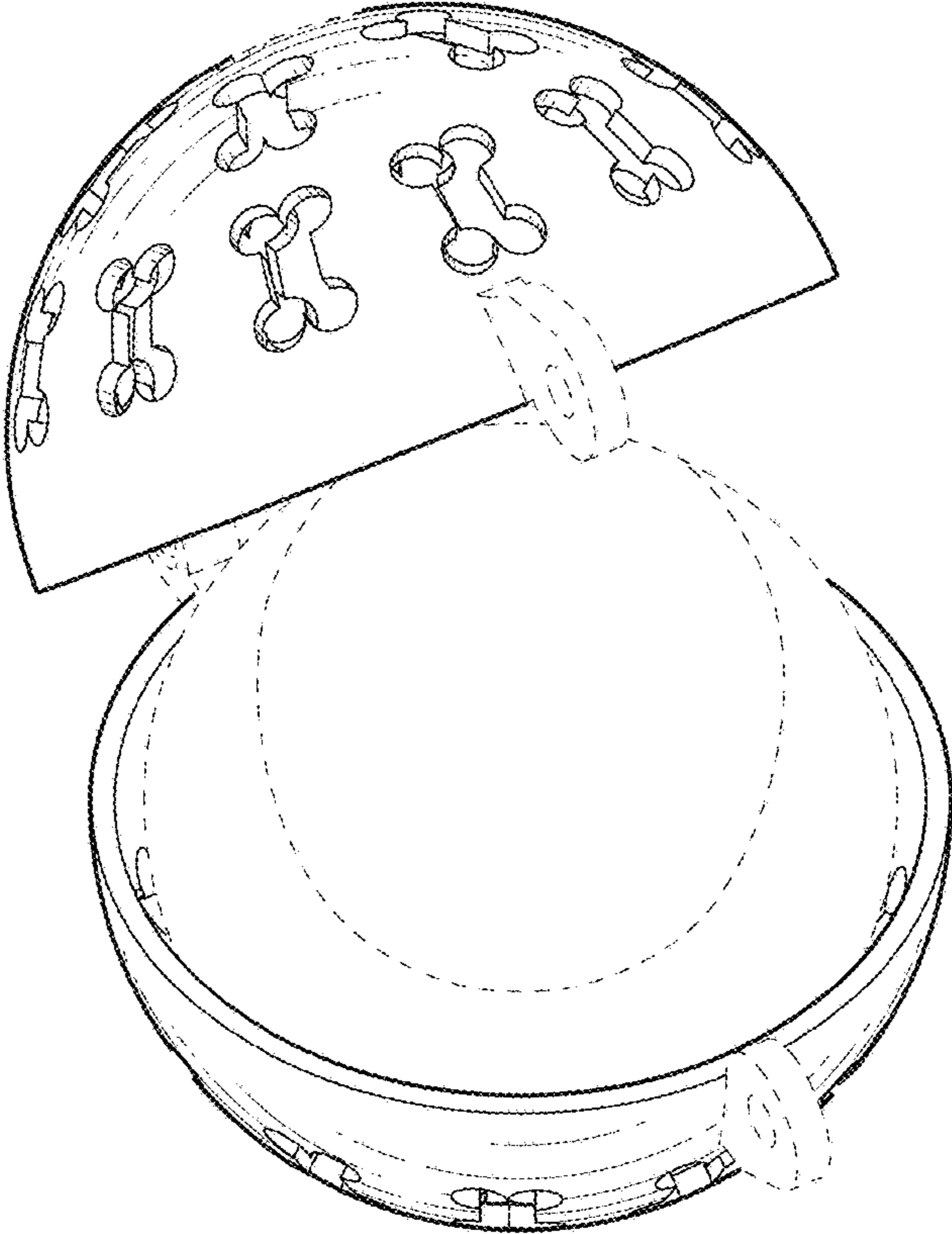

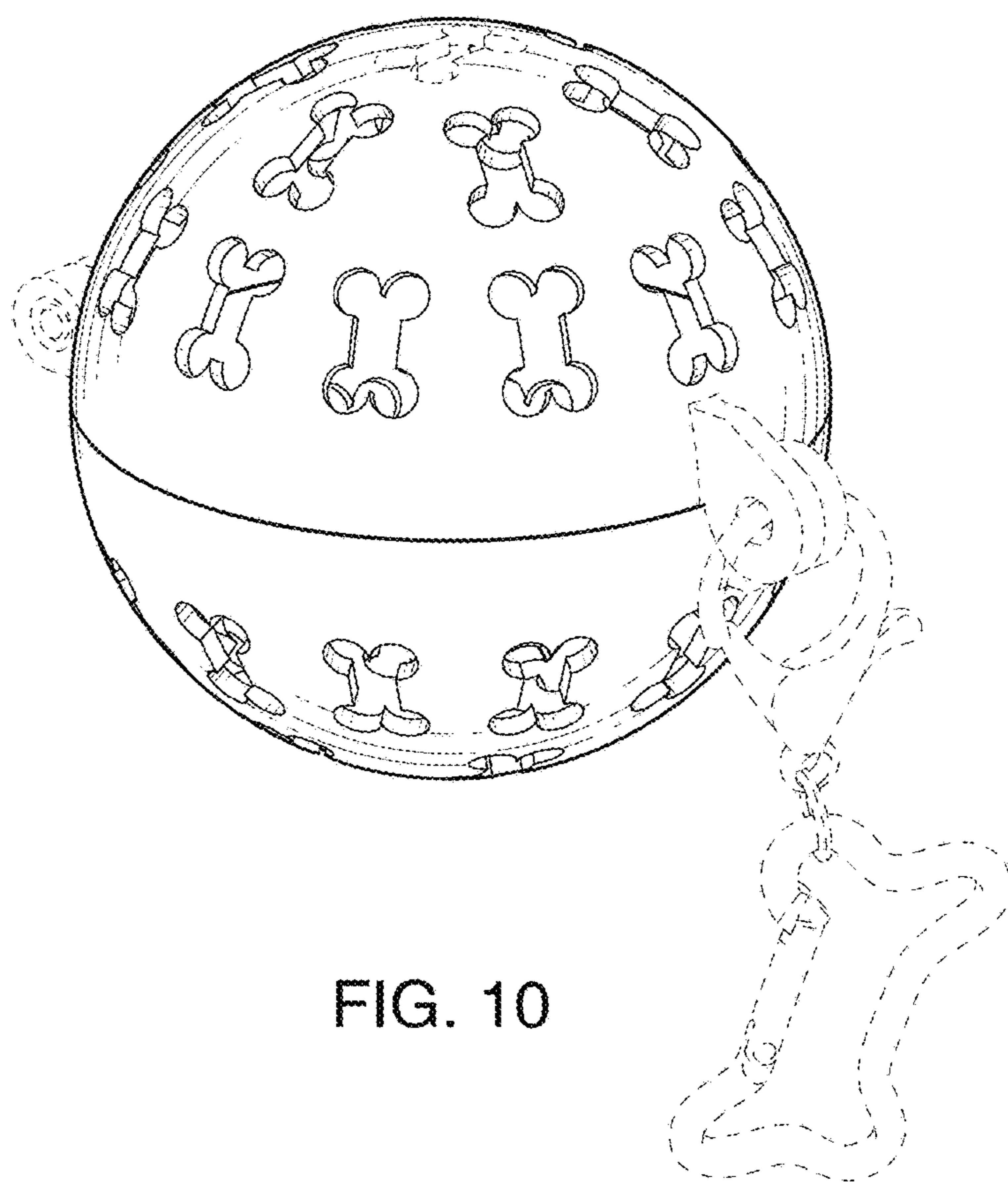
