FIG. 5 is a front side view of the double gun case thereof;

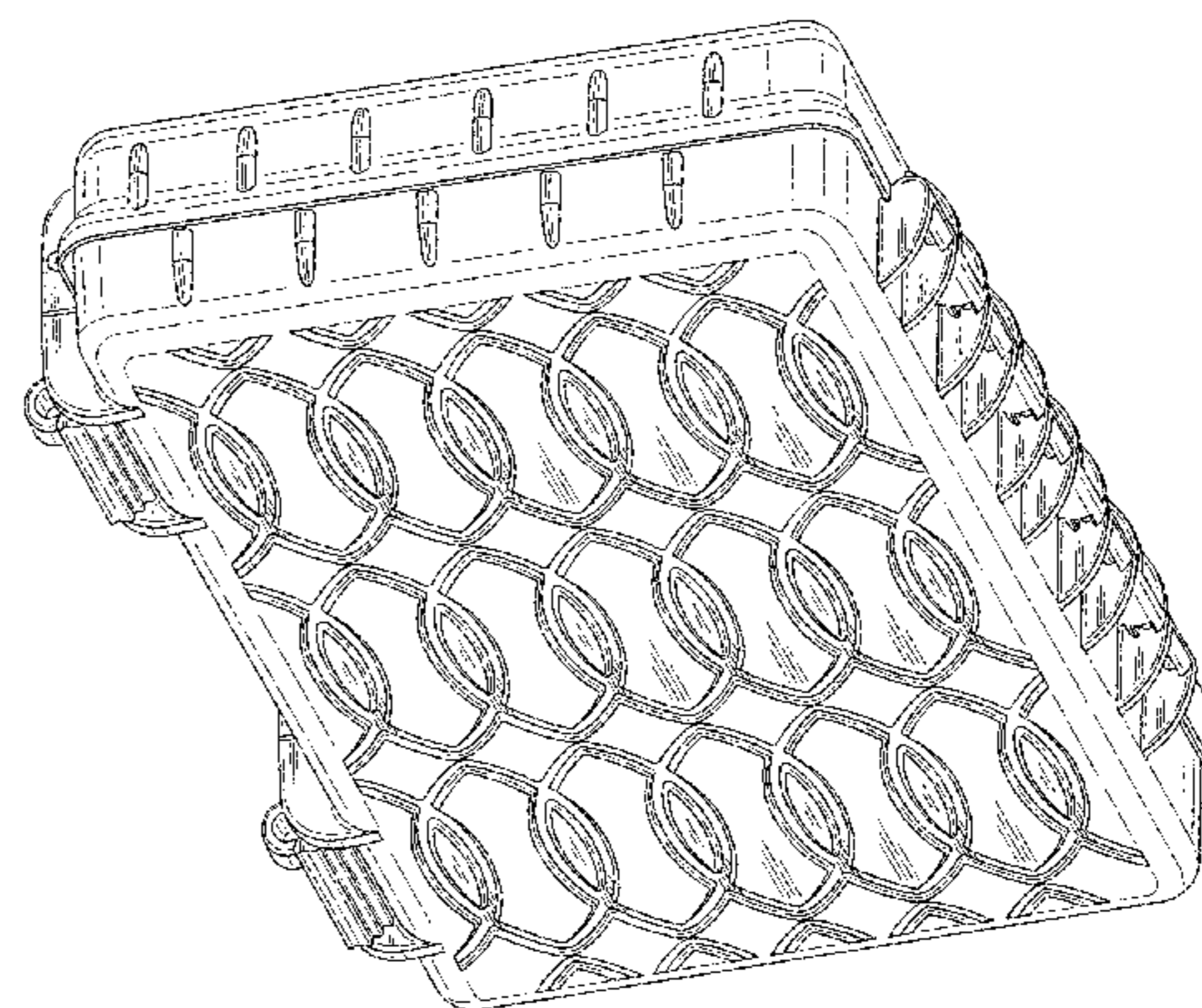
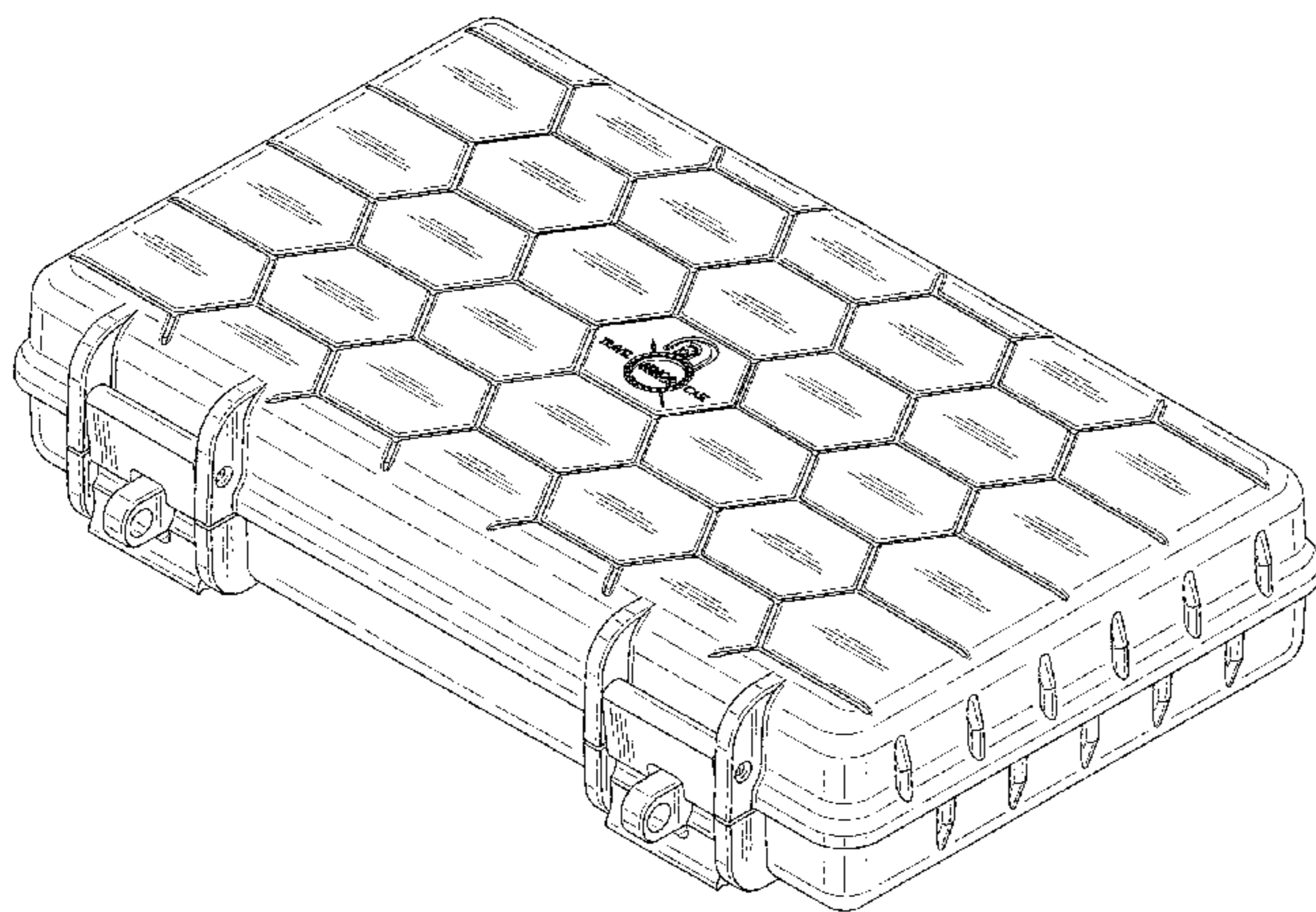
FIG. 6 is a rear side view of the double gun case thereof;

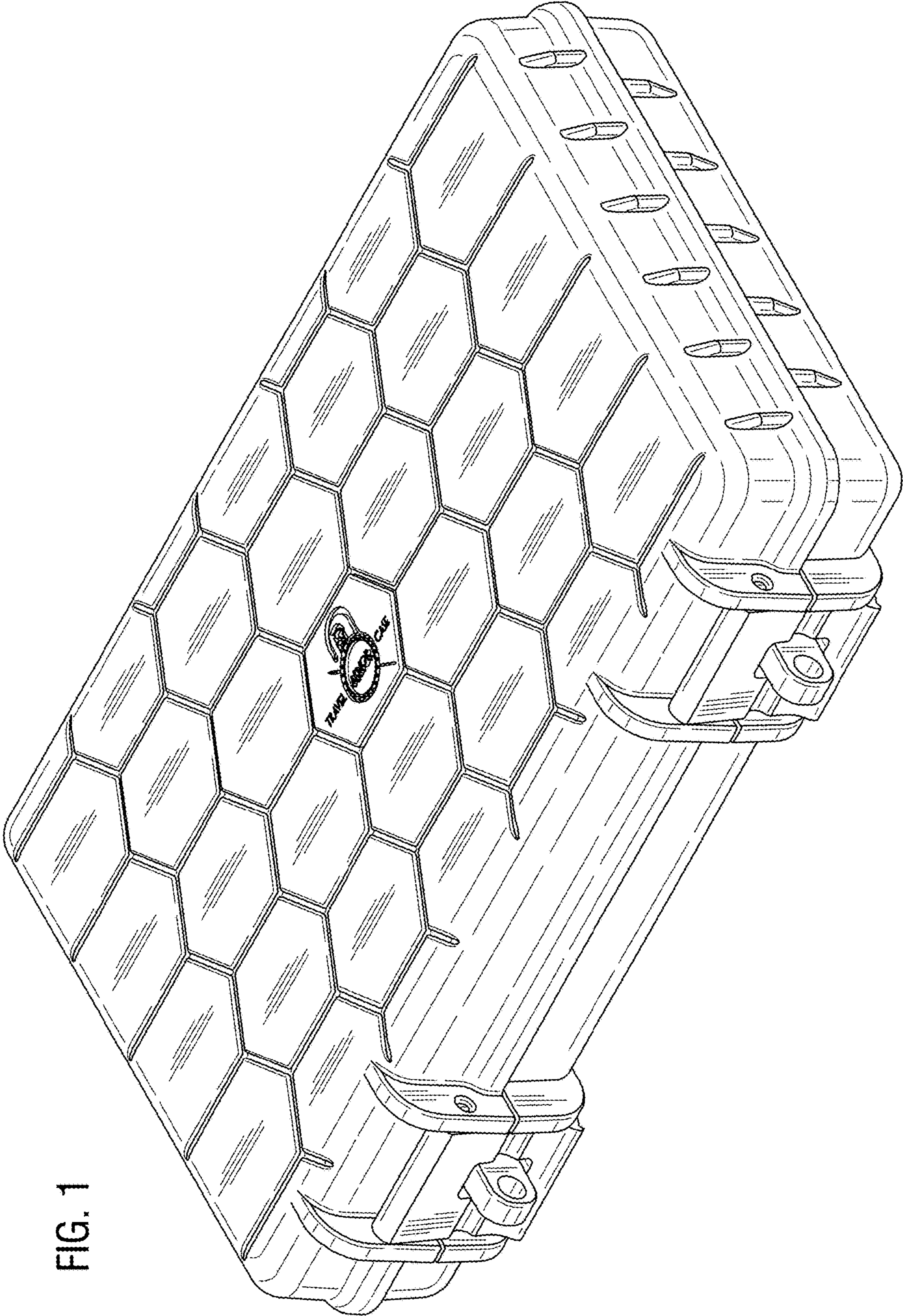

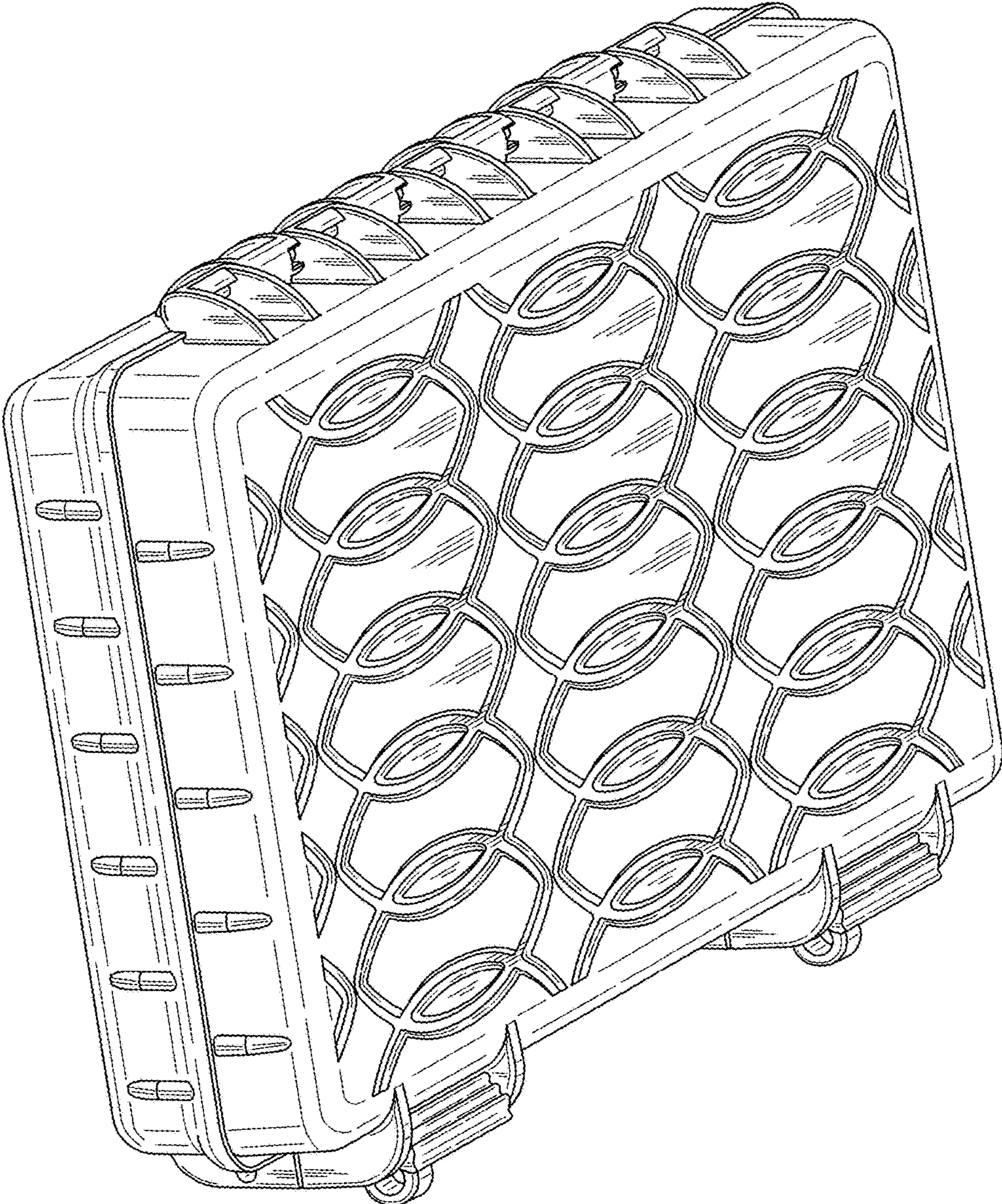

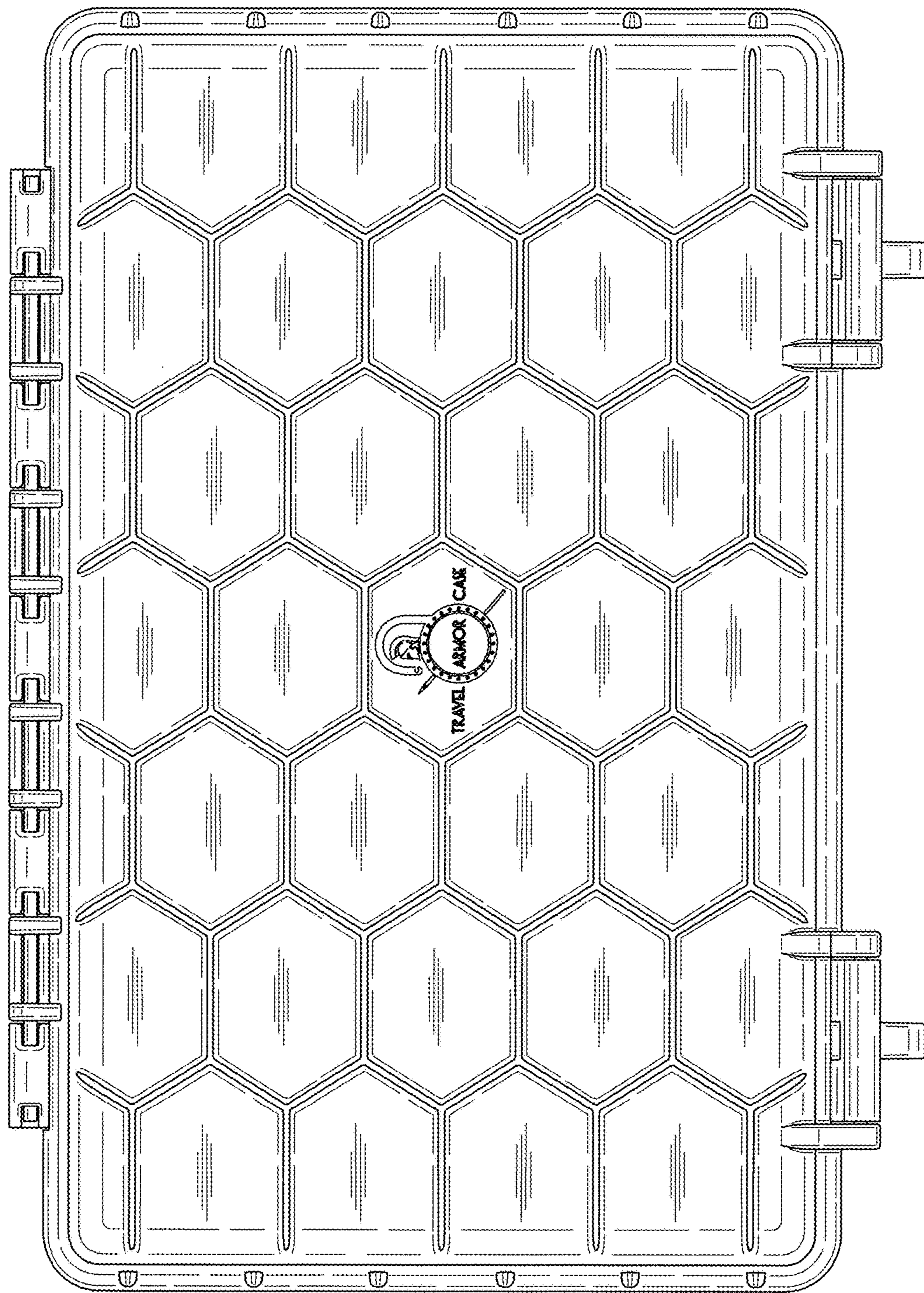

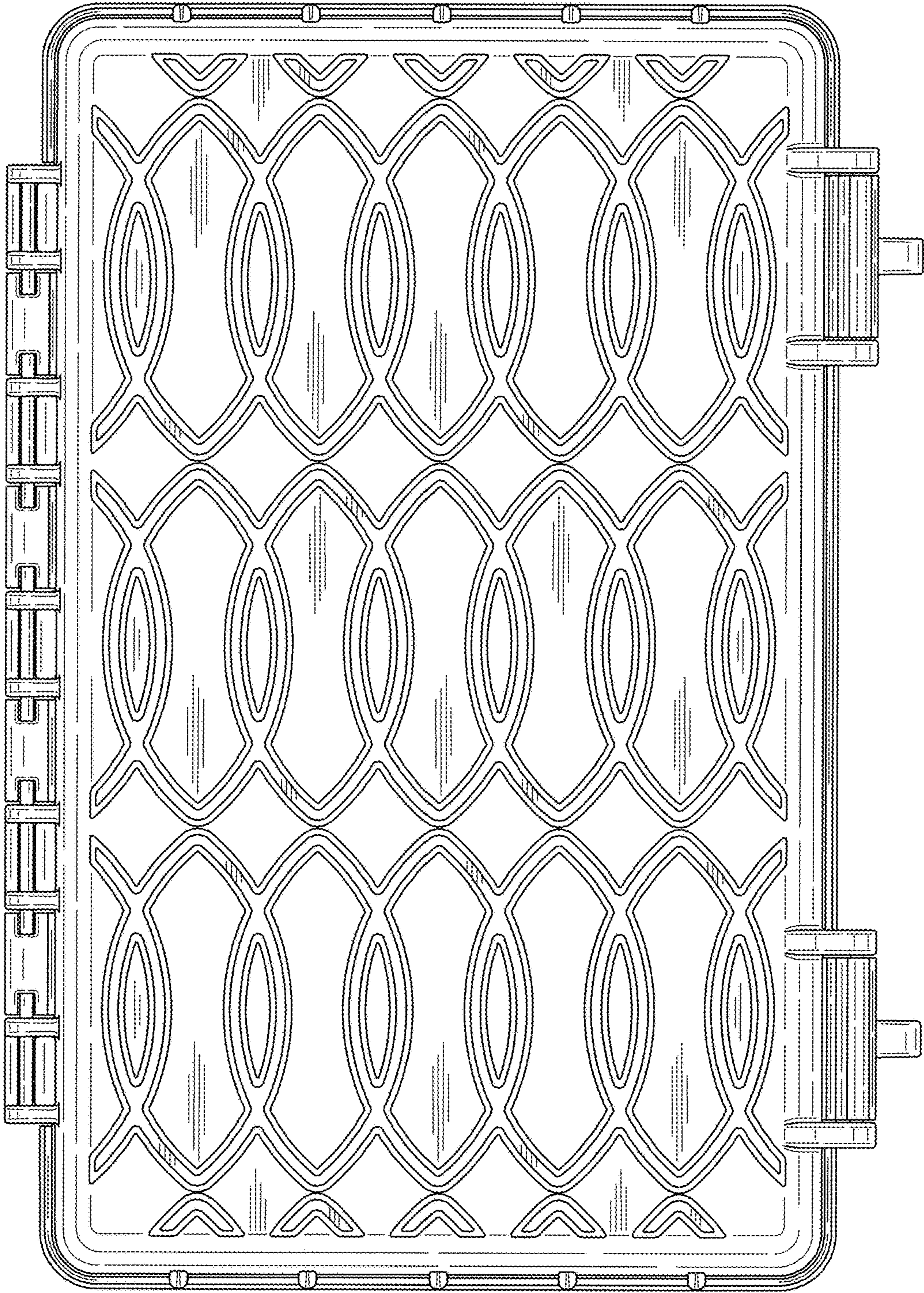

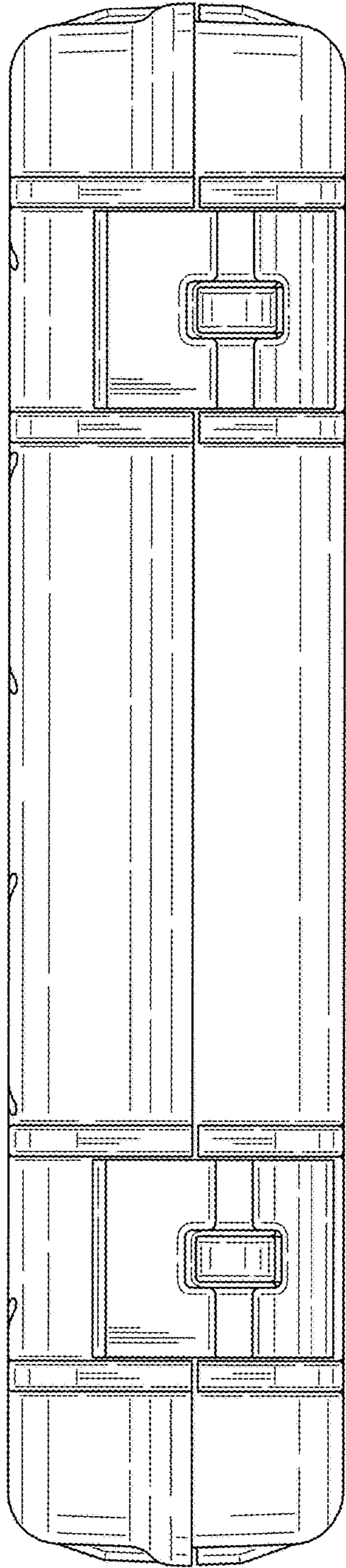

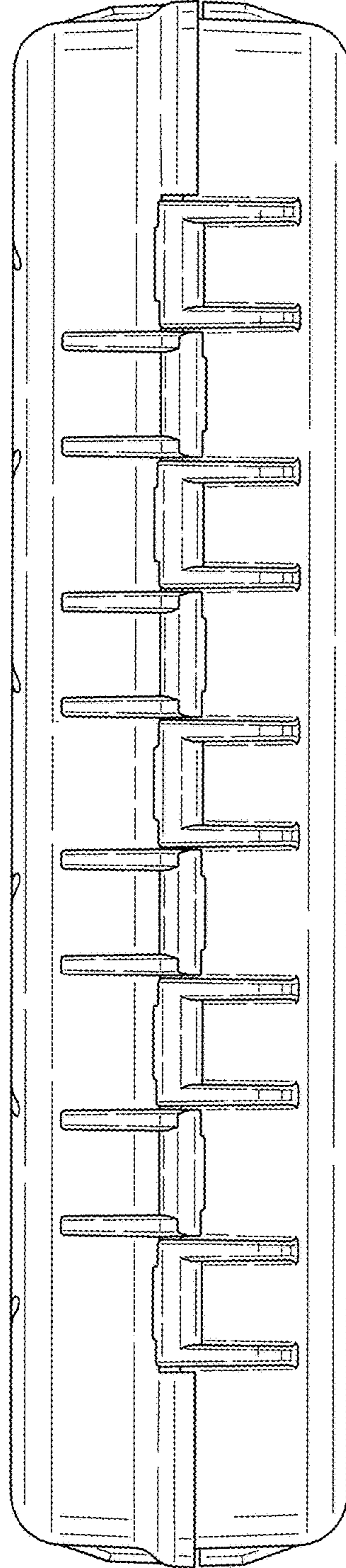

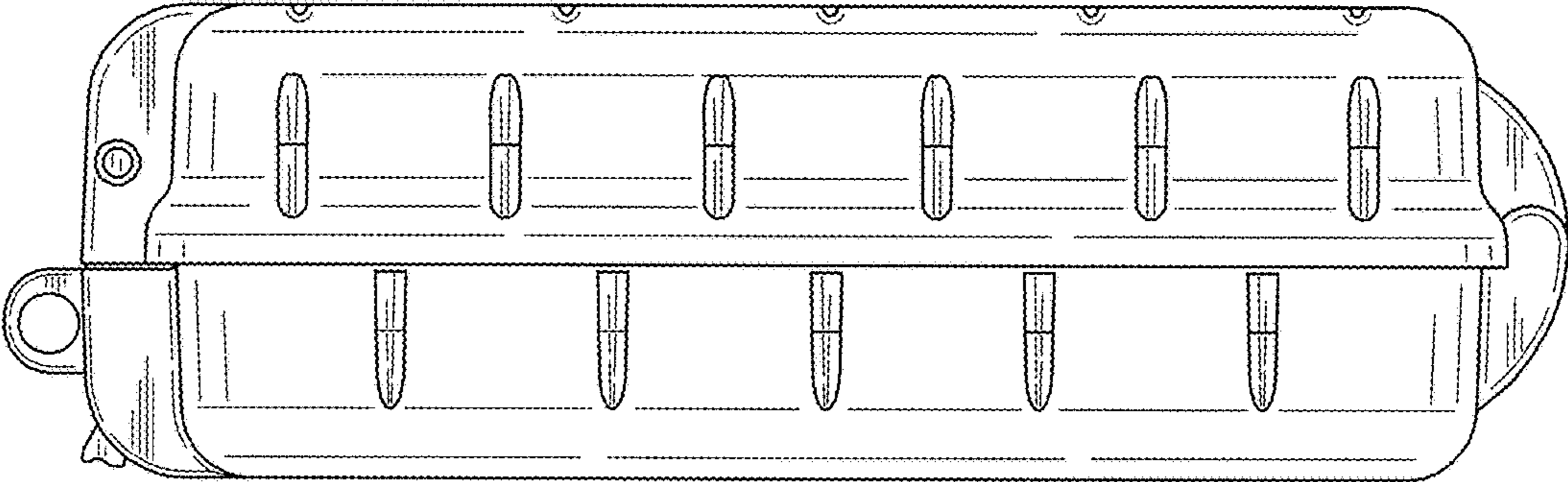
