(57) **CLAIM**

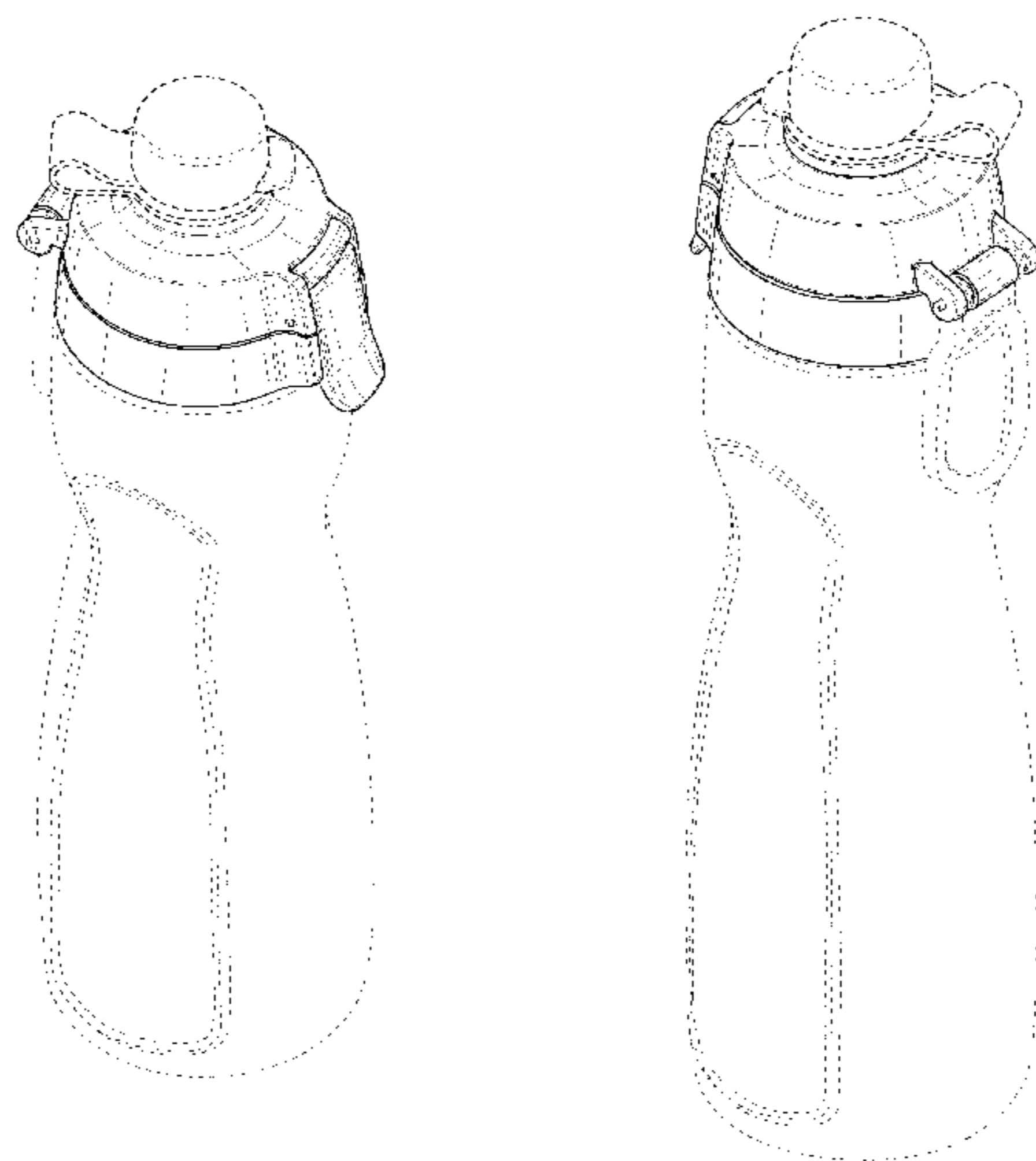
The ornamental design for a bottle cap, as shown and described.

**DESCRIPTION**

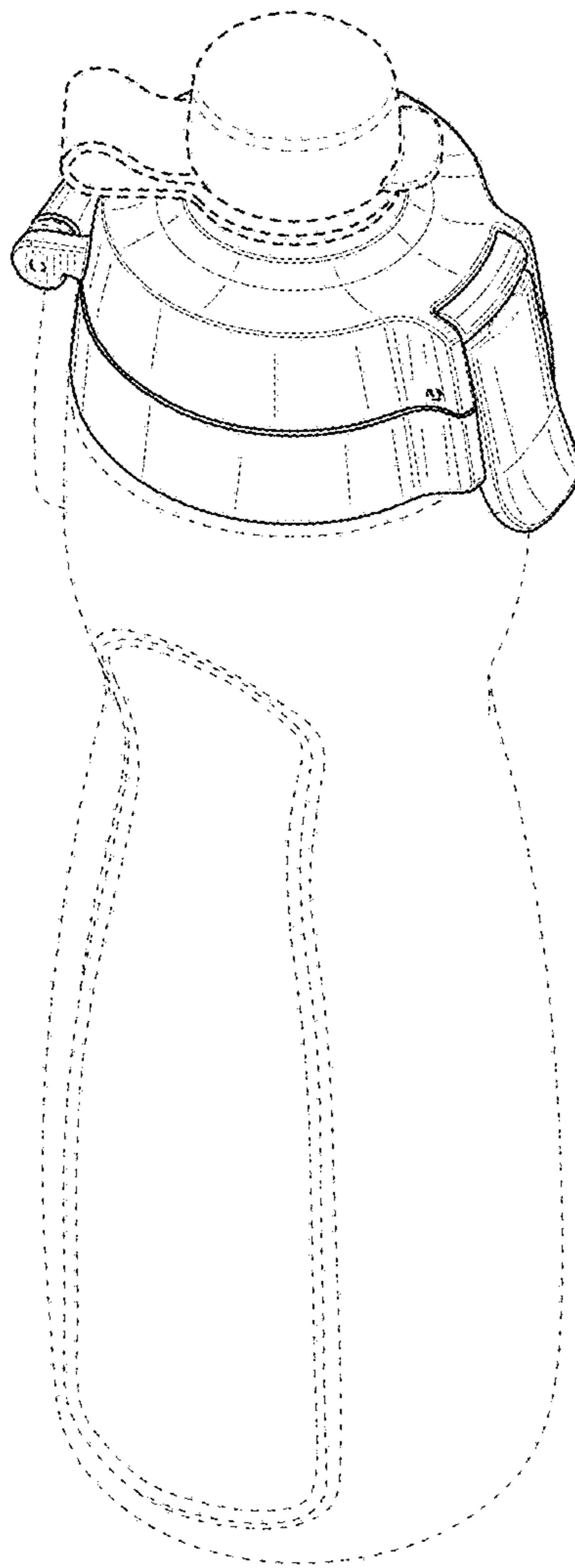

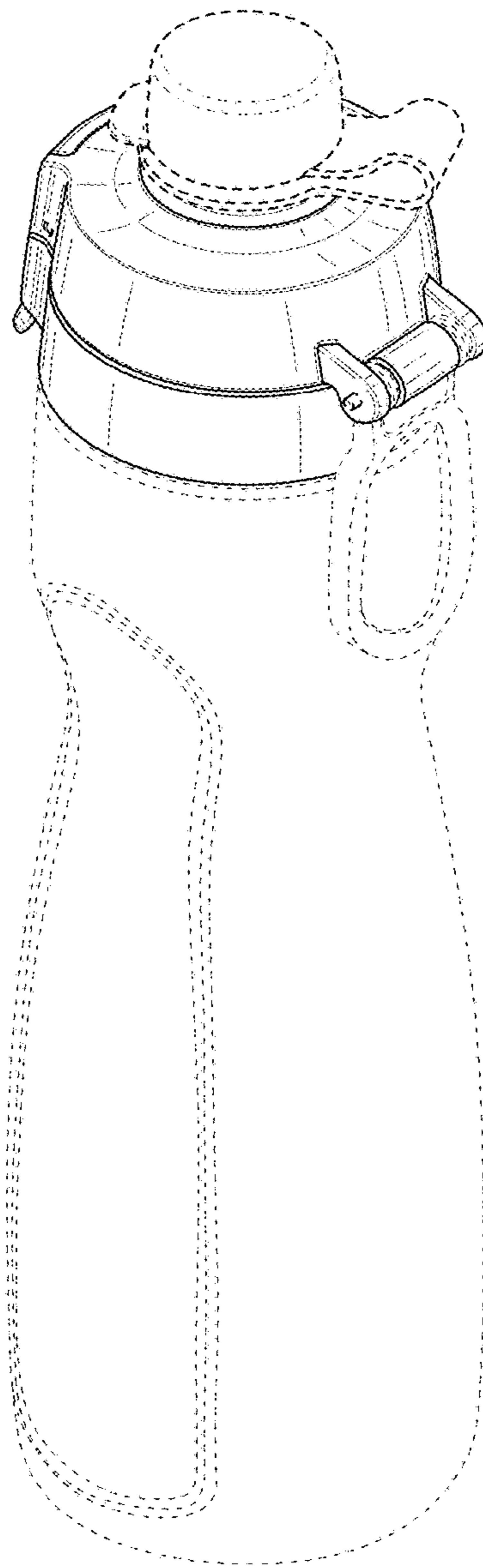

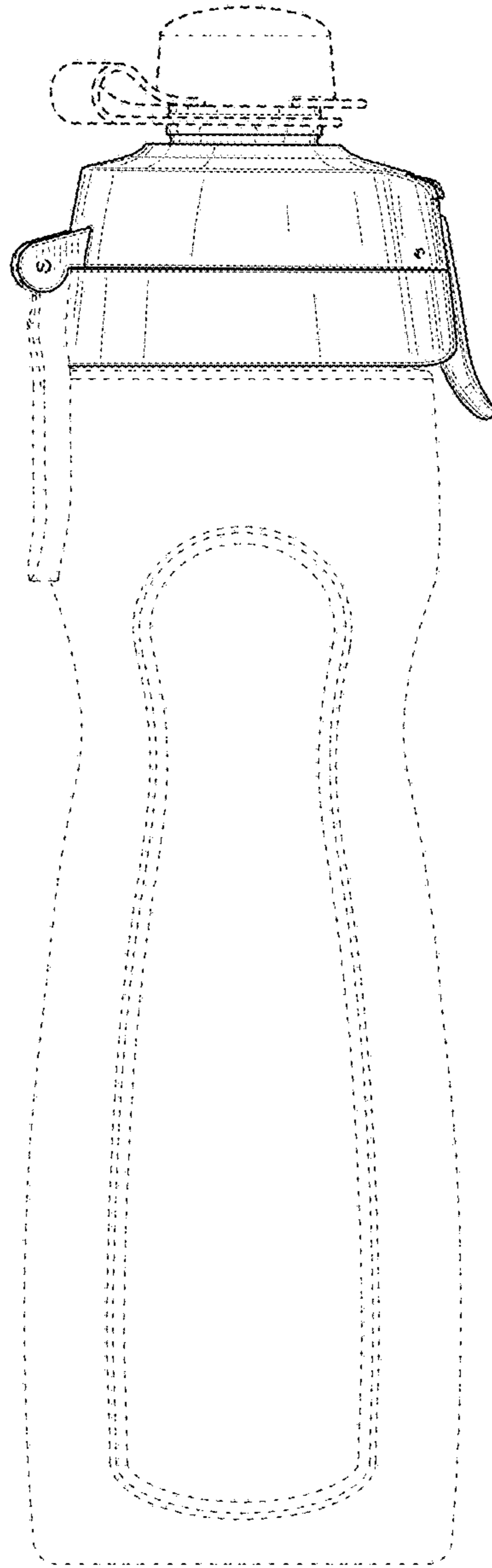

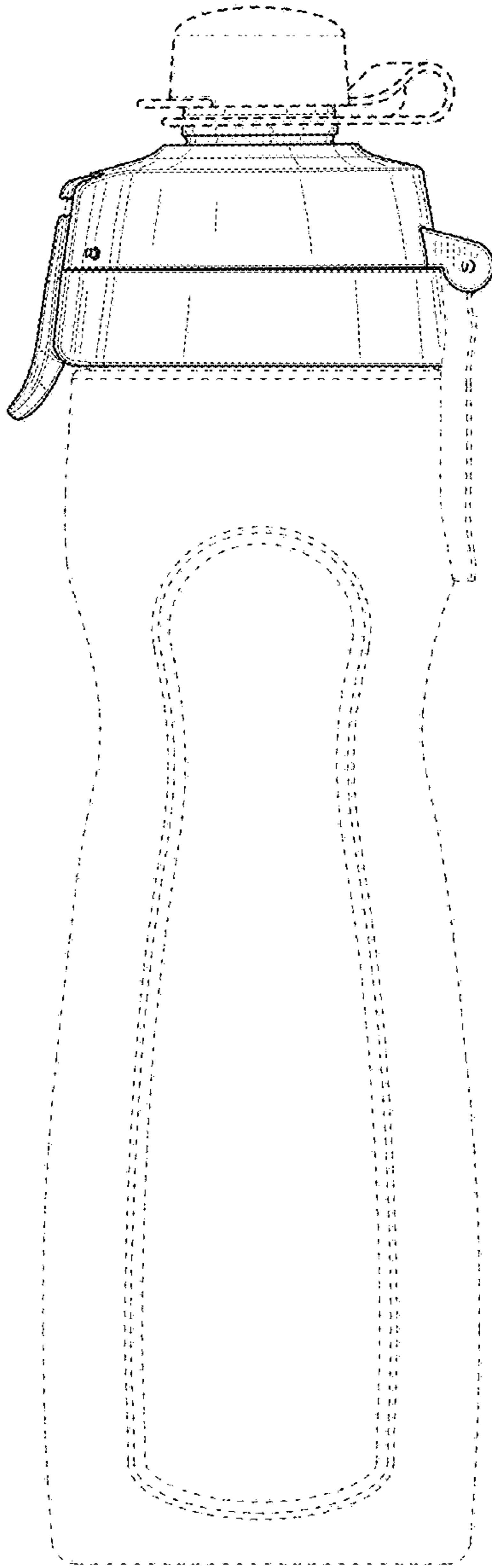

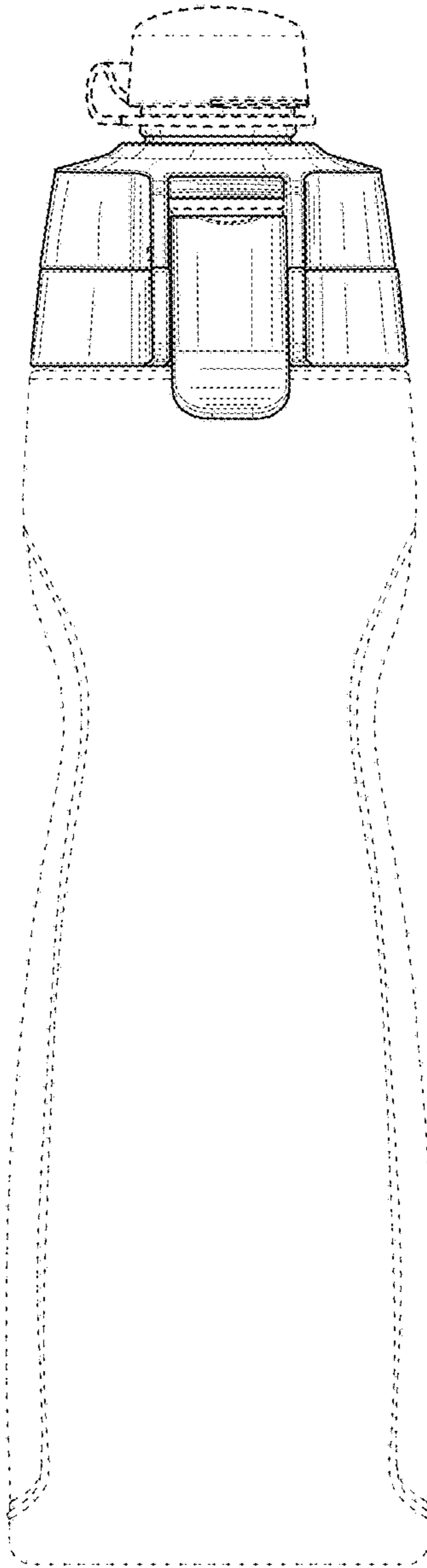

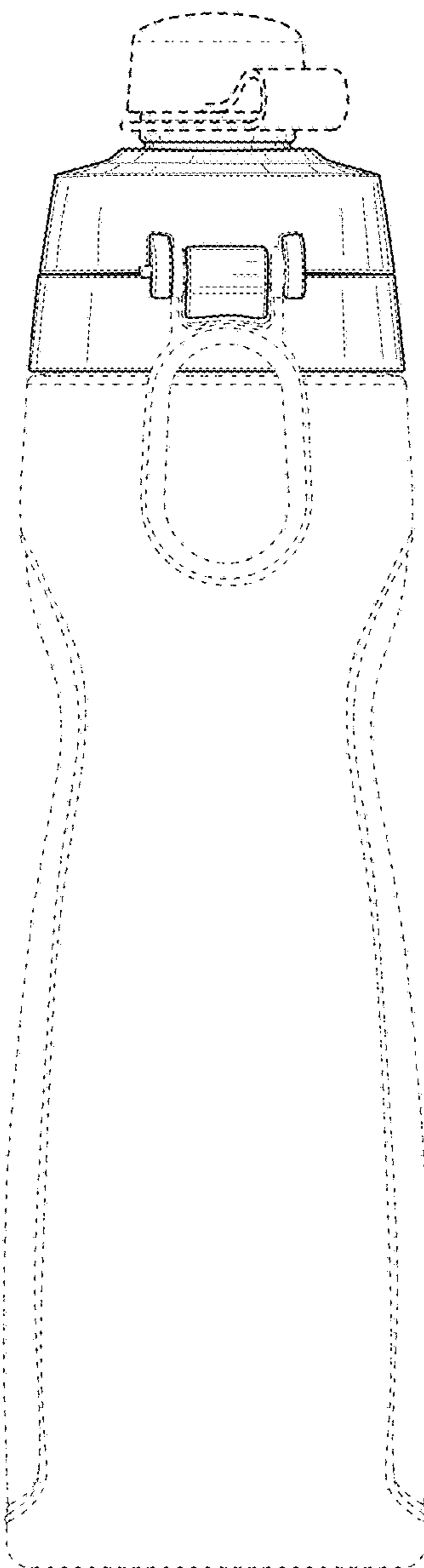

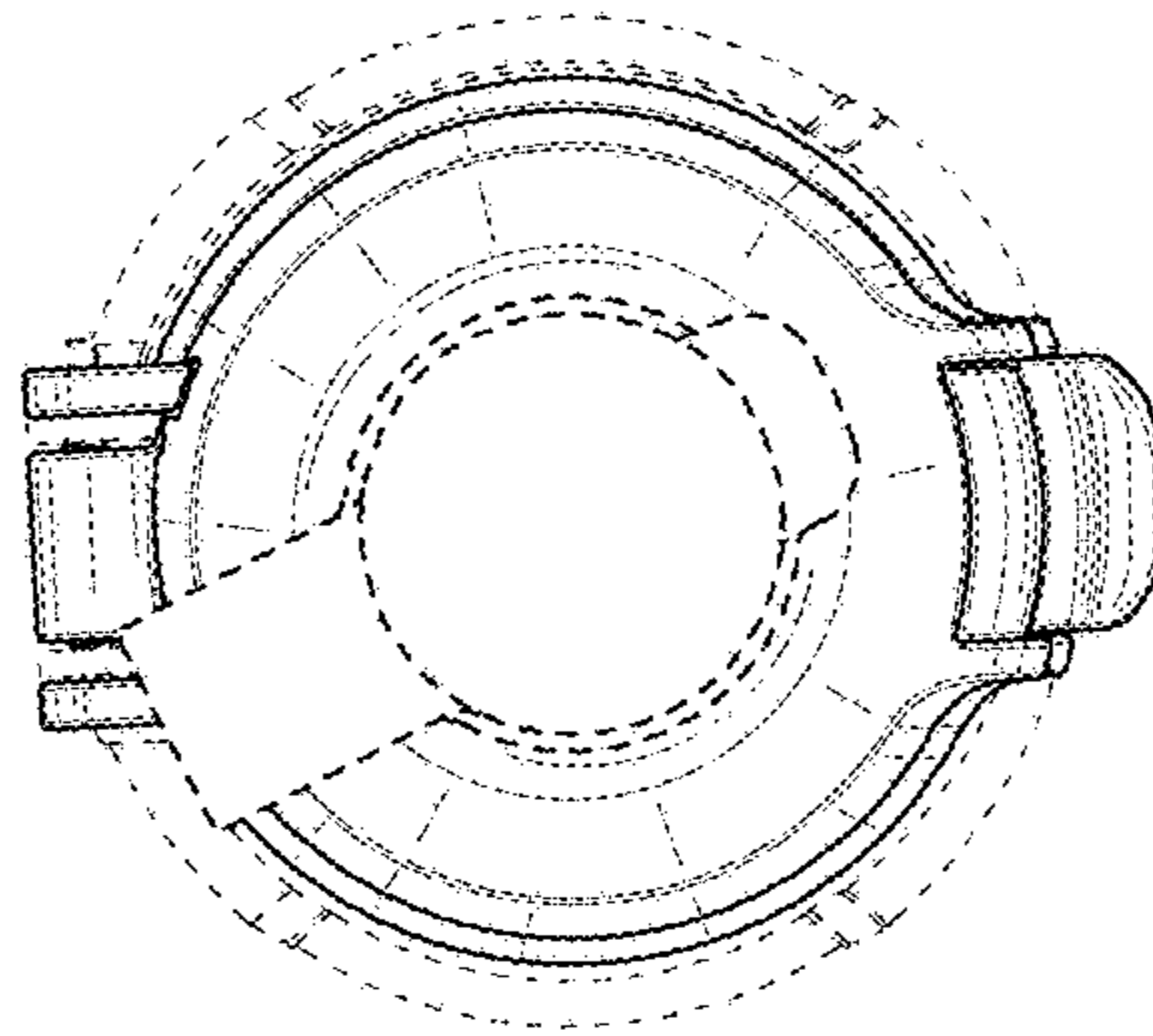

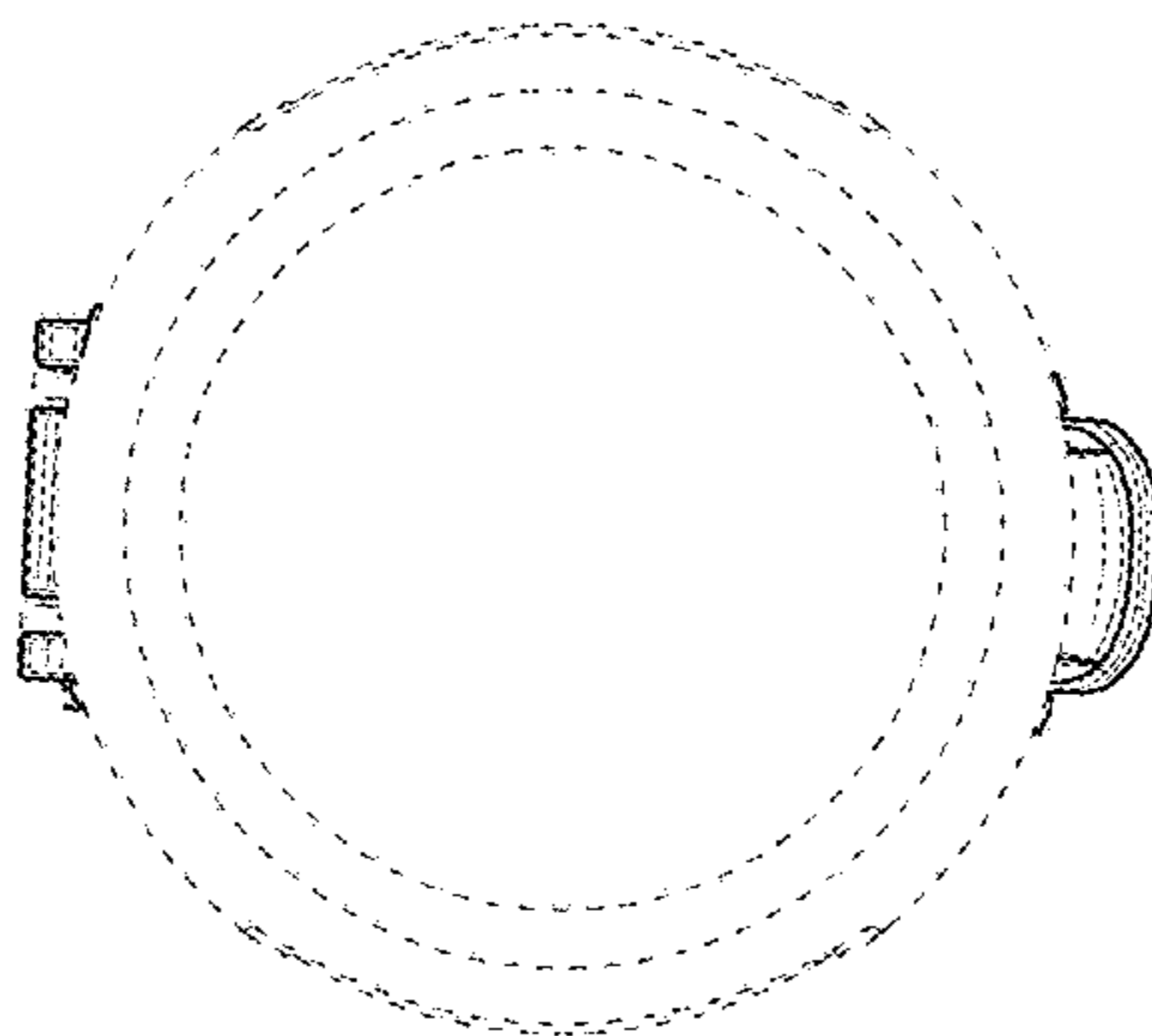
