(57) **CLAIM**

The ornamental design for tableware, as shown and described.

DESCRIPTION

FIG. 1 is a top view of tableware showing my design;
 FIG. 2 is a sectional view taken from line 2-2 in FIG. 1;
 FIG. 3 is a left side view thereof;
 FIG. 4 is a right side view thereof;
 FIG. 5 is a front view thereof;
 FIG. 6 is a bottom view thereof;
 FIG. 7 is a top perspective view thereof; and,
 FIG. 8 is an enlarged view of the encircled portion in FIG. 1.

The rear view is a mirror image of the front view.
 The broken lines encircling and referencing enlargements and the broken lines forming the cross-section markers form no part of the claimed design.

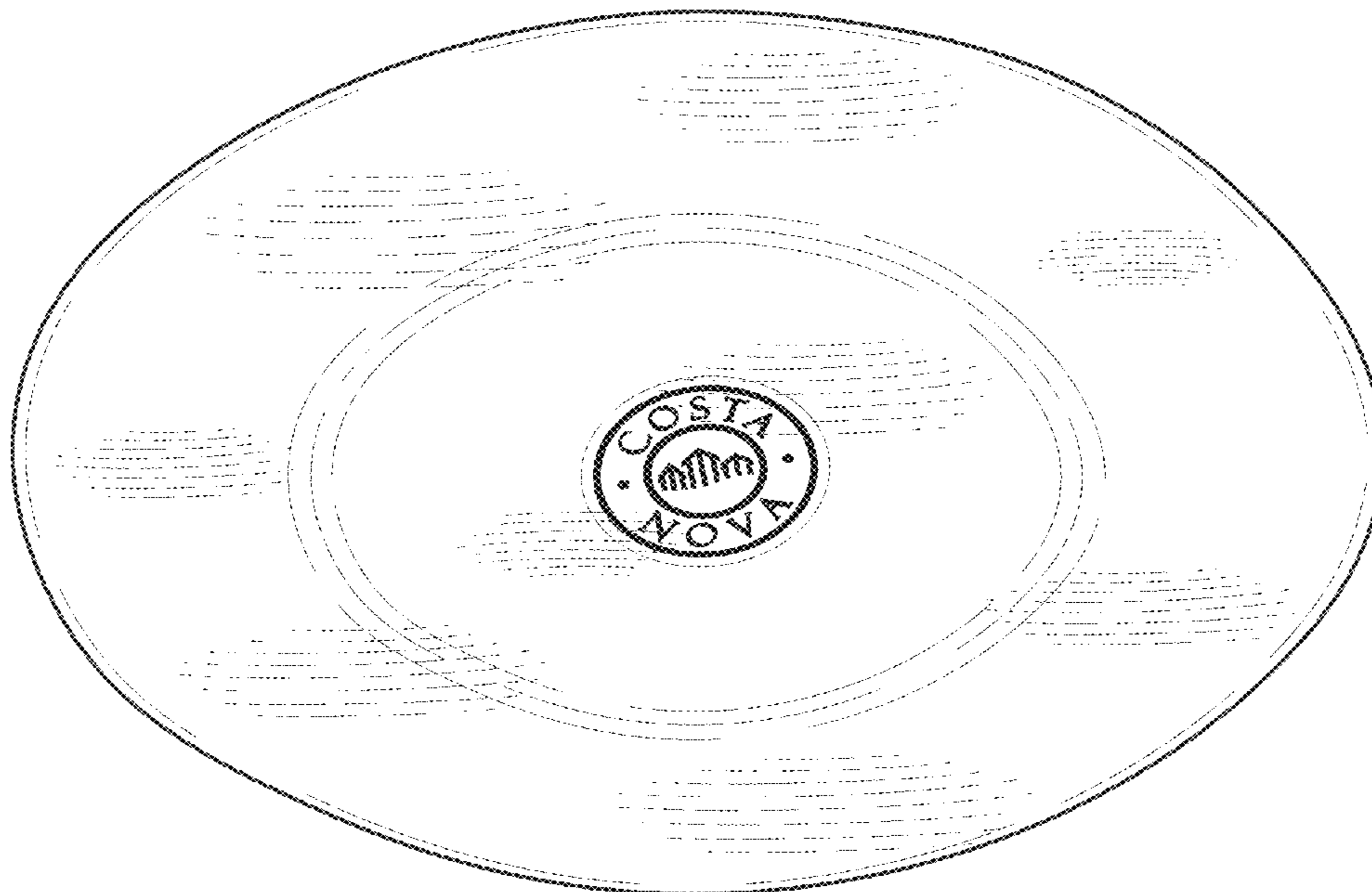

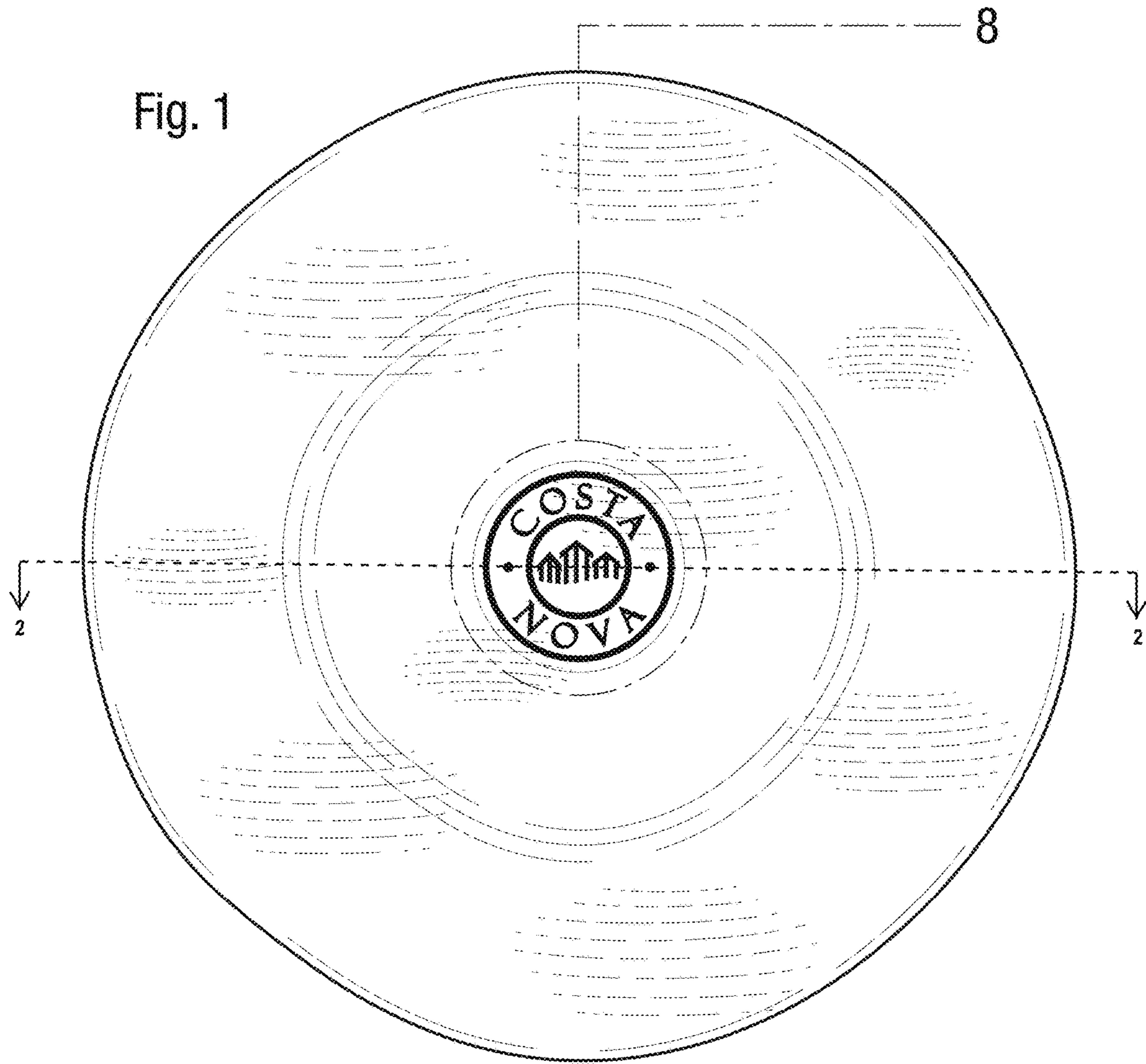

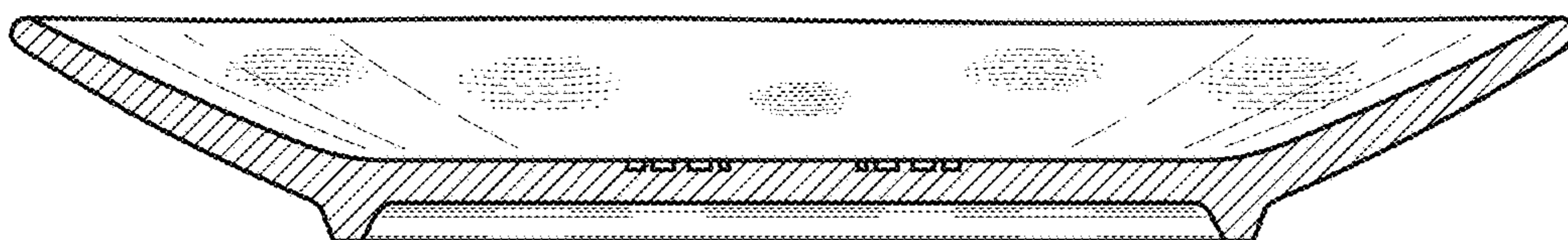

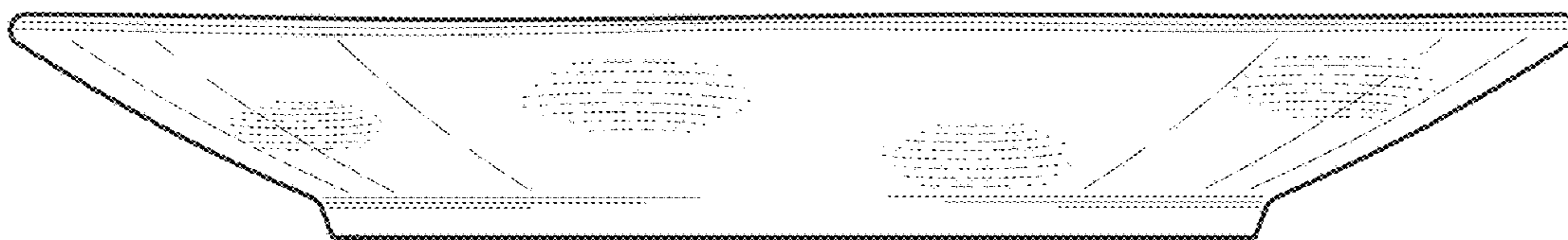

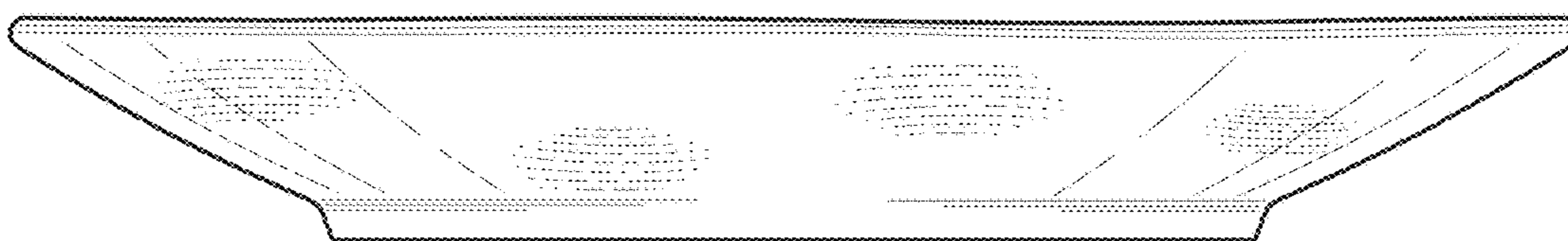

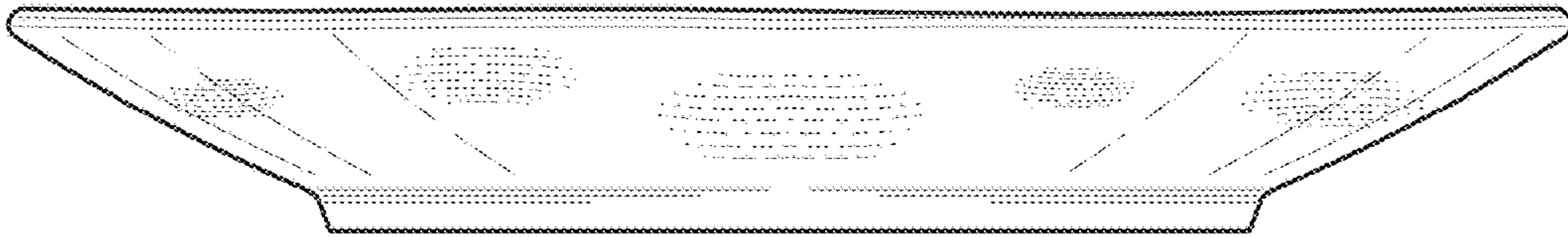

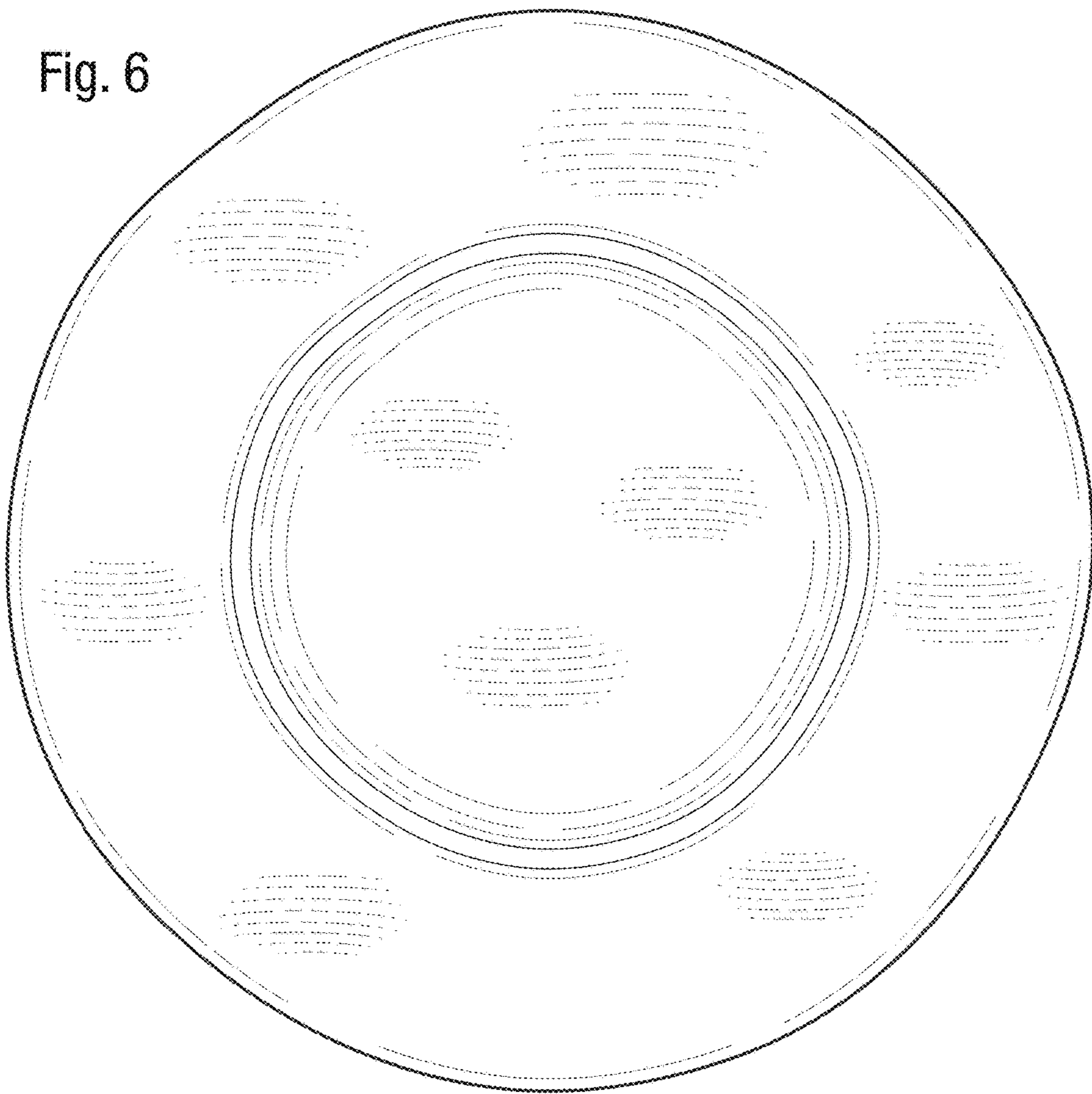

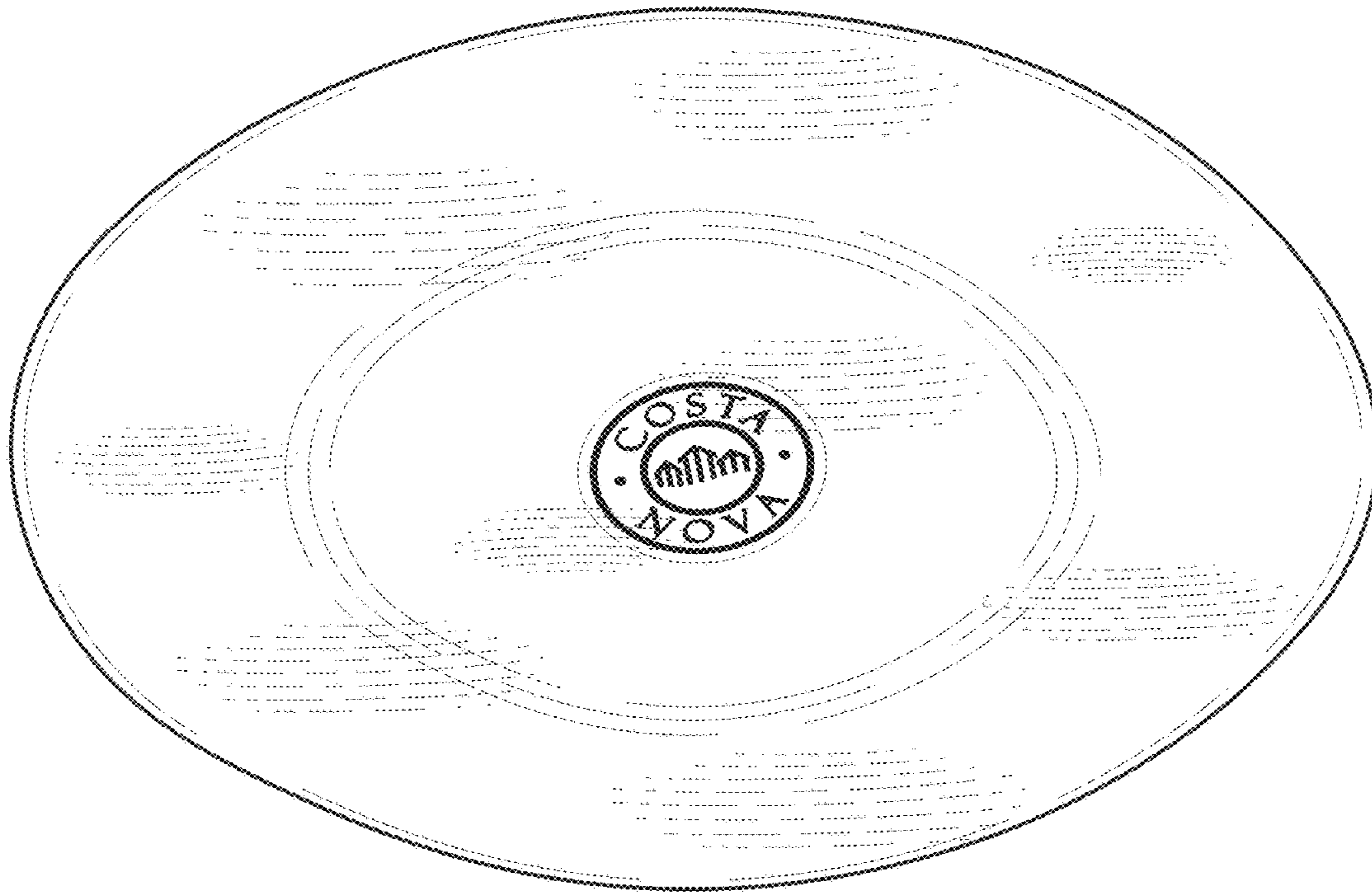
