(57) **CLAIM**

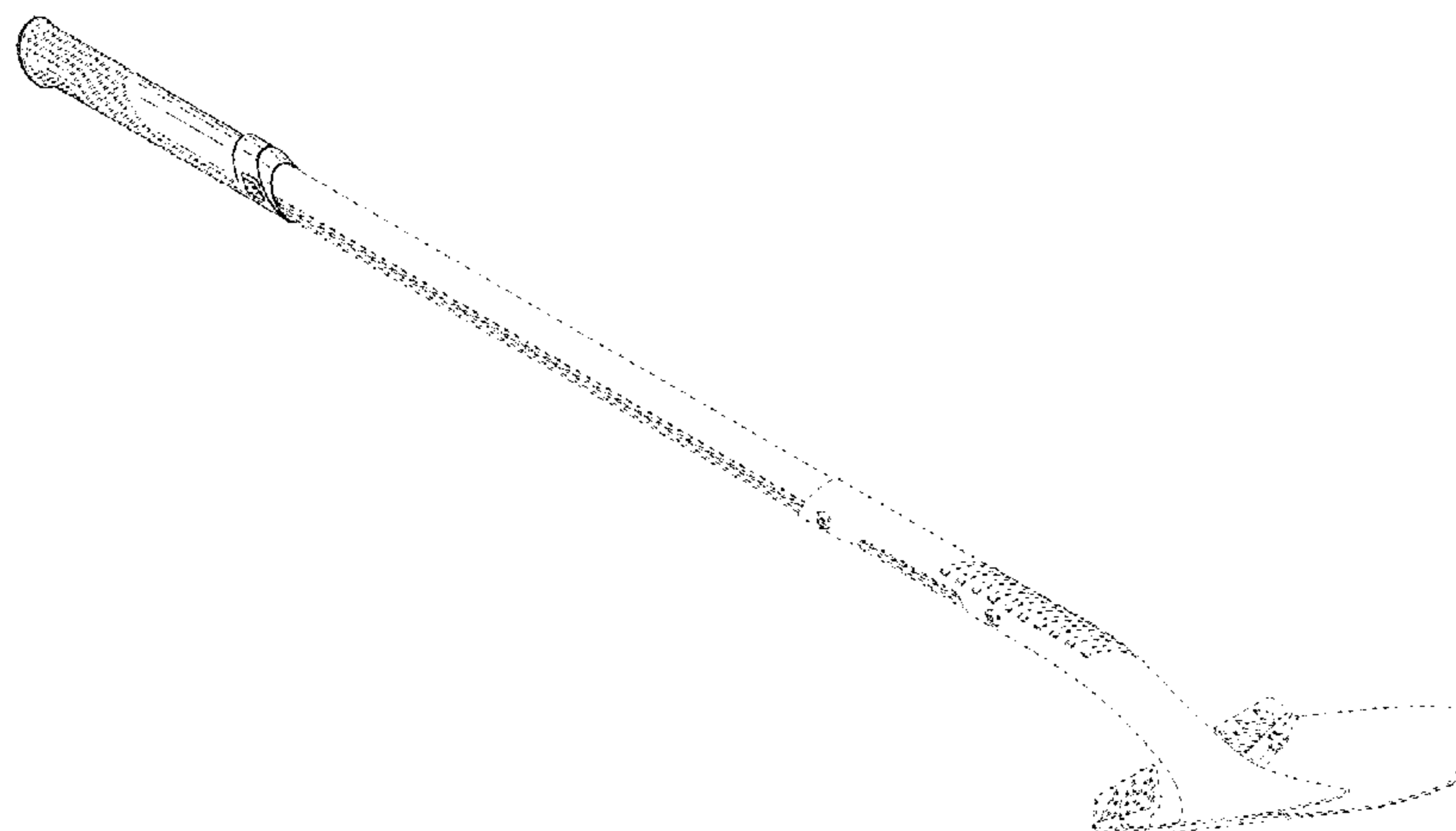
We claim the ornamental design for a tool handle, as shown and described.

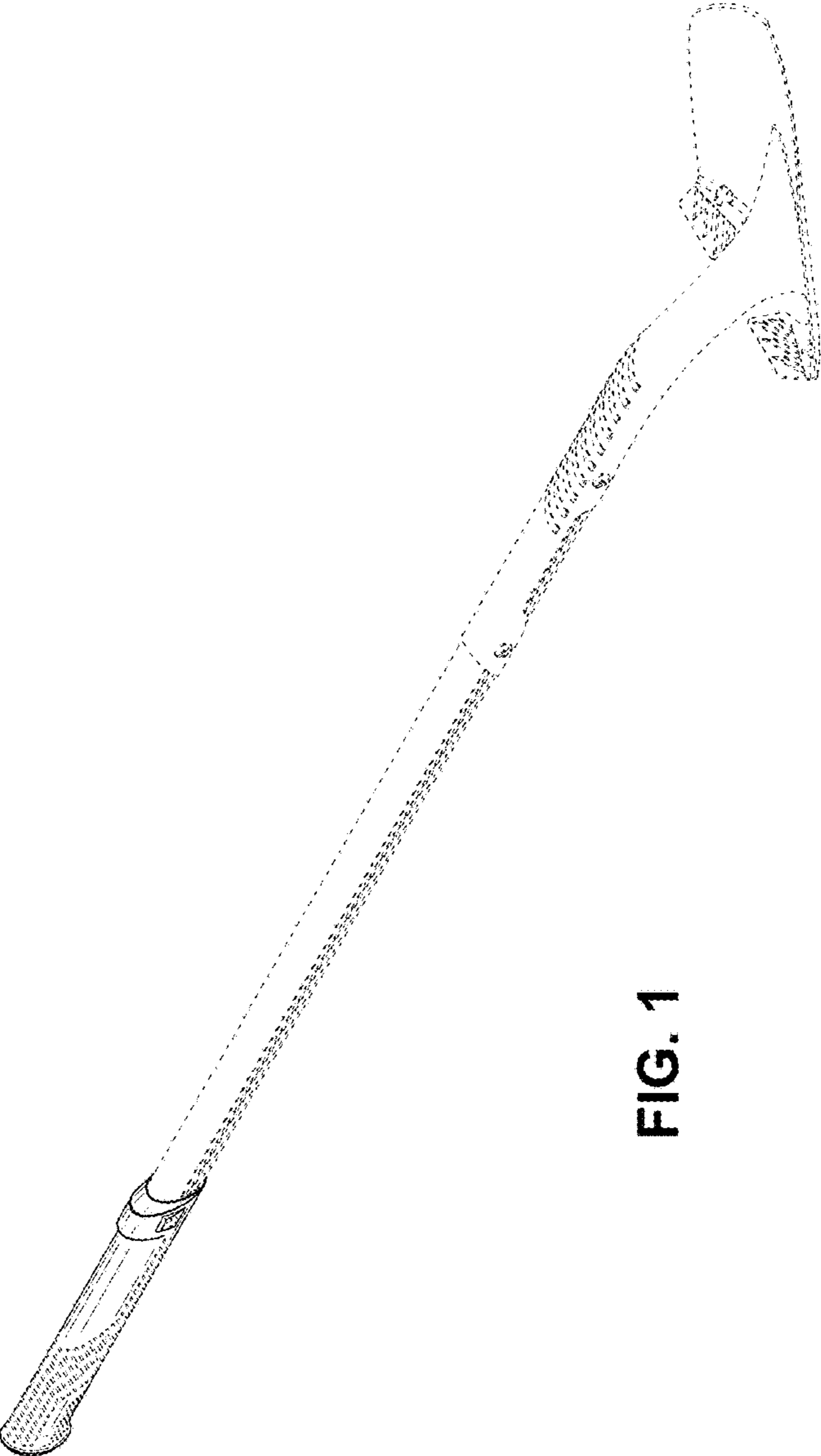

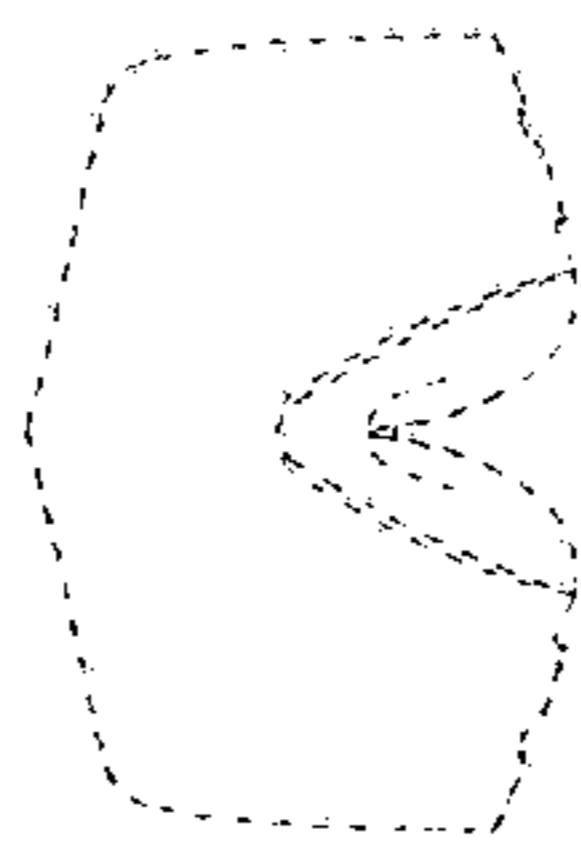

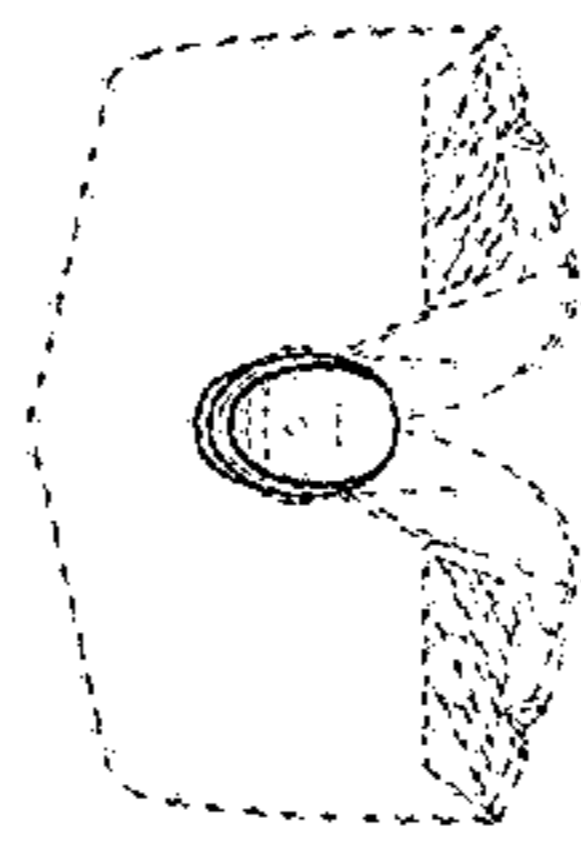

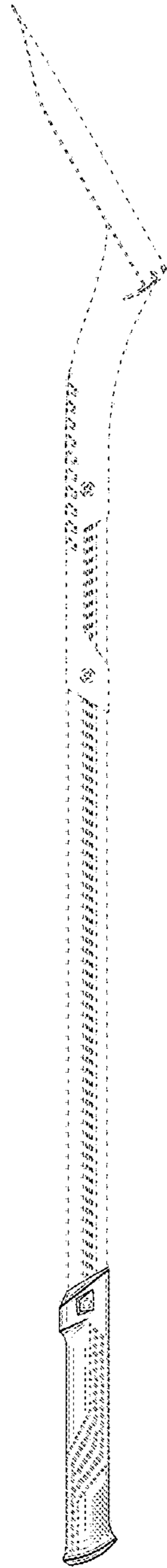

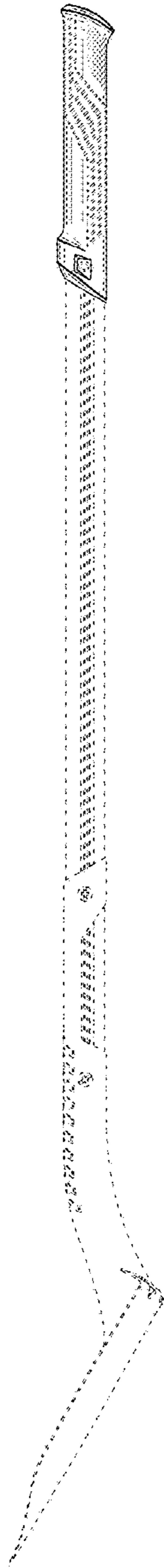

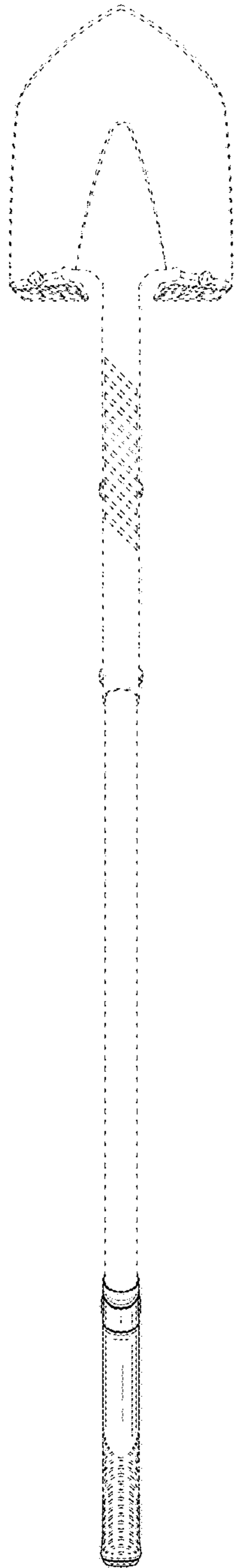

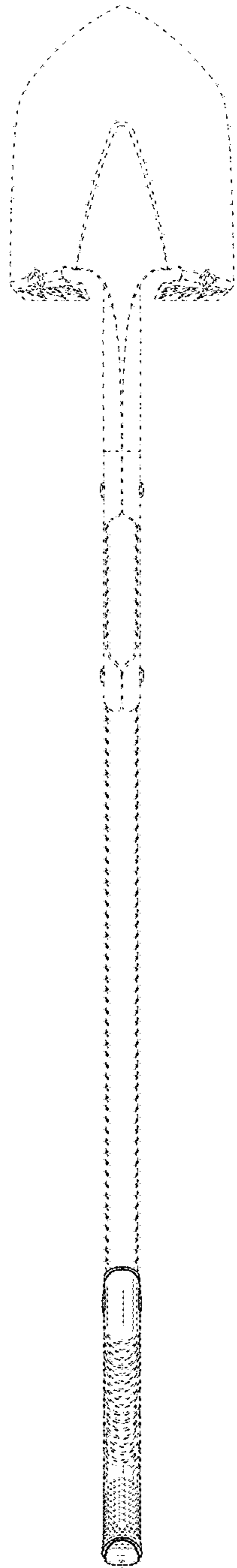

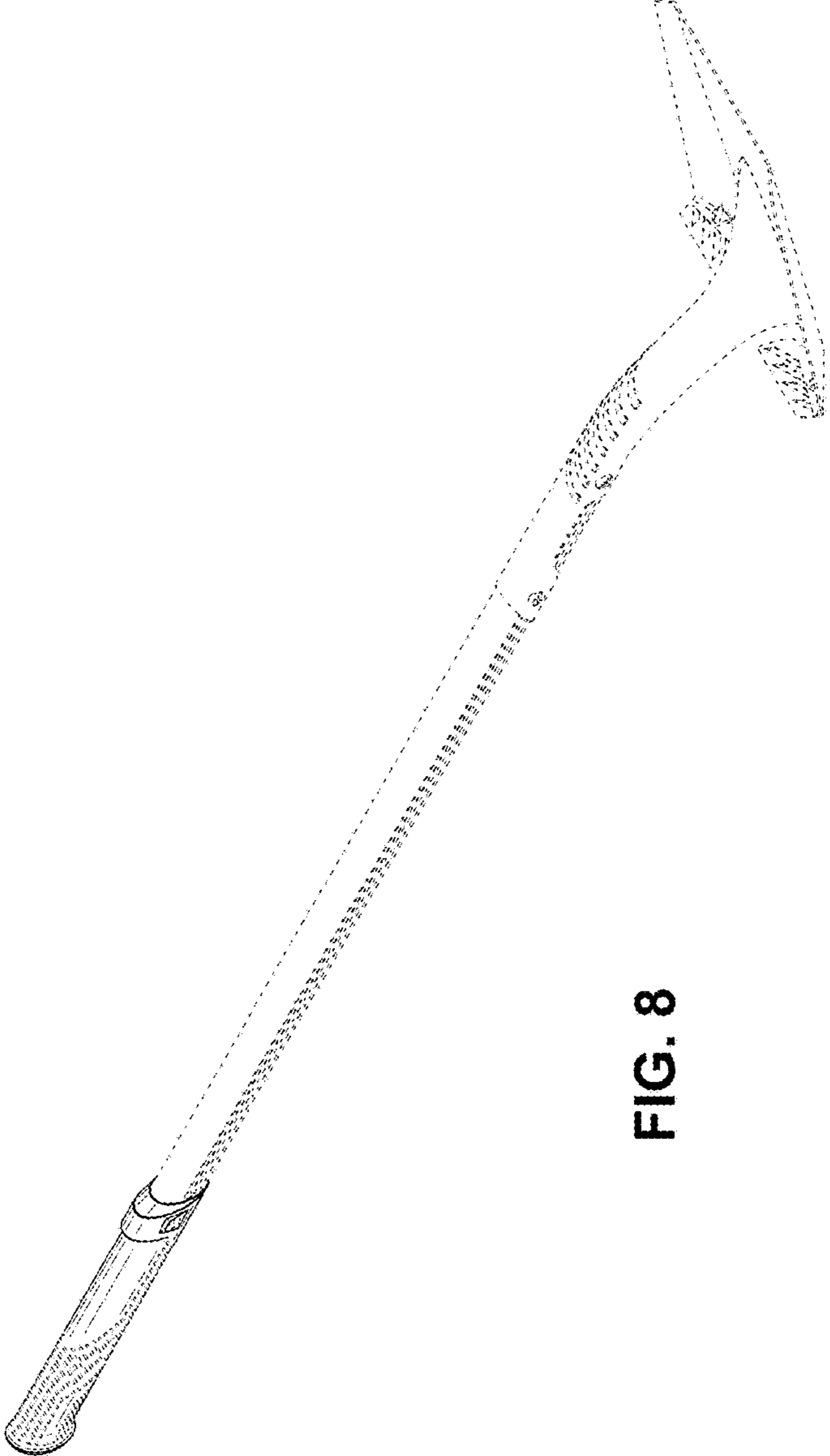

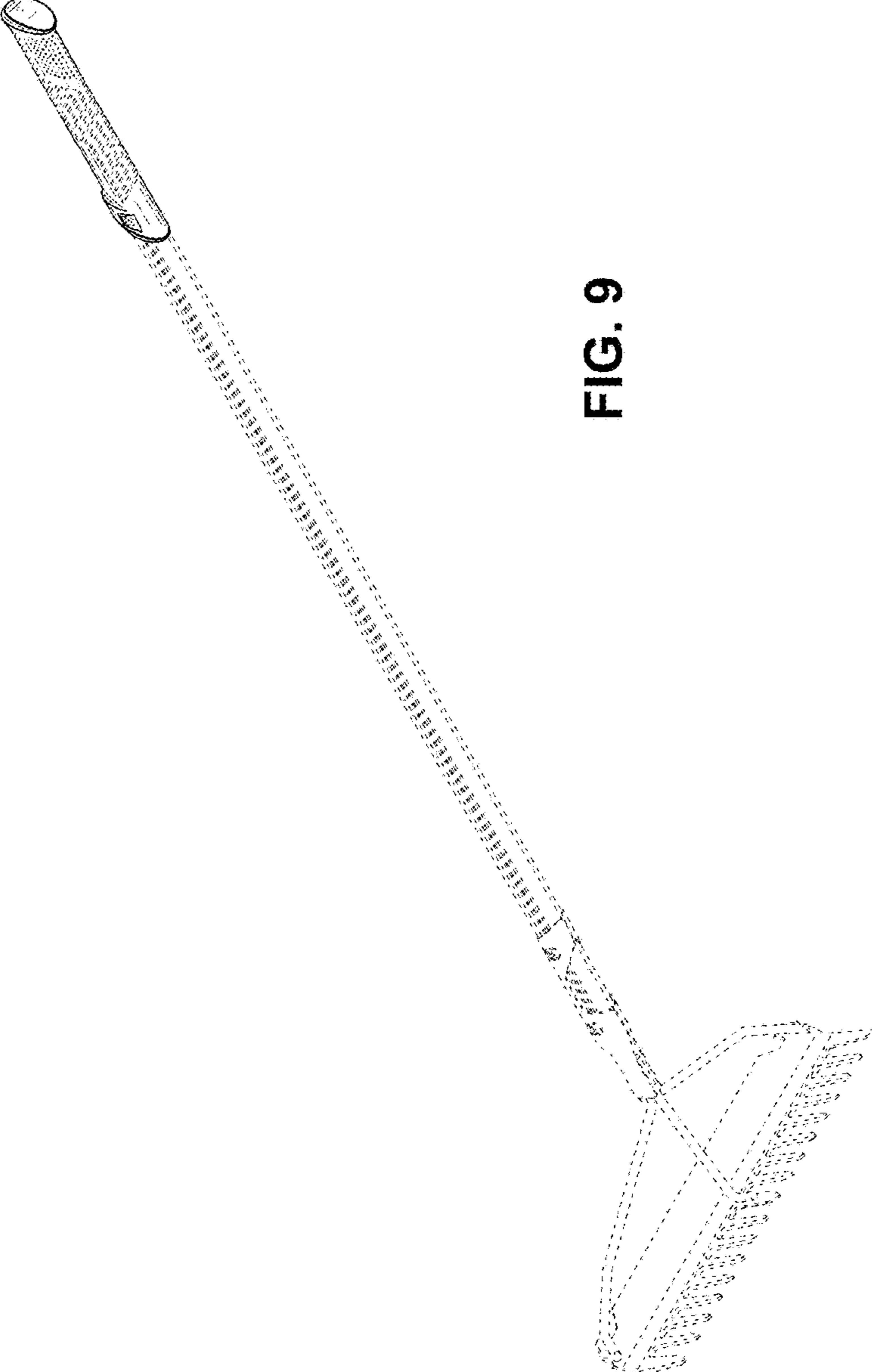
