The ornamental design for a shopping bag, as shown and described.

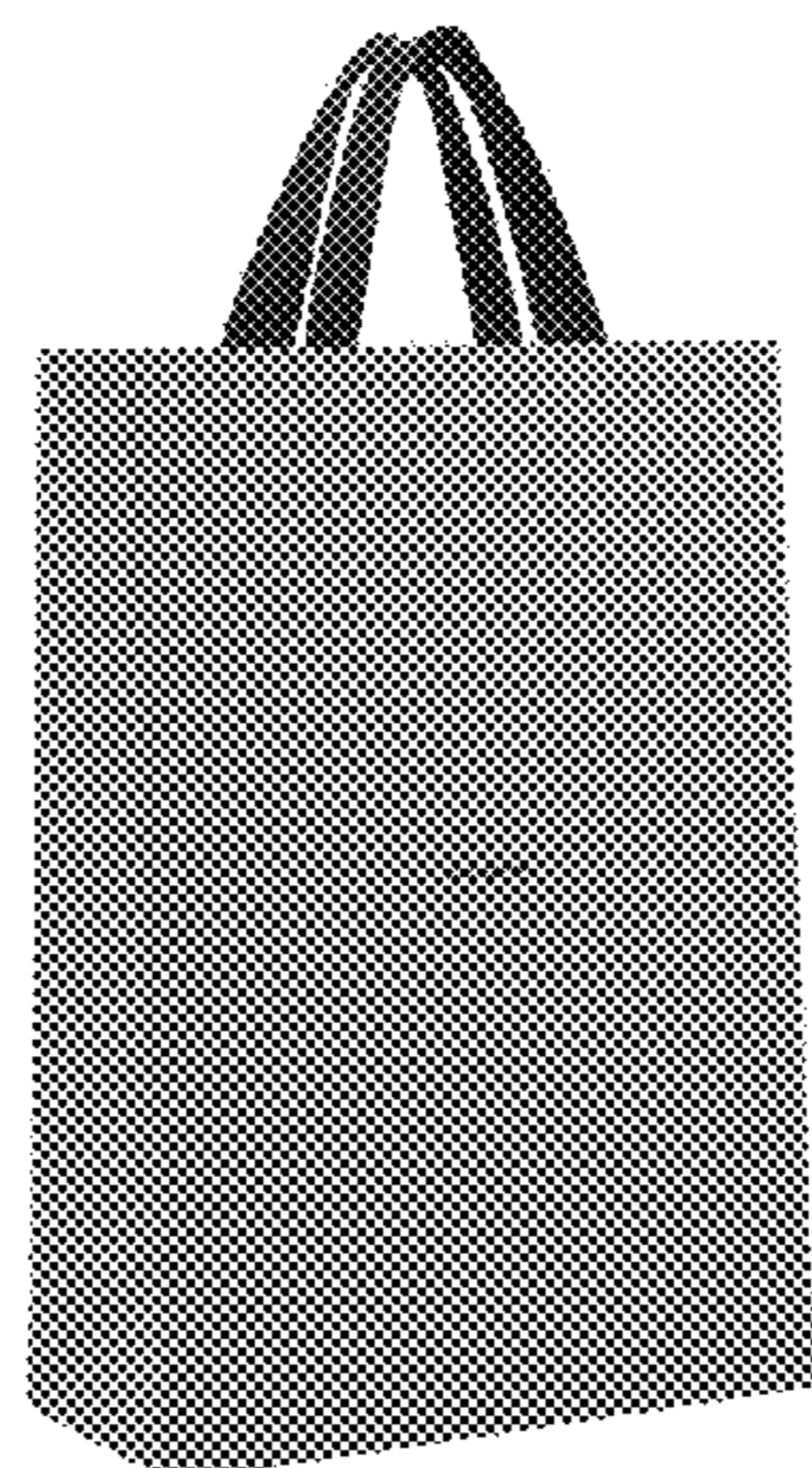
DESCRIPTION

FIG. 6 is a top plan view thereof, in which the interior of the shopping bag forms no part of the claimed design; and,
FIG. 7 is a bottom plan view thereof.

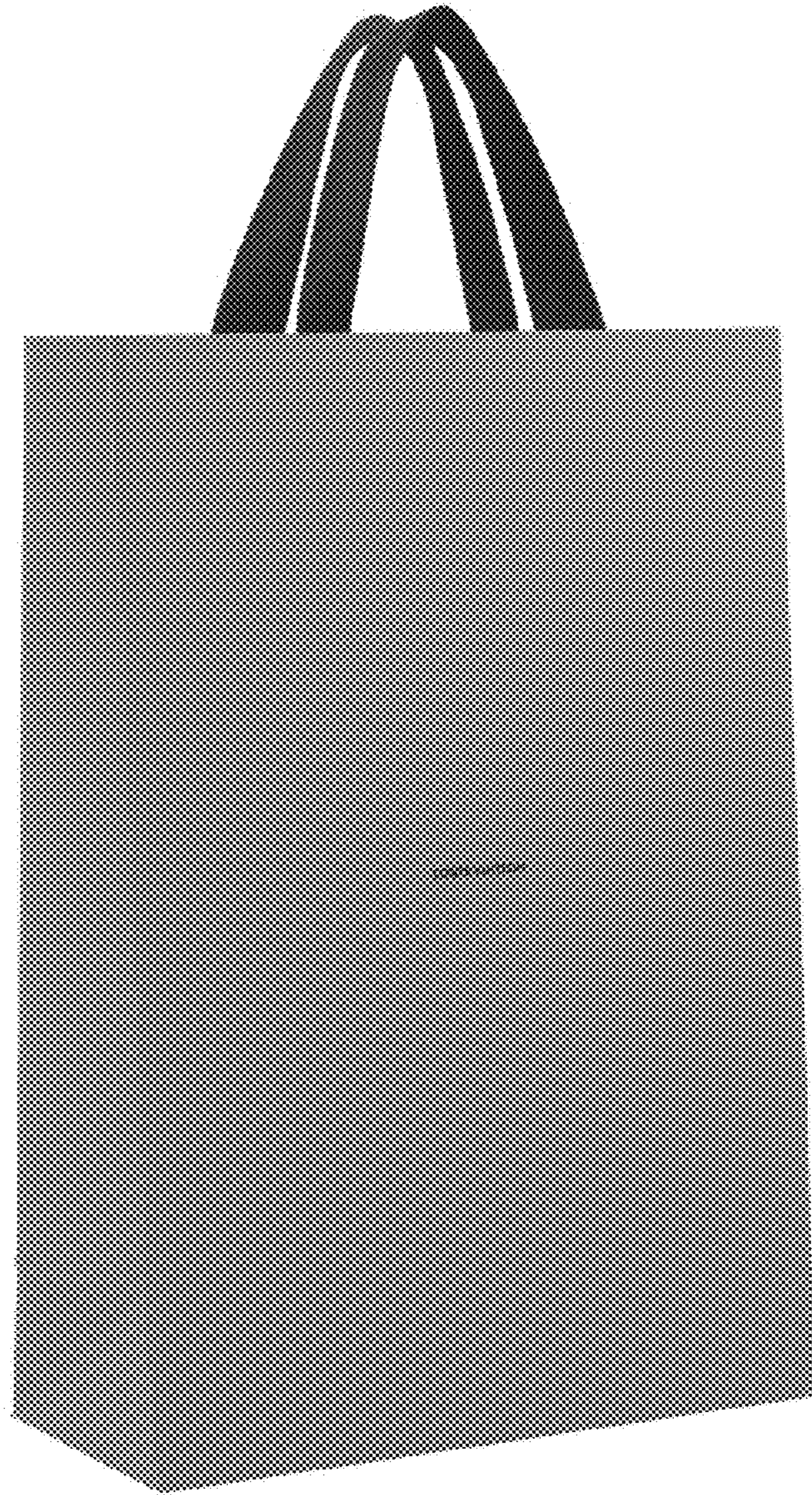

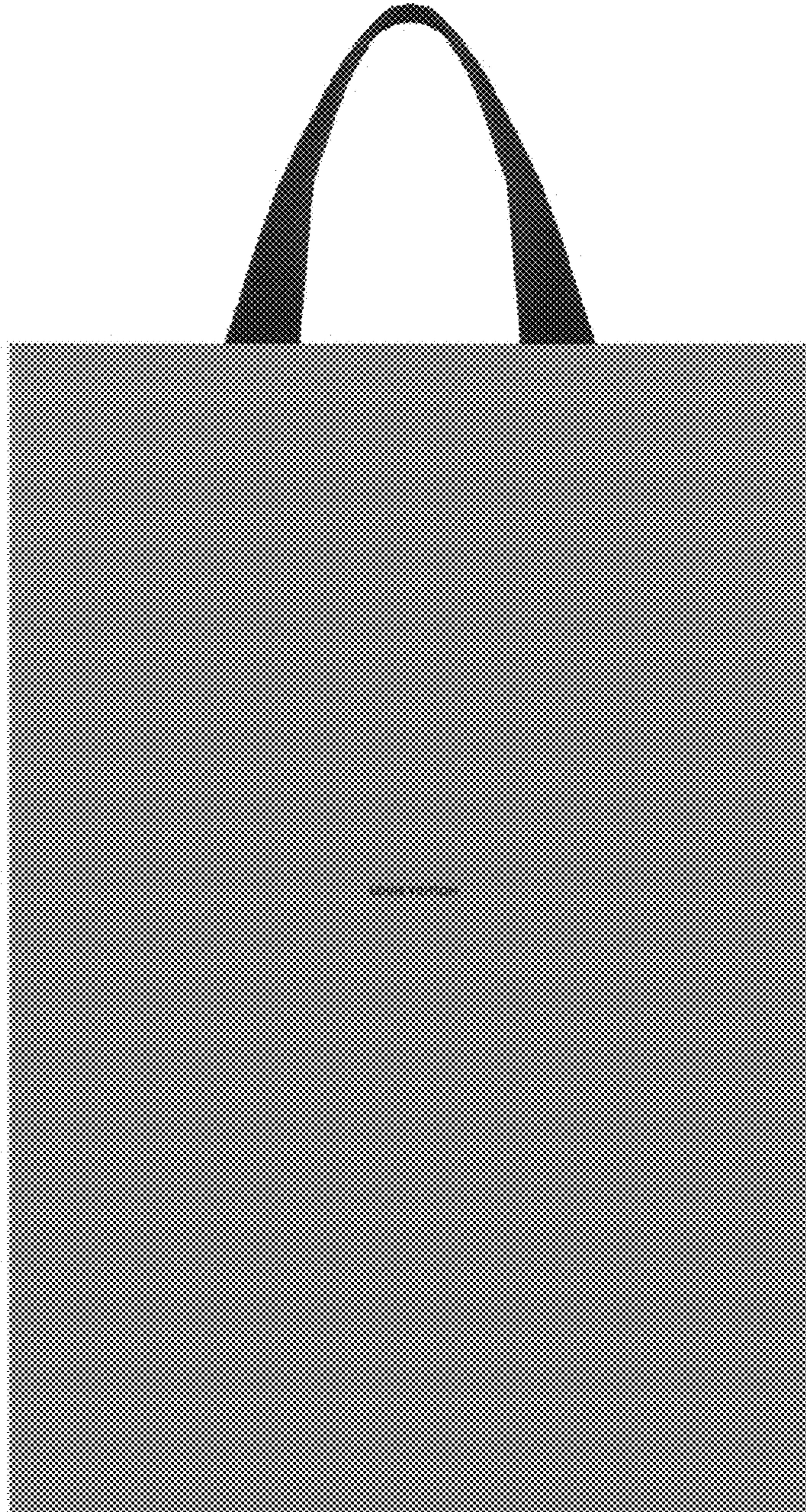

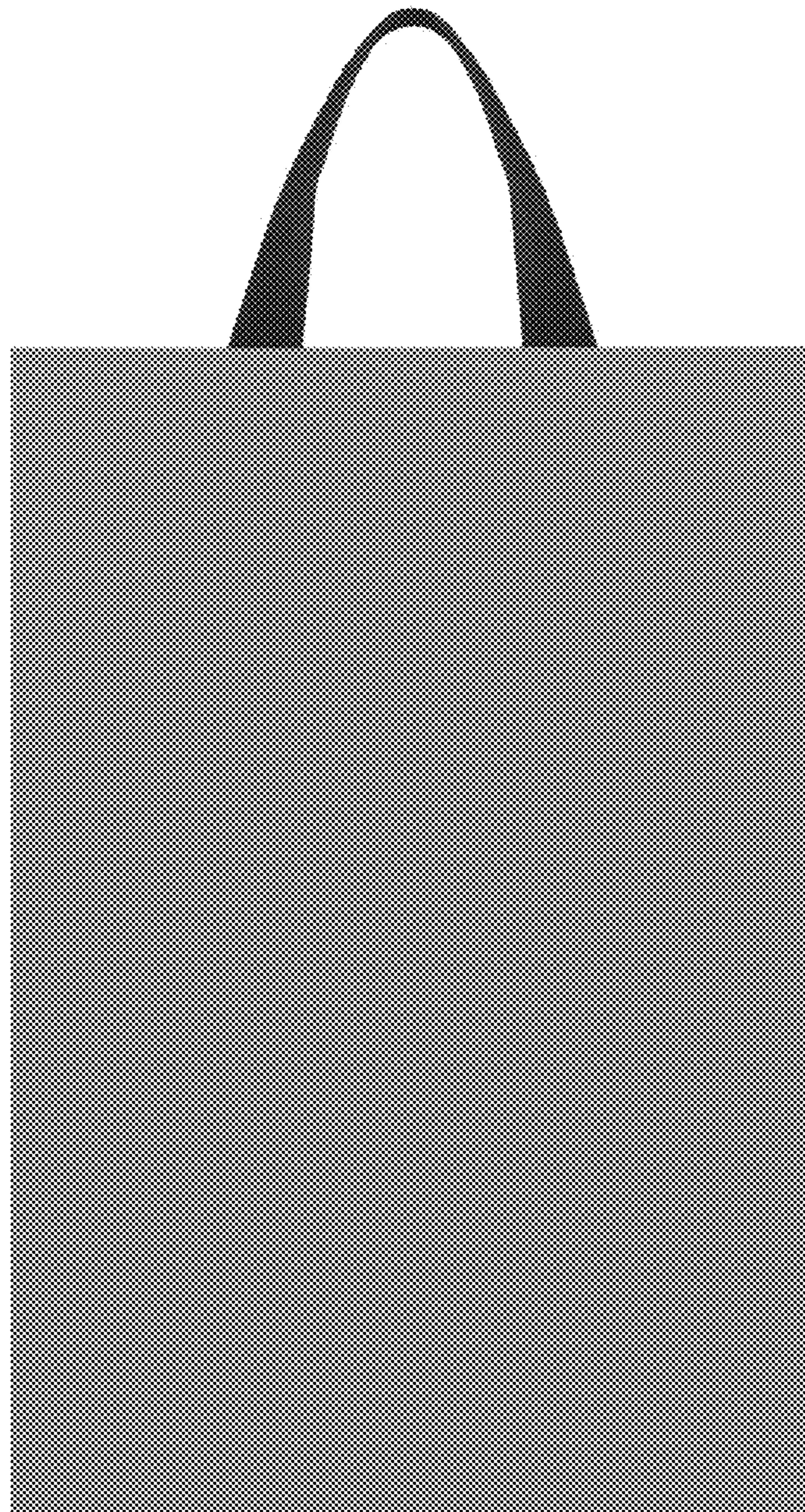

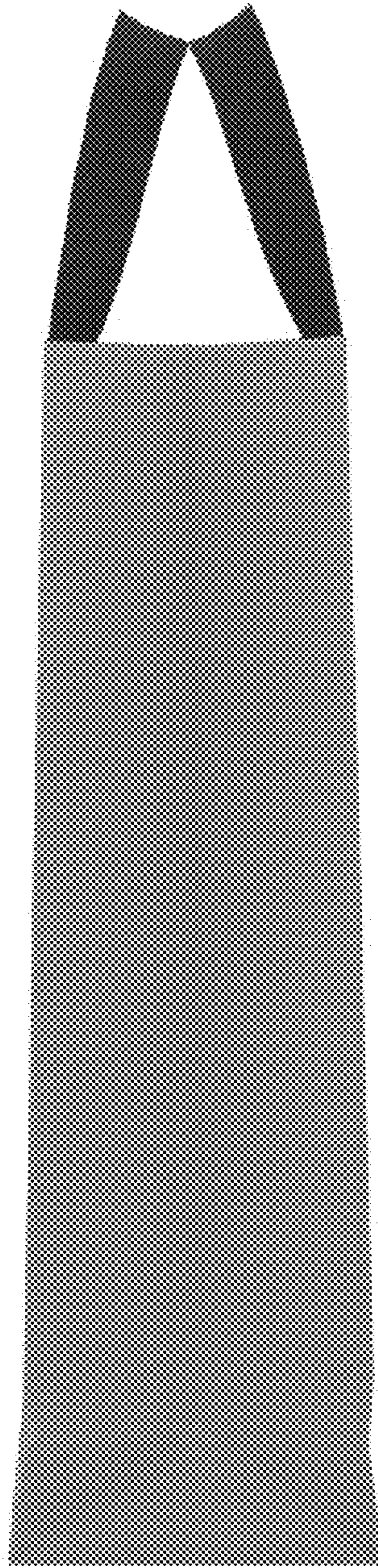

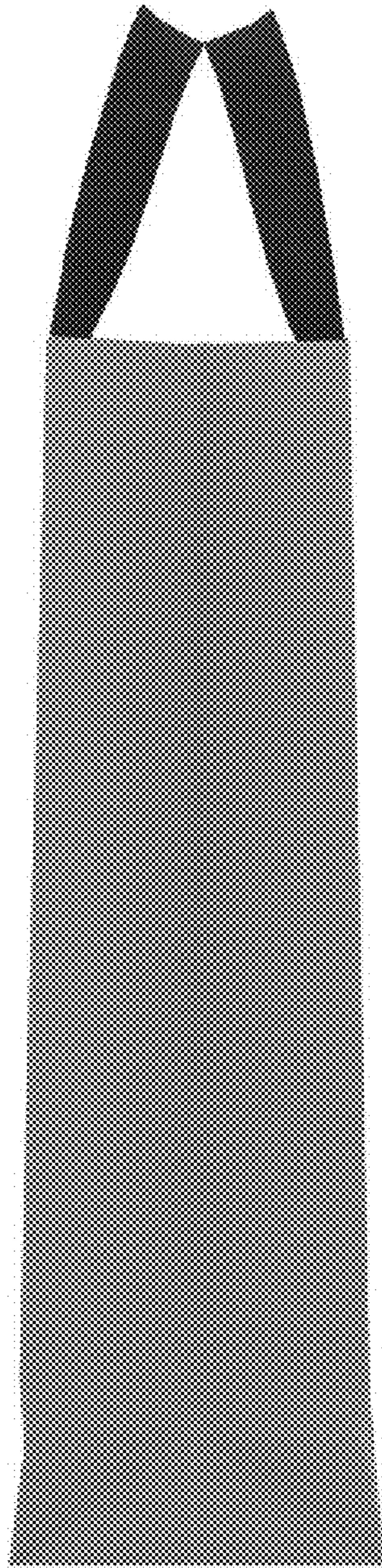

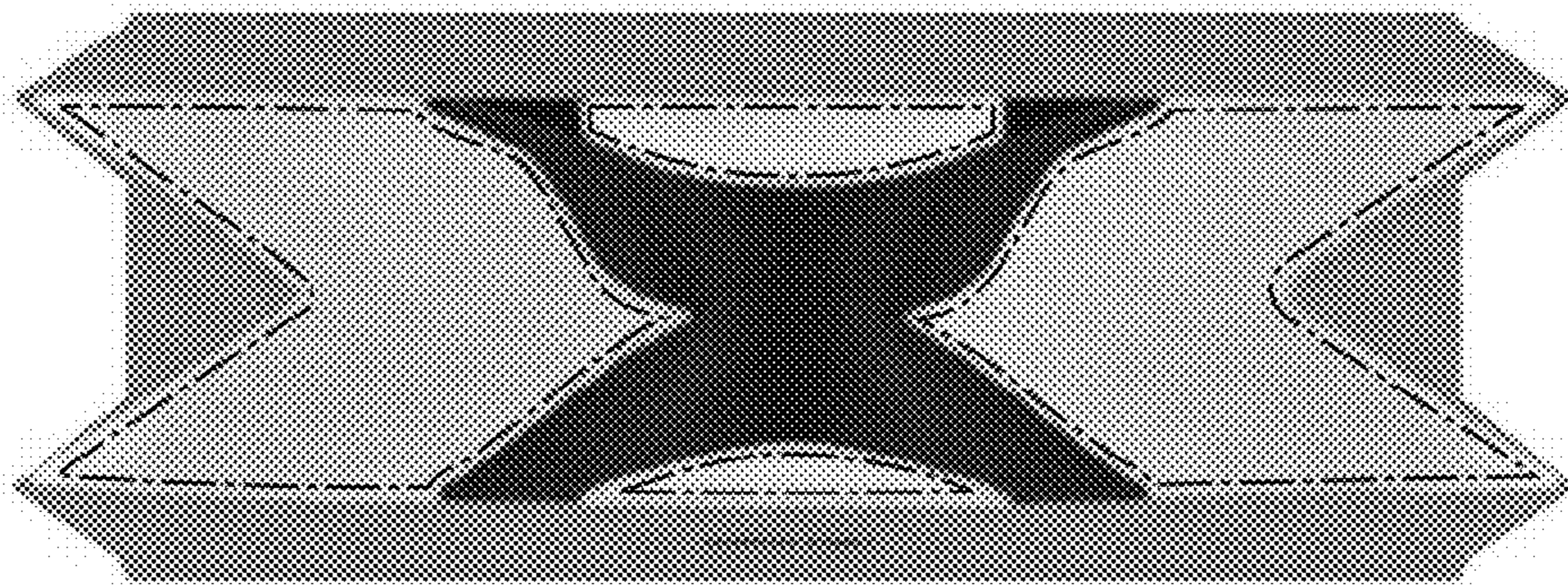

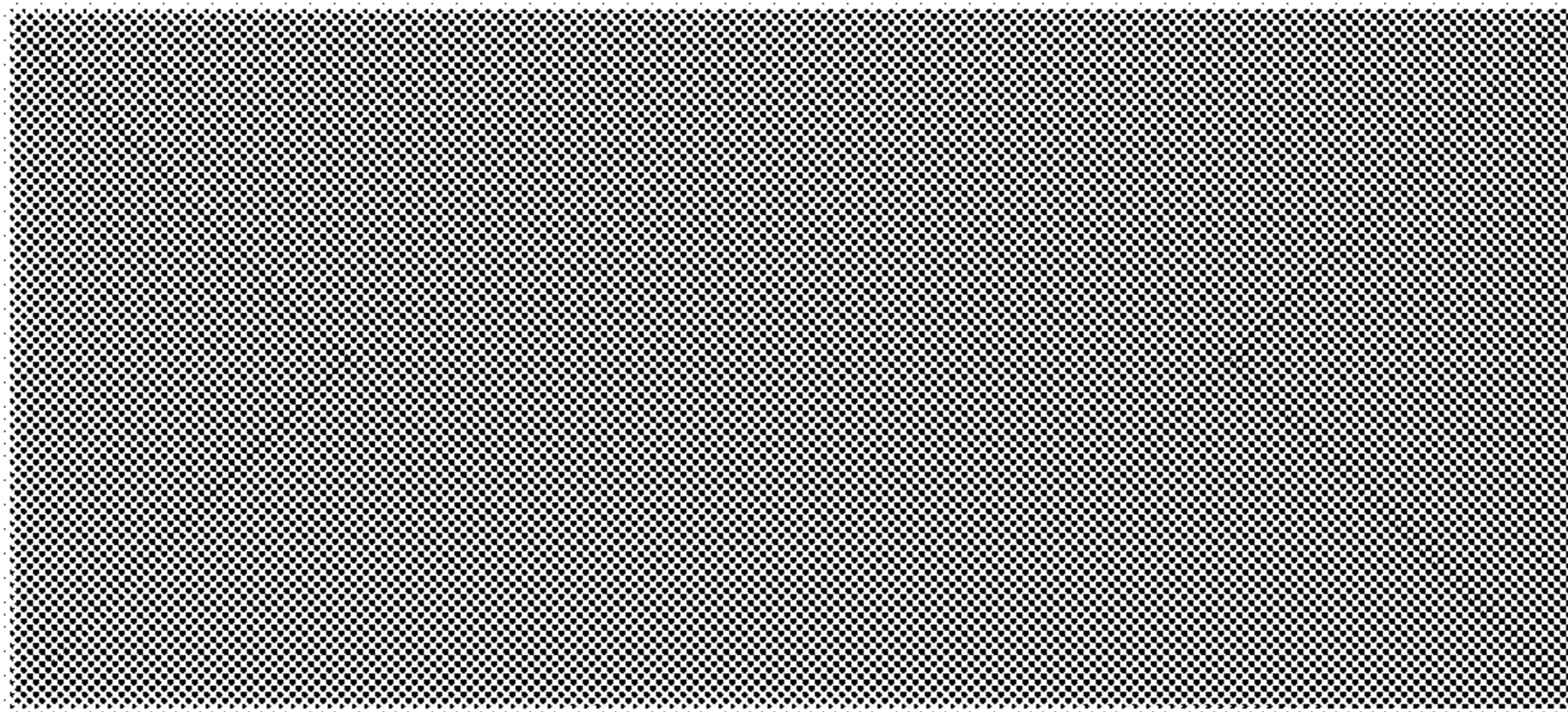
