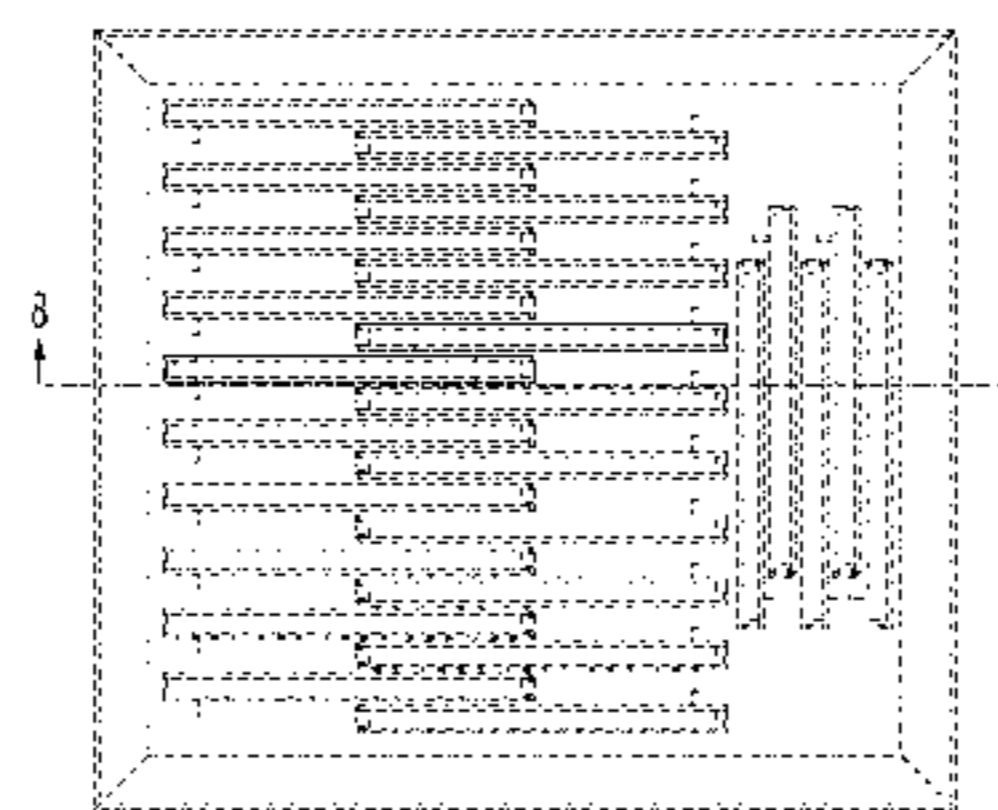
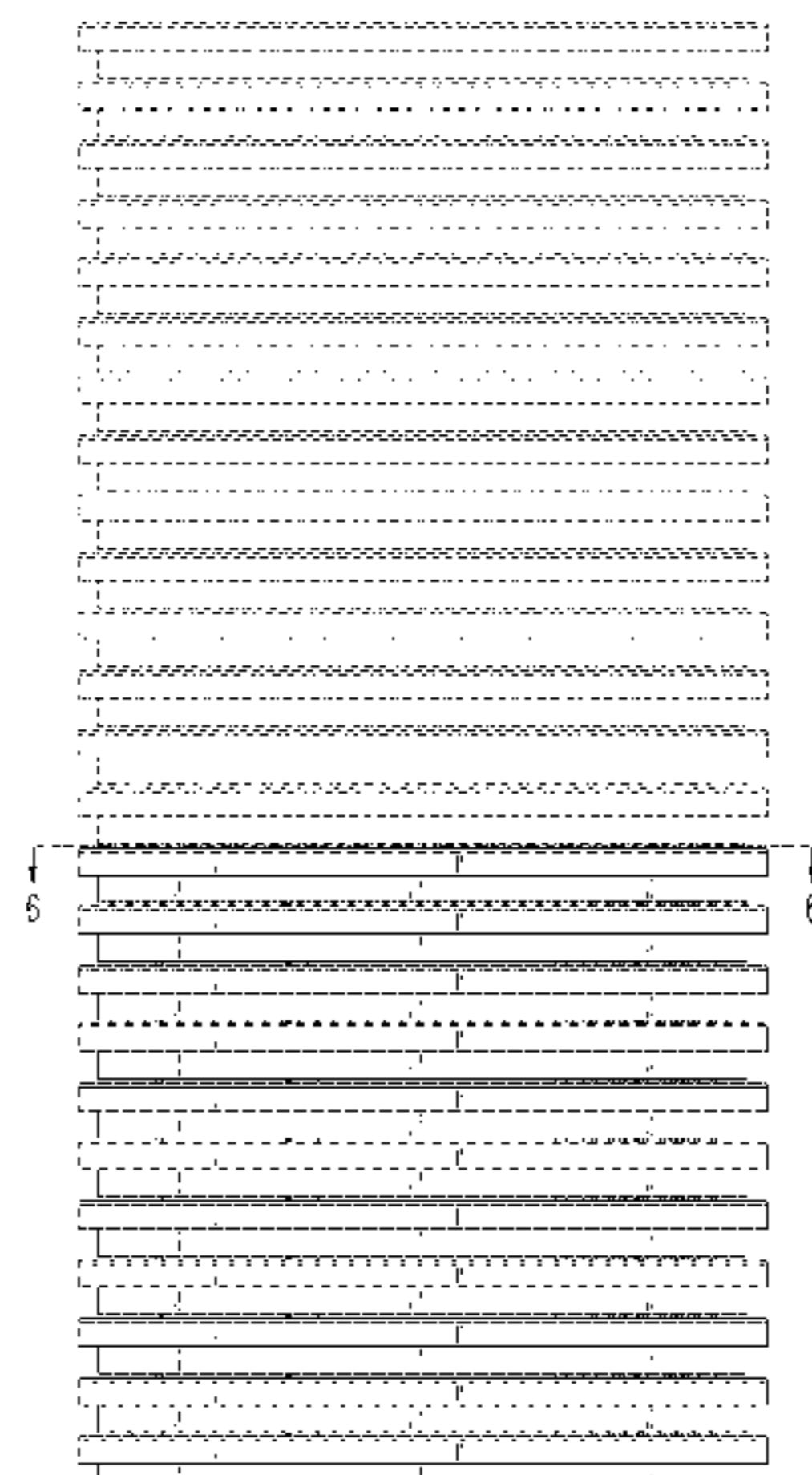
Applicant claims the ornamental design for a door assembly packaging, as shown and described.

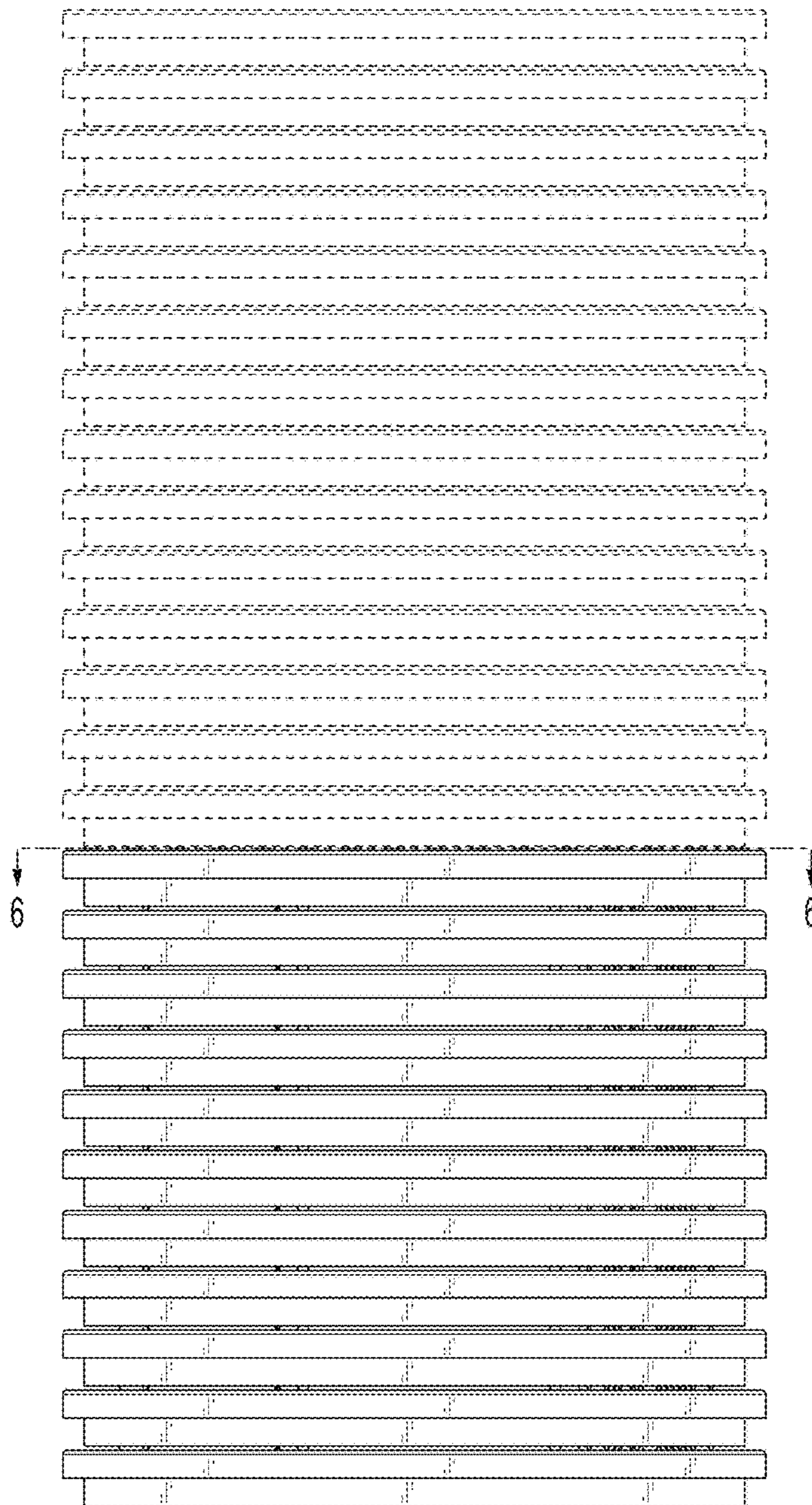

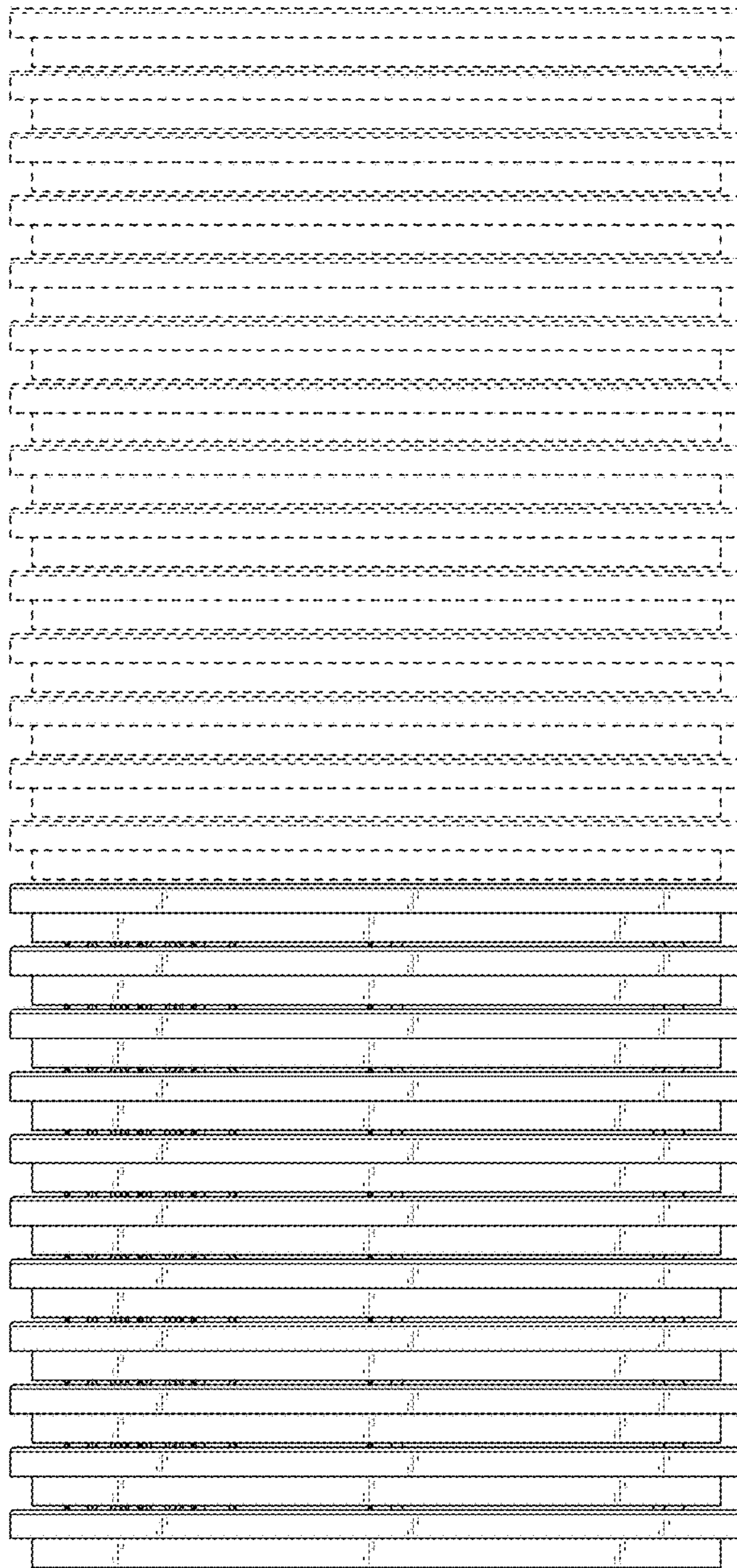

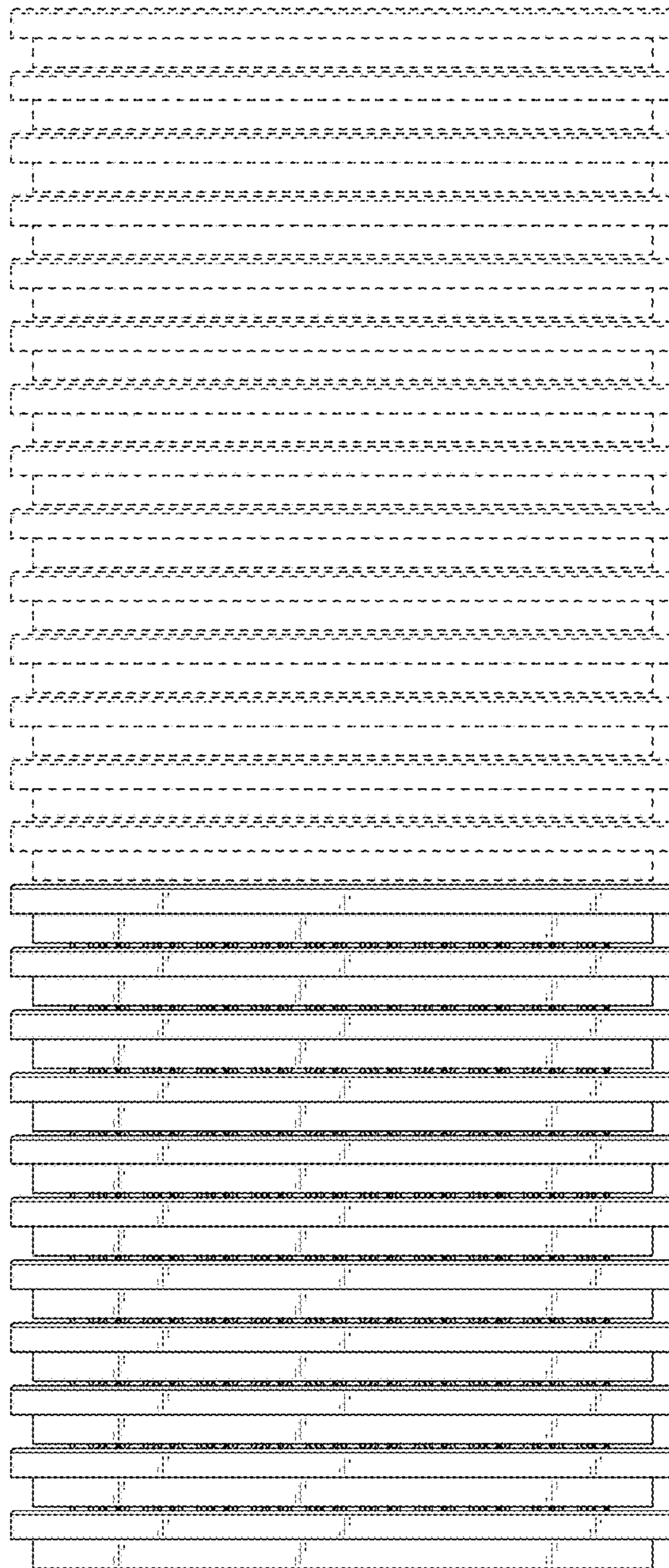

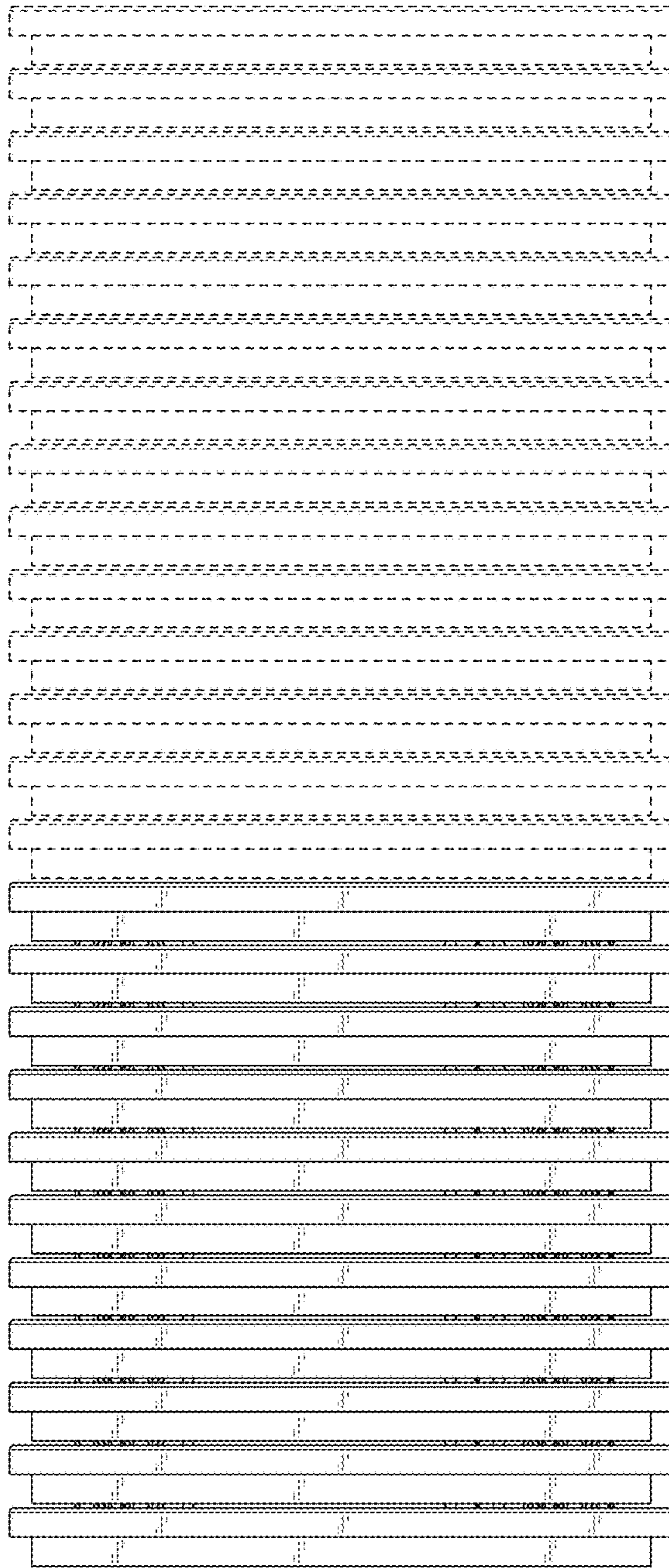

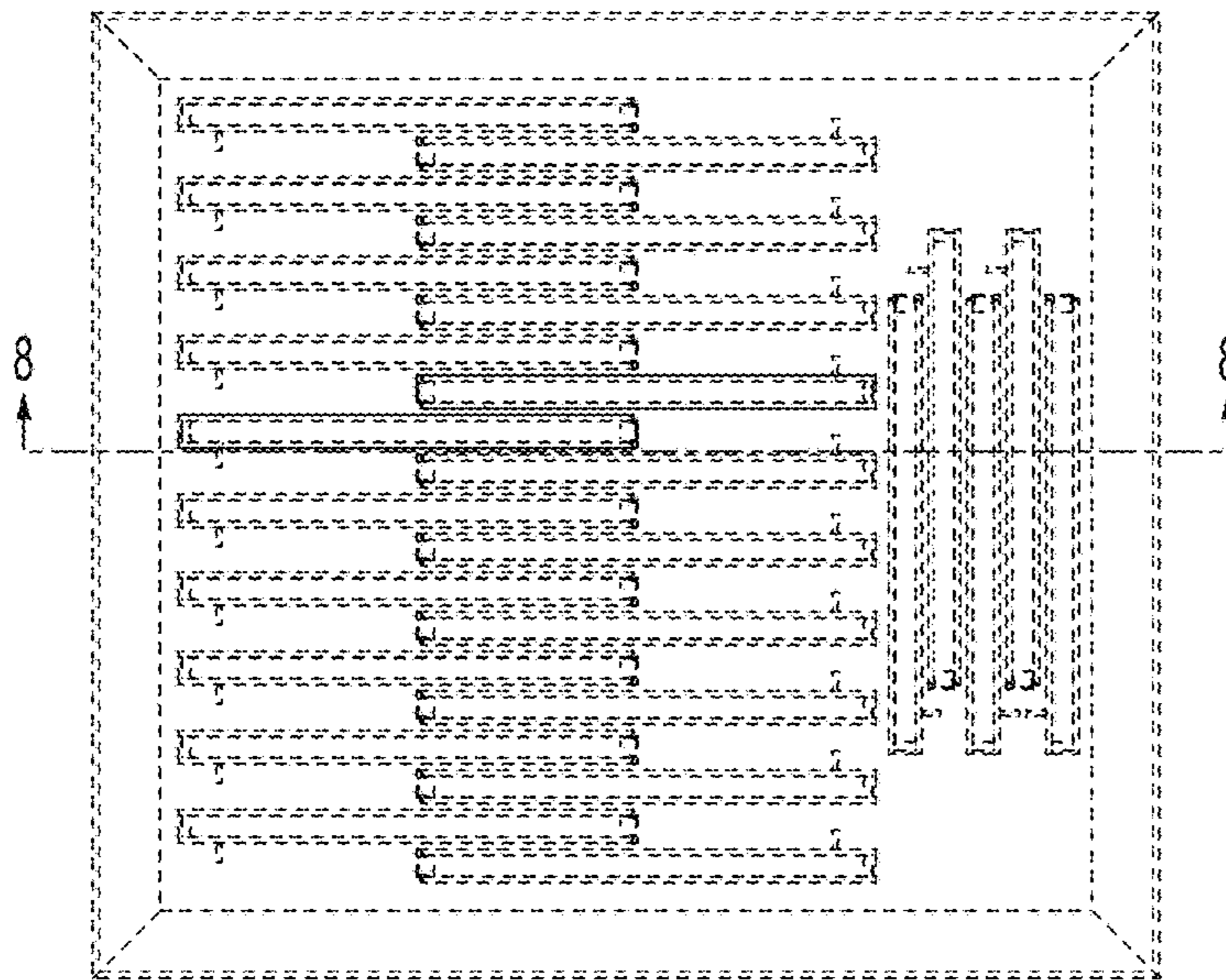

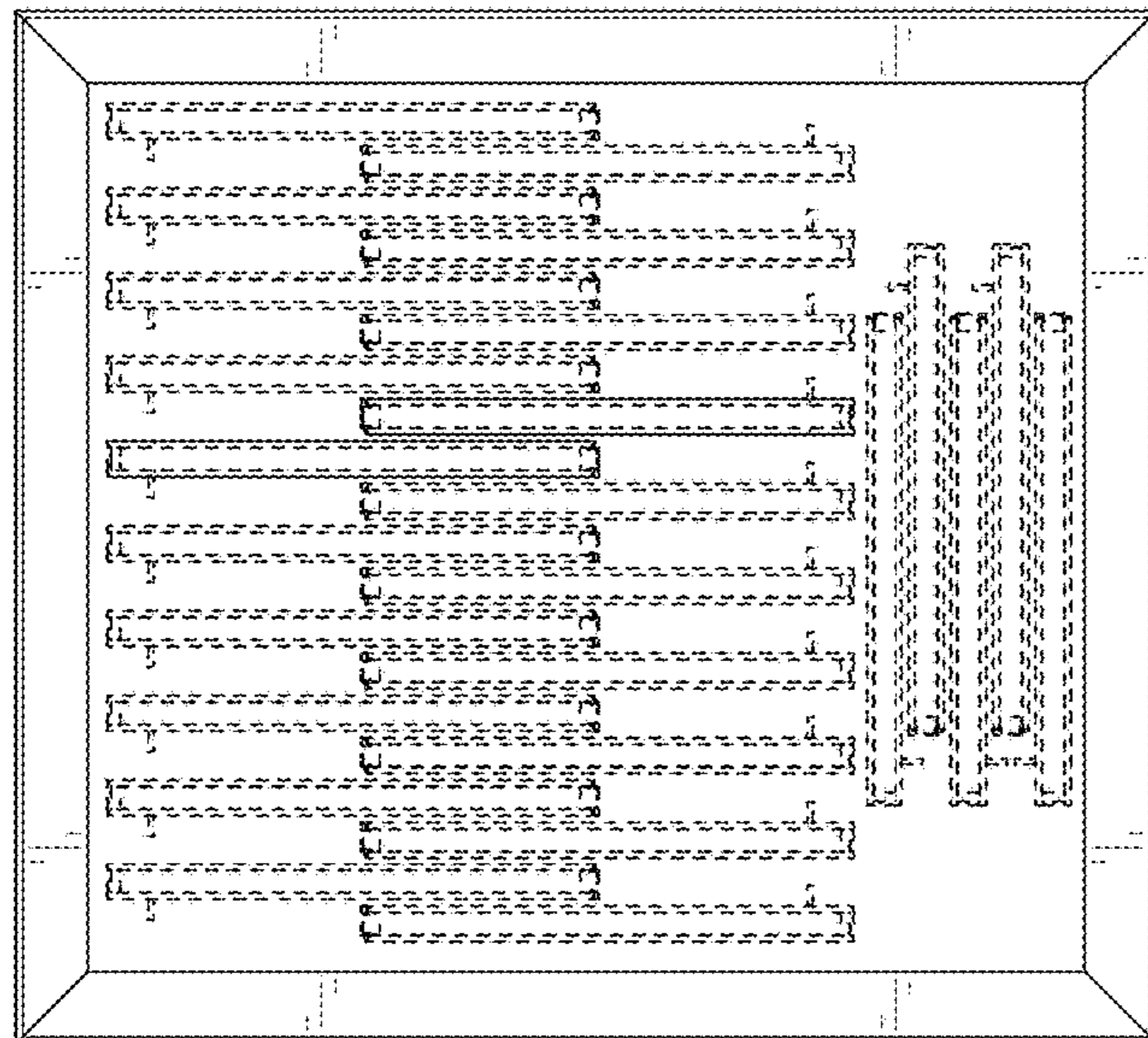

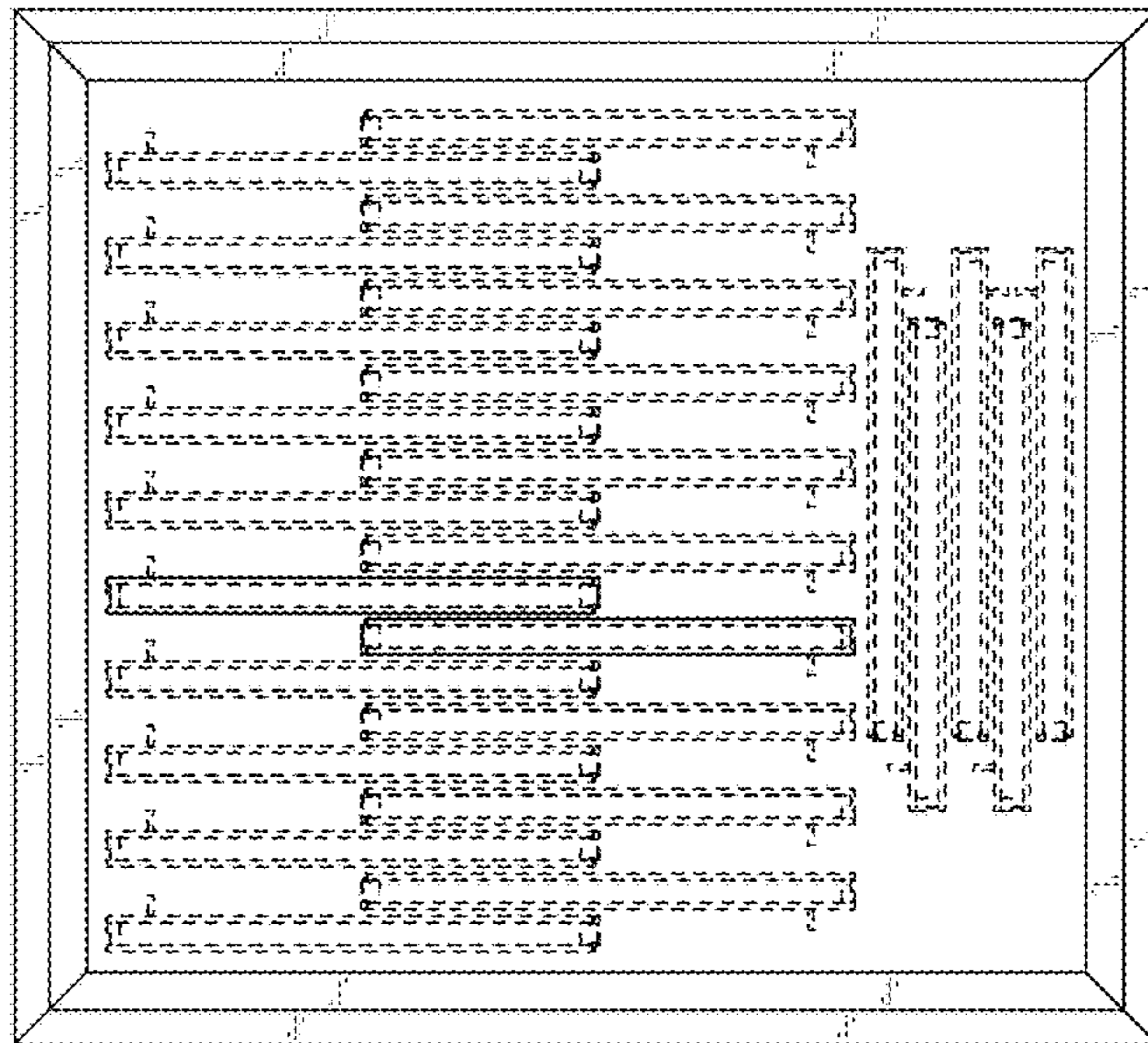

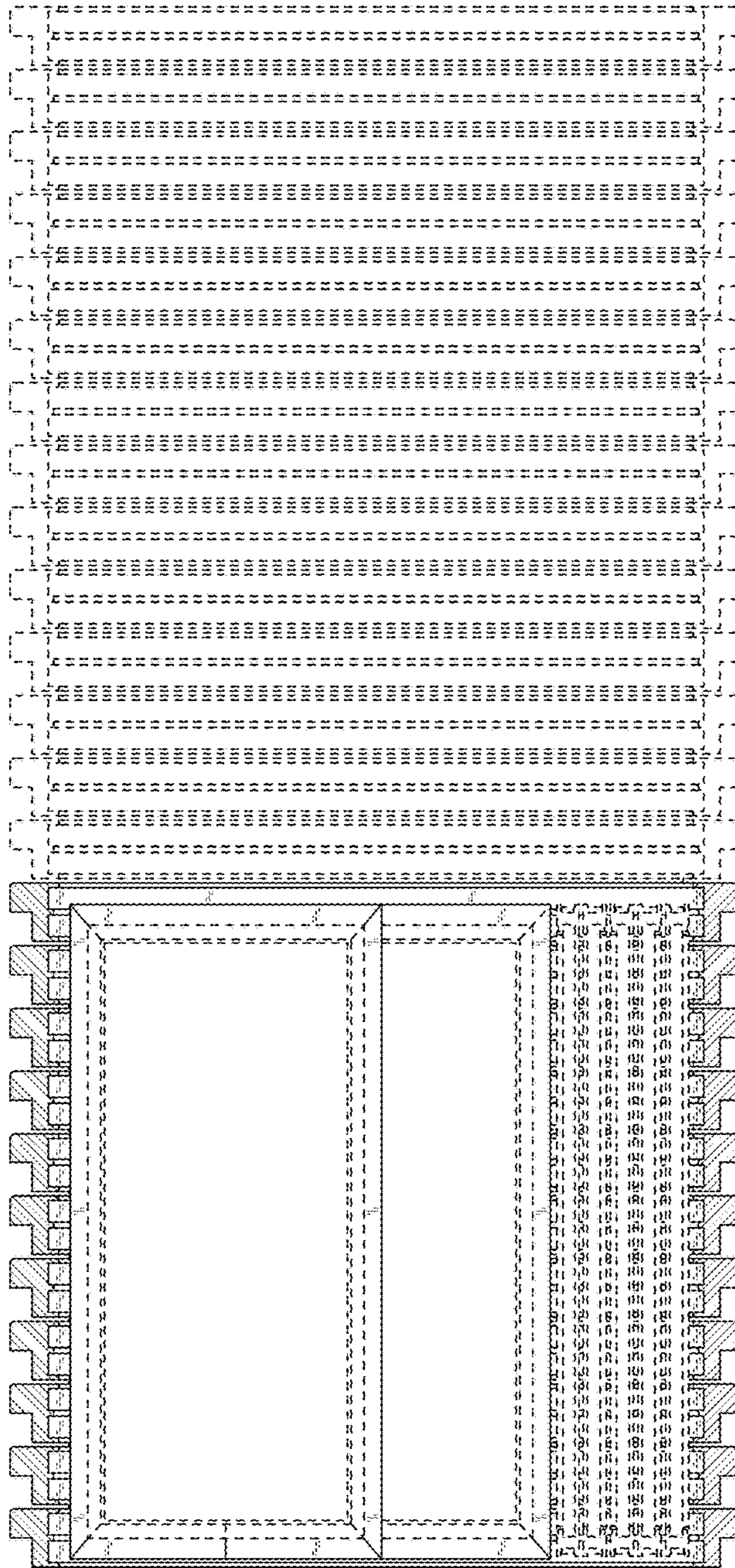

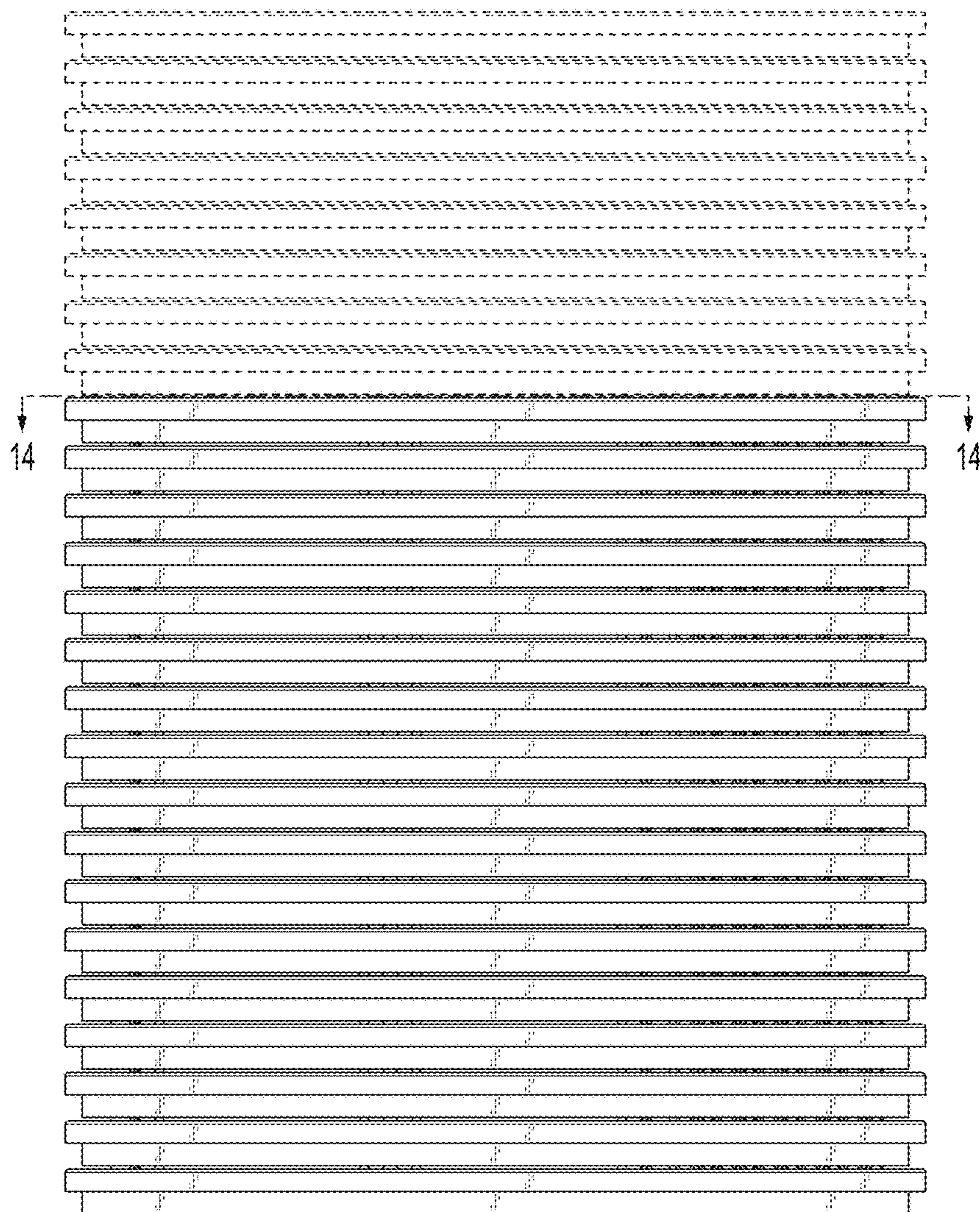

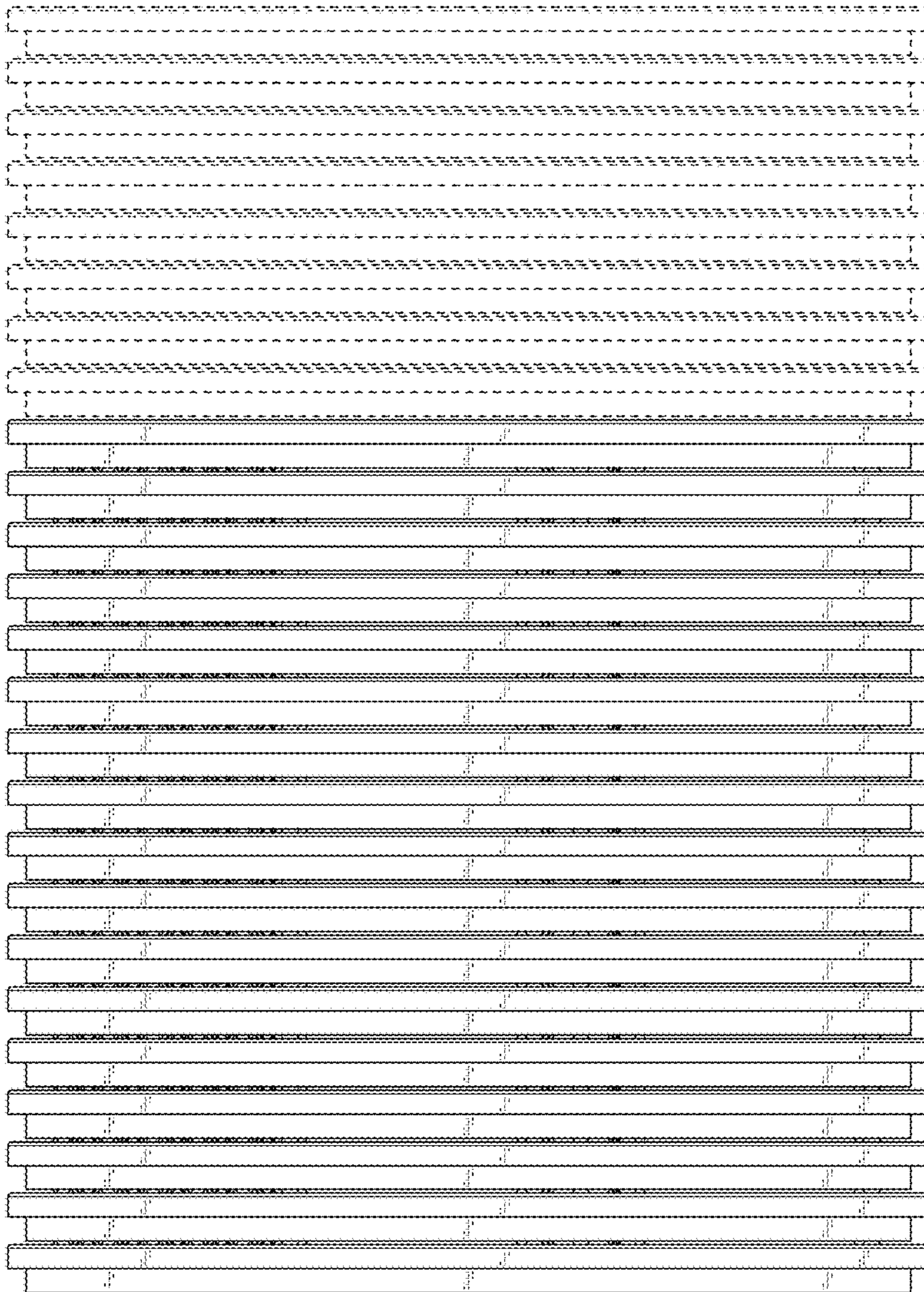

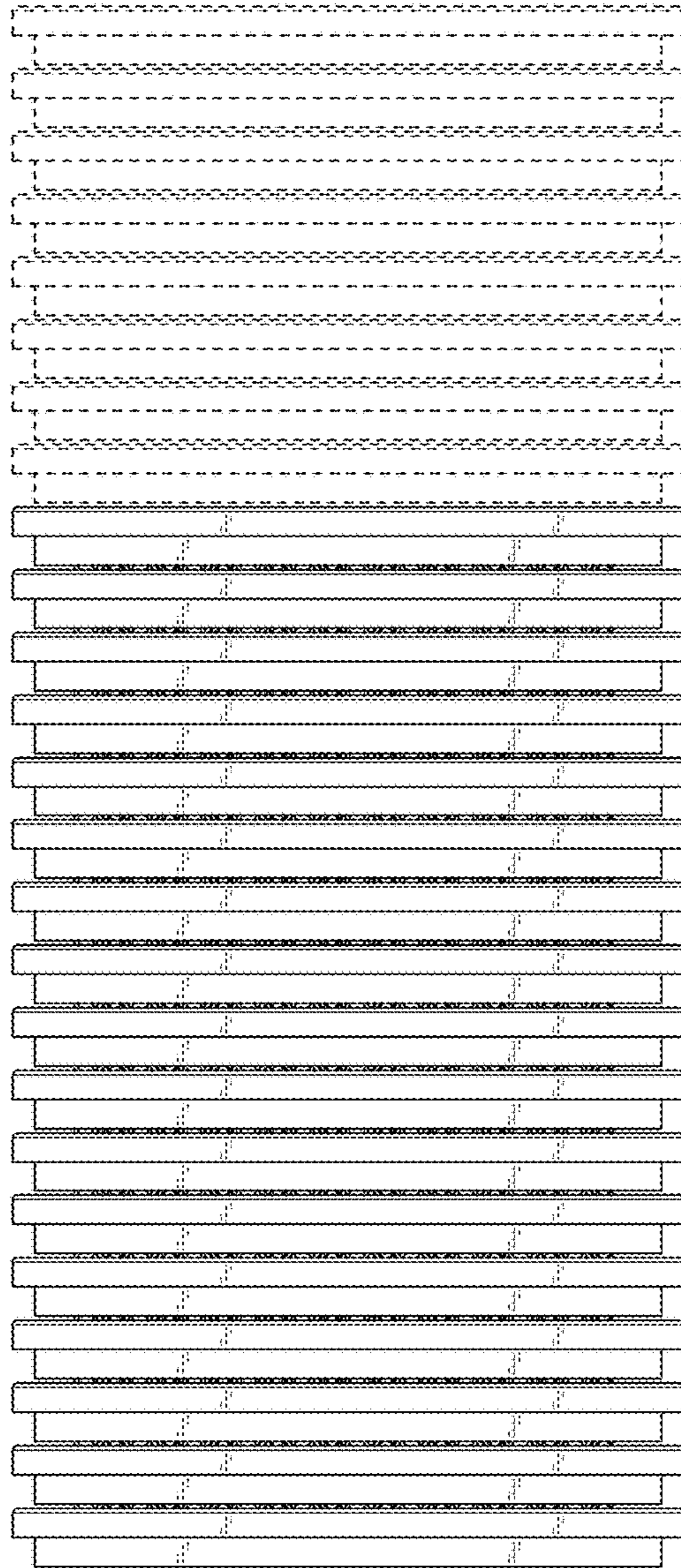

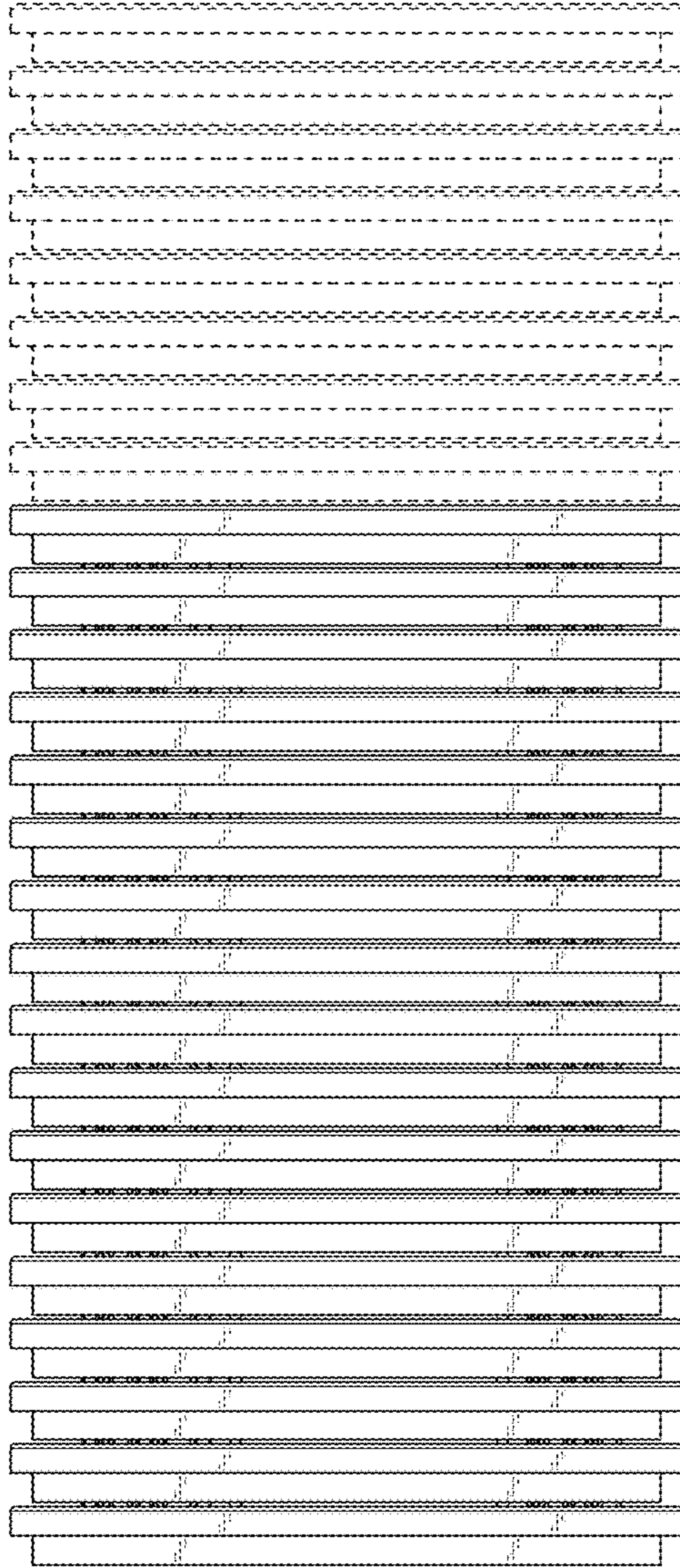

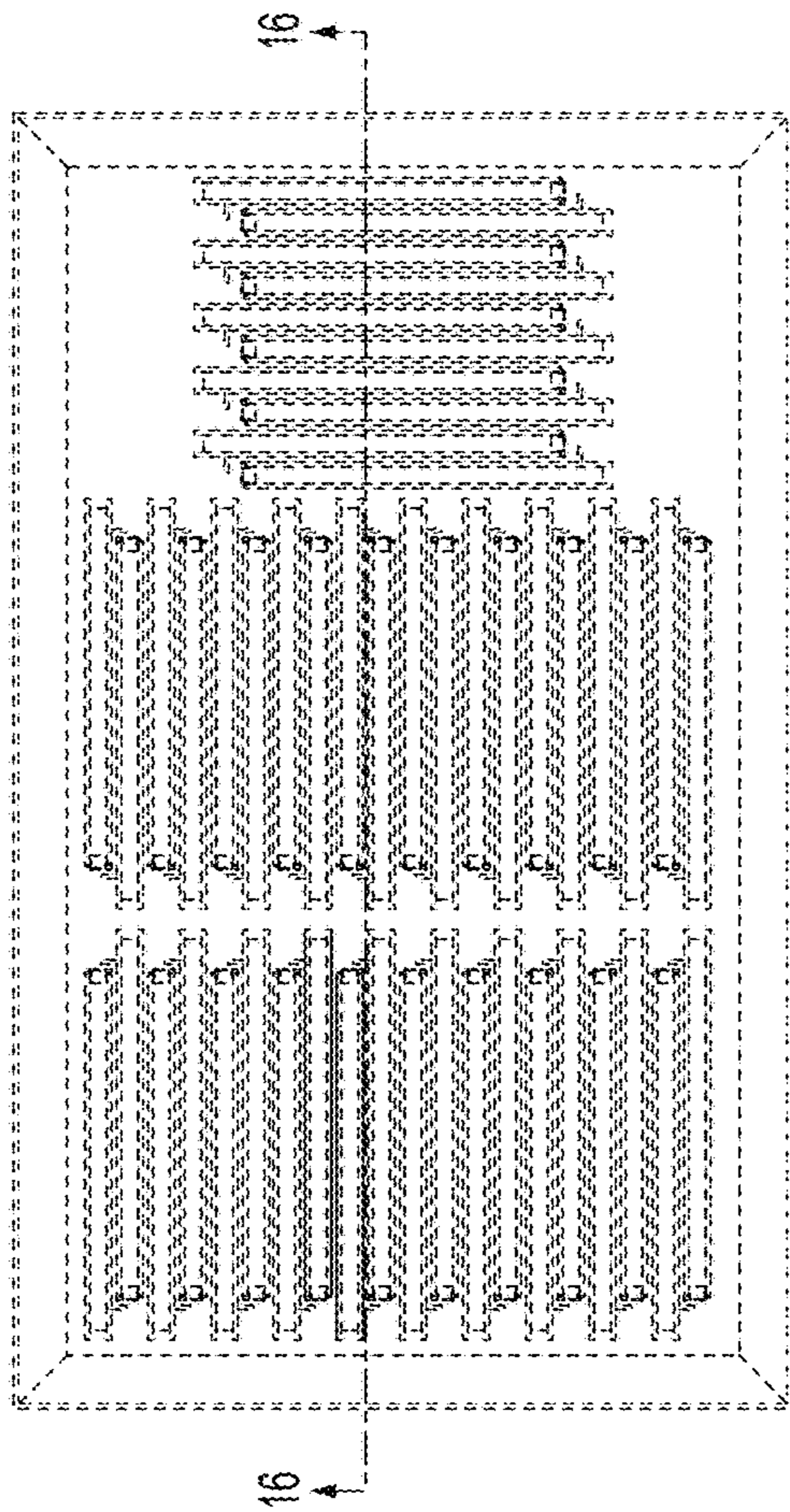

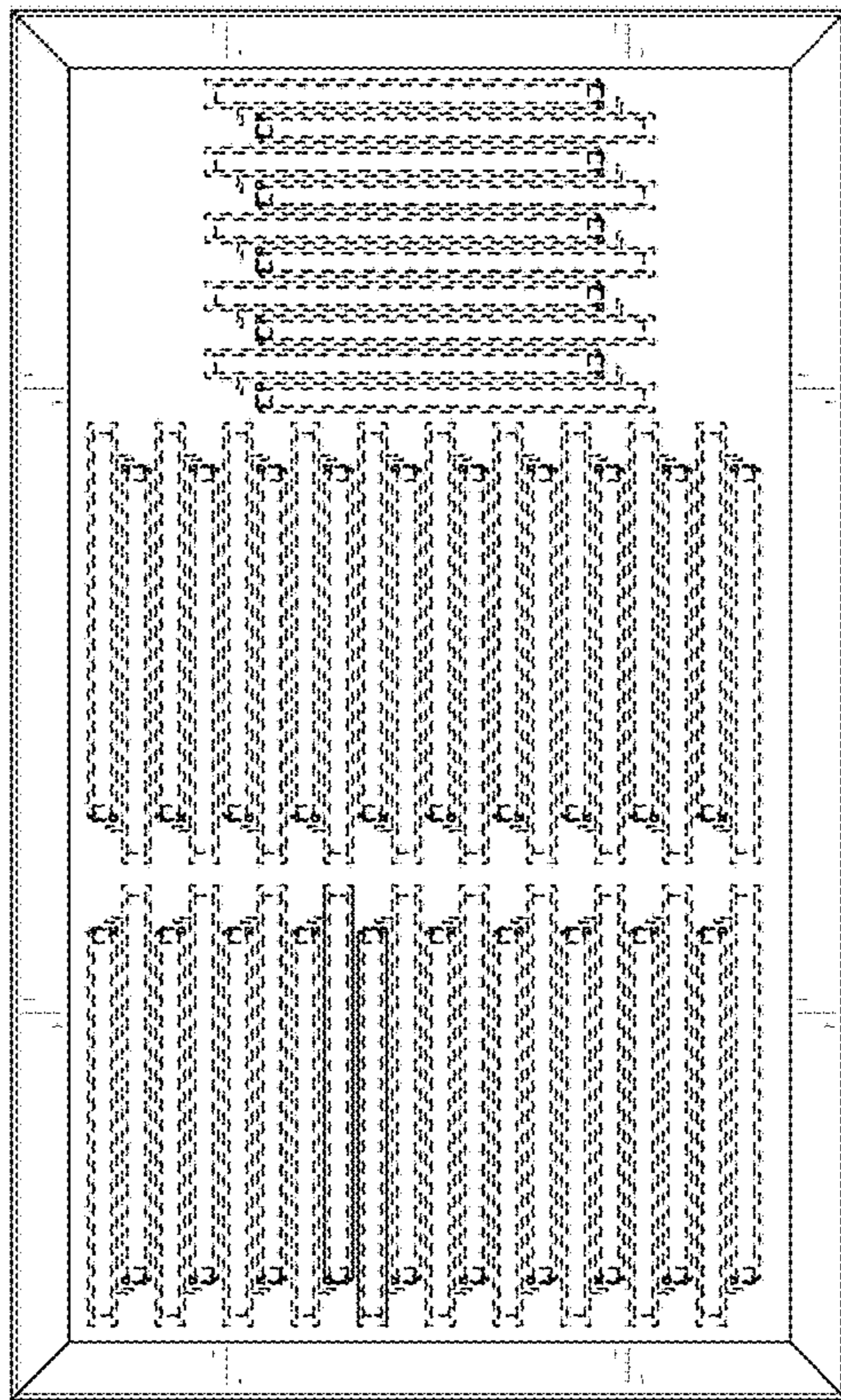

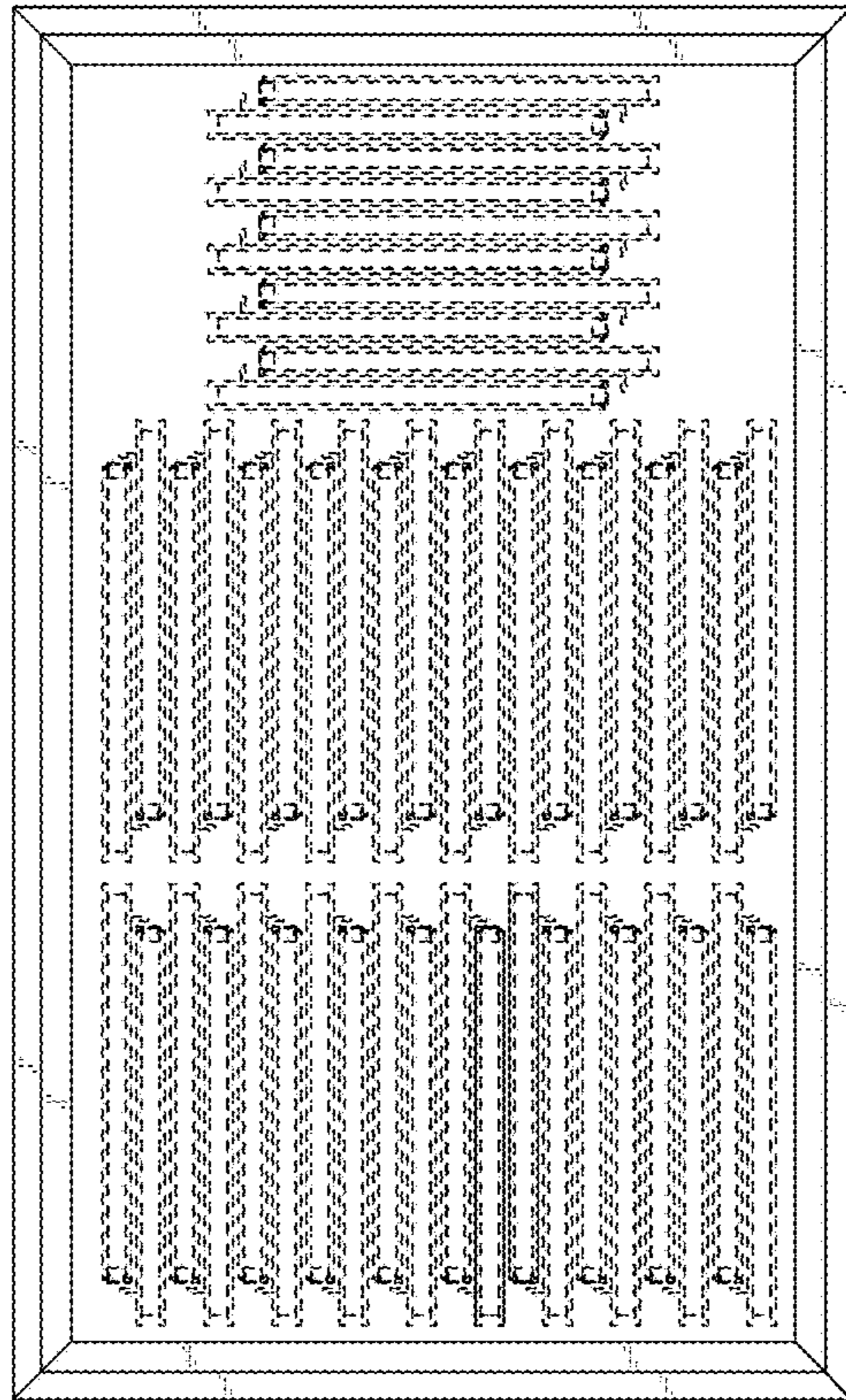

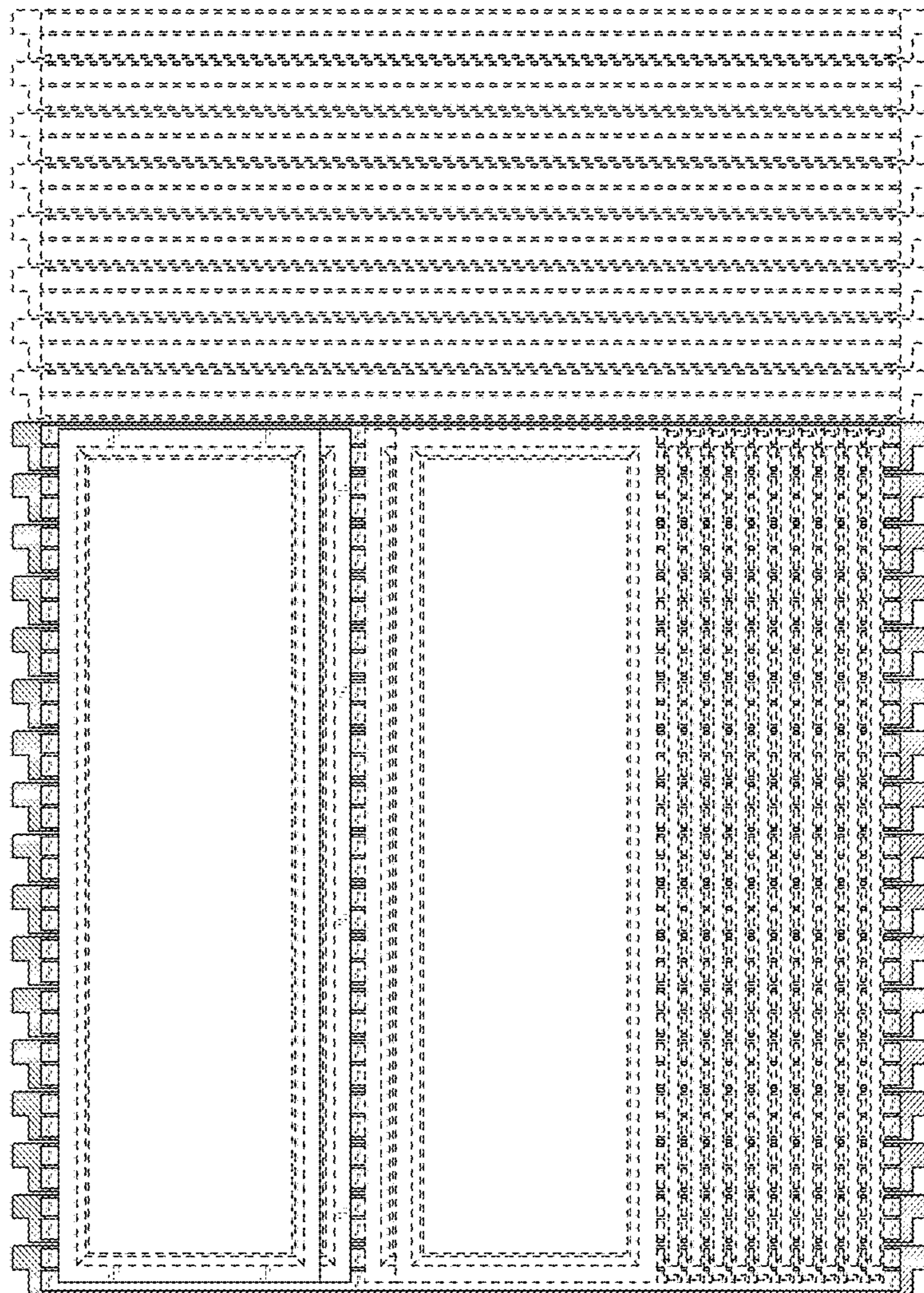

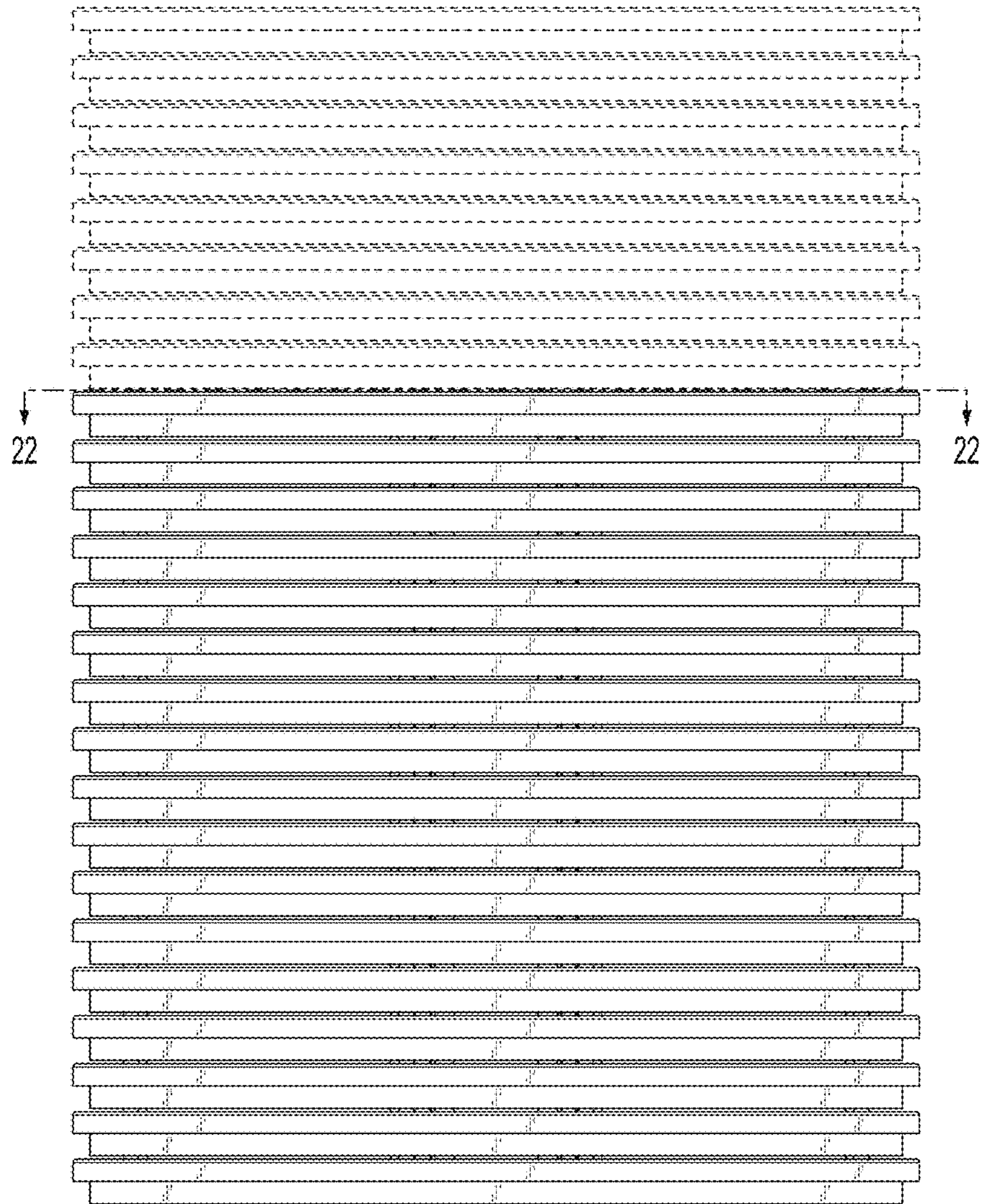

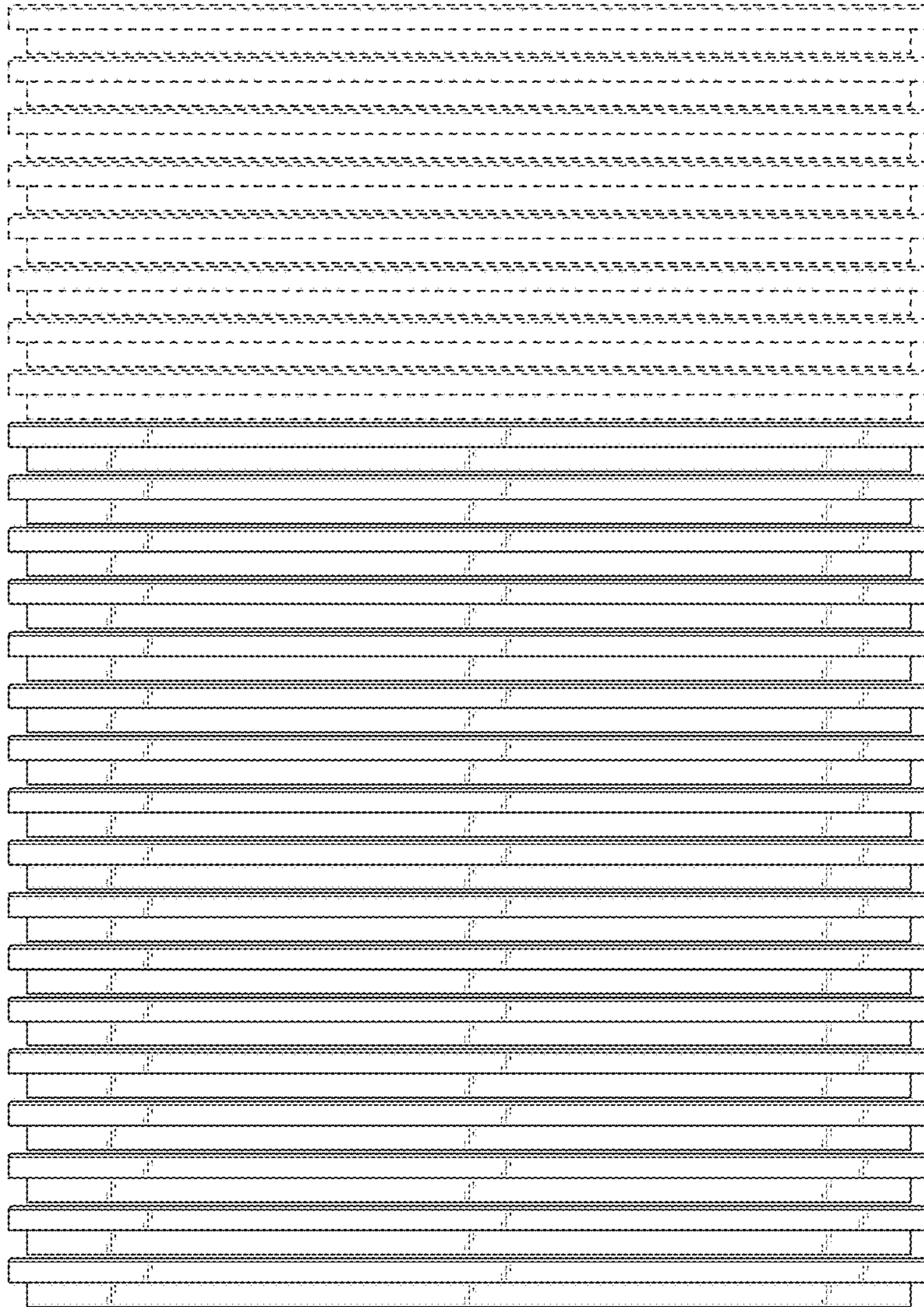

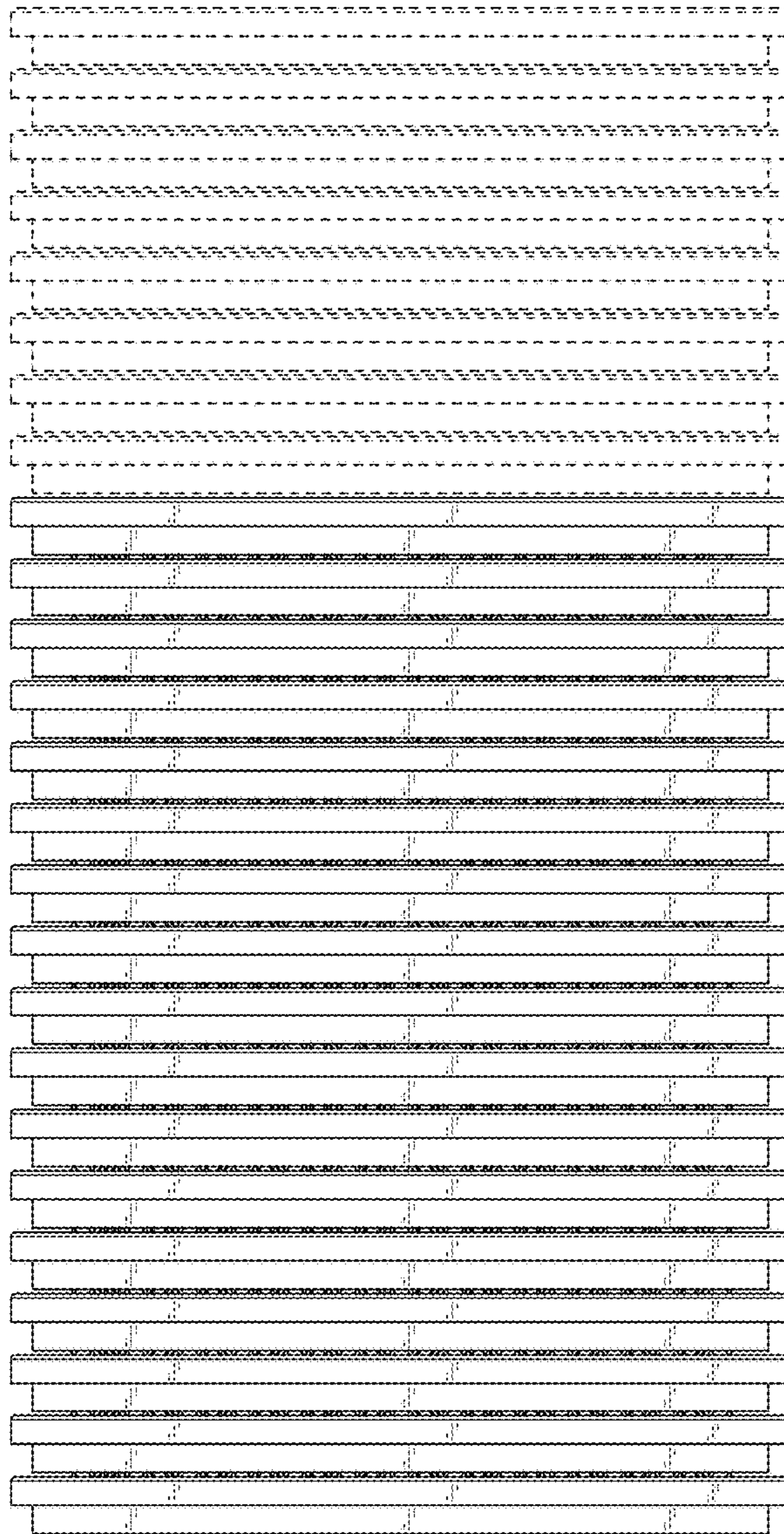

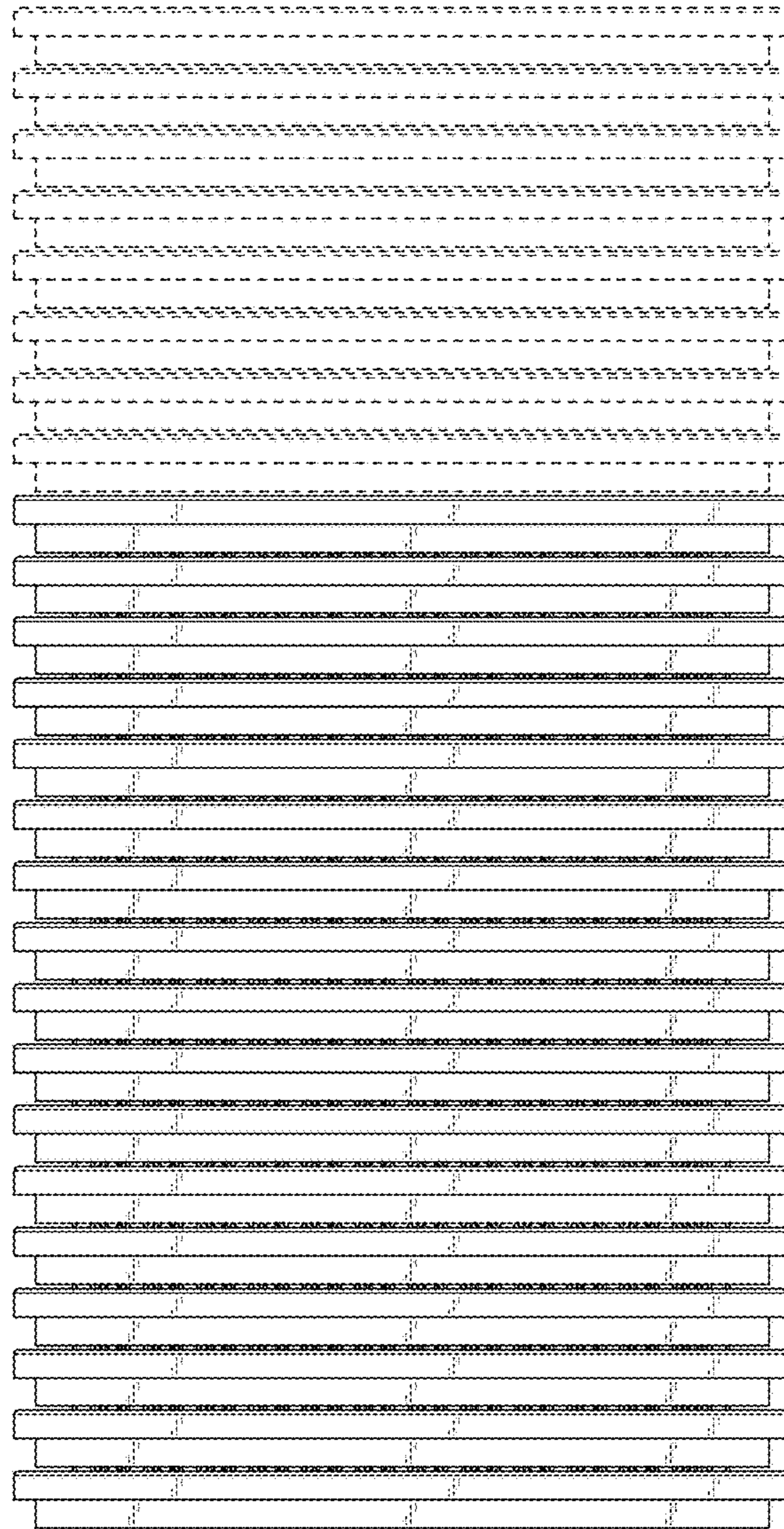

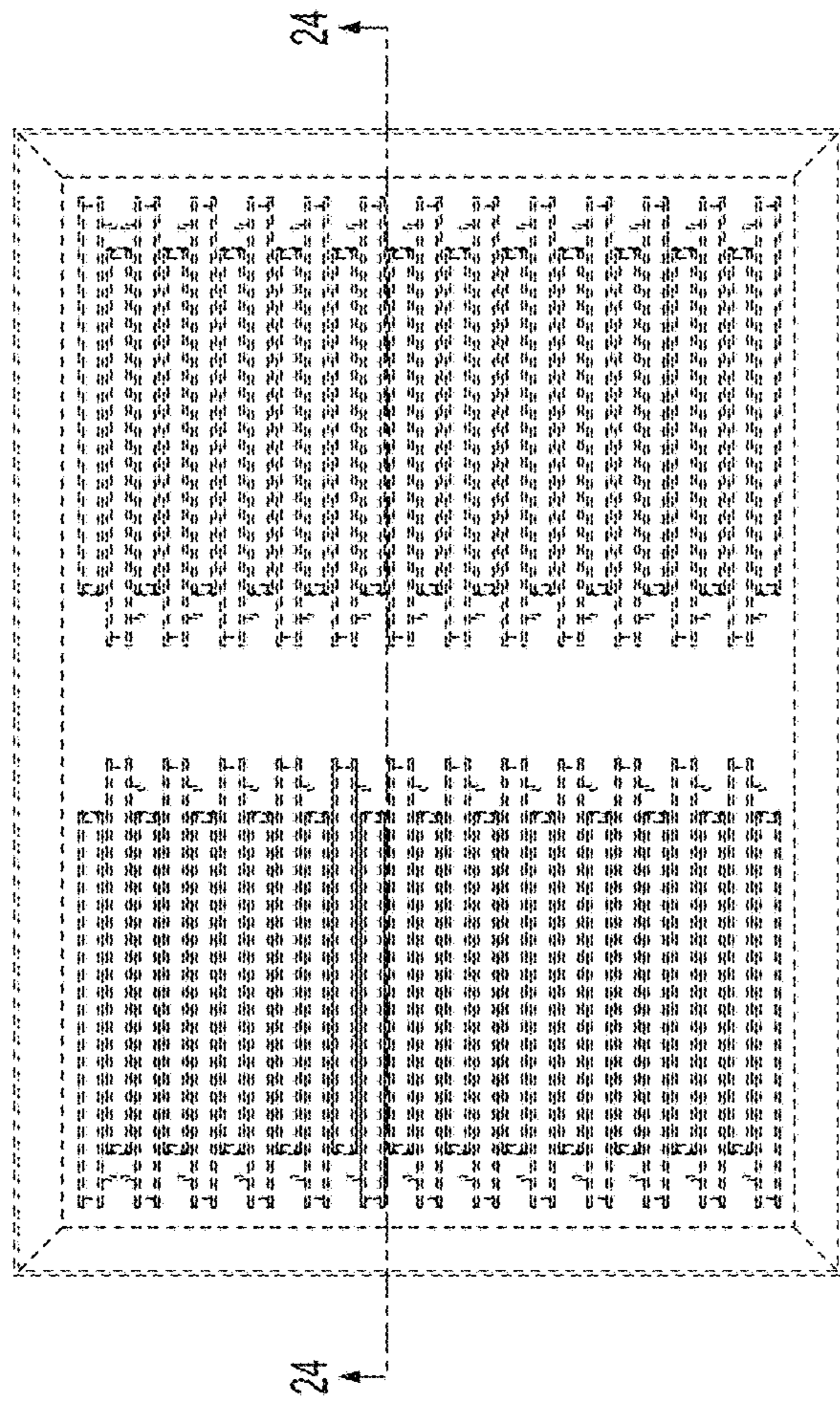

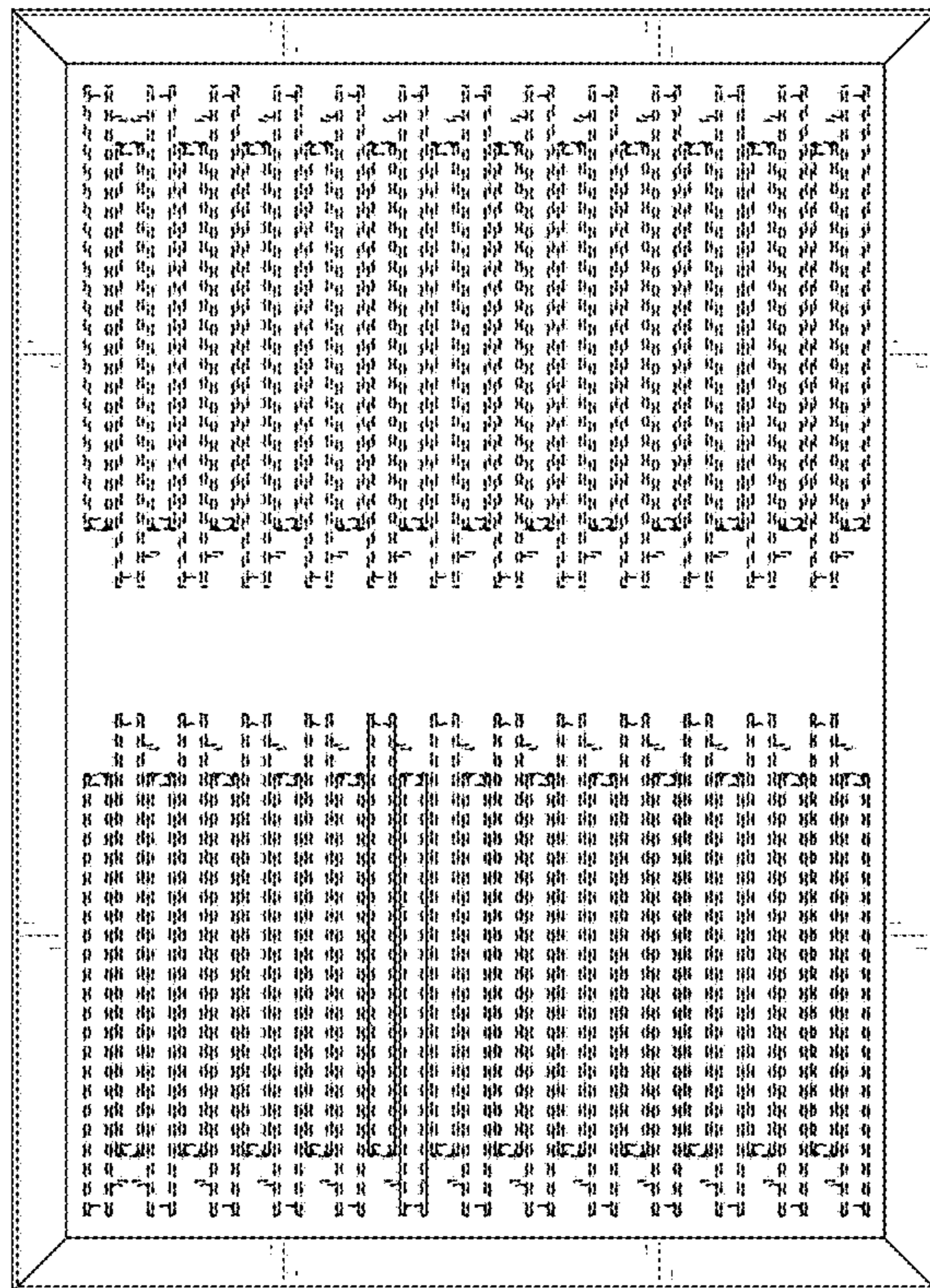

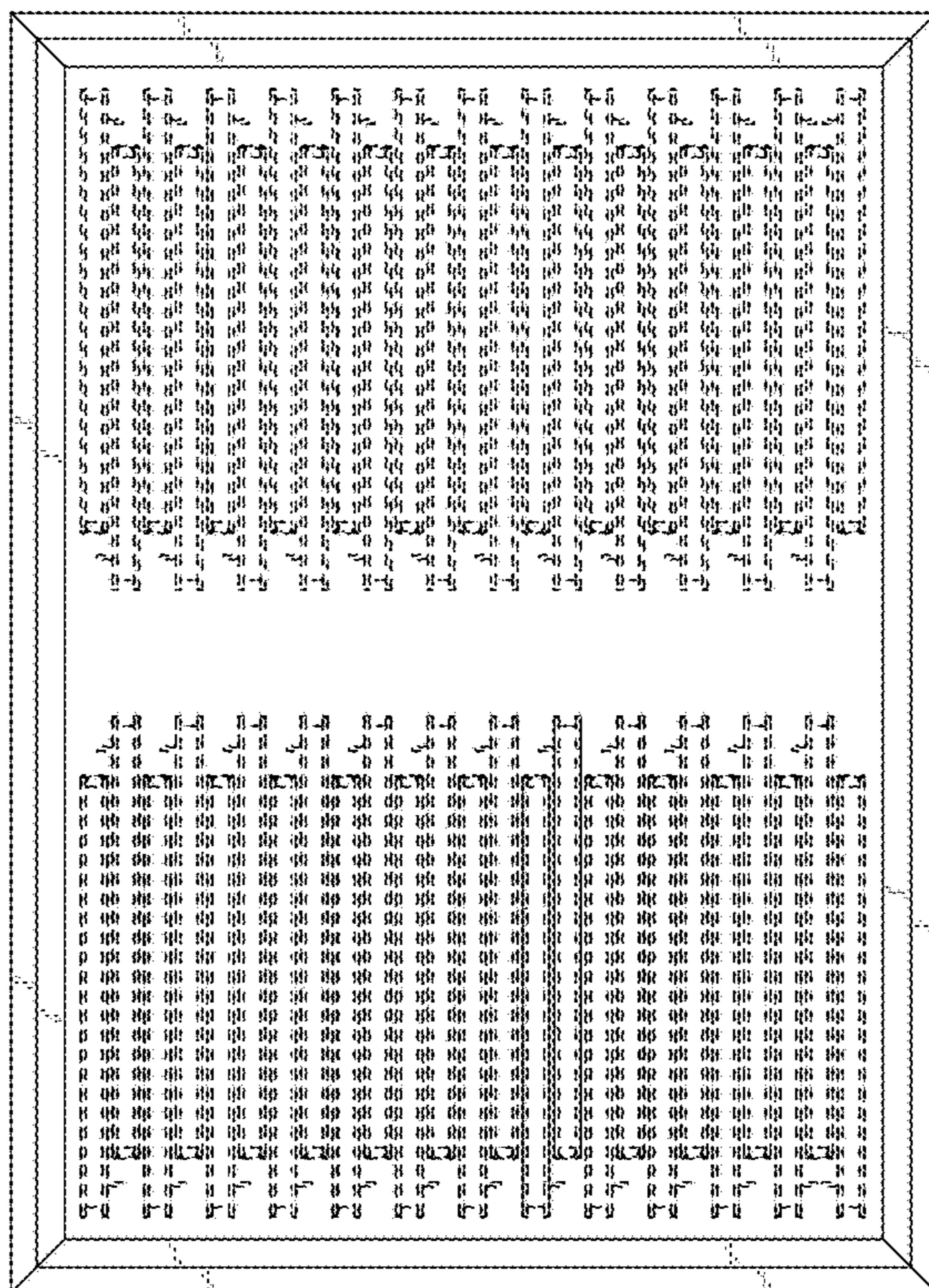

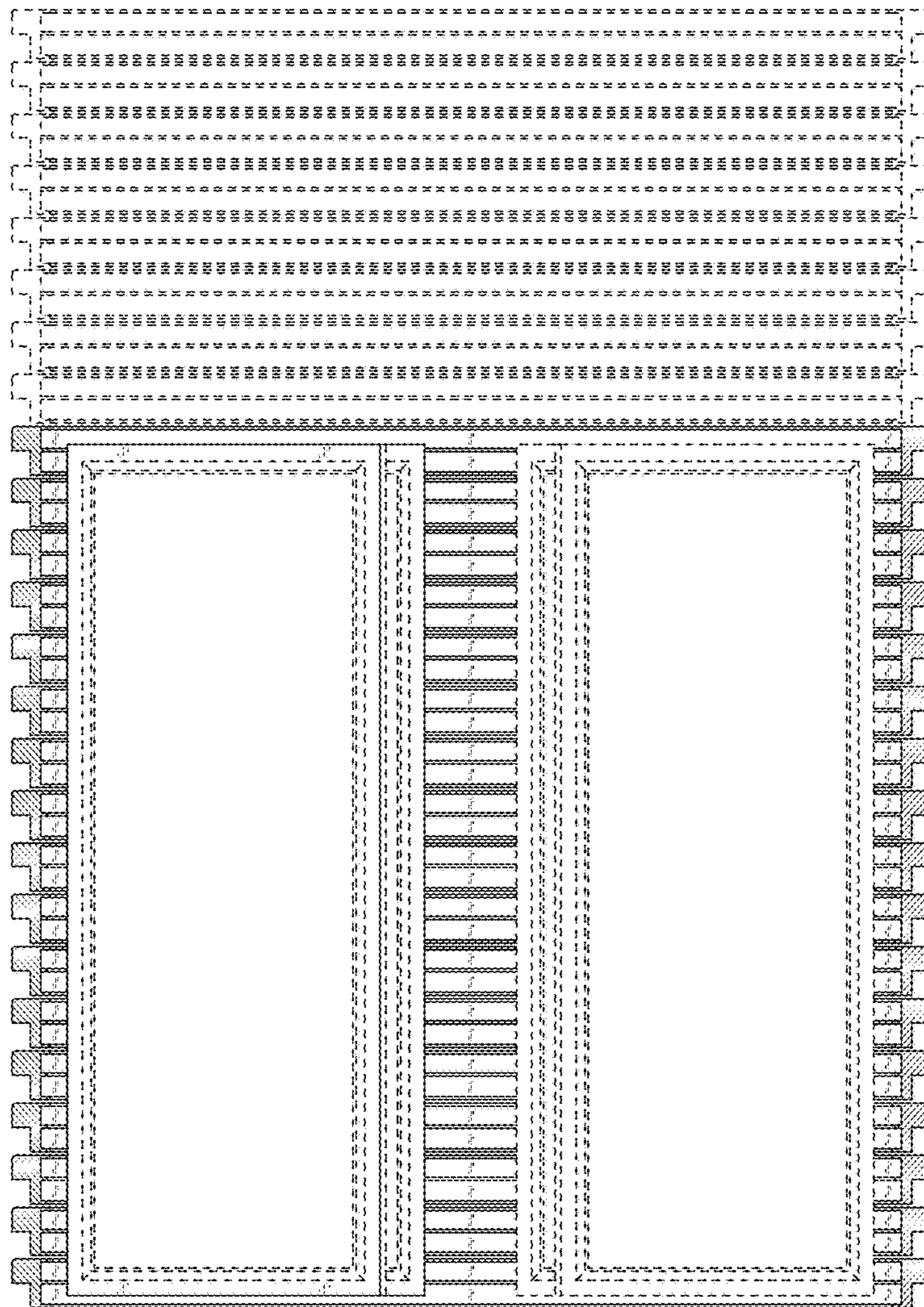

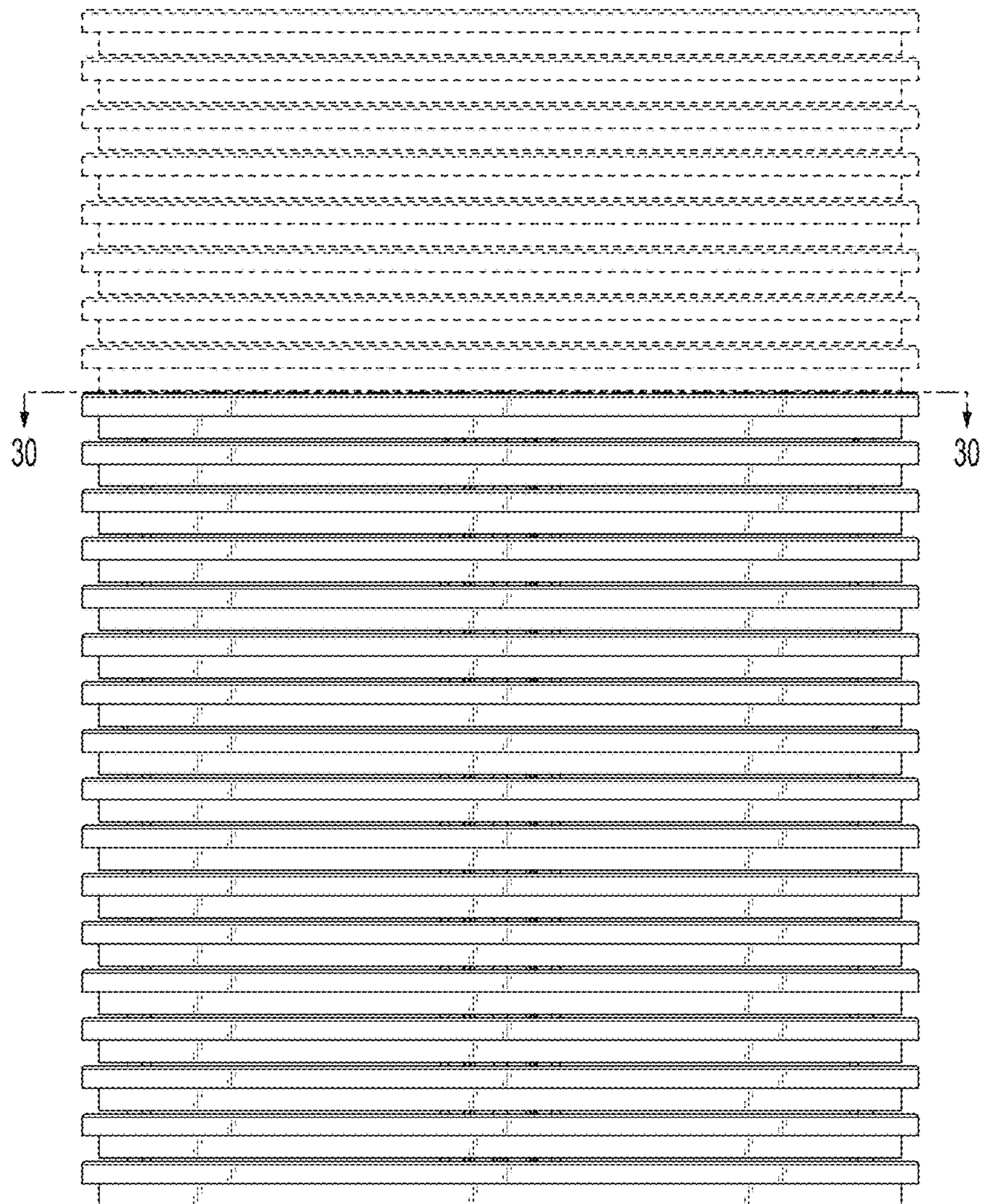

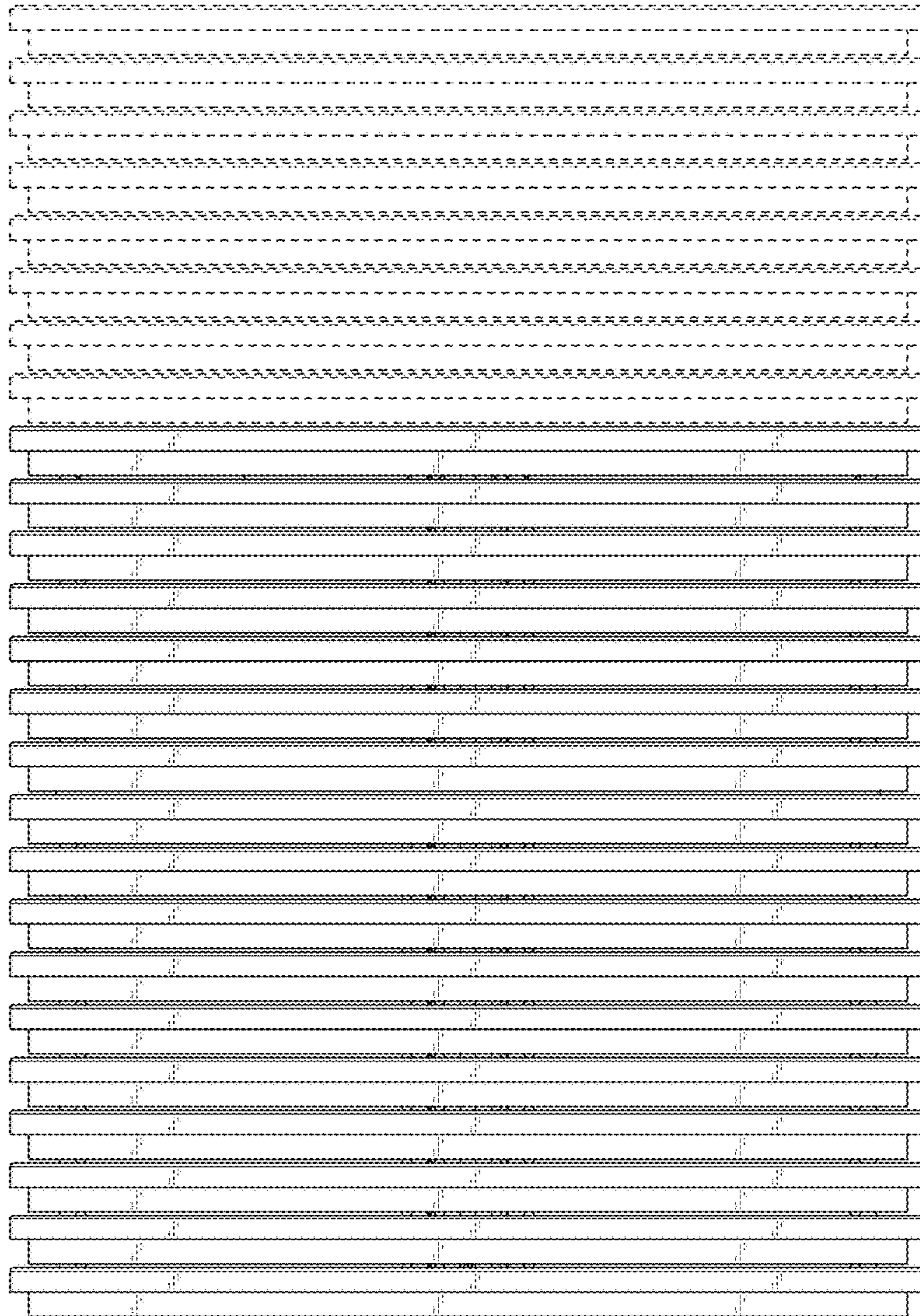

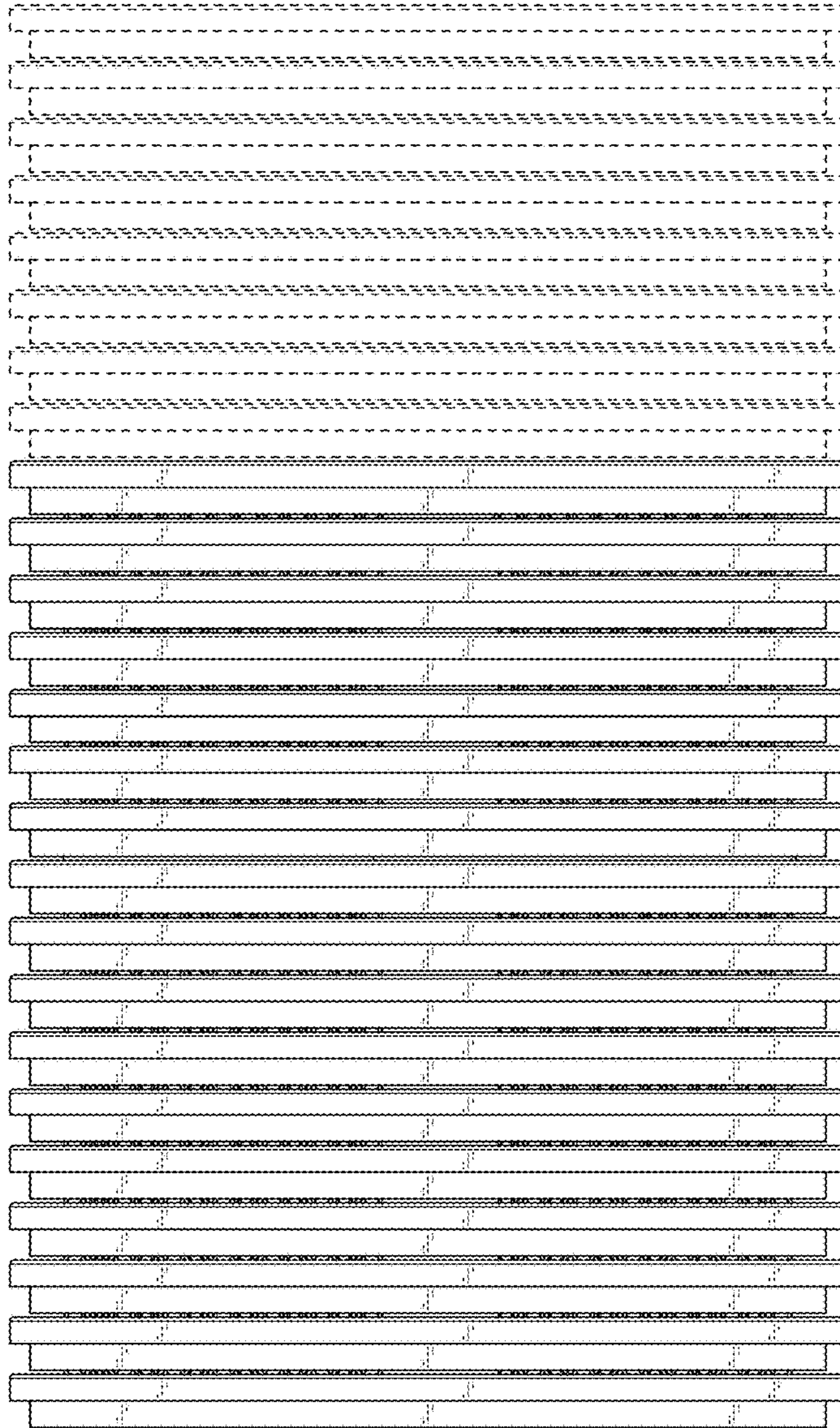

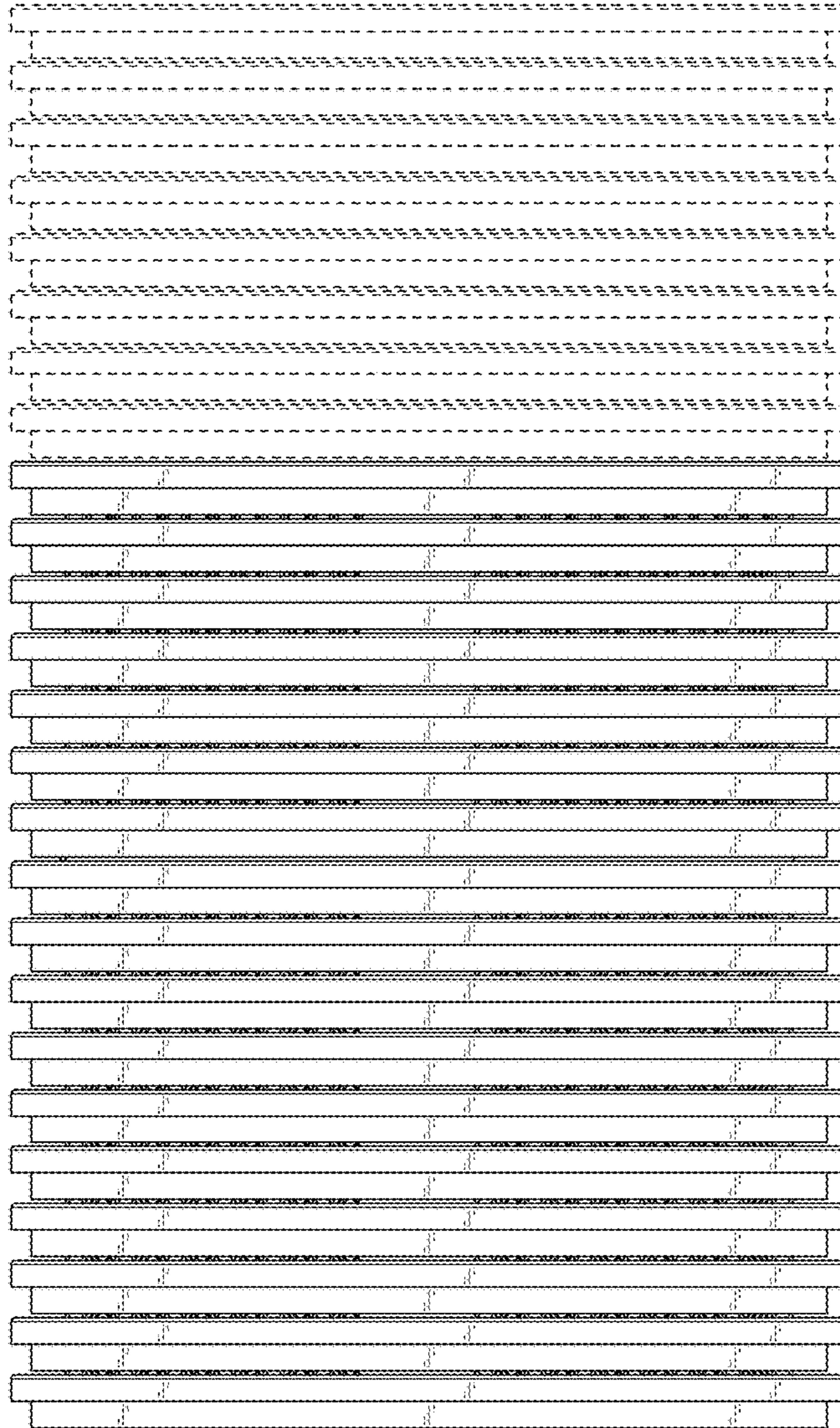

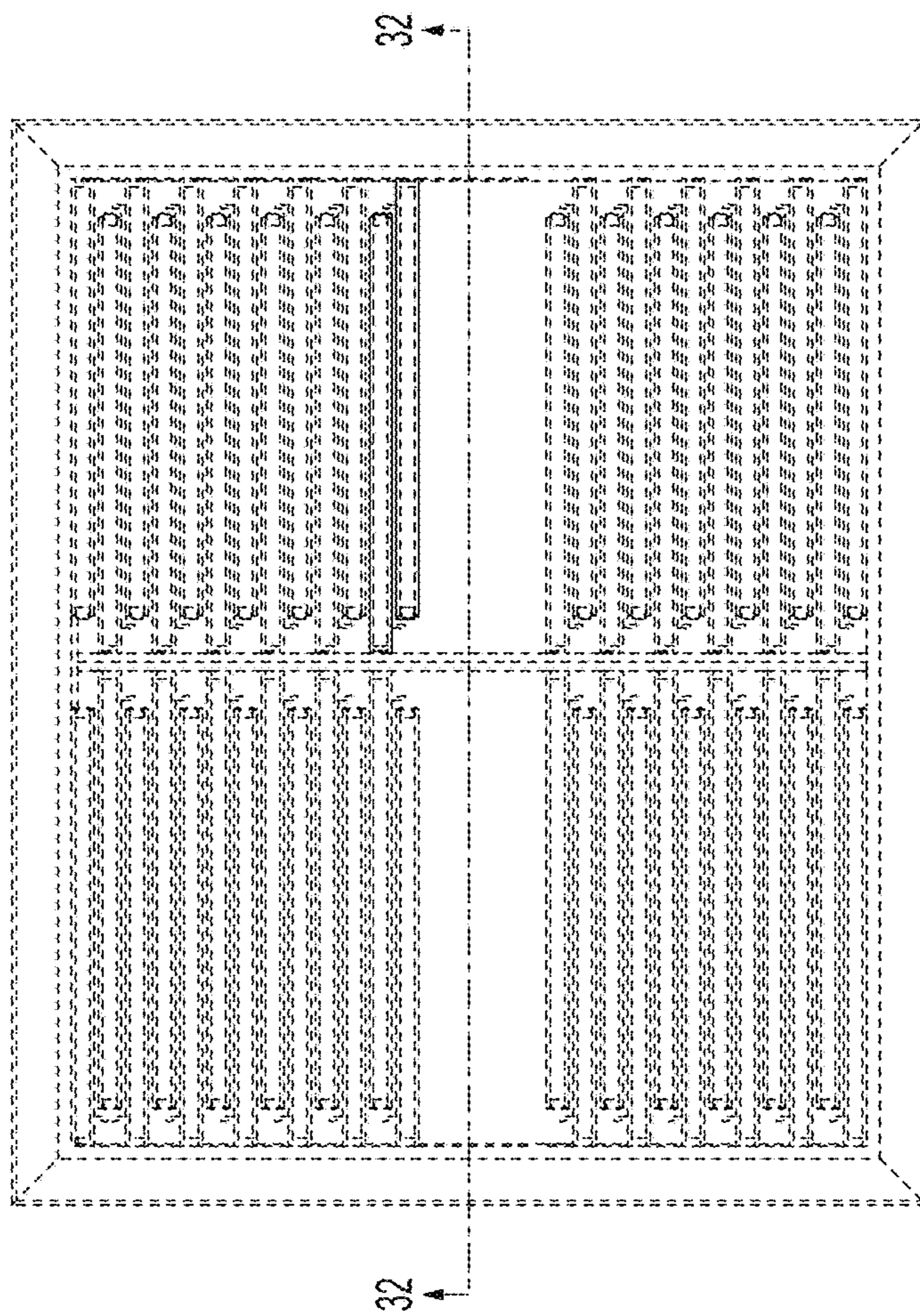

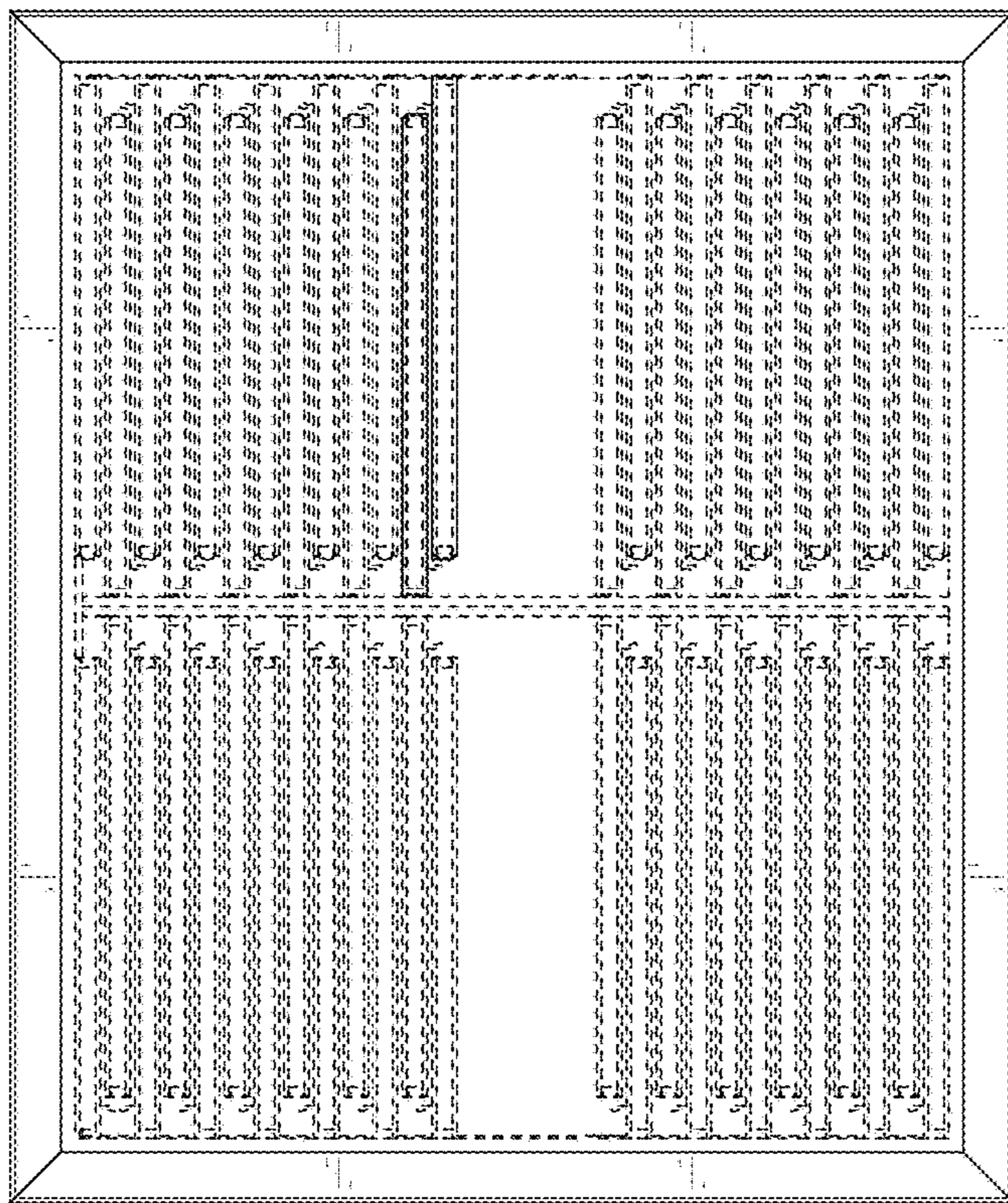

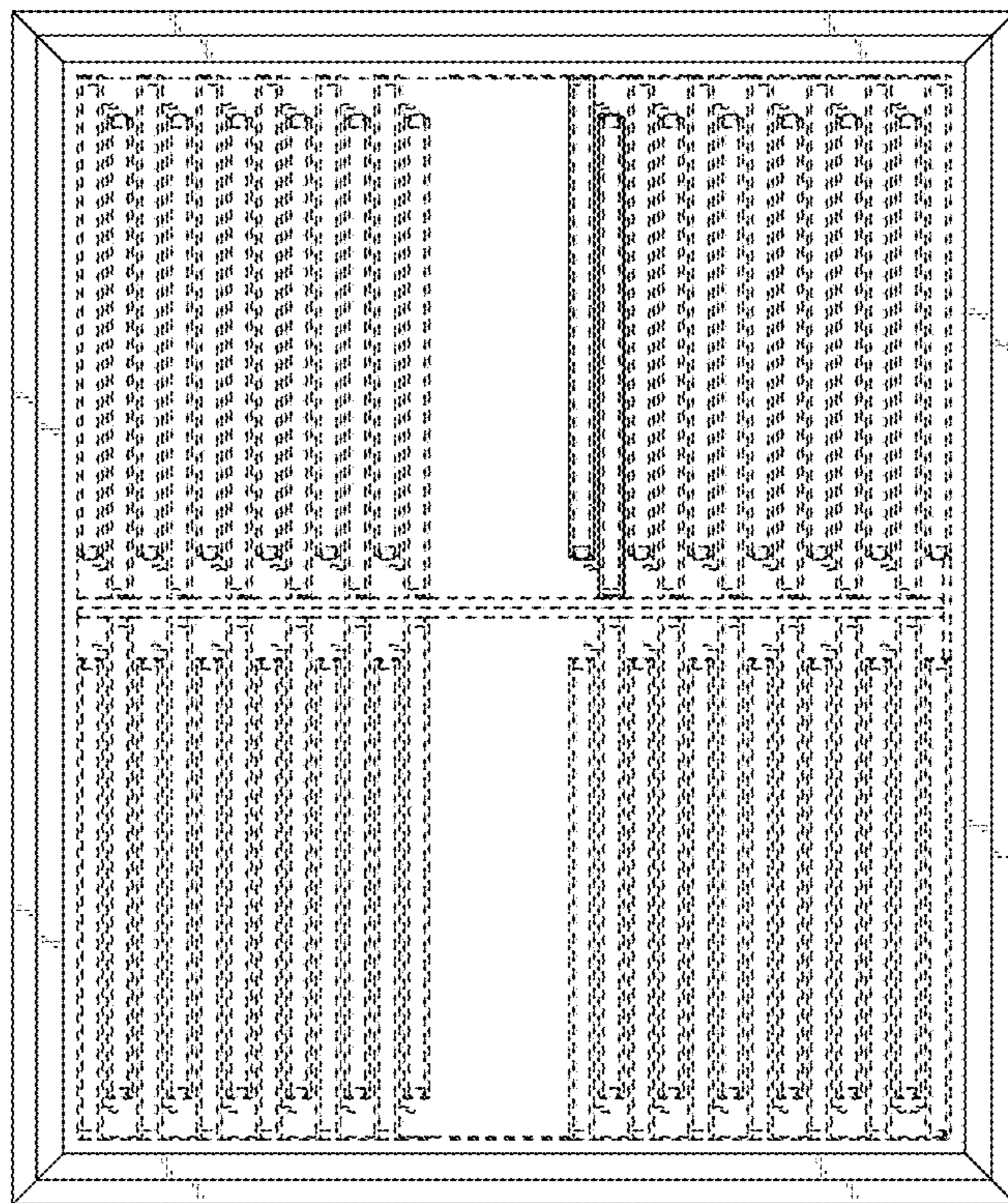

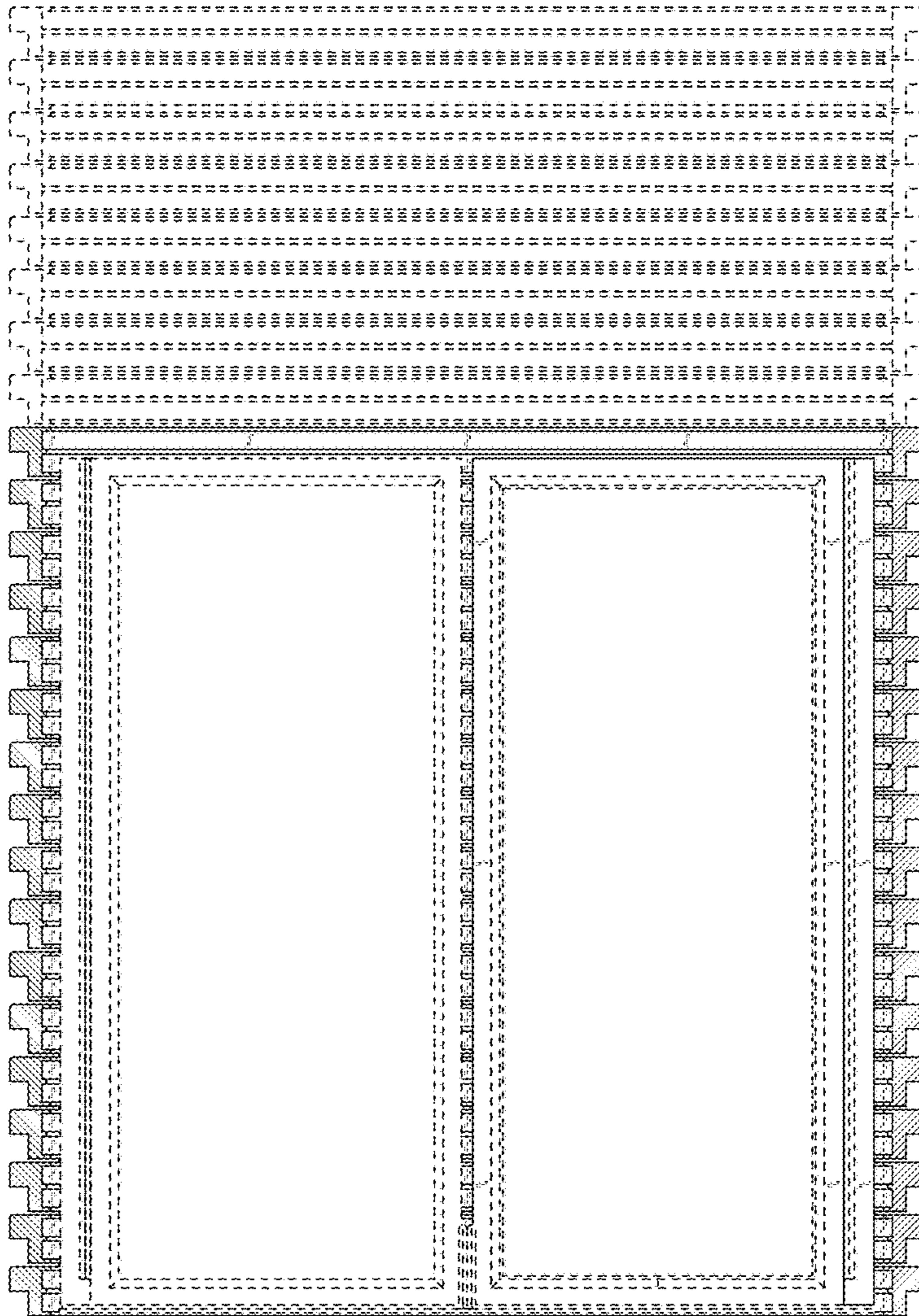
