(57) **CLAIM**

The ornamental design for spoke segment of a vehicle wheel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a spoke segment of a vehicle wheel according to my new design; and, FIG. 2 is a front elevational view thereof.

The broken lines showing the side of the wheel and the bolts and center cap in the central hub area are included for the purpose of illustrating environment and form no part of the claimed design.

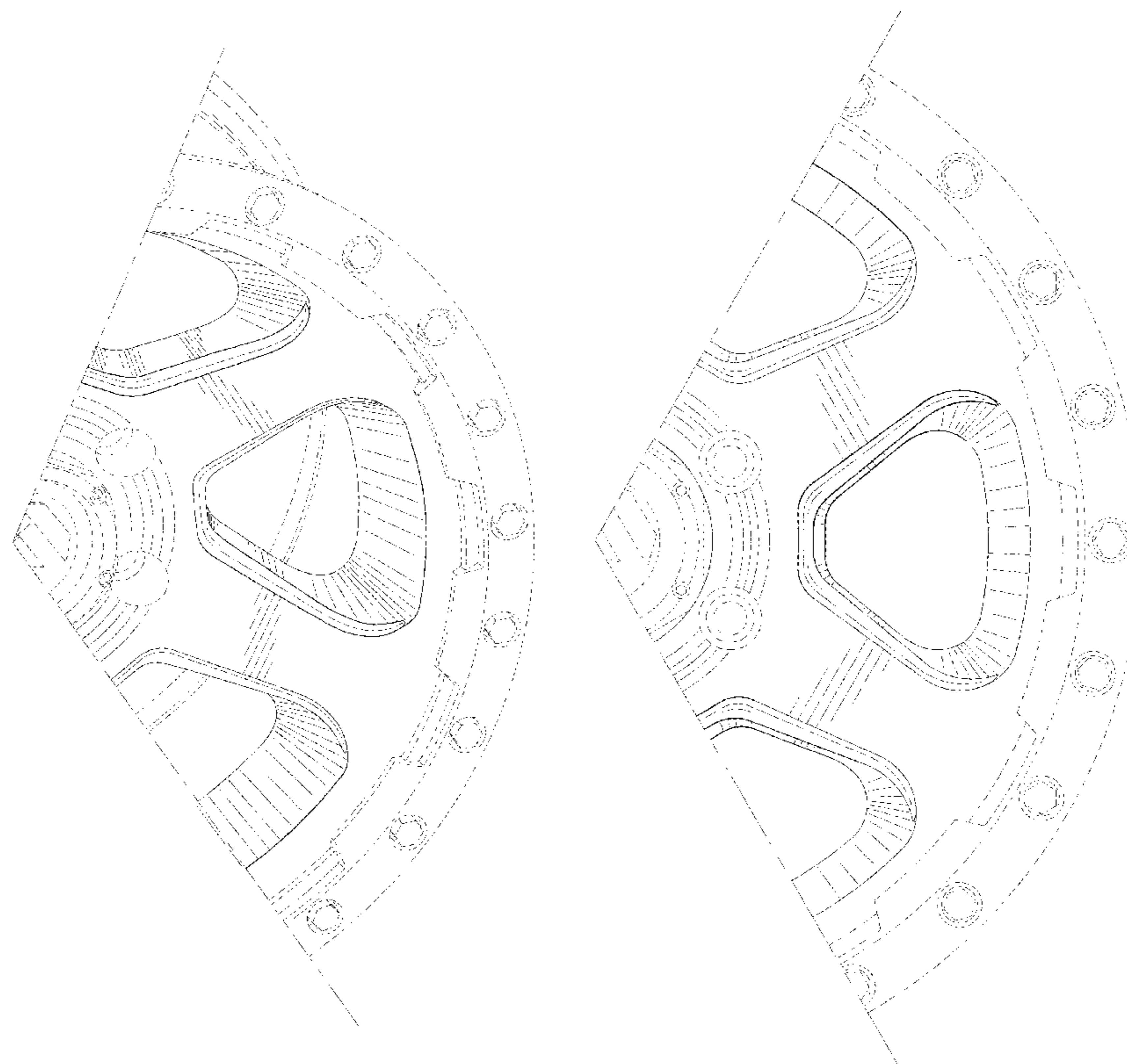

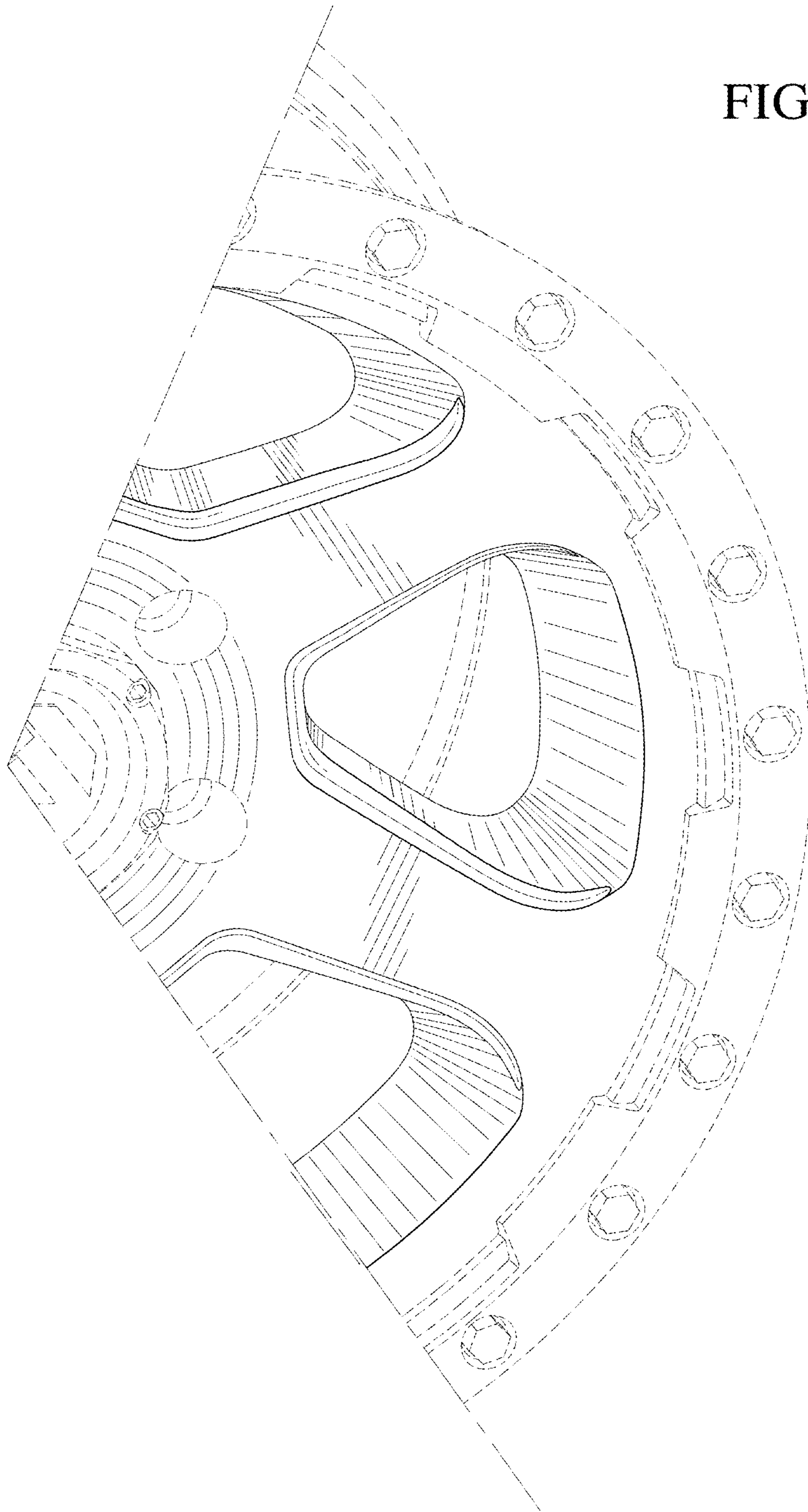
