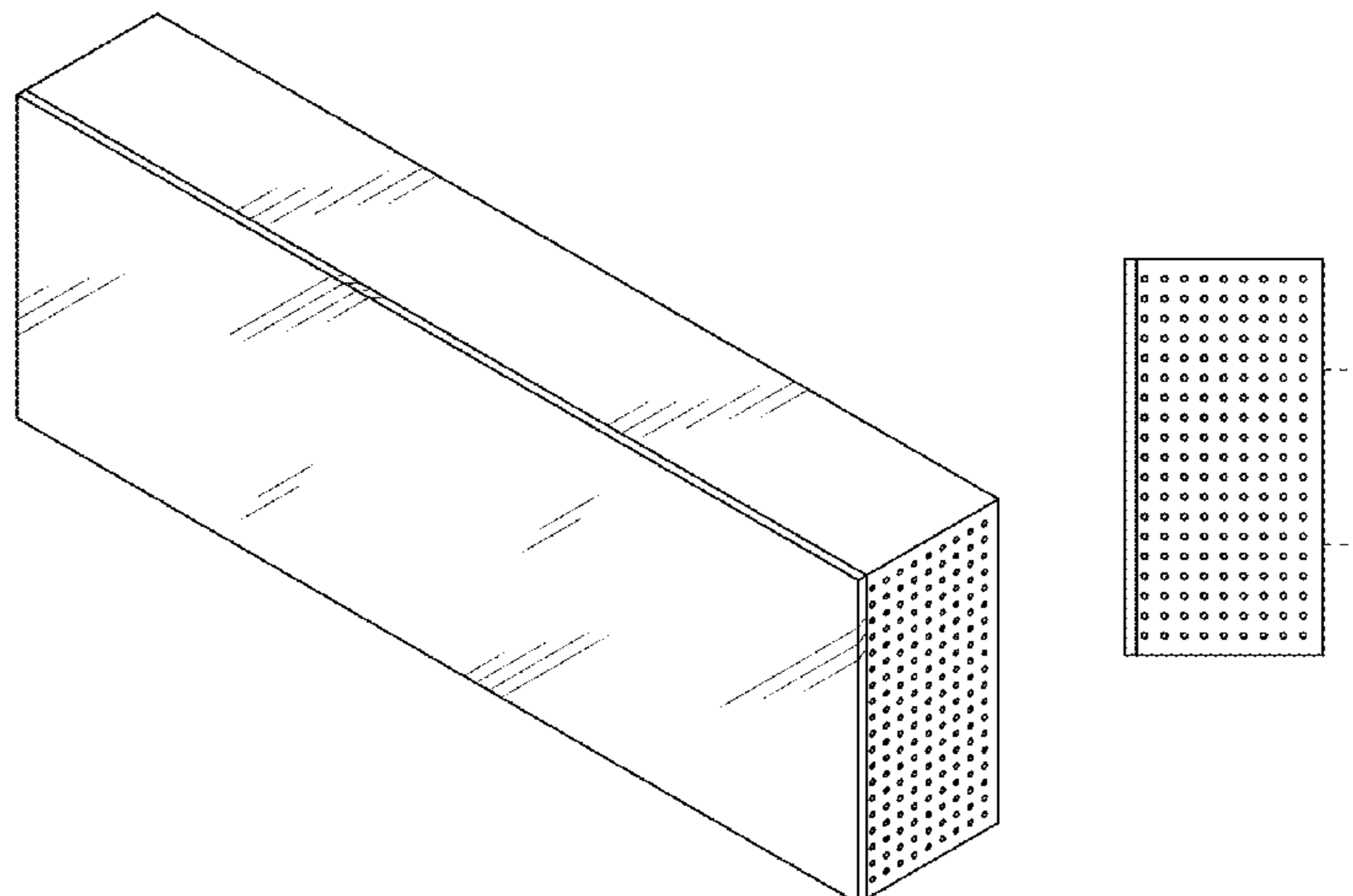
(57) **CLAIM**

The ornamental design for a remote controller for water heater, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of a remote controller for water heater showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a top view thereof; the bottom view being a mirror image thereof; FIG. 5 is a right side view thereof; the left side view being a mirror image thereof; and, FIG. 6 is a reference view showing state in use thereof.

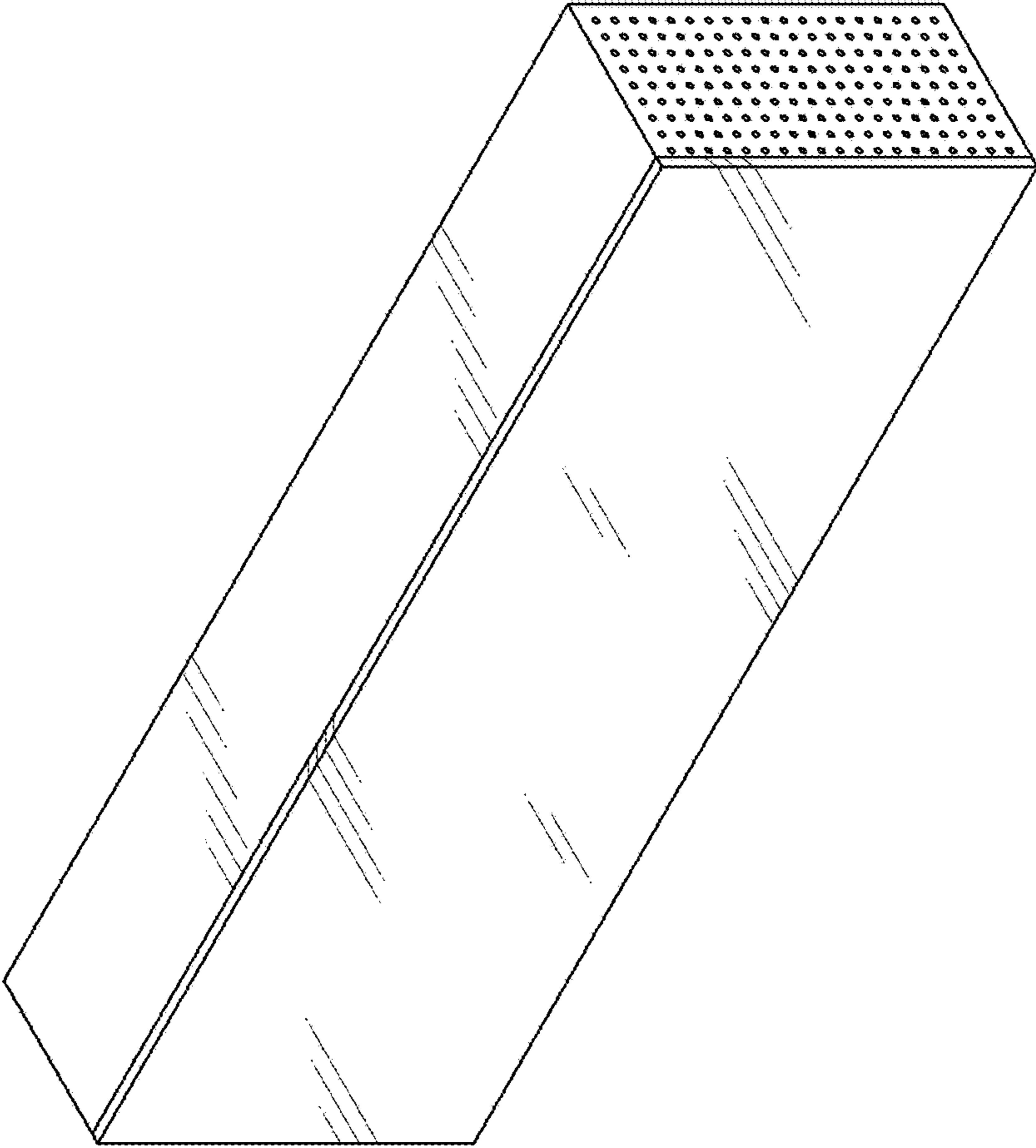

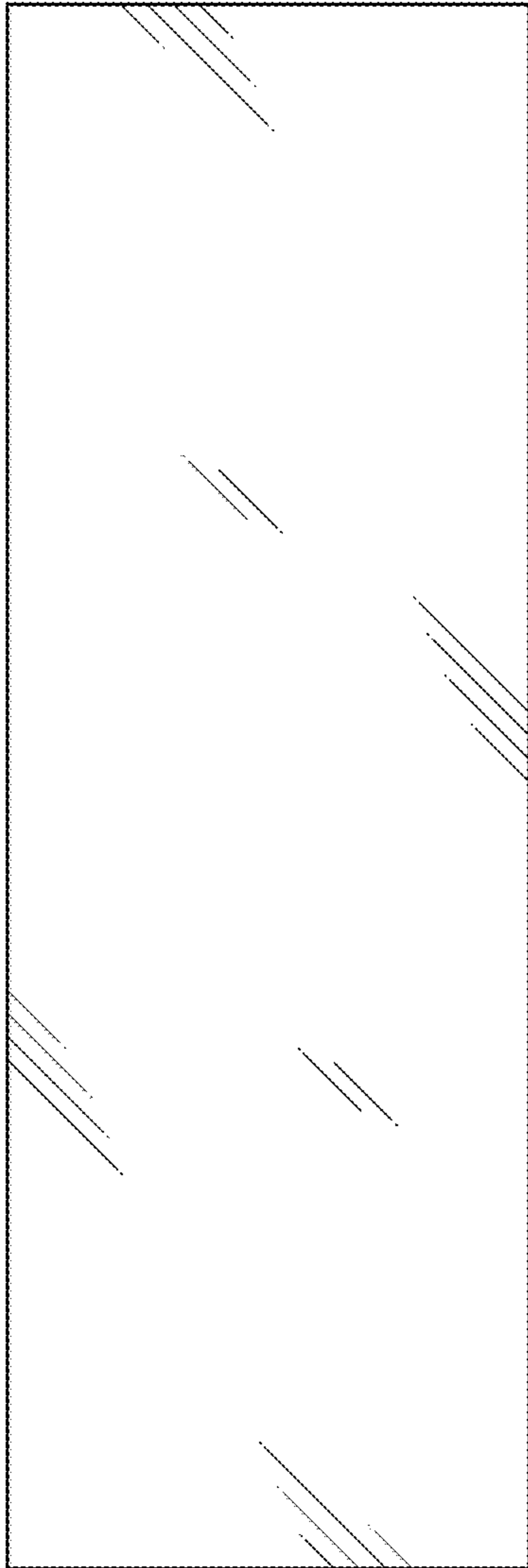

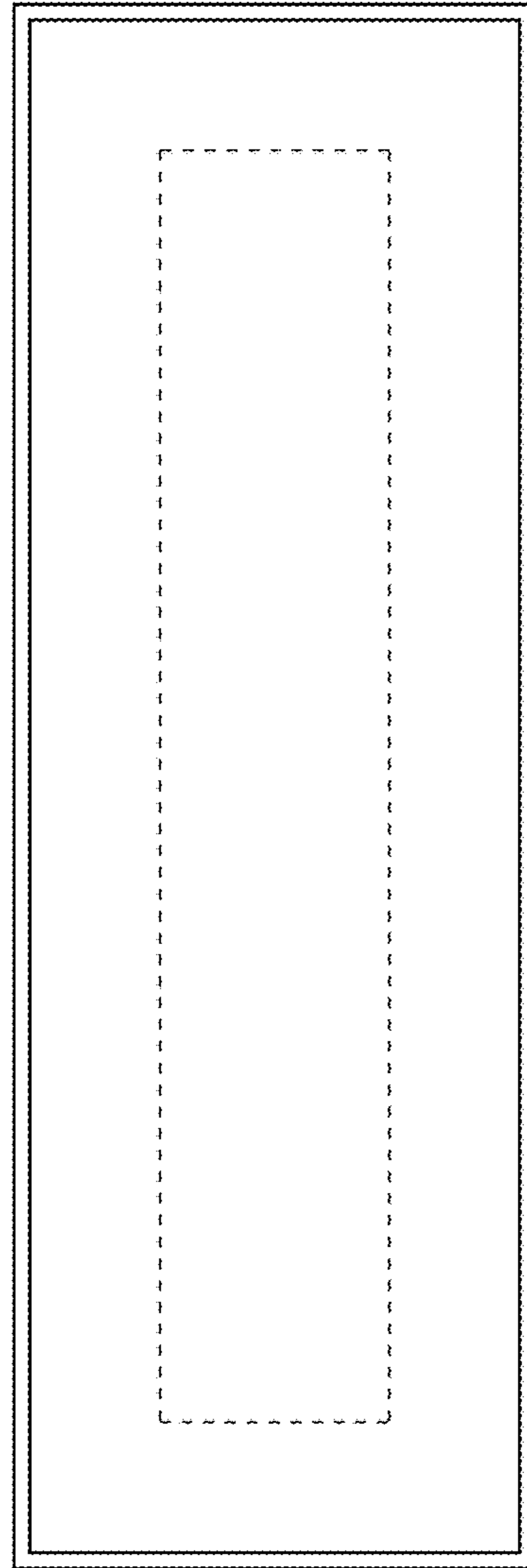

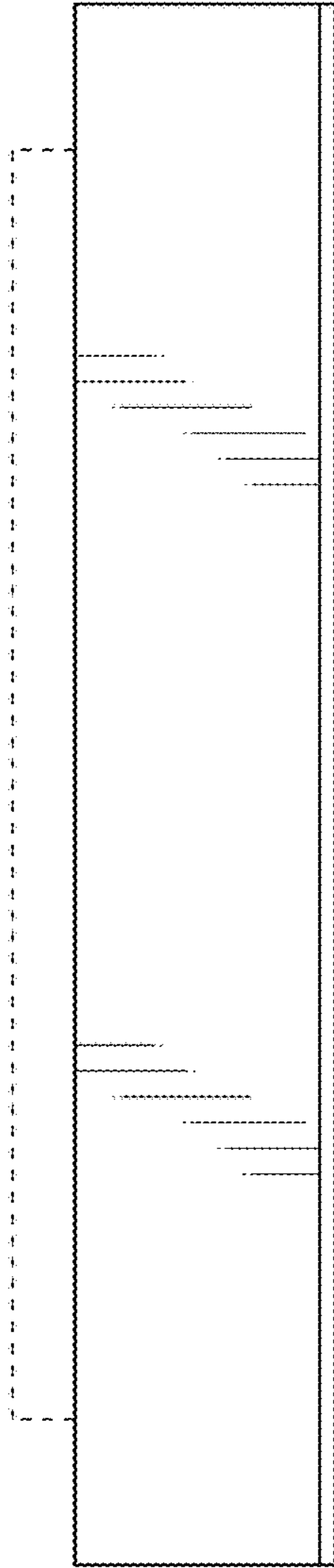

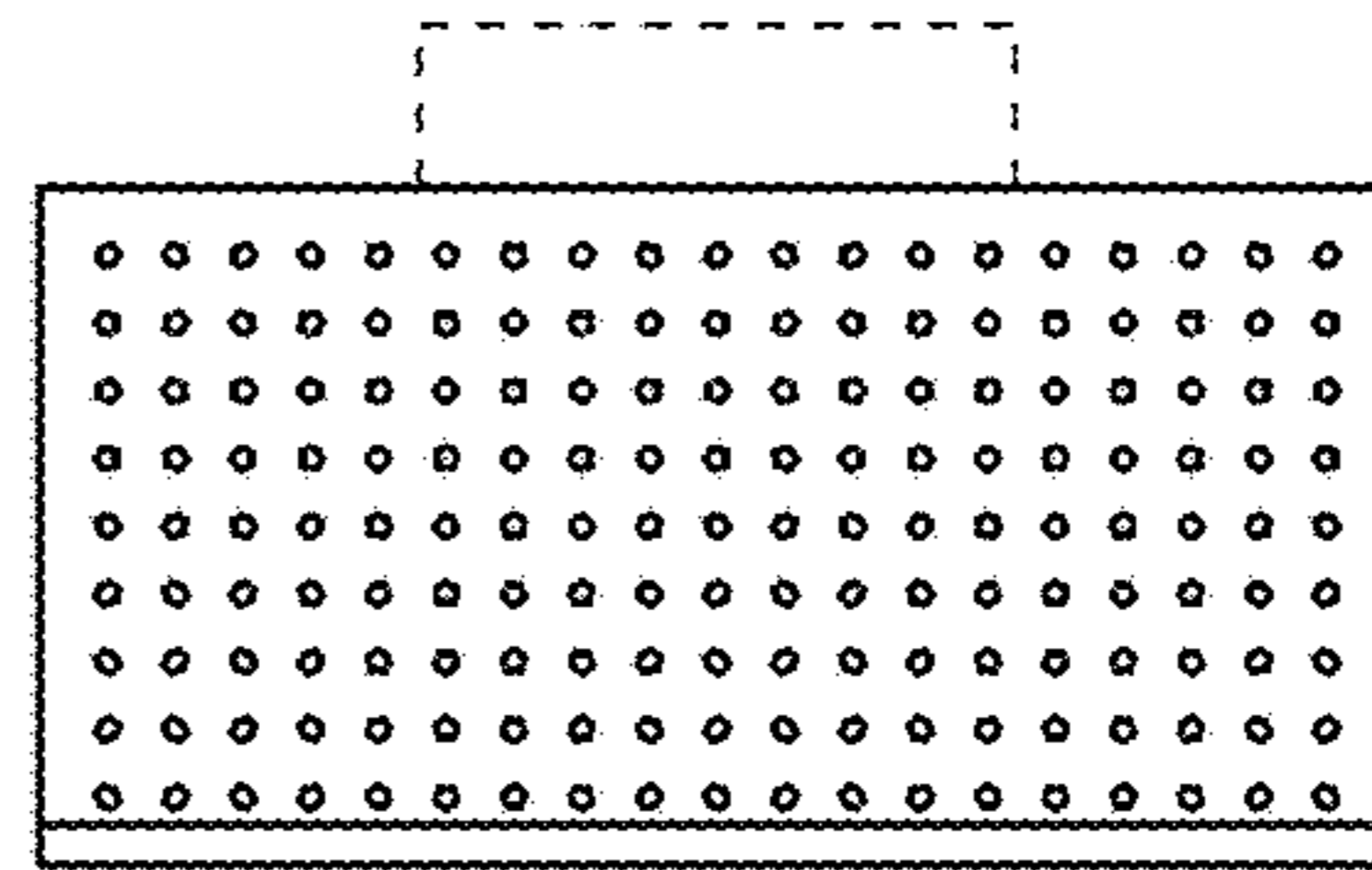
