The ornamental design for a display screen with animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 11 is a third view thereof; and,

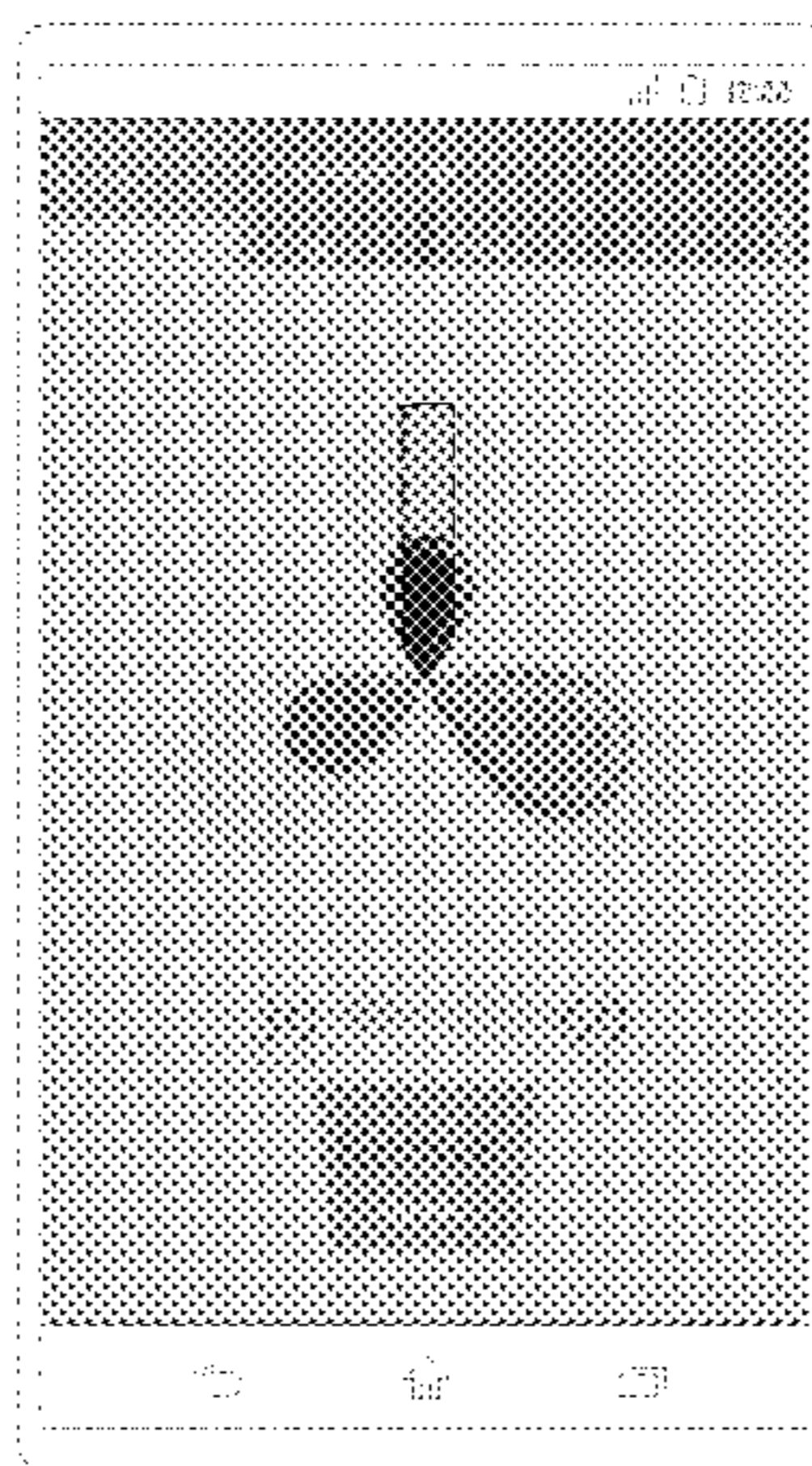
FIG. 12 is a fourth view thereof.

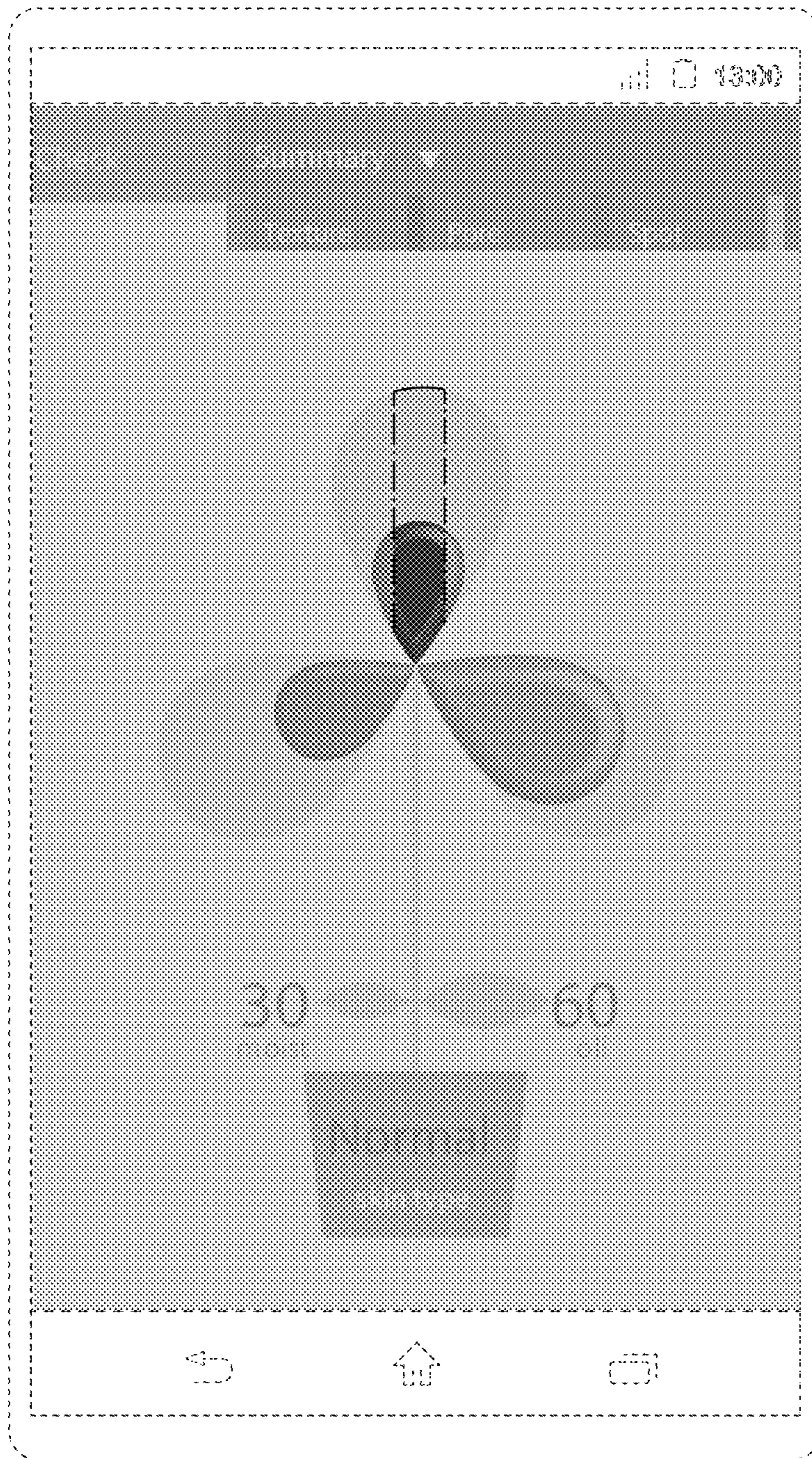

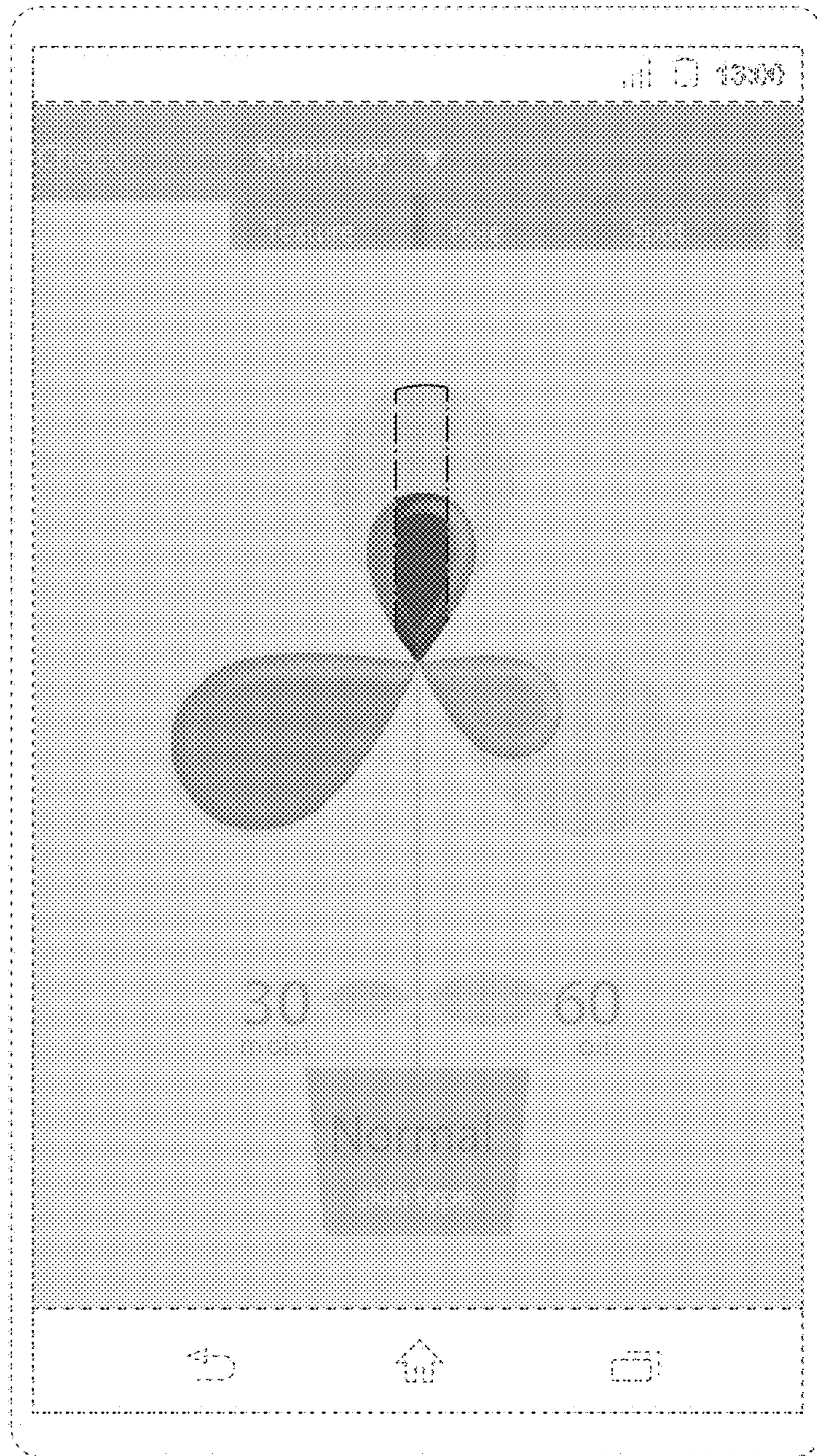

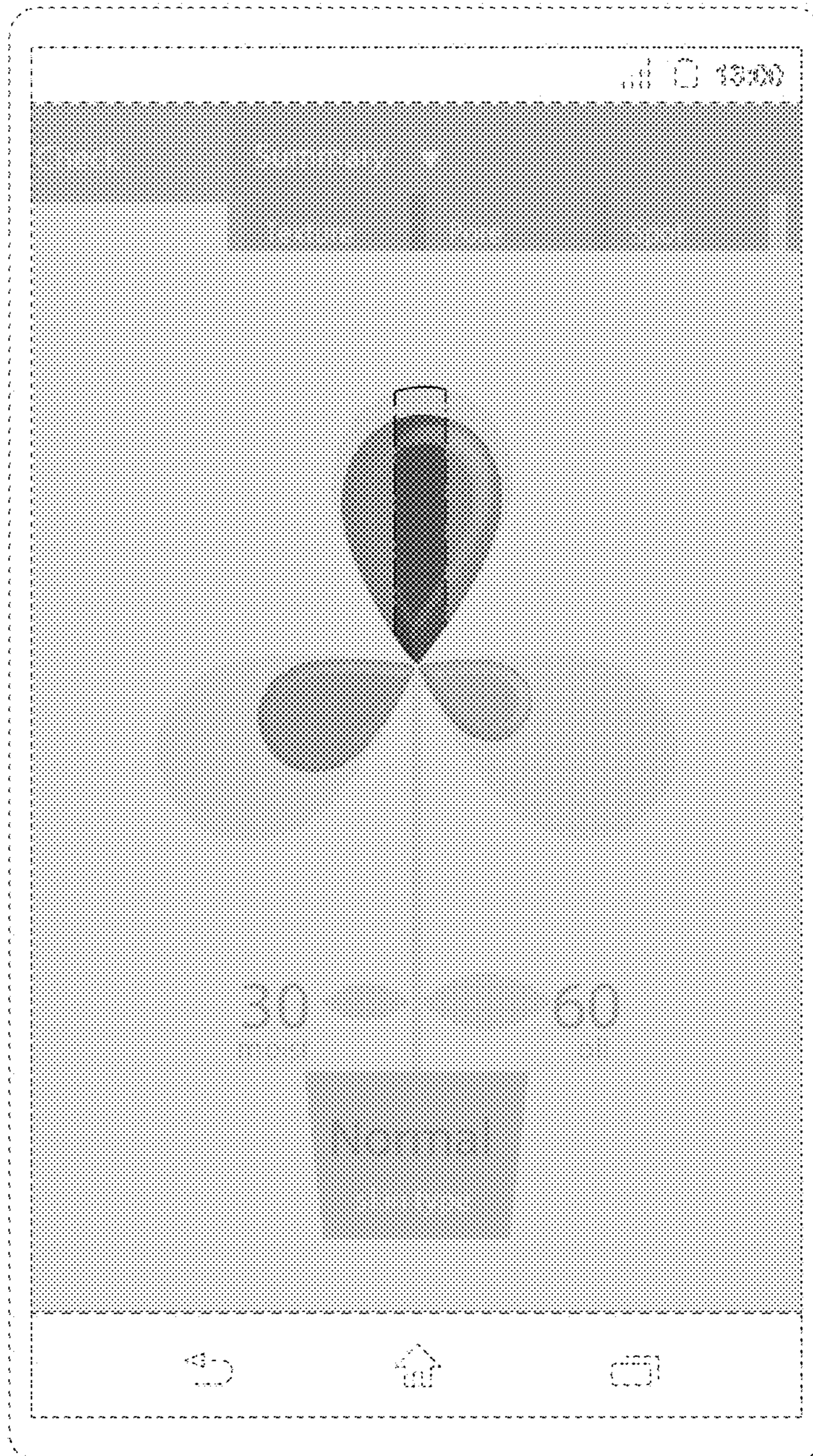

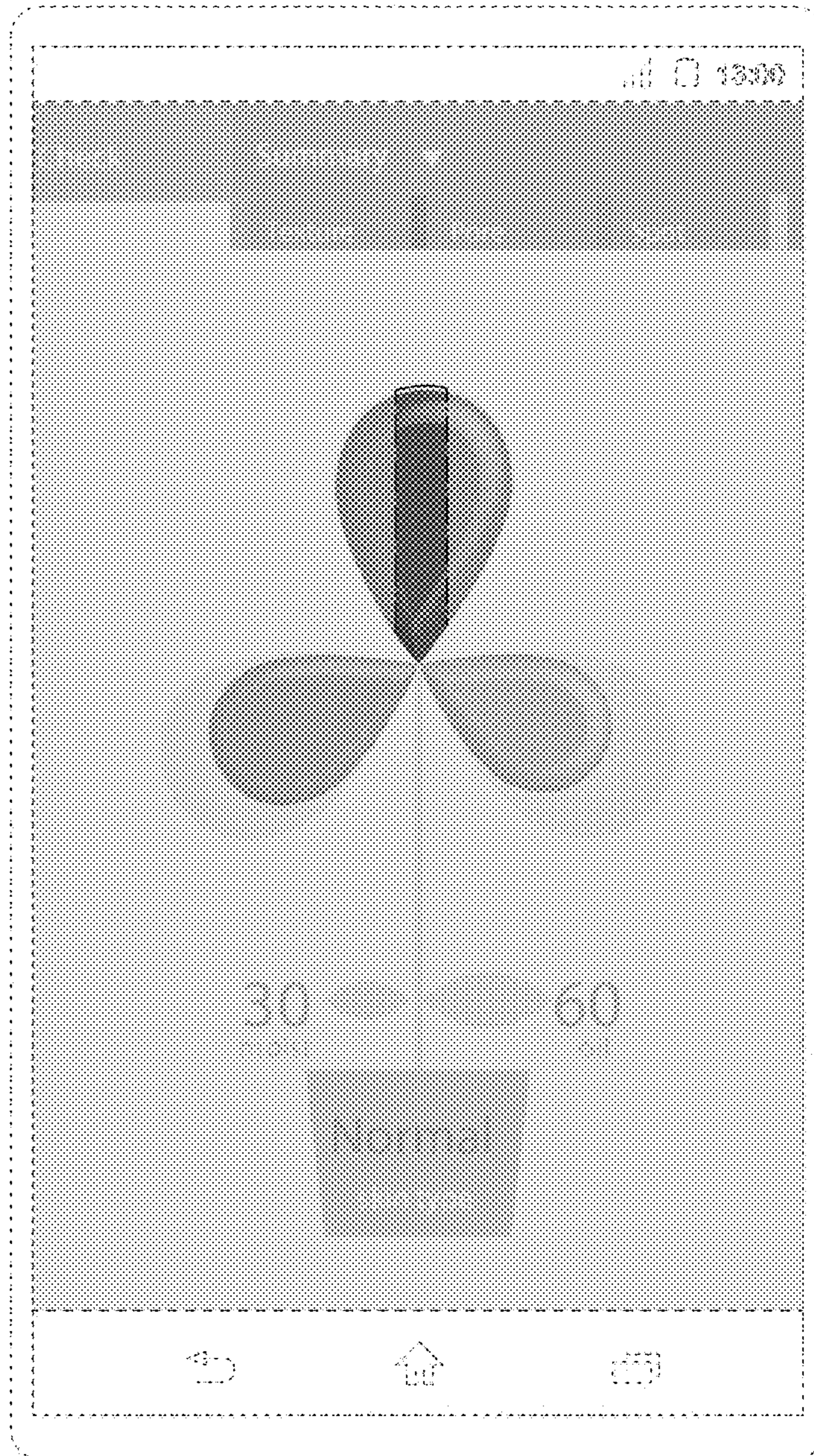

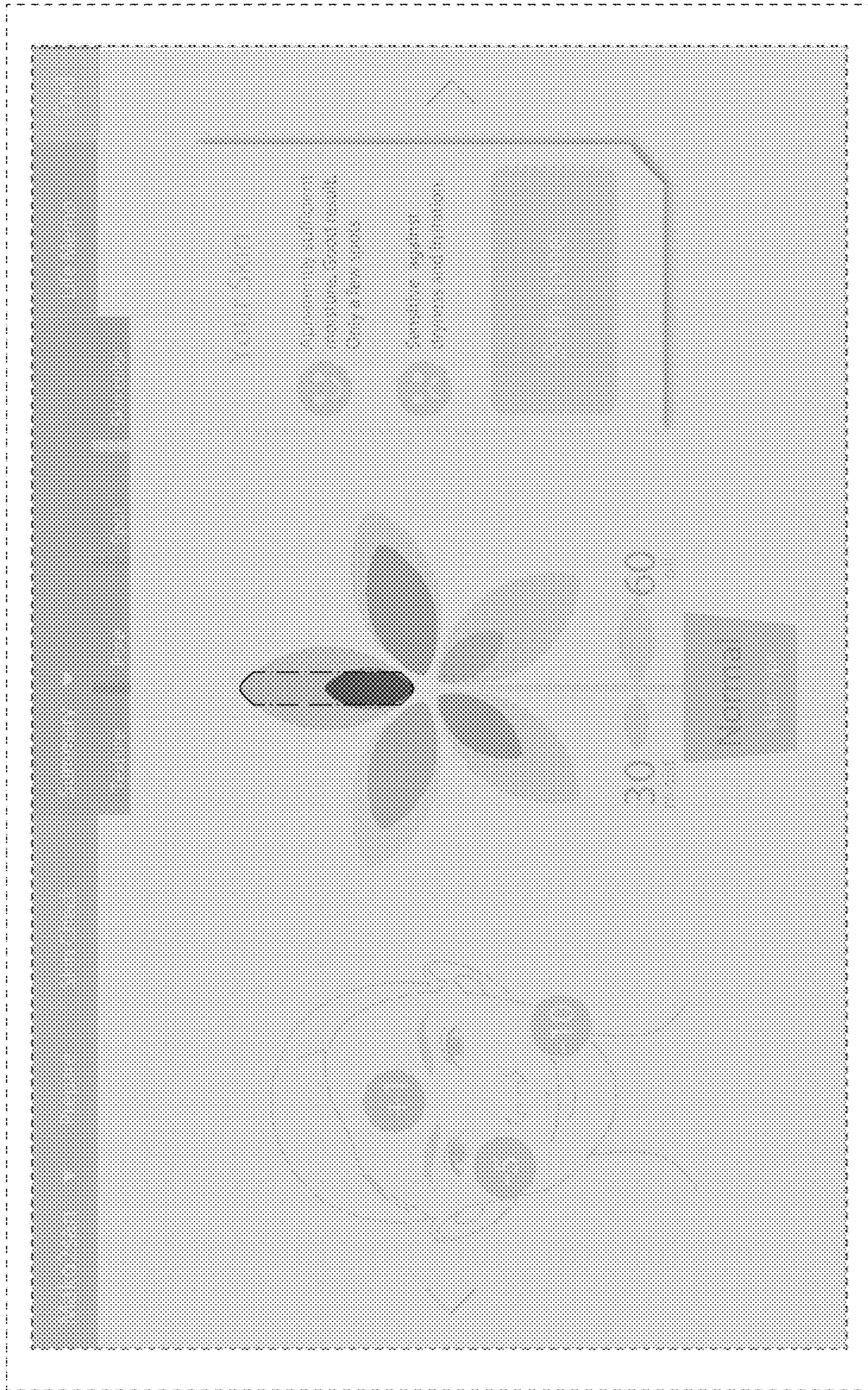

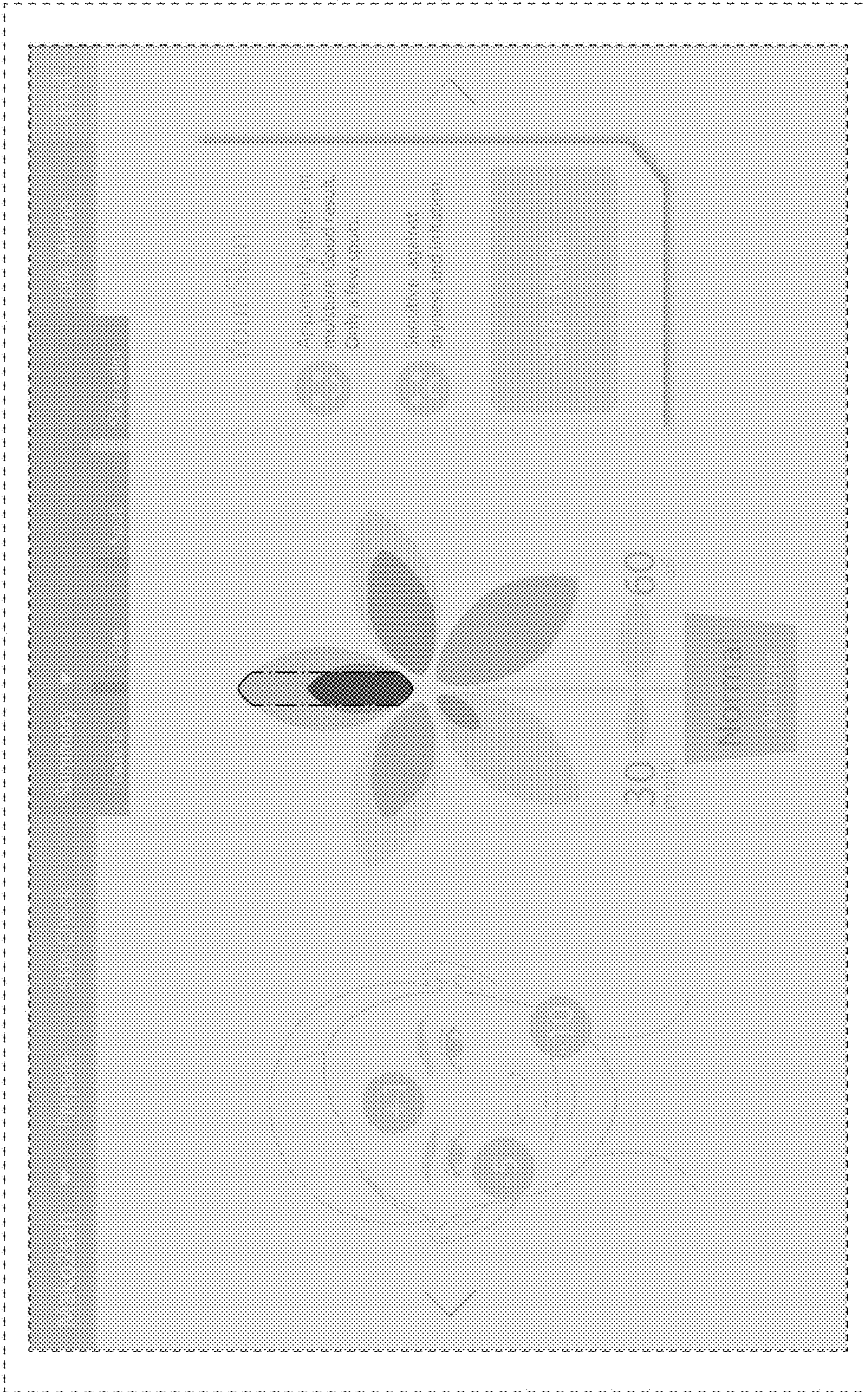

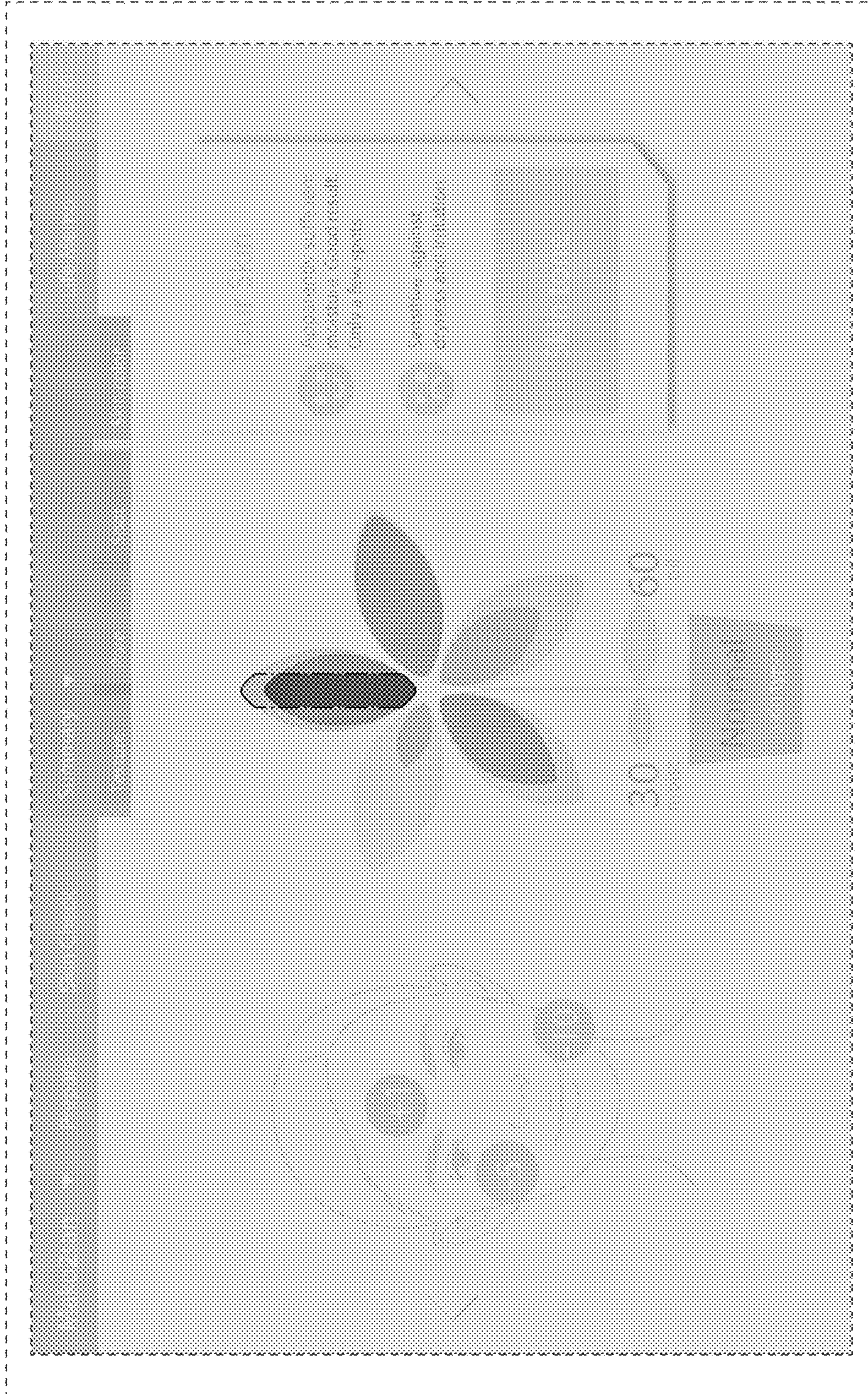

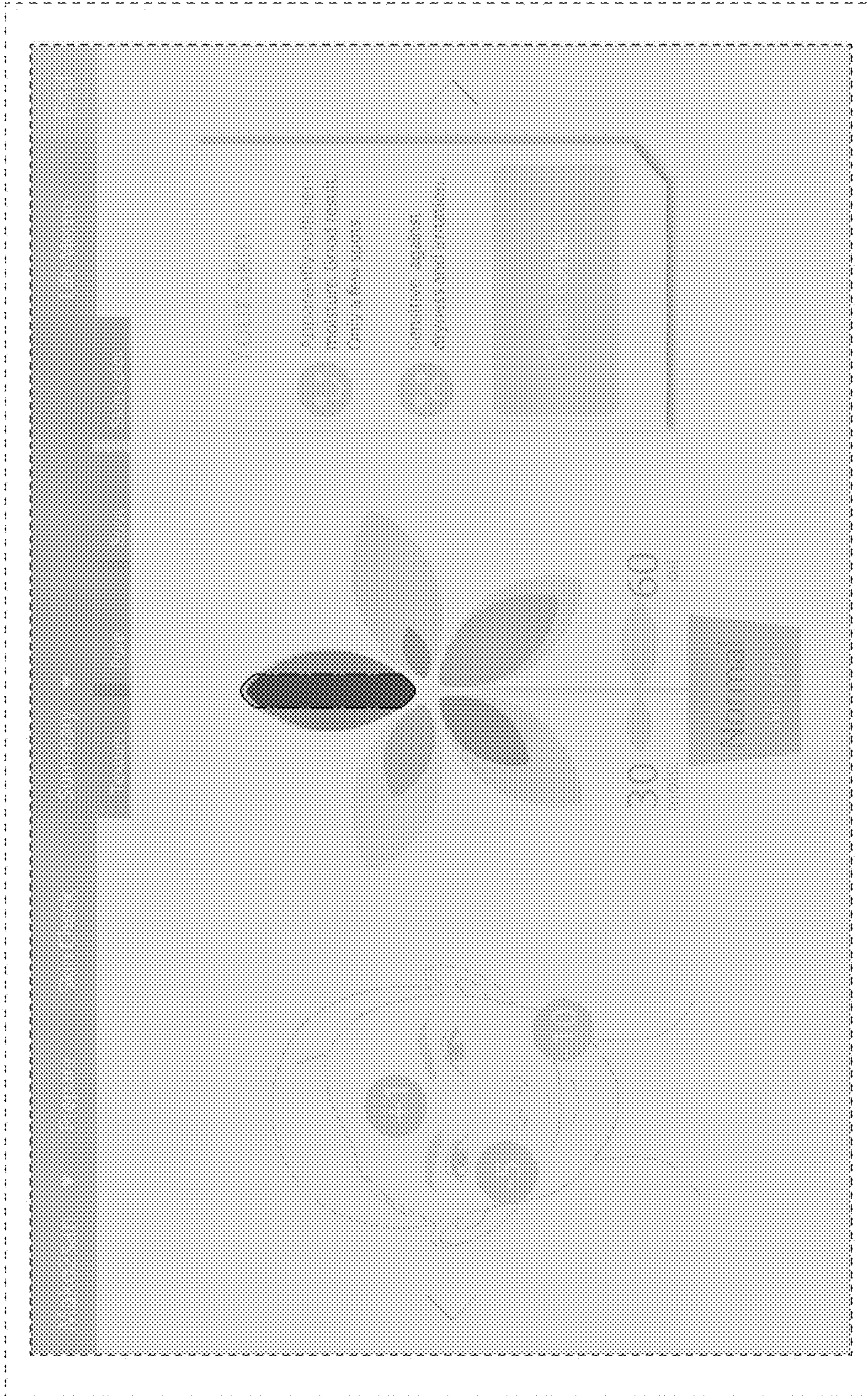

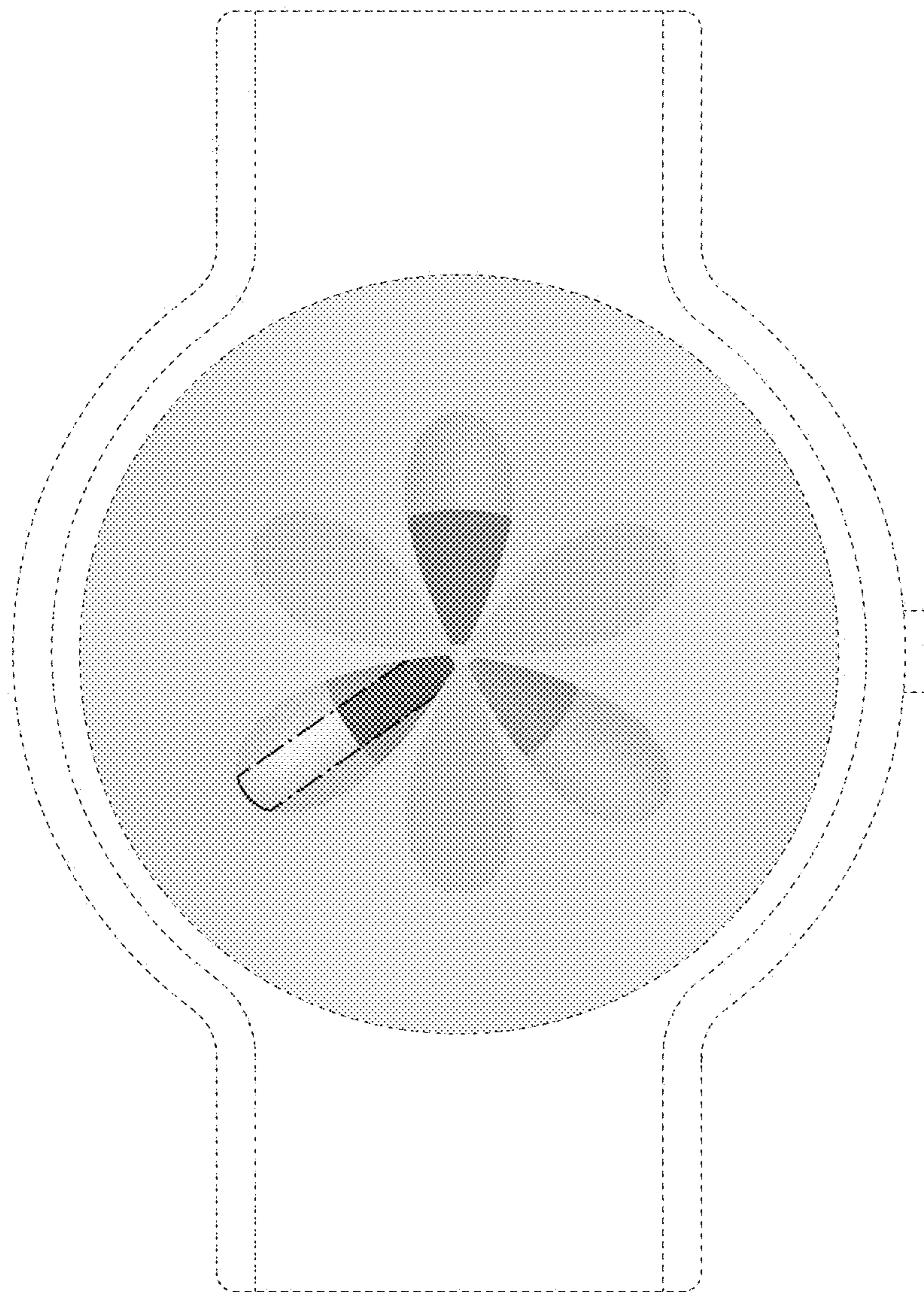

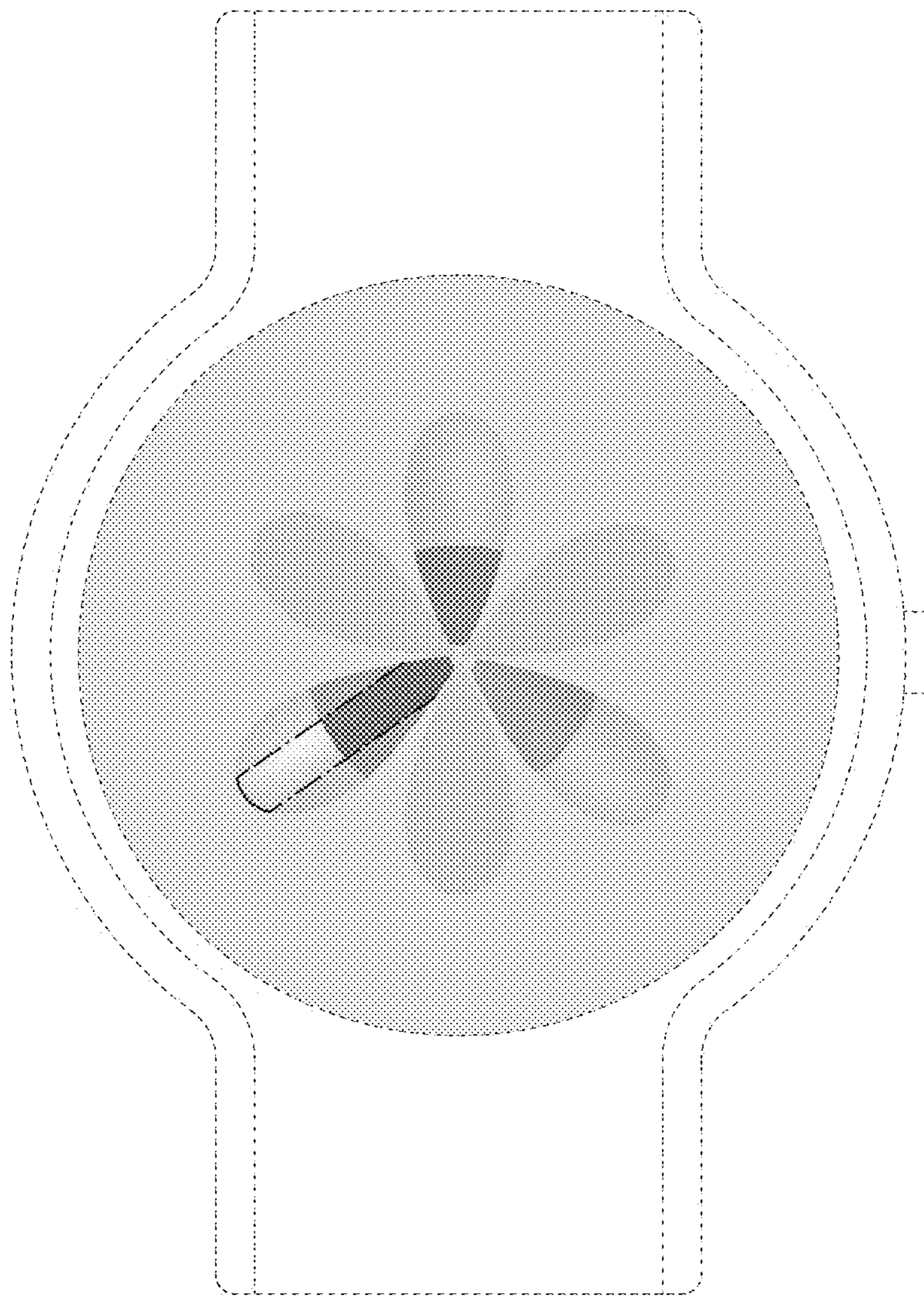

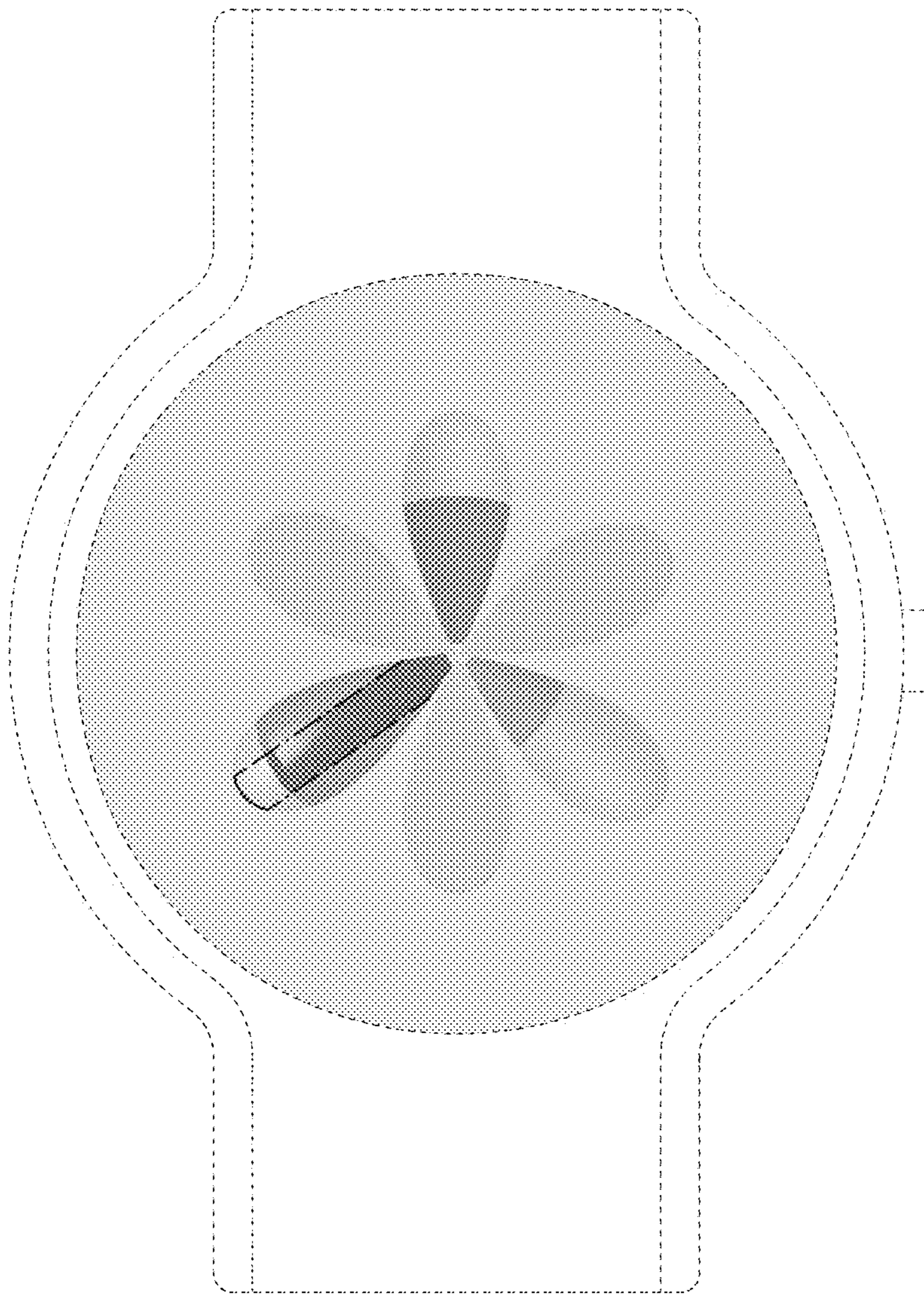
