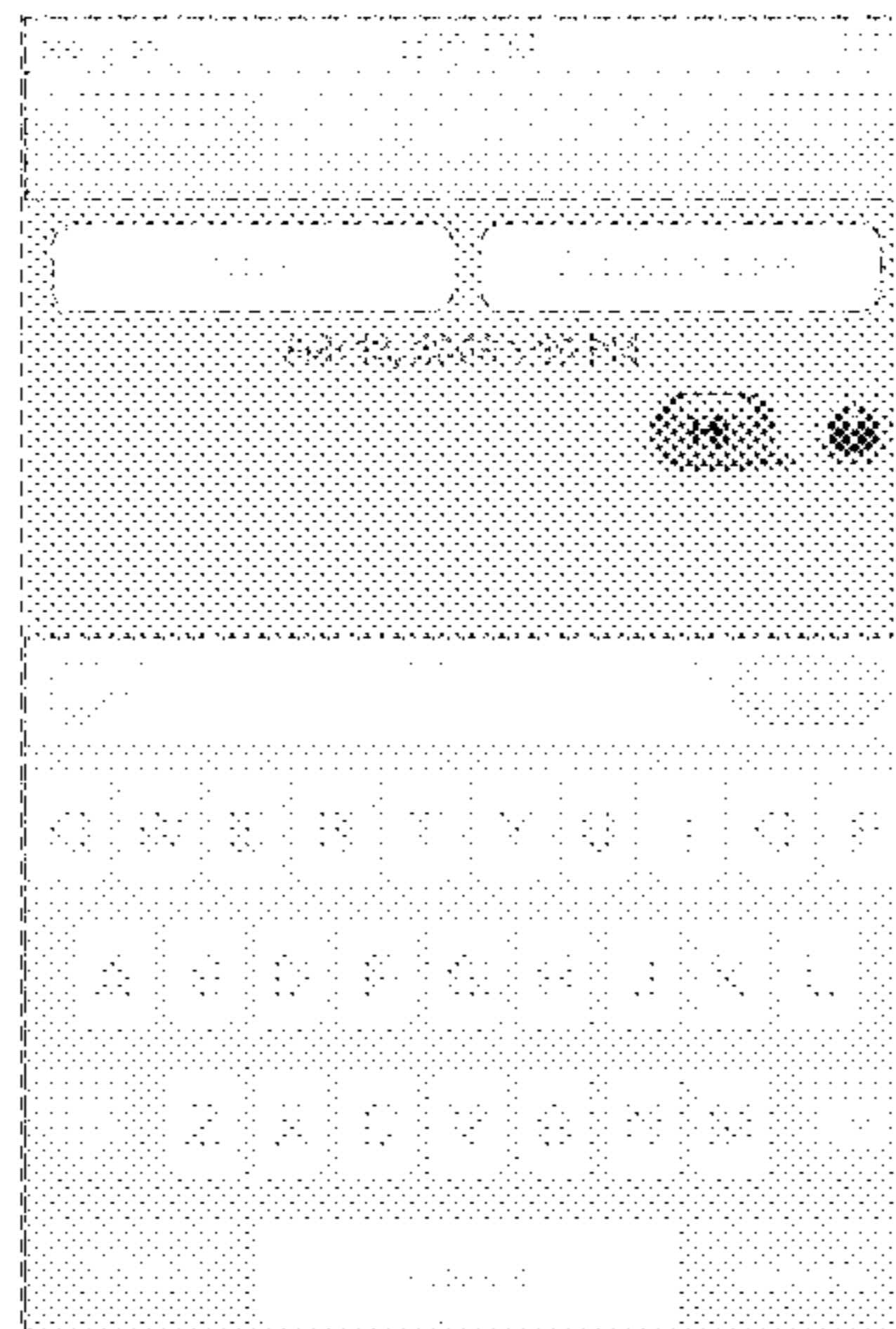
FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing the claimed design; and,

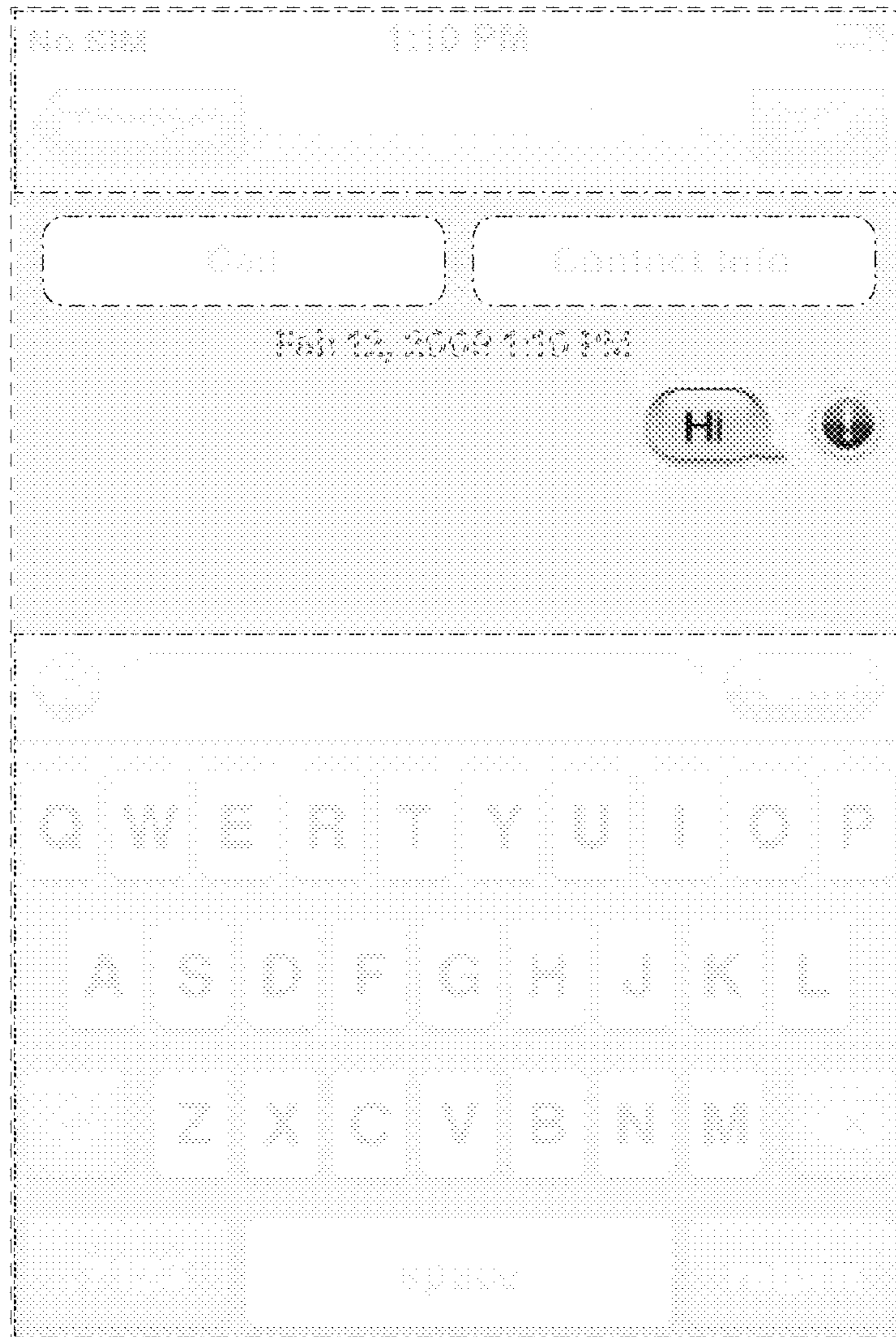
