DESCRIPTION

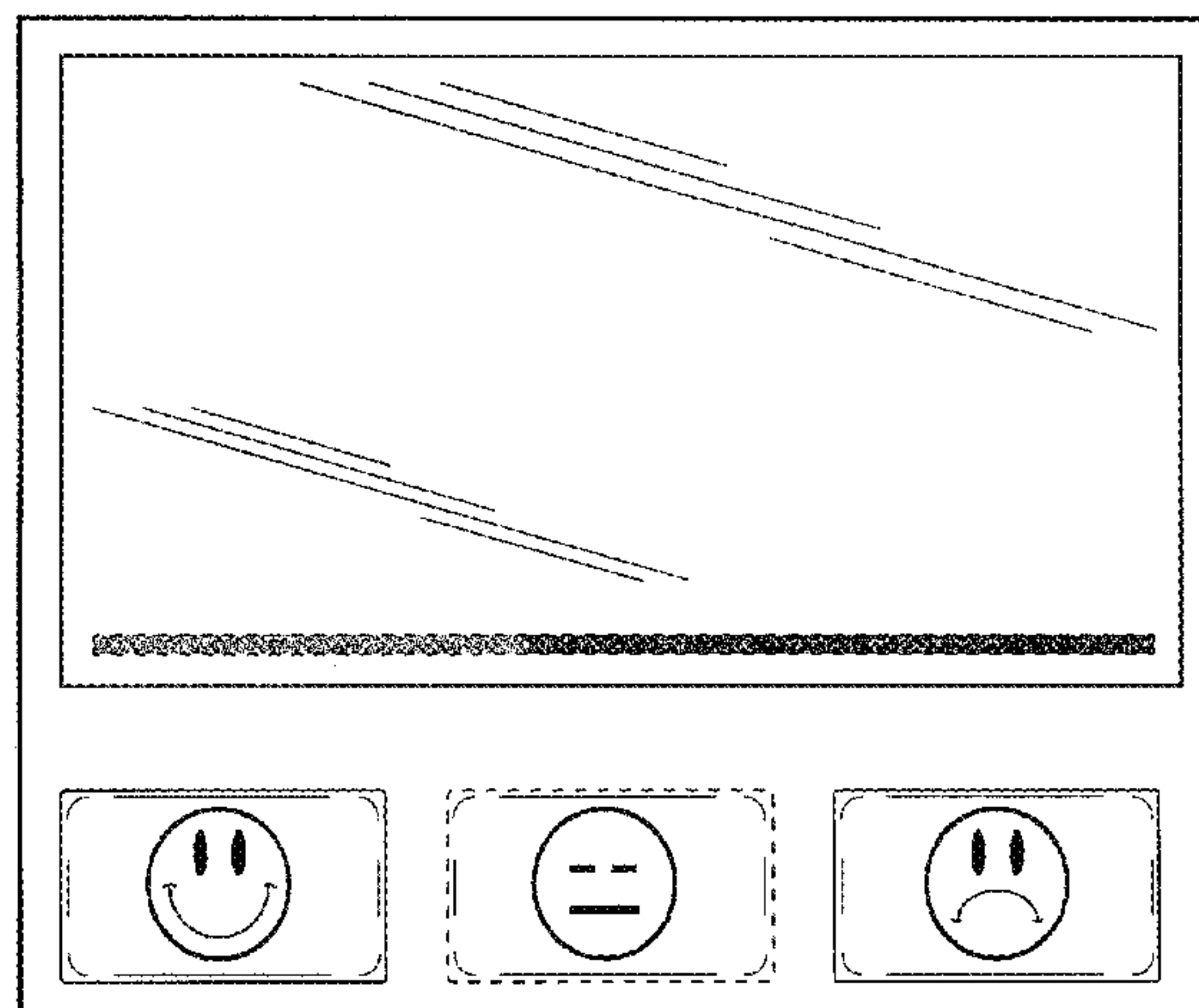
A display screen for media player with graphical user
